SRINAGAR: Two elderly men from twin districts of Shopian and Baramulla died at the hospitals here on Wednesday, taking the number of fatalities due to the disease in Iammu and Kashmir to 65, officials said.

65-year-old man from Feripora area of Shopian died of cardiopulmonary arrest at 4:15 am at SKIMS Hospital Soura, they said.

The officials said the patient was admitted to the hospital on Monday with complaints of fever and shortness of breath, and was diagnosed with acute exacerbation of chronic obstructive pulmonary disorder.

The patient was on non-invasive ventilation and his son who was attending him had given negative consent for intubation, they added.

## After Deadly Clash, China... "sovereignty of the Galwan Valley area has always belonged

to China," echoing a statement of the Chinese military on Tuesday, opening up another dispute.

When asked since Galwan is regarded as settled border and why China is claiming sovereignty over the area now, Zhao said, "regarding the mater of the Galwan area we are having communication through military and diplomatic channels. Right and wrong of this is very clear. This happened at the Chinese side of the border and China is not to be blamed for it."

He also refused to comment on reports of 43 casualties on the Chinese side during the face-off with the Indian Army in the Galwan Valley on Monday night.

"The border troops are dealing with relevant matter," he said.

When pointed out that the India has released the number of casualties and why Beijing was not providing the number for Chinese side, he said. "I have stated that Chinese and Indian border troops are now jointly dealing with the relevant matter on the ground. I have nothing to add at the moment." "On the situation at the China-India border both sides are

having close communication with each other to resolve this through diplomatic and military channels, Zhao said.

"The over all border situation is stable and controllable," he told correspondents to a volley of questions.

Responding to a question whether further clashes could be averted, the spokesman said, "from the Chinese side we do not wish to see more clashes.

"I believe you have noticed that China and India have both said that we are committed to resolve the differences through dialogue safeguarding peace and tranquility in the border area.

"As the world's two biggest countries and emerging economies, the shared interest of China and India are far larger than the differences.

"Both sides should earnestly follow important consensus reached by the leaders of the two countries and ensure that the bilateral relationship can move forward in the right direction and that serves our peoples interests and expectations. We hope India can work with China to this end," Zhao said.

Twenty Indian Army personnel, including a Colonel, were killed in the clash with Chinese troops in the Galwan Valley on Monday night, the biggest military confrontation in over five decades that has significantly escalated the already volatile border standoff between the two countries.

A large number of Indian and Chinese troops have been engaged in an eyeball-to-eyeball situation in Galwan Valley and certain other areas of eastern Ladakh for the last five weeks, including in Pangong Tso, Galwan Valley, Demchok and Daulat Beg Oldie in eastern Ladakh.

Monday's face-off was the biggest confrontation between the two militaries after their 1967 clashes in Nathu La when India lost around 80 soldiers while over 300 Chinese army personnel were killed in the face-off.

The Indian Army has been fiercely objecting to the transgressions, and demanded their immediate withdrawal for restoration of peace and tranquillity in the area. Both sides held a series of talks in the last few days to resolve the row. The India-China border dispute covers the 3,488-km-long Line of Actual Control (LAC). China claims Arunachal Pradesh as part of southern Tibet, while India contests it.

## HC Asks JK Bank To Hold ...

had participated in the selection process pursuant to a notification on 6 October 2018. The candidates have challenged the notification issued earlier this year by the Bank whereby it notified that the selection process conducted for the posts stands canceled. They have also challenged the fresh recruitment notice.

As soon as the petition came up for the hearing, Khan Roshan Khayal, an Officer of the J&K Bank, working in its Legal Section, appeared before the court and raised a preliminary objection to the maintainability of the plea. He submitted that the Jammu and Kashmir Bank Limited is not a State within the meaning of Article 12 of the Constitution. He, in this regard, invited the attention of the Court to the Full Bench Decision of the Court in Firdous Ahmad Tanki v the J&K Bank Ltd (2006), wherein the majority view taken was that the Bank was neither the State nor an authority or instrumentality of the State within the meaning of Article 12 of the Constitution of India. He submitted that the bank was not amenable to the writ jurisdiction of the High Court under Article 226 of the Constitution of India.

However, senior advocate Jahangir Iqbal Ganai on behalf of the petitioners submitted that the judgment of the Full Bench was distinguishable as the factors which formed the basis for such declaration have changed so much so the judgment was based on the fact that the share capital of the Bank was only 53% which is now 68.18%.

He submitted that in view of the "changed circumstances", the financial and Administrative control of Bank is now with the Government.

He also referred to the impugned notice by President-HR of the Bank, cancelling the selection process conducted for the posts by the Bank. "This notice reads that approval to the cancellation of the selection process was accorded by the Board of Directors of the Bank on 15.4.2020 in pursuance of directions of the J&K's Administrative Council," he said. After hearing both the parties, the court issued notice to the government, observing the impugned notice (dated

The cases detected on Wednesday included 22 persons who had returned to Jammu and Kashmir recently.

Shopian district, in south Kashmir, had the highest number of cases at 27, followed by Srinagar & Udhampur districts at 17 cases each, Kupwara at nine, Kulgam & Baramulla at seven each, Budgam at five, Anantnag at four, Rajouri& Reasi at three each, Pulwama, Bandipora & Ramban at two each and Ganderbal & Kathua at one each, the officials said.

Among the cases from Srinagar, include a fifteen day-old baby and a teenager from Bemina and two women from Ishber and Khanyar, besides two men and women from Nowshera.

They said four districts Jammu, Doda, Kishtwar and Poonch had no fresh cases.

The officials said that 133 more patients recovered and were discharged from different hospitals.

The number of confirmed cases has now reached 5,406, out of which 4,172 are in Kashmir, while 1,234 are in Jammu, the officials said.

There are 2,428 active cases of the coronavirus disease (CO-VID-19) in J&K – 1,762 in Kashmir and 666 in Jammu – and 2.914 (2.353 from Kashmir and 561 from Jammu) patients have recovered, according to officials.

The J&K has witnessed 64 COVID-19 (57 from Kashmir, 7

According to the news agency ANI, four soldiers were critically injured during the face-off.

However, government sources quoted by news agency IANS said that the number of critically injured personnel is in double digit. Indian Army refused to comment on the numbers and stated that several are injured.

The attack on Indian Army personnel by the Chinese Army took place on Monday night and it continued for almost six to seven hours.

On Tuesday, Indian helicopters flew around 16 times to bring bodies and injured Indian Army personnel from the site of attack at Galwan Valley in Ladakh region, government sources said. Four bodies of Indian Army personnel were flown to Leh from Galwan on Wednesday morning.

On Tuesday, Indian Army stated that 20 of their men, including officers, were killed in an unprecedented violent clash with the Chinese troops in the Galwan Valley. The force also said the attack was brutal and injuries sustained were critical.

Indian Army issued a statement late on Tuesday night, and said, "Seventeen Indian troops who were critically injured in the line of duty at the standoff location and exposed to sub-zero temperatures in the high altitude terrain have succumbed to their injuries, taking the total that were killed in action to 20."

The force further stated that Indian and Chinese troops have disengaged at the Galwan area where they had earlier clashed on the night of June 15 and June 16, 2020."

### No Road Ahead: Reporting...

Mir like his colleagues ended up reporting one of the highvoltage escalation events at the Line of Actual Control from Gagangeer itself.

The ongoing Sino-India standoff escalated at night hours of June 15, when over twenty Indian Army personnel, including a Colonel, were killed in the clash with PLA in the Galwan Valley.

New Delhi media has already reported some grotesque details-"Chinese death squads hunted down Indian troops in savage execution spree"-about the nocturnal encounter in the contested valley which Beijing now claims in its entirety. It proved to be the biggest military confrontation between the armies of the two most populous nations in over five decades. They had last traded guns in 1962.

New Delhi reacted sharply, with Prime Minister Narendra Modi saying "India can give fitting reply when provoked". Following the fierce clash, Zubair Dar, who works with Voice of America went to cover the biggest news. After waiting for hours at Gagangeer, he returned to Srinagar.

"Commercial vehicles were allowed to move on," Dar said, "but media-persons were stopped for reasons best known to officials."

When Kashmir Observer contacted some concerned police officials, they cited the COVID guidelines and travel passes as the reason to stop some Ladakh-bound passengers. "Srinagar - Kargil NHW is open for vehicular movement," The Prime Minister has also convened an all-party meet on June 19 to discuss the India-China border situation.

The Prime Minister's call for the meeting comes against the backdrop of demands by the opposition parties that the government should come out with the details of the violent face-off between Indian and Chinese troops in eastern Ladakh.

"In order to discuss the situation in the India-China border areas, Prime Minister Narendra Modi has called for an allparty meeting at 5 PM on 19th June. Presidents of various political parties would take part in this virtual meeting," the PMO tweeted.

Congress leader Rahul Gandhi on Wednesday asked Modi to share the truth of the India-China face-off, saying the entire country is standing behind him.

Monday night's clash was the biggest confrontation between the two militaries after their 1967 clashes in Nathu La when India lost around 80 soldiers while over 300 Chinese army personnel were killed in the conflict.

The External Affairs Ministry on Tuesday said the violent face-off between armies of India and China in eastern Ladakh was the result of an attempt by the Chinese side to unilaterally change the status quo in the region.

Defence Minister Rajnath Singh and Home Minister Amit Shah have paid tributes to Indian soldiers, who displayed exemplary courage and valour in the line of duty and sacrificed their lives in the highest traditions of the Indian Army. "The Nation will never forget their bravery and sacrifice. My heart goes out to the families of the fallen soldiers. The na-

tion stands shoulder to shoulder with them in this difficult hour. We are proud of the bravery and courage of India's bravehearts," the defence minister tweeted.

In a series of tweets, Shah said the pain of losing the brave soldiers at cannot be put in words.

"India will always remain indebted for their supreme sacrifice. Entire nation and Modi government stands firmly with their families in this hour of grief. Praying for the speedy recovery of those injured," he said.

Praising efforts of states and local administration, he said the country now has more than 900 COVID-19 testing labs, lakhs of special beds, thousands of isolation and quarantine centres, adequate stocks of testing kits, with over one crore personal protective equipment (PPEs) and almost same numbers of N-95 masks supplied to states.

Despite a rise in coronavirus cases in a few places, people's patience, administration's work and dedication of corona warriors have ensured that things did not go out of control, he said.

Stressing on the importance of providing timely information, the prime minister said it should be ensured that helplines are not "helpless" but helpful for people.

He called for building teams of senior doctors and young volunteers to guide patients through telemedicine and run

## **On The Brink**

n a dramatic escalation of the ongoing border stand-off between India and China in Ladakh, 20 Indian soldiers including a commanding officer died in a clash with the Chinese troops. This is the biggest loss suffered by India in a stand-off with China since 1975 when Four Indian soldiers died when a patrol of Assam Rifles jawans was ambushed at Tulung La in Arunachal Pradesh in 1975. The ANI has reported that 43 Chinese soldiers also were killed in the clash. And the US media reports quoting its intelligence officials have said that 35 Chinese troops have been killed in the clashes. However, China has so far neither confirmed nor denied its casualties. The killings on both sides have taken the border stalemate to a boiling point with the two countries on the brink of a full-fledged war. Prime Minister Narendra Modi has called for an all-party meet on the issue on June 19. On Tuesday, Defence Minister Rajnath Singh went to the Prime Minister's residence for a late night meeting. The duo are said to have been joined by Home Minister Amit Shah, External Affairs Minister S Jaishankar and Finance Minister Nirmala Sitharaman.

The coming days will be crucial as to what happens next. However from the statements emanating from New Delhi and Beijing both sides are trying to play down the incident and get back to resolving the issue through dialogue. In his first statement, the PM has said that India wants peace but was capable of giving befitting reply if instigated. India, he added, has tried that the differences with China do not become disputes. On the other hand, Chinese foreign ministry spokesman Zhao Lijian has said his country doesn't don't wish to see more clashes, while urging India to avoid "provocative gestures" that could complicate the border situation. Lijian said both countries were having close communication trying to resolve the crisis through diplomatic and military channels.

But this hardly detracts from the fraught situation on the border. The two sides have irreconcilable differences on the perception of the Line of Control, more so in Ladakh. A day after the killing of 20 soldiers China has laid claim to entire Galwan Valley, a strategic geographical feature in Ladakh. New Delhi has demanded China to go back to the status quo as it existed before May 5. China which has already captured areas falling in Galwan Valley, Pangong Tso, Hot Springs etc has so far refused to vacate them. The stand-off between the countries is likely going to be a long haul. As things stand, war will be in neither country's interest, a reality that also informs the statements of the leaders of the two countries. The way out is to continue engagement on military and diplomatic levels. It may take time but this remains the only viable option outside a military confrontation that will be mutually destructive and, in the end, may offer no solution.

# No 'Peaceful Rise' This

OVID-19 isn't the only threat that has crossed India's borders this year. According to alarming reports from India's defense ministry, China has deployed a "significant number" of troops across the disputed Line of Actual Control (LAC) along the countries' Himalayan frontier. So far, these transgressions have occurred at four points on the world's longest and most highly disputed border, with thousands of Chinese troops showing up in Sikkim and in parts of the Ladakh region, northeast of the Kashmir Valley.

Neither government disputes the fact that Chinese soldiers have occupied territory that India considers its own. Notwithstanding a brief but bloody war in 1962 that ended with the humiliation of India's underprepared army, China and India have managed an uneasy but viable modus vivendi on their common border for nearly half a century. No shots have been fired in anger since 1976, and both countries tend to downplay each other's troop movements, citing "differing perceptions" as to where the LAC - which has never been officially demarcated - actually lies.

Owing to these fraught conditions, an estimated 400 faceoffs occur each year along the LAC, all of which are quickly defused. But this time is different. Chinese troops have reportedly advanced into territories that China itself traditionally considers to be on the Indian side of the divide. And rather than merely patrolling, they have established a fixed presence (with pitched tents, concrete structures. and several miles of road) well beyond China's own "Claim Line," occupying the "Finger Heights" near Pangong Tso Lake.

Obviously, these encroachments have met with resistance. Last month alone, there were two physical clashes between Indian and Chinese soldiers, with brawls resulting in dozens of injuries on both sides. Though the two armies had a similar standoff on Bhutan's Doklam Plateau in 2017, that was in a third country. This time, India has every reason to interpret China's incursion as direct aggression.

True, the Doklam standoff ended with a Chinese climbdown, as did a similar episode in the same part of Ladakh during Chinese President Xi Jinping's first visit to India in 2014. But the China of 2020 more assertive, and eager to throw its weight around in a new era of Sino-American "decoupling." It will be less inclined to withdraw unilaterally this time. Still, the world is taking notice. Recent statements by US Secretary of State Mike Pompeo and Russia both expressed growing concern,



despite Chinese officials' statement that the situation is "overall stable and controllable."

But the problem is not that China is planning an all-out war or a major military campaign. Rather, it is using "salami tactics": minor military incursions that inflict small-scale military setbacks on India. Most likely, the Chinese will occupy a few square kilometers of territory for "defensive" purposes, and then declare peace. This approach is nothing new, and it poses a test of India's resolve.

Because India's government cannot afford to take China's latest aggression lying down, it is reportedly already preparing for a long standoff. Indian Prime Minister Narendra Modi's nationalist "strongman" regime, especially, cannot risk losing face before India's easily inflamed public. But even under a different government, India would have a strong interest in proving to would-be aggressors – not least Pakistan – that it is no pushover.

To be sure, China may argue that it was provoked by India's infrastructure construction along the LAC. But these projects are long overdue. Two summers ago, the Indian parliament's External Affairs Committee (which I chaired at the time) visited the border areas and found the infrastructure there to be woefully inadequate. China, meanwhile, has been building allweather roads, railway lines, and even airports on its side of the LAC. It also boasts conventional military superiority over India, both in the LAC area and overall; but India has shorter supply lines to maintain in the mountainous terrain.

The India-China relationship is nothing if not complicated. The wounds of the 1962 war never healed, yet annual bilateral trade has grown to almost \$100 billion, albeit overwhelmingly in China's favor. Moreover, China uses its alliance with Pakistan to needle, distract, and confine India within its own sub-region. The China-Pakistan Economic Corridor, one of the crown jewels of Xi's Belt and Road Initiative, runs through portions

of Pakistan-occupied Kashmir that even China acknowledges as disputed territory

China also continues to reiterate its claims to Indian territory directly, particularly the northeastern state of Arunachal Pradesh, which it describes as "South Tibet." Against this backdrop, episodes like the current standoff should be understood as part of a larger strategy of keeping India in check.

Indian foreign-policy analysts understand this, warning that, because the latest act of Chinese belligerence clearly marks a shift in the longstanding status quo at the border, it augurs the end of China's self-proclaimed "peaceful rise." Under Xi, China seems much more willing to demonstrate openly that it is the region's preponderant power. By taking a tough stand on the Indian border, China hopes to show the world, especially the United States, that it is not intimidated by Donald Trump's bluster, and that other Asian countries should fall into line.

For now, Indian officials have announced that high-level military talks with China have produced an agreement that the two sides will "peacefully resolve the situation in the border areas in accordance with various bilateral agreements." But, as the standoff has made clear, each side has a very different understanding of what those bilateral agreements mean. It remains to be seen whether China will actually withdraw its troops from the disputed areas. The devil, as always, is in the details.

Clearly, India and China need to finalize a permanent border agreement. China has long argued that a formal border settlement is best left to future generations, but that is because its geopolitical power – and therefore its negotiating position – grows stronger with each passing year. China is betting that the longer a settlement is deferred, the more likely it is to get the border it wants. In the meantime, it will use limited acts of aggression along the LAC to keep India off balance.

## An inflection point

he brutal killing of 20 Indian soldiers by the Chinese Army in the deadliest escalation of violence between India and China on the LAC in nearly four and half decades puts a heavy question mark on an already fraught process. It has the potential to vitiate and undermine the disengagement agreed upon only a few days ago between senior military officers on both sides and harden the standoff between the two countries. The provocation is grave — this is not the toll taken by an act of terror by a non-state actor, but a clash between two armies. Yet India must keep a clear and determined head. It needs to respond with calm deliberation and steely resolve. It must be fully prepared to escalate but it must not embark on such a course without a full assessment of what transpired on the ground, or without hearing out what the Chinese leadership has to say — and being mindful of what lies ahead.

When two armies are fully mobilised and standing eyeball to eyeball, there is always the possibility of an accident that triggers an escalation that neither side wants. Monday night's clashes came after both sides had publicly stated that the situation was under control and that disengagement had begun in the Galwan area. The Chinese Ministry of Foreign Affairs has accused the Indian Army of violating the consensus that the two sides arrived at, and New Delhi has accused Beijing of doing the same. Clearly, much is being lost in translation even as Chinese adventurism breaches the understanding underlined in several meetings between Prime Minister Narendra Modi and Chinese President Xi Jinping. New Delhi should activate all political lines of communication with Beijing, including the ones between the special representatives to the border negotiations and the foreign ministers, to make this point and take it forward.

Many in Delhi have been lulled into complacency by previous diplomatic successes in defusing military crises in Depsang (2013), Chumar (2014) and Doklam (2017). But Delhi can't ignore the profound change in Beijing's worldview and the new sense in Beijing that it can afford to take on all comers. Nor can Delhi turn a blind eye to President Xi Jinping's political swagger, China's growing assertiveness in the territorial disputes with its neighbours, its simmering Cold War with the United States, and the PLA's aggressive postures on the ground. In other words, India's political illusions about China are becoming increasingly unsustainable and Delhi has arrived at an inflection point in its policies toward Beijing. China, on its part, would be unwise to underestimate India's political resolve, its capacity to come together amid a national crisis and the international coalition in its favour. If Beijing refuses to restore the status quo ante on the frontiers, it will push India irrevocably towards a comprehensive and long-term political, diplomatic and military strategy of responding purposefully.

## 'I Lived Death At The Door of Hell': Kashmir's Chilling COVID Chronicles

HROUGHOUT his stay in a woeful ward, a young father from Baramulla craved to touch his toddler's warm fingers with his trembling hands. On his possible deathbed, he wanted to see his home, "one last time", before the virus could choke him to death and sent his boxed body for a hushhush burial

Ever since he "came out alive" from the hospital ward where he saw his fellow COVID patient dying a lonely and miserable death, Shabir Khan (not his real name) has taken to secluded gardening. His family members say their 35-year-old headman has grown quiet and thoughtful after having a near-death viral encounter.

Today, Khan restlessly talks about his state of numbness and hopelessness in the hospital ward. "That feeling somewhat explains the uncertainty of life and death when this coronavirus infects you," Khan says in a low voice.

Since March this year, when the first COVID-19 positive case was detected in Kashmir, the virus has unleashed new horrors in the society: Some it killed, some it spared, many it scared.

While administration is still trying to figure out ways and means to address this novel situation, and medical professionals try to figure out how to stop it, it has already killed more than 60 persons in Jammu and Kashmir.

Despite a decent recovery rate, it equally has an alarming death rate.

"It seems like COVID is the only killer, as our hospitals have no place for cancer and other fatal diseases," Khan says. "God forbid, if anyone catches an infection or a disease, it is only your good deeds that can save you!"

But as the valley has already lost many people in the COVID combat, many survivors share their moving journeys from their positive to negative test and trial.

#### Case 1: 'I Wanted To See Birds'

They came suddenly one day to take me away when my mother was tested positive. By then, I had shown what they now call COVID symptoms.

I thought I had just developed this constant cold after eating an ice-cream. I confused my cold and running nose with my poor immunity. So, yes, I was just hoping against the hope.

#### But eventually, they said it.

After tested positive for this vicious virus, I felt like world blurring from my eyesight. Constant coughing and burning lungs made me restless.

In the hospital, I would feel like dying alone.

Nights haunted me more. I had no comforting company of my mother around me. She was herself lying in serious condition!

Even in that distress hour, where I was staring at my possible end, I wanted to go out and watch birds. I wanted to see them fly and free.

Only a captive can value the true meaning of freedom

#### Case 2: 'I Was at the Door of Hell'

After losing my husband to cancer and son to abroad, I live alone. I hadn't stepped much out of home since the time pandemic lockdown was announced. I would only go out to buy groceries.

One fine day, when I went out to buy essentials, I was exposed to a lot of people on street. That evening, I

felt like inhaling more oxygen than I usually do. A quick test followed and I was declared COVID positive. On the third night in the hospital, I saw myself

standing at the door of hell, mourning in pain. It was a terrifying nightmare. I didn't want to die

After that night, I became more faithful and fun-loving — entertaining COVID-depressed souls in the ward. Sharing, caring and storytelling felt like a healing.

But at the same time, being COVID positive was no fun. There were days when I couldn't stop coughing. I was

running out of breath. My vision turned blurry at days. I couldn't even swallow anything. It was a terrible time. You understand life when you are an iota close of death.

#### Case 3: 'I Felt An Excruciating Pain'

Burning joints, pounding headache and numbness made me feel like a living corpse in that COVID ward. Pain was excruciating, so was this feeling of dying alone in that apathetic space.

They keep a tab on your vital signs from distance there. Then, one day, one of them came and told me that my body wasn't absorbing the right level of oxygen. My lung power was falling, so was the hope of coming alive from that ward.

It's terrifying to be in that situation. All of a sudden, you wondered about the futility of your dreams, goals and life plans. Nothing made sense.

I was looking forward to this summer to attend my niece's wedding. But then, who knew that I would instead be fighting for my own life in that horror ward, where you're being dumped as some filthy person.

Case 4: 'You Do Not Want To Catch This!'

After nursing COVID symptoms for 10 days, I

suddenly fainted one day, and vomited. I had to call for help and was under observation for one night. The long feared news finally came and sent me packing to a COVID-designated hospital.

Soon as I breathed heavy, they put a device in my mouth. I started to panic. I had this sense of drowning and dying. I thought of my young kids and how they would be managing at my relative's place. I imagined myself falling from a cliff and going down in an abyss. You develop that sort of mindset when you realise that you are up against a formidable enemy-who was slowly leaving you breathless.

Some days after, my situation started to improve. I moved on to another ward with four others.

After a few days, I was one of the lucky ones who made it through. I came home, but trust me, you do not want to catch this!

#### Case 5: 'I Lived Death'

I woke up one morning gasping for air, feeling that I was having a heart attack. An initial coronavirus test came back negative. But when the symptoms worsened, I got tested again. This time the results were positive.

In a ward full of COVID patients, I struggled with fever and heavy breathing. It felt like something was stuck there and not coming out.

Nights were more tormenting. I did not go to sleep for three days because I was scared that I wouldn't wake up.

I lived death and that too when there was hardly anyone to console you.

Yet I made it alive from the hospital, where I saw the virus consuming a poor patient.



# Pandemic's Impact On Adolescents

ovid-19 has undeniably upended life as we knew it, redefining what normal is. But the disruption brought on by the pandemic has dealt a heavier blow to teenagers. With educational institutions still closed and extracurricular activities at a standstill, young adults have lost out on their main avenue of human interaction and socialisation schools and universities.

"This can result in a feeling of boredom, social isolation, helplessness and even fear of exclusion from social connections," says Tanya Dharamshi, clinical director and counselling psychologist at Priory Wellbeing Centre, Dubai, who has seen a marked increase in anxiety, depression and OCD in teenagers since schooling went online. She suggests some tips families can follow at home to help their teenagers manage thoughts and emotions.

### 1. Develop a "worry box"

Get your kids to write down their worries about exams, missing their friends, loneliness, college placements. Writing feelings down will help them process it and discuss them with parents. Reassure them verbally, emotionally and physically; even the most independent and grown-up teens need a hug.

### 2. Lead by example

Children, no matter their age, look up to their parents as role models and mirror your calm and confident demeanour. But do normalise being vulnerable and acknowledge how the current situation is worrying for you as well so they know they're not alone.

### 3. Limit screen time

There is real potential for some teenagers to be addicted to their electronic devices and isolate from family and friends. Prevent that by scheduling time for digital learning, slots for communication with friends and time for accessing the news, so they're not overwhelmed by grim news reports and neverending statistics that can also exacerbate anxiety.

### 4. Count the positives

Missing out on important events to mark milestones, such as graduations, sports meets and fare-



wells, can exacerbate emotions of anger and disappointment. It's important to redirect their attention to what they can do. Point out how there's now time to bond with siblings and family members, rewatch their favourite movies, or even learn a new instrument or language

### 5. Don't predict the future

Trying to foresee what's in store in terms of internships, job opportunities and university admissions can make them feel anxious and being left in limbo. Instead guide them to prepare for the next part of their future by reading books for their upcoming academic year or university course, learning to touch type, doing fund raising or volunteer work to enhance CVs, etc.

### 6. Nurture friendships

Peer interaction shapes a teen's identity and beliefs and equips them with skills such as reading body language and non-verbal cues, how to react in

a variety of situations - all vital stepping stones into adulthood.

So it's critical their communication with friends now is over the phone or video chat instead of just texting, so that they can also hear changes in voice and see facial expressions.

### 7. Go outdoors

Encourage them to step out of the house daily. Running errands lets them interact with people other than family, which will hone their social skills, instil a sense of independence, make them feel valued and stop them from withdrawing into themselves. Also, outdoor exercise releases feel-good chemicals in our brain, such as endorphins and serotonin, which can reduce stress and symptoms of depression and anxiety.

### 8. Keep routines intact

Try and continue rituals such as sit-down family dinners, at least one meal per day. It's a chance to chat about what's on their mind and check-in on teens who spend a lot of time studying alone in their rooms

# 87 % Indian Adults Believe Online Gaming Affects Well-Being: Survey

EW DELHI: About 87 per cent adults in Indian cities believe that online gaming takes a toll on their physical and mental well-being, showed a survey on Tuesday.

About 76 per cent of respondents feel that addiction to action games lead to changed behaviour and can increase depression and anxiety levels, according to the "India Digital Wellness Report" by consumer cybersecurity brand NortonLifeLock.

Nearly 70 per cent of respondents feel that children connecting with strangers while playing games online can lead to cyberbullying, harassment, and violence. The findings are based on an online survey of over 1,500 city-based Indian adults.

"People could be drawn to online gaming for entertainment, but data shows that it is not all about fun and games. The virtual playing field comes with risks such as identity theft, cyber bullying, phishing, and credit card theft, to name a few," Ritesh Chopra, Director, NortonLifeLock, India, said in a statement.

Two of every three respondents said they prefer playing online games to going outdoors or having social interactions.

Almost 73 per cent of the parents in the survey said that their children prefer shooting and adventure games, while 21 per cent said that their children show a preference for casino and card games.

There is a sense of growing concern among parents as 45 per cent of respondents said they find it difficult to control their children's smartphone usage.

Interestingly, 81 per cent of the respondents who put a check mechanism on children's usage of smartphones feel they have not been effective in controlling the gaming time.

The children of 42 per cent of these respondents played games online for more than two hours every day. However, online gaming seems to have some posi-

tive impact, too, on users. About 81 per cent of respondents feel that multiplay-

er online games enhance teamwork skills, while 70 per

cent of respondents feel that playing online games can make people smarter, as they improve brain coordination and reaction.

The online gaming space, largely perceived to be male dominated, seems to have a lot of female takers, the results showed.

About 88 per cent of female respondents find online games to be the best pastime as compared to 86 per cent of their male counterparts.

The study also showed that when it comes to mobile gaming, children and parents tend to have a shared behaviour -- six in every 10 respondents said that they and their children spend roughly the same amount of time playing games online.

ondon: While facial masks reduce the spread of COVID-19, their filtering efficiency is adversely affected by repeated coughing, according to a new study which recommends complete personal protective equipment for healthcare workers including helmets with built-in air filters, and face shields.

Scientists, including Talib Dbouk and Dimitris Drikakis from the University of Nicosia in Cyprus, used computer models to map out the expected flow patterns of small droplets released when a mask-wearing person coughs repeatedly.

Earlier computer simulations the researchers showed that droplets of saliva can travel 18 feet in five seconds when an unmasked person coughs.

In the current study, published in the journal Physics of Fluids, they used an extended model to consider the effect of multiple cycles of coughing on the filtering efficiency of face masks.

According to the study, while masks can reduce the spread of airborne droplets, their effectiveness is ad-

versely affected by repeated coughing, as might happen when an individual is ill.

The scientists added that the use of a mask does not provide complete protection, and social distancing remains important during a pandemic.

In the analysis, the researchers modelled a sequence of coughs by applying several cycles of forward-directed velocity pulses to the initial droplets.

They then performed numerical simulations to account for droplet interactions with the porous filter in a surgical mask.

According to the scientists, even when a mask is worn, some droplets can travel a considerable distance, up to one metre, during bouts of mild coughing. Without a mask, they said droplets

travel twice as far, adding that wearing a mask will help.

While masks also decrease the number of droplets leaking out the sides of the mouth, they fail to eliminate this entirely, the researchers said.

"The droplet sizes change and fluctuate continuously during cough cycles as a result of several interactions with



the mask and face," said Drikakis.

"Masks decrease the droplet accumulation during repeated cough cycles. However, it remains unclear whether large droplets or small ones are more infectious," Dbouk explained.

Based on the results, the researchers recommended much more complete personal protective equipment for healthcare workers, including helmets with built-in air filters, face shields, disposable gowns, and double sets of gloves.

They also urged manufacturers and regulatory authorities to consider new criteria for assessing mask performance which account for flow physics and cough dynamics. portant factor linking the division of household labour to satisfaction in the relationship. ## Being happy can protect you from gastrointestinal distress

EW YORK: Researchers have found that Serotonin, a chemical known for encouraging happiness and well-being, can reduce the ability of some intestinal pathogens to cause deadly infections.

The findings, publishing in the journal Cell Host & Microbe, could offer a new way to fight infections for which few truly effective treatments currently exist.

"Although the vast majority of research on serotonin has centred on its effects in the brain, about 90 per cent of this neurotransmitter - a chemical that nerve cells use to communicate with each other - is produced in the gastrointestinal tract, study lead author Vanessa Sperandio from UT Southwestern Medical Centre in the US, explained.

In humans, trillions of bacteria live within this space. Most of these gut bacteria are beneficial, but pathogenic bacteria can also colonize the gastrointestinal tract, causing serious and potentially fatal infections.

Because gut bacteria are signif-

icantly affected by their environment, the research team wondered whether the serotonin produced in the gut can affect the virulence of pathogenic bacteria that infect the gastrointestinal tract.

They worked with Escherichia coli O157, a species of bacteria that causes periodic outbreaks of often deadly foodborne infection. The team grew these pathogenic bacteria in Petri dishes in the lab, then exposed them to serotonin.

Gene expression tests showed that serotonin significantly reduced the expression of a group of genes that these bacteria use to cause infections.

Additional experiments using human cells showed that the bacteria could no longer cause infection-associated lesions on the cells if these bacteria were exposed to serotonin. Next, the researchers examined how serotonin affected virulence in living hosts.

Using mice, the researchers studied how serotonin might change the ability for Citrobacter rodentium - a mouse gut bacterium often used as an analog for E. coli in humans - to infect and sicken their hosts.

## **CIA Unit That Crafts** Hacking Tools Didn't **Protect Itself**

Washington: A specialised CIA unit that developed sophisticated hacking tools and cyber weapons didn't do enough to protect its own operations and wasn't prepared to adequately respond when the secrets were stolen, according to an internal report prepared after the worst data loss in the intelligence agency's history.

'These shortcomings were emblematic of a culture that evolved over years that too often prioritised creativity and collaboration at the expense of security," according to the report, which raises questions about cybersecurity practices inside U.S. intelligence agencies.

Sen. Ron Wyden, D-Ore., a senior member of the Senate Intelligence Committee, obtained the redacted report from the Justice Department after it was introduced as evidence in a court case this year involving the stolen CIA hacking tools.

He released it on Tuesday along with a letter he wrote to new national intelligence director John Ratcliffe, asking him to explain what steps he's taking to protect the nation's secrets held by federal intelligence agencies.

The October 2017 report,

### whose findings were first reported by The Washington Post, examined the theft one year earlier of sensitive cyber tools the CIA had developed to hack into the networks of ad-

versaries. The document is dated months after WikiLeaks announced that it had acquired tools created by the CIA's specialized Center for Cyber Intelligence.

The anti-secrecy website published comprehensive descriptions of 35 tools, including internal CIA documents associated with them, according to the report

The report describes the spring 2016 theft as the largest data loss in agency history compromising at least 180 gigabytes to as much as 34 terabytes of information, or the equivalent of 11.6 million to 2.2 billion pages in Microsoft Word.

The agency did not realize the loss had occurred until the WikiLeaks announcement a year later, the report said.

As officials scrambled to pinpoint who was responsible, they ultimately identified as a prime suspect a CIA software engineer who they said had left the agency on stormy terms after falling out with colleagues and supervisors and had acted out of revenge.

ndia is expected to regis- nicated, namely, Mexico. ter a comfortable victory in the Security Council elections on Wednesday that will bring the country to the UN high-table as a non-permanent member for the 2021-22 term.

193-member UN The General Assembly will hold elections for President of the 75th session of the Assembly, five non-permanent members of the Security Council and members of the Economic and Social Council under special voting arrangements put in place at the UN headquarters due to COV-ID-19 related restrictions.

India is all set to join the powerful 15-nation Security Council as a non-permanent

member. India is a candidate for a non-permanent seat from the Asia-Pacific category for the 2021-22 term.

India"s victory is certain since it is the sole candidate vying for the lone seat from the grouping. New Delhi''s candidature was unanimously endorsed by the 55-member Asia-Pacific grouping, including China and Pakistan, in June last year.

President of the UN General Assembly Tijjani Muhammad-Bande on Monday circulated a letter to member states with the names of candidates for the various elections. For the two vacant seats from among the African and Asia-Pacific States, three candidates have been communicated, namely, Djibouti. India and Kenva.

Of those three candidates, India and Kenya are endorsed candidates. For the one vacant seat from among the Latin American and Caribbean States, one endorsed candidate has been commuahead of the elections.

For the two vacant seats from among the Western European and other States, three candidates have been namely, communicated, Canada, Ireland and Norway.

Each year the General Assembly elects five non-permanent members (out of 10 in total) for a two-year term.
