'India's Enemies Have Seen Fire And Fury Of Its Armed Forces'

LEH/NEW DELHI: In a clear message to China, Prime Minister Narendra Modi on Friday said the era of expansionism is over and that India's enemies have seen the "fire and fury" of its armed forces as he made an unannounced visit to Ladakh, signaling India's firmness in dealing with the border row with the neighbouring country.

In an address to troops, Modi paid glowing tributes to the 20 Indian soldiers killed in the Galwan Valley clashes, and said tales of the bravery and valour of the armed forces are echoing in every part of the country.

Covid-19: NEET, JEE Exams Put Off Till Sept

NEW DELHI: The HRD Ministry on Friday postponed crucial medical and engineering entrance exams NEET and JEE to September in view of the spike in COVID-19 cases.

The decision was taken following recommendations of a fourmember committee set up to review the feasibility of conducting the exams in July.

"Keeping in mind the safety of students and to ensure quality education we have decided to postpone JEE and NEET examinations. JEE-Main examination will be held between September 1-6, while JEE-advanced exam will be held on September 27. NEET examination will be held on September 13," said Union HRD Minister Ramesh Pokhriyal 'Nihank'.

Following the announcement of a nationwide lockdown to contain the spread of the novel coronavirus, the competitive exams for engineering and medical admissions were first postponed on May 5.

The medical entrance exam National Eligibility-cum-Entrance Test (NEET) was scheduled for July 26, while the Joint Entrance Exam (JEE)-Mains for admission to engineering colleges was to be held from July 18-23.

JEE-Advanced, which is conducted for admission to Indian Institutes of Technology (IITs), was earlier scheduled for • P-02

India Lodges Protest With Pak Over **Ceasefire Violations**

NEW DELHI: India has lodged a strong protest with Pakistan over "unprovoked ceasefire violations" by Pakistani forces along the Line of Control and the International Border with an aim to push militants into Jammu and Kashmir, official sources said on Friday.

They said 14 Indians have been killed and 88 sustained injuries in more than 2,432 incidents of ceasefire violations carried out by Pakistani forces till June this year.

The ceasefire violations are in contravention of the 2003 ceasefire understanding between the two countries, the sources said.

They said India has also conveyed its "strong concerns" at the continued support being extended by the Pakistani forces to cross border infiltration of militants, including by providing covering fire.

with personnel from the Army, Indian Air Force and the ITBP in Nimu. Located at 11,000 feet, Nimu is among the toughest terrains, on the banks of river Indus and surrounded by the Zanskar range. In the afternoon, Modi visited a military hospital in Leh where he interacted with soldiers, who were injured in the Galwan Valley clashes and are undergoing treatment.

"Whether during the world wars or peace, the world has seen the victory of our brave soldiers and their efforts towards peace," Modi said in his address.

During his visit, the prime minister also said that in the last few years, several steps have been taken for the wellbeing of India's armed forces and to further strengthen India's security preparedness.

This includes ensuring availability of modern weaponry, increased border infrastructure, border area development and expanding the roads network, he said, and added that expenditure on border infrastructure has been enhanced three times.

The Indian and Chinese armies are locked in a bitter standoff in multiple locations in eastern Ladakh for the last seven weeks. The tension escalated manifold after 20 Indian soldiers were killed in a violent clash in Galwan Valley on June 15. The Chinese side also suffered casualties but it is yet to give out the details.

The prime minister also spoke at length about how the virtues of peace, friendship and courage have been a part of India's culture since time immemorial.

He recalled that India has always given a befitting reply to anyone who has tried to disturb the prevailing atmosphere of peace and progress

He affirmed that India is committed to peace and friendship but this commitment to peace should not be seen as India's weakness.

Today India is becoming stronger, be it in naval might, air power, space power and the strength of our army, he said, adding modernisation of weapons and upgradation of infrastructure has enhanced the country's defence capabilities multifold.

He also said that the government is putting adequate focus on the requirements of armed forces.

In his address, Modi remembered all the "proud sons of Mother India" who made the supreme sacrifice at the Galwan Valley, adding those who were martyred belong to all parts of the country and "epitomised our land's ethos of bravery".

He affirmed that be it Leh-Ladakh, Kargil or the Siachen Glacier, be it the high mountains or the icy cold water that flows in the rivers, these are testimony to the gallantry of India's Armed Forces.

Recalling the greatness of Ladakh's culture as well as the noble teachings of Kushok Bakula Rimpoche, the prime minister described Ladakh as a land of sacrifice and a land that has given several patriots. Modi affirmed that the people of India are inspired by the teachings India and international travel is still restricted due to the coronavirus pandemic

Around nine lakh aspirants have registered for the JEE (main) exam, while 16 lakhs have registered for the NEET-Undergraduate exams. Raising concern over the worsening of the pandemic, candidates across the country have been demanding the postponement of the exams

According to HRD Ministry officials, the committee felt that delaying the exams was inevitable since many test centres were located in containment zones and safety of the students was top priority of the government.

The cases detected on Friday included 57 people who had returned to I&K recently.

Besides it, 10 personnel from 108 RCC Trehgam in Kupwara, four CRPF troopers, a policeman from District Police Lines Baramulla and two babies and a doctor also tested positive for coronavirus today. The number of confirmed cases has now reached 8,019 out of which 6,327 are in Kashmir, while 1,692 are in Jammu, the officials said. There are 2,825 active cases of the coronavirus disease in J&K – 2,401 in Kashmir and 424 in Jammu – and 5,075 (3,821 from Kashmir and 1,254 from Jammu) patients have recovered, according to officials.

The J&K has witnessed 119 Covid-19 deaths (105 from Kashmir, 14 from Jammu) so far.

"Of them five are from Hizb, 3 from LeT and other four from Jaish-e-Muhammad," he said.

"I have always told you if there's no encounter in any districts, it doesn't mean that there are no militants there. Militants are being killed before they can establish their base in Srinagar," the IGP said, while replying to a query by a journalist.

Meanwhile, a police spokesperson in a handout issued here today said that keeping in view the prevailing pandemic due to COVID-19 and to ensure the safety of people from inherent risk of contracting the infection, the body of ISJK commander has been sent to Handwara for his burial & last rites after completion of medico-legal formalities.

"The nearest family members of the militant were allowed to participate in the last rites at Handwara," he said.

The police spokesperson also said that incriminating material including arms and ammunition were recovered from the site of encounter.

Advocate Jehangir Iqbal Ganai, senior counsel, for the petitioners had submitted that the instant matter does not fall within the purview of sub-section (1) of Section 14, but is covered by sub-section (3) thereof, which exclusively refers to 'any local or other authority or corporation or society'.

However, he had submitted that the provision of sub-section (3) does not have an automatic application to local or other authorities or corporations or societies, but this provision is to be applied by the Central Government by notification.

"It is not that the Central Government has not issued any notification in exercise of the powers under sub-section 2 of Section 14 of the Act applying the provision of sub-section (3), "the court observed, "adding, " Certain documents / notifications issued by the Central Government, from time to time, in exercise of such power under subsection (2) of Section 14 have been placed before the Court which depict that so far nearly 214 organizations, by their name, have been brought under the purview of sub-section (3) of Section 14 of the CAT Act; the J&K Bank, in any case, is not one amongst them." (GNS)

3 Kashmiri women among 1,000 nominated for Nobel prize

SRINAGAR - Three prominent Kashmiri women are among 91 nominated from India for this year's Nobel Peace Prize. They figure in the list of 1000 women from all over the world for the coveted nomination. According to reports, the three Kashmiris who had made to lie crucial stage are Parveena Ahanger, Nighat Shafi Pandit and Dilafroza Qazi. They have made a mark in various fields of social service and empowerment of women and children.

Parveena Ahanger,48 is an extraordinary women who has been living with the trauma of the custodial disappearance of her son. Over the past over a decade, she has become rallying force for similarly circumstanced women and eventually formed an organization by the name of Association of Parents of Displaced Persons to fight the pernicious human rights abuse. In her relentless crusade against injustice, she braves physical danger to her own life and remains

undeterred by the perils that go with it. Ahanger has been instrumental in building up social pressure against the government

which was initially clueless as the exact number of those disappearing from custody. As a result of untiring efforts of APDP, the authorities finally acknowledged more than 3000 custodial disappearances and held out an assurance to call a halt to these. Having risen above her personal trauma, Ahanger is now a prominent human rights activist in Kashmir.

Born in 1951, Nighal Shafi Pandit is the chairperson of a leading non-governmental organization. Human Effort for Love and Peace (HELP) Foundation, established in 1997 with the primary objective of organizing a social response to the growing destitution with parrticular emphasis on the education and healthcare of orphans, it prefers to call special children' and rehabilitation of widows and other indigent members of the society irrespective of their creed, colour, community or region ...,

Wife of a senior IAS officer and the chairman of Public Service Commission. Muhammad Shaft Pandit, she preferred to step out of the comfortable home to move about extensively in the rural communities in both Kashmir and Jammu regions with a view to making a difference in the lives of its targeted segments. Nighal Shafi is more, focused on the education of orphans and rehabilitation of widows and leaves no occasion to share their pain and distress. She is actively involved in the promotion of peace and harmony in the insurgency-hit region.

Dilafroz Qazi is yet another Kashmiri woman who is engagned in promotion of literacy among rural folks. Born in 1972, she runs an engineering college known as SSM college of engineer ing near the highway town of Pattan. She is also running several primary schools.

Antifa: Will It Come To India?

he recent black protests in the United States have brought another player on the scene and media agenda. This is Antifa, which has been blamed as spearheading the protests in the US and several other

European countries. Now, what is Antifa? Simple enough, it is a short form of anti-fascists. Unsubstantiated historical evidence shows that Antifa is, in fact, highly networked, well funded and has a global presence. It has a flat organisational structure with dozens and possibly hundreds of local groups

Antifa professes to establish a communist world order. And in the United States, Antifa's immediate goal is to bring about the demise of the Trump administration.

Security experts claim that Antifa in the United States and Europe employs extreme violence and destruction of public and private property to prod the police into a reaction, which subsequently demonstrates Antifa's claim that the government is 'fascist.'

On the other hand, some European governments use it for their own purposes also. Bettina Röhl, a German journalist, writing for Neue Zürcher Zeitung (New Zurich Newspaper, a Swiss-German newspaper published from Zurich, Germany) claims that Antifa is not only officially tolerated, but is being paid by the German government to fight the far right. She further asserts that out of cowardice, its members cover their

faces and keep their names secret. Antifa constantly threatens violence and attacks politicians and police officers. It promotes senseless damage to property amounting to vast sums.

Recently, U.S. Attorney General William Barr has blamed Antifa -- as a militant movement — for the violence that has erupted at George Floyd protests across the United States. "The violence instigated and carried out by Antifa and other similar groups in connection with the rioting is domestic terrorism and will be treated accordingly," he said. Earlier, U.S. President Donald J. Trump had instructed the U.S. Justice Department to designate Antifa as a terrorist organisation.

The media outlets, analysts and academics sympathetic to Antifa argue that the group cannot be classified as a terrorist organisation as they say it is a vaguely defined protest movement that lacks a centralised command or organisational structure. Thus, according to them, it is a spontaneous response of the people, which happens when something out of the ordinary against the liberties of the people takes place. Mark Bray, an Antifa supporter in America and author of the book Antifa: The Anti-Fascist Handbook, asserts that Antifa "is not an overarching organization with a chain of command."

What is Antifa's ideology?

In simpler terms, Antifa can be described as a trans-national rebellious movement that endeavours, often with extreme violence, to subvert liberal democracy, with the aim of replacing global capitalism with communism. Antifa's stated long-term objective, both in America and abroad, is to establish a communist world order. In the United States. Antifa's immediate aim is to bring about the demise of the Trump administration.

Antifa claims to oppose 'fascism', a term it often uses as a widely critical or judgmental to discredit those who hold opposing political beliefs to it. The traditional meaning of 'fascism' as defined by Webster's Dictionary is 'a totalitarian governmental system led by a dictator and emphasising an aggressive nationalism, militarism, and often racism.'

Antifa started off in Germany and spread to other countries like Slovenia, Spain, Italy, France and the UK. However, after the fall of the East Germany it was discovered that the erstwhile state secret police Stassi used the Antifa in its fight against the far-right elements in Germany.

Now, this leads us to wonder whether the evolving situation in India, fulfils the Webster's definition or not? The protests, which shook the country beginning in November 2019, have been dubbed variously, but remember most of the protests across India were spontaneous and headless; they survived completely on the support of the common populace and students.

So, will it be possible for any move-

ment like Antifa to emerge in India? Doubts are expressed regarding such a scenario but the evolving conditions might lead to such a risk.

If we have to stop the emergence of an Indian Antifa, then the political powers that be need to engage more with people with sincerity and with concrete action taken to show sincerity and commitment to the people's welfare.

Recent events of the past have shown that the public is fast losing its trust in the government and its policies, as most of them are considered as antipeople, particularly the poor people.

In the current scenario, the government has to show more empathy to the common man on the street and win their trust and heart, if it wants to be seen as pro-people. Change of strategy to handle the prevailing Covid pandemic might give it a fair chance to project itself as pro-people and committed to the countrv's progress, making decisions that are in best of interest of all, particularly the common man. Otherwise, the day is not far off when it may have to deal with the Indian Antifa.

The China-India-Pakistan Triangle Origins, Contemporary Perceptions, and Future

ven as India and China find themselves embroiled in yet another border standoff at the Line of Actual Control (LAC), commentators have sounded alarm on how Pakistan could seek to utilize the situation. Concurrently, some have observed that China's transgression at the border is likely to push New Delhi closer to Washington, at a time when Sino-U.S. tensions are running high. A dvadic understanding of the security environment in Southern Asia, either through an India-Pakistan or India-China lens, is thus incomplete and does not account for the triangular dynamics that shape these interactions. To understand regional dynamics, it is critical to understand the India-Pakistan-China triangle and how it is impacted by the strategic chain, including the United States. The contemporary reality of these dynamics is grounded in an early Cold War history, and potential conflict scenarios involving these countries animate the geopolitics of Southern Asia.

A Triangle Made in History

The India-Pakistan-China triangle is mired in a convoluted history of unresolved border disputes, with military confrontations between India and China at the Line of Actual Control (LAC), and India and Pakistan at the Line of Control (LoC) occurring intermittently. In 1947, Britain's hasty withdrawal from the subcontinent as a result of post-war decolonization led to a haphazard redrawing of political boundaries in Southern Asia, leaving some territory contested. The four wars that India and Pakistan have fought since 1947, the Sino-Indian Border War of 1962, and recurrent India-China and India-Pakistan conflicts at the LAC and LoC trace their genesis back to this protracted history. The military dimension of this triangle evolved in the years after the 1962 Sino-Indian Border War, when Beijing and Islamabad signed the border delimitation agreement in 1963. As part of this agreement, Pakistan handed over the Trans-Karakoram tract, a territory in Kashmir that India claimed, to China, turning the dispute into a trilateral one.

Further, during the 1965 India-Pakistan War. Pakistan felt betrayed by a lack of U.S. support, and chose to strengthen relations with China. Pak-

istan had expected the United States to tilt to its side, due to the 1954 U.S.-Pakistan mutual defense agreement and Pakistan's membership in U.S. engineered alliances like the Southeast Asia Treaty Organization and the Central Treaty Organization. However, during and after the 1962 war, the United States showed hitherto unseen willingness to aid and assist India's military against Communist China, making it prudent for China and Pakistan to join hands. Although Washington premised arming both Pakistan and India to achieve its Cold War objective to contain communism in Asia, neither side bought Washington's assurances that its military supplies were not meant to be used against each other. Although China did not provide any direct military help to its new friend Pakistan during the 1965 war, it did engage in a psychological assault against India, repeatedly accusing New Delhi of showing aggression on the India-China border, and threatening Chinese reprisal.

During and after the 1971 India-Pakistan War, the United States tilted towards Pakistan, because it needed Islamabad as a conduit to Beijing during the 1972 Sino-U.S. rapprochement talks. Beginning in 1979, Pakistan played a frontline role for the United States in Afghanistan, in the last Cold War tussle between the United States and Soviet Union. In this context, geopolitics trumped nonproliferation concerns as Washington ignored intelligence that China was helping Pakistan develop a nuclear bomb. These conditions were hardly conducive for a healthy Indo-U.S. relationship, despite efforts at finding convergent points during the Reagan presidency. After the Cold War, the subsequent rise of China as a global power, followed by that of India, shifted dynamics of the India-China dyad, leading to heightened Sino-Indian competition, and tightening Sino-Pakistan military ties. Meanwhile, the India-Pakistan relationship remained volatile, taking an even more sinister turn as cross-border terrorism emanating in Pakistan targeted India, becoming a lingering roadblock to normalizing ties.

Conflict Scenarios

The regional postures of China, India, and Pakistan and the U.S. strategy in Southern Asia intend to maximize interest by capability enhancement,

either through internal or external balancing. This makes the security dilemma in the region more acute and creates the possibility of conflict, some scenarios of which are explored below.

Two-front war

Since India's border disputes with China and Pakistan are still unresolved and Beijing and Islamabad have a close strategic and military partnership, India perceives any conflagration with either Pakistan or China as raising the specter of a two-front war. The Indian military establishment is overt in asserting its recognition of and readiness to face such an eventuality. For example, General Bipin Rawat, currently India's Chief of Defense Staff, while serving as the Indian Army Chief, commented, "The two-front is a real scenario. Much has changed from before in terms of our capabilities... The Army, Navy and IAF are now jointly very much prepared for such an eventuality." India's military preparedness for a two-front war involves developing its overall deterrent capability and credibility, advances in terms of acquisition and production of military equipment, recalibrating its military strategy, relevant training efforts to meet exigencies, and border infrastructure development. Infrastructure building in the border areas and the issue of terrain advantage has been a major source of contention, particularly, as seen in the current clashes between Indian and Chinese forces in eastern Ladakh, or in the earlier Doklam standoff.

While the Indian military establishment understandably projects its readiness, others are more skeptical. The case of Pakistan taking the opportunity of an India-China conflict and opening a second front at the LoC is seen as most probable. Other scenarios include China opening a second front at the LAC or in the Indian Ocean region in the event of an India-Pakistan conflict, or a more sinister case of a pre-planned China-Pakistan military assault against India. Indian Army Chief M M Naravane said earlier this year, "[...]Though it can take place at any level, Siachen and Shaksgam Valley are the places where territory of these two countries meet. Threat of collusivity is maximum in the strategically important glacier which forces us to keep our possession." Talking about identifying a primary and

secondary front in such a scenario, he added, "For years, we have been focusing on western border on the basis of threats. Now, we have to rebalance our deployment towards northern sector." Irrespective of how probable such a scenario is, the perception of such a threat is likely to dictate both the reality and signalling of India's military preparedness.

Conclusion

The India-Pakistan-China triangle is determined by relative national power and mutual threat perceptions, further complicated by the regional implications of the growing confrontation between the United States and China. Pakistan remains the most steadfast ally of China in India's neighborhood, while India remains the only country in the region that comes closest to competing with growing Chinese influence. The power asymmetry between India and Pakistan in the former's favor, and the growing power imbalance between India and China in the latter's favor will continue to reinforce the inherent security dilemma of the triangle, justifying China-Pakistan collusion, in order to checkmate India's rise in the region. Moreover, Chinese perceptions of a U.S. containment strategy that involves India additionally impacts the triangle. The broad mistrust and zero-sum perceptions in the triangle will continue to determine the probability of crises and conflict playing out at the LAC and LoC. Besides the more volatile responses and counter-responses over the disputed borders, differences will simmer at global forums over issues such as counterterrorism and nonproliferation, and over the regional security situation in Afghanistan. Despite attempts at diplomatic maneuvers and confidence building measures to arrest uncontrolled escalation and inadvertent conflict in the triangle, the complex dynamics of the India-Pakistan-China triangle, further reinforced by the role of the United States in the region, make conflict a regular phenomenon that has to be managed, rather than eliminated. Why Risk It? Wear A Face **Mask When Stepping Outside**

One decade ago, medical professionals began suggesting that 'sitting is the new smoking'. Sitting for hours at a time does appear to be somewhat bad for you. But it won't murder you in a matter of days, the way Covid-19 can. We need to follow the lessons from other countries that have successfully brought their coronavirus infection rate down to low levels

wo decades ago, most restau-rants in the US allowed cigarette smoking. If you ate in a smoky restaurant, you probably couldn't taste your food as well as you might like. If you worked in a smoky restaurant, you probably increased your chances of getting lung cancer. Over time, public action took place, especially by seeking health protections for restaurant workers. Now, most restaurants do not allow smoking. The majority of Americans are happy that we don't have smoking in restaurants and other public places now.

One decade ago, medical professionals began suggesting that 'sitting is the new smoking'. Sitting for hours at a time does appear to be somewhat bad for you. But it won't murder you in a matter of days, the way Covid-19 can. We need to follow the lessons from other countries that have successfully brought their coronavirus infection rate down to low levels. The single most effective measure - among many that work best when combined - is simply wearing a face-covering when in public. We need to make wearing a mask when you're in a public place as common as not smoking in restaurants and shops. We need to treat not wearing a mask in public as "the new smoking.

Right now in the US, while Covid-19 is spreading rampantly, when you



walk into a public place not wearing a mask, it is indeed a lot like smoking. You are endangering other people's lives. Would you walk into your local grocery store smoking a cigarette? Of course not. Then, during this pandemic, why would you walk in there without a mask? You genuinely could be infected with coronavirus right now and just not know it because you aren't feeling symptoms yet. Walking into a public place without a mask will spread that virus everywhere, infecting people you know and people you don't know,

democrats and republicans, liberals and conservatives, indiscriminately. This novel coronavirus is not treating this situation as political. And neither should you.

But some Americans are treating this situation as political. A recent study shows that counties with a large number of hyper-conservative news media viewers and listeners are exactly the counties that are refusing to take Covid-19 seriously. These are the counties where local governments are re-opening businesses too fully and too

quickly. These are the counties where a large proportion of the population is refusing to wear face-coverings when they go to populated areas (irrespective of any state or local mandates). And these are the counties where the sheriffs openly refuse to enforce state mandates for reducing the spread.

Other nations have brought down their Covid-19 cases, but America's case count is already rising again. In April, the US imposed measures that flattened the curve but didn't yet bring the curve downward. Then, many local governments removed those measures and fully reopened businesses. That's like the proverbial man with an umbrella in a rainstorm who says to himself, "I'm not getting wet. What do I need this thing for?' So, he closes it up and then is shocked to find himself suddenly getting wet.

When you refuse to wear a mask at work or at the grocery store, you are risking lives.

When we don't take care of one another, and we let our community down, that attitude spreads like a mental virus. We need to cooperate. We can't be fighting amongst ourselves when we need to be fighting as one against a virus that is trying its damnedest to kill us.

The ones who were suffering emotionally before Covid-19 don't share Tommy's silver-lining experience, and most of them are feeling anxious and sad about what they've lost.

Adults know and feel that this crisis is uniquely stressful; it's global, it lasts month after month and no one knows when it will end, which is all mostly incomprehensible for children. A recent British survey of preschool parents found that three-quarters

felt unable to balance work and childcare adequately in lockdown. They worried most about their own work, their children's screen time and their children's overall emotional health. While most children's emotional distress doesn't reach the threshold of requiring mental health intervention, we need to be vigilant about helping, and the earlier the better.

Here are four things that might require closer attention from caregivers and a possible discussion with a childcare provider, especially if they appear in clusters:

Persistent changes in sleep patterns or appetites; Behavioural changes that seem out of character for a particular child, especially discouragement that lingers or motivation that seems to disappear

for longer and longer stretches;

Increases in aggression above and beyond the typical sibling squabbles;

. Frequent tearfulness, especially the out-of-nowhere variety.

Whether or not your child fits into any of those categories, there are strategies we can all use to reduce the negative effects of the pandemic and prevent them from undermining the critical social supports and reassuring rhythms of everyday life, both important developmental building blocks.

Set a routine that you review at the beginning of each day for eating, playing games, and exercising, doing any 'summer school' work (including games), screen time, personal hygiene, quiet time and bedtime.

Don't overdo it by being rigid, and be prepared to abandon your plans for a better schedule as the day evolves. It's starting and finishing together that matter.

. Consciously start your day with the intent to remain calm, and breathe. Parental calm is the best antidote to pandemic stress, and it is often in short supply. It helps children cope and parents to de-stress in the moment. If it's your natural temperament, you're lucky; if it's not, practice and breathe.

When meltdowns come, give your children a moment to collect themselves as you (calmly) join them at eye level and label the feelings they are struggling with as best you can ("You feel frustrated about., angry with or hurt by . and you wish that ."). You're not their therapist; you are their chief 'understander'. When we are heard and understood, we all settle down.

Wedding planners are offering packages for as little as Rs150,000 which include bridal make-up, specially designed e-invites, photography, mehndi (henna), the mandap or wedding pavilion, vegetarian food for 50 guests, DJ music and a decorated car, among others.

The cost is attractive enough to bring tears of relief to any parent's eyes, especially the bride's mum and dad who normally suffer sleepless nights adding up the cost of getting their girl married.

The package also provides for masks of different colours for the bride and groom's side as well as hand sanitation stations.

PPEs will be provided to the members of the band in attendance and caterers and the venue will be thoroughly sanitized just before the event.

The wedding planners say they are able to cut costs because they will use just one photographer and cloth decorations will replace expensive floral décor.

Another major saving is on cost of lighting as most people are opting for daytime functions in view of travel curbs. Make-up and henna artists are willing to offer their services at half the usual price as they, too, have been affected by the lockdown

"That this increase in infectivity was detected by careful observation of sequence data alone. and that our experimental colleagues could confirm it with live virus in such a short time," said Will Fischer from Los Alamos National Laboratory, a co-author author on the study.

Trial of Saudi officials in Khashoggi murder begins in Turkey

Istanbul: The trial in absentia of 20 Saudi suspects accused in the murder of journalist Jamal Khashoggi in 2018, including two former aides to Saudi Crown Prince Mohammed bin Salman, began in Istanbul on Friday.

Khashoggi was an insider-

Hong Kongers Clean Up Their Chat Histories In Face Of Security Law

Hong Kong: Hong Kongers are scrubbing their social media accounts, deleting chat histories and mugging up on cyber privacy as China's newly imposed security law blankets the traditionally outspoken city in fear and selfcensorship.

China's authoritarian lead ers enacted sweeping new powers on Tuesday -- keeping the contents secret until the last minute -- after more than a year of often violent protests in a financial hub increasingly chafing under Beijing's rule.

Certain political views such as wanting independence became outlawed overnight and legal analysts and rights groups warn the broad wording of the law -- which bans subversion, secession, terrorism and colluding with foreign forces -- will choke civil liberties and free speech.

20 Sikh Pilgrims Killed As Train Rams Into Bus In Pakistan's Sheikhupura

Sikh pilgrims returning from Nankana Sahib were killed when the driver of the minibus they were traveling reportedly tried to take a shortcut to avoid a shut railway crossing and rammed the vehicle into a passenger train in Pakistan's Punjab province on Friday, officials said.

The mini-bus carrying around 26 Sikh pilgrims, all from Peshawar, hit the Shah Hussain Express which



was coming from Karachi to Lahore at a crossing near Sheikhupura district at around 1.30 pm, police said. According to Rescue 1122

officials, at least eight people were injured in the accident, all of whom were shifted to District Headquarters Hospital, Sheikhupura, Dawn newspaper reported.

The gate at the crossing was closed and the driver apparently tried to take a shortcut instead of waiting for the gate to open, senior police officer Ghazi Salahuddin told reporters at the crash site.

Delhi Rioters Killed 9 People For Refusing To Shout 'Jai Shri Ram': Cops

ome of the rioters in the northeast Delhi riots of February used a WhatsApp group to coordinate with each other and killed nine Muslims after they refused to chant 'Jai Shri Ram', Delhi police has alleged in its chargesheets filed in a court in Delhi.

The accused were part of a WhatsApp group-Kattar Hindut Ektathat was created on February 25 to take revenge on Muslims, the charge-sheets said, adding that they used it to coordinate with each other and provide men. arms and ammunition to each other.

The creator of the WhatsApp group is still absconding, police said in the charge-sheets.

Kattar Hindut Ekta group was created on February 25 at 12.49pm. Initially, there were 125 members in this group; out of these 125, a total 47 had exited the group by March 8, it said.

The charge-sheets were filed before Additional Chief Metropolitan Magistrate Vinod Kumar Gautam on June 29 for the alleged bludgeoning to death of nine people-Hamza, Aamin, Bhure Ali, Mursalin, Aas Mohd, Musharraf, Akil Ahmed and Hashim Ali and his elder brother Aamir Khan.
