First Time Since 1947, Martyrs' **Day Observed Sans Govt**

SRINAGAR: For the first time since 1948, there was no holiday and official function to commemorate the annual Martyrs' Day in Jammu and Kashmir on Monday.

In a break from past, there was no function at the Martyrs' graveyard here after the government dropped July 13 from the list of gazetted holidays last year following the abrogation of special status of the state now turned into a union territory.

Sheikh Mohammad Abdullah, the then prime minister of Jammu and Kashmir, had declared July 13 as a holiday in 1948.

Apart from the official function at the Martyrs' graveyard situated in the lawns of Sufi shrine of Bahaudin Naqshband, unionist political leaders used to pay floral tributes at the resting place of 22 Kashmiris who were killed in Dogra army's firing while protesting the autocratic rule of Mahara-

Lockdown Re-Imposed In Srinagar After Spike In Covid Cases

SRINAGAR: Following the surge in the number of COVID-19 cases, authorities on Monday reimposed lockdown in many areas of Srinagar and other major towns to prevent the virus from spreading. In the last week, over 450 cases were detected in Srinagar district alone, thus prompting the administration to re-impose the lockdown in the areas, which were declared red zones.

Officials sources said that four patients who died include 55-year-old CRPF man, 65-year-old man from Rawalpora Srinagar, 46-year-old man from Sopore Baramulla and 55-year-old woman from Arabal Pulwama

Dr Nazir Choudhary, Medical Superintendent at SMHS said that a 55-year-old CRPF man of 174 Battalion Kulgam who was admitted on Sunday and was tested positive after his death on Monday. He was suffering from bilateral pneumonia and other ailments, he said.

Assistant Commandant and CRPF spokesman for (operations) in Kashmir, Junaid Khan also confirmed his death and said the deceased personal was tested positive for COVID-19.

He said that his last rites will take place as per the protocol and guidelines of authorities.

Dr G H Yatoo, Nodal Officer for COVID-19 at SKIMS said that a 46-year-old man from Sopore, who was admitted on July 07, died at SKIMS on Monday morning at 5:45 AM.

He said the patient was suffering from multiple myeloma, Thrombocytopenia, Electrolyte dysfunction and other ailments.

Dr Salim Tak, Medical Superintendent at CD hospital said that a 65-year-old man from Rawalpora Srinagar had come for CO-VID-19 sampling. However, he said that the man died while his sample was taken and he was tested positive after his death. He died due to Cardiac arrest and the patient was suffering from heart ailments.

He said that a 55-year-lady from Pulwama, who was admitted on July 05, died at CD hospital on Monday afternoon.

Dr. Tak further stated that the patient was suffering from COPD, bilateral pneumonia and other ailments.

With four more deaths, the death toll due to COVID-19 has reached to 186 in Jammu and Kashmir including 169 from Kashmir division and 17 from Jammu division- With inputs from KNO

Pertinently, during winter season, there used to be 12-16 hours of power curtailment in some parts of Kashmir Division. The commissioning of 12 Receiving Stations is a great leap forward to improve the capacity constraints from distribution side, he added.

Principal Secretary, Power Development Department, Rohit Kansal informed that the newly inaugurated projects will benefit around 35,000 households across Kashmir.

The Lt Governor said that the Government of J&K is aiming to achieve the larger goal of self-sufficiency in Power sector and stressed on putting concerted efforts towards achieving medium term target of providing reliable power supply to the consumers with no more than 2 hours of power curtailment.

During the last two years, J&K has witnessed rapid progress in execution and completion of major developmental projects. The projects under PMDP were sanctioned in 2015. However, the work on most of these projects started in the years 2018 and 2019 only, and within a short span of time, these projects are being commissioned, he added.

The Lt Governor set November 2020 as the timeline for the completion of 7 projects whose foundation stones were laid today. He also advanced the completion target for two power projects from December 2021 to May 2021.

The projects inaugurated today included- Construction of 33/11kV 10 MVA Receiving Station near DC Office Shopian, benefiting 1300 households; Augmentation of 33/11kV Receiving Station Qazigund from 1x 10 MVA to 2x10 MVA, benefiting 8200 households; Augmentation of 33/11kV Receiving Station SICOP (Bijbehara) from 1x6.3MVA to 2x6.3 MVA which would benefit 2850 households; Construction of 33/11kV 10 MVA Receiving Station Hanjoora, benefiting 1800 households; Augmentation of 33/11kV Receiving Station Kanir from 1x 6.3 MVA to 2x6.3 MVA which would benefit 2500 households; Augmentation of 33/11kV Receiving Station Khag from 1x 6.3 MVA to 2x6.3 MVA; Augmentation of 33/11kV Receiving Station Devsar from 1x 6.3 MVA to 2x6.3 MVA: Augmentation of 33/11kV Receiving Station Owantabhawan from 2x6.3 MVA to 2x10 MVA; Augmentation of 33/11kV Receiving Station Bone & Joint from 2x6.3 MVA to 2x10 MVA and Construction of 33/11kV 6.3 MVA Receiving Station Kellar benefiting 4400,5200, 2000, 2200 and 3000 households respectively.

Complaints pouring frequently against some private schools of charging miscellaneous fee: DSEK

Srinagar: The government on Monday said it will cancel the recognition of the private schools that violate the orders of the School Education Department and charge miscellaneous fees in the name of tuition fee during the **COVID-19** pandemic.

The School Education department also warned the management of private schools of strict action in terms of relevant provisions of law in case of any violation.

Following the government orders of de-recognition of accused private schools allegedly charging the miscellaneous fee in the name of tuition fee.

In this regard, the Directorate of School Education Department (DSEK) issued a circular, asking the private schools to refrain from violating the government orders

DSEK on June-16 issued circular-instructing all recognized private schools to charge only tuition fee from students on a monthly basis instead of quarterly basis for the lockdown period.

"No fee hike shall be made during the academic session 2020-21 and the annual fee, if any, can be charged monthly on a pro-rata basis, after



schools reopen," reads the circular. DSEK in a circular said that the complaints are pouring on a frequent

basis that some recognized private schools are still charging tuition fees as well as miscellaneous fees under the

caption of tuition fee.

It further stated that no School shall deny access to online education, material or classes for the continuous assessment to poor and deserving students, who are unable to pay school fees due to the prevailing situation.

The School Education department impressed upon the recognized private schools to adhere to the instructions in letter and spirit.

"In case any violation or nonseriousness, strict action shall be initiated against the particular School in terms of relevant provisions of law, which includes therecognition thereof without further intimation," it reads.

In view of COVID-19 pandemic, the government earlier instructed the private schools in Jammu and Kashmir to extend the last date of deposit of school fees up to April-30 without any late fees.

"No school shall either charge any fee for the online learning, assignments or shall link the result of the child on the basis of home assignment, "the government directed—(KNO)

3 LeT militants killed in Sopore gunfight were planning a big strike: DIG

Srinagar: At least three Lashkar-e-Taiba (LeT) militants including two foreigners were Sunday killed in a day-long encounter in Sopore area of north Kashmir's Baramulla district, a top police officer said. He also stated that they are putting their every effort to ensure that the local youth will not pick up arms.

Addressing a presser in Sopore, Deputy Inspector General (DIG), North Kashmir Range, Muhammad Suliaman Choudharv said that a major threat has been averted after three militants affiliated with LeT have been killed in Sopore gunfight. "We can't rule out the pos-

sibility of the attack. The arms and ammunition recovered from the slain militants also in-



dicate that they were planning for something big. After their killing, a major threat has been averted." he said.

He added that they have witnessed the attacks in the past

and are ready to face any kind of challenge.

He identified the two among the three slain militants as Usman Bhai and Saifullah, adding that the identification of the third militant was being ascertained. "Usman Bhai was involved in the recent attack in model town Sopore in which one CRPF man and a civilian were killed. The duo foreign militants were active here from the last two years," he said.

Giving details about the encounter, the DIG North Kashmir range said that the Cordon and Search Operation (CASO) was launched in the area after receiving inputs about the presence of militants. "Soon after the search party reached near the suspected spot, the hiding militants fired upon them, which was retaliated and thus resulted in an encounter." he said, adding that in the encounter that lasted for the entire day. three militants were killed.

Two Sootys, Eco Car stolen in **Central Kashmir** rinagar: Crooks have

stolen a car and two Scootys in Central Kashmir. Police have registered cases and set investigation into motion.

Police sources said that a scooty was stolen from Mochwa area of Chadoora, another from Zoonimar Srinagar while an Eco car has been lifted from Bemina area of Srinagar city.

Sources said that Fahad Furkaan Shiekh Furkan of Pamposh Colony Natipora reported at police station Chadoora that his scooty (JK01A/K8717) has been stolen by some unknown persons at Mochwa Chadoora during intervening night.

Similarly, another person Syed Mukhtar Ahmed, a resident of Pazwalpora Zoonimar reported at police station Zadibal that during intervening night his scooty (JK01C/7059) was stolen by some unknown persons.

Police station Zadibal instantly registered an FIR vide number 44/20 under section 379.

Ashiq Ahmed Gadoo, a resident of Bemina reported at police station Parimpora that his Eco Car (JK01R/8243) has been stolen by some unknown persons.

As reported earlier, the vehicle theft cases are on rise across Kashmir Valley. Scores of vehicles, motor-cycles and Scootys have been stolen in different parts of Valley during this pandemic.

ACB produces chargesheet against former ExEn

Srinagar: Anti-Corruption Bureau Kashmir on Monday produced chargesheet against former Executive Engineer Jammu and **Kashmir Projects Con**struction Corporation (JKPCC), Parvaiz Ahmad Naqash in alleged disproportionate assets case.

In a statement, ACB said that it presented a charge sheet in a case under FIR number 45/2007 under sections 5(1) (e) r/w 5(2) PC Act. Svt. 2006 P/S ACB against the former Executive Engineer Parvaiz Ahmad Naqash, son

of Ghulam Ahmad Naqash of Peerbagh Srinagar in the court of Special Judge Anti-Corruption Srinagar. 'The instant case was

registered in this Bureau against the accused with regard to accumulation of disproportionate assets beyond his known source of income on the basis of verification conducted by State Vigilance Organization (Now ACB)," ACB said. The statement reads that

several movable and immovable properties have been acquired by Parvaiz Ahmad

Naqas, which include two palatial houses at Peerbagh, Hyderpora, two cars and several bank accounts having sums in lacs were detected during the investigation of the case.

"During the course of investigation the charges were proved against the accused. Subsequently, sanction under relevant law was obtained from the competent authority in favour of the accused for judicial determination for commission of offences," the statement added.

LAWDA starts dredging of Settling **Basin at Teilbal**

SRINAGAR, JULY 13: Lakes and Waterways Development Authority (LAWDA) today started the dredging of the Settling Basin at Teilbal using the Pamposh Crawl Cat Suction Dredger.

The dredging work was started to remove a huge quantity of silt that had accumulated in the Settling Basin which otherwise has the carrying capacity of arresting 80000 tonnes per annum of silt coming from catchment.

Over the last two decades about 1.25mts thick layer of silt has got deposited in the Settling Basin and it is of paramount importance to desilt the Settling Basin having an area of about 0.12Sqkms (122500 sqmts) to clean it of unwanted material as it acts as a filter before the water goes into the Dal Lake.

Div Com reviews status of subjudice sanctioned building permissions in Srinagar

SRINAGAR JULY 13: The Divisional Commissioner Kashmir, Pandurang K Pole Monday chaired a meeting of officials to review the status of cases pertaining to violations of sanctioned commercial building permissions in Srinagar city and the court directions thereof.

The meeting discussed various matters that are under consideration in court including sanctioned commercial building permissions in Srinagar, besides measures undertaken to curb illegal constructions and monitor work on sanctioned building permissions.

The Div Com directed the officers to adopt proper and effective mechanisms to keep vigil on illegal constructions and deviation to sanctioned building permissions. He also stressed for taking



concrete and sustainable steps to curb illegal constructions and violation of the Master Plan.

Oman's Homily To Hurriyat 'Don't Look Towards New Delhi' **Observer News Service**

RINAGAR - Accusing the Centre of not being serious in resolving the Kashmir issue, President of opposi-tion National Conference Omar Abdullah today said the solution of the problem lies neither with India nor Pakistan but with the people of Kashmir, and counselled the Hurrivat Conference not to trust New Delhi.

The solution to Kashmir issue neither lies in the hands of India nor Pakistan. This complicated and long-standing issue could be resolved only in accordance with the wishes and aspirations of the people of Kashmir," Omar said addressing party workers and supporters at martyrs graveyard at Naqashband Sahib in Srinagar today.

Omar cautioned the Hurriyat Conference against trusting New Delhi, saying that his party too had lost faith in the Centre because of its dithering on the setting up of an autonomy committee.

"The Hurriyat should not place any trust with New Delhi," he said.

The antics of the conglomerate on this front are futile. All that the Hurriyat will get out of its talks with the central government is having a up of tea with the leaders." he said.

National Conference from its inception has been demand ing resolution of Kashmir issue in accordance with the wishes and aspirations of the people but unfortunately India has never been serious to address the long standing problem, the NC chief said.

Claiming that Centre was perusing a double standard with regard to Kashmir, the National Conference President said Centre has always used "puppets" like Mufti Mohammad Saveed (Chief Minister of Jammu and Kashmir) to deviate attention of the people from the real issue.

Sayeed is part of double policy of New Delhi. He is speaking in different tones to divert attention of the people from the basic issue," he said adding Sayeed at times talks about healing touch and sometimes beating the drum to highlight the opening of Srinagar-Muzaffarabad road. The reality is that the people are being oppressed on the name of healing touch, poor people are deprived of electricity to light their homes, he alleged.

The NC president also attacked the Centre for rejecting his party's demand for greater autonomy to the state, passed in the Assembly in 2000. Omar said Union Home Minister called him six months ago and asked to make the demand afresh for autonomy. He also made an announcement of for-mation of a high level committee to look into the issue but so far nothing has been done, he added.

'Martyrs' Day'

or the first time since 1948, J&K didn't ob-serve a holiday on July 13 otherwise commemorated as the Martyrs' Day by the successive governments. Now was there any official function held. On this day in 1931, twenty two people were killed near Srinagar's Central jail when they were protesting against the trial of an anti-government activist Abdul Qadeer. Kashmir was then ruled by Maharaja Hari Singh, an autocratic ruler. The killings became a trigger for a drawn political movement against Maharaja's rule spearheaded by Sheikh Mohammad Abdullah. Sixteen year later, as India got freedom from British, Maharaja's control of his state too slackened and finally it was the subsequent tribal invasion from Pakistan that forced his exit from power. But before that Maharaja had signed the Instrument of Accession on October 26, 1947 that made J&K an autonomous part of India. Later, Abdullah, then J&K's most popular leader, who too threw in his lot with Kashmir's destiny with India became the first Prime Minister of J&K. July 13 was made the gazetted holiday of J&K. It became a potent symbol and reference point for Kashmir's struggle against feudalism and Maharaja's rule. It remained one for 88 years before being struck off as a holiday this year. In recent years, however, sections of political opinion in Jammu had started observing July 13 as the "black day". They remembered the day when first ever communal attack took place against religious minorities in Kashmir.

Incidentally, the government has also delisted Abdullah's birthday on December 5 as the official holiday. The decisions have followed the revocation of Article 370 on August 5 last year. In the new list of gazetted holidays, the government, however, has declared October 26 as one. On this day in 1947, Maharaja had signed the Instrument of Accession with the dominion of India.

However, the government's decision not to observe the July 13 has not gone down well with the political and civil society organizations in Kashmir. There has also been a backlash on social media. The decision is being interpreted as an attempt by the government to erase an important event of Kashmir's history from the collective memory. Incidentally, the re-imposition of the Covid-19 lockdown which has come into force on this day has pre-empted any street expression of the opposition to the government move. On its part the government when it delisted the July 13 holiday didn't explain the rationale behind it. That said, the withdrawal of the government patronage of the day has made people more conscious of its historic and symbolic significance. If the government doesn't review its decision, July 13 is likely to grow in its symbolic significance with time and become a powerful rallying point for the dissident voices in the union territory.

Glancy's report provided a corrective to nearly a century of marginalizing the largest number of the Kashmir state's subjects. Through its many recommendations, it re-inscribed Muslims into their history and region

or Kashmiris, made double-subjects of the British empire in India and of the princely state the latter had installed under Dogra maharajas in 1846, nationalism's work of forging a nation and giving it political articulation involved taking a double step. It had to overthrow the yoke both of Dogra thraldom and of colonial dominance. Their martyrs could not be the same as those of the Indian nation. And it was 13 July 1931, not the familiar markers on the Indian independence movement's calendar, that gave Kashmiri nationalism its first sacrificial deaths for commemoration.

Srinagar, 13 July 1931

Several historians have elected this date to mark the inauguration of the freedom struggle of Kashmiris against Dogra rule. Neither the events of that day in Srinagar nor the death toll of twenty-two demonstrators and one policeman seem so outstanding as to command remembrance when compared to contemporaneous developments in British India. But this date was not intended to serve the fashioning of the Indian nation. In Kashmir, the date's emblematic importance drew from the fact that it was the first time a gathering of Kashmiri Muslims had openly challenged the Dogra maharaja and his government.

The portentous events of that day had followed upon rumours, spreading since mid-1931, about the maharaja's officials mistreating Muslims and deliberately offering insults to Islam in Jammu. The report that elicited the most vehement reaction was about a Hindu police constable who had not only prevented a Muslim subordinate from saying his prayers, but had added to this insult the injury of throwing the latter's copy of the Quran to the ground. Later investigation found the account of this incident to have been exaggerated although not entirely without basis. However, it brought to a head a gathering discontent born out of a number of factors other than the purely religious among Muslims in the state and, by the time its reports reached Sringgar it set the stage for the unprecedented occurrences of the following days. On June 25th, Abdul Qadir, identified by some as a Pathan and others as a Punjabi servant of a European vacationing in Kashmir, made an inflammatory speech at a meeting held in a Srinagar mosque that condemned the Dogra maharaja and incited his hearers to kill Hindus and burn their temples. He was promptly arrested. A general impression created by accounts of subsequent events was of an unprovoked attack led by Srinagar Muslims against hapless Hindus. However, contrary to later reconstructions of the events of the day, Kashmiri Pandits and other

Hindus, shaken by the expression of such hostile sentiments as those of Qadir, had not been sitting by idly as unwitting victims of a carnageabout-to-happen either. They had been disseminating their own set of rumours to rally other co-religionists into action. One such, spreading like wildfire and indicating the fear felt by a minority that had until then enjoyed security of power that they were in danger of possibly losing ground in the state to an increasingly vocal Muslim majority was that the Dogra ruler was about to lift the state-wide prohibition on cow slaughter. And were this to come about, it would have been no mean concession since the ban defined the identity of the state as one in which Hindu religious tradition enjoyed primacy. Thus, in the days preceding the fateful date of matyrdom, segments of both the Hindu and Muslim populations in Kashmir were raising their defences and the situation was moving inexorably towards a confrontation.

On July 13th, when Abdul Qadir was to be tried at the Central Jail in Srinagar, a crowd had attempted to enter the penitentiary to protest his prosecution. Retaliating, the police fired into the gathering that then scattered and went on a rampage in Srinagar city. In Maharajgunj, a quarter of Srinagar inhabited predominantly by Kashmiri Pandits and Punjabi Hindu traders, crowds of Mohammadan hooligans attacked shops, looted large quantities of goods and committed indiscriminate assaults. The British Resident in Kashmir had reported that there had recently been much discussion among Mohammadans in Kashmir about their grievances against the comparatively small Hindu community which, as a result of a mistaken policy of many years standing, had been allowed to monopolize most of the appointments in the State. Yet, the Resident confessed that no one had for a moment suspected then any danger was to be feared in the city of Srinagar. Evidently taken by surprise by the overt activism of the Kashmiri Muslims, the maharaja's government devised makeshift and quick fix solutions. Relving on the tested strategy of his predecessor, Maharaja Hari Singh received a deputation of all the leading Muslims of the city with a view to removing their apprehensions. Meeting with the ruler, members of these eminent Muslims assured him of their unfaltering loyalty. However, as the Resident suggested, the greatest difficulty the maharaja would have to face would come, not from the small Kashmiri Muslim élite but, from the public disapproval of his policies freely expressed in British India and particularly in Punjab. The events of July 1931 had catapulted a number of new actors onto the political stage of Kashmir

each seeking to capitalize on the momentum of Muslim restiveness unleashed through these incidents. A younger generation of Muslim politicians led by Sheikh Mohammed Abdullah and aiming at broad social bases of mobilization was pitted against the older and more socially exclusive, élite leadership of the Jama Masiid Mirwaiz and others. These Kashmiris were joined in their competition for the leadership of Muslims in the valley, by two rival sets of interests from the Punjab represented by the Ahmediyas and the Ahrars. By mid-August 1931, the Resident was already reporting on dissatisfaction among Kashmiri Muslims being fuelled by letters from Muslim organizations from outside the state urging them to keep up their agitation. Under such prompting, Kashmiri Muslims led by Sheikh Abdullah had refused to meet with the Maharaja on August 6th, 1931, aiming to procrastinate until August 14. The latter date had been declared Kashmir Day throughout Muhammedan centres in British India by the Kashmir Committee formed only a week after the killings of July 13th and supported by large numbers of the valley's Muslims long settled in the Punjab.

In the aftermath of July 13th, and viewing with trepidation the bleeding of political protest across their carefully demarcated and vigilantly policed borders between the Punjab and the Dogra state, the British colonial government of India exercised its prerogative as paramount power to appoint a commission, working under the direction of B. J. Glancy, to examine the grievances that had caused the disturbances. Its report of 1932 included a powerful indictment of the Kashmir durbar's partisan functioning in favour of its Hindu subjects to the neglect of Muslims. Strikingly, the report had also invalidated the principle of first peoples on the basis of which the Dogras and Pandits had re-imagined Kashmir as originally Hindu. Glancy's report provided a corrective to nearly a century of marginalizing the largest number of the Kashmir state's subjects. Through its many recommendations, it re inscribed Muslims into their history and region. And, perhaps unconsciously, it also redefined the contemporary territory of Kashmir no matter what lay beneath its historical layers as Muslim. From hereon, the challenge gathered a momentum that would end with stripping the legitimacy of the Dogra princes to rule over Kashmiris. Over the following decade, this newly grounded assertiveness extended into a wider struggle for the fulfilment of a spectrum of economic and political demands that culminated in the unravelling of Dogra sovereignty itself in 1947.

othing better exemplifies the collapse of rule of law in India than the daylight murder of gangster Vikas Dubey in Uttar Pradesh on Friday morning. The entire Vikas Dubey episode beginning with the ambush and massacre of eight cops, including Deputy Superintendent of Police Devendra Mishra, on July 3, reeks of the rot in the UP society, which celebrates the politician-policegangster nexus. The so-called encounter between Dubey and cops on their way from Ujjain in Madhya Pradesh to Kanpur prima facie appears to be an extra-judicial murder as it follows the UP Police's standard operating script in dealing with certain inconvenient criminals.

In the last one week, five of Dubey's accomplices were shot dead, of which at least one was caught and then killed as he attempted to snatch a cop's weapon when the vehicle stalled with a flat tyre. According to the same script, Dubey tried to snatch a gun when the vehicle he was travelling in overturned, leading to his custodial killing. But there are gaping holes in this story: news reports suggest that the police stopped TV crews following the convoy shortly before the shootout and more curiously, Dubey seemed to have been shifted from one vehicle to another according to CCTV footage from a toll plaza. The arrest from Ujjain itself was staged for all to see. Or else, how could a scheming, cop-killing gangster suddenly appear alone and unarmed, after crossing four state borders, to be so easily 'overpowered' by two temple guards?

Dubey and his key associates have been silenced. Now, it is difficult to prove who tipped him off about the raiding party headed by DSP Mishra, or at whose behest he mowed down the cops, or who offered him political patronage to remain at large despite 60-odd cases, including murder. More importantly, we will never know all that Dubey did for his political masters. The UP model justice delivery system is instant and foolproof: the real criminals in khaki and khadi never get caught. The UP Government is a metaphor for all that is wrong with this country's governance.

I was Covid-19 negative but was not allowed to go home

'Muhammad Kifaytullah from Plan, Bandipora, came from Dubai to Kashmir on the 30th June after months of struggle to get back home

We were almost 170 passengers in the plane and landed at Srinagar airport. Our samples were collected by the airport authorities.

From the Airport, the authorities took us to the Tourist Reception Center in SRTC buses, for registration and were quarantined till reports came.

After a few hours, we were told that we were put under quarantine in respective districts. I was happy that I will be finally at home town and even if they put me under quarantine for 20 days, I won't be having any issues. But Alas!

We were told that if the COVID-19 reports came negative then we can be put under home quarantine.

Following day, we were shifted to our respective districts and were put under quarantine at a local centre in the Bandipora town.

While on the way to Bandipora

from, I got a call from incharge quarantine centre Mr. Nisar Ahmed Para as he was waiting for me.

Luckily, the report came negative on 1 July, and following the protocol. I approached Mr. Parra and informed him that since the report came negative and that I shall be allowed to go home for home quarantine.

Seeing the conditions of the quarantine centre, I didn't want to be there at any cost. Also, my co-passengers came negative and they were allowed to go home, so I had no reasons to be there.

Mr. Para approached Dr. Nabeel Ishtiyaq, Nodal Officer, Bandipora that I should be allowed to go home since the report came negative.

I had strong apprehensions that if I stayed at the centre, I would fall ill because of the unhygienic atmosphere

But, Dr. Nabeel refused to allow me to go home and said we have to follow protocol for the international passengers. They have to do a 7-day

quarantine.

When I raised a point if there are other districts and out of 170 passengers, among them one person is not going to do home quarantine does it make any sense. But he didn't listen at all and even didn't bother to respond.

I approached almost all the officials in the administration but nobody was willing to hear my pleas. I felt suffocated.

My point was how can they treat a human like an animal? Why did they listen to my pleas? There was no doctor for my media check-up and so I didn't know what kind of strategy was this? What kind of SOPs are being followed in the district?

I also informed them as one more flight arrived on 3rd from Dubai to Srinagar ,and on 4th July , after the report came ,they sent passengers to do home quarantine, but there was no one to answer my pleas.

I was kept at the quarantine centre for over 7 days, and every single

day, I felt miserable. The quality of food was worst, pulses were served every other day.

After 7 days they allowed me to go home but didn't issue me a discharge certificate on the same day. After repeated pleas, I had to visit myself to the hospital and got the certificate.

I don't know how our administrations and doctors of Bandipora work, are they working for themselves or for people ?

Being abroad I saw how administration and Government officials take care of the public but here it is totally opposite. I realise here they are treating humans as animals and they don't bother to listen and act as uneducated .I would like to request higher authority if anyone is reading this article please look into this matter so onwards others will not face the same problem.

5 Historians On July 13, 1931: 'The Uprising Which Shook The State'

As a day of remembrance, **Kashmir's Martyrs** Day this year paints a different picture due to altered equations in the valley post abrogation of Article 370, removal of 13 July from the list of state holidays and obviously the 'invisible enemy' looming large in Kashmir.

VEN as Kashmir's grand old political party— National Conference—put up a classic carnage capture of the day on its official twitter handle as a mark of tribute, there's no official sanction for the 89th Martyrs' Day in Kashmir in the pandemicplagued 2020.

For the first time in years, there're no public and political gatherings at the historic Mazar-e-Shuhada of Old Srinagar. An armoured vehicle was earlier seen at the gates of the martyrs' cemetery sited nearby the revered shrine of the famous Sufi saint of Naqeshbandi order.

Restrictions coincided with the COVID lockdown return in the city and countryside "to tame the surging viral curve" in the valley.

Annually, Kashmiris would pay tribute to the 22 civilians who fell to Dogra police bullets this day, 89 years ago, at Srinagar's Central Jail premises.

But once vibrant public event in the valley, the remembrance day over the years had become a hush-hush political affair, with local unionists arriving during wee-hours in the well-guarded cemetery for the hasty floral tribute.

The incidents of the day have been seen as the harbinger of the biggest show of struggle against suppression and autocracy in the valley. The developments following it have completely revolutionised the internal politics of the region for the years to come.

Over the years, however, as a torrent of narratives and accounts interpreted the day—July 13, 1931—differently, *Kashmir Observer* looks at how five contemporary historians have accounted and talked about the historic day in their own perspectives.

Prem Nath Bazaz

The prominent Kashmiri Pandit politician and writer wrote in great detail about his personal observations and political happenings of the 1931 uprising in his book, Inside Kashmir (1941).

Historically and politically, Prem Nath Bazaz writes, 13 July 1931 was the most important day in the annals of contemporary Kashmir.

"From this day," he notes, "the struggle for independence and freedom in the most modern sense started openly."

Bazaz, whose accounts continue to be indispensable



Pathan's fiery and inflammatory speech, in a meeting at historic Khanqah-i-Moula that year against the Dogra rule and his subsequent arrest on June 25 had shaken the Muslim populace as well as Kashmiri Pandits and other Hindus.

In the days preceding the dreadful day of 13th July of 1931, both sections comprising the vocal majority Muslims, and minority Hindus—"who until then enjoyed primacy and security under Maharaja's rule"—started raising their voices almost like a confrontational situation.

Rai believes that the events of July 1931 had given rise to a number of new political actors and competition among leaders who would go on to capitalise on the valley's restiveness.

Tracing the significance of this particular day to the present scenario, Rai upheld that such days of remembrance and commemoration of the sacrificial deaths are not to be seen only in vacuum and as events of the past.

"It also shapes and constructs meaningfulness in the present and future," she asserts.



Khalid Bashir, the well-known historian of Kashmir: Exposing the Myth behind the Narrative, questions the allegations of widespread loots and arson at the hands of Kashmiri Muslims on July 13, 1931.

"Unsubstantiated and propagandist allegations were circulated to present 13 July 1931 as 'The Black Day' instead of 'The Martyrs Day' as the Muslims observe it," Bashir writes.

The historian notes that most of the narrative was manufactured over the years around "incidents of fracas between aggrieved mourners and pro Maharaja sympathisers at few places, like Maharaj gunj, were converted into stories of large scale murders, lootings, raping and killings of the Hindus and Pandits".

The authors observed that the Barjor Dalal's Riots Enquiry Commission of 1931 did not come up with any evidence to establish the loots while many prominent Kashmiri Pandits like Gwasha Lal Koul, Jia Lal Kilam and P.N.K. Bamzai, who wrote in great detail about the incident of July 13, 1931, do not mention such "large scale loot" or any attack on Kashmiri Pandit properties.

Bashir believes much of the facts were twisted and presented in a way so "the victims of police firing on that fateful day are seen as 'criminals' attacking and organizing communal carnages thus getting killed in

in understanding the historical event, considered the anti-Dogra protests of the yore as the urgency of his Muslim counterparts—"who had been treated unfairly and harshly by the rulers, over the years".

He went on to comment on his book, "Firstly, because contrary to all professions of treating all classes equally, it must be candidly admitted that Muslims were dealt with harshly in certain respects only because they were Muslims."

Among the few Kashmiri Pandits, Bazaz had realised the end of the Dogra rule and saw the happenings of that day outside the Central Jail of Srinagar as the "watershed moment" in Kashmir's socio-political history.

In July 1931, Bazaz subsequently observed, the Kashmiris rose in rebellion and turned the corner.

"It was an unprecedented elemental upheaval," he writes, "almost a revolution which shook the State and brought the Dogra Raj to realisation of the stark reality."

Mridu Rai



Historian and author of the much-acclaimed book, Hindu Rulers, Muslim Subjects: Islam, Rights, and the History of Kashmir (2004), Mridu Rai writes, "And it was 13 July 1931, not the familiar markers on the Indian independence movement's calendar, that gave Kashmiri nationalism its first sacrificial deaths for commemoration."

In her piece, "Memorializing 13 July 1931 in Kashmir", the historian observes that the symbolic significance of the day is that it was for the first time that a gathering of Kashmiri Muslims had openly challenged the Maharaja's rule.

In Rai's opinion, events of that day were followed by rumours that were spreading throughout the valley about Hari Singh's officials' mistreatment and insults towards Muslims.

But the author does agree that all of the incidents which triggered such vehement reactions by the Kashmiris were born out of their discontent over a number of factors, and not purely religion.

Rai talks about how Abdul Qadeer's, the disputed

Christopher Snedden

In his book, Understanding Kashmir and Kashmiris, Christopher Snedden writes about the event of July 13, 1931 when "Kashmiris mounted a serious anti-Maharaja uprising in the Kashmir valley."

The Australian political scientist observes in his writing that the memorandum presented to the Viceroy in 1924 by some leading Kashmiris resulted in Maharaja's excessively harsh treatment towards the petitioners and his Muslim subjects.

By 1931, the author mentions, the Kashmiris were 'suppressed and sullen.'

Snedden sees the particular incident of alleged desecration of the Quran by a Hindu cop in Mirpur as a catalyst of the uprising.

The writer observes that the Kashmiris became particularly vocal after the 13 July incident of Maharaja's police force brutality and killings of 22 civilians.

He mentions that Hari Singh's heavy-handed arrests, imprisonments and further shootings and crackdowns on Kashmiri Muslims, resulted in significant popular unrest and violence throughout the provinces of Jammu and Kashmir.

"For maintaining law and order, the British had to send a troop of about 500 soldiers to support the ruler," the author writes.

Snedden tells that the 1931 uprising had become a serious one, as the agitation and protests spread across.

"The uprising resulted in the rise of many prominent young voices such as Sheikh Muhammad Abdullah to the forefront," he writes.

Author of The Making of Modern Kashmir, Aftaf Hussain Para writes in his book that the incidents of July 13, 1931, caused "a great uproar and it shocked the very foundations of the Dogra Raj."

The historian wrote that huge public demonstrations against the autocratic Dogra ruler, protest rallies and bunch of meetings by the oppressed masses and fiery speeches by prominent public leaders such as Sheikh Mohammad Abdullah, Mirwaiz Mohammad Yusuf Shah, Abdul Rashid Tasir, were already happening during that year.

"But it was Abdul Qadeer's emotional and stirring speech against the government followed by his arrest on charges of sedition which provided a fresh focus for public demonstration and protest," he notes.

Para mentions that a huge crowd gathered at the gates of Srinagar Central Jail on the day of the hearing following which the angry crowd became uncontrollable and some of the Muslims forced their way into the outer compound of the jail.

On the order of the Magistrate, the police force retaliated and opened fire on the unarmed crowd.

"This very day saw the cold blooded massacre of twenty-two Muslims, and scores of demonstrators injured with bullets which went on to strengthen the national consciousness and struggle for freedom," he writes.

Pak to restore Afghan exports with India through Wagah from Wednesday stan Prime Minister's Special

Islamabad: Pakistan said on Monday that it will restore Afghanistan's exports through the Wagah border with India from Wednesday at the special request of Kabul and to facilitate Afghan Transit Trade.

Pakistan closed the Wagah border with India in mid-March in the wake of the coronavirus pandemic.

"At the special request of the Government of Afghanistan and with a view to facilitating Afghanistan's transit trade, Pakistan has decided to resume Afghan exports through Wagah border crossing from 15 July 2020, after implementing COVID-19 related protocols," the Foreign Office said in a statement.

The FO stated that with this step, Pakistan has fulfilled its commitments under Pakistan-Afghanistan Transit Trade Agreement (APTTA).

It also said Pakistan remains "fully committed" to improving bilateral relations with Afghanistan in all areas, including trade, and to facilitate Afghanistan's transit

Abdul Khalil Musadiq, a provincial hospital chief, said many of those wounded were civilians, including children.

US Man Dies After Attending "COVID-19 Party" Thinking Virus Was A "Hoax"

ew York: A 30-yearold man from Texas died from the new coronavirus after attending a "COVID-19" party hosted by an infected person, a doctor has revealed, underlining the risk to younger people.

Jane Appleby, chief medical officer at the Methodist Hospital in San Antonio, said the man thought the virus was a hoax, despite it killing more than 135,000 people in the United States so far.

"Someone will be diagnosed with the disease, and they'll have a party to invite their friends over to see if they can beat the disease." Appleby said in a video broadcast by US media on Sunday.

"One of the things that was



heart-wrenching that he said to his nurse was, 'You know, I how sick they are. think I made a mistake.

"He thought the disease was a hoax. He thought he was young and invincible and wouldn't get affected by the disease.

Appleby said young pa-

tients often do not realize

"They don't look really

sick. But when you check their oxygen levels and their lab tests, they're really sicker than they appear," she said, calling on people to take the risks seriously.

US Town Grows Money From Trees During Pandemic Downturn

ew York: Tenino had become a ghost town, and small businesses were struggling to survive amid the coronavirus pandemic, so local officials revived an unconventional idea from the last century: printing the town's own currency on thin planks of wood.

There was no trading, no selling and the city streets were dead. They looked the same at 3 pm as they did at 3 am," said Wayne Fournier, mayor of the town of 1,800 people in Washington state, in the northwestern United States.

"We were getting a lot of calls from businesses saying they were not sure if they would be able to hang on," he told AFP.

The town's museum had a printing press, so it was put to use to make \$10,000 worth of bills on wooden rectangles, each nominally worth \$25.

They feature a portrait of President George Washington and bear a Latin inscription that translates as "We've got it



under control."

The money is being given as a grant to locals who demonstrate they have been economically harmed by the pandemic. Each resident is allowed up to \$300 per month.

Known as "Tenino dollars," "COVID dollars" or, sometimes, "Wayne dollars" after the mayor himself, the bills are traded at almost all shops in the town at a fixed rate equivalent to \$1.

The currency is good only inside the town limits.

Nelson Mandela's daughter Zindzi dies at 59
