I'm Not In Self-**Ouarantine: Dr Faroog**

Srinagar: The National Conference patron and Member Parliament Dr Farooq Abdullah Wednesday said that he has not been advised for self-quarantine and the reports in the media were false. "There is no truth in it that I have been advised not to move around and stay indoors in selfquarantine," Dr Farooq Abdullah was quoted as saying. He said he is physically fit and no medical advice has been issued to him by the health experts.

Covid-19: Ladakh Has 84% Recovery Rate

Srinagar: Ladakh has the highest recovery rate of Covid positive patients, highest in the country, officials said. 14 more samples were tested positive on Wednesday in the UT taking the tally of positive cases to 1142 in Ladakh. "18 patients were discharged on Wednesday after their complete recovery taking the tally of recovered persons to 964 in Ladakh," official said. They said that with 18 more recoveries, 964 out of 1142 patients have recovered in Ladakh which is 84.41 percent of total cases in the Union Territory, highest in the country.

33 Discharged From Rainawari Hospital

Srinagar: At least 38 Covid-19 positive patients including 7 Gynae patients and 2 new born babies were discharged from Rainawari hospital today after their repeat samples tested negative for Covid-19 infection. Nodal Officer for Coronavirus at Rainawari Hospital, Dr Bilquis said that 33 patients were from Srinagar and one from North Kashmir's Baramulla district. She said 3 patients were from Mumbai and one was from Uttar Pradesh.

"All the patients were asymptomatic and discharged after 10 to 12 days of their Hospital stay.' "The total discharged patients from Rainawari Hospital till now are 560. Muskaan was six-months old when her father Abdul Majeed Guroo, a plywood businessman, was picked up from his house.

"On the morning of 22 December 1998," Muskaan's mother, in broken Urdu, recalled, "I was away with my elder daughter to buy some medicines. When I returned home, my mother informed me that the army took away my husband for some inquiry at around noon, and promised to send him back by 4:00 in the evening." She waited for him till 5:00 pm

comfort, she's still waiting for his homecoming.

Muskaan helped her mother as she struggled to explain the exact chronicle of the ill-fated day that haunts them even after twentytwo years. The memories of that fateful day in 1998 are still fresh in Habla's mind.

"Three to four uniformed personnel had come to our house and asked my father to accompany them to the police station," Muskaan translated for her mother. "When he asked for the reason, those men blindfolded him and took my father to an undisclosed place in their van."

SC Refuses To Entertain Plea Against 100% **Domicile Quota In J&K**

NEW DELHI- The Supreme Court Wednesday refused to entertain a plea challenging legal provisions which provide 100 per cent reservation to domicile of the Union Territory of Jammu and Kashmir in public employment.

À bench comprising Justices L Nageswara Rao, Hemant Gupta and S Ravindra Bhat asked Ladakhbased lawyer Najum Ul Huda to move the Jammu and Kashmir High Court with his plea.

(Decentralization and Recruitment)

Act as violative of Articles 14, 16, 19 and 21 of the Constitution of India as these sections direct 100 per cent reservation to domicile of the UT of Jammu and Kashmir in public employment."

The plea, filed through lawyer Nishant Khatri, said that since the abrogation of Article 370 in August last year, the UT is equally subject to all laws and the Supreme Court judgments which are applicable to the rest of the country.

Jailing Kashmir Bar Chief After Expiry **Of PSA Order:SC Seeks Explanation**

NEW DELHI- The Supreme Court Wednesday asked the Jammu and Kashmir administration to explain the basis for detaining high court's bar leader Mian Abdul Qayoom who has challenged his detention under Public Safety Act (PSA) since August 7 last year.

The top court asked it to take into consideration various aspects including Qayoom's age, expiry

of detention period and the CO-VID-19 pandemic. A bench of Justices Sanjay

Kishan Kaul and Indu Malhotra posted the matter for July 23 after Solicitor General Tushar Mehta, appearing for J-K, said that he needs 10 days time to consider various aspects.

"I begged at the doors of every authority promising me his return, but till date he's yet to come back home," said Habla in a bland tone.

After militancy erupted in Kashmir in 1989, thousands were killed and disappeared in the region. Kashmir has been classified as the world's most militarised zone. Many commentators call the conflict zone as a chamber of secrets, buried with mysteries and tears of women whose sons, husbands and brothers have vanished without a trace.

"My five children would wait for me the entire day, while I went out in search of my husband," Habla continued to voice her anguish.

"On most days, I would return at night. We've spent days without eating as my husband was the only earning member of our family."

Habla like many other half-widows is not educated enough. She has spent most of her life running from one jail to another trying to find answers for which she has only received false hopes as a consolation. She eventually became the sole breadearner with sudden responsibilities of bringing up her children.

After her father's disappearance, Muskaan's uncle sold off their plywood machine to help Habla financially. One by one they started selling off all the other items of their house.

Habla's son, now 26, had to leave his studies and work in warehouses to help his mother.

But all these years, Habla has gone through a lot of struggles. She did everything she could to help her kids. She got her elder daughters married and continued financing Muskaan's studies. She doesn't want Muskaan to face difficulties like she has been facing due to lack of education.

On her part, Muskaan didn't know about her father's fate until she was 15. Whenever she asked about his whereabouts, her mother would tell her that Abdul is working somewhere outside Kashmir. "I lived with this false belief for a long time," the daughter said.

But Habla's guarded secret eventually ended when her daughter returned tearful from her school one day. "Tumhaare Abbu ka intakaal hogaya hai, woh kabhi nahi ayenge wapas (Your father won't come back. He has died)," she was told by her friend. That day, heartbroken Muskaan demanded answers from her

mother. Habla then narrated the entire unfortunate incident, and said

that as a mother, she was just trying to protect her.

Muskaan doesn't even remember her father. Had she been told the truth, her mother said, she would've lived in trauma like thousands of other children in Kashmir.

But now, the sensible daughter wants to be her mother's support. Years of search for her husband has made Habla physically weak, yet she's the strongest woman Muskaan has ever seen in her life.

Habla hasn't still given up on her fight. With a lump in her throat, she hoped that her Abdul will return to her someday.

When I asked her why she didn't remarry, she instantly responded, "I got many proposals after my husband went missing, but I rejected each one of them. I was concerned whether my next husband would accept my children or not."

Many of these half-widows do not remarry in the hope that their husband will return someday.

When his father disappeared, Firdous was studying in an army school and staying in the boarding facility. For a week, nobody informed him about his father's disappearance.

"I never imagined that our happy life would suddenly come to an end," Firdous said. "We slowly lost everything."

From Gulmarg, they shifted to Latifabbad, a small village near Baramulla.

Nagina would spend her day and night in search for her husband and simultaneously look after her six children. She didn't lose her hope and will. She fought in court and kept on banging the doors of authorities and asked for justice.

"I still believe my father will return." Firdous said. "I was really young when I last saw him." And soon he had to leave his school to support his family.

Firdous sometimes works at an apple orchard or in warehouses. The perks they used to enjoy were snatched from them in one swipe.

"My mother doesn't get any pension," he said. "So I would mostly work at an orchard, but due to the pandemic lockdown, the business has come to a halt which has affected us tremendously. Now, my uncle helps us at times."

Today, even as lockdowns are escalating trouble for these conflict-torn families of Kashmir, their resolve for the reunion remains their lasting hope.

"I still look through my window in hope that someday I might catch a glimpse of my loved one," Nagina concluded.

The plea further said that the reservations contemplated in Article 16 should not exceed 50 per cent.

In March, the government issued the Jammu and Kashmir Reorganization (Adaptation of State Laws) Order 2020 which notified changes in the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Act.

Section 5A of the Act stated that Level 4 posts will be reserved for domiciles.

In August last year, parliament abolished Article 370, which had provided special status to Jammu and Kashmir, and then divided the state into two UTs which were Jammu and Kashmir and Ladakh.

The decision should also address the concerns of health of security personnel, healthcare personnel, priests, pilgrims and of the officials involved in the arrangements and conduct of the vatra besides the residents of the Union Territory.

The officer said that searches were launched to trace him. Asked whether the alleged abductors were armed, the officer had said: "It is a matter of investigation."

Malla had won unopposed from Marazigund (A and B) wards as a BJP candidate in last Municipal elections which were boycotted by mainstream parties leaving BJP without any rival.

Union Minister and senior BJP leader Jitendra Singh expressed relief on Malla's return. "Relieved to learn that our colleague in #BJP,Mehrajudin Malla who was abducted in Sopore this morning, is back home safe.While Security forces and @JmuKmrPolicedeserve all appreciation, where are the #Kashmir Apologists who lose no time in making unsubstantiated charges against," Singh wrote on Twitter.

BJP leader Ram Madhav also put out a tweet in this regard. "J&K Police say they rescued BJP's Vice President Municipal Committee Watergam Baramulla, Merajudin Malla who was allegedly abducted by some unknown persons in the north Kashmir district," Madhav wrote.

However, former Chief Minister and National Conference leader Omar Abdullah raised a volley of questions after police claimed his rescue.

"Rescued from where? Who abducted him? Was he given personal security & if he was then how was he abducted? How was he rescued without a shot being fired? Did the abductors just dump him & run when the police rescued him? This abduction & rescue raises more questions than answers," he tweeted.

tinently, even in the said decade old 4 FIRs, the Petitioner was neither arrested, nor any charge sheet ever filed by the police against the Petitioner, he added in his plea.

Qayoom said he had already been detained in 2010 on the basis of the said FIRs under the PSA, and the said detention was subsequently revoked.

on July 3 during which he also addressed troops and signalled the country's firmness in dealing with the India-China border row.

The sources said Mr Singh will carry out a comprehensive review of the security situation in the region with Gen Naravane, Northern Army Commander Lt Gen Yogesh Kumar Joshi, Commander of the 14 Corps Lt Gen Harinder Singh and other senior Army officials.

From Ladakh, the defence minister will travel to Srinagar where he will hold a high-level meeting with senior military officials on Saturday to review the situation along the Line of Control (LoC) with Pakistan, the sources said.

Mr Singh was originally scheduled to visit Ladakh on July 3 but it was deferred.

Indian and Chinese troops were locked in a bitter standoff in multiple locations in eastern Ladakh for over eight weeks since May 5.

The tension escalated manifold after the violent clashes in Galwan Valley in which 20 Indian Army personnel were killed.

However, following a series of diplomatic and military talks, the two sides began a mutual disengagement process on July 6 and withdrew troops from most of the friction points.

On Tuesday, senior commanders of the the two armies held a fourth round of talks during which the Indian delegation conveyed a "very clear" message to the Chinese army that status quo must ante be restored in eastern Ladakh and China will have to follow all mutually agreed protocols for border management to bring back peace and tranquillity along the LAC, government sources said

During the course of the intense and complex negotiations that lasted nearly 15 hours, the Indian delegation apprised the Chinese Army about the "red lines" and conveyed that the onus was largely on China to improve the overall situation in the region, the sources said.

The key focus of the talks was learnt to be on rolling out the phase two of the disengagement process besides firming up nodalities for withdrawal of forces and weapons from the re bases in a time-bound and verifiable manner, the sources said, adding they were aimed at further de-escalation of the situation at various friction points.

ment, "one day I'll be able to see my father's face and cook for him."

According to rights bodies, 8,000-10,000 Kashmiris have been subjected to enforced disappearance in Kashmir since 1989. Among them is Hafeeza Begum's Ghulam Nabi.

Before becoming a battered widow, Hafeeza was a 20-vearold shy bride, when her husband disappeared in Punjab during a trade trip.

Years of struggle has taken a toll on her. To feed her children, she kept working in fields and financed her daughter Tabassum's education. In lockdown, the family today is silently suffering.

Earlier. some NGOs would help Hafeeza's family financially, but since last Eid, her family hasn't received any help.

"This time I took a loan from a neighbour to submit my MA fees," said 27-year-old Tabassum. "Ammi remains ill most of the times. I don't know what has happened to her. She's mostly tired now.'

Behind her falling health is her years of agonized search and wait for her husband Ghulam Nabi Baba, a cloth merchant from Kupwara.

In November 1992, he disappeared in Punjab. And later, the family was told he died in a "cross-firing".

Even Kupwara police informed Hafeeza about Ghulam Nabi's death after a few days of the dreadful incident.

At that time Hafeeza was pregnant with Tabassum. She ran from one police station to another, filed an FIR, but all in vain. Hafeeza waited for her husband's body but never received it.

All these years, however, she hoped that maybe, one day, her husband will return and see his younger daughter's face.

With time as Tabassum learned about her father from her relatives, her mother fought hardships, battled depression and vet never gave up her hope. Like others in her conflict-torn tribe, she mostly found herself alone in her struggle. Her agony, however, doesn't end there.

Since half widows can't prove the death of their husband, they remain ineligible for widow welfare pension scheme. They face enormous financial difficulties, as they're ineligible for ration cards and the bank accounts of their husbands. Disappearance of their husbands marginalised their economic status even more.

"Ammi is very strong, she never gave up on Abbu, she still awaits his return," Tabassum continued. "I'm waiting for the day my father will return, that will make me the happiest person on this earth. I've never seen him. I don't even know how he looks. Hum har din khuda se dua karte hai ki hamari musibat khatam hojaye (We beseech Allah every day to end our agony).'

But as there're often no records of such cases, many half widows of Kashmir grapple with a host of issues. Over the year, however, Kashmiri women have overcome the trauma and risen like a phoenix – like Nagina Begum.

Nagina's son Firdous was 7 when his life was disrupted after his father was subjected to enforced disappearance in 2006. His father was a special police officer (SPO) in Kashmir police.

14 years ago, Nagina's husband got a call from some army officers, she said. He followed the order and left home.

That was the last time Nagina saw her husband. After that, she searched for him everywhere – from the DC office to army authorities but of no avail.

"Army ke log bolte thhe ki police ke paas jao, aur police ke log bolte thhe ki army ke paas jao (Army men would ask me to go suffering from hypertension, hypothyroid, bilateral pneumonia and other ailments," he said.

Officials from Budgam said that a 70-year-old patient from Rathsuna Budgam was tested positive after death.

According to Dr Majid Mehrab, Medical Superintendent at GMC Anantnag a 65-year-old male from Khrewan village of southern Kashmir who was admitted on 04 July died last night.

Dr Nazir Ahmad Choudary, Medical Superintendent at SMHS said that a 62 year old male from Baramulla who was admitted on 09 July died at SMHS on Wednesday. Patient was suffering from bilateral pneumonia, diabetes and other ailments, he said. With 11 more deaths, the toll in J&K has reached to 206 including of which 188 are from Kashmir division and 18 from Jammu division. With inputs from KNO

The bench said that was the reason it has issued notice on the plea during the last date of hearing.

Dave replied that he understands why the Solicitor General was uncomfortable and complained that the present matter was not listed despite specific directions of the court.

Justice Kaul told Mehta that firstly his detention period has expired and secondly his ideology remains the same.

Dave pointed out that Qayoom is 73 years old and should not be kept in Tihar jail.

In the current scenario of COVID-19 would you like to keep this petition pending, the bench told Mehta, who said that Qayoom's ideology remained the same.

The bench said it understands all these issues but sometimes there are compulsions which need to be complied with.

It told Mehta that he should respond by next date considering Qayoom's age, expiry of his detention order and the COVID-19 times

On June 26, the top court had issued notice to the J-K administration and sought its reply on Qayoom's plea challenging his detention order.

Qayoom has also sought a direction to shift him from Tihar jail here to central jail in Srinagar on medical ground.

He has challenged the May 28 order of the Jammu and Kashmir High Court rejecting his plea against his prolonged illegal detention under the PSA in jails outside the UT.

He said he is a Senior Advocate with more than 40 years' standing at the Bar and has served as President of the J&K High Court Bar Association for many terms, including from 2014 till the present day.

Qayoom said he was detained on the intervening night of August 4th and 5th, 2019, under the provisions of Jammu and Kashmir Code of Criminal Procedure and thereafter, an order of detention under the PSA was passed against him on August 7, 2019.

He said that on August 8 he was taken to Central Jail, Agra, Uttar Pradesh, without any prior notice of intimation, where he was kept in solitary confinement.

He said the high court's May 28 order is ex facie unsustainable in law as it is premised on "stale, irrelevant, remote, vague, imprecise and deficient" grounds of detention.

The impugned judgment and order concluded that most of the grounds in the detention order are somewhat clumsy which implies that the High Court too found them wanting. Placing reliance on the doctrine of severability as enunciated by this Court in Gautam Jain versus Union of India...the High Court then proceeds to uphold the detention order solely on one ground, his appeal said

He said the high court makes it abundantly clear that the detention order has been upheld solely on one ground – the four FIRs dating back to 2008 and 2010, as enumerated in the detention order.

These FIRs are stale, irrelevant and have no proximate, pertinent or live link to the present, and are thus superfluous and extraneous to the satisfaction required in law qua the tendency or propensity to act in a manner prejudicial to public order. Per-

The letter mentions the chronological sequence of all four cases in detail and reminds Government of India that "journalism constitutes a necessary service for any society, as it provides individuals and society as a whole with the necessary information to allow them to develop their own thoughts and to freely draw their own conclusions and opinions (A/HRC/20/17 para 3. A free, uncensored and unhindered press and other media constitutes one of the cornerstones of a democratic society (CCPR/C/ GC/34/ para. 13."

The letter also expresses the "lack of regard for the rights" of the four journalists. "We also express concern at the apparent disregard for the prohibition of unlawful and arbitrary interference in the private life of individuals, and the journalistic privilege.'

The letter makes a reference to the allegation that Naseer Ganai's computer and mobile phone was searched without a warrant, and that, in the case of Peerzada Ashiq, that he specifically was requested to reveal the sources of a news item published. It also says that neither Gowhar Geelani nor Masrat Zehra were informed of the charges against them.

The UN Special Rapporteurs also want Gol to "ensure the right to effective remedies, including the investigation violations to the rights of the journalists mentioned in the letter."

Mayoral Elections Slated for Today Deferred

rinagar: A day before mayoral elections for Srinagar Municipal Corporation (SMC), the Jammu and Kashmir government on Wednesday effected changes in the law governing the election through an executive order.

The government issued an order that empowers it to extend the time limit of conducting the elections up to a maximum of three months from the date the office of the Mayor or the Deputy Mayor falls vacant.

The Principal Act provides that election should be held within one month from the date the post of the mayor or the deputy mayor falls vacant.

The time limit for conducting the election has been extended by invoking section 427 of Jammu and Kashmir Municipal Corporation Act-2000 that empowers the government to remove difficulties in giving effect to the provisions of the Act.

"If any difficulty arises in giving effect to the provisions of this Act or by reasons of anything contained in this Act to any other enactment for the time being in force, the Government may, as occasion requires, by order direct that this Act shall during such period as may be specified in the order but not extending beyond the expiry of two years from the commencement orders have effect subject

to such adaptations whether by way of modification, addition or omissions as it may deem to be necessary and expedient," reads section 427 of Jammu and Kashmir Municipal Corporation Act.

The government has incorporated a proviso in the law through Jammu and Kashmir Municipal Corporation (Removal of Difficulties) Order, 2020 that empowers it to extend time limit for holding election for these posts."In section 36, after second proviso to sub-section (2), following proviso shall be inserted, namely: 'Provided also that the Government may, if the circumstances so warrant, on account of reasons of internal security, public health including health pandemic, natural calamity such as floods, earthquake, snowstorm or an event of a similar nature or any other reason which is a hindrance to the conduct of election of the Mayor or the Deputy Mayor, by reasons to be recorded in writing, extend the time limit of conducting the elections up to a maximum of three months from the date the office of the Mayor or the Deputy Mayor falls vacant," reads the order.

Interestingly, the removal of difficulties order has been issued twenty years after enactment of the law.

Subsequently, the Housing & Urban Development issued a separate order to extend the deadline for holding Mayoral elections



of SMC to three months from the date the office of the Mayor fell vacant.

According to the order, Commissioner, Srinagar Municipal Corporation has informed the government the conduct of election to the post of Mayor within the period of one month prescribed by Section 36 of the J&K Municipal Corporation Act, 2000, which expires on 16th July, 2020, is not possible due prohibition of inward/outward movement of people in/from the areas declared as red zones.

The post of Mayor, Srinagar Municipal Corporation has fallen vacant on 16th of June 2020 and is to be filled up within a period of one month, in terms of Section 36 of the Jammu Kashmir Municipal Corporation Act, 2000. The order states that the District Magistrate, Srinagar (Chairman, District Disaster Management Authority, Srinagar) has issued orders prohibiting any inward/outward movement in red zones of Srinagar District.

The Commissioner, Srinagar Municipal Corporation, vide his communication referred to above has informed that eighty eight areas of the Srinagar District have been designated as red/containment zones for the management of COVID-19, under the said orders of the District Magistrate, Srinagar, and that a large number of Councilors reside/fall in these areas," the order reads.

Soldier killed by CRP4 men Mistaken for a militant after girl's murder

SRINAGAR - A soldier was shot dead by CRPF personnel in an Anantnag village on Wednesday night minutes after he killed a local girl.

The soldier from the 49th RR was shot dead by a patrol party who mistook him for a militant on account of his plain clothes and furtive movements

while fleeing from the scene of his crime. Outraged by the killing of the girl, thousands of people

came out into the streets today holding protests against the security forces and demanding that the body of the RR man be handed over to them.

The soldier had sneaked into the house of Muhammad Akbar Dar in village Changoo

in Doom area through a window after climbing over a walnut tree, and demanded food and a place for the night.

Enraged when the family refused his demand, the soldier had shot and injured Dar's 19-' year-old daughter. Zahida, who fell down in a pool of blood?

The family tried to catch hold of him, but he pumped a fatal shot into the girl and managed to escape from the scene A CRPF patrol outside the village ordered the fleeing Soldier to stop, and opened fire taking him to be a militant, the KNS, quoting police sources as having said. He died on the spot after identifying the soldier, the CRPF left his body and weapons lying in the field.

The defence spokesman, Col V.K Batra, however, told the KNS that the soldier had committed suicide after killing the girl. The local population surged into the streets in a huge demonstration against the security forces, sitting on a dharna and disrupting traffic.

Demanding that the soldier's body be handed over to them, the villagers said he had entered Dar's house with evil Intentions and had molested his daughter before shooting her dead.

The senior superintendent of police in Anantnag, Aashig Hussain Bukhari, however said, that no molestation had taken place.

School Fees

'n Kashmir, running a school is considered one of the best businesses, something that is risk-proof, come hell or high water. No matter, how long there has been a shutdown or a lockdown, and how much as a consequence economy has been affected, private schools will charge their full fees. It also doesn't matter how many people have lost their livelihoods and how many businesses have been wound up. In 2016, private schools claimed their full fees during the six month long shutdown and also during the many preceding unrests, and they are displaying the same behaviour in the middle of a pandemic.

To be fair to them, Private Schools Association of J&K recently announced fee waiver to the students whose families have been hit financially due to the COVID-19 lockdown. This is first time that the Association has done so and it should be welcomed. The waiver, however, will be offered to the families whose income during the lockdown has either reduced to zero or has been drastically hit. The Association hasn't made it clear how much loss of income will it consider enough for the student to get fee waiver or a concession. While on its face it seems a good step, it isn't. Truth is other than government employees, the incomes of all others have been badly hit. It is a reality that the Valley has been under a lockdown for the past twelve months that has hit the businesses hard, leaving lakhs of people unemployed. And there is nothing that can compensate their losses.

It is nobody's case that private schools shouldn't get their fees. They depend on the fees to run their affairs and pay their staff. But it is also true that other than a brief period of a fortnight or so, the schools have been shut. And in this period they have saved on all the expenditures other than the salary of their staff, which some reports have pointed out has often been delayed or reduced. The teachers have delivered online classes and which too haven't been up to the mark considering the lingering curbs on the internet and the lack of the training of their staff to deliver online lessons. So, the schools can't charge a full tuition fees, let alone transportation fees for a service they have largely been unable to offer over the past year. Or resort to blackmail to extract it like some elite schools are doing. They are holding online exams and not allowing some students to appear unless their parents pay up.

True, it is not the fault of the schools for not being able to teach, but similarly it is not the fault of the hundreds of other businesses who have suffered. And if they have taken their losses on the chin, so should private schools. In Tamil Nadu, the state government has asked the private schools to just charge 70 percent of the tuition fees. It is time the local administration passes a similar order here.

What about the fruit vendors, daily wagers, transporters, masons, carpenters, painters, salespersons, shopkeepers and others who have to go to work to put the food on the table?

et us face two simple facts: One, the novel Coronavirus is an irrefutable reality. It is no conspiracy theory. It is a no brainer either that the threat posed by the tiny virus is real. Two, the parallels that are being drawn between Kashmir and Wuhan are erroneous, misleading and alarmist.

In Maharashtra alone, the number of positive Coronavirus cases is touching the 300,000mark with nearly 11,000 deaths. In contrast, the number of those infected due to the virus in Jammu and Kashmir is under 11,000, of which over 6,000 individuals have already recovered. The recovery rate is fast. And it should have been packaged as a good piece of news to avoid psychological burden on the hearts and minds of the people. Thankfully, the death toll also is below 200. But the alarmists are creating more panic in Kashmir for reasons known to them alone.

The focus should have been on creating more awareness with regards to preventive measures like wearing masks, strictly following physical distancing norms, maintaining cough etiquette and washing hands regularly with soap or a hand sanitizer. In Kashmir, the virus is being treated as a lawand-order problem. All the blame is squarely put on the local population when the bank employees, doctors, members of the police department and paramilitary forces are infected in huge numbers. Why was an order issued by

the J&K administration to force all the government employees to report to their offices in full strength? Why is the focus not on the WFH (Work from Home) culture to avoid overcrowding at the offices? Why hasn't the rotation roster policy been adopted? Why can't only 25 per cent staff be present in all important offices and banks on a policy of rotation? How are the people responsible for the mess created by a 'chosen' few?

Why is it that the J&K administration on July 8 decided to throw open parks and gardens for the public and then in a volte face on July 12 issued another order to re-impose lockdown and severe restrictions in many "containment zones"? Had the tiny virus gone on vacation on July 8 and it resumed its duties on July 12? Why is critical thinking being criminalised in Kashmir? In another bizarre move, the J&K administration issued yet another order to allow tourist activities in the region from July 14 besides giving a go-ahead to the holy Amarnath pilgrimage as a fortnightly affair while limiting the number to 500 pilgrims for a single day. The message telegraphed is that the virus somehow differentiates between the visiting tourists/ pilgrims and



the native population. Does the virus become hyperactive when it comes to dealing with the local population and goes into hibernation mode with respect to the visitors and pilgrims? Why can't these questions be asked? Has the critical thinking in Kashmir been quarantined or put in isolation? Or, may be, declared a "containment zone"?

What is also intriguing is that a few (not all) doctors refuse to apply their independent mind or critical thinking to question the weird orders. Instead, a few become mouthpieces of the administration. It is understood that in government service they have certain limitations. But why lend support to stupidity? Silence is also an option.

If the virus or the spike in the COVID19 infection curve is the reason, it is absolutely fine and justified to place a blanket ban on all social, religious and political gatherings in J&K. Obviously, it is for the betterment of the region and its people. By avoiding crowded and packed places the community transmission of the deadly virus can be stopped. Many precious lives can be saved. There are no two opinions about it.

But how is it justified to allow a pilgrimage of one community and ban all sorts of gatherings of another community? How is it just to force the natives indoors while leaving the field open for visiting tourists and pilgrims

sessed the colossal losses to local economy and businesses in the Kashmir Valley since last August when the restive region lost its semi-autonomous status and statehood in a unilateral and undemocratic decision. Going by their report which estimated the loss of INR 18,000 Crore to Kashmir economy between August and November, the loss could have exceeded INR 55,000 crore by now.

Several business houses in Kashmir are on the verge of a collapse. Young entrepreneurs have lost their savings and investments. Since the 2008 summer uprising the Kashmir economy has been under tremendous stress. The shopkeepers, transporters, tourism players and those associated with hospitality and IT-sectors have been at the receiving end. Prolonged shutdowns, curfews, internet blockades in 2008-09-10-16-19-20 and disturbances caused due to the devastating floods of 2014 have not given a breathing space to the economy.

Kashmir's traders, vendors, daily wagers, hoteliers, shikarawallahs, ponywallahs, houseboat owners, salespersons, transporters and others have suffered losses since August of last year. Most of them stand crushed because of the two lockdowns of different nature. The first one related to the August 5 decision and the second one due to the pandemic.

n 2018, after the Congress won underwhelmingly in Rajasthan, scraping past the halfway mark in a state where antiincumbency sentiment was strong against the BJP's VasundharaRaje government, Ashok Gehlot was made chief minister and Sachin Pilot his deputy. That was clearly not the end of the leadership tussle in the Congress. It was, in fact, only the beginning of a new phase of the attrition within. For that persistent unease in one of the few states where the Congress still has a government, both Gehlot and Pilot are to blame -Gehlot more, given that as the head of government, the buck stops with him. But Pilot isn't the innocent victim done in by a wily superior. If the No. 2 job, as it was defined, was too small for him, he should not have taken it. Sulking about the CM when you are his deputy in the government is neither good politics nor smart governance. But this time, Gehlot must take responsibility for the extraordinary sequence of events — a bizarre notice issued to Pilot, among others, by the Rajasthan Police's Special Operation Group, to record their statements in connection with the arrest of two BJP leaders allegedly conspiring to topple the Congress government. After that, an all-too-familiar political brinkmanship has played out in a Congress government still to turn two years old - MLAs openly divided into camps, being ferried in buses with tinted windows into fortress-like resorts. All this, even as the other staple of an Opposition government in crisis in recent times — income tax raids - takes place, apparently coincidentally.

But if Gehlot must own the larger share of the blame for the Congress unravelling in Jaipur, it is the party high command that is most answerable. If it knew of the patchy peace between the warring CM and his deputy — and how could it not — the question is: What did it do to resolve the resentments? What mechanisms did it put in place to prevent a breakdown like this one? There is no evidence that either Sonia Gandhi or Rahul Gandhi addressed themselves to the task in Rajasthan with any urgency. Like much else in the Congress, the CM vs Deputy CM conflict in Jaipur was left unattended, and allowed to fester and grow. The organisational listlessness that has marked the Congress ever since the Modi BJP laid it low has contributed to the implosion in Rajasthan — just as it led to the collapse, earlier, of the Kamal Nath government in Madhya Pradesh after the exit of JvotiraditvaScindia and subsequent cross-over to the BJP. The irresoluteness at the centre of the party, if it continues, could well stoke other simmering factional resentments in other state units, jeopardising more Congress governments.

Whichever way the Gehlot vs Pilot face-off goes, this much is clear: The Congress needs to get a grip on itself and that process must start with filling the apparent leadership vacuum at its centre. It cannot keep deferring important decisions indefinitely. This is a vital necessity for the Congress, if it wishes to survive. It is also necessary for the polity to have a coherent and healthy national party of the Opposition

LalKoul: The lost treasure

alKoul is a canal that flows from Bumhama through Drugmulla, Shalpora, Keegam and many other villages. There was a time when this canal was an important source of irrigation for thousands of kanals of paddy fields. During summertime, children would bathe in the canal to relieve themselves from the heat. Women used to frequent the LalKoul. It provided the crucial resource of water.

When we were children, the LalKoul was full of crystal clear water. The human settlements around the water drank from it.

But since the past several years, communities nearby have witnessed the LalKoul undergoing tremendous change and a steep decline in the quality of its water. Even the reduced flow is strikingly visible to the ones acquainted with its past glory.

As changes in climatic conditions continue to surprise old-timers, the growing temperatures in the valley have caused the water of the canal to evaporate, affecting water levels and on the contrary, resulting in the formation of marshy margins that create

spaces filled with floating algae and other weeds.

The new construction projects along the banks of the LalKoul is squeezing it further.

In addition to that, the human settlements on the periphery of the canal ironically cause the most damage to the natural body. Sewage belonging to these settlements is discharged into the canal directly. Mixed solid waste including vegetable scraps, polythene bags, papers, etc. is dumped into it. A lot of public latrines, which are frequented by locals, have been built along the banks of the canal

The water which was once sweet and pure, is now poisonous and choked with plastic dump. Commuters deal with bad odour and dirt while walking along the bank of the LalKoul.

The garbage on its edges has become the centre for the development of germs and diseases. A lot of stray dogs roam around these spots for food and carry the infectants with them to the villages.

Owing the contamination in the water body, farmers are not able to irrigate their paddy fields. This is also resulting in a lot of agrarian and economic losses

Albeit the people of the land are facing many problems, they are completely oblivious to the rot in their backyard. The LalKoul is in a pathetic condition and it is extremely urgent that the irrigation department and the civic administration find a joint solution to save the canal from dying. It is the responsibility of the irrigation department but it is sad that the concerned authority is lax in initiating steps for its proper and rightful maintenance. There are some rumours in the villages that the irrigation department wants the civic administration to take over the maintenance of the canal as it flows through more than one village

Even though it is expected of the people to properly dispose of their waste and avoid using the canal as their personal dumpyard, the authorities need to be pulled up for forcing the commoners to treat the LalKoul as the only space of dumping. There are hardly any dustbins around the area and the concept of scientific waste management is non-existent. The civic body

has done very little to nothing for installing dustbins along the crossroads.

The villagers must also be cognizant about the God gifted treasure they have had the privilege to enjoy and share. The communities need to come together to preserve and protect their canal from further deterioration and slowly restore its original majesty.

The civic administration needs to fulfil its basic duty by installing dustbins every 200 metres along the flow of the canal.

Every individual in the community should help in minimizing pollution by practising waste management at their homes

The old glory of the canal can never be retrieved but we suggest that the restoration work be handed over to an independent agency which has the complete knowledge of water bodies and their ecology. The work must be allowed to progress without political interference.

T t was not in jest. I meant it when during an informal gathering in our housing complex the other day, I suggested to my co-residents to go to bed properly clad. I told them, "Earthquake comes unannounced. You never know when it might drive you out to an open area."

Rushing out wearing minimal clothing might cause embarrassment in a mixed gathering of men, women and children. I said I was saying this because of the frequency of tremors that have been jolting people in various parts of the country — from Jammu & Kashmir in the north to Punjab, Haryana, Delhi; Rajasthan, Gujarat to Maharashtra in the West. It hit Mizoram in the east four times in a week, once with a magnitude of 5.6 on the Richter scale. Otherwise, the tremors have fortunately been of low to moderate intensity, causing little damage.

The fact that the quake occurred 17 times in a month (June 2020) continues to raise apprehensions bordering on genuine fears among the people. Nobody knows what is in store for the morrow. So better be on guard always.

The year 2020 is half-spent in counting the horror stories of all kinds that continue to bombard us, sending chills down our spine every now and then. However, during the light-hearted conversation, a young neighbour wondered what he would do if he were in the loo during an earthquake.

Earthquake is a serious matter, but sometimes, it creates comical situations in high-rise buildings.

As we sat imagining and smiling at his predicament, he shyly disclosed that during the last quake sometime ago, he was literally caught with his pants down in the washroom. As the building shook suddenly, he was in a bind; to rush out in 'as is where is' position or move out after completing the ablution process.

We all laughed out loud and despite requests to tell us what eventually happened, he refused to disclose the state in which he came out.

In earlier times, earthquakes did not evoke much concern. This was because most dwellings were single-storeyed and had expansive courtyards to rush to. There was no pressure on space. And the two or three-storeyed ones were in most cases conjoined with neighbouring houses insulating each other against the tremors. But today's multistoreyed structures, notwithstanding architectural safeguards, have their own merits and demerits.



World Population In 2100 Could Be 2 Billion Below **UN Projections: Study**

arth will be home to 8.8 billion souls in 2100, two billion fewer than current UN projections, according to a major study published Wednesday that foresees new global power alignments shaped by declining fertility rates and greying populations

By century's end, 183 of 195 countries -- barring an influx of immigrants -- will have fallen below the replacement threshold needed to maintain population levels, an international team of researchers reported in The Lancet.

More than 20 countries -- including Japan, Spain, Italy, Thailand, Portugal, South Korea and Poland -- will see their numbers diminish by at least half.

China's will fall nearly that much, from 1.4 billion people today to 730 million in 80 years.

Sub-Saharan Africa, meanwhile, will triple in size to some three billion people, with Nigeria alone expanding to almost 800 million in 2100, second only to India's 1.1 billion.

"These forecasts suggest good news for the environment, with less stress on food production systems and lower carbon emissions, as well as significant economic opportunity for parts of sub-Saharan Africa," lead author Christopher Murray, director of the Institute for Health Metrics and Evaluation (IHME) at the University of Washington, told AFP.

"However, most countries outside of Africa will see shrinking workforces and inverting population pyramids, which will have profound negative consequences

for the economy. For high-income countries in this category, the best solutions for sustaining population levels and economic growth will be flexible immigration policies and social support for families who want children, the study concluded.

"However, in the face of declining population there is a very real danger that some countries might consider policies that restrict access to reproductive health services, with potentially devastating consequences," Murrav cautioned.

"It is imperative that women's freedom and rights are at the top of every government's development agenda." Social services and healthcare systems will need to be overhauled to accommodate much older populations.

As fertility falls and life expectancy increases worldwide, the number of children under five is forecast to decline by more than 40 percent, from 681 million in 2017 to 401 million in 2100, the study found.

At the other end of the spectrum, 2.37 billion people -- more than a quarter of the global population -- will be over 65 years old by then. Those over 80 will balloon from about 140 million today to 866 million.

Sharp declines in the number and proportion of the working-age population will also pose huge challenges in many countries.

"Societies will struggle to grow with fewer workers and taxpayers," noted Stein Emil Vollset a professor at the IHME.

Trump Says 'More White People' Killed By Police Than Black People

Washington: President Donald Trump has downplayed police violence against Black people in the United States, saying "more white people" are killed by police officers.

During a CBS News interview that aired on Tuesday, the Republican president was asked why Black people were still dying at the hands of law enforcement.

"And so are white people, so are white people. What a terrible question to ask. So are white people. More white people, by the way More white people," Trump responded.

According to a Washington Post analysis updated on Monday, nearly half of the people killed by police are white, while 23 percent are Black. But Black Americans, who account for only 13 percent of the population, are shot at a disproportionate rate compared with white Americans, who make up 60 percent of the population, according to the analysis.

The May 25 killing of 46-year-old George Floyd, a Black American

Iran-China Deal to Ditch Dollar, Bypass US Sanctions

TEHRAN: A top aide of Iran's supreme leader said on Wednesday that the roadmap for strategic partnership between Iran and China is to help ditch the dollar in bilateral trade and bypass unilateral US sanctions.

Ali Aqa-Mohammadi an advisor to Ayatollah Ali Khamenei, said the 25-year document is more than an "agreement" which usually encompasses just a certain issue.

The official said the partnership roadmap solidifies the two countries' economic and defensive cooperation by protecting their dealings from "third-party intervention." Press TV reported.

It would "close up and eliminate the key spots," where sanctions, including those targeting defense cooperation between the two countries, could be implemented, he said

"This document upsets the sanctions and the Iran-China roadmap disarranges many of the US plans," he said.

Washington reimposed the sanctions in 2018 after leaving a landmark nuclear deal with Iran despite its ratification by the United Nations Security Council (UNSC).

"Coordination of Iran and China can take the region out of the US' hands" by pushing Washington aside, breaking its sprawling regional network apart, and frustrating its attempts at isolating Tehran. Mohammadi, who is also a member of Iran's Expediency Council, stated.

Times reported Iran and China were nearing the conclusion of strategic partnership in defiance of the US, saying the deal foresees "a sweeping economic and secu-

According to The New York Times, the document also de-

scribes deepening military cooperation in a region that has been a strategic preoccupation of the United States for decades. It calls for joint training and exercises, joint research and weapons development and intelligence sharing.

India Bypassed

Meanwhile the Iran-India Chabahar port deal has run out of fuel. Iran has reportedly expelled India from the Chabahar rail project according to a report by The Hindu.

The railway project was meant to be part of India's vow to the trilateral deal between India, Iran and Afghanistan to develop an alternate trade route to Afghanistan and Central Asia bypassing a hostile Pakistan

With India-Iran relations touching an all-time low, the West Asian country has shown the door to India for two key projects - the second phase of Chabahar Port and development of Farzad-B block

Airlines Down On Knees Pleading For Help From Passengers

Paris: Airlines are pleading for help from their clients as they face paving customers back for flights cancelled due to the coronavirus pandemic that could starve them of cash, the industry said Wednesday. 'We are asking passengers for

help... that's true, and we're doing it on our knees," the head of the International Air Transport Association (IATA), Alexandre de Juniac said on French TV and radio station BFM Business.

lockdowns Coronavirus forced most flights to remain grounded and air travel is recovering slowly, putting airlines in perilous financial shape.

Airlines operating flights to and from Europe are supposed to reimburse passengers for cancelled flights within two weeks under EU law, but with the sup-

port of France and a number of other countries, airlines are offering vouchers or making clients wait sometimes much longer to get their cash back

Consumer groups have cried foul and the European Commission has opened a case against 10 EU member states including France for failing to enforce the regulations.

De Juniac said the industry was still trying to convince the European Commission to allow it use vouchers or give it more time to reimburse passengers.

"Why are we asking for this? Not for fun. Our business is more to pamper passengers than to pose problems for them, in particular financial problems," he said.

But "the cash flow of airlines is in an apocalyptic situation," he added. IATA said last month it expected the world's airlines to suffer \$84 billion in losses this year due to the coronavirus pandemic.

Qatar wins air blockade case at UN court

THE HAGUE: The UN's top court on Tuesday backed Qatar in a bitter row with four Middle East nations that imposed an air blockade against Doha after accusing it of backing militants and Iran.

The decision by the Interna tional Court of Justice (ICJ) covers a key part of the acrimonious standoff that erupted three years ago pitting Bahrain, Egypt, Saudi Arabia and the United Arab Emirates against Qatar.

Qatar said after the decision that its rivals would "face justice". "We welcome today's decision by the ICJ that will see the blockading states finally face justice for violating internation al aviation rules," Qatar Minister of Transport and Communications, Jassim Saif Ahmed al-Sulaiti, said in a statement.


The president of the ICJ. Abdulqawi Ahmed Yusuf, said The Hague-based court unanimously "rejects the appeal" by the rival states against a deci-

sion by the world civil aviation body in favour of Qatar over sovereign airspace.

The court also "holds that the International Civil Aviation Organisation (ICAO) has iurisdiction" in the case, by 15 judges to one, Yusuf said.

The ICAO in 2018 ruled it had the jurisdiction to handle a dispute brought by Qatar, which accused its neighbours of violating a convention that regulates the free passage of its passenger planes through foreign airspace.

But the four allies disagreed, saying the ICAO was not the right body to judge in the dispute and that its decision to do so was "manifestly flawed and in violation of fundamental principles of due process and the right to be heard". They had asked the ICJ to declare the aviation body's ruling "null and void and without effect". The Gulf states of Saudi Arabia, Bahrain, the UAE and other allies abruptly severed ties with Qatar in June 2017, accusing the gas- and oil-rich country of backing militants and Iran.

Speaking to reporters at the White House, Trump defended police departments, saying they "do an incredible job", adding: "You can have a rogue, terrible cop, on occasion like you do in any industry, any business, in any profession."

Already accused of not taking a clear stance against systematic racism and police brutality, Trump has escalated his rhetoric against the Black Lives Matter movement in recent weeks, focusing his comments on violence that breaks out occasionally on the fringes of peaceful demonstrations.

The recent nationwide protests have added prominence to a longrunning debate about the flying of the Confederate flag in parts of the country and whether statues honouring Confederate leaders during the US Civil War should be removed from public view.

Asked by CBS if the flag should be "taken down," Trump responded: "I know people that like the Confederate flag, and they're not thinking about slavery.

Many COVID-19 Deaths **Go Unreported In Kashmir: DAK** Covid is a hoax and the virus

SRINAGAR: Doctors Association Kashmir (DAK) on Wednesday said the actual number of COVID-19 deaths in Kashmir is higher than what is reported.

"Many COVID-19 deaths go unreported in Kashmir," said DAK President and influenza expert Dr Nisar ul Hassan in a statement.

'The official count of Covid-19 deaths in the valley is an underestimate and only provides a snapshot of the true death toll virus has taken," he said.

Dr Nisar said many people with Covid symptoms don't get tested for the virus because of the fear of stigma and quarantine of family members. "Social stigma makes people hide their illness and keep them away from seeking health care," he said.

Dr Nisar said people fear of the positive cases may be that if they die of Covid-19, they will not get a decent burial and few will come to their funeral. "As a result, people are choosing to die at home, unrecorded," he said.

"Another apparent deterrent to testing is widespread conspiracy theories about the virus. People believe that
