Hideout Busted In Kupwara: Army

Srinagar: A militant hideout was busted in Kupwara district of Jammu and Kashmir on Friday and arms and ammunition recovered, the Army said. 
Order Disciplinary Proceedings Against Troops For Exceeding AFSPA Powers

Ease of Doing Business

J&K ranks 21st in the EODB rankings released by the Department of Industry and Internal Trade (DPIIT). The ranking is based on the implementation of Business Reform Action Plan (BRAP).

The DPIIT started a reform exercise in 2014 to rank all states and union territories in India based on some reform parameters with the aim to create a business-friendly environment.

The first report titled "Assessment of State Implementation of (EODB) and Export Preparedness Business Reforms" was released in September 2015 covering the findings of reforms implemented by States/ UTs under the Business Reform Action Plan (BRAP).

Similar reports of the ranking came out in 2006 and 2017-18.

For the rankings of 2019-20, the feedback from service users and taining electric and water supply, etc. assessment is based only on the industries. The respondent data is

shared by the states through the BRAP portal.

The users are then surveyed by the DPIIT to determine the efficacy of the reforms.

Under BRAP 2019-20, feedback is only sought on those reforms. which has been implemented by the states and UT.

In 2017-18, Kashmir was put under the category of "aspirers" who have implemented less than 80 percent of reforms. The combine scoreboard of reform evidence and feedback of I&K was 32.76 percent.

For BRAP 2019-20, out of 187 reforms proposed by New Delhi, 137

were implemented in the region. Neighboring states of J&K- Himachal Pradesh (HP) and Punjab have implemented 175 and 178 reforms respectively. HP ranks 7th and Punjab ranks 19th in EODB.

However, the methodology used in the 2017-18 ranking is different from that of 2019.

The 2017-18 edition used state government and user feedback to compute the score, whereas in 2019 only business feedback (for whom the reforms were intended) was taken onto account.

After the abrogation of Article 370, business stood standstill for a long time in Kashmir. Covid, in 2020, further dented it.

Paytm App Back On Google Play Store After Being Pulled Down Briefly For Policy Violation

The app was back on the Google Play store on Friday evening after the Softbank-backed Paytm removed the 'cashback' feature from a recently-launched game on the application.

"Update: And we're back!," Paytm said in a tweet.

On Friday morning, Google removed the Paytm app -- which facilitates use of wallet and payments bank services -- from the Play store.

However, users who had already downloaded the app could continue using the services.

"Unfortunately, Google believes this to be a violation of its policies and has unlisted the Paytm Android app from the Play Store," the spokesperson told PTI. The spokesperson added that the cashback feature has been app has been restored on the Play store.

"An undetermined implication would be the compliance of its policies by sports fantasy apps like Dream 11 and MPL that are not directly available on the Google Play Store platform but feature in advertisements and inducing similar effect on its user, eventually leading to a violation of its gambling policies," she noted.

In a statement, the Federation of Indian Fantasy Sports (FIFS) said it had sought clarity from Google to ensure a level-playing field for all fantasy sports apps.

FIFS also said it has never asked for any company, such as MPL or Paytm, to have any negative repercussions whatsoever.

"We are here to protect all our members no matter their business size and treat all members/ non-members the same.

"In the past, FanCode and SportsTiger, sister brands of Dream11 and MyTeam11 respectively, were removed from the Google Play Store for violation of Google Play Store's policy as they were promoting their Fantasy Sports Apps," it added.

Army Admits 3 Slain Youth... from Rajouri who worked as labourers in Shopian had also filed a police

complaint.

In a brief statement, the Army said the Shopian operation contravened the dos and don'ts of the Chief of Army Staff approved by the Supreme Court.

"The inquiry has brought out certain prima facie evidence indicating that during the operation, powers vested under the AFSPA 1990 were exceeded and the Do's and Don'ts of Chief of Army Staff as approved by the Supreme Court have been contravened.

"Consequently, the competent disciplinary authority has directed to initiate disciplinary proceedings under the Army Act against those found prima-facie answerable," the statement said.

It is not immediately clear how many Army men are being proceeded against.

The evidence collected indicates the three unidentified (militants) killed in Amshipura were Imtiyaz Ahmed, Abrar Ahmed and Mohammed Ibrar who hailed from Rajouri. Their DNA report is awaited. "Their involvement with (militancy) or related activities is under investigation by the police," the statement said.

General Officer Commanding Lt Gen B S Raju had taken note of social media reports and initiated a probe into the incident. A general advertisement was published in local newspapers, asking people with any "credible information" about the case to step forward and share it with the court of inquiry instituted by the Army.

Relatives of the three youths, belonging to Dhar Sakri village in Kotranka of Rajouri area in Poonch, had lodged a written missing persons report in the local police station after they lost contact with them on July 17. The three were working as labourers in apple and walnut orchards in Amshipura.

The relatives said in their complaint that they had last spoken to the three on July 16 when they informed their families they had got a room in Amshipura.

The room was the site of the encounter two days later, the complaint stated.

Police is also probing the three youths' call details and why they jumped out of a window when an operation was launched at their rented accommodation, a police official said.

China made the first provocative military moves, after which India too deployed its troops at these locations. At these two places, both the countries' troops have fired warning shots to intimidate each other. The Chinese People's Liberation Army made attempts to occupy the area between Finger 3 and 4 earlier this month which led to the firing of around 200 shots in the air. Thereafter, both the armies are now a

few hundred meters apart. The mountain spurs jutting into the lake are referred to as 'Fingers' in military parlance. The PLA troops armed with spears and guns again tried to start a me-

dieval-style fight similar to the June 14 clash at Galwan Valley, in which 20 Indian soldiers and an unknown number of Chinese soldiers died. In the confrontation, shots were fired for the first time in 45 years along the Line of Actual Control.

It was after External Affairs Minister S Jaishankar and his Chinese counterpart Wang Yi reached an agreement in Moscow that the situation has calmed down a bit at the borders.

India has asked China to completely withdraw its troops from Pangong Tso. But China has refused to budge.

Both the countries are engaged in the current four-month-long standoff at the Line of Actual Control in eastern Ladakh. Despite several levels of dialogue, there has not been any breakthrough and the deadlock continues.

Chinese aggression started increasing along the LAC and more particularly in Galwan Valley since May 5. The Chinese side transgressed in the areas of Kugrang Nala, Gogra and the north bank of Pangong Lake on May 17 and May 18.

Govt's High-Power China...

At a nearly 90-minute meeting of the high-power China Study Group, Defence Minister Rajnath Singh, National Security Advisor Ajit Doval, Chief of Defence Staff Gen. Bipin Rawat and the three service chiefs also looked at further enhancing the vigil along the nearly 3,500-km-long Line of Actual Control (LAC), including in Arunachal Pradesh and Sikkim sectors, they said.

Army Chief Gen. M M Naravane briefed the meeting about the fresh face-offs between Indian and Chinese troops at both the north and south bank of the Pangong lake and elaborated on steps taken to effectively deal with such attempts, the sources said.

"The meeting of the China Study Group reviewed all aspects of the situation," said a source.

The meeting also deliberated on arrangements being made to maintain the current level of troops and weapons in all forward areas in eastern Ladakh and other sensitive high-altitude sectors in the harsh winter months when the temperature drops up to minus 25 degree Celsius.

The sources said the meeting also briefly touched upon the main talking points to be raised by the Indian side at the next Corps commander-level talks which is expected to focus on the implementation of an agreement reached between foreign ministers of India and China at a meeting in Moscow on September 10.

"By virtue of Jammu and Kashmir Reorganization Act 2019, the Right of Children to free and compulsory education Act, 2009 (Act) has been made applicable to the UT of J&K. No school or person while admitting a child, collects any capitation fee and subjects the child or his or her parents or guardian to screening procedure," the order reads.

The order also states that any school or person, if in contravention of the provisions of sub-section (1) receives capitation fee, shall be punishable with fine, which may extend to ten times from the capitation fee charged.

"To subject a child to screening procedure, shall be punishable with fine which may extend to twenty five thousands rupee for the first contravention and fifty thousand rupees for each subsequent contraventions," it reads.

"It is hereby ordered that no private school or person while admitting a child shall collect any admission fee from any child or his or her parents or guardians and such fee and if already collected in violation of the Right of Children to Free and Compulsory Education Act 2009 from the date of its applicability-that is from 31.10.2019 shall be refunded with immediate effect otherwise action under section 13 of the ACT shall be initiated forthwith," reads the order-(KNO)



Woman Injured As Guns...

"At about 1630 hours today, Pakistan army initiated unprovoked ceasefire violation by firing with small arms and intense shelling with mortars along the LoC in Balakote sector," a defence spokesman said. According to reports, a 34-year-old woman identified as Mehnaz Kouser of Sohala was injured in Pakistani firing. She was removed to the public health centre (PHC) Burthi for treatment.

Pakistan troops have violated the ceasefire agreement 31 times so far this month. officials said.

On Thursday, a soldier was injured in Pakistani firing in Balakote sector. An army personal was killed and two others, including an officer, injured on Tuesday as Pakistani troops violated ceasefire by using heavy fire and mortar shells along the LoC in Sunderbani sector of Rajouri district, according to officials.

On September 2, a JCO was killed in ceasefire violation by Pakistani troops along the LoC in Keri sector of Rajouri.

Earlier, Pakistani troops violated the ceasefire along the LoC in Gurez sector of Bandipora district, the defence spokesman said. The Indian Army effectively retaliated.

"Pakistan initiated an unprovoked ceasefire violation along the LoC at Kanzalwan in Gurez sector today morning by firing mortars and other weapons," defence spokesman Colonel Rajesh Kalia said. There were no reports of any casualties so far.

The Indian side was called upon to respect the 2003 Ceasefire Understanding, investigate this and other such incidents of deliberate ceasefire violations and maintain peace along the LoC and the WB, the Foreign Office said.

"We will insist on early and complete disengagement of Chinese troops from all friction points. That is the first step for restoration of peace and tranquillity along the border," said a source.

The sources said the Chinese People's Liberation Army(PLA) is yet to respond to the Indian Army's communication to it on holding the next round of the Corps commander-level talks.

"There is no date as of now as the Chinese military is yet to respond to it. The talks could take place sometime next week," a source said. The two sides have so far held five rounds of talks at the level of Corps commanders.

The sources said the situation remained tense at both the north and south bank of the Pangong lake area as well as at other friction points in eastern Ladakh.

There have been at least three attempts by the PLA to "intimidate" Indian troops along the north and south bank of Pangong lake area in the last three weeks where even shots were fired in the air for the first time at the LAC in 45 years.

External Affairs Ministry Spokesperson Anurag Srivastava on Thursday said China should take forward the process for complete disengagement of troops from all friction points including at the Pangong lake area, and asked it not to make unilateral attempts to change the status auo

He said both sides should focus on easing tensions in the friction areas by refraining from any actions that may lead to an escalation in the situation.

The assertion by Srivastava came in the backdrop of remarks by Chinese foreign ministry on Wednesday that it was for India to initiate the process to disengage and restore peace along the LAC.

Both sides reached a five-point agreement to resolve the border standoff at a meeting between External Affairs minister S Jaishankar and his Chinese counterpart Wang Yi on September 10 on the sidelines of a Shanghai Cooperation Organisation(SCO) meet in Moscow.

The agreement included measures like quick disengagement of troops, avoiding action that could escalate tensions, adherence to all agreements and protocols on border management and steps to restore peace along the LAC.

The situation in eastern Ladakh deteriorated after China unsuccessfully attempted to occupy Indian territory in the southern bank of Pangong lake on the intervening night of August 29 and 30.

India occupied a number of strategic heights on the southern bank of Pangong lake and strengthened its presence in Finger 2 and Finger 3 areas in the region to thwart any Chinese actions. China has been occupying the areas between Finger 4 and Finger 8. The mountain spurs in the area is called Fingers.

China has strongly objected to India's move. However, India has maintained that the heights are on its side of the LAC.

India has also rushed in additional troops and weapons to the sensitive region following China's transgression attempts.

Following China's fresh attempts to change the status quo in the southern bank of Pangong lake, India has further bolstered its military presence in the region.

Khan will be calling upon the Indian government to immediately restore internet services in J&K, release all prisoners, especially the civil society members and journalists, remove Armed Forces Special Powers Act, Public Safety Act and other laws, and allow independent media and international human rights observers to visit the region to independently observe the situation in Jammu and Kashmir, the source maintained.

Khan will be calling on UN member countries to pressure India over Kashmir and ask the member states to push New Delhi on table talks with Pakistan over the Kashmir dispute.

Khan will also talk about the initiation of the Afghan dialogue process, highlighting Islamabad's efforts to ensure that the dialogue for Aghan peace becomes a reality. The Pakistan premier is also expected to drag India in it as well, calling it a 'spoiler', which intends to destabilise the peace process.

Khan is also expected to reaffirm Pakistan's all out alliance and support to China over its dispute with India.

The EPI is done to assess the readiness of the states in terms of their export potential. The readiness is measured based on four pillars (policy, business ecosystem, export ecosystem, and export performance), 11 sub-pillars and 55 indicators.

Gujarat at 75.19 emerged as the leading state followed by Maharashtra (75.14) and Tamil Nadu (64.93).

The scores of J&K in the four pillars are- policy pillar: 0, business ecosystem pillar: 14.92, export ecosystem: 5.63 and export performance pillar: 25.87.

Under the business ecosystem pillar, the sub-pillars like business environment, infrastructure, transport connectivity, and access to finance scored 7.82, 0, 48.29 and 3,56 respectively.

Some important indicators like labour reforms, number of investor summits, single-window clearance scored zero.

In the case of the export ecosystem, sub-pillars like export infrastructure, trade support and R&D infrastructure scored 9.83, 0, and 2.86 respectively

Growth and Orientation and export diversifications sub-pillar under export performance scored 6.96 and 44.78 respectively.

According to the report, "There is a high scoring range amongst Indian states on the EPI where Gujarat has the highest score of 75.14 and Jammu & Kashmir with the lowest score of 12.27."

Since the report considers the data from 2016-17 up to 2018-19, J&K is being considered as a state and is grouped under the landlocked category.

Among the other landlocked states like Raiasthan, Telangana, Harvana, Chhattisgarh, Uttar Pradesh, Madhya Pradesh, Jharkhand, Punjab, Assam, and Bihar, J&K has scored the least (12.27) in export preparedness. The report mentions that J&K needs to improve its performance under the policy and the export ecosystem pillars, considering that it "indicates a glaring paucity in both enabling and facilitating factors that could drive the states towards export-oriented growth."

As per the report, Kashmiri shawls have the highest Market Performance Index in J&K. It is exported to 44 countries and accounts for 17.8 percent of the share in the erstwhile state's total export.

Other items having high Market Performance Index are carpets, medicine put up for retail sale, shelled walnuts, basmati rice, yarn of polyester and derivatives of pyridine.

NGDRS Launched in J&K

NGDRS switches existing manual system to online registration

SRINAGAR : Lieutenant Governor, Manoj Sinha launched the National Generic Document Registration System (NGDRS) at a ceremony organized at Deputy Commissioner Srinagar's office, today.

NGDRS represents a major shift from the existing manual registration system to online registration of all transactions in salepurchase/transfer of land and the stamp papers have been replaced by e-stamps which have been incorporated in coordination with Stockholding Corporation of India. J&K will be the 10th among States/UTs to become part of NGDRS.

Speaking on the occasion the Lt Governor remarked that today's launch marks another step of the government towards the establishment of an accountable and transparent governing system where the welfare of common citizen is at the core. The overall intent is to ensure hassle-free service delivery and transparency in the registration process by online uploading of the document, appointment with the registration office, e-stamp, and a one-time visit to the Registration office. The entire process has been reduced to 15 minutes which earlier would take several days in view of

multiple steps involved. Now all 5 steps are under the digital process. The Lt Governor handed over

an Endorsement Deed and an estamp generated through NGDRS to a Srinagar resident marking the launch of NGDRS. Earlier, Deputy Commissioner,

Srinagar, Dr. Shahid Iqbal Choudhary briefed the Lt Governor about the progress of Land Record Digitization in the district. He informed that apart from 100% updation of Jamabandis and digitization under completion, 558 estates have been digitised and updated on NGDRS Portal. A revenue of Rs 46 Cr has

been generated in district Srinagar so far and NGDRS will entail an ease of doing business both for revenue department and land owners/ buyers.

In the first phase, apart from District Srinagar four other districts viz. Jammu, Samba, Kathua and Udhampur have also been included under NGDRS coverage. The Lt Governor directed the officers to launch the system in the rest of the Union Territory before 31st October 2020. He remarked that the launching of NGDRS is a big step towards National Integration and a leap towards 'One Nation One Software'.



Alterations to the status quo open up a Pandora's Box. They have a snowballing effect. This is proved not only in border disputes that India currently has with China and Pakistan, but also with Nepal, a friendly Hindu country, that has claimed areas in the map that supposedly belong to India.

India did something unprecedented. It abrogated Article 370 of the Constitution that gave the state of Jammu & Kashmir special status, and it downgraded the state into the union territories of Jammu & Kashmir and Ladakh. The state's elected leaders, Farooq and Omar Abdullah, and Mehbooba Mufti among others, were placed under house arrest. Did the Government of India realize then that its brash action would have farreaching consequences?

n August 2019, the Government of

Soon after the abrogation of Article 370, the Government of India's next tactical move was to hurriedly pass the Citizenship Amendment Bill (CAB) in both houses of the parliament. The bill unjustly singled out Muslims for the right to citizenship. This outraged not just Muslims but all democratic Indians with a sense of justice. There were student protests against the CAB in college and university campuses across the country.Not just in JamiaMilia, JNU and Aligarh Muslim University but also in my university, the University of Pune, led by student leaders like Satish Gore.

To add insult to injury, the Home Minister, Mr. Amit Shah, spoke of a National Register of Citizens (NRC) as the next step. Once again, there were apprehensions that Muslims would be excluded from the NRC, though on paper, the Government of India vehemently denied this.

Ironically, the Citizenship Amendment Bill turned people, who otherwise may have felt that the scrapping of Article 370 wasn't such a bad idea after all, against the regime. These were moderate Indians who believed that Balakot was a fitting and much-needed answer to Pulwama. But they now began to see though the government's treacherous game plan. They were able to join the dots and estab-



lish connections between the abrogation of Article 370, and the CAB and NRC.

The agitation against the CAB and proposed NRC culminated in protests by women activists in Delhi's ShaheenBagh and riots in North East Delhi. But then, the Covid-19 pandemic, and the lockdown it necessitated, put an abrupt end to the campus and ShaheenBaghagitations.

In Jammu & Kashmir, though, the lockdown triggered by the novel corona virus wasn't a novelty. The state-now comprising two union territories-was in a state of lockdown since the abrogation of Article 370. Foreign TV channels like Al Jazeera that managed to sneak into Kashmir, portrayed a grim picture of what went on inside. They interviewed HameedaNayeem, Head of the Department of English at Kashmir University, who spoke of the learning process of school and college students being retarded; and of barriers having been put on the free flow of learning as a result of political

developments.

Yet the Government of India politicized even the pandemic. It viciously held a Muslim sect, known as TablighiJamaatis, who attended a religious event at the NizamuddinMarkaz in Delhi, as responsible for the spread of corona in India. That this was false is proved by a recent Delhi High Court ruling which states that there is no evidence that the people who attended the congregation were in any way accountable for India's growing corona numbers. It is clear that the government made the TablighiJamaatis scapegoats only because they were Muslim. No insinuations were made against Hindu shrines that attracted the same crowds of devotees around the same time

Today, the ramifications of the abrogation of Article 370 resurface in India's Ladakh standoff with China.

Wang Shida, Deputy Director at the China Institute of Contemporary International Relations, who specializes in South Asian studies, and Wang Xianfeng, a Chinese diplomat who is press officer at the Chinese embassy in Pakistan, believe that, "India's actions of unilaterally changing the status quo of Kashmir...have posed a challenge to the sovereignty of China and Pakistan, and made India's relations with its two neighbours more complex.'

According to Wang Shida, in the wake of the abrogation of Article 370, India opened up new territory on the map, incorporating areas formerly under Xinjiang and Tibet into Ladakh, which was now a separate union territory. This angered China. Its intrusions across the LAC in Ladakh are thus seen as an act of vendetta.

As far as the newly formed union territory of Jammu & Kashmir is concerned, Wang Shida is of the view that India illegally included areas under Pakistan Administered Kashmir within it.

The abrogation of Article 370 and the downgrading of the state of Jammu & Kashmir into two union territories have altered the status quo. Alterations to the status quo open up a Pandora's Box. They have a snowballing effect. This is proved not only in border disputes that India currently has with China and Pakistan, but also with Nepal, a friendly Hindu country, that has claimed areas in the map that supposedly belong to India.

Needless to say, there will be other implications that the abrogation of Article 370 will have in the months to come. But all we can do is wait and watch.

Biden, a "Lesser Evil" ? Yes, Trump is an American monster but so is Biden.

nce again it is presidential election season in the United States and once again progressive critical thinkers who care about the future of our humanity find themselves in a quandary - to get rid of the wicked Donald Trump and his corrupt family and cronies should they or should they not opt to vote for yet another corporatist liberal, Joe Biden. It is deja vu, it is a rerun of a tired old movie, it is Groundhog Day: We had it with Trump and Hillary Clinton last time, and we have it again with the same Trump and even worse Biden now

I completely sympathise with the leading American public intellectuals caught in this snare.

Cornel West, the eminent African American philosopher, for example, says he is planning to cast an "anti-fascist" vote for Biden in November despite his concerns about the former vice president's ties to "Wall Street and militarism". West knows all too well Biden will betray every single ideal and principle for which West stands, but he is so disgusted with Trump - and rightly so - he is doing what in Persian we call "jumping from one crumbling column to another with hope".

The same is true with Noam Chomsky, the worldrenowned linguist and political activist who is also on the record encouraging people "to vote for Joe Biden and then haunt his dreams" - whatever that may mean. Politicians like Trump or Biden do not dream for us to haunt their dreams. They are the definitions of nightmares. Neither Trump nor Biden is to be trusted, and Chomsky knows that. But he is jumping from one crumbling column to another - is it with hope or is it in despair?

The revolutionary thinker and activist Angela Davis too has said she is supporting Biden for president, calling it crucial to back the candidate "who can be most effectively pressured". But really? How so? Biden could not tolerate a single BDS-backing Palestinian activist, Linda Sarsour, taking part in his campaign and swiftly moved to kick her out. That is the sort of zealot Biden is. What sort of "pressure" can one hope to exert on him?

Between a rock and a hard place

Still, the terrorising presidency of Trump and the Dark Ages of ignorance and criminal racism he

has unleashed in the US, make it perfectly understandable why these and many other eminent critical thinkers who would not be caught dead with Biden are now rushing to declare their support for him. They are jumping from one crumbling column to another and forming a strategic alliance in the hopes that once Trump is out of the picture they can charge ahead beyond Biden's perilous promises.

But I write this essay to differ with these towering moral figures and openly declare that I will not vote for Biden. This is not to say I am more principled than them or care less about the consequences of yet another calamitous term of Trump. For the future of my own and millions of other American children I hope and wish for a day he is collected from the White House and taken to prison or asylum - whichever is closer.

But still, I will never vote for Biden for I believe the function of people like me is entirely different from even those among the American left with whom I wholeheartedly identify. The task of critical thinking at this point is not to rush to declare we are voting for Biden - an unrepentant racist and self-declared Zionist with a frightening record of misogyny who has actively supported the Iraq war. We had a far superior choice in Bernie Sanders, but twice in a row, the Democratic Party made absolutely sure to kill his chances.

The task at hand is to sustain the course of critical thinking that could not possibly embrace Biden. Voting for Biden is voting for the very foundation of a political culture that has a whole platoon of Trumps and Bidens waiting to surface. If we choose between Trump and Biden today, next time we will have to choose between Ivanka Trump and Chelsea Clinton. This vicious cycle can only come to an end through a sustained and uncompromising course of critical thinking against the very grain of this political culture that demonises the Black Lives Matter uprising. celebrates neo-Nazis, and canonises Hillary Clinton and Biden as God-given salvation against this murderous banality.

A fateful moment

It was Barack Obama's speech that sealed my decision to never vote for Biden. Up until then, I was thinking to myself that a vote for Biden is not actually a vote for him, but a vote against Trump, alongside other such tall tales and poor excuses. But when Obama took to



the podium and began to get emotional and pleaded for people to go and vote for Biden, right there and then, I decided it would be obscene of me to do so, especially with this hypocritical con man on his side

Every time Obama starts choking up, I remember him crying in public for children who have fallen victim to gun violence in the US, just before going back to his Oval Office to send even more arms to Israel with which to slaughter Palestinian children, or sell them to Saudi Arabia and the United Arab Emirates to kill more Yemeni children. Are Palestinian and Yemeni children not children? Every single human being stands for the entirety of our humanity. How could this coward be so openly cruel and callous when it comes to children in Yemen, Palestine, Afghanistan and beyond, and still pretend to care deeply about America's children?

Biden is even worse than Obama in his die-hard Zionism - in his support for the apartheid state of Israel, in his categorical disregard for Palestinians. Voting for Biden means excusing all the times in the past he helped arm Israel to murder Palestinians. Voting for him means, should he become the next president, siding with him every time he signs - and he will undoubtedly sign many - a new arms deal to support Israel and its murderous tyranny.

Why would any decent human being want to do anything like that? Yes, Trump is an American monster but so is Biden. People like me have no candidate in this election.

The ethics of ultimate responsibility

The task of my sort of critical thinkers is not to jump on the bandwagon and rush to vote for Biden and his running mate, Kamala Harris, reluctantly. Generations of critical thinkers from Rosa Luxemburg to Aimee Cesaire to Frantz Fanon to Edward Said to Arundhati Roy did not live and think and write for us to cast a strategic vote for a reactionary liberal, an unrepentant warmonger, a hardcore Zionist, with a record of racism and alleged sexual abuse. Our task is something else.

In his famous essay, Politics as Vocation (1919), the eminent German sociologist Max Weber made a crucial distinction between an "ethics of responsibility" and an "ethics of ultimate end" that to this day remain a hallmark of a moral choice in politics: "We must be clear," he told his audience at the University of Munich, "about the fact that all ethically oriented conduct may be guided by one of two fundamentally differing and irreconcilably opposed maxims: conduct can be oriented to an 'ethic of ultimate ends' or to an 'ethic of responsibility'." These are two identically ethical acts, but in two diametrically opposed directions.

Weber further clarified: "This is not to say that an ethic of ultimate ends is identical with irresponsibility, or that an ethic of responsibility is identical with unprincipled opportunism. Naturally, nobody says that." Be that as it may, he still insisted: "There is an abysmal contrast between conduct that follows the maxim of an ethic of ultimate ends ... and conduct that follows the maxim of an ethic of responsibility, in which case one has to give an account of the foreseeable results of one's action.'

But in between the two choices Weber left us, emerges a third: An ethic of ultimate responsibility. Our specific and ultimate responsibility today is not to rush to vote for a lesser evil, as I also argued about four years ago when the choice was between Trump and Clinton, but to sustain the course of critical thinking that seeks to overcome both evils. More than 300 million human beings trapped to choose between a Coke and a Pepsi deserve and must strive for a healthier choice. An entire planet at the mercy of US militarism and warmongering most certainly has everything to lose from either of these two American calamities.

The Curious Case Of Women's Inheritance Rights In Kashmir

women are conditioned or (precisely) indoctrinated to forgo her property rights in the name of some constructed sense of feminine generosity and benevolence. atriarchy, like any other forms of injustice feeds itself on the detritus of disinformation: by twisting the truths and realities. Unjust societies have a default embedded paraphernalia in place toreproduce themselves in new forms. Such societies incubate the culture of silence over telling issues to the point that they become non-existent or non-issues. One such issue which by the dent of our collective disservice has metamorphosed into a non-issue in Kashmir is the question of women's property rights or the rights of inheritance. Women, over the ages have either been conditioned not to seek her share in property or the subject of women's property rights

Womenfolk,todayare challenging stereotypes and reclaiming their agency in realms which hitherto were monopolised by men. However, even in the present times, women seem to be inheriting genetic docility when it comes to the question of property rights. Inheritance rights of women guaranteed by Islam long usurped by the patriarchal ghost don't even exist in name; nor is any data available on the subject which makes the case even worse.

While our society keeps strict and detailed manuals of expectations that women must fulfil without fail; educating them about their property rights in particular and other array of rights is apparently deigned subversive. In fact, women are conditioned or (precisely) indoctrinated to forgo her property rights in the name of some constructed sense of feminine generosity and benevolence. While women breaking the silence over the injustice is bound to offend the patriarchal sensibilities, thistopic remains nearly untouched in routine conversations, Friday khutbas, public debates, media and every other platform which could prove to be icebreakers in this regard.

Islamic legislation in this respect is not only comprehensive but based on justice. It provides for the rights of inheritance for both men and women in a way that maintains social equilibrium. The force with which these rights were at first pronounced in Surah Nisa of Quran was subversive to the existing system of inheritance which was managed by men and favourable to men alone. As the verse goes, "men shall have a share in what parents and kinsfolk leave behind, and women shall have a share in what parents and kinsfolk leave behind, whether the property be small or large- a determinate share" (Qur'an, 4 : 7). Further in verse 32 of the same chapter, economic rights of both men and women have been ascertained as,"men shall have a benefit of what



they earn and women shall have a benefit of what they earn".

The aforementioned verses are followed by many other allied verses which lay down the legal framework for inheritance. Surprisingly, in more cases than one, female heirs receive a larger share of property than their counterparts. It is a subject which escapes our notice partly because of tainted social-construction of the subject and partly owing to our fragmented and irresponsible understanding of religion. Islamic legislations aim at ascertaining the overall wellbeing of its adherents which by default includes economic well-being but the entire structure of rights has been foreshadowed by androcentric propensities of the society.

Islam came as a liberatory force for women and toppled male-controlled economic system of that period in favour of women. The whole concept of women's rights of inheritance was alien to the society of 7th century which adhered strictly to the system of male primogeniture.

Being a Muslim majority society, we seem to have deeply cultivated an unjust system against the equitable spirit of our religion. Unfortunately, lavishing our life-time earnings in ostentatious marriages still finds more meaning with us than upholding the rights of already marginalised section of our society. We have reversed the sacred law quite conveniently and established a system of injustice where women are devoid of cultural and economic capital guaranteed to them by their Maker.

The Lost Word: Acedia A forgotten word which is perfect to describe what we're feeling during the pandemic lockdown

www.ith some communities in rebooted lockdown conditions and movement restricted everywhere else, no one is posting pictures of their sourdough. Zoom cocktail parties have lost their novelty, Netflix can only release so many new series. The news seems worse every day, yet we compulsively scroll through it.

We get distracted by social media, yet have a pile of books unread. We keep meaning to go outside but somehow never find the time. We're bored, listless, afraid and uncertain.

What is this feeling?

John Cassian, a monk and theologian wrote in the early 5th century about an ancient Greek emotion called acedia. A mind "seized" by this emotion is "horrified at where he is, disgusted with his room ... It does not allow him to stay still in his cell or to devote any effort to reading". He feels:

such bodily listlessness and yawning hunger as though he were worn by a long journey or a prolonged fast ... Next he glances about and sighs that no one is coming to see him. Constantly in and out of his cell, he looks at the sun as if it were too slow in setting.

This sounds eerily familiar. Yet, the name that so aptly describes our current state was lost to time and translation.

Noonday demon

Etymologically, acedia joins the negative prefix a- to the Greek noun k dos, which means "care, concern, or grief". It sounds like apathy, but Cassian's description shows that acedia is much more daunting and complex than that.

Cassian and other early Christians called acedia "the noonday demon", and sometimes described it as a "train of thought". But they did not think it affected city-dwellers or even monks in communities.

Rather, acedia arose directly out the spatial and social constrictions that a solitary monastic life necessitates. These conditions generate a strange combination of listlessness, undirected anxiety, and inability to concentrate. Together

these make up the paradoxical emotion of acedia.

Evagrius of Pontus included acedia among the eight trains of thought that needed to be overcome by devout Christians. Among these, acedia was considered the most insidious. It attacked only after monks had conquered the sins of gluttony, fornication, avarice, sadness, anger, vainglory, and pride.

Cassian, a student of Evagrius, translated the list of sins into Latin. A later 6th century Latin edit gave us the Seven Deadly Sins. In this list, acedia was subsumed into "sloth", a word we now associate with laziness.

Acedia appears throughout monastic and other literature of the Middle Ages. It was a key part of the emotional vocabulary of the Byzantine Empire, and can be found in all sorts of lists of "passions" (or, emotions) in medical literature and lexicons, as well as theological treatises and sermons.

It first appeared in English in print in 1607 to describe a state of spiritual list-

lessness. But it's barely used today.

Making like monks

As clinical psychology has reclassified emotions and mental states, terms like "melancholy" can sound archaic and moralising.

Emotional expressions, norms, and scripts change over time and vary between cultures. They mark out constellations of bodily sensations, patterns of thought and perceived social causes or effects.

Since these constellations are cul-

turally or socially specific, as societies change, so do the emotions in their repertoire. With the decline of theological moralising, not to mention monastic influence, acedia has largely disappeared from secular vocabularies.

Now, the pandemic and governmental responses to it create social conditions that approximate those of desert monks. No demons, perhaps, but social media offers a barrage of bad (or misleading) news.

Social distancing limits physical contact. Lockdown constricts physical space and movement. Working from home or having lost work entirely both upend routines and habits. In these conditions, perhaps it's time to bring back the term.

More than a label

Reviving the language of acedia is important to our experience in two ways.

First, it distinguishes the complex of emotions brought on by enforced isolation, constant uncertainty and the barrage of bad news from clinical terms like "depression" or "anxiety".

Saying, "I'm feeling acedia" could legitimise feelings of listlessness and anxiety as valid emotions in our current context without inducing guilt that others have things worse.

Second, and more importantly, the feelings associated with physical isolation are exacerbated by emotional isolation – that terrible sense that this thing I feel is mine alone. When an experience can be named, it can be communicated and even shared.

Learning to express new or previously unrecognised constellations of feelings, sensations, and thoughts, builds an emotional repertoire, which assists in emotional regulation. Naming and expressing experiences allows us to claim some agency in dealing with them.

As we, like Cassian's desert monks, struggle through our own "long, dark teatime of the soul", we can name this experience, which is now part of our emotional repertoire.

UN Asks Billionaires For Help As 270 Million People Face Starvation

United Nations: UN food chief David Beasley called on the world's billionaires on Thursday to step up to help save some 30 million people he said are at risk of dying if they don't receive help from the World Food Programme.

Globally some 270 million people were headed toward the brink of starvation and WFP hopes to reach 138 million people this year, Beasley told the **UN Security Council**

"We need \$4.9 billion to feed, for one year, all 30 million people who will die without WFP's assistance." Beasley said, noting that there are some 2.000 billionaires with a net worth of \$8 trillion and several made billions during the pandemic.

"Lam not making money, but humanity is facing the greatest crisis any of us have seen in our lifetimes," said the former South Carolina governor. The combined wealth of America's billionaires jumped over 19% or by half a trillion since the outbreak of the novel coronavirus pandemic in the United States, according to a report published by the Institute

Moscow: Russia has approved R-Pharm's Coronavir treatment for outpatients with mild to moderate COV-ID-19 infections and the antiviral drug could be rolled out to pharmacies in the country as soon as next week, the company said on Friday.

Pakistan govt sends arrest warrants for Nawaz Sharif

Islamabad: The Pakistan government has sent arrest warrants through its mission in London for deposed prime minister Nawaz Sharif, who has been living in the UK for medical treatment, a media report said on Friday.

Sharif (70) has been in London since November last year after the Lahore High Court granted him permission to go abroad for four weeks for treatment.

The three-time premier, his daughter Maryam and son-in-law Muhammad Safdar were convicted in the Avenfield properties case on July 6, 2018.

Sharif was also sentenced to seven years in the Al-Azizia Steel Mills case in December 2018, but he was bailed out in both cases and also allowed to go to London for medical treatment. He was given eight weeks to return but failed to come back due to health complications, according to his lawyer. The Pakistan High Commission in London has received arrest warrants sent by the government for Sharif, the Dawn newspaper reported.

The documents were received on Thursday but the mission did not make an official comment on the development, it said.

However, sources confirmed to the newspaper that the mission had received the papers to serve the arrest warrants on Sharif, who has been living in London for treatment, the report said.

The sources added that all legal formalities and procedures would be followed.

Earlier, the assistant reg istrar of the Islamabad High Court (IHC) directed the foreign secretary to ensure production of the former prime minister before the court on September 22.

The secretary has been told to "cause the production of the appellant (Mr Sharif) through the High Commission of Paki stan in the United Kingdom" by 11 am on September 22. The IHC earlier this week had issued non-bailable arrest warrants for Sharif while dismissing his application seeking exemption from personal appearance in the hearing of appeals against his conviction in the Al-Azizia and Avenfield properties references



AI-Based Cameras Detect Rail Travellers With Fever, Without Masks



NEW DELHI: Technology has come to the rescue of the Indian Railways--operating 310 passenger, Mail and Express trains as of now across the country--in detecting passengers with coronavirus-like symptoms, as Artificial Intelligence-based surveillance cameras have so far detected 28 passengers with mild fever before they could get on board.

"Central Railway (CR) has taken several measures to prevent Covid-19 spread. In order to effectively scan the passengers for COVIDlike symptoms, CR has set up a body screening facility (FebriEye) at the Chhatrapati Shivaji Maharaj Terminus (CSMT) and Lokmanya Tilak Terminus (LTT) in Mumbai," CR spokesperson Shivaji Sutar told IANS.

It not only ensures contactless entry for travellers to avoid the spread of coronavirus but also helped detect 28 passengers whose body temperature was above normal.

"They were not allowed to travel by trains and advised to go for medical check-up and further necessary medical action," he added.

The CR is using the Febri-Eye human body screening facility developed by Vehant Technologies, which is a thermal and vision camera that not only measures forehead temperature but also detects face mask and social distancing violations.

Sutar said that FebriEye cameras can cover a large area for scanning, which means these can detect and trains. -- IANS

'New Rapid Covid-19 Test With Improved Sensitivity Developed'

esearchers have developed a new rapid test for the detection of the novel coronavirus that can be performed in less than an hour, and with minimal equipment, and "can detect nearly as many cases as the standard CO-VID-19 diagnostic."

With further research, the scientists, including those from the Massachusetts Institute of Technology (MIT) in the US, said the new test, known as STOPCovid, could be made cheaply enough so that people could test themselves every day.

In the study, published in the New England Journal of Medicine, the researchers showed that the new test detected 93 per cent of the positive cases as determined by conventionally used COVID-19 diagnostic.

"We need rapid testing to become part of the fabric of this situation so that people can test themselves every day, which will slow down outbreak," said study co-author Omar Abudayyeh from MIT.

The researchers hope the test could be further developed for use in point-of-care settings, such as doctors' offices, pharmacies, nursing homes, and schools.

They explained that such tests depend on an RNA extraction process and multiple liquid-handling steps that increase the risk of cross-contamination of samples.

"We developed STOPCovid so that everything could be done in a single step," said Julia Joung, another coauthor of the study from MIT.

"A single step means the test can be potentially performed by nonexperts outside of laboratory settings," Joung said.

In the latest version of STOPCovid, reported in the study, the researchers incorporated a process to concentrate the viral genetic material in a patient sample by adding magnetic

beads that attract RNA. They said this step eliminates the study from MIT.

According to the researchers, this concentration step boosts the test's sensitivity so that it now approaches that of the conventionally used PCR diagnostic method.

'Once we got the viral genomes onto the beads, we found that that could get us to very high levels of sensitivity," said Jonathan Gootenberg, another co-author of the study.

The researchers tested STOPCovid on 402 patient samples -- 202 positive and 200 negative -- and found that it detected 93 percent of the positive cases as determined by the standard US Centers for Disease Control and Prevention's (CDC) PCR test. They said the STOPCovid test works on samples taken using the

Dubai Suspends Air India Flights For Bringing Covid-Positive Passengers

NEW DELHI: The Dubai Civil Aviation Authority has suspended Air India Express flights till October 2 for allegedly bringing passengers with COVID-positive certificates twice during the last couple of weeks, senior government officials said on Friday.

As per the UAE government rules, each passenger travelling from India need to bring original COVID-negative certificate from RT-PCR test done 96 hours prior to the journey.

"Å passenger, who had a COVID-positive certificate dated September 2, travelled on Air India Express' Jaipur-Dubai flight on September 4. A similar incident had happened with a passenger on one of the airline's other Dubai flights previously," said one of the officials. Therefore, the Dubai Civil

Aviation Authority has suspended Air India Express flights from September 18 to October 2, the officials stated. Both the incidents of passengers flying with COVIDpositive certificates to Dubai



NEW DELHI: Parliament today passed a bill to reduce for one year the salaries of MPs by 30 per cent "to meet the exigencies arising out of CO-VID-19 pandemic".

Rajya Sabha passed the Salary, Allowances and Pension of Members of Parliament (Amendment) Bill, 2020. It had got the approval of Lok Sabha on Tuesday.

The bill was introduced in the upper house by Parliamentary Affairs Pralhad Joshi on Thursday.

salaries and allowances of ministers by 30 per cent for a year, to meet the exigencies arising out of the COVID-19 pandemic.
