Two Medium-Intensity Quakes Hit Ladakh

New Delhi: Two medium-intensity earthquakes of magnitude 5.4 and 3.6 hit the Ladakh region on Friday, the National Centre for Seismology (NCS) said. The first guake of magnitude 5.4 occurred at 4.27 pm at a depth of 10 kms and the second quake of magnitude 3.6 at a depth of 10 kms hit the region at 5.29 pm, it said. The Himalayan region is known for high seismic activities.

Car Falls Into Kathua Gorge, 2 Dead

Kathua: Two persons were killed and a minor girl seriously injured when a car they were travelling in skidded off the road and rolled down into a 100-feet gorge in Jammu and Kashmir's Kathua district on Friday, officials said. The car, which was going from Sandhar to Bhoond in the district, skidded off the road and rolled down into the deep gorge at Jandarli belt of Basholi area, they said. DNA Confirms 3 Slain Shopian 'Militants' Were Labourers

SRINAGAR: The DNA samples of three men who were killed in an alleged fake encounter with the Army in Jammu and Kashmir's Shopian district in July have matched with their families from Rajouri, a senior police officer said on Friday.

Asked whether the three men were indeed labourers, as claimed by their families, and not involved in militant activities, he said it is a matter of further investigation.

The relatives of three youths, belonging to Dhar Sakri village in Kotranka of Rajouri area in Poonch, had lodged a written missing persons report at the local police station after they lost contact with them on July 17.

In their complaint, they informed the police that they had last spoken to the three, who were mainly involved in apple and walnut trading, on July 17 when the youths had informed their families that they had got a room at Ashimpora in Shopian.

SRINAGAR: The Jammu and Kashmir Police on Friday said it has constituted a special investigation team (SIT) to probe the killing of advocate Babar Qadri who was shot dead by unidentified gunmen here on Thursday.

Speaking to reporters at a press conference here, Inspector General of Police, Kashmir, Vijay Kumar said the case was a top priority for the force and an SIT has been formed to probe it.

On whether it had been established that the three men were labourers and not involved in any militant activities, Kumar said, "The police are now taking up further investigations in the case."

The Army completed its inquiry into the matter in a record four weeks.

On September 18, the force said it had found "prima facie" evidence that its troops "exceeded" powers under the Armed Forces Special Powers Act (AFSPA) during the encounter and has initiated disciplinary proceedings.

Will there be any change? Will the sanctity of human life be restored? No. nothing will change. This encounter was exposed by our media forcing initiation of investigation. As hiding it in today's digital age was not possible. My thoughts with the 3 men murdered in cold blood, Lone wrote on his Twitter handle.

Had this been the first time, one could have hoped it won't happen again. It is not the first time and not the last time. There is no deterrence and in Delhi there is a lot of tolerance for HR violations in Kashmir. Justice will be ornamental unless it is divine, he added.

In a statement issued here, a PDP spokesperson said that the policy of incentivizing killings has been at the core of many instances of "murder for medals" in the past as well and that it is about time that the government makes Shopian incident an example to ensure justice & create deterrence. "With the statements of the army and the police as well as the conclusive forensic reports, it is amply clear that what happened in Shopian was a staged encounter wherein innocent youth of Rajouri who had come to Shopian to eke their livelihood working as laborers were murdered and passed off as militants. And now is the test for the government to ensure justice to the families by taking the case to its logical conclusion of punishing the guilty," the PDP spokesperson said. "Proofs at hand notwithstanding, the history doesn't inspire much confidence given what happened to similar cases of Pathribal and Machil fake encounters. Where evidence was collected and the crime and criminals established beyond doubt only to see the victims still waiting endlessly for guilty to be punished and justice delivered," he added.

He said it was a high time that the culture of impunity at the cost of human lives ends and legal maneuvering to shield the perpetrators of such heinous crimes is given up.

mar said the two militants were Lashkar commanders.

"One of the militants has been identified as Abu Rehan from Pakistan, who was active since March 2019. The second one has been identified as Adil Rashid Bhat, who was also a Lashkar commander," he said. "Bhat was involved in an attack on two policemen at Nowgam on August 14," the IGP said, adding that he had decamped with an INSAS rifle which was recovered from the encounter site.

The killing of the two militants is a huge success for the forces, he said. Kumar said LeT militants were also behind the killing of Bhupinder Singh, Block Development Council chairman, Khag, in central Kashmir's Budgam district.

Singh was shot dead by militants on Wednesday evening.

After touring his area, Singh dropped his two personal security officers (PSOs) at Khag police station and left for his home, the IGP said. "He then went to his village, about 10 to 12 kilometres from there, in his private car without informing the police. We have suspended the two PSOs," he said. "Investigations are on and two suspects have been called. SP Budgam is himself investigating the matter. Perhaps the militants had known that he was coming home. We have taken all the details and will solve this case soon," Kumar said.

Prima facie, from his call and location details, names of two Lashkar militants have come up LeT commander Yousuf Kandroo and Abrar from Narbal, he said.

On the killing of an assistant sub-inspector of the Central Reserve Police Force in Wadipora, Budgam, Kumar said the attack was carried out by Jaish-e-Mohammed (JeM) as M-4 cartridges were found at the spot. "M-4 is usually used by JeM militants," he said.

Responding to a question, Kumar said 170 to 200 militants are active in Kashmir.

On the alleged custodial death of a man, Irfan Ahmad Dar, in Sopore area of Baramulla last week, the IGP said the matter is being investigated even as a magisterial inquiry is on.

He said two policemen have been suspended because Dar had fled from their custody.

Protests erupted in north Kashmir's Sopore town after Dar (23) allegedly died in police custody on Tuesday.

While the police claim Dar was an overground worker and his body was found after he escaped from custody, his family claims it was a "murder in custody".

Asked about the recent spike in militant attacks, Kumar said Pakistan is trying to create a "fear psychosis" by asking militants to carry out killings of innocent people.

For the last few months, especially since March, Pakistan has been instigating a lot through digital media and sending arms and ammunition through drones or manually, he said.

"We should not be worried about such incidents," the IGP said.

When there is some action by militants, there is a proactive action from the side of security forces as well, he said.

On the hit list released by The Resistance Front (TRF), a new militant outfit, comprising names of police officers, activists and others, Kumar said the police will conduct a security review of those named in it.

"The TRF is not a real organisation, but a virtual one. It is an offshoot of the LeT. The police will undertake a security review of all the people mentioned in the list prepared by the TRF," he said.

"The two sides had candid and in-depth exchanges of views on stabilising the situation along the LAC in the India-China border areas," Indian Army had stated.

"They agreed to earnestly implement the important consensus reached by the leaders of the two countries, strengthen communication on the ground, avoid misunderstandings and misjudgements, stop sending more troops to the front line, refrain from unilaterally changing the situation on the ground, and avoid taking any actions that may complicate the situation."

The two sides also agreed to hold the 7th round of the Military Commander-Level Meeting as soon as possible, take practical measures to properly solve problems on the ground, and jointly safeguard peace and tranquility in the border area.

It was for the first time that the Indian delegation had two Lt Generals, two Major Generals and a Joint Secretary from the Ministry of External Affairs (MEA).

Headed by Lt Gen Harinder Singh, Commander of the Leh-based 14 Corps, the Indian delegation also had Lt Gen P.G.K. Menon from the Army headquarters in Delhi. Menon will eventually take over Commander of the 14 Corps in November.

Joint Secretary, East Asia, Navin Srivastava was there to ensure that deliberation with China takes place on an agreed five-point roadmap, including quick disengagement of troops, between both the countries. The countries reached he five-point roadmap during the talks between External Affairs Minister S. Jaishankar and his Chinese counterpart Wang Yi in Moscow on September 10.

India and China are engaged in a four-month-long standoff at the LAC in Eastern Ladakh. Despite several levels of dialogue, there has not been any breakthrough and the deadlock continues.

The president's remarks in this regard come days after senior Indian and Chinese military commanders held talks aimed at resolving the months-long standoff along the Line of Actual Control (LAC) in Ladakh. The two countries agreed to stop sending more troops to their disputed border in the Himalayas.

Meanwhile, The Wall Street Journal reported that the border conflict is pushing India to look for an asymmetric response: flexing its naval might. "India is intensifying joint naval maneuvers with the US and its allies while building new ships and setting up a network of coastal surveillance outposts that would allow New Delhi to keep an eye on the Indian Ocean's maritime traffic," the newspaper said.

A "Grand Tamasha" podcast with senior fellow and director of the South Asia Program of Carnegie Endowment for International Peace, eminent American expert on India and South Asia Ashley Tellis said the Trump administration has taken a very transparent position of support for India in this crisis.

"And, of course, it is motivated in part by the opportunities to confront China on a grander scale, which sort of makes it part and parcel of the US's own bilateral problems with China. But I think there is something more going on here. And the more is that I do not think the United States had the alternative of doing otherwise.

"That is, Chinese aggression in this instance has been so blatant that the United States could not stand by and either ignore it or not come to India's defence," said Tellis, the Tata Chair for Strategic Affairs.

"What are the issues here? We all agree that those borderlands along the Himalayan territories are undefined. We all agree that they should be negotiated, delimited, demarcated through a peaceful process. We all agree that the agreements that China and India have repeatedly reached among themselves since the 1990s actually offer a good enough framework for how to resolve this dispute over the long term," he added. What China has done is that it has thrown all those understandings overboard, Tellis said. "And it is very important to recognise this that whatever the provocations may have been, the provocations created by Article 370 or whatever, I do not think they justified a reaction of this kind. Because a diplomatic provocation should have, you know, elicited a diplomatic response, rather than a quick jump to military action, which has enormous risks.

"By China taking the step to move quickly to military action, which has now resulted in loss of lives, I think it has put itself on the opposite side of the United States, which is arguing more loudly than ever for a rules-based community," he added.

"And so, even beyond the Trump administration's own bilateral problems with China, I think they were left in absolutely no position but to support India on this count and I think even a Democratic administration would have done the same in these circumstances," Tellis said.

Appeal In Israel Against...

"I'm fighting a case against government gunman Papa Kashtwari, who killed my father," said Zahoor Ahmad of Nishat, Srinagar, who had turned up for condolence. "My counsel was advocate Babar Qadri. For years he didn't charge a penny for the case."

Not only that, the family member said, the fallen advocate would arrange fares and give monetary help to many poor families, whose kin were detained in militancy or stone-pelting cases. Insert Pic 4 here

After his stint with student politics, Qadri had started practicing law in



2008 and shortly became known for taking up cases for detained juveniles. He launched the All J&K People's Justice Party and had named himself its President. Following this, his membership of the Kashmir High Court Bar Association (KHCBA) was suspended.

But over the year, the 40-year-old lawyer became a regular TV debater, known for calling spade a spade.

"We would usually scold him for his appearance in TV debates but he would say 'who will talk on behalf of Kashmiris'," his father Syed Yaseen Qadri told Kashmir Observer.

"He would tell his father, 'if you had given service for the Kashmir cause throughout your life, why wouldn't I? But I want to do it in my own style," a family relative said.

Back in his home, his inconsolable friends describe him a "lion" who would roar in front of anyone.

"He was not hardcore, but he would have argument with his colleagues at court but on next day he would say sorry and spread smiles on their faces," said Advocate Shafqat Nazir, Babar's close friend. "It's unbelievable that he is no longer with us."

Before he was shot dead, the senior Qadri said his son would receive threats in-front of his family.

"Even the last time," his father said, "BJP Spokesman Sambit Patra told him in a live TV show, 'Babar, tum abi zinda hou' (Are you still alive, Babar?)"

China Wants India To Vacate...

India vacates the strategic positions. Chinese People's Liberation Army troops are adamant on resolving the situation first on the south bank where the Indian troops are in position of strength tactically, but India wants a roadmap for de-escalation all along the Line of Actual Control (LAC) in eastern Ladakh to be drawn out. India stated, during the talks, that all friction areas, including Depsang, should be discussed for disengagement all along the LAC. "Why should discussions be restricted to one or two places when there is a massive build-up all across the LAC," a top Indian Army officer said.

India has occupied critical mountain heights on the south bank of the Pangong Lake, including Rechin La, Rezang La, and Mukpari that were unmanned till now. This step, along with some others peaks it holds, allows India to dominate the Spangur Gap under Chinese control and also the Moldo garrison on the Chinese side.

This has irked the PLA which has made multiple attempts to dislodge Indian troops, leading to instances of warning gunshots being fired. India had changed the rules of engagement after the Galwan Valley clash of June 15 where 20 Indian soldiers and unknown number of Chinese soldiers were killed.

Chinese had attacked Indian troops with medieval barbaric weapons like iron-studded clubs.

After that, the Indian Army had empowered its commanders on the ground to take a decision whether to use firearms if their troops face a life-threatening situation and this has been communicated to China as well, sources said.

The Indian Army has also put barbed wire obstacles near the heights under its control at the LAC, signalling to the Chinese not to enter its territory. Three days ago, the Indian and Chinese sides, in a joint statement, after the 14-hour-long diplomatic-military talks in Moldo said that both have agreed to implement the consensus reached by their leaders over the border issue.

On September 21, senior Indian and Chinese commanders held the 6th round of Military Commander-Level Meeting.

India and Israel signed a comprehensive agreement in 2014 to cooperate on issues related to "public and homeland security", including fighting organised crime, money laundering, human trafficking and counterterrorism operations.

"We understand that it [the petition] won't be successful, but we can't just sit quietly," Avivi said, according to Al Jazeera.

"When the militants were fleeing, they fired a few rounds in the air. We are assessing the CCTV footage from a camera installed nearby, he said. The IGP said the Oadri's car was fired upon in 2018 and he had a threat perception but had declined to shift to a safe zone.

"A police officer, who is a relative of Babar, had requested him to shift from Hawal area to a safe zone, but the lawyer declined. Local police officers also said they were requesting him to shift for the last one week as the locality was congested and the police patrolling was difficult.

"He (Qadri) had said he did not want to leave his house. I have seen the tweet by him about danger to his life. Unfortunately he had not tagged the Kashmir police in that tweet, but Jammu police, Kumar said.

The IGP appealed to people -- whether protected or not -- who face a threat to approach the police.

Babar had not shared any such thing with us, otherwise we would have shifted him to a safer place, he said.

Action oriented approach fundamental aim of B2V3: Kansal Reviews preparations for upcoming B2V3

SRINAGAR : Principal Secretary Power Development & Information, departments. Rohit Kansal today reviewed the arrangements regarding the flagship "Back to Village-3 (B2V3) programme starting from 2nd October to 12th October, 2019 at Civil Secretariat here.

Commissioner Secretary GAD, Manoi Kumar Dwivedi, Secretary Rural Development and Panchayati Raj, Sheetal Nanda, Secretary Planning, Development, Monitoring and Disaster Management Departments, Simrandeep Singh, Director Information and Public Relations, Dr. Syed Sehrish Asgar was also present during the meeting while all the Deputy Commissioners of Kashmir, Jammu Divisions, Chief Engineers of PDD, Jal Shakti of both divisions participated in the meeting through video conferencing

While chairing the meeting, the

Principal Secretary stressed upon the DCs that the fundamental objective of B2V3 programme should be an action oriented approach on all the works that have been allotted or started during the previous two Back to Villages programmes.

He impressed upon the Deputy Commissioners that the plan for works to be carried out in this phase of B2V should be prepared well in advance besides arrangements for holding Gram Sabhas, Ward Sabhas, Bal Sabhas and Mahila Sabhas should be done earliest and the public should be made aware about these programmes beforehand.

Kansal instructed the DCs that a proper mechanism should be developed regarding segregation of grievances received during the B2V3. He added that the public should also be intimated about the

status of these grievances in a proper time frame.

Highlighting the need of departmental coordination during the programme, the Principal Secretary maintained that B2V is entirely an inter departmental effort. He directed the DCs to ensure that all departments are represented during the B2V3 programme besides specified counters of all departments should be established in each visiting block highlighting different beneficiary schemes and other programmes for the general public. Terming this phase of B2V vil-

lage has a unique affair, Kansal informed the meeting that during B2V3 Safai Abhiyan in all Panchayats should be carried out with other activities like mega Gram Sabha and sports programmes. He asked the DCs that people should be encouraged about using dustbins and biodegradable materials so as to maintain cleanliness in their surroundings. He directed them to hold awareness camps in each panchayats for the same besides other mediums should also be used to maximize the reach of the information disseminated.

Kansal impressed upon the DCs that they should establish Control Rooms for B2V3 programme in their respective districts and directed them that they should hold a meet with visiting officers of Panchayats before and after B2V3 programme.

He further instructed the DCs that the visiting officers should be provided with information regarding languishing projects, major developmental plans and schemes carried in the district, besides action taken report on all the works

RINAGAR- In a significant departure from its known stance vis-a-vis Kashmir issue and centre-state relations, the National Conference today appealed to Indian and Pakistani leaders "to settle Kashmir issue without any delay so that the on-going massacre should be stopped".

"The long pending issue may be settled according to the will of Kashmiri people who are the real masters of Kashmir", a National Conference press release issued by the provincial president of the party and MLC G N Shaheen read. He demanded that all 'innocent detenues languishing in many jails should be released without any delay".

Expressing 'great concern', the NC leader said Kashmiri youth were not being provided central jobs which was "to-tally against norms". He demanded that Muslims as well as people from other communities should be given jobs.

NC leader also expressed concern that the central gov¬ernment had not so far released the annual plan for devel-opment works to the state and said "the fundamentalist Hindus are wholly and solely responsible for demolishing historical Babri Masjid as/well as one portion of Golden temple in Amritsar". He said it was the golden chance to restore peace and restore autonomy in the state.

Talking to Observer News Service this evening, Sha¬heen said the state's accession to India was conditional; Even at that time, a solemn pledge had been made to ascertain the final opinion of the state people. "That pledge was never redeemed as the people's opinion was never ever sought", he asserted.

On the denial of central government jobs to Kashmiri Muslims, Shaheen said he endorsed the views of Shiv Sena supremo, Bal Thakarey that he would never allow any non-Maharashtrian get a job in his state. He assert¬ed locals should be given representations in the state administration. He described the People's Democratic Party (PDP) of Mufti Muhammad Sayeed as that of the former state governor and BJP leader, 'Jagmohan, as the former was responsible for sending the latter to Jammu and Kashmir'.

Gatekeepers or Cheerleaders?

The threat to sacrosanctity of media is a matter of concern not only for us but for generations to come

The content in TV news media specifically is driven by an inclination to place sensation above sense in the quest for appraisals. The race for higher TRPs has made news media a mock epic. Press freedom in India is being endlessly compromised by the ever developing nexus among legislators and degenerate distributers. In the age of digitalization, journalists are constrained either to toe the government's line or face consequences. Lion's share of news media is by all accounts willfully diverting the majority from what ought to be really shown. This is writ large in the coverage given to topics that are sensational rather than issues that are pressing and more sensitive.

India is home to one of the greatest and fastest growing media industry on the planet. However, Media here is far from being fair. A nation with a populace of more than 138crores, is being ceaselessly indoctrinated by an assortment of biased news sources. India, which has a ground breaking and powerful electronic media with solid homegrown viewership is enabling a detrimental venture betweencorporate players, government and electronic media. Broadcast media, in particular, is creating news out of nonsense. While instances of media bias are nothing new, it has now stretched far beyond the tolerable limits.

One of the graces of a democratic system is the freedom of expression and the space that is provided to disagreement. It has four pillars: Judiciary, Legislature, Executive and Media. The former three keep up an arrangement of balanced governance while as the media guarantees straightforwardness in each of the three frameworks. It makes us aware of different social, monetary and policy centered issues that encompass us. As the backbone of democracy, media plays a vital function in molding it solid. Humans crave information, which is why they rely heavily upon media. The African-American Muslim minister and Human Rights activist, Malcolm X once said that, "The media is the most powerful entity on earth. They have the power to make the innocent guilty and to make the guilty innocent, and that's power, because they control the minds of the masses'

The deteriorating state of Journalism in India can also be seen as an outcome of increased surveillance and censorship. World Press Freedom Index positions India at 138th out of 180. Media intimidation is surely a reality, however, it is a danger confronted generally by correspondents situated in smaller towns where a murder of journalist barely manages to draw wider attention on the issue.



Currently under Governor's rule, the New Media Policy was introduced in Jammu and Kashmir. Avinash Kumar, Amnesty International's Executive Director for India, in an article published by Amnesty International in April said, "Harassment and intimidation of journalists through draconian laws such as UAPA threatens the efforts to address the CO-VID-19 pandemic and creates an atmosphere of fear and reprisal. In Kashmir, this has been compounded through the general lockdown, prolonged restrictions on internet speed and arbitrary detentions often without any kind of documentation, access to lawyers and recourse to justice. This severely undermines the human rights guarantees of the people of Kashmir and denies the people in India and around the world the right to know'

A few cases that are not even pertinent to the overall population get a great deal of consideration while issues like joblessness, financial log jam, increase in covid-19 cases get merely one show a month. The content in TV news media specifically is driven by an inclination to place sensation above sense in the quest for appraisals. The race for higher TRPs has made news media a mock epic.

Advancement is inescapable in any industry, with media being no exception. However, the purpose of evolution should not bypass a collective cause. India has numerous difficult issues that require considerationlike destitution, defilement, poverty, crime rate and so on. Power of media with the help of citizens can be a danger to any individual or organizationthat carries obstruction to any nation's development.

The threat to sacrosanctity of media is a matter of concern not only for us but for generations to come because the hogwash by contemporary media will eventually affect the next generation.

Northeast India Caught In The Middle Again

India and China are once again clashing along their disputed border in the Himalayas — for the first time since 1975. Soldiers on both sides have lost their lives — including at least 20 Indians and an unknown number of their Chinese counterparts.

Yet headlines in the outside world have largely overlooked the fate of local civilians — embodied by five young men from the northeastern state of Arunachal Pradesh. Apparently hired as porters for the Indian Army, they were captured by the Chinese on Sept. 1 and held captive until just a few days ago, when, thankfully, they were finally returned home to their families.

Those of us who call India's Northeast home aren't at all surprised to hear that geopolitics is once again overshadowing the lives of the people who live in the area. For decades, we have coped with the fallout from intense regional militarization and the excesses of the Indian security state. We've also spent generations contending with deep-seated racism among our compatriots - a regrettable reaction to the amazing ethnic and religious diversity of our strategically sensitive region, which borders on five different countries (China, Myanmar, Bhutan, Nepal and Bangladesh).

Connected to the rest of India by a 14-mile "chicken-neck corridor," our region is home to 45 million people from over 272 indigenous communities who speak more than 400 languages and dialects and adhere to several indigenous and other faiths. The area includes four formerly independent nation-states that joined India between 1940 and 1975. To quell local insurgencies, India imposed the Armed Forces Special Powers Act in the region in 1958, a de facto martial law that continues until the present day.



The conflict in northeast India has resulted in the killing of over 50,000 people. The International Committee of Jurists has reported over 1,500 cases of extrajudicial executions, while Human Rights Watch and other groups have documented numerous cases of arrest, torture and rape over the years. Our schools, colleges, cultural sites and hills have become military barracks.

The war has widowed countless women. Manipur alone has 20,000 registered war widows. In 2007, I set up the Manipur Women Gun Survivors Network to help female survivors of the conflict. Most troubling of all, our region remains relatively unknown to the rest of India and the world. Our histories are not taught in any Indian schools — even in Northeast India itself — and the national government restricts media and humanitarian access to the region.

That ignorance has helped to fuel widespread racism against those from our region who have found ourselves in other parts of India. Perhaps the most notorious case occurred in 2014, when 19-year-old Nido Tania was beaten to death in New Delhi by a group of men who hurled racial insults at him, called him (among other things) "Chinese." His killing was something of a tipping point, stirring protests against the culture of racist violence long endured by the indigenous peoples of India.

Yet such bigotry did not end with Nido Tania's death. It stirred again when covid-19 hit India and the world. The first case of the virus was reported in the country in February 2020, and it sparked a stark increase in attacks against indigenous people simply be cause they, like Nido Tania, looked different. Since the pandemic began, indigenous peoples from our region have been thrown out of rented apartments, beaten, removed from jobs, detained, spat at, called "corona carriers" and told to "go back to China" for looking "more Asian" than other Indians. In the early stages of the covid-19 pandemic, the Northeast India Women Initiative for Peace, of which I am a founding member, documented at least 200 racially motivated attacks.

The Citizenship Amendment Act passed by Narendra Modi's Hindu nationalist government discriminates against indigenous peoples who live within India, including those who follow indigenous faiths. Of the 2 million people left out of the National Register of Citizens, we estimate that 700,000 are indigenous peoples living in Assam and the Northeast.

While India signed the U.N. Convention on Elimination of All Forms of Racial Discrimination in 1967, the Indian Parliament has yet to pass any laws that address racism in the country. A report from the Ministry of Home Affairs has proposed urgently needed reforms. As a multiethnic, multi-religious country, India should also adopt the National Action Plan to Combat Racism proposed by activists. India should also include information on the history, culture and politics of Northeast India in school curricula.

Rising border conflicts in South Asia, as well as growing authoritarianism, militarization and xenophobia in the region and beyond, make it incumbent upon democratic nations to ensure the dignity and security of all people regardless of race, ethnicity, religion, gender or other attributes — and that includes the indigenous peoples of Northeast India. Only then can we successfully address the issues of racism, social justice and health, and bring about sustainable peace and development.

Physical Disability and Depression

• I seek my inspiration not from people who consider me less than them but from people who've done far better even as they had physical disabilities. he common definitions of physical disability available easily on the internet is that it is a substantial and long-term condition affecting a part of a person's body that impairs and limits their physical functioning, mobility, stamina or dexterity. Observing minutely this definition, it seems that only physical functioning, mobility, stamina or dexterity is assumed to be affected.

However, this definition eliminates the presence of other challenges that are as much of an outcome of being a person with disability. This dominantly ignores the correlation between physical disability and mental health. Many researches have explored the causality between physical disability and mental health especially depression.

My personal experience has made it obvious that traditionally, our society looks down upon people with disability. I myself am a Person With Disability (PWD). These three alphabets should only describe my physique but not my emotions, my mental strength, my creative ability, my ability to earn(both money and respect) or my caliber to absorb pressure. However, there are times when the assumptions of society make me question my own self-image. But when others are preferred over me for no fault of mine, I seek inspiration through people like Robert Collis, Christy Brown, Helen Adams Keller and Stephen William Hawking. I seek my inspiration not from people who consider me less than them but from people who've done far better even as they had physical disabilities.

In a study conducted by James D. Leeper, Lee W. Badger, and Tamar Milo, it was argued that persons claiming physical disability who were evaluated at a primary care health center in a small southern city were administered the Diagnostic Interview Schedule. Fifty-six per cent of the 43 patients were found to have one or more psychiatric disorders.

Forty-three consecutive disability determination patients were the subjects for this pilot study. There were 23 males, 15 of them White; the 20 females were equally divided between Black and White. Sixty per cent (N = 9) of the White males were between ages 50 and 59 whereas the



Black males were represented approximately equally in the 10-year intervals between ages 30 and 69. Black females were younger (50 per cent were less than 39 years old) than White females (70% were over 50 years old). Fifty-six per cent of the patients were found to have one or more current psychiatric disorders according to the DIS. Ten patients had one disorder, seven had two disorders, two had three disorders, two had four disorders, and three had five disorders. The most common DIS diagnoses were phobia, anxiety, and panic. Other diagnoses were alcoholism, depression, somatization, organic brain syndrome, schizophrenia, and barbiturate dependence. Two-thirds of Blacks and 48 per cent of Whites had one or more diagnosis. Proportionately more males than females had one or more diagnosis. An equal percentage of those under age 50 and those age 50 or older had one or more diagnosis. Married patients had a slightly lower prevalence of disorder than those unmarried. None of these relationships was statistically significant

Albert Schweitzer, a French-German

theologian once said, "The purpose of human life is to serve, and to show compassion and the will to help others". This approach is the need of the hour in our society. We need awareness as much as compassion. Ableism and Ableist language should be discouraged in our society. Meaningful interventions should be made to ensure that people with disability have better access to resources and opportunities. We need to normalize as well as sensitize people towards physical disability. This will be only possible if we change conventional attitudes. People with disability only need others to treat them with dignity as well as compassion, so they do not find such hindrances on their way to achieve things and contribute, both, economically as well as socially.

Covered Mouth and Speaking Eyes In the era of Covid-19, masks have altered the dynamics of

conversations but studies show that eyes can also do the talking

here's a good chance that you when you leave the house today you'll put on a face mask that obscures your mouth. Such coverings can affect our ability to communicate and provides a particular challenge to those that need to see lips to understand speech.

But what of the eyes that remain uncovered? Shakespeare said the eyes were the windows to the soul. I'm not sure about "souls", but it's very clear that eyes can provide a great deal of information.

It's why poker players sometimes wear dark glasses because of a fear of giving away a "tell", a tiny almost imperceptible cue to other players that they are holding a good hand, or bluffing. This might be common wisdom, but there is also some science that supports this.

Our emotions are how we understand others and how they understand us. And research has found that it is possible to interpret people's emotions by analysing their eyes. In 2017, researchers at Cornell University showed volunteers images of eyes expressing different emotions: sadness, disgust, anger, joy, surprise or fear.

The participants were able to consistently rate how well different words describing mental states matched the "eye expression". The researchers concluded that the eyes provide essential interpersonal insight, and that different aspects of the eyes (such as how open they are or how sloped the brow is) give information about different mental states.

The neuroscience is also interesting here. We know humans are exceptionally sensitive to very tiny changes in direction of gaze. When you are trying to judge which direction someone is looking in, it significantly activates your amygdala, a part of the brain we have long known to be associated with emotion. This shows there is a link between emotion and eyes at a neurological level.

We know that the amygdala is relevant in all things to do with emotion, and



it is best known for its role in fear and its mediation of the "fight or flight" response. Further research has shown that the amygdala is also active when we are monitoring the scene for events where a person may be looking in our direction, or changing their direction of gaze.

This could indicate the importance of the eyes in finding a mate, expressing interest in others, or perhaps conversely in identifying threats from others. In short, we are wired to extract information from the eyes – information that can help us assess the emotions of those around us and so allow us to engage more effectively with them.

There is further evidence of the importance of the eyes from neurochemistry. We know that oxytocin, a naturally produced hormone, is important in social interactions and that it may be important in how we perceive the faces of those around us.

Researchers have found that, when shown images of faces, people who are

given oxytocin spend more time looking at the eyes than those given a placebo. Since oxytocin is a factor in social interactions, this finding suggests the eyes are very important in how we understand our engagement and interaction with those around us. Those with elevated levels of oxytocin appear to seek out the eyes to help them better engage socially with others.

For the dog-lovers among us, there's also some research that suggests that when dogs and their owners look into each other's eyes, oxytocin levels increase in both the humans and the pets, suggesting an increased social bond. This only seems to happen with domesticated dogs with whom a close social bond is important to the owners and their animals, the results are not shown with wolves.

Eye don't believe it

There are, however, some things that the eyes can't tell us. There is one rather

sticky myth that comes from so-called "neurolinguistic programming" (NLP), the approach often favoured by those who like to claim you can use psychology to achieve an advantage over others.

The theory goes that if someone is looking up and to the right when they are talking then that somehow indicates that they are lying. But when researchers filmed a group of people telling true and false stories, and then asked another group to try to spot the lies by looking at the speakers' eyes, they found no evidence for a link between lying and eye movements at all.

If you want to know what someone is feeling when face coverings are the norm, the eyes may well have the answer you are looking for. We can definitely tell if people are smiling by looking at their eyes, and a smile is so very important, now more than ever.



United Nations: The International Civil Aviation Organization (ICAO) has advised Pakistan to undertake "immediate corrective actions" and suspend the issuance of any new pilot licenses in the wake of a scandal over falsified licenses, according to an official and a document seen by the Reuters news agency.

The recommendations from ICAO, a specialised agency of the United Nations that works to ensure safety in international air transport, come days after Pakistan opened a criminal probe into 50 pilots and five civil aviation officials who allegedly helped them falsify credentials to secure pilot licences

"Pakistan should improve and strengthen its licensing system to ensure that it takes into account all necessary processes and procedures and prevents inconsistencies and malpractices before new licenses are issued and privileges of suspended licenses are reestablished," the ICAO said in a previously unreported letter to the Pakistan Civil Aviation Authority (PCAA) last week.



A spokesperson for Pakistan's aviation ministry, who is also a spokesperson for the PCAA, was not immediately available for comment on the ICAO advisory when contacted by Al Jazeera.

Al Jazeera reported in July claims by Pakistani pilots that fraud and improper flight certification practices at the country's civil aviation regulator were rampant, and that air safety has routinely been compromised by airlines through faulty safety management systems, incomplete reporting and the use of regulatory waivers

Pakistan International Airlines (PIA), the country's largest airline and only major international carrier, was at the centre of most of the air safety complaints, and has denied all of the allegations.

The country's aviation minister has said that almost a third of all licensed Pakistani pilots had obtained their certifications fraudulently.

United Nations: The United States, China and Russia fought bitterly on Thursday during a United Nations Security Council meeting on the coronavirus pandemic as United Nations chief Antonio Guterres told the body that they had failed in their han-

dling of COVID-19. Guterres blamed "a lack of global preparedness, cooperation, unity and solidarity" for the coronavirus spreading out of control and a death toll nearing one million globally. More than 32 million people have been diagnosed with the virus.

"The pandemic is a clear test of international cooperation - a test we have essentially failed," he told the 15-member body. If the climate crisis were approached in the same way,

he said, "I fear the worst." US President Donald Trump, who is facing a re-election battle made more challenging by the disease's spread across the country, on Tuesday demanded action against China for spreading the "plague" of

COVID-19 to the world. The US has reported more than 200,000 deaths, the highest in the world and accuses Beijing of a lack of transparency that it says has worsened the outbreak. China denies the claims.

'Enough is enough'

US Ambassador Kelly Craft reiterated those accusations at the council's virtual meeting, drawing an angry response from her Chinese counterpart Zhang Jun.

"Enough is enough," he said. 'You have created enough troubles for the world already. ... The US should understand that blaming others will not solve its own problems."

"It looks like this virus has one big trick," said Shane Crotty, a professor in the Center for Infectious Disease and Vaccine Research at the La Jolla Institute for Immunology in California, "That big trick is to avoid the initial innate immune response for a significant period of time and, in particular, avoid an early type-1 interferon response.'

The work highlights the potential for interferon-based therapies to enlarge a slowly accumulating range of Covid-19 treatments. These include Gilead Sciences Inc.'s remdesivir and convalescent plasma, a component of the blood of recovered patients that may contain beneficial immune factors.

These treatments provide limited benefit and are typically used in very sick, hospitalized patients. The possibility that interferon may help some people is enticing because it appears most efficacious in the early stages of infection, when life-threatening respiratory failure could still be averted. Dozens of studies of interferon treatment are now recruiting Covid-19 patients.

Finland's Airport Uses Dogs To Sniff Out Coronavirus

elsinki: Dogs trained to detect the novel coronavirus began sniffing passenger samples at Finland's Helsinki-Vantaa airport this week, authorities said, in a pilot project running alongside more usual testing at the airport.

The dogs' efficiency has not been proven in comparative scientific studies so passengers who volunteer to be tested and are suspected as carrying the virus are instructed to also take a swab to confirm the result.

A team of 15 dogs and 10 instructors are being trained for the job in Finland by volunteers, sponsored by a private veterinary clinic. Among them is Kossi, a rescue dog from Spain, who was trained as a sniffer dog in Finland and who has worked before detecting cancers.

Queen Elizabeth's Finances Hit, Royal Budget May Lose 15 Million Pounds

ondon: Britain's Royal Household on Friday defended taxpayer-funded trips, including a golfing jaunt by the beleaguered Prince Andrew, as it warned of a financial hit stemming from the coronavirus pandemic.

Unveiling the annual financial report of Queen Elizabeth II's household, officials also said Prince Harry and his wife Meghan were now paying commercial rent on their UK residence at Windsor Castle, after quitting the royal frontline.

The Sovereign Grant, which pays for the monarch's official duties and upkeep of royal palaces, came to 82.4 million pounds (\$105 million, 90.1 million euros) in the financial year ending in March 2020, a slight rise from the year before.

In March, the UK went into lockdown against the coronavirus pandemic and royal finances have been dented by the loss of sizeable income generated from public visits to the palaces. Losses to the Royal Household's



core budget will come to 15 million pounds over the next three years, according to Michael Stevens, who as Keeper of the Privy Purse is the queen's treasurer.

A separate budget for long-term repairs designed to avert a "catastrophic failure" to the fabric of Buckingham Palace, the queen's main residence in London, will suffer a shortfall of 20 million pounds.

By law, the Sovereign Grant cannot go down year-on-year, and the monarchy has become increasingly cost-conscious given wider public scrutiny of its affairs.

Legendary newspaper editor, publisher and muckraker dies

ew York: Sir Harold Evans, the charismatic publisher, author and muckraker who was a bold-faced name for decades for exposing wrongdoing in 1960s London to publishing 1990s best-sellers such as Primary Colors, has died, his wife said on Thursday. He was 92.

His wife, fellow author-publisher Tina Brown, said he died on Wednesday in New York from congestive heart failure.



Evans was high-profile go-getter, starting in the

1960s as an editor of the Northern Echo and The Sunday Times of London and continuing into the 1990s as president of Random House.

A defender of print journalism well into the digital age, Evans was one of the all-time newspaper editors, startling British society with revelations of espionage, corporate wrongdoing and government scandal.
