He was 91. ## **China Says It Does Not Recognise UT Of Ladakh**

NEW DELHI: Amid the ongoing military standoff with India along the Line of Action Control (LAC), China on Tuesday declared that it does not recognise the Union Territory of Ladakh and called it "illegally established" by India. A belligerent China also said it was opposed to India building military infrastructure in the border areas.

"China does not recognise the so-called union territory of Ladakh illegally established by India, and opposes infrastructure construction in disputed border areas for military control purposes," Chinese Foreign Ministry spokesperson Wang Wenbin said while commenting on India's move to build roads along the border.

"According to the recent consensus reached between China and India, neither side should take any actions in border areas that would complicate the situation, so as not to affect the efforts of both sides to bifurcation of Kashmir came into May and escalated in June to the ease the situation," Wang told reporters at a daily briefing.

## Amnesty Int'l Halts Operations In India

The rival countries have amassed tens of thousands of soldiers, backed by artillery, tanks and fighter jets, in the Ladakh area since the deadly standoff.

After that clash, the two countries partially disengaged from the site in Ladakh's Galwan Valley and at least two other places, but the crisis has continued in at least three other areas, including the glacial Pangong Lake

In recent weeks, the world's two most populous nations have accused each other of sending soldiers into each other's territory in the Pangong area and firing warning shots for the first time in 45 years, raising the spectre of a full-scale military conflict.

The fiercely contested control line separates Chinese- and Indian-held territories from Ladakh in the west to India's eastern state of Arunachal Pradesh, which China claims in its entirety. It is broken in parts where the Himalayan nations of Nepal and Bhutan border China.

According to India, the de facto border is 3,488 kilometers (2,167 miles) long, while China says it is considerably shorter.

China had responded strongly in August, 2019, after New Delhi had stripped Jammu & Kashmir of its special status and bifurcated the state as two separate union territories of J&K and Ladakh.

"China has always opposed India's inclusion of Chinese territory in India's administrative jurisdiction in the western part of the Sino-Indian border. This position is firm, consistent and has never changed," the foreign ministry had said in a statement at the time.

"In recent days, the Indian side has continued to undermine China's territorial sovereignty by unilaterally amending its domestic laws. This practice is unacceptable and will not produce any effect," the 2019 statement had said.

The fresh Chinese foreign ministry statement came on a day when Indian Air Force chief, Air Chief Marshal RKS Bhadauria, said that the prevailing situation along the Line of Actual Control was "uneasy". According to the IAF chief, a "no war, no peace" status was prevailing along the northern border amid the ongoing standoff in eastern Ladakh.

He, however, assured that the Indian armed forces were prepared for any eventuality and that the IAF was resolved to counter "any misadventure".

"Present security scenario along our northern frontiers is at an uneasy - no war, no peace status... The recent induction of Rafales along with other aircraft has provided the IAF with substantial practical and strategic capability enhancement," Air Chief Marshal Bhadauria said.

### Never Accepted China's 1959...

foreign ministry insisting that it takes the 1959 line on perception of the LAC amid a nearly five-month-long border standoff in eastern Ladakh triggered a strong reaction from India.

"India has never accepted the so-called unilaterally defined 1959 Line of Actual Control (LAC). This position has been consistent and well known, including to the Chinese side," MEA Spokesperson Anurag Srivastava said in response to a question by the media on the issue.

The spokesperson's comments came after a Chinese Foreign Ministry spokesperson told Hindustan Times that China abides by the LAC as proposed by then Premier Zhou Enlai to Prime Minister Jawaharlal Nehru in a letter dated November 7, 1959.

Srivastava referred to various bilateral agreements including the 1993 agreement on maintenance of peace and tranquility along the LAC, 1996 pact on confidence building measures (CBMs) and the 2005 agreement on political parameters and guiding principles for settlement of the boundary issue, to emphasise that both sides showed commitment to reach a common understanding of the alignment of the LAC.

"Therefore, the insistence now of the Chinese side that there is only one LAC is contrary to the solemn commitments made by China in these agreements," he said, adding the Indian side has always respected and abided by the LAC.

Referring to Defence Minister Rajnath Singh's recent address to Parliament. Srivastava said it is the Chinese side which by its attempts to transgress the LAC in various parts of the Western Sector has tried to unilaterally alter the status quo.

The MEA spokesperson also talked about repeated affirmation of the Chinese side in the last few months that the current situation in the border areas should be resolved in accordance with the agreements signed between the two countries.

"In the agreement reached between External Affairs Minister and his Chinese counterpart on 10th September also, the Chinese side has reiterated its commitment to abide by all the existing agreements," Srivastava said

etc. The law on which is well settled," the court said, adding, "Due to callous approach of the detaining Authorities in passing such orders, the whole purpose of the Preventive laws is getting defeated."

The court said that either the detaining authorities are not aware about the requirements of law or they are dealing the issues of preventive detention very "casually".

"Be that as it may, time has come when the detaining Authorities must be imparted proper training about the requirements of law in passing the detention order so as to ensure that such orders are not set aside on technical grounds," the court said as per GNS and asked Registrar Judicial to send copies of the judgment to the Chief Secretary, Commissioner Secretary, Department of Home, and Law Secretary, for compliance through email. "It is made clear that any such slackness in future may invite imposition of personal cost on the officer concerned," the court said.

Meanwhile allowing the petition by Sartaj who was booked under PSA on 28 November 2018, the court ordered that he be released forthwith provided he is not detained in any other matter including FIR Nos. 260/2017 and 333/2017.

The Learned AAG (additional advocate general) has not been able to bring to our notice any such satisfaction recorded by the detaining Authority while passing the detention order. The Single Judge though has discussed about the appellant (Sartaj) being in custody at the time of passing of detention order but has not dealt this issue in right perspective," the court said, adding, "On this ground only the appeal deserves to be allowed."

## **'Camouflaging Illegal Occupation'** exploitation" of people in Pakistan-controlled -Kashmir. Pakistan has announced that elections for the legislative assembly

of Gilgit-Baltistan will be held on November 15.

"The government of India has conveyed its strong protest to the government of Pakistan and reiterated that the entire Union territories of Jammu and Kashmir and Ladakh, including the areas of so-called Gilgit and Baltistan are an integral part of India by virtue of its accession in 1947," the MEA said in a statement.

The MEA said Pakistan has no locus standi on territories "illegally and forcibly occupied" by it.

"Action such as these can neither hide the illegal occupation of parts of Union Territories of Jammu and Kashmir and Ladakh by Pakistan nor the grave human rights violations, exploitation and denial of freedom to the people residing in Pakistan occupied territories for the past seven decades," it said.

"These are cosmetic exercises intended to camouflage its illegal occupation. We call upon Pakistan to immediately vacate all areas under its illegal occupation," the MEA said.

The MEA also asked Pakistan to immediately vacate all areas under its illegal occupation.

In a ruling earlier this year, the Pakistan Supreme Court allowed Islamabad to amend a 2018 administrative order to conduct general elections in the region. The Gilgit-Baltistan Order of 2018 provided for administrative changes, including authorising the prime minister of Pakistan to legislate on an array of subjects.

Following the verdict, India issued a demarche to a senior Pakistani diplomat here and lodged a strong protest over the apex court ruling.

The polls in Gilgit-Baltistan were to be held on August 18, but Pakistan's election commission on July 11 postponed them due to the coronavirus pandemic.

Failure to firm up the requirements jeopardised the work on the State Service Delivery Gateway (SSDG) project, it said, adding, implementation of the Common Service Centres project was impacted due to lack of coordinated efforts in ensuring availability of services, absence of a reliable connectivity, lack of awareness or sensitisation and delays in the roll out process.

On the NAP, the CAG said the overall forest cover to geographical area in Jammu and Kashmir decreased from 16.09 percent in 2009 to 15.78 per cent in 2015.

Against target of 66 percent of geographical area in hills to be covered under forest and tree cover as per National Forest Policy 1988, only 24.02 per cent was under forest and tree cover, leaving a shortfall of 41.98 percent of the envisaged goal, the report said.

It said seven forest development agencies could not be brought under the ambit of NAP by the state forest development agency during 2010-17, despite the fact that five forest development agencies had formulated and submitted their plans (2010-15) costing Rs 37.59 crore to the state agency which was not forwarded to the National Afforestation and Eco-Development Board.

The Receipt of funds from the National Afforestation and Eco-Development Board by the State Forest Development Agency were allocated disproportionately to Forest Development Agencies. Against release of Rs 4.44 crore by the National Afforestation and Eco-Development Board to the State Forest Development Agency for 15 Forest Development Agencies, only Rs 1.80 crore were released (2013-14), whereas against release of Rs 5.46 crore for nine Forest Development Agencies, Rs 9.23 crore were released (2011-14), it said.

The CAG said the funds of Rs 24.46 crore were retained by the state forest development agency up to 265 days and further there was delay in release of Rs 6.30 crore up to 681 days by the forest development agencies to the village forest committees.

Delay in submission of annual works programme by the State Forest Development Agency to National Afforestation and Eco-Development Board resulted in non-receipt of grant of Rs 11.72 crore during 2010-15, the report said.

It said neither five year Perspective Plan nor Annual Plan of Operations was prepared by the Forest Development Agencies. Only Annual Works Programme of the forest territorial area were prepared and that too without the consultation with the Village Forest Committees/ potential village members.

The report said no entry point activities were undertaken in any of the 11 forest development agencies test-checked in audit despite Rs 1.03 crore being approved in the annual works programme of 10 agencies for undertaking such activities.

No training and capacity building measures were undertaken for skill development as no provision was made in the works programme by 11 Forest Development Agencies test-checked in Audit. No plantation journal showing year/compartment/ species-wise and geo-reference details of the plantation was maintained, as such impact assessment to monitor survival vis-a-vis mortality against plantation could not be analysed, it said.

It said No Annual Report was prepared by the state forest development agency since its inception in July 2010.

The Governing Body met only once (April 2014) as against seven times, whereas the Executive Body conducted only five meetings as against at least 27 meetings during 2010-16.

She's herself living on the edge with hardly any means to support her family.

"I had finally bagged a job before the pandemic, but even that is gone now," says Vasundhara, who lost her job as a teacher due to the cost cuts and employee layoffs phenomenon that emerge amidst the Covid-19 lockdown, multiplying the problems of especially those in the private sector.

She lives in a two-storey house that had almost submerged under the floods in 2014, which she think can fall with a slightest earthquake. And there's no way she can renovate it.

"We've suffered both financially and mentally here and no one cares," sighs Vashundhara who feels that the "golden time" of their lives is already wasted and what's just another day for the government are moments of grief and distress for the pandits living in the valley. Official Lip service

"Recently, Lieutenant Governor announced something that is already there and nothing new," continues Kumari who compares the announcement as putting a candy in a baby's mouth.

On September 23, LG Manoj Sinha approved the re-allocation of 1997 number of unfilled supernumerary posts for recruitment of registered Kashmiri migrants and non-migrant Kashmiri Pandits, who are willing to serve and settle down in Valley under the Prime Minister's Package.

But as per the people part of the hunger strike, the problem lies not in the criteria, rather in the implementation of the orders and the schemes

"I don't understand why there's a delay in providing us jobs despite the clearances from the Ministry of Home Affairs (MHA) and the high court order," asks Kumari.

The delay, she says, is only making many people from her community ineligible for the jobs which follow a certain age criteria.

Vasundhara and Kumari both argue that there's conscious negligence towards their cause, which is to secure the rights of the nonmigrants Kashmiri pandits, from certain departments, authorities and the government of past and present.

"If we were to specifically blame someone, it would be the Disaster Management Relief, Rehabilitation and Reconstruction (DMRR&R) Department for not taking any action," says Vasundhra while referring the possibility of the further deterioration in the health of Sanjay Tickoo, who is leading the hunger strike at the moment. **Abrogation Myth** 

On August 5, last year, the BIP-led central government scrapped the special status of Jammu and Kashmir in a bid to further integrate the former state with the Indian union.

Although the decision created quite a stir in the valley, many people outside Kashmir, especially migrant pandits, welcomed it thinking it would become a gateway for them to go back home.

"If they aren't able to do anything for those who're already here, how will they rehabilitate those coming from outside?" asks Vasundhra in a fierce tone.

It's a myth that Article 370 is a win for Hindutva or a pandit community, Sanjay Tickoo says.

"So far, the community has not been able to see any positive changes out of it [abrogation] for their upliftment."

#### "Ready to come out on roads"

Already, it has been ten days since Kumari and Vasundhara along with others from her community are sitting inside the courtyard of the temple in support of the hunger strike. But so far, they've not got any reaction from the government.

However, they refuse to be the inheritors of the grief and misery of their ancestors

"If someone had to do something, they would not have delayed," he says.

However, the government has said that Amnesty has been receiving foreign funds illegally.

In 2018, the Enforcement Directorate had carried out searches at the headquarters of Amnesty International in Bangalore.

The raids were conducted for an alleged violation of the foreign exchange act.

The organisation claimed that the attacks on Amnesty International India and other outspoken human rights organisations, activists and human rights defenders are only an extension of the various "repressive policies and sustained assault by the government on those who speak truth to power".

"This is latest in the incessant witch-hunt of human rights organizations by the Government of India over unfounded and motivated allegations," Amnesty International India said.

Amnesty International India said it stands in full compliance with all applicable Indian and international laws.

"For human rights work in India, it operates through a distinct model of raising funds domestically. More than four million Indians have supported Amnesty International India's work in the last eight years and around 100,000 Indians have made financial contributions," the organisation said.

These contributions evidently cannot have any relation with the Foreign Contribution (Regulation) Act, 2010 and the fact that the "government is now portraying this lawful fundraising model as money-laundering is evidence that the overbroad legal framework is maliciously activated when human rights activists and groups challenge the government's grave inactions and excesses", it alleged.

"Treating human rights organisations like criminal enterprises and dissenting individuals as criminals without any credible evidence is a deliberate attempt by the Enforcement Directorate and Government of India to stoke a climate of fear and dismantle the critical voices in India," Avinash Kumar, the executive director of Amnesty International India, said.

The bench said he requests for visitation and meetings may be placed before the authorities concerned and allowed.

At the outset of the brief hearing, the bench said that it would like to deal with certain issues as to what can be the maximum period of detention under the law and asked the authorities about the period of detention to which she may be kept.

"Find some via media out. Detention can't be forever," the bench observed, while posting the matter for hearing on October 15 after filing of the fresh reply of the UT administration to the amended plea of Iltija.

Referring to the earlier reply of the UT authorities, the bench said that it needed to go through the reply and "will have to see what is to be done"

The top court, in February this year, had issued notice to the UT authorities on the habeas corpus (bring the person) plea of Iltija challenging the detention of her mother and had sought the response by March 18.

The PDP president was put under detention on the eve of abrogation of special status of Jammu and Kashmir under Article 370 on August 5 last year.

In her application, filed in the pending petition, Iltija said it has been filed praying for permission to amend the plea and seeking a writ of habeas corpus.

"The amendment sought is to include grounds of challenge and additional prayers for challenging the orders of confirmation (dated February 26) and subsequent extensions (May 5 and July 31) of the detention order (of Mehbooba) impugned in the writ petition," the application reads.

The writ petition has challenged Mehbooba's detention on several grounds. It contends that the grounds and the dossier for detention are "stale, vague and that they suffer from non-application of mind, malice in law and that they violate the provisions of Section 8(3)(b) of the PSA".

"The detention order based on stale grounds have become staler even more since the petition was filed and the respondent administration has continued to act with total non-application of mind and the malice in law has only been reinforced and aggravated in confirming and extending the order of detention for further periods," it said.

Seeking permission to allow her to amend the section of the writ petition entitled Prayers, Iltija pleaded for issuance of the writ in the nature of habeas corpus commanding the respondents - the central and Jammu and Kashmir governments - to produce Mehbooba forthwith before the court for being set at liberty.

Pleading for direction or order quashing the impugned order of detention and subsequent extension orders, the application sought appropriate compensation to Mehbooba for the "illegal detention that she has suffered" and to award costs of the litigation to the petitioner.

"I have challenged her PSA order and the subsequent extensions to ensure her continued detention. Her detention is illegal and questionable in a democracy," Iltija had said, adding "a key opposition leader has been jailed for over a year without recourse to trial.'

"In order to clear the inner lanes of villages off snow, where machines cannot be deployed, the administration can hire the trained manpower, and must clear the snow for smooth movement," the LG said.

Stressing upon synergy between the departments, Sinha, the official spokesperson said directed the officers to monitor and keep a close watch on the functioning of their respective departments pertaining to winter preparedness for better coordination to avoid inconvenience to the public.

He directed the Power Department for establishment of a task force to ensure power supply and gave strict directions for the availability of surplus transformers to cater to the need during the winter season," the official spokesperson said.

He said that the LG directed the Jal Shakti Department to take all the measures required to ensure that there is no scarcity of drinking water.

"He also stressed upon enough stock of fuel, cooking gas before harsh winter slams the region," the official spokesperson said.

"The LG also asked the top government officials to put in place every available facility including emergency services such as power back-up for hospitals, water pumping stations, important government offices and state of the art ambulance services at all hospitals, especially in the higher reaches area," he added.

The official spokesperson further said that the officials in the meeting said snow control rooms will be established in every district headquarters by 15th October for smooth operation of snow clearance mechanically and manually.

## 'We're Here Because We're...

As she grew up, she missed the experience of living a "normal-life" without the fear of getting killed or attacked.

"During our school days the common sight would be crackdowns, stone-pelting and what not," she recalls.

At home, Kumari would make all the efforts to focus on her studies but that too would go in vain because the air would always be filled with smoke, cries and sound of gun-shots.

But more than that, what has been haunting her is the lack of financial upliftment and better opportunities for the people in her community.

"I've played 6 Nationals and I wanted to continue playing but there was no way I could," says Kumari in disillusionment, who failed to continue her B.ed due to financial shortfall.

Like Kumari, many others from her community are having a hard time to meet basic requirements.

"I know a family which has no proper or regular source of earning," says 26-year-old Vasundhara, another pandit woman, sitting in sup-

unanimously to oust his predecessor, the ailing Sheikh Saad Al Abdullah Al Sabah, just nine days into his rule.

Yet, as Kuwait's ruling emir, he struggled with internal political disputes, the fallout of the 2011 Arab Spring protests and seesawing crude oil prices that chewed into a national budget providing cradleto-grave subsidies.

SRINAGAR : Lieutenant Governor, Manoj Sinha has stressed upon innovative and efficient measures for conservation and preservation of world-renowned Dal lake, Wular lake and other water bodies.

He called for zero release of sewage waste of household and commercial establishments into Dal lake. The Lt Governor welcomed the suggestions and recommendations made by the CoE and said that all the

vital inputs will play an imperative role in framing future action plan for the restoration of the lake. The CoE briefed the Lt Governor about major steps required for safeguarding and conservation of Dal lake.

A threadbare discussion was held on important issues like preventing sewage waste flowing into the lake, bio-digesters for all houseboats, demarcation of the lake's boundary, empowering Lakes authority, putting a check on encroachment and its removal, sewage treatment plant for houseboats, rehabilitation, extending all the requisite facilities to tourists etc.

The Lt Governor laid special emphasis on formulating long term and short-term solutions and said that these solutions should go parallel for their effective implementation

Preservation of the unique biodiversity of Dal lake is the topmost priority of our Hon'ble Prime Minister and the UT Government is also committed to provide all the necessary support for the restoration of the ecosystem of the lake, he added.

He said that the implementation of all recommendations should be realistic and thrust shall be given on public-private participation. **T**EW DELHI- A team of counter-insurgency experts from Israel art touring Kashmir on the invitation of Indian Home Minister Lal Krishna Advani, news reports said Saturday. The team is headed by Eli Katzir of the Counter-Terrorism Combat Unit of the Israeli prime minister's office, reports said adding that other members of the group include senior Israeli police commanders and military intelligence personnel. There was no immediate confirmation of the report but the times of India newspaper today said the team will prepare a feasibility study of India's security needs in Kashmir, where Muslim insurgents have waged an armed homeland campaign since 1989.

The newspaper said the Israelis will also visit other areas in India which are plagued by insurgencies.

Home Minister Advani during a trip to Israel in June had sought help from Tel Aviv to fight cross-border militancy in Kashmir, where around 34,000 people have died in violence linked to Muslim secessionism.

Israel reportedly agreed to transfer information, military hardware and counter-terrorism methods, but said it will not participate in training Indian personnel or dispatch Israeli experts to India. The Israeli daily Haaretz in a similar report on Friday also said the visit was in line with Advani's June visit "India is particularly interests in improving secu¬rity along its border with Pakistan, especially in Kashmir, and in particular with blocking guerrilla infiltrations it said adding experts wound up their trip cm Today.

t took just fifteen days for New Delhi to take steps to address the demand in Buddhist majority Leh for constitutional safeguards to protect region's demography. According to 2011 census, the population of Leh is just 1,33,487. But this fact didn't come in the way of the centre not considering Leh's demand on an urgent basis. Contrary to this, population of Muslim majority Kashmir Valley in J&K is over 7 million but a similar demand for protection to local demography has no takers in New Delhi.This, despite the fact, that the six political parties that comprise the three-fourth of the entire mainstream politics of J&K passed a resolution - also called Gupkar declaration - to this effect. In Ladakh again, Muslim ma-

In Ladakh again, Musilm majority Kargil with a population of 1,40,802 wants to stay as a part of Kashmir Valley and also agrees with Gupkar declaration but New Delhi doesn't give a damn about it. Kargil leadership has also challenged Leh's remit to speak for more importantly the anticipated shift of political power away from Kashmir Valley. In fact, under the current dispensation this shift has already happened. And with delimitation that is supposed to give more Assembly seats to Jammu, this power-shift will also be inherited by a future democratic government. So, unlike Leh, Jammu is least likely to hit the road against the prospect of a demographic change and the potential loss of land to outsiders.

Where does this leave Kashmir Valley? Nowhere. The Valley could have hoped for some restraint by centre in the execution of its J&K project only if some of its elements say demographic change had been resolutely opposed in Jammu. There is, no doubt, an undercurrent of unease in Jammu over these issues but the people are willing to overlook it as the new dispensation gives the majority community in the region a political weight that is

gle for rights and empowerment in the Valley? On its face, it doesn't, Gupkar declaration, notwithstanding. Truth is it would hardly bother New Delhi, should demand for restoration of autonomy become a part of the political agenda of the Kashmiri parties either individually or collectively. In the existing situation, these parties will hardly be in a position to take this demand to the streets. And even if they did and held a peaceful rally or a protest, so what? The Valley has little political clout at the national level to force any ruling party at New Delhi to change its mind, let alone the BJP.

Also, as for the revocation of Article 370, there is now a broad consensus across the political spectrum in the country, Congress included. Congress may have been a party to Gupkar declaration, but at the national level, the party is only against the manner in which Article 370 was read down, not the

t a time when India's coronavirus cases have crossed six million and the number of deaths as a result of the contagion is over 95000, the government is mulling further opening up of the economy. In the Unlock 5 that is set to start from October 1, the government is likely to announce further relaxations that allow more economic activities to take place. One can expect some action on reopening of schools and colleges and also cinema halls. There are likely to be more measures to reopen previously closed sectors that will be known in the coming days.

One thing is clear, the union government is gradually moving towards re-opening the economy as it fears the economic fallout from stay-at-home measures will be worse than the virus. Indian economy like many economies across the world has already gone into recession. In India, the impact of the pandemic has been devastating. Millions of people have lost jobs. Millions of migrant labourers have lost livelihood and shelter in the cities forcing them to go back to their homes in the villages. This has triggered a massive suffering in its wake. And it will only get worse if the economy is not reopened.

Government has thus done well to take steps towards resuming the economic activity. In the west too, the governments are similarly moving towards getting back to normal life. And this is happening even as the Covid-19 cases are spiking and the experts are warning of a second wave of infections. But the further damage to the economy is seen to be a cure worse than the disease. More so in a country like India where a significant population lives below the poverty line. In the absence of jobs, people will die of hunger. Government is therefore doing well to unlock the economy. It should, however, make the businesses accountable for any laxity in implementing the norms of social distancing.

The world, meanwhile, is waiting for a vaccine with a bated breath. Though some vaccine candidates are in phase-3 trials, we are still some time away from their use against the contagion. So, the governments worldover have no option but to buy time till the vaccines are ready and can be produced on a mass scale. Though the cases in India have spiked exponentially in recent past, the number of infections is not huge given the size of its population. Moreover, on a positive note, the recoveries in India have been higher than the global average. With hopefully, the vaccine around the corner, things from hereon are only expected to look up. While the union government will need to take measures to steer the nation through this critical period, the onus is also on the ordinary people to exercise the safety precautions to ensure the infection is held in check.

## The NDA's labour laws

s part of its economic reforms programme, the Union government passed three codes on labour laws recently. These, along with the Code on Wages enacted in 2019, complete the labour market reforms agenda of the National Democratic Alliance government. The reforms aim to achieve two main objectives. The first is to rationalize the existing bits and pieces of legislations pertaining to labour markets into four simplified codes covering wages, workers' rights, industrial relations, occupational safety and social security. The second objective is to energize economic activities by making it easier for employers to hire and fire workers without creating additional uncertainty for the latter. Indian industry has long been constrained by archaic labour laws that had the aim of protecting workers from arbitrary exploitation in a labour-surplus economy. Although the aim was certainly laudable, it made it extremely difficult for employers to be flexible in disengaging workers. Indeed, labour began to be treated as a fixed cost by employers and they began to find ways and means, through suitable choice of technology, to minimize employment. The paradoxical outcome was high unemployment with labour-saving technologies being preferred by even small and micro enterprises. In the informal sector, which employs the largest segment of the nation's labour force, workers had hardly any rights worth mentioning. In the organized sector, on realizing that it was difficult for the employers to retrench them, militant workers often went on strike and disrupted production on flimsy grounds.

The new codes aim to correct many of these anomalies. For instance, the right to strike remains but the notice period has been increased. Similarly, employers will find it easier to offer employment to workers on a contractual basis provided they are treated on a par with regular workers in terms of working hours, pay and benefits like gratuity. Finally, economies with easy flexibility enable employers to hire and fire. But they also have a wide social security network, which provides safety to individual workers when they are not employed. This task of protection is taken up by the State and not left as the private liability of an employer. The new codes aim to provide additional and wider cover for India's embryonic social security apparatus. These changes are certainly going to benefit employers. The rules that protect workers must be followed strictly. Only then would Indian industry become mature and more efficient.

In J&K, centre has similarly shown it is sensitive to the public sentiment in the Hindu majority Jammu. This is why, it was only after Jammu protested against jobs in J&K being made available to outsiders, that centre reserved all of them for the domiciles of J&K.

Jammu thus holds key to how New Delhi deals with J&K. And so far the region has given little indication that it is unhappy with the existing state of affairs beyond a point. At one level, the situation in Jammu is not greatly different from that of Ladakh. The region is also witnessing a degree of anxiety about the post-Article 370 state of affairs and for more or less similar reasons: loss of jobs, land and identity. People apprehend that their region will be the first destination for the eligible outsiders choosing to settle in J&K.

But as things stand, these apprehensions are not deep enough to cause people to protest publicly. disproportionately bigger than its demographic strength.

Jammu would certainly have fought any attempt at a demographic change and loss of land and jobs, had the region been carved into either a separate state or a union territory just like Ladakh. And it is probably for the same probable reason that New Delhi didn't trifurcate J&K despite the longstanding demand for statehood in Jammu.

This has created a structural reality that is inherently aligned against Kashmir Valley. And the people in the Valley are deeply conscious of this fact. The new situation has created a massive sense of disempowerment, something that Farooq Abdullah in an interview to Karan Thapar described as "a feeling of slavery".

Does this reality leave any scope or space for a peaceful strug-

act of doing so. For the BJP, on the other hand, acting tough with Kashmir wins it more popular support. And in the remaining four years of its power the party thus seems set to take its project to remake Kashmir in its own image to its logical conclusion.

This reality neither affords space to local politics nor lends it any power to force centre to modify its existing approach to Kashmir. As of now, the importance of Gupkar declaration is only in giving the establishment parties an agenda point that makes their politics relevant to the transformed situation. They have something to go to people with, something to fight for. Nothing more, nothing less.

The Oculus Quest 2 is the latest step in Facebook's long-term strategy of making VR more accessible and popular. Facebook recently brought all its VR work under the umbrella of Facebook Reality Labs, it has announced new applications like the Infinite Office VR workplace, and will also require a Facebook login for future Oculus devices.

The compulsory link to Facebook has many consumers concerned, considering the social media giant's chequered history with privacy and data. VR and its cousin, augmented reality (AR), are perhaps the most data-extractive digital sensors we're likely to invite into our homes in the next decade.

Why does Facebook make virtual reality headsets?

Facebook acquired VR company Oculus in 2014 for an estimated US\$2.3 billion. But where Oculus originally aimed at gamers, Facebook boss Mark Zuckerberg wants VR for social media.

At the same event last year, Zuckerberg said Facebook sees VR as a pathway to a new kind of "social computing platform" using the enhanced feeling of "presence" that VR affords. For Facebook, the introduction of VR-based computing will be like the leap from textbased command line interfaces to the graphical user interfaces we use today.

This may well be right. VR affords a strong feeling of embodied presence that offers new possibilities for entertainment, training, learning and connecting with others at a distance.

But if the VR future is the one Facebook is "working in the lab" on, it will function via the company's existing social computing platform and business model of extracting data to deliver targeted advertisements.

#### Virtual reality collects real data

A VR headset collects data about the user, but also about the outside world. This is one of the key ethical issues of emerging "mixed reality" technologies.

As American VR researcher Jeremy Bailenson has written:

...commercial VR systems typically track body movements 90 times per second to display the scene appropri-

ately, and high-end systems record 18 types of movements across the head and hands. Consequently, spending 20 minutes in a VR simulation leaves just under 2 million unique recordings of body language.

The way you move your body can be used to identify you, like a fingerprint, so everything you do in VR could be traced back to your individual identity.

Facebook's Oculus Quest headsets also use outward-facing cameras to track and map their surroundings.

In late 2019 Facebook said they "don't collect and store images or 3D maps of your environment on our serv-

ers today". Note the word today, which tech journalist Ben Lang notes makes clear the company is not ruling out anything in the future.

#### Virtual reality leads to augmented reality

Facebook wants to collect this data to facilitate its plans for augmented reality (AR).

Where VR takes a user to a fully virtual environment, AR combines virtual elements with our real surroundings.

Last year Facebook unveiled the Live Maps application, a vision of an expansive surveillance apparatus presumably powered by AR glasses and data collected from Oculus Insight. Live Maps will provide many minor conveniences for Facebook users, like letting you know you've left your keys on the coffee table.

Now Facebook have announced their first steps towards making this a reality: Project Aria. This will involve people wearing glasses-like sensors around Seattle and the San Francisco Bay area, to collect the data to build what Wired co-founder Kevin Kelly calls "the mirrorworld", the next big tech platform.

framing questions about VR and AR surveillance in terms of individual privacy suits companies like Facebook very well. That's because their previous failings are actually in the (un)ethical use of data (as in the case of Cambridge Analytica) and their asymmetric platform power.

#### We need more than just 'tech ethics'

Groups like the XR Safety Initiative recognise these emerging issues, and are beginning work on standards, guidelines and privacy frameworks to shape VR and AR development.

Many emerging technologies encounter what is known as the Collingridge problem: it is hard to predict the various impacts of a technology until it is extensively developed and widely used, but by then it is almost impossible to control or change.

We see this playing out right now, in efforts to regulate Google and Facebook's power over news media.

As David Watts argues, big tech designs its own rules of ethics to avoid scrutiny and accountability:

Feelgood, high-level data ethics principles are not fit for the purpose of regulating big tech ... The harms linked to big tech can only be addressed by proper regulation.

What might regulation of Facebook's VR look like? Germany offers one such response – their antitrust regulations have resulted in Facebook withdrawing the headset from sale. We can only hope the technology doesn't become too entrenched to be changed, or challenged.

But regulation has not always stopped Facebook in the past, who paid out US\$550 million to settle a lawsuit for breaching biometric privacy laws. In the multi-billion dollar world of bigtech, it's all a cost of doing business.

## Threat to evacuate US diplomats from Iraq raises fear of war

#### Agencies

Washington: Washington has made preparations to withdraw diplomats from Iraq after warning Baghdad it could shut its embassy, two Iraqi officials and two Western diplomats said, a step Iraqis fear could turn their country into a battle zone.

Any move by the United States to scale down its diplomatic presence in a country where it has up to 5,000 troops would be widely seen in the region as an escalation of its confrontation



with Iran, which Washington

blames for missile and bomb attacks.

That in turn would open the possibility of military action, with just weeks to go before an election in which President Donald Trump has campaigned on a hard line towards Tehran and its proxies. Secretary of State Mike Pompeo threatened to close the embassy in a phone call a week ago to President Barham Salih, two Iraqi government sources said. The conversation was initially reported by an Iraqi news website.

By Sunday, Washington had begun preparations to withdraw diplomatic staff if such a decision is taken, those sources and the two Western diplomats said. The concern among the Iraqis

is that pulling out diplomats would be followed quickly by military action against forces Washington blamed for attacks.

## **Defying US Sanctions Iranian Tanker Reaches Venezuela**

Beijing: China began five military exercises simultaneously along different parts of its coast on Monday, the second time in two months it will have such concurrent drills against a backdrop of rising regional tension. Two of the exercises are being

held near the Paracel Islands in the disputed South China Sea, one in the East China Sea. and one in further north in the Bohai Sea, the Maritime Safety Administration said in notices on its website. In the southern part of the Yellow Sea, drills including livefire exercises will be held from Monday to Wednesday, it said

in another notice. All ships are prohibited from

entering the area, it said. In a bid to train a combatready military force, China holds military drills periodically, but rarely do multiple exercises happen at the same time.

Last month, China announced four separate exercises, from the Bohai Sea to the East and Yellow Seas and down to the disputed South China Sea, in what Chinese military experts said was a rare arrangement of drills. The United States sent spy planes into a no-fly zone over Chinese live-fire military drills last month. In response, China

lodged "stern representations" with the United States. China and the United States have recently been at loggerheads over a range of issues from Taiwan to the coronavirus pandemic to trade and human rights.

China has also held frequent military activities near Chinese-claimed Taiwan and has taken the usual step of declaring that such drills are directed at Taiwan.

## Afghan peace negotiator urges new era in ties with Pak

Kabul: The chief of Afghanistan's peace negotiating team said Tuesday on a visit to Pakistan that the time has come for the two neighboring countries to shun the suspicion, "stale rhetoric" and tired conspiracy theories that have dogged past relations.

Abdullah Abdullah is in Pakistan on a bridge-building mission meant to mend deeprooted mistrust between the two countries. It was his first visit in 12 years.

## 'No more ladies and gentlemen': Japan **Airlines embraces gender neutral greetings**

apan Airlines is ditching the phrase "ladies and gentlemen" and instead embracing gender neutral terms during inflight and airport announcements from next month, the company said Monday.

From October 1, JAL "will abolish expressions that based on (two types of) sex and use gender-friendly expression" like "good morning" and "good evening," a spokesperson for the airline told AFP.

Japanese, the expression generally used for such announcements is already gender-neutral, but the decision applies to other languages used by the airline.

The decision appears to be a first for major Japanese carriers, with a spokeswoman for rival ANA Holdings telling AFP they would "study the issue based on comments from



our customers.

Same-sex marriage is not legally recognised in Japan but the government has gradually expanded rights protections for lesbian, gay, bisexual and transgender citizens in recent years.

JAL last year operated trial "LGBT Ally Charter" flight for same-sex partners and their families, and has already changed rules to extend spouse and family allowances to same-sex partners.

While Japan is relatively tolerant of homosexuality, there are no specific legal protections for gay people.

Japan's LGBTQ population has campaigned for greater recognition from the government in recent years.

Thirteen same-sex couples filed suits last year accusing Tokyo of discrimination for failing to recognise their unions.
