#### SC Directs Refund Of Flight Tickets Cancelled Due To Lockdown

NEW DELHI: The Supreme Court Thursday directed refund of air tickets, domestic and international, for travel during the CO-VID-19 lockdown period from March 25 to May 24 within three weeks from the date of the cancellation of flights.

Accepting the Centre's proposal, the top court directed that if the tickets have been booked through an agent for travel within the lockdown period, in all such cases full refund shall be given by the airlines immediately and the amount shall be passed on immediately by the agent to the passengers. #### 5% Interest Subvention For **Onus On Pakistan To Create Normal Ties: India Borrowers: Govt**

SRINAGAR: Jammu and Kashmir government on Thursday evening accorded formal sanction for interest subvention of 5% in case of all borrowers, excluding borrowers under KCC, ACC, Loan against deposits, Loans under personal segments, NBFCs for a period of six months w.e.f 1st April, 2020 announced

COVID-19 pandemic and any strict enforcement action of Civil Aviation Requirement (CAR) (aviation norms) against the airlines would further restrict their operations.

It cannot be disputed that the civil aviation sector, which is one of the important sectors, is seriously affected in view of the ban imposed for operating flights. Added to the same, air passenger traffic has come down heavily and which is gradually being restored, the top court said. It added that any such enforcement action may further jeopardise the possibilities of generation of cash by airlines which can further adversely affect/delay the refund cycle.

It may be recalled that although a Memorandum of Understanding (MoU) had been signed among J&K Power Development Department, J&K State Power Development Corporation Limited and NHPC Limited on 3rd Feb, 2019, regarding the execution of the project in JV mode, yet the matter had remained pending for want of a final decsion on the mode of execution. The government of J&K had been consistently arguing for exceution of the work in the IV mode as agreed in the Feb 2019 MoU.

J&K has over 20,000 MW of hydro power potential, out of which 16000 MW has been identified. With the PIB decision, J&K would have moved another step closer to harnessing nearly 2500 MW of this potential. While the 1000 MW Pakaldul project and 624 MW Kiru are already under exceution by Chenab Valley Power Project Private Limited (CVPPL), a Joint Venture of JKSPDC, NHPC and PTC India limited, the 540 MW Kawar is likely to be taken up shortly.

Now that the decks have been cleared for the 850 MW Ratle project too to come up after incorporation of Joint Venture company i.e Jammu Hydroelectric Power Corporation Limited, an additional 3000 MW will be available to supplement the demand-supply position in J&K and boost the overall economy of the UT.

### SC Directs Refund Of Flight...

airline/airlines are not able to refund then they shall provide credit shell, equal to the amount of fare collected, in the name of passenger when the booking is done either directly by the passenger or through travel agent so as to consume the same on or before March 31, 2021. It is open to passengers either to utilise such credit shell up to March 31, 2021 on any route of choice or transfer the credit shell to any person including the travel agent concerned, and the airlines shall honour such a transfer, the top court said.

A bench of Justices Ashok Bhushan, R Subhash Reddy and M R Shah said the suggestions and formulations arrived at the meeting held by the Ministry of Civil Aviation (MCA), Director General of Civil Aviation (DGCA), which are acceptable to the majority of stakeholders have to be implemented in letter and spirit.

We also feel that such formulations are workable solutions in these peculiar circumstances which are prevailing in the country, the bench said, while passing a slew of directions for refund of air tickets to the hassled passengers, whose flights were cancelled due to the pandemic induced lockdown.

The top court's verdict came on a batch of petitions, including by NGOs and passengers associations, seeking complete refund of ticket fare for the flights cancelled.

It said that the court cannot lose sight of the present situation prevailing in the country and across the globe with regard to the effect of the

for travel after May 24, then the refund of fares to the passengers covered under this category shall be governed by the provisions of CAR. Even for international travel, when the tickets have been booked on an Indian carrier and the booking is ex-India (flights originating from India), if the tickets have been booked during the lockdown period for travel within the lockdown period, immediate refund shall be made, the bench said in its order.

If the tickets are booked for international travel on a foreign carrier and the booking is ex-India during the lockdown period for travel within the lockdown period, full refund shall be given by the airlines and said amount shall be passed on immediately by the agent to the passengers, wherever such tickets are booked through agents, it added.

In all other cases airline shall refund the collected amount to the passenger within a period of three weeks, the bench emphasised and added that the credit shell issued in the name of the passenger shall be transferable which can be utilized up to March 31, 2021 and the concerned airline shall honour such a transfer by devising a mechanism to facilitate such a transfer.

It is also made clear that such a credit shell can be utilized by the concerned agent through whom the ticket is booked, for third party use. It is also made clear that even in cases where the credit shell is transferred to a third party; same is to be utilized only through the agent who has booked the ticket at the first instance, it directed. Justice Reddy, who penned the verdict on behalf of the bench, said that in cases where passengers have purchased the ticket through an agent, and credit shell is issued in the name of passenger, such credit shell is to be utilized only through the agent who has booked the ticket. It said that in cases where tickets are booked through agent and credit shell is issued in the name of the passenger remains unutilized till March 31, 2021, then the refund of the fare collected shall be made to the same account from which account amount was received by the airline. The bench said that in all cases where credit shell is issued there shall be an incentive to compensate the passenger from the date of cancellation up to June 30, 2020 in which event the credit shell shall be enhanced by 0.5 per cent of the face value (the amount of fare collected) for every month or part thereof between the date of cancellation and June 30, 2020.

#### Ex-JK Bank Chairman Booked ...

"The ACB has registered an FIR against Sahil Vora and Rishabh Vora, directors, SILA Solutions Pvt Ltd, on the allegation that officials of J-K Bank awarded tenders of housekeeping to a Mumbai-based company by not following the proper tendering norms that led to the losses to the tune of Rs 6.29 crore to the bank from the date of award of contract," an official spokesperson said.

In its FIR, the ACB has also named Surjeet Singh Seghal, the then executive president J-K Bank (now retired), Parvaiz Ahmad, the then chairman of J&K Bank (now retired), Feroz Ahmad, the then assistant vice president, he said.

The spokesperson said the case pertains to allotment of tenders for housekeeping of off site ATMs to SILA Solutions by not following proper tendering norms as provided the contract to the said firm despite not falling into the criteria of any such allotment.

"Earlier, a verification was conducted by the Anti Corruption Bureau into the matter wherein it was revealed that J-K Bank with headquarters at Srinagar came out with a pan-India tender for housekeeping services in 2015.

"I-K Bank officials in contravention of tender conditions negotiated the rates with SILA Solutions and the company was awarded the tender in gross violation of the General Financial Rules (GFR)," the officials, pending enquiry into their conduct in connection with a case registered by the vigilance organization Kashmir, now Anti-Corruption Bureau, in 2014.

The suspension order has been issued with immediate effect in terms of Rule 31 of Jammu & Kashmir Civil Services (Classification, Control & Appeal) Rules 1956, reads a government order issued here, reported news agency GNS.



# Mehbooba Mufti's detention

Superior Court on Tuesday asked the centre and J&K government how long it wished to keep the former J&K Chief Minister Mehbooba Mufti in custody. The observation was made while hearing the petition of Mehbooba's daughter Iltija Mufti that challenges the former Chief Minister's detention under the stringent Public Safety Act (PSA). Mehbooba along with other political leaders was taken into custody on August 5, 2019 when the centre repealed Article 370 that granted J&K autonomy under India's constitution. But while other leaders including Dr Farooq Abdullah and his son Omar Abdullah, both former J&K Chief Ministers, have since been released, Mehbooba not only continues to be under detention but has also the PSA slapped against her to perpetuate her incarceration.

Supreme Court has asked the government that prima facie it had "exceeded the maximum period of detention" for Mehbooba. However, the reality is that there is still no indication that Mehbooba is going to be released anytime soon. Her release will depend on how the court disposes of the case in a future hearing.

Besides political leaders, there were civil society activists and hundreds of youth who were part of over 13000 detentions made in the wake of August 5 move. A large number of them have since been released. But many who have not been have also filed their petitions with the courts. Their cases are yet to be disposed of leading the High Court Bar Association to raise this issue in a letter written in June to Chief Justice of India S ABobde.

According to Bar Association, 99 per cent of the habeas corpus petitions filed with the J&K High Court since the scrapping of Article 370 in August last year have remained pending. The letter reveals that "since 6th of August, 2019, more than 600 habeas corpus petitions have been filed before the Hon'ble High Court of Union Territory of J&K at Srinagar and till date not even 1 per cent of such cases have been decided". The bar association has also said that it had approached High Court Chief Justice Gita Mittal with their concerns, but no concrete steps were taken.

The past year, however, has been tough on both the people and the institutions of J&K. Due to a stringent security lockdown and snapping of all means of communications, even High Court could not function properly. Things became worse when post-Article 370 lockdown was followed by Covid-19 lockdown that brought the economy and the government to a stop. But with economy incrementally re-opening, things can be hoped to get back to normal in near future. There is hope that not only the habeas corpus petitions in the High Court will be disposed of soon but there will also be a decision on Mehbooba's continued detention.



# View from the Foyer Encounter Killings

his week saw the death of both a soldier and a militant in Pulwama, which has somehow become synonymous with killings. It began with news about the presence of militants in Kamrazipora, which led the forces to scout the area. An exchange of fire ensued, in which the soldier, SowarJilajeet Singh Yadav, lost his life. But a militant was also killed in the encounter. Search operations in the fruit orchard in which the militants hid, continued for the next few days. Colonel Rajesh Kalia, the Indian Army's Public Relations Officer, told journalists that an AK 47 rifle, grenades, pouches and other ammunition were recovered during the search

The incident reminded me of what happened in Srinagar on 1st July, when a 60-year-old man who was driving with his four-year-old grandson was pulled out of his car and shot dead, allegedly by security forces. We who securely live in mainland India were moved to tears by images of the little boy innocently sitting on his grandfather's corpse, which went viral on social media. How long will such atrocities go on in Jammu& Kashmir, we asked ourselves.

### Impunity in Hathras

he gangrape and maiming of a 19-year-old woman from the Dalit community in Hathras, Uttar Pradesh, ended on Tuesday night with her death, and a hasty, lonely cremation in the dead of the night. It was a crime that stands out for being enabled by many inequalities and injustices. The most striking is the caste privilege that allows upper-caste men entitlement, with apparent impunity, over the bodies of Dalits. (The accused are from a Thakur family with a record of caste violence against the victim's family). It is one more example of the epidemic of sexual violence that regularly crushes Indian women and girls. UP police officials stand accused of cremating the woman, without allowing a last glimpse to the grieving parents and without their consent. To be able to inflict so much cruelty takes insensitivity, of course, but it is also a function of a reflex, honed over years, to bend to entrenched systems of power.

The Uttar Pradesh police, in the last few years, has consistently chipped away at its facade of being a professional police force. In the service of "a tough administration" and a "nationalist" macho government, it has crossed several red lines. Extra-judicial killings are projected and celebrated as justice, despite reprimands from the Supreme Court — and no police officer is held accountable. As an investigation in this paper has shown, the National Security Act (NSA) is used recklessly in cases of cow slaughter — often a dog whistle in heartland politics against the minorities — and also to book those protesting against the Citizenship Amendment Act. The crackdown against protestors during the anti-CAA protests, their naming and shaming through posters in public places, were all giveaways of a police force ready to use a heavy hand to serve a partisan agenda.

In a democracy, the state is granted the monopoly of violence, but, in turn, it is bound to fairness, justice and due process for all — and not just the few. But lawkeepers, unless held accountable to law, remain a weapon in the hands of the powerful. The Hathras incident underlines that the all-powerful UP policeman, impatient with the checks of procedure and law, stands against the vulnerable and powerless. The UP police has often justified its excesses in the name of maintaining law and order; it must ask itself what law was protected by violating the sanctity of a 19-year-old girl's last rites.

lyincident, a 62-year-old father and his 32-year-old son in Tamil Nadu were arrested, tortured and brutally killed in custody by policemen for keeping their mobile store open well beyond the stipulated hours during the coronavirus lockdown. However, in this case a Tamil Nadu court held the cops guilty on the basis of autopsy reports, and ordered their arrest. Later, the Madurai bench of the Madras High Court asked the CBI to investigate the case. Only last week, we heard that the CBI has charge-sheeted the nine policemen guilty of the heinous crime. They have been booked for murder, criminal conspiracy and destruction of evidence.

record when it comes to opening fire on civilians. Only last month, they beat up two journalists, again in Pulwama. One of them, Faisal Bashir, was a freelance journalist, while the other, Kamran Yousuf, was a photo-journalist employed by a news portal. Yousuf's camera, it is said, was damaged in the scuffle.

A human rights violation is a human rights violation, regardless of who commits it. It thus comes as a welcome change when we hear that the army has finally initiated disciplinary action against its soldiers for firing upon and killing three civilians in the name of encounters in Shopian district on 18 July, a little over a fortnight after the Srinagar incident. The civilians were casual labourers the Fundamental Rights granted to citizens by Article 19 of the Constitution. It is also contrary to the spirit of the welfare state. Soldiers must not get away with the impression that they have the licence to rape, torture and kill civilians without the fear of being court-martialled. Unfortunately, they have been doing this for decades in all the so-called "troubled" regions of the country.

### **Disclosing Identity of a Rape Victim**

he Hathrasgangrape incident took the internet by storm and netizens were demanding that the culprits should be brought to Justice and strictly penalized. This is a legitimate call. But in this entire hue and cry, many, including high class celebrities crossed the line and disclosed the identity of victim.

These celebrities who have a great following on social media used a Hashtag which disclosed the name of the victim and this criminal hashtag was obviously set to become a trend. Some of them even shared pictures of the victim without blurring it. This was another illegal and worrisome instance incidental to this rape case and equally shocking and condemnable. The point of law on the issue is well settled by statutory declarations and the judicial pronouncements. By and large, they place an absolute bar on any kind of identity disclosure of rape victim in the public domain. The act of disclosing the identity of rape victim constitutes an offense and is punishable under Section 228A of Indian Penal Code (I.P.C). Section 228A of I.P.C is clear and unambiguous — the consequence of breach of it is inescapable and the question whether the disclosure was intended, bonafide or without knowledge of law has no relevance.

Supreme Court, in the NipunSaxena Case had declared,"No person can print or publish in print, electronic, social media, etc. the name of the victim or even in a remote manner disclose any facts which can lead to the victim being identified and which should make her identity known to the public at large. Where the victim is dead or of unsound mind the name of victim or her identity should not be disclosed even under the authorization of the next of the kin, unless circumstances justifying the disclosure of her identity exist, which shall be decided by the competent authority."

This law has a social objective of preventing social victimization or ostracisation of the victim or her family. It needs to be understood that it is not mandatory to use the name of victim as a symbol for protest or to arouse public opinion and sentiment against heinous sexual offenses.

Furthermore for the efficient implementation of any law and to avoid repercussions of lawlessness, the awareness of laws in public becomes sine qua non. Mere publication of laws in official gazette will definitely not suffice. There should be legal awareness programmes conducted on a large scale by governmental and nongovernmental organisations throughout the country so as to have an effective check and permanent control on such mass violation of laws.

# Valuing Reflection in Understanding Religious Texts



Although wellmeant, we inadvertently allow our reverence to morph into an insurmountable hindrance for children whose relationship with God's word becomes shallow and dictated.

he tradition of transmitting the Word of God is a rigorous exercise throughout the Muslim world including Kashmir. Various mechanisms are followed in different cultures to pass down the Sacred word to new generations. The exercise at every succeeding level becomes more nuanced and branches out further to include the study of allied subjects like Islamic Jurisprudence, detailed exegesis and Tassawuf studies. However, being the first encounter with the Sacred Word, elementary learning of Quran is of quintessential importance for children and society at large as it sets the trajectory for their future relationship dynamic with religion. This calls for a very subtle, carefully planned teaching pedagogy and robust learning environment to foster critical thinking and deeper engagement which unfortunately is gravely missing in our context.

In our Valley, transmitting down the Sacred Word at basic level has undergone a sea of change over the past few decades. Traditionally, elementary Quranic teaching was a household exercise taken up by family elders which encapsulated perusing Kashmiri translations as well. In past few decades the entire framework of dispensing the Quranic knowledge has undergone some major positive changes which have underlining sociological reasons.

Over the years, Quranic teaching wrested itself from the hegemonic clutches of few dominant groups who exercised exclusive control over its dispensation. With the decentring of epistemological hegemony over the Word of God, Darsgahs now became primal centres for elementary teaching and learning of Quran. Today, preaching the Sacred Word is no longer a prerogative of dominant few groups and age barriers on learning are also dwindling down. Nonetheless, the common thread that runs through these phases of teaching is impermeability to critical thinking and intolerance to questioning which is either taken as a disregard for the sacred



text or dismissed as weakness in faith.

Quranic teaching has become a robust and commonplace exercise with the establishment of study centres for Quranic learning which have diversified it further with the inclusion of allied religious texts like Hadith and nuances like rules if recitation. Some schools have also redefined their curricula and mandated teaching and memorising of Quran, and allied subjects right from the elementary level. Internet has further democratized preaching practices. Yet despite all these wellmeant and informed transformations in teaching and learning dynamic, critical learning largely faces a dismissal. This partly entails from the fact that questioning and critical understanding is often dismissed as digression from Satan. In our common understanding, in darsgahs and other religious platforms. reflection and reasoning is almost pitted against faith. Critical engagement which engenders a holistic relationship remains undervalued and the Prophetic teaching, "The cure for ignorance is to question", unpractised

Although well-meant, we inadvertently allow our reverence to morph into an insurmountable hindrance for children whose relationship with God's word becomes shallow and dictated. Mumtaz Mufti, a prominent Pakistani writer's personal observations in this case offer some prolific insights. He once noted in his renowned work Talaash (The Search) that he always wanted to informalise his relationship with the Glorious Quran by, for example, keeping the Book by his bedside or on a regular table so that he could read it anytime. He wanted his relationship with the Sacred word to be intimate and more engaging rather than of hesitation and formalities

Mufti's observations are not out of place for us even today. Our bond with the Holy book is of mere reverence and not of close engagement when it should be both. We recite and memorise it usually with an intent to find our way to Paradise which is but an incomplete exercise. The tradition of reflecting upon the Holy verses, posing questions and digging into answers is however missing. "Afala Taqi'lun", Afala Tattafaqarun, as many times Quran invites us to reason and think rigorously, we prefer only to read rather than study it. Wrapping it up in the fabrics of satin and silk finds more meaning with us than adopting an approach of reflection.

> Also, isolated understanding of Quran and other religious texts is not free from fallibilities. Complementary and responsible reading of history, psychology, culture, developments in science is important to attain a more contextual and nuanced grasp over religious knowledge. This will also serve as a panacea to counter unhindered information overload and fragmented treatment meted out to religious texts that is a character of the present, networked societies. Imparting the spirit of questioning and reasoning to children in particular and every learner in general is indispensable to encouraging selfresearch and hence the quest of finding answers. Bottling up doubts, or casting a cynical eye conversely, in the name of reverence or often goes into birthing passivity or faith crises specially for children as they grow up.

> Darsagahs, religious Islamic learning centres and schools in addition to disseminating religious education need to foster the atmosphere of critical inquiry for younger generations to become active contributors rather than passive adherents of a set of rules they don't understand the true spirit of. Further, debunking deep-seated colonial tropes that have tainted Muslims' understanding of their own history and religious texts essentially warrants this pedagogical reformation. Such reformation will resolve many issues that our society is facing internally and prepare it for various challenges coming from without.

apart from many of his contemporaries, Keshavarz told me. Still, Rumi built a large following in cosmopolitan Konya, incorporating Sufis, Muslim literalists and theologians, Christians, and Jews, as well as the local Sunni Seljuk rulers. In "Rumi's Secret," Gooch helpfully chronicles the political events and whose book "Iron John: A Book About Men," from 1990, greatly informed the modern men's movementlater translated some of Rumi's poems himself.) Barks had never studied Islamic literature. But soon afterward, he told me recently, over the phone from his home in Georgia, he had a dream. In the dream he was sleeping on a cliff near a river. A stranger appeared in a circle of light and said, "I love you." Barks had not seen this man before, but he met him the following year, at a Sufi order near Philadelphia. The man was the order's leader. Barks began spending his afternoons studying and rephrasing the Victorian translations that Bly had given him. Since then, he has published more than a dozen Rumi books. In our conversation, Barks described Rumi's poetry as "the mystery of opening the heart," a thing that, he told me, "you can't say in language." In order to get at that inexpressible thing, he has taken some liberties with Rumi's work. For one thing, he has minimized references to Islam. Consider the famous poem "Like This." Arberry translates one of its lines, rather faithfully, as "Whoever asks you about the Houris, show (your) face (and say) 'Like this.' " Houris are virgins promised in Paradise in Islam, Barks avoids even the literal translation of that word: in his version, the line becomes, "If anyone asks you how the perfect satisfaction of all our sexual wanting will look, lift your face and say, Like this." The religious context is gone. And vet, elsewhere in the same poem. Barks keeps references to Jesus and Joseph. When I asked him about this, he told me that he couldn't recall if he had made a deliberate choice to remove Islamic references, "I was brought up Presbyterian," he said. "I used to memorize Bible verses, and I know the New Testament more than I know the Koran." He added. "The Koran is hard to read." Like many others, Omid Safi credits Barks with introducing Rumi to millions of readers in the United States; in morphing Rumi into American verse, Barks has dedicated considerable time and love to the poet's works and life. And there are other versions of Rumi that are even further removed from the original—such as the New Age books by Deepak Chopra and Daniel Ladinsky which are marketed and sold as Rumi but bear little resemblance to the poet's writing. Chopra, an author of spiritual works and an alternative-medicine enthusiast, admits that his poems are not Rumi's words. Rather, as he writes in the introduction to "The Love Poems of Rumi," they are ' 'moods' we have captured as certain phrases radiated from the original Farsi, giving life to a new creation but retaining the essence of its source.' Discussing these New Age "translations," Safi said, "I see a type of 'spiritual colonialism' at work here: bypassing, erasing, and occupying a spiritual landscape that has been lived and breathed and internalized by Muslims from Bosnia and Istanbul to Konya and Iran to Central and South Asia." Extracting the spiritual from the religious context has deep reverberations. Islam is regularly diagnosed as a "cancer," including by General Michael Flynn, President-elect Donald Trump's pick for national-security adviser, and, even today, policymakers suggest that

non-Western and nonwhite groups have not contributed to civilization.

For his part, Barks sees religion as secondary to the essence of Rumi. "Religion is such a point of contention for the world," he told me. "I got my truth and you got your truth—this is just absurd. We're all in this together and I'm trying to open my heart, and Rumi's poetry helps with that." One might detect in this philosophy something of Rumi's own approach to poetry: Rumi often amended texts from the Koran so that they would fit the lyrical rhyme and meter of the Persian verse. But while Rumi's Persian readers would recognize the tactic, most American readers are unaware of the Islamic blueprint. Safi has compared reading Rumi without the Koran to reading Milton without the Bible: even if Rumi was heterodox, it's important to recognize that he was heterodox in a Muslim context-and that Islamic culture, centuries ago, had room for such heterodoxy. Rumi's works are not just layered with religion: they represent the historical dynamism within Islamic scholarship. Rumi used the Koran, Hadiths, and religion in an explorative way, often challenging conventional readings. One of Barks's popular renditions goes like this: "Out beyond ideas of rightdoing and wrongdoing there is a field. / I will meet you there." The original version makes no mention of "rightdoing" or "wrongdoing." The words Rumi wrote were iman ("religion") and kufr ("infidelity"). Imagine, then, a Muslim scholar saying that the basis of faith lies not in religious code but in an elevated space of compassion and love. What we, and perhaps many Muslim clerics, might consider radical today is an interpretation that Rumi put forward more than seven hundred years ago. Such readings were not entirely unique back then. Rumi's works reflected a broader push and pull between religious spirituality and institutionalized faith-though with a wit that was unmatched. "Historically speaking, no text has shaped the imagination of Muslims-other than the Koran-as the poetry of Rumi and Hafez," Safi said. This is why Rumi's voluminous writings, produced at a time when scribes had to copy works by hand, have survived. "Language isn't just a means of communication," the writer and translator Sinan Antoon has said. "It's a reservoir of memory, tradition, and heritage." As conduits between two cultures, translators take on an inherently political project. They must figure out how to make, for instance, a thirteenth-century Persian poet comprehensible to a contemporary American audience. But they have a responsibility to remain true to the original work-an act that, in the case of Rumi, would help readers to recognize that a professor of Sharia could also write some of the world's mostly widely read love poetry. Jawid Mojaddedi is now in the midst of a yearslong project to translate all six books of the "Masnavi." Three of them have been published; the fourth is due out this spring. His translations acknowledge the Islamic and Koranic texts in the original by using italics to denote whenever Rumi switches to Arabic. His books are also riddled with footnotes. Reading them requires some effort, and perhaps a desire to see beyond one's preconceptions. That, after all, is the point of translation: to understand the foreign. As Keshavarz put it, translation is a reminder that "everything has a form, everything has culture and history. A Muslim can be like that, too.'

Kum has helped the spiritual journey of whom similarly incorporated his work into theirs. Aphorisms attributed to Rumi circulate daily on social media, offering motivation. "If you are irritated by every rub, how will you ever get polished," one of them goes. Or, "Every moment I shape my destiny with a chisel. I am a carpenter of my own soul." Barks's translations, in particular, are shared widely on the Internet; they are also the ones that line American bookstore shelves and are recited at weddings. Rumi is often described as the best-selling poet in the United States. He is typically referred to as a mystic, a saint, a Sufi, an enlightened man. Curiously, however, although he was a lifelong scholar of the Koran and Islam, he is less frequently described as a Muslim.

The words that Martin featured on his album come from Rumi's "Masnavi," a six-book epic poem that he wrote toward the end of his life. Its fifty thousand lines are mostly in Persian, but they are riddled with Arabic excerpts from Muslim scripture; the book frequently alludes to Koranic anecdotes that offer moral lessons. (The work, which some scholars consider unfinished, has been nicknamed the Persian Koran.) Fatemeh Keshavarz, a professor of Persian studies at the University of Maryland, told me that Rumi probably had the Koran memorized, given how often he drew from it in his poetry. Rumi himself described the "Masnavi" as "the roots of the roots of the roots of religion"-meaning Islam-"and the explainer of the Koran." And vet little trace of the religion exists in the translations that sell so well in the United States. "The Rumi that people love is very beautiful in English, and the price you pay is to cut the culture and religion," Jawid Mojaddedi, a scholar of early Sufism at Rutgers, told me recently.

Rumi was born in the early thirteenth century, in what is now Afghanistan. He later settled in Konya, in present-day Turkey, with his family. His father was a preacher and religious scholar, and he introduced Rumi to Sufism. Rumi continued his theological education in Svria, where he studied the more traditional legal codes of Sunni Islam, and later returned to Konya as a seminary teacher. It was there that he met an elder traveller, Shams-i-Tabriz, who became his mentor. The nature of the intimate friendship between the two is much debated, but Shams, everyone agrees, had a lasting influence on Rumi's religious practice and his poetry. In a new biography of Rumi, "Rumi's Secret," Brad Gooch describes how Shams pushed Rumi to question his scriptural education, debating Koranic passages with him and emphasizing the idea of devotion as finding oneness with God. Rumi would come to blend the intuitive love for God that he found in Sufism with the legal codes of Sunni Islam and the mystical thought he learned from Shams

This unusual tapestry of influences set Rumi

religious education that influenced Rumi. "Rumi was born into a religious family and followed the proscribed rules of daily prayer and fasting throughout his entire life," Gooch writes. Even in Gooch's book, though, there is a tension between these facts and the desire to conclude that Rumi, in some sense, transcended his background—that, as Gooch puts it, he "made claims for a 'religion of love' that went beyond all organized faiths." What can get lost in such readings is the extent to which Rumi's Muslim teaching shaped even those ideas. As Mojadeddi notes, the Koran acknowledges Christians and Jews as "people of the book," offering a starting point toward universalism. "The universality that many revere in Rumi today comes from his Muslim context."

The erasure of Islam from Rumi's poetry started long before Coldplay got involved. Omid Safi, a professor of Middle Eastern and Islamic studies at Duke University, says that it was in the Victorian period that readers in the West began to uncouple mystical poetry from its Islamic roots. Translators and theologians of the time could not reconcile their ideas about a "desert religion." with its unusual moral and legal codes, and the work of poets like Rumi and Hafez. The explanation they settled on, Safi told me, was "that these people are mystical not because of Islam but in spite of it." This was a time when Muslims were singled out for legal discrimination-a law from 1790 curtailed the number of Muslims who could come into the United States, and a century later the U.S. Supreme Court described the "intense hostility of the people of Moslem faith to all other sects, and particularly to Christians." In 1898, in the introduction to his translation of the "Masnavi," Sir James Redhouse wrote, "The Masnavi addresses those who leave the world, try to know and be with God, efface their selves and devote themselves to spiritual contemplation." For those in the West, Rumi and Islam were separated.

In the twentieth century, a succession of prominent translators—among them R. A. Nicholson, A. J. Arberry, and Annemarie Schimmel—strengthened Rumi's presence in the English-language canon. But it's Barks who vastly expanded Rumi's readership. He is not a translator so much as an interpreter: he does not read or write Persian. Instead, he transforms nineteenth-century translations into American verse.

It's verse of a very particular kind. Barks was born in 1937 and grew up in Chattanooga, Tennessee. He received his Ph.D. in English literature and published his first book of poetry, "The Juice," in 1971. The first time he heard of Rumi was later that decade, when another poet, Robert Bly, handed him a copy of translations by Arberry and told him that they had to be "released from their cages"—that is, put into American free verse. (Bly, who has published poetry in The New Yorker for more than thirty years—and

The team includes ambassadors Guy Trouveroy of Belgium, Bernard de Monteferrand of France and Johaa Nordenfelt of Sweden. Emerging from the meeting EU ambassa¬dors ducked questions from reporters present there about the nature of discussions with the APHC leaders. When the French envoy Monteferrand was asked specifically whether they had brought a new proposal for solving the Kashmir issue, he parried the question and said the purpose of their visit was of the same nature as the previ¬ous ones. He said the Indian government was aware of the purpose of their current visit.

### **Chaotic debate leaves** America dispirited

WASHINGTON: US President Donald Trump and Joe Biden return to the campaign trail on Wednesday after a chaotic debate that allowed the 77-yearold Democratic candidate to rebuff Republican claims that he doesn't have the stamina for the White House job.

Snap polls on the debate performances of the presidential candidates leaned towards Biden, who withstood a barrage of barbs from the 74-yearold Trump while delivering some of his own.

A CBS sampling of 1,039 likely voters who watched the televised debate held in Cleveland, Ohio, had Biden edging Trump by 48 percent to 41 percent — a margin similar to that of the national polls heading into the November 3 election.

But the overall winner or loser in the case — was the 69 percent of those surveyed who said the unruly shoutfest simply left them "annoyed." "A hot mess inside a dumpster fire inside a trainwreck," said CNN host Jake Tapper, an assessment shared by many viewers and analysts. "That was the

worst debate I have ever seen. "It was a disgrace and it's primarily because of President Trump," Tapper said.

Trump spent much of the time interrupting Biden, accusing him of being controlled by the "radical left" and trying to get under his skin with comments about his son Hunter's past business affairs.

Trump had insinuated ahead of the debate that Biden is too old for the job and his mental faculties have been diminished by age.

An exasperated Biden variously described Trump as a "clown," a "fool," a "liar" and "Putin's puppy" while telling him at one point to "shut up, man." But the former vice president mostly kept his composure and went toe-to-toe with Trump for the full 90 minutes, attacking his handling of the coronavirus pandemic, race relations and the economy.

"Much of the tone for this debate was driven by Donald Trump's strategy to rattle Joe Biden with constant interruptions, taunting, and name-calling," said Mitchell McKinney, a communications professor at the University of Missouri.

### Joe Biden's use of 'Inshallah' to mock Trump raises eyebrows

emocratic Presidential candidate and former US vice president Joe Biden used a phrase during Tuesday night's chaotic first presidential debate that is all too familiar to speakers of the Arabic language and Muslim households but could hardly be expected to be heard in a nationally televised American debate: Inshallah.

Biden used the word — meaning 'God willing' in Arabic and Farsi — as Republican President Donald Trump hedged on saying when he would release his tax returns.

"Millions of dollars and you'll get to see it," Trump said of the amount he claims to have paid, according to The Washington Post.

"When?" the Democratic presidential candidate interjected. "Inshallah?"

The use of one of the most ubiquitous phrases in Arabic by gaffeprone Biden, 77, a Roman Catholic. raised evebrows in the Mideast and migrant communities, with many de-



bating the contextual meaning of the phrase

Al-Arabiya, a Saudi-owned satellite channel based in Dubai, and The National, a state-linked newspaper in Abu Dhabi, both published articles noting Biden's use of the word.

Others questioned whether Biden had used the word at all. The former vice president has battled a stutter and is known for sometimes tripping over his words, so many viewers were left wondering if he had actually said "under the law?" or "In July?" or even "Enchilada?"

However, the Democratic nominee's campaign confirmed to NPR that he had, in fact, used the phrase.

### **Banker Arrested For Insider Trading Walks Free After Deleting WhatsApp**

onstantin Vishnyak, a former VTB Capital Plc banker who deleted his Whatsapp messages "under the noses of the police," was acquitted by a London jury, dealing a blow to the Financial Conduct Authority's pursuit of insider dealing.

Vishnyak was found not guilty after jurors deliberated for slightly more than 3 hours and was promptly released by the judge. Prosecutors at the FCA had alleged that the 42-year-old banker removed the application knowing that it might be relevant to an insider-trading investigation.

But Vishnyak insisted that he'd deleted the messages because he feared being dragged into a "political scandal" if his links with a Russian suspect in a British murder investigation were known.

The verdict leaves the FCA empty handed. While the agency dropped the insider-trading investigation against Vishnyak and two other suspects, it had pursued the lesser charge of deleting the texts, a first for it.
