Police Seeks Arrest Of Dr Mubeen Shah

He was speaking after launching the third-phase of the pioneering 'Back to Village' programme in Shopian district in south Kashmir.


Sinha said the people of J-K, especially the youth, want to tread on the path of progress and development and appealed to the misguided youth to shun violence and return to the mainstream.

2 Dead Militants Of Lashkar **Among 3 Charged By NIA**

NEW DELHI: The NIA has filed a charge-sheet against three persons who allegedly underwent training in Pakistan to carry out militant attacks in India on the instructions of Pakistan-based group Lashkar-e-Taiba (LeT), an official said.

The charge-sheet against Muneeb Hameed Bhat, Junaid Ahmad Mattoo and Umer Rashid Wani, all residents of Jammu and Kashmir's Kulgam district, was filed before a special NIA court in Jammu on Thursday.

It was filed under sections of the Ranbir Penal Code and the Unlawful Activities Prevention Act (UAPA), the official said.

Mattoo and Wani were killed in separate encounters in Jammu and

Kashmir in 2017 and 2018, respectively, the NIA official said.

The case relates to subversive activities of the LeT in Kulgam. It was motivating youths such as Bhat to join the militant group and organised their travel to Pakistan for training on the basis of valid travel documents following the recommendation of separatist leaders, the NIA official said.

Investigations by the NIA, which took over the case on September 25, 2018, established that LeT militant Mattoo motivated Bhat to join the LeT and go to Pakistan for arms training, the NIA spokesperson said. He added that Wani, another LeT militant, gave him funds to meet the expenses of his visit to the neighbouring country. → PAGE 02

HC Dismisses Plea Against e-Auction Of Minor Minerals In J&K

SRINAGAR: The J&K high court has dismissed plea against e- auctions of minor minerals in Jammu and Kashmir, observing that it is the most transparent and efficient method of conducting a public auction.

A bench of Chief Justice Gita Mittal and Justice Sanjay Dhar said that decision of the government to cancel the auction of 2017 was "bonafidely based on material on record and arrived at after application of mind and full consideration of the relevant material purely in public interest."



president of the Kashmir Chamber of Commerce and Industry. Singh said that during course of investigation, police teams made correspondence with Facebook to get details of the person holding the account on the social media platform.

"On the basis of the evidence collected so far, a request has been made to the competent court for getting arrest warrant issued against him.... The process of getting a lookout notice issued on the basis of the arrest warrant is also in progress," he said.

The Jammu and Kashmir Police is trying to secure an Interpol Red Corner Notice against Shah.

The police chief said that correspondence has also been made with the revenue authorities to get his property details to declare him a proclaimed offender and subsequent attachment of his property as per law.

Shah was detained on August 6 last year, a day after the Centre abrogated special status of the erstwhile state and bifurcated it into union territories -- Ladakh and Jammu and Kashmir.

Shah's wife moved the Supreme Court challenging the order and on December 7 last year he was initially released "temporarily" from Agra jail and later all charges against him were dropped after the Jammu and Kashmir administration revoked the PSA order against him. "In exercise of the powers conferred under section 19 (1) of the Jammu and Kashmir Public Safety Act, 1978, the government hereby in supersession of government order...dated December 6, revokes the detention order...dated August 7, 2019...," the order said.

A Supreme Court bench of Justices N V Ramana, R Subhash Reddy and B R Gavai declared the petition of Shah's wife as infructuous after Solicitor General Tushar Mehta, appearing for the union territory, said the PSA has been permanently revoked.

Shah figured during the US Congress hearing on human rights in South Asia, focused on India's action in Kashmir last November, when Indian-American Democratic lawmaker from Washington's 7th Congressional district Pramila Jayapal raised the matter of his detention. "One of the individuals detained without charges is Dr Mubeen Shah, who is the uncle of my constituents in Seattle...this is former CEO of chamber of commerce. His urologist who is affiliated with Registrar General of Hospital has called for his immediate release because of serious medical issues."

Assuring Jayapal, the US Assistant Secretary of State for South and Central Asian Affairs Alice G Wells had replied that America had taken up the issue of Shah with the Indian government.

"Yes, we explicitly raised the case of Dr Shah and shared your concern about the grounds for detention particularly given the health condition. We have received a response that he is receiving medication,"

Process To Exhume, Hand...

Mohammad Ibrar, a resident of Tarkassi village of Rajouri, left their homes to work as labourers in Kashmir's Shopian and went out of contact with their families after July 17 late evening.

A day later, the Army claimed three militants were killed in Amshipura village in the higher reaches of south Kashmir's Shopian. It initiated an inquiry after social media reports indicated that the three

men were from Rajouri and had gone missing in Amshipura. The Army completed a probe on September 18 and said it has found "prima facie" evidence that its troops "exceeded" powers under the Armed Forces Special Powers Act during the encounter and has initiated disciplinary proceedings.

The police also launched its investigations and collected the DNA samples of the families to match with those killed.

Last week, the police said the samples have matched with the families from Rajouri and further investigation in the case was going on

The media bodies further said that Kashmir journalists across the groupings and the status they hold in their respective organisations have, once again, felt pained over the unwarranted propaganda, aimed at bringing a bad name to individuals and institutions for no apparent reasons or justification.

"This propaganda is being deliberately peddled to gossip-hungry social media so that reputations of the professionals are sacrificed for the political ends of the virtual rumour mongers. This propaganda, however, adds to the vulnerability of the media," the statement said. The media in Kashmir, it said has always grown stronger by the assaults from here and there. The vilification may massage the ego of the people behind these shameful acts but it eventually hurts Kash-

In July-August 2017, Bhat visited Pakistan on valid travel documents and was imparted training on using weapons and secret social media chat platforms, the official of the premier investigation agency said. After returning from Pakistan, he was in constant touch with LeT handlers in Pakistan and with active militants of Kulgam on secret messaging platforms to carry out subversive and militant activities in the Valley, the NIA spokesperson said.

Bhat was working as a sleeper cell of the LeT and intended to join the banned militant organisation, the official said.

From 2016-2018, many Kashmiri youths were sent by separatist leaders to Pakistan, he added.

They were trained in the camps for five to 15 days. After returning, they were initially used as sleeper cells by militant organisations and subsequently recruited for active militancy, the official said.

The division bench directed the Chief Secretary to take immediate steps for appointing professional and qualified person(s)/ agency(ies) for technically and scientifically evaluating, in strict time frames, the issues of fixation of the reserved prices of minerals in the J&K; the terms and conditions on which auctions and tenders for grant of all mineral concessions are conducted and recommendations of the experts so appointed be implemented in public interest.

"The Chief Secretary shall, if not already done, appoint a Committee of Experts on the lines of directions given by the Supreme Court in National Green Tribunal Bar Association v. Virendra Singh (State of Gujarat), as well in Mushtakeen v. MOEFF & CC, to assess the components and scales of compensation and recommend measures of reparation for acts and omissions of the appellants which have resulted in environmental degradation."

The court also directed the Chief Secretary to appoint a nodal officer and committee of officers to compute the scale of compensation as recommended by the Committee with a time bound mandate to issue notices to show cause to the appellants with regard to payment of compensation, if any, consideration of the responses, making appropriate determination of liability and effecting recoveries thereof. The court set aside the conclusion of the Single Judge in its judgment that the appellants had a remedy in common law to seek compensa-

It also set aside the liberty granted by the Single Judge to the appellants to claim refund of their bid amount(s), if any, lying with the Department of Industries and Commerce or to sue the latter in appropriate proceedings for any loss or damage, if any, suffered by them.

had actually two scripts in use, we would have accepted the existing situation and recommended the compulsory teaching of both scripts in the state. The introduction of the controversy of the second script will be a distinct disservice to the cause of national solidarity."

Knowing that Persian had been the official language in the state for centuries and both Muslims and Hindus were well versed with it. N. Gopalaswamy Ayangar, the then Prime Minister of J&K, ordered at the behest of the Maharaja, the introduction of two scripts-Devanagari and vogue Persian script.

It gave rise to a long controversy that also led to a crisis in National Conference where the opinion was split along religious lines, Bashir told Kashmir Observer.

The communal forces had failed to get their way and introduce Devanagari which is a way to make Hindi the main language of J&K and impose it on the 70 per cent Muslim majority so that their culture, tradition, literature is destroyed, the scholar added.

"To preserve our culture, our language, our way of life, our own stories and respond to this cultural onslaught effectively, we will have to document all such assaults in the past so that we can resist the current onslaught on us," he said. A Larger Plan

Changing Kashmiri script is a part of larger plan to boost the radical Hindu chauvinistic political narrative, said Mir Tariq Rasool, former Secretary J&K Adbe Markaz Kamraz (AMK) and Patron Kashmir Literary and philosophical foundation.

According to him, the changing script would not only add to the destruction of India's secular fabric but also outdate and make all the literary treasure irrelevant for the future generations.

"Besides it will damage the etymological fabric of Kashmiri langue because a huge chunk of words cannot be fitted in the Devanagari script," Rasool told Kashmir Observer.

The move of changing script of Kashmiri language is nothing but an effort to kill the basic living Kashmiri literary and linguistic thought,

Against Kashmiri Sentiments

People in Delhi should read between the lines, said Dr. Rafiq Masoodi, former additional director general Doordarshan, adding that people guiding the Centre do not know the ground reality of Kashmir.

"The AIKS is asking for Devanagari as an additional script but it is already there," Dr Masoodi told Kashmir Observer.

"They want Devanagari to be constitutionally added and it would somewhere or the other touch the sensitivity of Kashmiri people." There is an apprehension amongst people that the demand for the additional script would ultimately replace Nastaliq with Devanagari,

All religious books are in Nastaliq and the conversion of these books would hurt the sentiments of Kashmiris, he added.

"When the Kashmiri language was born it was read in Sharda script and even the AIKS know Sharda script but they demand Devanagari, not Sharda," he said.

Masoodi has been the secretary of culture for four years and during his tenure, he released many books in Devanagari script but the books didn't find any reader, "so ultimately, they had to shift to Nastaliq,"

'Saffronisation' of the Script

The use of Devanagari is tantamount to a kind of "saffronisation of the script", said Rao Farman Ali, a Kashmiri based author.

"This demand would create a rift between the Hindus and Muslims in the Kashmir region," Ali said. "It is a surprise that AIKS is asking for Devanagari script and not Sharda script."

Aga Hasan Leads Prayers...

CAG's scathing remarks on functioning of JKMSCL

Srinagar: The Comptroller and Auditor General of India has made scathing remarks on the functioning of the Jammu & Kashmir Medical Supplies Corporation, saying the purpose of setting up it has been defeated.

"There were delays in finalisation of rate contracts and consequent delay/ nonprocurement of medicines/drugs, instruments, machinery, equipment; thereby defeating the purpose of creation of the Company," reads the CAG report on functioning of Public Sector Undertakings in Jammu and Kashmir.

In May 2013, J&K cabinet cleared a proposal for setting up Jammu and Kashmir Medical Supplies Corporation Limited (Company) for procurement of medicines and equipment for government hospitals in the State.

It was incorporated on 5th March 2014

under the Companies Act, 1956 and functions under the administrative control of the Health and Medical Education (HME)

The CAG report reveals that 59 percent procurement of drugs, machinery, equipment and were done by heads of department in Health and Medical Education and only 41 purchases were made by the Corporation.

"Out of total expenditure of Rs 573.63 crore incurred by the 113 Heads of Department in HME Department for procurement of drugs/medicines, machinery/ equipment, furniture etc. during 2014-15 to 2017-18, only Rs 236.07 crore (41 per cent) were transferred to the Company and procurements worth Rs 337.56 crore (59 per cent) were made by these HoDs themselves, which indicated that the objective of relieving the service providers

of the extra burden of purchase/ distribution was not served," reads the report.

The PSU was set to relieve the service providers (head of the departments/Doctors) of the additional burden of procurement and distribution process

The audit also observed that there had been delay in finalisation of Annual Rate Contract (ARC) leading to delay in procurement of drugs/ medicines/machinery/ equipments.

"In first phase, the Company invited tender for the procurement of drugs/ medicines/ fluids comprising 870 items (increased to 9404) in June 2015, January 2016 and July 2016, out of which the Company finalised ARCs for only 592 items (63 per cent) in three instances during November 2015 and June 2017 by taking time ranging between 87 days and 320 days after issue of NIT (Notice Inviting Tender). Similarly, out of 723 items advertised (February 2017) in second phase, the ARCs for only 362 items were finalised during November 2017 and March 2018 by taking time ranging between 273 days and 403 days. Delay and non-finalisation of ARCs in respect of 348 drugs and medicines in first phase and 361 drugs and medicines in second phase implied that these items could not be procured by the Company for the indenting Department, thereby defeating the purpose of creation

The audit reveals that JKMSCL had not prescribed anytime-line for finalisation of technical/ financial evaluation, meeting of the State Level Purchase Committee (SLPC) and issuance of ARC in its Standard Procurement Procedures (SPP)—(KNO)

SRINAGAR- Even as army promised an Inquiry into the raid on Beeru police station and Central Reserve Police Force (CRPF) battalion headquarters a fortnight ago a case has been registered against the commanding officer, of 34 Rashtriva Rifles Col TJ Shashidharan in this connection. official sources said today. Station House Officer (SHO) of Beerwah police station registered the case on September 25 for unauthorised entry by the army personnel into the police station after higher authorities gave a green signal to do so, they said. Following strong protests by the police over unbecoming behaviour of the Rashtriya Rifles troops, the army promised an inquiry into the conduct of its officers involved in the raids on the intervening night of September 18/19/. Personnel of Rashtriya Rifles conducted raids on the Beerwah police station and the battalion headquarters of the CRPF in connection with September 12 attack by a two-mem ber Fidayeen of Lashkar-e-Taiba and Jamiat-ul-Mujahideen on a Rashtriya Rifles camp in Beeru in which 15 armymen including a major were killed The army suspected involvement of policemen in harbouring

militants. It also conducted an identification parade of policemen and raided the residential quarter inside the police station premises. The police, sources said, believe that raids were an attempt by the RR to cover up its failures in preventing the attack as it had specific intel¬ligence suggesting an attack by militants. .But, the army personnel took the report lightly, the

They found nothing, because the whole search opera-tion was a ploy to cover up their own failure and shift blame on others, they claimed.

or a place that rarely drinks coffee, rather prefers its noon chai sitting on the ground; a coffee table book is somewhat of an oddity. Be that how it is, recently someone in the administration floated an idea that each department of the valley must conceive and compile a coffee table book highlighting their achievements, especially since the abrogation of article 370. These were released by the Lt Governor recently at a well-covered function, even as the process of compiling them has been stopped in early September by official order. What the motives and rationale of the books were, I leave to your imagination and the administration to decide.

However, to my ill-informed mind, it appears to be largely a self-congratulatory move. But vanity is the bane of almost every human being. Government bashing may be the order of the day, but surely blaming them for a bit of vanity is carrying your bias a little too far, or is it? Either way, I have no bone to pick with the vanity, or the self-congratulatory air of the gesture, what I have a bone to pick with is the politics of such a book.

The compilation of the book is not just another attempt by the government to legitimize itself to convince a cynical population. Such gestures are passé. and merit no special attention. However, the coffee table book is different because its politics are well thought out and tie up with the larger project of commemorating and translating routines for consumption of an audience, which is as yet unconverted to either the popular ideology or the narrative of the government. However, this needs to be discussed in detail, or else one runs the risk of being accused of making mountains out of molehills.

First, why a coffee book? Why not a proper report or a white paper detailing the achievements? Or hy not a proper book in the first place. The answer lies in the form of a coffee table book, which allows information to be consumed at a single glance without paying attention to detail, where the devil lies. A coffee book relies majorly on images and photos, which exploit the human tendency to privilege sight over other senses. After all what is seen is what is believed, and vice versa! The photograph particularly is crucial in this context as by its permanence it freezes the reality, and erases the contexts in which the reality it captures was constructed or realized. By focusing on the immediate and visual, the photograph erases the constraints and contexts of time and space, and therefore allows for a glossing over of reality to suit narratives. Susan Sontag writes therefore "In teaching us a new visual code, photographs

alter and enlarge our notions of what is worth looking at and what we have a right to observe. They are a grammar and, even more importantly, an ethics of seeing. Finally, the most grandiose result of the photographic enterprise is to give us the sense that we can hold the whole world in our heads — as an anthology of images.

The coffee table books released exploit this very tendency and introduce a grammar of progress and development conveniently erasing the contexts of censorship and repression within which such progress is articulated. Rather, the immense materiality and factity of the development in terms of tangible figures, statistics and images is foregrounded in both image and prose to obliterate the more abstract narratives of happiness, justice and liberty that ought to underpin real development.

Moreover, the prose in which the photographs are translated, builds on this edifice of evasion and erosion. One, the prose is deprived of any claim or trace of authorship since it is written in the most generic manner as possible, and merely highlights the factity of the photographs. If it diverges from the factity to explore the emotive, it usually does so by praising the material and tangible benefits that will be accrued from the 'development'. By doing so, it commemorates the benevolence of the state, and establishes its legitimacy as being engaged in the welfare of people, when the reality on ground testifies otherwise. In other words, it creates a fiction of progress and benevolence that invites the reader to recognize the beneficence of subjugation.

The question that arises then is how must such fiction be contested? Apart from poetry and slogans, what other media are present that can translate local routes and roots of dissent and translate them into a form that can be disseminated to convert and motivate a people to the parrative of the oppressed

Fiction offers a useful medium for such activism, for diamond cuts diamond. To the fiction of state, we offer our own fiction. The question, however, is not to define the role of fiction in enacting resistance. As I have previously written, writing offers the subjugated to conceive of and produce alternative papers to the paper trail of subjugation. The question is: what form should fiction take or what idiom may it adopt to achieve maximum effect?

Normally, one would steer clear of such prescriptive questions, and suggest that a writer is free to adopt any style which suits her. However, as in everything, the question of art in a situation of turmoil is a particularly vexed one; for the writer is tasked with the responsibility of voicing the aesthetic of the

collective, and find space for collective memory in writing. Besides, the writer is implicated in the same collective memory, and therefore is bound to draw from it in writing.

It is no surprise then that like poetry, fiction too has greatly revolved around the turmoil and trauma of Kashmir, besides being realistic in tenor. This has attracted the charge of a 'pornography of reality' against contemporary fiction, which has been accused of peddling "slave narratives" apologetically as 'resistance literature'. The Palestinian critic Hanan Mikhail Ashrawi offered a succinct summary of this pejorative attitude with respect to Palestinian fiction, and an observation, which holds true to Kashmir too: "There is a tendency to suggest that the literature is 'Palestinian' and unfortunately this national definition has become the rationalization for the lack of any objective study or criticism of the literature which is in itself a source of national pride, a symbol as well as means of resistance." Is the fact that a work is produced by a Kashmiri or is about Kashmir enough to insulate it from criticism? A corollary to this question is: Must a work be necessarily dismissed on account of not being 'fictional' or 'lyrical' enough. This is a debate that offers no easy answers but rather must be deliberated in detail.

The purveyors of realistic fiction will point to the nature of resistance literature as produced within harsh realities, and immediate contexts of subjugation, oppression and trauma. Such literature defies the expectations of being instruments of entertainment, rather focuses on intervening in the cultural appropriation by the state and allied structures.

Literature offers a site of contestation over power to shape and articulate narratives that determine the collective memory and possibilities of expressing that memory. Fiction that is representative of the diverse contemporary realities may not permit a fictionality which can be best described only in negation of realism. The immediacy and plainness of the literature could be read as rebelling against cultural imperialism, which permits neither the luxury nor resources (servile academia, dreary and outdated curriculum and complete absence of any spaces and liberty for peer interactions owing to prohibitions on movement and internet, to quote an example) to produce enough quality' literature.

Human Rights Halted?

Amnesty International shut its work in India citing government attacks. The event is emblematic of the state of human rights in India at the moment

n Tuesday, Amnesty International, one of the most respected human rights nonprofits in the world, announced that it was halting its operations in India after the government of Prime Minister Narendra Modi froze the organization's bank accounts. The closing is another shameful blow to civil society, human rights and free speech in India.

"The continuing crackdown on Amnesty International India over the last two years and the complete freezing of bank accounts is not accidental," said Avinash Kumar, the executive director of Amnesty International India. "The constant harassment by government agencies, including the Enforcement Directorate, is a result of our unequivocal calls for transparency in the government, more recently for accountability of the Delhi police and the government of India regarding the grave human rights vio-

lations in Delhi riots and Jammu and Kashmir." The fact-finding work of Amnesty International has long been an eyesore for the Modi administration. The organization has produced detailed reports holding the government culpable for serious human rights abuses. In October of last year, Amnesty International testified before the U.S. Congress on

the "ongoing arbitrary detentions, use of excessive force/torture and silencing of dissenting voices" in Kashmir and the attacks and threats the organization had received.

Six months after the anti-Muslim violence that rocked New Delhi in February, Amnesty released a

scathing report alleging that Delhi police officials indulged in violence and aided and abetted rioters. The violence claimed the lives of at least 53 people and injured more than 500. The report also accused the Delhi police of dismantling protest sites used by peaceful protesters and arresting innocent bystanders.

The backdrop of this action against Amnesty International is of course the government's inept handling of the covid-19 crisis. With more than 6 million cases and almost 100,000 deaths, India is battling the second-largest coronavirus outbreak in the world.

A scholar from Jawaharlal Nehru University who was hailed for his speeches against India's discriminatory citizenship law is now facing charges under a sedition law and has been jailed. The evidence against Sharjeel Imam includes books by the acclaimed political scientist Paul Brass, which alleg-

edly radicalized him. Safoora Zargar, a 27-year-old Kashmiri student activist who is pregnant, is also in jail for speaking against the Citizenship Amendment Bill. Hundreds more like Safoora and Sharjeel, who led peaceful protests, have been jailed while the perpetrators and instigators of the February anti-Muslim violence, including ministers from the Modi regime, remain free.

Many of us who have been sounding the alarm about the erosion of India's democracy saw the attack against Amnesty International coming. It seems like it's part of a strategy by government to set highprofile examples.

The same day as Amnesty shut its India operation, a 19-year-old lower-caste woman who was gangraped by upper-caste men in the Bharatiya Janata Party-ruled state of Uttar Pradesh succumbed to her injuries. The remains of the woman, Manisha Valmiki, were cremated by the police against the wishes of her family, who wanted the world to see the horrific brutality India had unleashed against her.

This attack and the harassment against Amnesty International should not be seen in isolation. The Indian government will continue to ignore or mock organizations and institutions that warn about our decline into a majoritarian abyss.

Why Fear Feminism?

Taking lessons from all the historical and topical lapses at the hands of men, the best we (men) can do is to acknowledge how our gender has exploited and oppressed women and to stand by them in their quest of reclaiming their rightful rights of a dignified life with freedom, liberty and no constraints.

with our community, we observe hundreds of posts appropriating women, demanding from them to abide by a male structured societal system, write what men there approve and say what they find appropriate.

Ironically, by this sense of entitlement, men are proving a classic argument of men being oppressors of women. This exhibition of dominance and entitlement is nothing but a deplorable display of male chauvinism, reactionary patriarchy, and male social conditioning. By practicing it, we are contradicting our own claims of fairness towards women and proving that nothing has changed with time and we still continue to oppress women in overt and covert ways.

One word which we very often see thrown around is feminism and those who support it or write about it are trolled and are often questioned on flimsy grounds. Without even having any concrete knowledge of feminism, it's vilified through reactionary arguments which end up in negative labelling of women and consequent shaming of them. No regard is paid to the history of feminist movements and this ignorance ends up in a total disregard of the struggles of great women philosophers and feminist activists like Kate Millet, Simmone de Beauvoir or Virginia Woolf.

Yet another word used callously is, "radical feminism" which is actually an adjective meaning going to the fundamentals or foundations. Radical feminists locate the root cause of women's oppression in patriarchal gender relations, as opposed to legal systems or liberal feminism or class conflict or Marxist feminism. In all its shades, even if we take radical feminism into account, it nowhere has any overt overtones of an ideological fanaticism in it. This school of thought asserts that women are viewed as "the others" to the male norm and as such have been marginalized and oppressed systematically.

In the Western world, freedom is generally perceived in terms of the ability to satisfy personal desires and impulses for self-expression, in absence of any impediments or obstructions or retraining factors of authoritarianism. Emphasis is laid on external factors of freedom as they relate to the outer aspects of life—freedom of expression, autonomy, self-determination, self-dependence, self-regulation, democracy etcetera.

The concept of freedom is usually considered in terms of 'free will'. It is taken as freedom of 'choice' that is 'political freedom' or 'social freedom' or 'social liberty' in accordance with biological theory and the evolutionary process. Human growth and development results in the person's autonomy and independence of the environment which defines full individuality and true freedom of maturity or self-actualisation. This is a self-initiated development of personal integrity and mature growth.

On the other end, in the eastern world, freedom is perceived in terms of ability to act according to those convictions which are a proponent of internal harmony or freedom of conscience. Emphasis is laid on the



inner fundamentals of freedom as they lay foundations of the inner aspects of life or "inner peace".

These two conceptions of freedom point out a very important thing regarding the relationship of an oppressed seeking freedom and that of the oppressor seeking control — externally or internally, by conditioning or by controlling an individual's thought process and thinking.

Now, human values develop and flourish with the environment provided to humans. In this schema, the oppressed will learn resistance while the oppressor will continue to maintain their control through various tactics including the use of institutions which are revered and unquestionable, and through a clever and efficient use of moral high ground which has a razor sharp impact on a reactionary society.

In case of gender, this relationship of an oppressor and that of an oppressed is quite clear. For instance, The French Revolution, a revolution which is often referred to as the movement which gave the modern world the ideals of liberty, justice, fraternity and equality, did not grant women any political rights and they were again rendered as passive citizens; a citizenry which had no say in the functioning or election of the government.

The desperation and frustration which men reflect is understandable and it only takes us back to the conservative times when women rights movements had started gaining impetus and men came out and opposed them from reclaiming their rights.

Today in this modern age, we can see the same pattern. The patriarchal policing present not only in our homes but even outside its four wallscompels women to submit to a male designed social structure. God, Plagues And Pestilence – What History Can Teach Us About Living Through A Pandemic

ost of us are living through a year that is unprecedented in our lifetimes. Too young to remember the Spanish flu, we've grown up in a world where we take Western wonder drugs and life-saving vaccines for granted. We have no memory of a time when disease brought the world to a standstill or shut down entire economies. We could not have predicted life in Melbourne in 2020 would include a 5-kilometre travel limit or a curfew.

A longer view of history reminds us we are not the first community to experience and reflect on life during a time of plague or pandemic. So what might we learn from history as we continue to navigate life during a pandemic?

We want to blame someone

Given the ubiquity of religion in most human communities throughout history, it is not surprising reflections on pandemics often begin with God. Plagues and diseases on such a scale feel "biblical" in the sense they are beyond the norm and therefore supernatural in some way. While modern science gives us insight into COVID-19, we still look for someone, anyone, to blame for its presence.

In antiquity, that someone was often God.
One of the earliest records of plagues comes from the Hebrew Bible. Anyone who has celebrated Passover, read the biblical book of Exodus, or seen the animated Dreamworks movie Prince of Egypt will be familiar with the plagues that Moses (or God) unleashed on Egypt when Pharaoh would not free the enslaved Hebrews.

Not all of the plagues were disease, but they all brought destruction and potential death. In that ancient narrative, a plague served two functions: it is divine punishment for injustice, and an assertion of religious power in the battle between Egypt's gods and the god of the Hebrews. In the Hebrew Bible texts, Pharaoh's refusal to release the slaves is to

blame. It is his fault.

ally to teach some moral lesson – we tend to focus our wrath on human scapegoats. In the 1980s, the HIV-AIDS viral pandemic was blamed on the gay community or Haitians, revealing the racism and homophobia behind such views.

US President Donald Trump's constant reference to COVID-19 as the "China virus" reflects a similar desire for a scapegoat. In its worst form, the blame game leads to widespread retribution against anyone identified with that group.

Role of government is key to protecting the com-

munity

Another link with the past is the role of government in containing disease. Governments have for centuries used quarantine as a way to preserve public health, often with great success.

Yet resistance to forced quarantine has an equally long history, with reports of those in isolation being "unruly" and needing to be contained during the Great Plague in 17th-century England. During this period, quarantine procedures made a marked difference to the mortality rate when comparing cities.

Balancing individual freedom with the health of whole communities is a tricky business. Karen Jillings's work on the social history of the plague in 17thcentury Scotland shows that, while physicians, magistrates and preachers all regarded the plague as supernatural (either directly from God or by God working through nature), the responses of those of faith differed.

Jillings describes the arrest of a Scottish preacher in 1603 for refusing to comply with the government's health measures because he thought they were of no

use as it was all up to God. The preacher was imprisoned because he was viewed as dangerous: his individual freedoms and beliefs were deemed less important than the safety of the community as a whole.

Being religious does not mean being anti-science Being a person of faith, however, does

not necessarily make one anti-science.

COVID sceptics take a wide variety of forms in contemporary culture, including anti-religious conspiracy theorists. Yet anti-science views are often associated with people of faith thanks, in part, to some now tragic examples from North

One example of a cleric who did not pit faith against reason was Martin Luther, the 16th-century theologian and reformer. Luther wrote about living through the plague in a pamphlet titled Whether One May Flee from a Deadly Plague.

Oxford University professor Lyndal Roper writes that while many fled Wittenberg in 1527 when the plague struck, Luther stayed out of a sense of duty to help nurse and care for the dying. This is what he thought all leaders should do.

His staying was not the decision of a martyr, nor was it born of a naïve idea that God would necessarily save or protect him. Luther, writes Roper, "advocates social distancing", the use of hospitals, and necessary precautions according to the science of his time. While he believed that God was ultimately in control, he also affirmed human responsibility. Luther harshly condemned those who went about knowing they were sick and spreading the disease.

A historical perspective does not make living through a pandemic easy. But perhaps there is a small comfort in realising we are not the first community to live through such times, and neither will we be the last.

The things we find hard to balance – individual freedoms versus the group, accountability versus blame, science versus personal beliefs – are centuries old and deeply human.

And, like others in centuries past, we too are capable of incredible acts of care and sacrifice for the sake of the sick and vulnerable.

from it," Sude said. The researchers measured the participants' views on the four topics again after they read the websites to see if their attitudes had changed at all. Results showed that when participants were not able to vote, time spent reading articles that agreed with their original views strengthened these views. The more time they spent reading,

the stronger their views became. When participants were able to vote, their voting behavior was as influential as their reading time. Even if they stopped reading and upvoted an article, their attitudes still became stronger. "It is important that people's views still became stronger by just having the opportunity to vote,"

Knobloch-Westerwick said. "When they had the opportunity to vote on the articles, their attitudes were getting more extreme with limited or no input from the articles themselves. They were in an echo chamber news. "Don't just click the like button. Read the article and leave thoughtful comments that are more than just a positive or negative rating," he said.

Canadian Study Reveals Girls **Benefit From Doing Sports**

irls, but not boys, who participate actively in school sports activities in middle childhood show improved behaviour and attentiveness in early adolescence, suggests a new Canadian study.

The results of the study were published in the journal Preventative Medicine.

"Girls who do regular extracurricular sports between ages 6 and 10 show fewer symptoms of attention-deficit/hyperactivity disorder (ADHD) at age 12, compared to girls who seldom do," said Linda Pagani, a professor at Universite de Montreal's School of Psychoeducation.

Armenia withdraws ambassador to Israel over Azerbaijan arms sales

Baku: Armenia has recalled its ambassador to Israel over the country's arms sales to Azerbaijan, as the two Caucasus countries continue to clash over the disputed Nagorno-Karabakh region.

Protesting against the Israeli weapons exports on Thursday, Anna Naghdalyan, Armenia's foreign ministry spokeswoman, said: "Israel's workstyle is unacceptable. The ministry has to call back its ambassador in Israel.'

Israel's foreign ministry said Armenia's decision to withdraw its ambassador was regrettable.

"Israel attaches importance to our relations with Armenia and sees the Armenian Embassy in Israel as an important tool for promoting those relations for the benefit of both peoples," the foreign ministry said in a statement.

Dozens of people are reported to have been killed and hundreds wounded since fighting renewed in the disputed Caucasus region on Sunday.

Nagorno-Karabakh is internationally recognised as part of Azerbaijan, but is majority ethnic Armenian.

In 1991, the region broke away to form the Artsakh Republic, which led to violent clashes that have left tens of thousands of people dead since

Israel and Azerbaijan have long been close allies in the region, while Armenia has enjoyed close relations with Israel's main rival Iran.

Israeli-made drones

The Stockholm International Peace Research Institute (SIPRI) - a leading conflict and armaments think-tank - has reported that Israel provided Azerbaijan with around \$825m in weapons between 2006 and 2019.

On Wednesday, Azeri presidential aide Hikmat Hajiyev also told Israel media that Azerbaijan was using "some' Israeli-made drones in fighting around Nagorno-Karabakh.

"[We] have one of the strongest [drone] fleets in the region. And among them we have Israeli ones, we have other drones as well, but Israeli drones especially, including reconnaissance and attack drones, and kamikaze 'Harop' drones, [which] have proved itself very effective," Hajiyev told the Walla news website in a video interview

Armenia had only inaugurated its embassy in Tel Aviv on 17 September following delays caused by the coronavirus pandemic.

'US didn't inform Pakistan about Bin Laden raid due to lack of trust'

Washington: The US did not inform Pakistan about Osama bin Laden's location due to lack of trust and past experiences of terrorists being tipped off after information was shared with Islamabad. former American defence secretary and ex-CIA chief Leon Panetta has said.

Panetta, in an interview to WION TV, also said he finds it "difficult to believe" that there wasn't somebody in Pakistan who was aware of Osama bin Laden's Abbottabad compound.

Osama bin Laden, the world's most-wanted terrorist and the then al-Qaeda chief. was killed in a covert raid by a US Navy SEAL team at his Abbottabad compound in Pakistan on May 2, 2011.

"When we discovered the lotion of this compound in Pakistan, it was located in a place called Abbottabad. Abbottabad is a centre for their intelligence services and the Pakistani West Point is located there as well," Panetta said. The US military academy is located in West Point in New York.

This compound was three times the size of other compounds, it had 18-foot walls on one side and 12-foot walls on the other side with barbed wire around it, said Panetta, who was the Central Intelligence Agency (CIA) director when the raid was carried out.



I find it very difficult to believe that there wasn't somebody in Pakistan who was aware of this compound," he said.

Once the US found the compound, it had to make a decision whether it would share that information with Pakistan and President Barack Obama made the decision on the basis that when information was shared with Pakistan about the location of terrorists, they were tipped off and sud denly were able to disappear, Panetta said.

"Because of that concern and that lack of trust, very frankly, we decided not to inform the Pakistanis about the location of bin Laden and we did not inform them about the operation that we conducted because we were concerned that if we did that it was likely bin Laden would be advised to

move," he said. "So, because of what we did I think we were able to be successful in the mission to go after bin Laden," Panetta said.

the support provided by some of our country's greatest medical professionals and institutions.' Conley said.

Rest assured I expect the President to continue carrying out his duties without disruption while recovering, and I will keep you updated on any future developments, the physician added.

Trump's positive report comes just hours after his senior aide Hope Hicks was tested COVID-19 positive.

"Hope Hicks, who has been working so hard without even taking a small break, has just tested positive for COVID-19. Terrible! The first lady and I are waiting for our test results. In the meantime, we will begin our quarantine process!," Trump earlier said in tweet.

Hicks, 31, is the closest aid of the president to have tested positive with coronavirus. She had travelled with the president on Air Force One early this

Trump, in an interview to Fox News, on Thursday night said he and the first lady spend a lot of time with her.

In the middle of the election campaign, Trump has been travelling a lot in particular in the battleground States. The development is likely to bring to standstill his hectic campaign for the November 3 presidential election.

In a statement, Judd Deere, the Deputy White House Press Secretary said that the President takes the health and safety of himself and everyone who works in support of him and the American people very seriously.

Mossad chief holds talks with Bahrain as ties with Israel deepen

Jerusalem: Israel's top spy chief Yossi Cohen has held talks with Bahrain's intelligence services following the two countries recent normalisation of relations, Bahraini state media reported on Thursday.

The Bahrain News Agency (BNA) said that Cohen, director of Mossad, Israel's national intelligence agency, had visited Bahrain on Wednesday to discuss "topics of mutual interest" and "cooperation between the two countries'

"They stressed the importance... of the role the [normalisation deal] will play in significantly contributing to promoting stability and peace in the region," BNA said.

Bahrain's normalisation deal was signed in Washington last month at the same time as an Israel-UAE normalisation agreement.

Israeli Prime Minister Benjamin Netanyahu travelled to the US capital for the ceremony, along with the foreign affairs chiefs of the two Gulf

Bahrain and the UAE became the third and fourth Arab countries to normalise ties with Israel, following Jordan in 1994 and Egypt in 1979.

'Great divergence'

Bahrainis however reacted with anger at the government's move and quickly turned the hashtag "Bahrainis against normalisation" into the most popular topic on social media.

Both religious and political figures in the kingdom also released statements rejecting the deal.

"There is a great divergence between the rulers and the ruled in thought, mind, aims and interests. Governments are experiencing a psychological defeat and want to impose it on the people, and the people have to resist this defeat," said Ayatollah Sheikh Isa Qassim, who lives in Iran.

Qassim is the spiritual leader of Al-Wefaq, Bahrain's biggest opposition society.

As the leading cleric for the country's Shia majority, he has previously criticised their treatment by the minority Sunni royal family.

The Palestinians have condemned the US-brokered Gulf deals with Israel as "a stab in the back" for their aspirations to establish an independent state of their own.

They argue it violates a longstanding pan-Arab position that Israel could normalise relations only in return for land

Macron says Islam 'in crisis', prompting backlash from Muslims

resident Emmanuel Macron has unveiled a plan to defend France's secular values against what he termed as "Islamist radicalism", saying the religion was "in crisis" all over the world, prompting a backlash from Muslim activists.

In a long-awaited address on Friday, Macron insisted "no concessions" would be made in a new drive to push religion out of education and the public sector in France.

"Islam is a religion that is in crisis all over the world today, we are not just seeing this in our country," he said.

He announced that the government would present a bill in December to strengthen a 1905 law that officially separated church and state in France

The measures, Macron said, were aimed at addressing a problem of growing "radicalisation" in France and improving "our ability to live together'

'Secularism is the cement of a united France," he insisted, but added that there was no sense in



stigmatising all Muslim believers.

The law permits people to belong to any faith of their choosing, Macron said, but outward displays of religious affiliation would be banned in schools and the public

Wearing the hijab is already banned in French schools and for public servants at their workplace. Macron's speech led to a debate on social media

Yasser Louati, a French Muslim activist, tweeted: "The repression of Muslims has been a threat, now it is a promise. In a one hour speech #Macron burried #laicite. emboldened the far right, anti-Muslim leftists and threatened the lives of Muslim students by calling

for drastic limits on home schooling despite a global pandemic."

Rim-Sarah Alaoune, a French academic, tweeted: "President Macron described Islam as 'a religion that is in crisis all over the world today'. I don't even know what to say. This remark is so dumb (sorry it is) that it does not need any further analysis ... I won't hide that I am concerned. No mention of white supremacy even though we are the country that exported the racist and white supremacist theory of the 'great replacement', used by the terrorist who committed the horrific massacre in #Christchurch.'

Iyad el-Baghdadi, Norwaybased writer and activist, simply wrote on Twitter; "F*** you, @EmmanuelMacron.

In his speech, Macron also claimed he is seeking to "liberate" Islam in France from foreign influences by improving oversight of mosque financing.
