# 3 Militants Killed In **Shopian Encounter**

**SRINAGAR: Three local militants** of Hizbul Mujahideen and Al-Badr were killed on Wednesday in a fierce overnight encounter with government forces in Zainapora area of south Kashmir's Shopian district.

Hizbul Mujahideen militant Sajad Ahmad Malla of Shopian and Al-Badr's Junaid Rashid Wani and Waseem Ahmad Magray, both residents of Pulwama were killed after army's 44 RR, special operations group (SOG) of police and the personnel of CRPF 178 battalion resumed anti-militancy operation in Sugan village of Shopian in the wee hours on Wednesday, a police spokesperson said.

The search operation, he said was launched around 7:00pm Tuesday by the state forces on the basis of specific input about the presence of militants in the village. During the operation, he said militants turned down surrender offer and instead fired on the joint

# **HC Imposes Rs 10000 Costs On Mission Director**

**SRINAGAR:** Observing that judicial time has been "unwarrantedly wasted", Jammu and Kashmir High Court has imposed Rs 10000 costs to Mission Director State Rural Livelihood who had filed an appeal against the court's single bench order way back in 2017.

The Mission Director had assailed the order dated 4 August 2017 whereby the court had allowed a plea by one Tariq Ahmad Bhat who had challenged an order dated 30 August 2016 issued by the Additional Mission Director SRLM Kashmir, terminating the cancellation of the hiring of an Innova vehicle alongwith Driver with effect from 25th of March 2016 in the State Rural Liveli-

hoods Mission Kashmir. This hiring had been sanctioned by order dated 31.03.2016 for one year strictly as per the approved rates of Transport Commissioner, Jammu & Kashmir subject to the terms and conditions incorporated in the order.

"The learned Single Judge noted that the engagement of hiring of the vehicle was for a period of one year which period has expired on 31st of March, 2017. As such, the order dated 31.08.2016 terminating the hiring of the vehicle had lost its efficacy," a division bench of Chief Justice Gita Mittal and Justice Puneet Gupta.

Promise To Make J&K A Hub Of Solar Power Remains A Hoax

n the last few years, Solar Energy Corporation of India (SECI) has proposed many mega solar power projects in few districts of the erstwhile state of Jammu and Kashmir (J&K), but the completion of these projects is far from reality. Concerns over the safety and viability of these projects in J&K are

raised from time to time. Experts suggest that such projects may help in boosting job opportunities and electricity production that ultimately will benefit the local population. While it is a challenging task for

engineers to set up power grids on tough terrains of the region but, many say, the innovative solutions may help in yielding promising results.

which has managed to install 20 MW Solar Roof Top (SRT) power.

Interestingly, the successive cen-

tral and state governments over the past few years promised to make I&K a hub of solar energy production but the study conducted by the Centre for Science and Environment has placed J&K at bottom of the list. J&K was placed even below Bihar

Notably, ever since Union Ministry of New and Renewable Energy lagging behind. launched the Jawaharlal Nehru So-



lar Mission in 2010, J&K has been released by Jammu Kashmir Ener-According to the official figures

gy Development Agency (JAKEDA), SRT panels of 8 MWs were installed in different parts of J&K. The primary reason for the lack

of growth in the solar sector in J&K is the shortage of resources.

According to the agreement between the centre and the states, J&K was bound to pay 40 percent of the total funds but a majority of the projects were scrapped, subjecting to J&K's inability to pay its share of funds.

As per an estimate, a 70 percent subsidy is provided by JAKEDA to any household installing SRT panels on rooftops of their homes.

It's believed that since the cost of electricity is very less in J&K, majority of households hesitate in

investing in solar panels.

The lack of cooperation from the various authorities concerned is equally proving to be a major stumble in developing solar power infrastructure in J&K. The red-tapism is also being blamed for not helping the cause.

In past, a 200 KW plant was installed by JAKEDA at Sher-E-Kashmir Institute of Medical Sciences, but no progress had been made on it so far.

The only department that has been utilising the benefits of renewable energy is the J&K Police department. A good number of SRT panels are installed on the rooftops of many police stations over the past few years.

"The order which was passed by the learned Single Judge was in accordance with law and warranted in the facts of the case. This Letters Patent Appeal which has been filed by the appellants of having 275 days delay is totally misconceived," the court said, adding, "In our view, judicial time has been unwarrantedly wasted by filing an appeal which is completely without merit."

While dismissing the appeal as well as application seeking condonation of delay, the court imposed Rs.10,000 costs upon the appellants (Mission Director) within two weeks in the Advocates Welfare Fund. Proof of deposit shall be placed before the Registrar Judicial.

....in case they fail to deposit the costs imposed on them within the aforesaid time period, in that eventuality, the Registrar Judicial shall place this matter before the Court for appropriate orders.

#### Panel For Fixing School Fees... and its violation or non-compliance shall amount to disobedience under the provisions of section 188 of Indian Penal Code," the order reads.

According to the order, the private schools shall not charge any fee from the students or guardians, except tuition fee, annual fee, transport fee and voluntary special purpose fee such as the picnic, tour and excursions, etc. completely voluntary in nature or any other fee as may be approved by the committee.

The law further states that the committee for the purposes of making any inquiry or initiating any proceedings under this Act, have the same powers as are vested in a Civil Court, under the Code of Civil

# Beerwah police, CRPF taste RR ire

RINAGAR- In an unprecedented operation, army carried out a cordon and search operation at a police station in the central Kashmir district of Budgam yesterday. Administra-tion and police authorities have taken a strong exception to the incident which left the police and central reserve police force | (CRPF) personnel shell shocked and gripped in fear.

Quoting police, agency reports said troops of 34 Rash¬triya Rifles (RR) led by Col T Shaahidharan laid seige to the police station at Beerwah at about 6 p.m. yesterday and called out all the policemen and the CRPF

personnel from its 197 battalion deployed in a portion there. Six persons lodged in the police lock up at the mo¬ment were also brought out. Accusing the police of harbouring militants in the police

station, the army officer told the officials a suspect had entered the premises shortly before. That was why the operation was started, he said. The surprised policemen produced one Ghulam Rasool before him saying he had come to report the theft at his Denying that he was the person who had entered the

prem-ises earlier, the army officer allegedly threatened the police¬men of torching the police station alongwith the personnel in the event of any untoward incident there. The entire premises including the police station and the family quarters were thor-oughly searched. The operation last one and a half hours.

On learning about the incident, the deputy commis¬sioner, Budgam, accompanied by the superintendent or police, visited the police station this morning, primarily to mollify the visibly agitated police officials. They assured them of investigation into the matter and 'appropriate ac-tion' against those responsible.

Reports said the RR action has generated fear not only among the police and security forces, but among the local people as poll Residents told AP the RR personnel had allegedly made their life miserable. Viewed in light of the action against the police and CRPP, they Said, one could easily guess what could be the extent of harassment they caused to the common people.

# **Getting Back To Work**

ourteen months after the revocation of Article 370 that granted J&K semi-autonomous status under India's constitution, Kashmir economy is in dire straits. According to an estimate by the Valley's business bodies, the local economy has suffered a loss of more than Rs 40,000 crore. In response, the administration has belatedly announced a revival package of just Rs 1350 crore that would hardly help ameliorate the lot of the wrecked economy.

It is true, the economy of whole of the country is in pretty bad shape. India's economic growth plunged dramatically by 22.8% in the April-June quarter of this year compared with the corresponding quarter of last year, This has crippled the economy rendering lakhs of people unemployed. And this is what just three months of lockdown has done to the country's economy.

Now imagine the situation in Kashmir which has been in a state of siege for the past fourteen months. To make matters worse, the administration in Kashmir was a bit more exuberant about enforcing lockdown. It was much more strict with it than was warranted. Its rationale was that the lockdown is critical to bring down the number of infections and flatten the curve. And its reasoning appeared plausible under the circumstances. But as the example around the world would have one believe, lockdown has only reduced the infections not controlled them. And there is little chance that an extended lockdown will eliminate the infection.

At the same time, lockdown crushed the Valley's economy, leaving thousands of people unemployed. It stopped the circulation of money and hit the marginalized sections very hard. The fallout of the lockdown has thus been far worse than that of the Covid-19 and on a much bigger scale. What was billed as a cure turned out to be worse than the disease

As things stand, we have moved past the stage where recourse to a lockdown is even an option. What the government can focus on instead is to strictly enforce the social distancing norms in public. And it can do so, considering the smaller population of Kashmir makes the infections more manageable than the densely populated states across India.

Kashmir economy is looking forward to a post Coronavirus period and hopes it remains peaceful. The region has been through a long period of disruption. We can only hope that the world is able to get a handle on this deadly virus and get back to a normal life. But meanwhile it is time for us to cautiously get back to work.

# Spirit of mutuality

he impasse in the GST Council on the issue of com-pensating states for the shortfall in their protected revenues remained unresolved at its 42nd meeting on Monday. The divisions between the Centre and the states seem to be drawn along political lines, with states ruled by the BJP and its allies opting for one of the options proposed by the Centre, while Opposition-ruled states continue to oppose the Centre's formulation. This is unfortunate. The GST Council has long been held up as an example of the spirit of cooperative federalism the NDA government professes commitment to. Yet the manner in which this issue has been dealt with suggests that the consensual decision-making process that has largely guided the Council's deliberations so far is being given the go-by.

The two options presented by the Centre place the burden of the shortfall in GST revenues squarely on the states. Opting for either of them absolves the Centre of any obligation of having to protect the states' revenues — in direct contravention of the grand bargain struck between the Centre and the states in order to shift to this new indirect tax architecture. Moreover, the complications arising out of the shortfall are unlikely to be limited to this year. It is likely that collections through the compensation cess will not be enough to bridge the shortfall next year as well. Thus, the Council will also have to deliberate on whether the same formulation will be adopted next year. This will also have a bearing on the extent to which the GST compensation cess is levied beyond the five-year period.

If by the next Council meeting, scheduled for October 12, an acceptable resolution is not found, it could well mean that the Council is headed for voting on the issue. Votes cast along political lines will only deepen the chasm between the Centre and states and make such negotiations in the future, needed in a federal polity, increasingly difficult. It is still not too late for the Centre to adopt a more conciliatory approach. The solution has to be both political and economic: In a federal polity, decision-making should be consensual in nature, rather than being driven by the force of brute majority, and at the same time, the Centre should assure states, who are at the forefront of fighting the COVID pandemic, of adequate resources.

# Israel-China Relations on an Upswing

China views Israel as an important link in its larger design to extend its hegemonic influence through its Belt and Road Initiative (BRI) to control trade from the Far East to Europe.

China and Israel have increased considerably in recent years. In addition, Israel has also been working hard to strengthen political and cultural interaction between the two nations.

In its 72 years of existence, Israel has been a nation with few friends except for the US. Thus, its diplomatic outreach with different countries have been considered one of Israel's greatest political triumphs.

This diplomatic outreach has befriended nations like India; which is now Israel's largest defence customer, Gulf nations like the UAE and Bahrain are the recent addition. But their most important ally that they've found is China.

#### China views Israel as a conduit for increasing regional influence

China views Israel as an important link in its larger design to extend its hegemonic influence through its Belt and Road Initiative (BRI) to control trade from the Far East to Europe. The BRI is a multibillion-dollar strategy to bring nations in Asia, the Middle East, and Africa under the Chinese influence through economic development by gaining leverage by gifting these nations with non-repayable debt. Beijing's goal is to use that leverage to manipulate other nations' foreign policy in its favor while gaining access to intelligence where there are military relations with the US.

The overtures between the two are not just confined to economic or defence relations but extends even to people-to-people or societal links, litical intimacy.

Avid China-watcher, James M. Dorsey, senior fellow at the S. Rajaratnam School of International Studies at Singapore's Nanyang Technological University, is of the view that China's international ventures are aimed at China dominating the Eastern Mediterranean with six ports in four countries: Israel, Greece, Lebanon, and Syria that would create an alternative to the Suez Canal. All that is missing are Turkish, Cypriot and Egyptian ports. Additionally, the Chinese military build-up threatens to complicate US and NATO's ability to manoeuvre in the region. The Trump administration has already warned Israel that Chinese involvement in Haifa could jeopardise continued use of the port by the US fifth fleet.

China covets improving relations with Israel due to its political interests. Israel is a top priority in China's Middle Eastern policy. China, which has established good relations with Arab countries and Iran for many years, has diversified its Middle Eastern policies by making Israel an important station of the Maritime Silk Road Project. This high level of interaction has brought cultural and academic partnerships. Israel has also increased its investments in China, which it rarely does

China's strategic interest is based on the fact that Israel is one of the world's foremost commercial, food and security technology powerhouses and it enjoys significant grassroots support in the United States.

The bilateral trade between the two has increased fourfold in the last ten years, and China has become Israel's third largest trade partner with \$14 billion bilateral trade per year.

#### US view of Sino-Israel relations

The US views these ties as a potential threat as it feels that this proximity will allow China to spy through Israel on US interests.

The importance America places on Israeli-Chinese ties was highlighted by a trip by US Secretary of State Mike Pompeo to Israel during the pandemic for the express purpose of directly sharing the administration's profound concern for Chinese entanglement in Israel's infrastructure, research and development across many cutting-edge fields, coupled with a warning to Israel that America might need to rethink its security relationship if Israel doesn't disengage from some of this activity.

include the Chinese operational control of the Haifa seaport by the Shanghai International Port Group for 25 years, where the US Mediterranean Sixth Fleet docks that some view as a direct threat to American security and intelligence gathering. America is worried that this port can become one of the stepping stones of China's new "Silk Road" (One Belt One Road, or Belt and Road) program linking over 60 nations.

The most recent Israeli-Chinese commercial transaction under the microscope is the possible deal with a Hong Kong-based Chinese controlled company to build the world's largest desalination plant (Sorek 2) at an Israeli kibbutz. Another bone of contention is China's Railway Tunnel Group that is close to finalizing a deal for Tel Aviv's light rail transportation system: this too may be seen to have major security implications. China's first infrastructure project in Israel was

the Carmel Tunnels, also an American concern. The American fear is that China could gain unprecedented intelligence with the help of intelligence operatives implanted within Chinese companies, undermining both Israeli and American security interests.

If there is one thing Israel cannot afford, it is a rupture in its bonds to the United States. That is no truer than at a time in which the United States is the only power supportive of Israeli annexation plans on the West Bank.

It's time for Israel to step back from the economically tempting involvements with China. Washington also needs Israel for its deep-water port in Haifa, its unrivalled intelligence, Israel's R&D that advance American weapons systems and cyber capabilities, and joint operations and training of US troops in Israel. It's not permissible for these activities to be spoiled by Chinese entrenchment into Israel's infrastructure.

America is also worried about joint research and Chinese investment with Israeli technology companies that use cyber security, AI (Artificial Intelligence), and satellite telecommunications that could be used by Chinese companies like ZTE and Huawei. The question is whether Israel can develop a formula that convinces the United States that US interests will delineate Israeli dealings with China and reassure China that it can still benefit from Israeli assets within those boundaries.

"Right now, without taking the right steps, we are looking at being put in the situation in which the US is telling us we need to cut or limit our relations with China. The problem is that Israel wants freedom of relations with China but is not showing it really understands US concerns. Sorek-2 was a good result. It shows the Americans we get it." said Carice Witte, executive director of Sino-Israel Global Network and Academic Leadership (SIGNAL) that seeks to advance Israeli-Chinese relations

Although the effects of the pandemic have battered Israel economically, it must heed Washington's warning, even if there is short-term financial loss. Israel must prioritize its long-term security relationship with the US

# Is Poverty only Lack of Money?

ocio-economic biases are prevalent by large in our society. Not only do the poor fall short of resources that directly depend on money but also empathy and respect. The biases that stem from downward classism are more often than not explicitly functional in our everyday lives.

The troubles associated with poverty stretch far beyond the realm of unaffordability on account of figures. In workplaces, or other social institutions, individuals belonging to the economically weaker sections of society are often not held in the same esteem as their relatively affluent counterparts. This is an undeniable dark truth of our society. The unfortunate fact that the lack of health care and hygienic living conditions breed several physical diseases is known and

well established. Besides physical ailments, the statistics unequivocally suggest that the poor are far more vulnerable to develop psychosocial disabilities in comparison to the economically privileged. A study conducted by the centre of social justice revealed that in Britain, children and adults coming from families that fall within the lowest 20% of the income spectrum are twice or thrice more likely to develop a mental health issue compared to those whose income fall within the highest end of the spectrum. A similar revelation was made by the Millennium Cohort Study in 2012 that declared the children with household incomes falling in the lowest quintile are 4.5 times more likely to develop acute mental health problems compared to the highest.

Child labour is one of the most brutal repercussions of poverty. The children from these

families not only have to go through the tribulations of living a life with inadequate means but also the onus of making endeavours in order to find means of alleviation from

this situation This deprives them of an education and the opportunities that come along. Hence, creates a viscous cycle because a lack of awareness further pushes them deeper into the porthole of misery. However, it must be articulated that poverty is not an exhaustive means of hindrance.

Racism, sexism, caste system, homophobia etc are all impediments to one's growth.

In all ages and times, the world has witnessed people who were averse to the idea of poor ascent. The ones who make class denying claims regarding our society need to abandon their heavily rose-tinted glasses of oblivion. Charles Dickens in his second novel, Oliver Twist, depicted a society that treated poverty as a crime and this did not sit well with some of his contemporaries who found this portrayal as problematic and far from truth. # **Unlearnt Lessons: On** 8th October 2005 Earthquake

On the 15th anniversary of the devastating earthquake of 2005, we need to acknowledge our under awareness and facilitate plans to stay alert, aware and prepared to avoid future loss of life and property in a place like Kashmir which is prone to earthquakes

The occurrence of small magnitude earthquakes is a wakeup call to check on our ground preparedness to tackle a major hazard that may come anytime. So, the current tremors are helpers and informers to alert us to get ready for any eventuality. We must respond to it with an action oriented strategy, if we wish to avert the ugly memories of the 2005 devastation.

he recent cycle of earthquake occurrences in certain parts of Kashmir and Ladakh regions should seriously worry us: not only because it may be a precursor to a major earthquake but more on what would be the ground reality if a medium to large magnitude earthquake occurs tomorrow. Think about it. We are not prepared to handle any major earthquake hazard in the region, which is reflected by the ground realities where neither earthquake science education nor preparations are up to the mark. We have to take responsibility and worry about changing it for good.

The vast scale of devastation during the 2005 earthquake that struck Muzaffarabad Kashmir is still fresh in our memory. We lost more than 80000 people and billions worth of property. This was avoidable to a large extent, and that is reflected by the scale of devastation caused by the similar magnitude earthquake in some of the world's well prepared nations. For example when the moment magnitude 7.0 earthquake occurred in Haiti in 2020 it devastated the country and resulted in an unfortunate loss of more than 85000 people (some estimates suggest the number could be 300,000). Contrary to this, when New Zealand, a relatively well equipped nation to deal with earthquake hazards, was also hit by the similar magnitude event (moment magnitude 7.1) there was no loss of life.

The stark difference in the scale of destruction caused by the similar magnitude earthquakes in two different geographic locations clearly suggests that poorly prepared nations will always suffer the most. Haiti is one of the poorest countries in the world and it is also marred by high corruption rates and an unstable political landscape, and that has directly contributed to the noticeable and contrasting difference in devastation caused by a similar sized earthquake in New Zealand in 2010.

Haiti is comparable with the Jammu, Kashmir, and Ladakh regions because we too are enmeshed in our own political and social mess, which has penetrated in almost all spheres of life. The ground preparations to tackle earthquakes hazards are next to nil, and our political landscape only postpones every possibility of preparation.

Therefore, our current setting is a perfect setup to turn a hazard into a major disaster. This is not just about earthquake related hazards but floods, landslides and so on. It should worry us a lot, and we must not wait until we have no option than to mourn the incoming devastations. We have to learn from the past, and reflect on how to improve our ground realities.

The lessons from what went wrong during the 2005 devastation in our neighbourhood, clearly demonstrates that we have to work day and night in building the infrastructure, and in particular, the mind-set to win the battle with earthquakes.

We are awaiting major earthquakes in the re gion, and these can occur anytime, so we have no created our land that we call home, otherwise, it



choice than to live with earthquake hazards.

The scientific reasoning behind the occurrence of earthquakes is simple and if people understand this simple reasoning they will start loving faults and earthquakes. We are part of the tectonic plates because we live on land that belongs to lithospheric plates.

Kashmir is sitting in the north of the major Himalayan faults, and the present day mega thrust plate boundary fault between India and Eurasian tectonic plates. The plate convergence between these lithospheric plates has to be compensated by the building of strain in rocks, and that is what has been going on over the entire developmental history of the Himalayas.

# Rise of Mediocrity in the Age of Populism

he Chinese say: "Give a man a fish and you feed him for a day; teach a man to fish and you feed him for a lifetime." This old saying was meant, most probably, to motivate people to learn a skill rather than count on handouts and to highlight the importance of education.

But does that great proverb apply to cultures and our modern public discourse? I believe it does. We live in an age where more and more people have become dependent on packaged contexts - many of us have stopped thinking and analysing. Instead, we wait for that analyst or that social media influencer to tell us X is good and Y is bad.

In his book, Mediocracy: The Politics of the Extreme Centre, Canadian academic Alain Deneault argues that the mediocre have taken over the world.

These are the people without a vision or the ability or the desire to excel. We became content with the middle. We no longer want to disturb the sweeping conformism. "There was no Reichstag fire. No storming of the Bastille. No mutiny on the Aurora. Instead, the mediocre have seized power without firing a single shot.

They rose to power on the tide of an economy where workers produce assembly-line meals without knowing how to cook at home, give customers instructions over the phone that they themselves don't understand, or sell books and newspapers that they never read," he says in the introduction of the book.

# The rise of populism

If we  $\bar{look}$  at today's political spectrum, we will surely understand Deneault's point. Moreover, we will be able to understand the rise of populism, although Deneault didn't address this is his book.

Populists thrive on the inability of some to make their own independent opinions. They target the mediocre because they are easy to win over.

Their buttons are easy to press. Natives are faced with the danger of overwhelming immigration. Religious extremists are threatened by secularists and liberals. Followers of this sect don't want to live with the followers of the other sect.

n the United States, President Donald Trump



represents a clear example of a populist as he uses preconceived prejudices and 'street' language to fight his way back into the White House

His strength in this regard stems from his use of a language that is often incendiary, not fit for a president, and one that doesn't need a highly or even moderately educated person to understand. There is no depth in his sentences.

They target those who can be described as Trump's support base - many of them used to admire him when he was a reality TV celebrity.

# **Counting on the mediocres**

Those who liked "You're fired" will sure like "Lock her up", "Sleepy Joe", "China Virus", "Thugs, outlaws and anarchists", "Democratic hoax". It worked for him well in 2016. He counts on the mediocres to carry him again to the White

House in November.

Italian economists, Ruben Durante, Paolo Pinotti and Andrea Tesei argued in a study published in July 2019 by the American Economic Association that "trash TV" helped Silvio Berlusconi, one of Europe's best known populists, win the premiership four times, between 1994 and 2011.

Italians were exposed to entertainment TV while children were "less cognitively sophisticated and civic-minded as adults, and ultimately more vulnerable to Berlusconi's populist rhetoric," the study noted. Needless to say one of the biggest Italian TV networks, Mediasat, is infamous for its provocative reality programmes.

# Reign of superficiality

In the Arab world, the situation can get even worse. It might not be reality TV oriented but surely

similar in outcome. The rise of Daesh and Al Qaida is squarely populist. Audio tapes of Osama Bin Laden and later Al Baghdadi videotaped sermons appealed to the mediocre.

They were told over and over again that their religion was under threat. Most investigations into the recruitment methods of these terror networks found out that most recruits were either school dropouts or with low education. Mediocracy again. And it keeps getting worse.

Historians argue that the rise of superficiality began in the 1980s which coincided with the rise of the Right in the US and UK, with the elections of Ronald Reagan and Margaret Thatcher.

Oliver Stones did a great job in chronicling this period in his classic film, Wall Street. "Greed is good," Gordon Gecko kept repeating in the movie.

# Postmodern movement

The Arab world is not far from this shift. I think the impact has been even bigger in this region. The Arab world was hit by two vicious currents: the ultra-religious movement and the postmodern movement (this one was unfortunately not a natural evolution of modernity, in which we did not enter at all by that time, but was more of a jump into the void).

These two currents were not interested in building on the prevailing societal values but sought to completely break with those foundations. The roles of a sensible leader, the intellectual and the creative artist were replaced by religious extremists and petty artists.

Even our food outlets were replaced overnight by the likes of McDonald's and Pizza Hut. Consumerism, dependent on imports, replaced national manufacturing – especially in traditional manufacturing states such as Egypt and Lebanon.

The imports culture extended beyond consumer goods and food. We imported pre-packaged culture too. And with the recent social media surge in the region, we began importing our collective awareness from the mediocre, the so-called 'fashionistas' or 'influencers'.

Now influencers have the power to define the social standards and draw the boundaries of our culture. Replacing the Bin Ladens and Al Baghdadis, the influencers are our new populists. This is mediocracy at its best.

# **China's Experimental COVID-19 Vaccine Appears** Safe In Early Trials: Study

Beijing: A Chinese experimental coronavirus vaccine being developed by the Institute of Medical Biology under the Chinese Academy of Medical Sciences was shown to be safe in an early stage clinical trial, researchers said.

In a Phase 1 trial of 191 healthy participants aged between 18 and 59, vaccination



with the group's experimental shot showed no severe adverse reactions, its researchers said on Tuesday in a paper posted on medRxiv preprint server ahead of peer review.

The most common adverse reactions reported by the trial participants were mild pain. slight fatigue and redness, itching and swelling at the injection site.

The candidate also induced immune response.

"All the data obtained in this trial support the safety and immunogenicity of this inactivated vaccine and are encouraging with regard to further studies of its efficacy in the future," the paper said.

China has inoculated hundreds of thousands of essential workers and other groups considered at high risk with other vaccines, even as clinical trials had not been fully completed, raising safety concerns among experts. China has at least four experimental vaccines in the final stage of clinical trials.

# **Pakistani Court Acquits Christian Man On Death Row** For Blasphemy

Islamabad, Pakistan - A Pakistani appeals court has acquitted a Christian man who spent about seven years in jail on the accusation of blasphemy, a charge that led to communal rioting that saw more than 120 houses in a Christian-majority area in Lahore city burned down by an enraged mob

insulting Islam, its prophet and the holy book, as well as other offences against the religion.

These crimes can carry a death sentence and, increasingly, mobs and vigilantes have been taking matters into their own hands. At least 77 people have been killed in mob and targeted attacks in connection with blasphemy allegations since 1990, according to an Al Jazeera

Sawan Masih, 40, was arrested in 2013 on blasphemy charge following an argument with a Muslim man in the east-

A two-member bench of the Lahore High Court on Tuesday acquitted Masih of all charges, with a full verdict detailing the reasons for the acquittal to be issued at a later date.

Masih was convicted and sentenced to death under Pakistan's strict blasphemy laws by a lower court in 2014. The court had convicted him of insulting Prophet Muhammad, a charge that carries a mandatory death

penalty under Pakistani law. Blasphemy is an emotive subject in Pakistan, where the country's strict laws criminalise tally. The latest such attack took place in the northwestern city of Peshawar in July, when a man accused of blasphemy was shot dead in a court during a hearing in his case.

In 2013, a day after the accusations against Masih surfaced, a mob attacked his Christian-majority neighbourhood of Joseph Colony, in Lahore's Badami Bagh area, in what was then one of the worst incidents of violence around the blasphemy laws.

More than 120 homes were burned down, in addition to a church and several shops, as hundreds of protesters armed with sticks, pipes, and stones ransacked the colony before setting it on fire.



# By 2021, 150 Million People May **Be In Extreme Poverty Due To Covid: World Bank**

Washington: The World Bank today warned that by 2021, as many as 150 million people are likely to be in extreme poverty because of the coronavirus pandemic and countries will have to prepare for a "different economy" post-COVID by allowing capital, labour, skills and innovation to move into new businesses and sectors.

The COVID-19 pandemic is estimated to push an additional 88 million to 115 million people into extreme poverty this year, with the total rising to as many as 150 million by 2021, depending on the severity of the economic contraction, according to the Washingtonbased global lender.

This would represent a regression to the rate of 9.2 per cent in 2017, according to the biennial Poverty and Shared Prosperity Report.

Had the pandemic not convulsed the globe, the poverty rate would have been expected to drop to 7.9 per cent in 2020, it said.

The pandemic and global recession may cause over 1.4 per cent of the world's population to fall into extreme poverty, World Bank Group President David

In order to reverse this serious setback to development progress and poverty reduction, countries will need to prepare for a different economy post-COVID, by allowing capital, labour, skills and innovation to move into new businesses and sectors, he said.

Noting that the new poor will be in countries that already have high poverty rates, the report said that a number of middle-income countries will see significant numbers of people slip below the extreme poverty line.

About 82 per cent of the total will be in middle-income countries, the report estimates.

The convergence of the COVID-19 pandemic with the pressures of conflict and climate change will put the goal of ending poverty by 2030 beyond reach without swift, significant and substantial policy action, the World Bank said, adding that by 2030, the global poverty rate could be about seven per

India, one of the economies with the largest population of extreme poor, creates substantial uncertainty around the current estimates of global poverty, the Bank said.

Observing that effective approaches have tapped the skills and dedication of community members, the World Bank said that in Mumbai, city officials were able to stem the rapid spread of the coronavirus in Dharavi, one of the city's largest urban settlements, by mobilising community members and staff from private medical clinics for a strategy based on mass screening for fever and oxygen levels.

In the space of three months, by July 2020, reported cases in the area had been cut to 20 per cent of their peak in May. To help poor families during the lockdown, foundations, nongovernmental organisations and volunteers provided thousands of households with ration kits.

Dharavi's success stemmed from a combination of customised solutions, community involvement and perseverance, it added.

# '14 Million Tonnes Of Microplastics On Sea Floor'

Sydney: The world's sea floor is littered with an estimated 14 million tonnes of microplastics, broken down from the masses of rubbish entering the oceans every year, according to Australia's national science agency.

The quantity of the tiny pollutants was 25 times greater than previous localised studies had shown, the agency said, calling it the first global estimate of sea-floor microplastics. Researchers at the agen-

cy, known as CSIRO, used a robotic submarine to collect samples from sites up to 3,000 metres (9,850 feet) deep, off the South Australian coast.

"Our research found that the deep ocean is a sink for microplastics," principal research scientist Denise Hard-

"We were surprised to ob-

serve high microplastic loads in such a remote location.'

The scientists, who published their findings in peerreviewed journal Frontiers in Marine Science, said areas with more floating rubbish generally had more microplastic fragments on the sea floor.

"Plastic pollution that ends up in the ocean deteriorates and breaks down, ending up as microplastics," study lead Justine Barrett said.

"The results show microplastics are indeed sinking to the ocean floor.'

Hardesty called for urgent action to find solutions to marine plastic pollution, which affects ecosystems, wildlife and human health.

"Government, industry and the community need to work together to significantly reduce the amount of litter we see along our beaches and in our oceans," she said.

# 2020 Saw Hottest **September On Record** Globally, Shows Data

Paris: Earth's surface was warmer last month than during any September on record, with temperatures since January tracking those of the hottest ever calendar year in 2016, the European Union's Earth Observation Programme said Wednesday.

This year has now seen three months of record warmth --January, May and September -- with June and April virtually tied for first, the Copernicus Climate Change Service reported.

"There is currently little difference between 2020 and 2016 for the vear-to-date," Copernicus senior scientist Freja Vambourg told AFP.

For the 12-month period through September, the planet was nearly 1.3 degrees Celsius above pre-industrial levels.

That is alarmingly close to the 1.5C threshold for severe impacts detailed in a major 2018 report by the UN's climate science advisory panel, the IPCC.

The Paris Agreement has enjoined nations to cap global warming at "well below" 2C, and 1.5C if feasible.

So far, Earth has warmed on average by one degree,



enough to boost the intensity of deadly heatwaves, droughts and tropical storms made more destructive by rising seas.

Climate change driven by greenhouse gas emissions from burning fossil fuels has picked up pace in recent decades.

Jineteen of the 20 last years are the warmest since ac rate readings began in the late 19th century.

Since the late 1970s, the global thermometer has crept up 0.2C every decade, according to EU data.

Temperatures in September were "exceptionally high" over northern Siberia, which -- along with much of the Arctic Circle -- has seen freakishly warm weather for months.

September was brutal in the Middle East, with new high temperatures reported in Turkey, Israel and Jordan. Fire and ice

arts of North Africa and Tibet were also scorching hot, while maximum daytime values reached 49C in Los Angeles County early in the month

Across California, five of the state's six biggest wildfires in history were still burning at the end of the month.

"September was warmer by 0.05C than September 2019, the previous warmest September," the Copernicus report said.

# N E W S M A K E R S PM For A Day: Teenager Fills Finland's Top Job

Finland: Finnish Prime Minister Sanna Marin faced a quieter day than usual on Wednesday after handing power to a 16-year-old as part of a campaign to promote girls' rights.

Aava Murto, from Vaasky in southern Finland, said she was having an "exciting day" as she faced media on the steps of parliament after meeting with the chancellor of justice.

Murto added that she had "learnt some new things about legislation.'

In the afternoon, the student who actively campaigns on climate and human rights issues was to speak with MPs and the minister for development and foreign trade.

Her message to decisionmakers has been that girls "need to realise more how important they are, and how they are just as good at technology as boys," she told AFP.

"I think young people could teach adults to be more innovative and think more about the



future," she added.

The swap is part of a global "Girls Takeover" campaign by children's rights charity Plan International, which aims to raise awareness of girls' digital skills and opportunities in technological industries and highlight the problem of online harassment against women.

Although Finland scores highly in international gender equality comparisons, women are still heavily under-represented in technology firms and boardrooms,

while the country's share of females starting technologyrelated studies is the lowest in the OECD.

The global campaign coincides with the UN's International Day of the Girl Child on Sunday, and will also allow girls take on the jobs of ministers in Kenya, Peru, Sudan and Vietnam.

Elsewhere, senior jobs at Microsoft, Samsung, Facebook and Twitter will go to teenage girls in countries including El Salvador, Guatemala, the Netherlands and the Philippines.

# **Nobel Prize In Chemistry Awarded To Emmanuelle Charpentier, Jennifer Doudna**

tockholm: Emmanuelle Charpentier of France and Jennifer Doudna of the US on Wednesday won the Nobel Chemistry Prize for the gene-editing technique known as the CRISPR-Cas9 DNA snipping "scissors", the first time a Nobel science prize has gone to a women-only team.

'Using these, researchers can change the DNA of animals, plants and microorganisms with extremely high precision," the Nobel jury said.

This technology has had a revolutionary impact on the life sciences, is contributing to new cancer therapies and may make the dream of curing inherited diseases come true." The technique has been tipped for a Nobel nod several times in the past, but speaking to reporters in Stockholm via telephone link Charpentier said the call was still a surprise.

"Strangely enough I was told a number of times (it might happen) but when it happens you are very surprised and you feel that it's not real," she said.

"But obviously it is real so I have to get used to it now," she added. Charpentier, 51, and Doudna, 56, are just the sixth and seventh women to re-

ceive the Nobel Prize in Chemistry, and



this is the first time a Nobel science prize goes to a women-only team.

Charpentier told reporters she considered herself "a scientist" first, but hoped the prize would provide "a really strong message for young girls". Rewriting 'the code of life'

While researching a common harmful bacteria, Charpentier discovered a previously unknown molecule -- part of the bacteria's ancient immune system that disarms viruses by snipping off parts of their DNA.

After publishing her research in 2011, Charpentier worked with Doudna to recreate the bacteria's genetic scissors. simplifying the tool so it was easier to use and apply to other genetic material.

# Trump scoffs at Covid-19, signs of election defeat

**T**ASHINGTON: dent Donald Trump doubled down on Tuesday on the macho image his fans adore after declaring himself cured of Covid-19 and scoffing at disastrous opinion polls only four weeks before election day against Democrat Joe Biden.

"FEELING GREAT!" he tweeted, also insisting that he is "looking forward" to holding a second scheduled debate against Biden in Miami on October 15.

There had been speculation, even among some Republicans, that Trump might emerge from hospital chastened or at least with a new tone of empathy for the roughly 210,000 Americans who have died from the virus.

Instead the Republican has returned to the White House boasting he vanquished the disease that upended the country this year — and, by extension, that he is still capable of vanquishing his grim odds on election day of Nov 3.

# **High Court Rejects Plea For Charging Only Tuition Fees By Universities During Covid-19**



Court today declined to entertain a PIL seeking guidelines to universities and such institutions to charge only the tuition fee, that too in installments, in view of the prevailing COVID-19 pandemic, and said "concessions are not a matter of right".

A bench of Chief Justice DN Patel and Justice Prateek Jalan instead asked the concerned authorities to treat the plea as a representation and take a decision in accordance with law, rules, regulations and government policy applicable to the facts of the case.

With the direction the petition, by a fourth year law student, was disposed of.

During the brief hearing, the bench said that universities have to pay their professors and also set up the infrastructure for online classes and therefore, they cannot be directed to grant fee concessions.

It disapproved of the several reliefs, like providing gadgets and 4G internet packs to students by the varsities, sought in the PIL and said "what is the harm in asking for it".

"Maangne mein kya jaata hai (what is the harm in asking for it). You can ask for the heaven and the sky. Why not ask for cycles and cars also as they (students) have to go to the college/university. What is the harm in asking.'

"Such petition deserve to be dismissed with costs, but we are not doing it now," the bench said while disposing of the plea filed through advocate Kush Sharma.

The petition had also sought framing of guidelines to ensure the varsities provide gadgets and fast internet connections, to those who cannot afford the same, so that all students have access to the online education or classes being held during the pandemic.

It had claimed that while the University Grants Commission and Bar Council of India has issued advisories to the varsities to grant concessions with regard to fees, these were only requests and the universities were not adhering to the same.

The petition had contended that due to the pandemic not only the country's GDP has shrunk but people employed in various sectors have lost their jobs or have faced reduction in salaries.

"Consequently, household income across all income groups has reduced considerably and people are facing severe cash crunch and financial burden. Owing to these circumstances, the parents of students pursuing undergraduate and postgraduate courses are finding it exceedingly difficult to pay the fees of their wards."

"This situation is more alarming in the case of parents of those students who are pursuing their education in educational institutions which are set up under private universities and deemed universities which charge fees at a huge premium," the petition had said.

# **NSCN-IM Wants Naga** Peace Talks In 3Rd **Country Involving PM**

The NSCN-IM, which has been negotiating with the government to resolve its long pending issues, has demanded the involvement of Prime Minister Narendra Modi in the talks for faster determination of their demands, insisting that the negotiations be held in a "third country".

"In order to save the political dialogue, the talks should resume at the Prime Minister's level, without pre-condition and outside India in a third country," NSCN-IM led by its chief negotiator Thuingaleng Muivah said in a letter to the Prime Minister.

"If our stay in India is no more welcome, all necessary arrangements must be made for us to leave India and the political talks be resumed in a third country," said the letter, written to Modi on February 25.

The National Socialist Council of Nagaland-Isak-Muivah (NSCN-IM) in a separate statement on Tuesday said that they deliberately withheld the letter for seven months before releasing it to the media for public consumption as it waited with all confidence that the Prime Minister would respond positively.

"NSCN-IM being accountable to the Naga people hereby released the letter to inform of the delay and the lack of response from the office of the Prime Minister to our people," the statement said.

Muivah, who is the Ato Kilonser (Prime Minister) of the self-styled Naga government, referred to the circumstances in which he and the then chairman of the outfit, Isak Chishi Swu, first arrived in India in 2002 and "patiently" stayed here since 2010 to conclude an "acceptable and honourable political settlement".

The letter, which is available with IANS, said that the NSCN-IM started talks with the government only after the latter recognised the Naga problem as a "political issue" and stopped calling it India's

Muivah was also critical about the role of Nagaland Governor R.N. Ravi, who, before taking up the new assignment, was the Government of India's chief negotiator for the Naga talks.

"Ravi was interfering with the law and order issues in 'deliberate deviation' from his appointment as the Centre's representative for the peace talks.

"The activities of the representative of the government is polarising the Naga society instead of uniting the Nagas for an honourable political solution," the NSCN-IM leader said.

According to officials in Nagaland, a nine-member team of NSCN-IM led by Muivah has been holding informal talks with the Centre since the second week of August in New Delhi as a prelude to the formal parleys which are expected to begin soon.

# **UGC Declares 24 Universities As Fake; Maximum From UP Followed By Delhi**

The University Grants Commission (UGC) on Wednesday announced a list of 24 "self-styled, unrecognised institutions" in the country, terming them as "fake" with the maximum of them operating from Uttar Pradesh followed by Delhi.

"Students and public are informed that currently 24 self-styled, unrecognised institutions are functioning in contravention of the UGC Act. which have been declared as fake universities and these are not empowered to confer any degree," UGC Secretary Rajnish Jain said.

The majority of eight of these universities are from Uttar Pradesh --Varanaseya Sanskrit Vishwavidyalaya, Varanasi; Mahila Gram Vidyapith, ed Nations University, Vocational Allahabad; Gandhi Hindi Vidyapith, University, ADR Centric Juridicial Allahabad; National University of University, Indian Institution of Sci-Electro Complex Homeopathy, Kanpur; Netaji Subhash Chandra Bose Open University for Self Employ-Pradesh Vishwavidyalaya, Mathura; laya (Spiritual University).

They are --Sree Bodhi Academy of Higher Education, Puducherry; Christ New Testament Deemed University, Andhra Pradesh; Raja Arabic University, Nagpur; St John's University, Kerala and Badaganvi Sarkar World Open University Education Society, Karnataka.

"The UGC Act, 1956 provides that a degree can be awarded, only by a university established under a central, state, provincial Act or an institution especially empowered by an Act of Parliament to confer the degree," Jain said.

# Chief Justice Bobde: Will Smoke From Stubble Burning Kill Coronavirus?

Supreme Court on Tuesday wanted to know whether the smoke produced from stubble burning could kill the novel Coronavirus as cases in India inched closer to 67 lakh while 1,03,569 lost the battle against the pandemic.

Chief Justice S.A. Bobde asked the question during a hearing of a PIL against the seasonal stubble burning exercise in Punjab, Haryana and Uttar Pradesh.

"Will the smoke kill the Coronavirus?" Chief Justice Bobde said.

The smoke would not kill the coronavirus, but it would certainly worsen the situation and contribute towards its spread, said senior advocate Vikas Singh, representing the petitioners citing scientific study. The PIL has been moved in the Supreme Court seeking directions to the Punjab and Haryana governments to ban
