J&K Seeks Rs 367 Cr Funds From WB For Healthcare Institutions

JAMMU: The Jammu and Kashmir government has submitted a comprehensive proposal seeking over Rs 367 crore funding from the World Bank for strengthening of healthcare institutions including dedicated COVID hospitals and ICUs and procurement of critical care ambulances in the union territory, senior health officials said.

The proposal has been prepared by the health and medical education department with the objective of providing state-ofthe-art medical services and facilities to people living in urban areas as well as the remotest parts of the union territory, they said.

"A comprehensive proposal was formulated amounting to Rs 367.48 crore (approximately US\$ 50 million) and submitted for funding its," as per the report.

Jammu and Kashmir does not have a major or middle-level chain of hospitals on the lines of those operating in the rest of the country, except Batra hospital in the private sector. A latest report on manpower audit in the health department reveals that nearly 99 percent of the UT's healthcare needs are met by public health institutes, underlying the importance of the government healthcare system. "In 2018-19 at least 2.39 crore OPD visits of patients were recorded in J&K and out of them 99.2 percent (2.22 crore patients) were seen only in government hospitals. The private sector accounted for a minuscule 0.8 percent of all OPD vis-

On August 4 last year, all major political parties in Kashmir, except BJP, had met at the residence of Farooq Abdullah amidst uncertainty and tension in the erstwhile state as the Centre had rushed additional paramilitary forces there while asking all tourists including Amarnath pilgrims to leave the Valley as soon as possible.

The joint statement issued by the political parties, expressing concern over the situation, came to be known as the Gupkar Declaration.

The Centre revoked the special constitutional status of the state and also bifurcated it into two union territories -- Jammu and Kashmir, and Ladakh. In a follow up, the political parties had met again in August this year and vowed to fight for restoration of the special status of Jammu and Kashmir.

This is the second time in Jammu & Kashmir since 1947 when such a number of political groups have joined hands over an issue. In 1987, several political parties had formed "Muslim United Front" to take on NC- Congress combine===

The Chinese spokesperson had also claimed that development of border infrastructure by India was the "root cause" of tensions between the two countries.

Gadkari initiates the first blasting at Zojila Tunnel

Zoji-la Tunnel to be 'Turning Point' for UTs of Jammu Kashmir and Ladakh: LG

SRINAGAR, OCTOBER 15: Lieutenant Governor, Manoj Sinha termed the ceremonial blasting of Zoji-la Tunnel as a 'Turning point' for the Union Territories of Jammu Kashmir and Ladakh, which will not only make the emotional connections of regions to a new level but will also provide physical connectivity throughout the year.

The Lt Governor was speaking on the occasion of the first ceremonial blast at Zoji-la Tunnel- the longest tunnel road in Asia. The ceremonial blast was initiated by Union Minister for Road Transport, Highways and MSMEs Shri Nitin Gadkari through virtual mode.

The Lt Governor expressed his heartfelt gratitude to Hon'ble Prime Minister, Narendra Modi, and Union Minister for Road Transport, Highways and MSMEs Nitin Gadkari for the beginning of work on the ambitious project.

The Lt Governor hoped that after completion of the project in December 2023, Sonamarg in Ganderbal district would receive and attract more winter tourism. It was informed that the project has been planned on the European Model.

The Lt Governor said that work on the approach road to the tunnel is expected to be completed within 30 months while the tunnel itself will take around 72 months to complete. With a length of 14.83 km, the tunnel would be the longest bi-directional tunnel in Asia. 'The tunnel will add to the socio-economic and cultural growth of the region and will address our strategic needs', observed the Lt Governor.

'The tunnel will not only provide all-weather connectivity between Srinagar and Leh but will also reduce travel time from three and a half hours to only 15 minutes'. claimed the Lt Governor.

In connection with the project, 5 brides, 6 catch dams, 13 deflector dams, 8 cut and covers, 2 snow gal

leries, and 8 blast walls will also be constructed to provide avalanche protection between Sonamarg and Baltal. Exhaustive research and planning have been done while designing the project which includes manual fire alarm, portable fire extinguisher, automatic fire detection system, etc.

Works are also underway by NHILDCL on Z-Morh and Zojila Tunnel along with the work on the approach road and Avalanche Protection Works. While the Z-Morh tunnel is 6.5 km long, the Nilgrar Twin Tunnel is 2.4 km and the Zojila Tunnel is 14.15 km.

MoU contained some deficiencies **Observer News Service**

RINAGAR: In a candid admission, the chief minister, Dr Fa¬rooq Abdullah, today said the centre had taken im for a ride when the former union energy Minister PKKumaramanglam, obtained his signatures on the memorandum of understanding (MoU) whose contents later turned out to be detrimental to the state's interests

According to a CNS report Dr Abdullah told the state assem¬bly during an obituary reference to the late Kumaramanglam that a MoU had been signed between him and union minister. However, when the documents were prepared the union energy minister allegedly with malafide intentions, obtained his signa¬tures on such papers which, on closer scrutiny later revealed that these were against the interests of the state.

However an official handout issued today said the chief min¬ister had said "the MoU signed by him with the then union en¬ergy minister had been signed in good faith to benefit the State." However the handout said"Later on the state officials pointed out some deficiencies." He said he immediately up the matter with Kumaramanglam who "readily agreed". But before $correc\neg$ tion could be effected, the union Minister passed away. "These clauses have to be modified to protest the interests of the State" Dr. Abdullah added.

When contacted the principal secretary power development department Ajit Kumar told Observer News Service, the 'defi-ciencies pertained to the state's claim for reimbursement of the expenditure it had already incurred on the power projects. The MoU did not mention this. However, Kumar said the centre had agreed to reimburse the expenditure and necessary modifica¬tions would be incorporated in the MoU shortly. Talk for peace

he interview of Pakistan National Securi-ty Advisor Moeed Yusuf to the renowned Indian journalist Karan Thapar has become a subject of discussion in India and Pakistan. It was first such interview of a top government functionary in Pakistan to an Indian publication following the revocation of Article 370 in August last year. So, there was this huge interest in what Pakistan may have to say about the situation of the past fourteen months. And the interview did, to a large extent, satisfy the curiosity. Yusuf was combative in his response to Thapar's questions. And he made a few revelations too. For example, that India had expressed "a desire for conversation". and sent feelers through some channels. But Pakistan, he said, wanted New Delhi to reverse constitutional changes, undo domicile law and make Kashmiris the third party before the talks can go ahead.

Yusuf, however, added that Pakistan was prepared to look towards future and improve relations with India. He said Pakistan was ready to discuss Kashmir and also terrorism that has invariably been the Indian demand. At the same time Yusuf offered some proofs of the alleged Indian involvement in sabotage activities in Pakistan. He also said Islamabad had yet to take a final decision on granting a provincial status to Gilgit Baltistan, something that is also being opposed in Kashmir.

Overall, the interview underlined the prevailing bitterness in the relations between India and Pakistan following the withdrawal of J&K's autonomy last year. Considering that Yusuf made any restoration of engagement with New Delhi contingent upon reversal of Article 370 move and making Kashmiris a third party to Kashmir issue, the conditions New Delhi will be loath to meet, there is little hope of a dialogue between the neighbours anytime soon. Moreover, the lingering China-India stand-off in Ladakh has only added to complications.

One outcome of the Article 370 move was that it made Pakistan-China relations even closer. Ladakh stand-off has broken the decades-old peace and stability along the Line of Actual Control. Now India's northern and western borders are unstable. This has created a difficult regional situation, something that needs an urgent engagement among the three countries or between New Delhi and either of the two others to address. As things stand, the dialogue with China has shown little promise of success. But this hardly is a reason not to persist with the execise. More so, with Pakistan which if pursued with seriousness holds a real possibility of regional peace.

Underlying anti-fragile drivers & emerging black swan risks

Can be changed by what happens to me. But I refuse to be reduced by it." - quoted the celebrated American poet, memoirist & civil rights activist Maya Angelou. This inspiring message has been an integral part of numerous campaigns across the globe during the times of natural calamities, wars, political movements and other crisis that demanded collective grit, perseverance and resilience. Kashmir economy, which has demonstrated a miraculous survival spirit despite operating within a consistently hostile & turbulent political environment, is nothing short of a living manifestation of this powerful quote.

Despite losing almost an entire decade (3000 days of shutdown since 1990 as per KCCI) in the last three decades to this never ending political turmoil, the statistics of the formal economy have surprisingly beaten some of the comparatively peaceful and economically diverse states of India with fair margins. Take for example the per capita income, which in case of J&K is far better than even Madhya Pradesh, Uttar Pradesh, Bihar & other north eastern states. The poverty ratio at 10.35 % is almost half of the national average (21.92). J&K ranks at an impressive 3rd place in life expectancy (73.5 years) and 10th in infant mortality rate (24) among all Indian states/UTs. In terms of Human Development Index (HDI) J&K at 0.68 is ahead of 18 Indian states including the likes of Gujarat and Andhra Pradesh. In terms of literacy rates, J&K at 77.3% has outperformed 9 major states of India. Now take a look at the credit discipline of the region's borrowers. Despite being trouble torn, energy starved, geopolitically strangulated, under a hostile whether & treacherous road connectivity, the default rates in the region are remarkably low. J&K Bank's (regions 2/3rd share holder in lending) gross NPA to gross advances ratio is 5.75% as on June 2020 (for within J&K loans), significantly lower than its "rest of India" loan portfolio. A similar pattern of low NPA ratio in J&K can be observed in other lending institutions and banks operating in the region.

The explanation for this paradox is beyond the standard economic models they teach in the universities. J&K's economy is a classic case of resilience which fits in the category of extreme economies. The concept of economic evolution under extreme systemic shocks and the resulting unconventional economic structures was popularized by the former economics editor of "The Economist" who's also been an adviser at the Bank of England-Richard Davies, in his popular book "Extreme Economies". Akin to economies that develop in war torn regions, inside a prison or amidst refugee camps, Kashmir's economy too has evolved in complexity & diversification over decades. The central principle which seems to have governed this evolution has revolved around the effective decoupling of some sectors from the domestic markets. By virtue of the nature of the turmoil, all those industries which were concentrated in domestic markets and were dependant solely on the regional conduciveness of the situations surrounding the buyers and the sellers were doomed. Contrary to this, there emerged five major pillars of J&K's economic resilience, which over a period of decades, successfully evolved into more robust and some even into anti-fragile entities (entities that gain in disorder). First is J&K state's ever expanding Government salaries & pension bill. Irrespective of the scale and intensity of the violent cycles, which engulfs the valley every now and then, resulting in excruciatingly frequent & long curfews and strikes, this component of the region's economy has never felt the mildest of the income shocks. With the current annual size of Rs. 37,000 crore, this conduit of income sustains over 4.5 Lakh individuals. Is this unique with J&K? Yes, the UT has one of the highest Government employee to population ratio in entire India. This conflict immune, stable and assured amount that they earn is around a quarter of J&K's annual GSDP. The fact that Government jobs have been one of the main selling points of mainstream political parties in the region, has over a period also resulted in an oversold market. Salaries sometimes drop and nature of employment gets engineered into various forms (daily wager, rehbre-taleems, contractual etc), but it is ensured that the numbers always remain high. This highly sought after job industry has gradually assumed an anti-fragile nature with a Government jobs bonanza announced every time a bout of turmoil grips the region. However, the

fact remains that as this conduit of our income has helped us remain afloat all these troubled decades.

Second is the time tested and "shutdown & curfew" immune agrarian Industry. We might not be cultivating enough rice even to suffice our domestic consumption but we have made sure those apples, saffron and walnuts fetch us more money to buy anything including rice. J&K has a comparatively well developed horticulture sector with cash rich flagship products like apples, walnuts, cherries & almonds. The rapid pace at which paddy fields were converted into orchards raised many alarm bells initially, but the volume of money that this industry of Kashmiris working in various states of India. Although data for domestic remittances is not available, however, it is very likely that the number of people working and the volume of money received are comparatively higher than foreign remittances. The aggregate of both these incomes has consistently been growing with more channels of communication getting established in various countries generation after generation. This segment too gets a shot every time a wave of turmoil hits the valley evolving into anti-fragile entity for the regional economy.

Fifthly, as ironic as it may sound, but, the argument that the conflict industry also helps the

earns and the forward integration in terms of processing which is taking place, though slowly, has shelved all the apprehensions with confidence. By virtue of the seasonality of this sector, less impact of "shutdowns and curfews" and importantly its limited dependence on regional markets, this sector has been a stable backbone of our survival economics. Importantly the sector supports over 16% of the states GSDP.

Third is our wide base of home based artisans. According to the directorate of handicrafts in Kashmir, with earnings of around Rs 1,700 crore as foreign exchange every year, there are nearly 2.5 lakh artisans directly dependent upon handicrafts for their livelihood. As per various estimates done by Government and Non-Government agencies almost 60% of the households in the Valley are connected with crafts one way or another. This sector, although not that big in size in terms of dollar value when compared to the first two, has three distinct risk mitigants which makes it very robust, less volatile to shocks and more lucrative. First is the nature of processing which is almost entirely home based making it immune from the vagaries of frequent political cyclones that hit the region. Second is the nature of its market which is mostly high end, elite, resourceful customer segment and the third part is the geographically diversified markets spanning across the globe. This stable and growing tributary of income from foreign exchange and from mainland India has been one of the significant bed rocks of the economic resilience demonstrated by J&K in last so many decades. Fourth is the export of human resource to various states of India and across the world. Scores of highly educated youth who fall outside the ambit of farming and artisan segments find it extremely difficult to fetch decent earnings outside the limitedly available Government sector. As a result there has been a conscious and gradually increasing trend of exporting human resource to more resourceful geographical locations across India and outside India. As per official data, the annual foreign remittances received by J&K from people working outside country range from Rs 1300 to Rs. 1500 Crore. This figure gets even more inflated if we factor the large base

regional economy in surviving the frequent tides is not misplaced. Traditional economics says peace is the basis of economic growth but when it comes to Kashmir, we have presumably learned the art of even milking the conflict. It is a matter of fact that the region of Jammu & Kashmir has been the epicenter of conflict between three nuclear armed countries. The stakes vis-à-vis national security in and around this region are therefore extremely high. As a result, the size of investments on security & discourse management that flow from the national coffers to this region is quite substantial

In defence of secularism

In a letter to the Maharashtra chief minister Uddhav Thackeray, urging him to open religious places for worship, the state governor, Bhagat Singh Koshyari, commented on Mr Thackeray's politics of Hindutva and asked him, mockingly, if he had "turned secular". In a separate development, an advertisement for the jewellery brand, Tanishq, which portrayed a multireligious home where Muslim family members adopted rituals to make their Hindu daughter-in-law feel at home at her baby shower ceremony, drew a backlash on social media for ostensibly hurting Hindu sentiments. The ad, which was based on the theme of unity, was withdrawn.

Both events — one related to the functioning of the Indian State and the other related to cultural trends in Indian society are disturbing. Take the governor's letter first. Mr Koshyari, as the constitutional head of the state, is perfectly within his rights to correspond with the chief minister, and even make suggestions including the need to open religious places, though whether this is indeed wise in a state that has had the highest share of Covid-19 cases in India is open to question. But the problem is not the letter or its specific theme; the issue is the contempt with which Mr Koshyari used the term "secularism", equating it with the closure of religious places. Secularism may be a controversial word for dominant sections of India's polity, but it is a cherished constitutional value. There have been distortions in the practice of secularism, but this does not take away from the importance of the principle. To demean the word is not just to undermine the Preamble, but also encourage a majoritarian conception of the nation.

The Hindutva Right, based on its entirely flawed and incorrect idea of "love jihad", frowns at Hindu-Muslim relationships, especially if the man is a Muslim. The fact that even a moving ad triggered a backlash, and that the company withdrew the ad, speaks of a deep divide that could threaten the very idea of India. Both the State and society must return to the original constitutional vision of pluralism, coexistence and integration.

This pillar, although immeasurable, always grows in disorder making it one of the most anti-fragile conduits of the regional economy.

As long as the wide steel frame of Government servants and the ability to produce cash rich apples, walnuts, saffron & handicrafts remains. J&K economy's ability to survive economic shocks will refuse to give in. However, the emerging black swan risks posed by the global slowdown and the Indian recession are exposing the otherwise stable drivers of J&K's economy to serious systemic threats. The export of handicrafts is getting contracted and is impacting lakhs of artisans due to the ongoing global recession. The cash rich horticulture is facing a dent in demand, posing a serious challenge to lakhs of apple, walnut and saffron growers. The job and salary cuts for people working outside J&K and India is severely reducing the remittances which otherwise formed an essential component of the regional economy. Unlike previous shocks, this time the basis of our risk mitigation i.e. geographical diversification of markets is getting drastically compromised. In this emerging backdrop, how the regional economy evolves this time and responds to the challenges never witnessed before is surely going to be the real test of our economic resilience.

Do Pandemics End?

Some societies recovered relatively quickly from their losses caused by the Black Death. Others never did. For example, medieval Egypt could not fully recover from the lingering effects of the pandemic, which particularly devastated its agricultural sector. hen will the pandemic end? All these months in, with over 37 million CO-VID-19 cases and more than 1 million deaths globally, you may be wondering, with increasing exasperation, how long this will continue.

Since the beginning of the pandemic, epidemiologists and public health specialists have been using mathematical models to forecast the future in an effort to curb the coronvirus's spread. But infectious disease modeling is tricky. Epidemiologists warn that "[m]odels are not crystal balls," and even sophisticated versions, like those that combine forecasts or use machine learning, can't necessarily reveal when the pandemic will end or how many people will die.

As a historian who studies disease and public health, I suggest that instead of looking forward for clues, you can look back to see what brought past outbreaks to a close – or didn't.

Where we are now in the course of the pandemic

In the early days of the pandemic, many people hoped the coronavirus would simply fade away. Some argued that it would disappear on its own with the summer heat. Others claimed that herd immunity would kick in once enough people had been infected. But none of that has happened.

A combination of public health efforts to contain and mitigate the pandemic – from rigorous testing and contact tracing to social distancing and wearing masks – have been proven to help. Given that the virus has spread almost everywhere in the world, though, such measures alone can't bring the pandemic to an end. All eyes are now turned to vaccine development, which is being pursued at unprecedented speed.

Yet experts tell us that even with a successful vaccine and effective treatment, COVID-19 may never go away. Even if the pandemic is curbed in one part of the world, it will likely continue in other places, causing infections elsewhere. And even if it is no longer an immediate pandemic-level threat, the coronavirus will likely become endemic – meaning slow, sustained transmission will persist. The coronavirus will continue to cause smaller outbreaks, much like seasonal flu.

The history of pandemics is full of such frustrating examples.


Once they emerge, diseases rarely leave

Whether bacterial, viral or parasitic, virtually every disease pathogen that has affected people over the last several thousand years is still with us, because it is nearly impossible to fully eradicate them.

The only disease that has been eradicated through vaccination is smallpox. Mass vaccination campaigns led by the World Health Organization in the 1960s and 1970s were successful, and in 1980, smallpox was declared the first – and still, the only – human disease to be fully eradicated.

So success stories like smallpox are exceptional. It is rather the rule that diseases come to stay.

Take, for example, pathogens like malaria. Transmitted via parasite, it's almost as old as humanity and still exacts a heavy disease burden today: There were about 228 million malaria cases and 405,000 deaths worldwide in 2018. Since 1955, global



programs to eradicate malaria, assisted by the use of DDT and chloroquine, brought some success, but the disease is still endemic in many countries of the Global South.

Similarly, diseases such as tuberculosis, leprosy and measles have been with us for several millennia. And despite all efforts, immediate eradication is still not in sight.

Add to this mix relatively younger pathogens, such as HIV and Ebola virus, along with influenza and coronaviruses including SARS, MERS and SARS-CoV-2 that causes COVID-19, and the overall epidemiological picture becomes clear. Research on the global burden of disease finds that annual mortality caused by infectious diseases – most of which occurs in the developing world – is nearly one-third of all deaths globally.

Today, in an age of global air travel, climate change and ecological disturbances, we are constantly exposed to the threat of emerging infectious diseases while continuing to suffer from much older diseases that remain alive and well.

Once added to the repertoire of pathogens that affect human societies, most infectious diseases are here to stay.

Plague caused past pandemics – and still pops up

Even infections that now have effective vaccines and treatments continue to take lives. Perhaps no disease can help illustrate this point better than plague, the single most deadly infectious disease in human history. Its name continues to be synonymous with horror even today.

Plague is caused by the bacterium Yersinia pestis. There have been countless local outbreaks and at least three documented plague pandemics over the last 5,000 years, killing hundreds of millions of people. The most notorious of all pandemics was the Black Death of the mid-14th century. Yet the Black Death was far from being an isolated outburst. Plague returned every decade or even more frequently, each time hitting already weakened societies and taking its toll during at least six centuries. Even before the sanitary revolution of the 19th century, each outbreak gradually died down over the course of months and sometimes years as a result of changes in temperature, humidity and the availability of hosts, vectors and a sufficient number of susceptible individuals.

Some societies recovered relatively quickly from their losses caused by the Black Death. Others never did. For example, medieval Egypt could not fully recover from the lingering effects of the pandemic, which particularly devastated its agricultural sector. The cumulative effects of declining populations became impossible to recoup. It led to the gradual decline of the Mamluk Sultanate and its conquest by the Ottomans within less than two centuries.

That very same state-wrecking plague bacterium remains with us even today, a reminder of the very long persistence and resilience of pathogens.

Hopefully COVID-19 will not persist for millennia. But until there's a successful vaccine, and likely even after, no one is safe. Politics here are crucial: When vaccination programs are weakened, infections can come roaring back. Just look at measles and polio, which resurge as soon as vaccination efforts falter.

Given such historical and contemporary precedents, humanity can only hope that the coronavirus that causes COVID-19 will prove to be a tractable and eradicable pathogen. But the history of pandemics teaches us to expect otherwise.

umar smiled his way to our notice a year or so ago. You know one of those genuine smiles that etch creases into a person's face and reach right up into the eyes almost lighting up the soul within.

Rather his was a voice tempered with humility — the knowledge that there were many things out there that he didn't understand, such as why it had fallen to his lot to spend his prime years far from home and family, picking trash, dusting cobwebs, and throttling bulging black bags of rubbish before removing them from the public bins kept around the residential building he worked in.

Around him, well-groomed and coiffed residents emerged briefly through the fogged up glass doors and into the basement car park, tasting the blistering heat for a few seconds ... a few minutes... before hurriedly stepping into their BMWs and Mercs, and firmly shutting the door against the heat. Air con in full blast, and sunglasses perched on noses, off they went passing Kumar by.

And yet to this day, it has never seemed to me that he bears us any malice, as we live our lives and he his.

Elsewhere in our city live a mother and daughter. While the young 20-yearold — thanks to her education — has found a job in the accounts section of a good company, it is her mother who continues to serve as the family's backbone. She doesn't have a degree to her name the result either of parental neglect, pov-

erty, or her own lack of interest back in her childhood days.

Peppered with "sorries"

And so she makes a living with skills she has picked up at home — sweeping, mopping and washing. Unlike Kumar, who is severely limited by his poor grasp of English, letting his smiles do all the talking, this middle-aged lady makes every attempt to learn the language and uses it without inhibition. Her speech is peppered with "sorries" and "thank yous" as she wears her humility and gratitude for all to see.

Then there is a 50-year-old lady who puts in 10-hour shifts, 6 days a week, at a salon, cheerfully engaging her clients in friendly banter as she goes about snipping hair, lathering on hair colour, buffing nails, exfoliating feet, and removing callus. Give her a chance to talk about herself, and she will tell you about her son back home who is studying to be an architect. It's quite evident that she has let go of all her own hopes and dreams and now shares those of her only son. Whatever she saves goes back home for his university needs and to her mother with whom he stays.

Heading to work and back

Like them, there are countless men and women for whom the daily grind isn't a 9-5 job, or driving bumper to bumper through traffic while heading to work and back. Life for them isn't about awaking to daily household chores and noisy, tantrum-throwing children and the every day school run. It doesn't involve coffee shops, jogging on the beach, Yoga classes and a Friday brunch.

For them, making a living means having to take care of tasks that don't rank on anyone's career ladder unless poverty and illiteracy hound them. Tasks that no one wants to do.

Making a living means leaving their homes and families and villages and arriving on foreign soil where a bunker bed awaits them with space underneath for their meagre possessions. It means walking from bus stops to their workplace in the heat so as to save a few dirhams on transport. It means being alone with their thoughts and anxieties since those who love them are not around to share them.

They will gratefully accept clothes that have seen better days, shoes that 'bite', old appliances that have made way for new, dented pots and pans, electronics that have fashionably expired and all manner of hand me downs. There is no room for false pride.

Theirs are lives lived to the staccato rhythm of wake up, work, eat, sleep and repeat.



Washington: United States Secretary of State Mike Pompeo on Wednesday encouraged Saudi Arabia to recognise Israel in what would be a massive boost for the Jewish state amid normalisation by two other Gulf Arab kingdoms.

Bahrain, which tightly coordinates its foreign policy with Saudi Arabia, and the United Arab Emirates on September 15 signed the so-called Abraham Accords with Israel at the White House.

Meeting Saudi Foreign Minister Prince Faisal bin Farhan, Pompeo said the agreement "contributed greatly to our shared goals for regional peace and security".

"They reflect a changing dynamic in the region, one in which countries rightly recognise the need for regional cooperation to counter Iranian influence and generate prosperity," Pompeo said.

'We hope Saudi Arabia will consider normalising its relationships as well. We want to thank them for the assistance they've had in the success of the Abraham Accords so far."

President Donald US Trump has highlighted Arab normalisation with Israel as a major achievement as he

seeks another term in November 3 elections, with his evangelical Christan base widely supportive of the Jewish state. Trump said last month

that he also expected Saudi Arabia to recognise Israel "at the right time". Gulf Arab kingdoms have found common cause with Trump in his hawkish line against regional rival Iran.

The administration in turn has been sparing in raising human rights concerns with the Arab allies, including over the killing two years ago of US-based writer Jamal Khashoggi at a Saudi consulate in Istanbul.

Pompeo said the US "supports a robust programme of arms sales to Saudi Arabia", saying the effort helps "protect its citizens and sustains American jobs". In a controversial move that triggered an internal probe, Pompeo last year cited a crisis with Iran to bypass Congress to push ahead \$8 billion in arms sales to Saudi Arabia.

Lawmakers across party lines have been appalled by the heavy toll on civilians, including destruction of schools and hospitals, in Saudi Arabia's campaign against Iranian-aligned Houthi rebels in Yemen

'World Experiencing One Of The Deepest Recessions Since Great Depression'

Washington: The world is experiencing one of the deepest recessions since the Great Depression in the 1930s owing to the novel coronavirus, World Bank President David Malpass has said, terming the COVID-19 pandemic a "catastrophic event" for many developing and the poorest countries. He told reporters that given the extent of the economic contraction, there was a rising risk of disruptive debt crises in countries. "So that has got a lot of focus

here at the meetings," Malpass told the media on Wednesday at the start of the annual meetings of the International Monetary Fund and the World Bank.

"The recession has been deep, one of the deepest since the Great Depression. And for many developing countries, and for the people in the poorest countries, it is truly a depression, a catastrophic event. It is continuing to add to the ranks of those in extreme poverty," he said.

That is the focus of this meeting and the focus of their actions, he said, adding that the World Bank was building as big a growth programme for countries as they can in this

fiscal year A day earlier, the board approved the extension of

Joe Biden And Democrats Raised Record \$383 Million For White House Bid

emocrat Joe Biden and his party raised record-shattering \$383 million in September for his presidential bid, likely bolstering his financial advantage over President Donald Trump ahead of the November 3 election.

The campaign had \$432 million in cash at month's end, campaign manager Jen O'Malley Dillon said on Twitter.

The haul outstripped the \$365 million that Democrats raised in August, which was itself a monthly record for any U.S. presidential campaign.

'To every person who chipped in a few dollars last month - thank you," Biden wrote on Twitter in announcing the sum. "I'm incredibly humbled."

The Trump campaign has not vet announced its September total, but it pulled in \$210 million in August along

Biden has held a significant lead over Trump in national polls for months, although Reuters/Ipsos polling shows a somewhat closer race in the battleground states likely to decide the winner.

As of Aug. 31, Democrats had \$466 million available to spend on the presidential

race, compared with \$325 million for Republicans. The figures cap a stunning

turnaround for the Biden campaign, which emerged from a crowded Democratic primary field earlier this year with little cash. The Trump campaign, which began raising money almost as soon as he took office in 2017, had once appeared to be a financial juggernaut.

n the final days of campaigning before New Zealand holds an election on Saturday, Prime Minister Jacinda Ardern is being greeted like a rock star.

Hundreds of students are crammed into a common area at the Victoria University of Wellington to hear her speak, and her message of hope is being punctuated by thunderous applause. One student volunteer looks on the verge of tears while others are shrieking or singing.

It's an unusually emotive display in a country where people often pride themselves on keeping things low key.

And yet as Ardern talks in uplifting tones about her plans to address mental health and climate change, she never mentions what many around the world consider her greatest success: leading the effort to stamp out the coronavirus from the nation's shores

Nobody in the crowd is social distancing or wearing a mask — they don't need to because the virus is no longer spreading in New Zealand. Life has returned to normal in the country of five million and Ardern's popularity has skyrocketed as a result.

"There is cause for optimism," Ardern



tells the crowd. "There is cause for hope. There is reason, I hope, for all of you to look to New Zealand and feel proud — but also, feel willing to keep pushing us to do more, to be more."

Opinion polls indicate Ardern is on track to win a second term as prime minister. Her liberal Labour Party is polling far ahead of the conservative National Party. led by Judith Collins.



91 Million Urban Indians Lack Basic Handwashing Facilities At Home: UNICEF

NEW DELHI: Around 91 million urban Indians lack basic handwashing facilities at home, UNICEF has said while noting that washing of hands with soap is critical in the fight against infectious diseases like COVID-19.

In a statement released on the occasion of Global Handwashing Day, UNICEF said lack of handwashing with soap puts millions at increased risk to COVID-19 and other infectious diseases.

"In Central and South Asia, 22 per cent of people in urban areas, or 153 million people, lack access to handwashing. Nearly 50 per cent of urban Bangladeshis, or 29 million people; and 20 per cent of urban Indians or 91 million, lack basic handwashing facilities at home," it said. Dr Yasmin Ali Haque, UNICEF India Rep-

resentative said as the pandemic continues to spread, it is important to remember that handwashing is no longer just an individual choice, it is a societal imperative. "It is one of the most low-cost and high-



ly effective measures you can take to protect yourself and others against coronavirus, and many other infections," she said.

"As schools consider the new parameters for reopening, we need to make sure that they continue to prioritize access to handwashing with soap, clean drinking water and safe sanitation for every child," she added. According to data provided by the child rights body only three out of five people worldwide have access basic handwashing facilities.

"Forty per cent of the world's population, or three billion people, do not have

a handwashing facility with water and soap at home. Nearly three-quarters of the people in the least developed countries lack basic handwashing facilities at home," UNICEF said.

"Forty-three per cent of schools lacked handwashing facility with water and soap affecting 818 million school-age children. In the least developed countries, seven out of 10 schools have no place for children to wash their hands with water and soap," it said.

The global child rights body further said that according to the Joint Monitoring Programme 2019, approximately 60 per cent of households in India have handwashing facilities with soap while the coverage in rural communities is lower.

Meanwhile, the National Sample Survey, 2019, reported that only 36 per cent of households in India washed their hands before eating and only 74 per cent cleaned their hands with soap after defecation, it added. PTI

MUMBAI: Following the fake cal committee review and aug-Television Rating Points (TRP) ment the current standards of scam, the Broadcast Audience Research Council (BARC) on Thursday announced a temporary suspension of weekly ratings of news channels across languages.

The council intends to review and augment the current standards of measurement to improve on "statistical robustness", and the exercise will result in a "pause" in the weekly ratings for up to 12 weeks, an official statement said.

At least five people have been arrested by the city police which busted the scam earlier this month.

Those arrested include news channel employees, while the police is also questioning executives of Arnab Goswami-led Republic Media Group with regard to the case. Republic Media Group has denied any wrongdoing.

"In the light of the recent developments, BARC Board has proposed that it's techni-

Corporates And Business Houses Donated Rs 876 Crore To National Political Parties In 2018-19: ADR

NEW DELHI: Corporates and business houses donated at least Rs 876 crore to various national political parties in the fiscal year 2018-19 and the BJP was the biggest recipient of such funds, followed by the Congress, a study conducted by poll rights group ADR (Association for Democratic Reforms) showed on Thursday.

While the BJP got Rs 698 crore, the Congress came a distant second with a total amount of Rs 122.5 crore, ADR said, citing data made public by the Election Commission of India, to which all parties are required to disclose details about donors and donations above Rs 20,000 in a financial year.

The collective donations totalling Rs 876.10 crore, made by corporates and business houses, accounted for nearly 92 per cent of overall donations received by various national parties during the financial year 2018-19, the report said.

"Out of five national parties, the BJP received maximum donations of Rs 698.082 crore from 1,573 cor-



porate donors followed by Congress tails available online or whose nature which received a total contribution of work is unclear." the report said. of Rs 122.5 crore from 122 corporate donors, and NCP with Rs 11.345 crore from 17 corporate donors," it said.

"Out of the total of Rs 876.10 crore donated by the corporate/ business houses to the 5 national parties in FY 2018-19, Rs 20.54 crore was received from the unsegregated category, which includes companies with no de-

The report said that a total of 319 donations through which national parties received Rs 31.42 crore do not have ad-

dress details in the contribution form. "National parties have received Rs 13.57 crore from 34 donations which do not have PAN details in the contribution form. Rs 13.33 crore or 99.75 per cent of address details worth Rs 13.364 crore belong to the BJP," the report said. In its recommendations, the ADR said all donors who have donated a minimum of Rs 20,000 as a single or multiple donations should provide their PAN details.

"A total of Rs 13.364 crore was collected by the national parties from 274 corporate donors without obtaining their PAN and address details. Such incomplete contributions reports must be returned to the parties by the ECI, to deter them from providing incomplete information," it said.

The report further recommended that corporates should make details of their political contributions available in public domain through their websites (in annual reports or in a dedicated page) for increasing transparency in political financing.

"Annual scrutiny of donations reports of National, Regional and unrecognized parties should be initiated by a dedicated department of the CBDT, to discourage donations from shell comsuch donations without PAN as well as panies or illegal entities," it said. PTI
