udden demise of Mohammad Ashraf Batku on Tuesday night evoked massive condolences across the valley, with many calling it a passing of a man who made the erstwhile state of Jammu and Kashmir's tourism an 'adventurous' sector.

Known as 'tourism man of Kashmir', Batku breathed his last at SKIMS, Srinagar on October 13. He had been unwell for a brief time.

The deceased was a prolific columnist and had four published books on ing Jammu" and "Travels in Ladakh" his name. Two of them "Remember-

Batku was a trained engineer before becoming an administrator. In 1973, he tried to promote adven-

ture tourism in J&K when he gave a project to the State Tourism Department. His accepted pitch promoted him as the in-charge of the wing. He worked tirelessly to promote mountaineering in Kashmir. He was also a patron and current president of the Jammu & Kashmir Mountain-

eering and Hiking Club which is currently the oldest and also the largest hiking club in J&K.

In 1974, when Ladakh was opened for foreign tourism, Batku was extensively involved in developing tourism in this mysterious and enchanting land beyond the Himalayas.

"No it is not an opportunistic alliance. We are political parties so you could hardly term this as a social alliance," he said.

He said that restoration of special status was a single most important issue in front of the people of Jammu and Kashmir today. He said that the politics of the Valley can't be divorced from the issue of special status.

"Whether you oppose what BJP did or you support it, it is still an is-sue in Kashmir, Jammu or for that matter in Kargil and Leh as well. So, this is part of political process, and it is going to be an important component of politics in both these regions," he said.

"At the moment, we are committed to the Gupkar declaration which is why We are coming together to reemphasize that we are committed to fighting, using all constitutional and peaceful means for the restoration of what was snatched from us legally and unconstitutionally on the August 5, 2019 in the parliament of India,"

The NC leader also denied that his father has said that Article 370 will be restored with China's help. He said that Farooq's words were being twisted by the BIP spokesperson to suit their agenda.

"He (Farooq) said China has been commenting on J&K's internal affairs. He said China has taken a position on the renovation of Article 370 and 35A. Those are both facts. China has done that, whether we like it or not," he said.

Omar also rubbished that his father said Beijing had intruded into Jammu and Kashmir because of the Centre's decision to abrogate Article 370 and that the people of the Union Territory would prefer being Chinese citizens.

"All he did was to reflect what some of the people on the ground are saying. All he was trying to give voice to the anger that was on the streets of the Valley with regard to what happened last year on 5th of August. There is a lot of anger, there's a lot of bitterness and resentment about what happened." Omar said.

He also cited his example saying that he faced a backlash over his Twitter post in which he had said that looking towards China was not in the interest of the people of Kashmir.

"He is not advocating a role of China in Jammu and Kashmir. He is telling you what people are saying here," the former Chief Minister said.

He also dismissed claims that the citizens of the Union Territory were angry with his family and the Muftis and said that the anger was not against them.

"This anger is not against Muftis and Abdullahs because if it was, why aren't they quite happily adopting BJP, or the BJP's king's party that has been formed here. Show me a single piece of political activity that these two entities have been able to do," he said.

"Mehbooba Mufti came out after 14 months of detention, my father was in detention for months, I was in detention for nine months. There was more than enough time to create alternatives to us," he added. when asked if he was angry at the central government, the Abdullah responded by asking if a person would come out happy after being detained. He added that he was locked up under the Public Safety Act and was considered a threat to his people. "Why don't you ask those who locked us up?" he asked. Omar's hard hitting comments came barely hours after his party Peoples Democratic Party, People's Conference and other regional groups formed an alliance following a meeting of six Jammu and Kashmir-based parties to discuss the Gupkar Declaration in Srinagar. The other parties include the Communist Party of India (Marxist), Jammu and Kashmir People's Movement and the Awami National Conference.

"We will never ever allow the agenda of the Gupkar alliance to be implemented in J&K and allow it to succeed," he said.

The J&K BJP president warned these alliance partners that if any misadventure is carried out and any "anti-national" agenda is carried forward, they have to face serious consequences. "We will not tolerate it. At no cost their nefarious designs will be allowed to succeed." he said.

Raina said that after the abrogation of Article 370, the common mass in Jammu, Kashmir and Ladakh jumped for joy because Article 370 did criminal injustice with the common people of Jammu & Kashmir. He said that a conspiracy is being hatched by Abdullah Parivar and Mufti Parivar against the Country and we will not tolerate this anti-National move.

"The alliance formed by Abdullahs and Muftis has nothing to do with the betterment of the people of J&K. they are just dancing on the tones of Pakistan and China and demanding the restoration of the Article 370 which is next to impossible because it did criminal injustice to common mass in Jammu, Kashmir and Ladakh'', Raina said.

He said, "Article 370 will not be implemented till doomsday. It doesn't matter how much cry Abdullahs and Muftis make" He further said that Article 370 had given birth to separatism and militancy and also tried to develop Pakistanism in J&K, which gave rise to militancy in which thousands of innocent people got killed.

"We will not tolerate anyone who tries to instigate the people of Kashmir against India," Raina said.

"He has further appealed the family of SPO Altaf to help police in bringing him back," Kumar, as per official spokesperson said.

under relevant sections of the law was registered in Cyber Police Station and investigation was set into motion. During the course of the investigation, the said unknown Facebook user was found operating more than 15 fake Facebook accounts (male and female).

"He had fraudulently obtained a number of SIM cards from the victims which he was using to cheat and deceive the female victims, especially young and destitute girls. The accused by his vicious and wicked plans has grabbed lakhs of rupees from the victims on the pretext of providing them jobs," the police spokesperson said.

He said the modus operandi of the accused included the creation of fake Facebook accounts by using profile pictures of high profile dignitaries mostly associated with politics and the television industry and sending friend requests to the young girls.

The girls, who were attracted by the profiles, would often chat with the accused, who used to impress them with his activities and promises of jobs, said the police spokesperson.

"He made them believe that he could help them in getting jobs and consequently coerced them to pay money. The accused also used to compel the young girls to share their objectionable photos and videos and then used the same for blackmailing. He would make the victims transfer money not into his personal account, but in the accounts of other victims who were cheated in the same manner and subsequently used to collect the amount by sending some other person(s) to avoid getting himself exposed," he added.

the course of the last 30 years and a basis for building that relationship has been peace and tranquillity along the Line of Actual Control. He said there are multiple agreements, starting from 1993, which created the framework for that peace and tranquillity, which limited the military forces that came to the border areas, how to manage the border, how border troops behave when they approach each other. So, from the conceptual level down to the behavioural level, there was an entire sort of framework out there. Now, what we saw this year was a departure from this entire series of agreements. The massing of large amount of Chinese forces on the border was clearly contrary to all of this.

And when you had friction points which have large number of troops at different points very close to each other, then something tragic like what happened on 15th of June happened," he said.

"To underline the enormity of that, it was the first military casualty we had after 1975. So what it has done is, it has obviously had a very deep public impact, very major political impact and it has left the relationship profoundly disturbed."

In response to a question on what did the Chinese actually do on the border and why they did it, Jaishankar said: I haven't frankly got any reasonable explanation that I can tell myself from them on this matter.'

At the special Asia Society Policy Institute (ASPI) event, Jaishankar was in conversation with ASPI President Kevin Rudd, a former Australian prime minister. The two also spoke about Jaishankar's new book The India Way: Strategies for an Uncertain World".

Jaishankar said that apart from the Wuhan Summit in April 2018, there was a similar summit in Chennai last year and the idea of these parleys was that Prime Minister Narendra Modi and President Xi Jinping spend time, talk to each other directly about their concerns. What happened this year of course was a very sharp departure. Now

it's not just a sharp departure from the conversation, it's a sharp departure over a course of relationship over 30 years," he added.

also stop looking at the mainstream political parties and the people of Jammu and Kashmir as "anti-national".

The assertion comes a day after mainstream political parties in Jammu and Kashmir held a meeting and formed an alliance for restoration of the special status of the erstwhile state as it existed before August 5 last year and also to initiate a dialogue between all stakeholders on the issue.

"The coming together of mainstream regional parties of J&K to fight a constitutional battle to restore the rights of the people of Jammu, Kashmir and Ladakh is a development that must be welcomed by all the people of India," he said on Twitter.

"The Congress also resolutely stands for restoration of the status and rights of the people of J&K. The arbitrary and unconstitutional decisions of the Modi government of August 5, 2019 must be rescinded," the former Home Minister said.

"The central government must stop looking at the mainstream parties and the people of J&K as secessionist or anti-national." he said. After a meeting Thursday at the residence of National Conference president Farooq Abdullah which was attended by PDP president Mehbooba Mufti, Peoples Conference chairman Sajad Lone, Peoples Movement leader Javaid Mir and CPIM leader Mohammad Yousuf Tarigami, the NC chief said they decided to formalise the alliance and it was named 'Peoples' Alliance for Gupkar Declaration'.

The alliance will strive for restoration of the constitutional position in respect of Jammu and Kashmir as it existed before August 5 last year, he had said.

he Police spokesperson added that the accused used to frequently change his mobile phones and SIM cards and create new Facebook accounts in the name of senior government employees and convinced the victims that they too had been provided jobs by him.

During further investigation, he said the accused was found to have used various devices and had cheated more than 100 destitute and young girls belonging to Kashmir as well as Jammu Division who were in desperate need of government jobs.

"During questioning the accused person admitted that he was inspired by a famous TV serial "Crime Patrol" and he learnt the modus operandi of social media crimes by watching the said serial. Further, one accomplice of the accused who used to provide fake SIM cards to him was also arrested. More arrests in the case are expected," he added.

Property Worth Crores Of... Chief Supervisor, FCI Godown, CA&PD Udhampur and Incharge Vigi-

Chopper To Be Used For Medical Emergency

RINAGAR, OCTOBER 16: In another welfare measure for the underprivileged, Lieutenant Governor Manoj Sinha on Friday approved the use of Raj Bhavan's helicopter free of cost for emergency evacuation of patients living in the remote areas of Jammu and Kashmir.

During his string of remote areas visits as part of the Back to Village programme, the Lt Governor acknowledged the hardships faced by villagers, especially during severe winters when most of the hilly areas owing to difficult terrain remain cut off from the major towns and district headquarters.

To assuage the sufferings of the people living in these areas, the Lt Governor approved the use of Raj Bhavan's Bell 407 across the UT to airlift patients who face medical emergencies and cannot afford the regular chopper services.

To ensure that the facility is effectively utilized, the concerned Deputy Commissioner and the Chief Medical Officer of the district shall submit a certificate indicating the urgency of situation, the income status of the patient, and the reason for airlift as and when the requisition is raised.

The service shall exclusively cater to the emergency airlift of patients who fall below the poverty line and cannot even afford to pay the subsidized charge for the helicopter service which is already in place and available at the disposal of both the Divisional Commissioners.

NEW DELHI: US Secretary of State Madeleine Albright will make a "sentimental and personal" visit to Kashmir before her term runs out this year, a daily said Wednesday.

Quoting state department sources in Washington, the Business Albright was keen to visit the divided Kashmir where her diplomat father, Josef Korbel, served as a UN observer.

"All senior state department officials have to routinely submit their resignations on January 19, 2001 when the new US is sworn in." the daily said

"Whether she will get her job back if the Democrats return to power is an open question But before that hap¬pens, Albright feels she owes it to the memory was the crowning glory of his career.

Korbel was appointed Czechoslovak ambassador to Bel¬grade when he was 36. Later in 1948, he was persuaded to take up the post of Czech representative to the UN commission which was supposed to mediate on the Kashmir question.

Korbel found there was little the UN could do to solve the problem-which has led to two wars and a military conflict between arch-rivals India and Pakistan since their 1947 independence from British rule.

According to Michael Dobbs, Albright's biographer, Kor¬bel also took up the job of her father to visit Kashmir presi-dent is sworn in, and the (UN) observers' office because it would enable him to cross the Iron Curtain with his family. which he did, choosing the United States as his new country.

Albright has been actively involved with the Kashmir issue in her present job. Dobbs said that Albright was very attached to her father and cherished his stint in Kashmir.

Dobbs claimed that when President Bill Clinton named Albright US envoy to the UN the first thing (she) did was to arrive in her office and unpack a framed photograph.

"It showed Josef Korbel and other members on the UN commission on: Kashmir. starting off for the Indian sub¬continent in the summer of 1948." "In the winter of 2000, Albright will make a similar journey" the paper said. (Kashmir Observer, October 17, 2000)

India Inc. and India's healing

Like America, India needs to heal; the nation is dangerously divided.

Like America, India needs to heal, too; the nation is dangerously divided along religious lines. But the Indians can't rely on Modi to bring the country back together. n Nov. 3, Americans will decide if they want President Donald Trump to run their country for four more years or former Vice President Joe Biden should replace him. Their likely pick is Biden, based on opinion polls.

It is not at all surprising that U.S. voters have turned against the populist president. Trump has given them ample reasons. He has mismanaged the Covid-19 pandemic, the disease that has so far killed more than 210,000 Americans and brought the world's largest economy to its knees.

What is amazing, however, is how quickly misfortune befell Trump who seemed invincible just months ago. His bad luck foretells the fate of communal politicians, including Prime Minister NarendraModi.

To be fair, Modi has handled the Coronavirus better than Trump, even though the prime minister's score card is nothing to brag about. His main test, however, is going to be how he puts India's economy back on the right track. India's growth will shrink by 10.3 percent this year, according to the IMF, and per capita income will dip below Bangladesh's. By way of comparison, Bangladesh's GDP was 40 percent smaller than India's before Modi took over in 2014.

To ride out tough times, a leader must maintain domestic tranquillity and enjoy public trust. Modi has fractured the nation and sent the economy into a tailspin. When populist leaders like Modi squander political capital, they walk on thin ice.

Trump has caused deep anxiety among many Americans by playing highly racially charged politics. Barry Sternlicht, a billionaire corporate mogul, is among those worried about America's future. Once a Trump ally, Sternlicht is chairman of Starwood Capital Group, an investment fund that manages \$60 billion in assets. He made a name for himself in corporate America as founder of Starwood Hotels. Being in real estate, he had a natural affinity with fellow real estate tycoon Trump. But no more.

India needs to heal

Sternlicht is no way connected to India or anything Indian. But the way this American business executive talks about Trump these days is something that might resonate with many Indians.

"The nation needs to heal, and I think we need to get back together, and I don't think we're going to to that with the rhetoric from the right " Sternlicht recently lamented on CNBC television. To reunify America, he wants a healer in the White House. Biden is his probable choice. Like America, India needs to heal, too; the nation is dangerously divided along religious lines. But the Indians can't rely on Modi to bring the country back together. Like Trump, Modi is the divider-in-chief, and both of them use the same dirty tricks to energize their respective bases just to stay in power. When Modi was swept into power, despite his religious bigotry as chief minister of Gujarat, many Indians hoped he would stay clean as the nation's chief executive. India's prime minister and Gujarat's chief



minister are two different political animals. India's top leader takes the high road, leads the world's largest democracy, doesn't stoop down to nasty sectarian politics and split apart a nation that 1.4 billion Indians call home.

Because of his good economic showings in Gujarat, people also expected Modi to shape up India's economy — to give it a stiff dose of pragmatism and put it on the fast track to prosperity. Sadly, his record is bleak, as is Trump's. Modi's performance in foreign affairs is equally dismal.

Modi's Indo-Pacific trap

Trump created a circus by first warming up to North Korea's Kim Jong-un and then retreating into hibernation. Modi did the same by first embracing Prime Minister Nawaz Sharif and then ratcheting up tension with Pakistan. Trump is now locked in a fistfight with President Xi Jinping of China, and Modi is trapped in the Indo-Pacific conundrum, a ghost of the SEATO, a 1950s' U.S.-inspired military pact that included Pakistan.

Worst of all, Modi has played the Hindutva card rile up his fanatical saffron warriors to stir-up trouble. He has played provocateur by revoking Kashmir's constitutional autonomy. For political purposes, he cheered up his lapdogs to propagate that India would use its military to wrest control of Pakistan-administered Kashmir and make the dream of "Akhand Bharat" come true someday. All of his predecessors, including the two immediate-past prime ministers, Manmohan Singh and AtalBehari Vajpayee, sought peace with Pakistan. Singh came very close to a deal with President Pervez Musharraf. Modi has pushed everything back. His mishandling of boundary, water and trade issues with Bangladesh and Nepal has vitiated the environment in the neighborhood. India's smaller neighbors are tilting toward China. With their backs against the wall, today the Kashmiris would even welcome Beijing's intervention in Kashmir.

Violence made Muslims meek

Soaring violence against Muslims has made India's largest minority group timid and meek. Black Lives Matter enjoys a groundswell of popular support in America. But sympathy for the Muslims is nonexistent among common Indians.

Unlike American CEOs, India's business executives have been mum on the rise of the far-right; they have failed to denounce Hindutva supremacists. Facing criticism online, The Tata Group just this week caved in and pulled out an ad, showing a Hindu bride receiving affection from her Muslim mother-in-law at a baby shower. India's famous conglomerate had no guts to stand up to religious bigotry.

Last month, U.S. financial giant Citigroup Inc. found that racial bias cost America \$16 trillion in wealth during the past 20 years. The U.S. economy would add \$5 trillion over the next five years if the social injustice issue was addressed today.

India's loss from its sectarian curse has yet to be calculated, but no doubt the number would be staggering. India has suffered far too long both socially and economically from this debilitating menace. It's now high time for India Inc. to end its deafening silence and help India heal.

mnesty International India is part of an Amnesty International global human rights movement. It is one of the world's most significant human rights organizations thatholds governments accountable for human rights violations. It has also been a recipient of the Nobel Prize.

Last month Amnesty International shut shop in India and laid off all its Indian employees. It was the fifth time that they were compelled to do so by the Government of India. They were accused of violating Indian laws and illegally receiving foreign funds for advocacy work. Their bank accounts were also frozen.

"Human rights cannot be an excuse to defy the law," Amnesty International was categorically told. The Government of India believes that the reports released by Amnesty International are "exaggerated and far from the truth."

Similar things have happened to Amnesty International in Russia and Turkey, neither of which are democracies. In Russia, the flimsy excuse given to the watchdog while deporting them from the country was that their lease had expired!

Liberal intellectuals all over India see the government's hounding of Amnesty International as a witch hunt. As Sreenivasan Jain of NDTV 24x7 said, "The government treats Amnesty International like a terrorist outfit." According to Vrinda Grover, Amnesty International was asked to leave India because they were asking inconvenient questions about the abuse of power by the government.

Mr. Aakar Patel,Amnesty International's India head, believes that removing them from India is an act of revenge on the government's part for theircritical coverage of the situation in Jammu & Kashmir after the abrogation of Article 370 in August 2019. He also attributes the hostility to their

reportage of the Delhi riots in February this year. These investigations have ensured that Amnesty International has been continuously harassed by the CBI and the Enforcement Directorate for the past one year.

In August this year, Amnesty International released a 'Situation Update' regarding life in Jammu & Kashmir a year after the abrogation of Article 370 and the downgrading of the state into two union territories. They gathered data from 37 sub-districts and twelve jails across Jammu & Kashmir. Their findings revealed that as many list of political leaders and journalists who have been arrested may be found in Amnesty International's Situation Update.

Amnesty International calls the abrogation of Article 370 "alienation of the people of the state" as the people were not consulted about the abrogation as they should have been. The abrogation, it pointed out, was characterized by a clamping down on press freedom, a curbing of free speech, and a silencing of the opposition. There were also severe restrictions imposed on 4G internet access, affecting sectors like health and education.

as 1249 people were detained by the authorities without a trial and without any specific charges levelled against them. This, in spite of the fact that there is a provision known as habeas corpus in the Constitution, which holds that no one can be arrested without a fair trial by a magistrate.Unsurprisingly, of the 1249 people detained, over 90 per cent are from the Kashmir valley. A detailed According to Amnesty International, after the 24th March lockdown triggered by the coronavirus pandemic, many overcrowded prisons in Jammu & Kashmir became Covid-19 hotspots, as rules regarding social distancing, the wearing of masks, and hand hygiene were openly flouted.

As for the Delhi riots of February 2020, Amnesty International has said that the police com-

mitted serious human rights violations by beating up protestors, torturing detainees, and what is worse, sometimes joining hands with Hindu rioters to attack Muslims.

Though the police deny the charges and are yet to come out with a detailed response to Amnesty International's report, it must be borne in mind that similar conclusions about the Delhi Police's biased involvement in the riots were made by BBC. Amnesty International, however, does not believe that in spite of video evidence that shows that the police sided with Hindus and gave them stones to hurl on Muslims, the latter would take action against their own men. The atrocities committed by the police during a riot are swept under the carpet more often than not.

What redress does Amnesty International have? It plans to approach the Karnataka High Court against the government's decision to send them packing. But it is anybody's guess whether the judiciary will come out with a judgement in their favour. A decision may be granted in their favour, though, if one thinks of how courts have refused to prosecute and convict several people who have been wrongly charged with sedition under Section 124 A of the Constitution by the Government of India. If that happens, our faith that India is a democracy and not an autocracy like Russia or Turkey will be restored. If not, we have no option but to sulk and live in fear. Tomorrow, there may be a midnight knock on our door.

Genetic Purity, A Hoax

ar-right white supremacist ideology is on the rise in Europe, North America and Australia. It appeals to a racist notion whereby many white supremacists see themselves as members of a "pure" race that is at risk of dilution and contamination.

Science does not support the idea of pure races with ancient origins. In the past few years, genetic sequencing of ancient and modern humans and related species has given us a flood of new information about how human populations have evolved.

The evidence reveals a history of ongoing genetic mingling, due to interbreeding between different populations and even species. Humans from different groups had children together, and even with Neanderthals and members of other now-extinct hominin species.

This mingling occurred constantly in the long process of human migration across the globe. Europeans inhabit one region of a large genetic continuum and are no more or less "pure" than any other population.

From Africa to the world

The genetic history of humanity begins in what we now know as Africa. The exact location (or locations) of the first anatomically modern humans is debated, but there is a consensus they lived south of the Sahara desert between 100,000 and 200,000 years ago.

A group or groups of these early humans migrated out of Africa and into the Middle East, as we now know it, some time between 50,000 and 70,000 years ago. Next, some went east into Asia while others headed west into Europe.

At some point, the wandering humans met and bred with Neanderthals. These now-extinct hominins had left Africa many thousands of years earlier.

Modern Asians and Europeans

still carry genetic signatures of Neanderthals, while sub-Saharan Africans do not.

The humans that migrated east into Asia also met and bred with other extinct species of hominins, including at least two major injections of genes from a group we call Denisovans.

Early modern humans almost certainly bred with other ancient hominins as well, because interspecies breeding was likely common. The remains of a girl with a Neanderthal mother and Denisovan father have recently been discovered. Another recent study has shown some Neanderthals too carried traces of human DNA.

Genetic diversity leads to greater fitness

Genetic diversity, as measured by a metric called heterozygosity, decreases with geographic distance from Africa. Higher heterozygosity is generally associated with greater genetic fitness for survival.

From this perspective it could be argued that, when the humans who walked away from Africa lost genetic diversity through living in small groups, they also lost genetic fitness. By the same argument, interbreeding between populations increases fitness.

In fact, Europeans probably benefited from picking up some Neanderthal DNA: these genes are thought to have diversified their immune systems and may have contributed to their lighter pigmentation.

Humans who migrated west into Europe continued to meet and breed with other human populations.

Another wave of humans from what

we call Anatolia (roughly modern-day Turkey) followed the initial spread of humans into Europe. The Yamnaya population from what we now know as the Russian steppe migrated west into Europe between 3,000 and 5,000 years ago. In fact, little genetic trace remains of the first human inhabitants of Europe, as they were continually supplanted by others.

Even the Roman civilisation, considered to be one of the historical foundations of European identity, was home to great genetic variety. A recent study looked at the genomes of 127 people from 29 sites across the past 10,000 years. It found an initial wave of hunter-gatherers had been supplanted by an Anatolian population, and during the age of Imperial Rome (27 BC to 300 AD) there were significant introductions of genes from what is now Iran and the eastern Mediterranean.

Even Vikings were diverse

Blonde-haired, blue-eyed northern Europeans are considered by many white supremacists as the ideal of racial purity. They are epitomised historically by the Vikings.

However, the reality was different. A recent study of 442 human genomes from archaeological sites across Europe and Greenland found substantial ancestry from elsewhere in Europe entering Scandinavia during the Viking Age. In fact, Vikings were more likely to have dark hair than modern Scandinavians.

In short, the idea of a pure white race has no basis in genetics. Lightly pigmented skin, hair and eyes are simply an adaptation to northern European climates (and represent an inferior adaptation in equatorial regions). These features exist in a background of countless other genetic influences borrowed from many populations, old and new.

"Starting in March 2020, as the virus began to spread in the GCC, all of these governments have issued statements to all people in the country warning of criminal liability for publishing 'false news' or 'spreading misinformation'," Amnesty said in a statement

The countries went on to prosecute individuals who posted on social media about the viral outbreak or the government's response to it.

Amnesty said none of the social media restrictions imposed were necessary to protect public health in the countries. It also said the penalties for critical or "misleading" posts were disproportionate

There is an important deliberation going on to decide what should be the ideal age of marriage for daughters," Modi said. The prime minister said he has been receiving letters from women from across the country, asking about the report of the committee and when the government will take a decision on it.

"I want to assure them, the government will soon take its decision after the submission of the report," Modi said. In his Independence Day speech, the prime minister had announced that the

government was deliberating on what should be the minimum age of marriage for women and has set up a committee to look into the matter.

Currently, the minimum age of marriage is 18 years for women and 21 for men.

Modi highlighted the efforts taken by his government in the last six years to fight against malnutrition.



The prime minister said his government has taken an integrated and holistic approach to deal with the challenge of malnutrition.

The government has adopted a multidimensional strategy to work on all those factors responsible for high malnutrition, he added.

Supreme Court Steps In After High Court Tells Molester To Get Rakhi Tied From Woman To Get Bail

NEW DELHI: The Supreme Court to- traordinary circumstance. day sought Attorney General's assistance on a plea for stay on the Madhya Pradesh High Court order which granted bail to an accused in a molestation case on the condition that he would request the woman to tie him 'Rakhi'.

A bench headed by Justice AM Khanwilkar issued notice to the office of Attorney General KK Venugopal on an appeal filed by nine women lawyers who have said that courts across the country should be restrained from imposing such conditions as these are against the principle of law.

The high court, in its July 30 order, had granted bail to the accused and imposed a condition that he along with his wife shall visit the house of the complainant and request her to tie 'Rakhi' to him with the promise to protect her to the best of his ability for all times to come.

Senior advocate Sanjay Parikh, appearing for the petitioners including lawyer Aparna Bhat, told the bench that the appeal has been filed in a ex-

The trauma of the woman is trivialised by such conditions, Mr Parikh told the bench, also comprising Justice BR Gavai.

These kind of conditions are imposed which are against the principle of law. Repeatedly such observations are being made, he said.

Are you making the submission only for Madhya Pradesh or for the entire country, the bench asked.

To this, Mr Parikh said he is making submission with regard to entire country and the petitioners have made pravers to restrain courts, including high courts and trial courts, from making such observations.

The bench, which said it is issuing notice to the office of the top law officer of the country, posted the matter for hearing on November 2.

In their appeal, the petitioners have sought stay of the bail condition imposed on the accused by the high court. The plea said that substantial questions of law, including whether in a



case seeking bail it is appropriate for a court to impose extraneous conditions which allows contact between the accused and the complainant, is involved in the matter.

Whether the bail condition which is impugned herein stands to further victimise the complainant and trivialize the trauma that she has suffered, the plea said, adding, Whether the above mentioned bail condition is in line with the principles that govern trials within the criminal justice system?

It said another question of law which arises for consideration of the top court in the matter is whether the High Court ought to have employed circumspection and sensitivity while dealing with a case involving a sexual offence having been committed against a woman.

The high court erred in imposing a condition that defeated the very purpose of granting bail by directing the alleged perpetrator to establish contact with the woman, the plea said.

It alleged that imposing such a condition results in further victimisation of the survivor in her own house.

In the context of Rakshabandhan being a festival of guardianship between brothers and sisters, the said bail condition amounts to gross trivialization of the trauma suffered by the complainant in the present case, it said, adding that the alleged incident is said to have been committed by the accused by forcibly entering the complainant's house.

While it is routine for courts to award certain compensation to survivors of sexual offences to be paid by the accused, it is highly objectionable for the high court in the present case to put the complainant in a position where she is forced to accept the sum of 11,000 as part of the customary
