5 Militants Killed In Twin South Kashmir Encounters

SRINAGAR: Five Lashkar-e-Taiba and Hizbul Mujahideen militants were killed in two separate encounters with the government forces in twin districts of Pulwama and Kulgam in south Kashmir, police said Tuesday.

Acting on a specific input about the presence of militants, army's 50 RR, police and the personnel of CRPF 183 battalion laid a siege around Hakripora area of Pulwama and launched a cordon and search operation, a police spokesperson said. The militants hiding in the village, he said opened fire upon the search team after rejecting the surrender offer.

The search team retaliated to the fire triggering off an encounter. In the exchange of fire, three militants were killed and their bodies retrieved from the site of encounter," the police spokesperson said.

He claimed that the killed militants were involved in Monday's attack in Pulwama in which a CRPF man was injured.



their identification at PCR Kashmir Srinagar," the police spokesperson said. In another operation that started in Melhora area of Shopian district on Monday evening, the police spokesperson said 2 militants were killed.

State forces launched a cordon and search operation in the area Monday evening following specific inputs about the presence of militants there, he said. He said the search operation turned into an encounter after militants fired upon a forces party, who retaliated.

"One militant was killed in the initial exchange of fire between the two sides last evening, while another militant was killed when the operation was resumed in the wee hours today," the police spokesperson said. He identified the militants as Towseef Ahmad Khandav and Umar Thoker from Kulgam, both affiliated with Hizbul Mujahideen outfit. "Both of them were involved in recent attacks in Kulgam-Shopian areas," the police spokesperson said.

He said that keeping in view the prevailing pandemic, the bodies of the militants shall be sent to Baramulla for burial after completion of all medico-legal formalities.

"The nearest family members of the killed militants shall be allowed to participate in the last rites. In this connection a case under relevant sections of law has been registered and investigation has been initiated," he said. "People are requested to cooperate with police till the area is completely sanitized and cleared of all the explosive materials, if any," he added.

NIA Files Charge-sheet... its proceeds to Pakistan and militants based in Jammu and Kashmir,

The 14,000-page charge sheet was filed before a special NIA court in Mohali under relevant sections of the IPC, the Narcotic Drugs and Psychotropic Substances Act, the Unlawful Activities (Prevention) Act and the Indian Passports Act.

Hilal Ahmed Shergojri (35) of Pulwama; Bikram Singh (27), Maninder Singh (22), Ranjit Singh (41), Gagandeep Singh (27), Iqbal Singh (24) of Amritsar; Ranjit Singh (42), Jaswant Singh (25) of Gurdaspur; Zafar Hussain Bhat (52) of Anantnag, who is presently in Pakistan; and Naikoo have been named in the charge sheet, the spokesperson of the National Investigation Agency (NIA) said.

Naikoo was killed by the Army earlier this year. The case pertains to the arrest of Shergojri and recovery of Rs 29 lakh from his possession by Punjab Police on April 25.

The NIA, after taking over the investigation on May 8, found that Shergojri, who had come to Amritsar to collect Rs 29 lakh, was a member of Hizbul Mujahideen (HM) and a close associate of Naikoo, the then HM commander of Kashmir Valley, the official said.

This led to the busting of a major narco-militant module involved in smuggling and selling of heroin in India, and channelising of drugproceeds to Pakistan through hawala and to the Hizbul Mujahideen militants based in Jammu and Kashmir, according to the official.

Investigation also unearthed the conspiracy hatched by the Pakistanbased HM commanders and their associates, and militants gangs in Punjab to support and augment the militancy infrastructure of HM in India by raising money through drug smuggling/drug peddling, the NIA spokesperson said.

During investigation, it emerged that the accused had received at least six consignments of heroin through the Indo-Pakistan border in Attari in the garb of importing rock salt granules from Pakistan, the official said. Of these, money proceeds of five consignments were partly sent

back to Pakistan through hawala operators while a substantial portion was channelised to HM militants in Kashmir through a network of overground workers and other associates, the NIA official said. In July 2019, the 6th consignment of around 532 kg of heroin was seized at Attari border and a separate case was registered. The NIA investigated the case and filed a charge sheet.

During investigation, the NIA carried out searches at 15 locations in Punjab, Haryana and Jammu and Kashmir.

So far, Rs 98.5 lakh, eight vehicles and three kg of heroin have been seized from the accused and investments worth several crores of rupees have been identified.

During searches, incriminating documents relating to benami properties and gadgets, including mobile phones, pen drives and laptops, were seized and forensically examined.

Many incriminating chats between the accused have been recovered from the seized digital devices, the NIA spokesperson said, adding that further investigation in the case was underway.

China Asks India To Return...

Army (PLA), has been identified as Wang Ya Long and he will be returned to the Chinese military at the Chushul-Moldo border point after completion of formalities.

"China hopes that India will hand over soon the Chinese soldier who

got lost in China-India border areas on the evening of October 18 when helping local herdsmen retrieve a yak at their request," said Senior Colonel Zhang Shuili, spokesperson for the Western Theater Command of the PLA said in a statement on Monday night.

"The PLA border troops informed the Indian military right after the incident and hoped the Indian side would aid in search and rescue, and the Indian side promised to offer help and return the missing soldier timely after finding him, he said.

The latest information from the Indian side is that the lost Chinese soldier has been found and will be handed over to the Chinese side after receiving medical examination, Col. Zhang said.

"We hope that the Indian side will live up to its promise to hand over the missing Chinese soldier as soon as possible and implement the consensus reached by the two sides in the 7th round of Senior Commanders meeting, so as to maintain peace and tranquillity in the border areas," Zhang said.

"With the establishment of family court, J&K made an effort to develop a sensitive system and processing of family matters expeditiously, at the first place. We recognize that the proceeding before family court are conciliatory and not adversary as ours is a land of diversified culture, local customs and various conventions," she said, as per official spokesperson.

"The Chief Justice said that so far 1100 cases have been recognized and transferred to Srinagar family court and such figures may increase as the process of identification of cases is underway," he added.

The official spokesperson further said that Chief Justice emphasized for urgency to establish family courts in every district saying as soon as resources and man power is available the process would be started so as to ensure expeditious justice in family court matters.

"We have already undertaken an exercise for which the committee is working on and is identifying space for the family court in Jammu and hopefully we will shortly establish a family court in Jammu also as well as in other districts," she added.

280 Proposed Constituencies...

Next day, the administration of the UT framed Rules for implementation of the amendments requiring deputy commissioners to divide entire area of DDC of a district into 14 territorial constituencies.

Spread over 20 districts, J&K UT will have 280 such constituencies as each district will have 14 such segments spread over Panchayat areas According to the amendments in Panchayati Raj Act, only elected members of territorial constituencies will have voting rights to elect or remove chairmen of district developments, even as MLAs of J&K UT and chairpersons of block development councils will be members of DDC. "All members of district development council, whether or not elected by direct election from territorial constituencies in the district shall have the right to vote in the meeting of the district development

The term of DDCs shall be five years except for holding common elections to all the tiers of the Panchayats simultaneously so that all the

tiers have co-extensive terms in the district. The provision of disqualification for elected members of DDCs shall

While a faction headed by AJKPC president Anil Sharma earlier welcomed the amendment and said the people of the union territory were waiting for over 70 years to see real empowerment of the local bodies, its chairman Shafiq Mir described the amendment as an attempt to disempower the newly established Panchayati Raj System in the Union Territory.

The Jammu and Kashmir government had on Saturday amended the Jammu and Kashmir Panchayati Raj Act to provide for setting up of District Development Councils (DDC) in each district which will have directly elected members.

The DDCs of each district shall have 14 constituencies after their delimitation by the respective deputy commissioners, an official spokesperson had said, asserting that the move marked the implementation of the entire 73rd Amendment Act in the UT.

Flanked by several Block Development Council (BDC) chairpersons including Arun Kumar Sharma, Surinder Kumar Bhagat, Sarshad Natnoo, Brijeshwar Singh and Aftab Ahmad Beig, AJKPC chairman Mir demanded a rollback of the amendments and said by such order, doors have been opened for political activists to enter this institution which is clear injustice and has demoralised the panchavat leaders.

Not only this, by this amendment, the elected BDC chairpersons will not have any right to vote or to contest the district chairman election which is against the spirit of Panchayati Raj Act, Mir, who is also BDC chairman from Bufliaz in Poonch district, said. On the other hand, AJKPC president Anil Sharma welcomed the recent

amendments in the J&K Panchayati Raj Act and said the people of the union territory were waiting for over 70 years to see "real empowerment of local bodies". He, however, cautioned the panches and sarpanches to remain vigi-

lant from "negative forces who are always inimical to India and democracy and might mislead the public on one pretext or other". Sharma congratulated Prime Minister Narendra Modi and Union Home Minister Amit Shah for taking such historic and courageous steps to empower the panchayati raj institutions in Jammu and Kash-

"All the people of Jammu and Kashmir were waiting for over 70 years to see real empowerment of local bodies and it is time to celebrate

when the decision is announced to give real autonomy to rural local bodies," he told reporters here.

Calling it a "historic move", Sharma said "with these amendments, all major provisions of 73rd Amendment of Indian Constitution have been extended to Jammu and Kashmir. This is what panchayat members had been fighting for".

Sharma said around 40,000 elected panchayat members of the union territory are hopeful and request the union government to immediately announce the elections of the vacant panchayat seats and also hold parallel polls of the territorial district constituencies.

He also demanded that these elections must be conducted on nonparty basis as panchayati raj institutions are meant for community development and must not be dragged into political issues.

"The AJKPC is also hopeful to get good news soon with regard to constitution of separate Election Commission and Financial Commission for panchayats as they have been promised that the government is mulling to constitute a separate Election Commission that would hold timely elections of panchayats without any interference from the regional government," he said.

Sharma also paid homage to all those panches, sarpanches and Block Development Council (BDC) members who laid down their lives for strengthening this institution and demanded adequate relief to the family members of those who were killed during the last 10 years. Without identifying anyone, he said panches and sarpanches need to remain vigilant from negative forces who are always inimical to India and democracy.

"These individuals and organisations might mislead people and panches, sarpanches or the BDC chairperson on one pretext or the other (with regard to the recent amendments)," the AJKPC president

Criticising the previous governments at the Centre and in Jammu and Kashmir, he said they had only made "hollow promises" with people, especially with the elected panchayat members but none of them were sincere to strengthen them.

The Guild has called on the administration to unseal the premises from which Kashmir Times and KNS offices were operating from "till the due process of law comes out with a solution.

Guild has asked authorities to revisit the Media Policy and make it a 'forward-looking professional document rather than an early twentieth century dictate'.

"The Guild takes this opportunity to request the stakeholders in media and society to avoid resorting to the vilification of the Kashmir media because it helps nobody to prosper."



'Missing' ITI instructor's body found buried

SRINAGAR: A dead body retrieved from supposedly unused portion of a graveyard in Tangmarg has sent shock waves throughout Baramulla district and reliable sources have said the body is that of an instructor who, along with his brother, was picked up by security forces during a pre-dawn raid in September According to reports, the victim's brother has identified the corpse. The ITI instructor, Muhammed Jamal Najjar and his brother, Abdul Rasheed, had been arrested by the 22nd RR during the night intervening 19th and 20th of September from Noorpur Jaagir, Sopore. While Rashid was dumped half-dead in Bandipora on the 10th of this month, nothing was known about

Tangmarg residents came upon the body while they were preparing a grave in a cemetery at Hardhoora, Tarhama. The discovery stunned residents as no one had been interred in the vicinity of the spot recently; and neither the body was not in advanced state of decomposition,, the locals Informed the police, It was soon that people began to connect the body with the September disappearance. Rasheed, who rushed to Taarhama on hearing of the corpse, identified the body as that of his brother.

Speaking to this news agency, IG Baramulla, Dilbagh Singh said that Muhammed Jamal and Abdul Rasheed had 'mysteri¬ously disappeared' during the night Intervening the 19th and 20th of September, and when certain quarters raised the pos¬sibility of the body recovered in Taarhama being that of Ja¬mal, the body was exhumed by the civil and police authorities of the district. The incident is being viewed in the district as custodial killing. The body has been taken to Sopore, and anger against the security forces is palpable in the town.

Bihar polls

ihar is going to polls and this time the situation is opposite of what it was in the last Assembly election. Unlike last time when Nitish Kumar was part of a Mahagathbandan along with the RJD of Lalu Prasad Yadav, he is now a part of the NDA. And it remains to be seen whether Kumar pulls off yet another victory this time. He has already been Bihar Chief Minister for two successive terms and for the better part of his career has been an alliance partner of the BJP. Though in the run up to last Assembly election in 2015, Kumar had formed a broad anti-NDA alliance alongwith Lalu Yadav and at the time it had stopped the then reigning Narendra Modi juggernaut in its tracks in the state. Mahagathbandan had defeated the BJP fair and square. Kumar became the Chief Minister but he soon ditched Lalu Yadav and went back to the BJP. At the time, it was seen as a betrayal of the Mahagathbandan mandate. But this didn't faze Kumar. Ever since, it hasn't appeared even once that Kumar has stood to lose because of this. Nor does it appear this time that the RJD stands to gain in the ongoing election because of this.

Kumar was once a leading light of India's secular political block. And for a while, he had successfully set himself up as the most prominent proponent of secularism in the country. But his dramatic return to the NDA fold was a betrayal of the secular ideal he had once so aggressively claimed to stand for. Would he have to pay for this betrayal in the current election? Nothing is clear as of now. Kumar's by and large good governance is expected to bail him out. But at the same time the RJD is no pushover. Lalu may be in jail but he continues to enjoy a dogged support among his vote-bank, a significant section of which is comprised of Muslims.

Also at stake is not only the mundane question of who rules Bihar over next five years but where the India is headed as a country. A win for the Grand Alliance will arrest the disarray among secular forces and give them confidence to stand up to Modi in the upcoming state elections. One such being the all important polls in West Bengal. But a victory for Kumar and the BJP will only reinforce the political invincibility of Modi. So a Kumar victory will be once again an emphatic endorsement of the PM Modi's six years in government. This would mean the opposition will have to start from the scratch again to take on the overarching figure of the PM Modi. But for now all we can do is to stay with our fingers crossed.


A tool for thought

committee of experts - well-regarded mathematicians and infectious disease experts — appointed by the Department of Science and Technology to use mathematical modelling and forecast the course of the pandemic has brought good tidings. By their estimate, India passed its COVID-19 peak in September and the decline in the overall caseload being observed for nearly a month now is to continue. Active cases, about 7.5 lakh now, are expected to drop below 50,000 by December, and by February, the pandemic is likely to extinguish itself with only 'minimal' (not zero) infections. While it is reasonable to assume that the seven-member committee has been scrupulous, the caveat is that this is still a forecast based on mathematical modelling. There are some strong assumptions. The decline will continue only if there are no major mutations during winter, protective antibodies are durable, and current restrictions are maintained. There would be no significant gains from a strict lockdown beyond the district level, and current containment measures would suffice, except if there are local outbreaks that threaten to overwhelm healthcare facilities there. Their calculation also showed a peak by July latest, with anything from six to 15 times the existing infections had there been no lockdown or if it had been delayed

The latest model is expected to be published in the Indian Journal of Medical Research this week, but it appears to be a quotidian exercise. The datasets it has relied on are publicly available and the modelling employs a category of models called SEIR that estimates, within a population, those Susceptible, Exposed, Infected and Recovered.

Experts associated with the pandemic have reiterated many times that mathematical modelling ought not to be taken literally. The latest assessment too should then be used not to critique or justify past decisions but dwell more on the future. For instance, if the model suggests that the pandemic would extinguish by February with a dramatic dip by December, then should the accelerated clinical trials of potential vaccines be top priority? Mathematical models, to be useful, must induce policy or behavioural change to avoid their own worst-case scenarios and this latest assessment must be seen — no more, no less — as a tool to this end.

People's Union needs regional alliance

As of now, the Gupkar coalition has only a symbolic value. Key to its relevance will be its ability to draw support from Jammu and Ladakh

oon after Mehbooba Mufti's release from 14 month long detention on October 14 she issued an evocative audio statement that called for a sustained struggle for the restoration of Article 370 that granted J&K an autonomous status within Indian Union. She termed "the illegal, unconstitutional and undemocratic" erasure of J&K autonomy as a "daylight robbery" and narrated how the pain of the loss of the autonomy had been "lacerating" her mind and soul during the period in detention.

Her freedom has since lent some momentum to the otherwise defunct mainstream politics. Six political parties who are signatories to Gupkar Declaration met again at the National Conference leader Dr Farooq Abdullah's residence to formalize a structure, to evolve an agenda and to give the alliance a proper name.

Later talking to reporters, Abdullah said theirs was a, "constitutional battle to ensure the return of all the rights which the people of Jammu and Kashmir, including Ladakh, enjoyed before the abrogation of Article 370".

More importantly, the parties this time didn't limit their demand to restoration of Article 370 but sought a solution to the larger Kashmir issue. "We want steps taken for the resolution of the Kashmir issue. All the stakeholders should be taken on board in this regard".

Inclusion of the resolution of Kashmir issue in their agenda subsumes the Kashmir settlement formulae of National Conference, the PDP and the People's Conference like autonomy, self-rule and achievable nationhood respectively. This takes care of the criticism the new grouping faced about marking down their long-standing political agenda by seeking only the restoration of Article 370.

Now, where do we go from here? The parties have decided to hold consultations with likeminded representatives from Jammu and Ladakh and plan to offer them to join the grouping. This is a smart move. In recent months, Jammu and Ladakh have exhibited visible signs of disaffection with the post Article 370 move state of affairs. A looming prospect of demographic change, loss of jobs and land rights have made people uneasy. But while the expression has been muted in Jammu, people have been vocal about their rights in Ladakh. In fact, all parties in the union territory recently closed ranks against entry of outsiders and to this end threatened to boycott elections if the centre didn't

promise safeguards like the grant of 6th Schedule of Constitution. Centre was prompt to assure these protections to Ladakh unlike its approach to Kashmir. But until it actually grants these safeguards, Ladakhis will have reason to feel apprehensive. At the same time, Muslims in Ladakh who are in a slim majority in the region, aren't interested in these safeguards. Like their counterparts in Kashmir, they also want reversal of Article 370 move and rejoining of Ladakh with J&K.

In Jammu, on the other hand, the parties other than the BJP have a varying degree of beef with the new state of affairs, although the local parties like Panthers Party support the revocation of Article 370 but ironically want Article 370 like guarantees to protect the region's unique identity. Helpfully for new Kashmir alliance, Congress, a national party, has supported restoration of Article 370 and the rights for Kashmiris. In fact, the party is a constituent of the Gupkar alliance.

This opens up a possibility that the three regions can agree on a common minimum agenda. And should that happen, it will be a major achievement for the six party alliance and will only strengthen its case at the national level.

parties were to mobilize the public opinion against the withdrawal of Article 370, their ability to force a shift in centre's policy will be minimal. For in doing so, they will be up against the new national consensus on Kashmir that sees the integration of the former state into India as a fait accompli.

Also, a broad regional cooperation on the issue of rights of J&K will afford more space for political activity to the leaders in Kashmir. Such an alliance will also require influential local leaders to represent it in Jammu and Ladakh.

But there is still a big if about the chances of a regional cooperation happening anytime soon. Or happening of it at all. The reasons are the deep mutually antagonistic political cultures and the largely contradictory interests of the three regions. Even, in case of Ladakh where Muslims are in a slight majority, their political weight is undone by the centre's support for Buddhists. So, for a regional alliance to materialize, all such opposing forces will have to be reconciled. This will not be an easy task.

As for remaining a Kashmir-centric grouping, the six party coalition will have little political space to operate. Centre is likely to come down hard on the alliance at any sign of the civil strife that will be promptly traced to its actions, real or imagined.

One option for the new mainstream political grouping to build some pressure on New Delhi is to mount a sustained public resistance against the erasure of the special status. But there are valid doubts about the scope for such a resistance at a time when the centre has drastically squeezed the space for any democratic dissent in the region. And the Gupkar amalgam is mindful of this fact: They have so far issued the joint statements, given themselves a name, formalized their structure and worked out an agenda but stayed well short of calling for a peaceful protest, a public rally, a press conference or for that matter even a hartal.

At the same time, even if the parties were to mobilize the public opinion against the withdrawal of Article 370, their ability to force a shift in centre's policy will be minimal. For in doing so, they will be up against the new national consensus on Kashmir that sees the integration of the former state into India as a fait accompli.

This makes the demand for the restoration of Article 370 just like the one for autonomy, self rule and Achievable Nationhood. Much will also depend on the evolving geo-politics of the region and how India's equations with China and Pakistan will shape up, and also whether Afghanistan will pass again into the hands of Taliban. It still remains to be seen how these developments will impact Kashmir. As of now, a Kashmir observer has no option but to stay with his fingers crossed.



Why Turkey Is Flexing Its Muscles Abroad

'mmediately after a long-simmering conflict in the South Caucasus burst into open warfare late last month, Turkey came to the aid of its Turkic allies in Azerbaijan. It has supplied arms and, allegedly, fighters transferred from Syria, although that has been denied in Ankara.

Unlike most outside powers that called for an immediate ceasefire, Turkish President Recep Tayyip Erdogan told Azerbaijan President Ilham Aliyev to

The Caucasus is only the latest venture for a more muscular Turkey, whose military engagements have stretched from Syria across the Mediterranean.

Where has Turkey become involved? In the last few years, Turkey has:

- launched three military incursions into Syria
- sent military supplies and fighters to Libya deployed its navy to the Eastern Mediterra-
- nean to assert its claims in the region
- expanded its military operations against Kurdish PKK rebels in northern Iraq
- sent military reinforcements to Syria's last rebel-held province of Idlib
- recently threatened a new military operation in northern Syria to confront "terrorist

armed groups". Turkey also has a military presence in Qatar, Somalia and Afghanistan and maintains peacekeeping troops in the Balkans. Its global military footprint is the most expansive since the days of the Ot-

What is behind Turkey's new foreign policy?

Turkey's reliance on hard power to secure its interests is the cornerstone of its new foreign policy doctrine, in the making since 2015.

The new doctrine is deeply suspicious of multilateralism and urges Turkey to act unilaterally when necessary

It is anti-Western. It believes that the West is in decline and Turkey should cultivate closer ties to countries such as Russia and China.

It is anti-imperialist. It challenges the Westerndominated World War Two order and calls for an overhaul of international institutions such as the United Nations, to give voice to nations other than the Western countries.

The new foreign policy doctrine views Turkey as a country surrounded by hostile actors and abandoned by its Western allies.

Therefore, it urges Turkey to pursue a proactive foreign policy that rests on the use of pre-emptive military power outside its borders.

This is a far cry from Turkey's previous focus on

diplomacy trade and cultural engagement in its relations with other nations. The change is a function of several domestic and international developments.

What changed?

Turkey's new doctrine began to take shape in 2015, when the ruling AKP lost its parliamentary majority for the first time in over a decade due to the rise of the pro-Kurdish Peoples' Democratic Party (HDP).

To regain the ruling party's majority, Mr Erdogan formed an alliance with nationalists both on the right

They backed him when he resumed the fight against the Kurdish rebels.

How focus turned to Kurds

Turkey's conflict with the PKK - Kurdistan Workers' Party - had to a large extent stopped after the group's imprisoned leader, Abdullah Ocalan, called for a ceasefire with the Turkish state in 2013.

Despite their ideological differences, both the farright nationalist MHP and neo-nationalists on the left support a heavy-handed approach to the Kurdish problem. They also prioritise national security at home and abroad and espouse strong anti-Western views.

With their support, Mr Erdogan also switched the

forces and judiciary, and some other state institutions. The void left by the purges was filled with Erdogan loyalists and nationalist supporters.

The failed coup also strengthened the nationalist coalition's narrative that Turkey was besieged by domestic and foreign enemies and that the West was part of the problem. That justified unilateral action. supported by pre-emptive deployment of hard power beyond Turkey's borders.

How approach changed in Syria

The Assad regime's decision to give a free hand to Syria's Kurds in the north led to an autonomous Kurdish zone along Turkey's border and in 2014 the US decided to airdrop weapons to the Kurdish militants, considered to be a terrorist organisation by Turkey. This all fed the narrative that Turkey had to act alone and deploy military forces to protect its borders.

The failed coup also paved the way for consolidation of power in Mr Erdogan's hands.

Through purges he hollowed out institutions, sidelined key actors in foreign policymaking such as the foreign ministry, and emasculated the military, which had put a brake on his previous calls to launch military operations in neighbouring countries.

country's parliamentary system to a presidential one granting him sweeping powers.

This alliance with the nationalists and consolidation of his power became the key driving factor behind Turkey's unilateralist, militaristic and assertive for-

The failed 2016 coup played a key role in this process.

How coup changed the narrative

According to President Erdogan, the botched coup was orchestrated by former ally Fethullah Gulen, an Islamic cleric in self-exile in Pennsylvania, and it did several things to pave the way for Turkey's militaristic foreign policy.

It strengthened Mr Erdogan's alliance with the nationalists

His sweeping purge of civil servants suspected of having links to the Gulen movement led to some 60,000

Before the coup attempt, he had signalled his intention to launch a military operation into Syria to stem the "terrorist threat" emanating from the Kurdish militias there. But Turkey's military, which had traditionally been very cautious about troop deployment outside Turkey's borders, was opposed.

A few months after the coup attempt, President Erdogan got his wish. Turkey launched its first military operation into Syria to curb the influence of the Kurds in the north in 2016 and two more incursions after that.

The move was applauded by the president's nationalist allies, who fear an independent Kurdish state built with US help along its border. To curb Kurdish influence and counterbalance the US presence in Syria he worked with Russia.

How Turkey switched focus to Libya and E Mediterranean

In January, Turkey stepped up military support to Libya's UN-backed government of Prime Minister Fayez al-Serraj, to stop an offensive by forces allied with Gen Khalifa Haftar.

Turkey's primary goal in Libya was to secure the Serraj government's support in a matter important to Mr Erdogan's nationalist allies: the Eastern Mediterranean. Turkey has been at loggerheads with Greece and Cyprus over energy drilling rights off the coast of the divided island of Cyprus and maritime boundaries

Ankara signed an agreement on maritime boundaries with Mr Serraj in November in return for military support to the Tripoli government.

Mr Erdogan's aim was to redraw maritime borders in the Eastern Mediterranean which, in his opinion, provided disproportionate advantages to Turkey's arch-enemies - Greece and the Republic of Cyprus.

Meanwhile, Turkey sent warships to escort its drilling ships in the Eastern Mediterranean, risking a military confrontation with its Nato partner Greece.

Has it been a success?

Turkey's assertive policy in Syria, Libya and the Eastern Mediterranean has not yielded the results that President Erdogan's ruling coalition hoped for.

Turkey could not entirely clear Kurdish militia forces from its border with Syria. Neither Ankara's maritime agreement with Libya nor its actions in the Eastern Mediterranean have changed the anti-Turkey status quo in the region.

On the contrary, Turkey's military involvement in these conflicts hardened anti-Erdogan sentiment in the West and unified a diverse group of actors in their resolve to oppose Turkish unilateralism, eventually forcing Turkey's leader to back down.


A similar fate awaits Turkey's involvement in the Nagorno-Karabakh conflict, which is already seeing the emergence of a more forceful Russian response and a Russian-Western front against Turkey's support for Azerbaijan.

What next?

But Mr Erdogan's nationalist allies want him to fight on. A prominent neo-nationalist, Retired Rear-Admiral Cihat Yayci, argued that Greece wanted to invade western Turkey and urged Mr Erdogan to never sit down with Athens to negotiate

Why China May Want To **Keep Donald Trump In White House**

Beijing: Donald Trump has frustrated and enraged China during a tumultuous first term, but Beiiing may welcome his re-election as it scans the horizon for the decline of its superpower rival.

Relations are as icy as at any time since formal ties were established four decades ago, with China warning it does not want to be drawn into a new "Cold War" with the United States.

Under his 'America First' banner, Trump has portrayed China as the greatest threat to the United States and global democracy.

He has launched a massive trade war that has cost China billions of dollars, harangued Chinese tech firms and lav all the blame for the pandemic with Beijing.

But another Trump triumph in November may have its advantages for China as President Xi Jinping seeks to cement his nation's rise as a global superpower.

China's leadership could be handed "the opportunity to boost its global standing as a champion for multilateralism, globalisation, and international cooperation," said Zhu Zhiqun, professor of political and international relations, Bucknell University.

Trump has pulled America from a sprawling Asia-Pacific commercial deal and climate agreements, imposed billions of dollars of tariffs on Chinese goods, and withdrawn the US from the World Health Organization at the height

of a global pandemic. Where the US has retreated, Xi has stepped forward.

He has presented his country as the champion of free trade and a leader in the fight against climate change, as well as vowed to share any potential Covid-19 vaccine

with poorer nations.

"A second Trump term could give China more time to rise as a great power on the world stage." Zhu said. Philippe Le Corre, a China expert at the Harvard Kennedy School in the United States, agreed an extension of Trump's 'America First' policies would be of longterm benefit for Beijing.

"(It) partially cuts Washington off from its traditional allies," he added, and that gave China room to manouevre.

China's nationalists have openly cheered, or jeered, for Trump. "You can make America eccentric

and thus hateful for the world,' Hu Xijin, editor-in-chief of the Global Times, a chest-beating nationalist paper, warned in a Tweet directed at the US president.

"You help promote unity in Chi-

Trump is also lampooned on China's heavily censored social media as 'Jianguo', meaning "help to build China".

- Biden trouble Trump has undoubtedly inflicted economic and political pain on China. "China has lost out enormously in its plan for trade and technology," said Beijing-based political analyst Hua Po.

Nawaz Sharif's Brother Shehbaz Sharif Sent To Jail In Money Laundering Case

Pakistan Muslim Lahore: League-Nawaz (PML-N) chief and Opposition Leader in the National Assembly Shehbaz Sharif was sent to jail on Tuesday in a money laundering case. Shehbaz, the younger brother of three-time former prime minister Nawaz Sharif, was arrested by the National Accountability Bureau (NAB) on September 28 after a court here rejected his bail application in the crores money laundering case. Next day, the 69-year-old former chief minister of Punjab province was sent on a physical remand by an accountability

On Tuesday, an accountability court of Lahore rejected the NAB's plea seeking further ex-Shehbaz told the court that NAB didn't ask any questions about money laundering during his three weeks detention. Talking to reporters, Shehbaz criticised the Imran Khan government for arresting Mohammad Safdar, son-in-law of Nawaz Sharif, for raising slogans in giving respect to the ballot.

Safdar was on Monday briefly arrested from his hotel room in Karachi, a day after he staged a protest at the tomb of the country's founder and attended a joint opposition rally.

Shehbaz also termed unholy alliance of Imran Khan and NAB behind political victimisation of opposition leaders. He has been shifted to Kot Lakhpat jail in Lahore.

Maryam Nawaz, daughter of Nawaz Sharif, had said that Shehbaz had been arrested only because he did not leave his elder brother (Nawaz).



Prime Minister Khan recently should be convicted in cases against them. He was complaining about delay in such cases. Shehbaz, who has denied any wrongdoing, was arrested just ahead of the planned protests by his party - the Pakistan Muslim League-Nawaz (PML-N) - to demand the resignation of Prime Minister Khan.

The political temperature is high in the country since the 11 opposition parties formed an alliance - Pakistan Democratic Movement - against the armys involvement in politics.



Karabakh sees fresh fighting despite ceasefire

STEPANAKERT: A new ceasefire agreed between Armenia and Azerbaijan to halt fighting over the disputed region of Nagorno-Karabakh was again failing to hold on Monday as both sides accused each other of fresh attacks. The truce, backed by international mediators to put a stop to three weeks of fighting that has left hundreds dead, was supposed to have come into force at midnight (2000 GMT Saturday) but both sides immediately accused each other of violating the deal.

But it has never been recognised by any other state, including Armenia, while Azerbaijan has always made clear its desire to regain control in one of the most combustible conflicts left after the fall of the USSR.

The Azerbaijani defence ministry said that Armenian armed forces had shelled areas in four districts inside the country overnight.

Meanwhile, the local authorities in Karabakh said Azerbaijani artillery fire continued overnight, with the Karabakh army taking "proportionate actions" in response. Nagorno-Karabakh's However main city Stepanakert was quiet overnight

The ceasefire was the second agreed after a previous truce

thrashed out in Moscow earlier this month never showed any sign of seriously holding.

Russian Foreign Minister Sergei Lavrov, who has acted as a mediator between Armenia and Azerbaijan in negotiating both ceasefires, said on Monday the continued fighting was "unacceptable." He said the warring sides and international players should "immediately stop ratcheting up confrontational rhetoric" and reiterated the importance of putting in place ceasefire monitoring mechanisms.

"We are working on this," he added following talks with Secretary General of the Council of Europe Marija Peicinovic Buric

Azerbaijani President Ilham Aliyev accused Armenian forces of "blatantly" violating the ceasefire, including firing on residential areas, and said there were dead and wounded.

Writing on Twitter, he said Azerbaijani forces had taken control of 13 more Armenian-held settlements.

repeatedly Azerbaijan has claimed military success in the current fighting by taking control of areas both within Karabakh and other Azerbaijani territory that had been held by Armenian

But analysts say Azerbaijan is

unlikely to be able to retake control of Karabakh through military means alone, while the seemingly irreconcilable positions on both sides makes a diplomatic solution elusive.

Fears remain of the conflict broadening, with Turkey strongly backing its ally Azerbaijan even as Ankara rejects charges it has sent in both Turkish military personnel and Syria militia members to help Baku.

UN chief Antonio Guterres on Sunday called on Armenia and Azerbaijan to "fully abide" by the new ceasefire, his spokesman

The new deal was announced after one of the conflict's deadliest attacks on civilians so far on Saturday, when a missile hit a residential area of Azerbaijan's second city Ganja, killing 13 people including children.

The clashes over Karabakh that erupted on September 27 have left more than 800 dead, according to official figures, but the real number may be much higher as Azerbaijan has not disclosed its military toll.

According to Yerevan, 710 Armenian soldiers and 36 civilians have been killed in the current flare-up of fighting. Baku says 60 Azerbaijani civilians have been killed.

London: British researchers on Tuesday said they hope to expose healthy volunteers to the virus that causes Covid-19 in a groundbreaking study to discover the amount needed for people to become infected.

The Human Challenge Programme -- a partnership that includes Imperial College London hopes the work will ultimately help to "reduce the spread of the coronavirus, mitigate its impact and reduce deaths".

In what researchers called a world first, the opening stage of the project will examine the possibility of exposing healthy volunteers to the SARS-CoV-2 coronavirus.

They aim to recruit volunteers between the ages of 18 and 30 with no underlying health conditions such as heart disease, diabetes or

"In this initial phase, the aim will be to discover the smallest amount of virus it takes to cause a person to develop Covid-19," Imperial College said in a statement. The volunteer would be infected via the nose, Peter Openshaw, professor of experimental medicine at Imperial, told BBC Radio 4 on Tuesday.

"The great advantage of these volunteer studies is that we can look at each volunteer very carefully not only during the infection but also prior to infection, and we can work out exactly what's going on at every stage," he added.

The researchers would use the results to study how vaccines might work and to explore potential treatments.

Because the study deliberately infects the volunteers, "it should be possible for scientists to begin to establish efficacy very quickly, by testing if those who have had a vaccine are less likely to become infected with the virus", explained the researchers.

"Our number one priority is the safety of the volunteers," said Chris Chiu, from Imperial's department of infectious disease.

"No study is completely risk free, but the Human Challenge Programme partners will be working hard to ensure we make the risks as low as we possibly can."

"The UK's experience and expertise in human challenge trials as well as in wider COVID-19 science will help us tackle the pandemic, benefiting people in the UK and worldwide," he added.

The study is expected to begin early next year, said the research team from the partnership, which also includes the government, a clinical company and a hospital.

No Danger To Crew After ISS Issues Resolved: Russia


Moscow: The International Space Station (ISS) is now working normally with no danger to its occupants after the crew managed to resolve a series of technical issues overnight, Russia's space agency said Tuesday.

The crew aboard the ISS had reported issues with the oxygen production system, a toilet and the oven for preparing food.

"The problems that occurred on board the ISS during the night of 19-20 October have been fully resolved by the crew," Russia's space agency Roscosmos said in a statement.

"All the systems of the station are working well and there is no danger to the crew or the ISS."

The crew had reported overnight that the toilet on the Russian segment of the ISS was out of order, that the water systems used to supply oxygen to the crew were empty and that there were problems with heating food.



half of the six person crew -- NASA's Chris Cassidy and cosmonauts Anatoly Ivanishin and Ivan Vagner -- are preparing to leave for an

arrival back on Earth early Thursday. The issues were the latest technical problems to hit the ISS, whose crew have had to manage an array of troubles in recent weeks. The orbital lab's first module was launched over two decades ago in

1998 and there have been growing concerns about its age Last week, the oxygen supply system in the Zvezda module of the Russian segment of the station failed. Roscosmos said at the week-

end that this has now been repaired. A small air leak that was detected in August has also now been patched up, after tea leaves from a torn tea bag helped alert the crew to the site of the leak.

Quoted by the RIA Novosti news agency last week, veteran Russian cosmonaut Gennady Padalka said that the Russian equipment on the ISS was well past its use-by date.

"Fauci A Disaster. We'd Have 500,000 **Deaths If I Listened To Him": Trump**

AS VEGAS/WASHING-TON: President Donald Trump called coronavirus expert Anthony Fauci a "disaster" on Monday, airing his frustration with the scientist during a call meant to reassure campaign staff he has a path to victory on November 3 despite trailing in opinion polls. Trump and Fauci, a mem-

ber of his coronavirus task force, have been at odds over how best to handle a pandemic that has killed more than 219,000 people in the United States and weakened the Republican president's case for re-election.

Fauci, 79, who has served under Republican and Democratic presidents and is one of the most admired scientists in the United States, has urged that COVID-19 continue to be taken seriously. Trump has suggested the worst has passed.

"Fauci is a disaster. If I listened to him, we'd have 500,000 deaths," Trump said during the call, which the campaign al-



lowed reporters to join. Fauci has openly com-

plained about being cited in a Trump re-election campaign advertisement that discussed the administration's pandemic response, and said in an interview broadcast on Sunday night by CBS' "60 Minutes" that he was not surprised Trump himself contracted the virus.

Trump, speaking from his signature hotel in Las Vegas ahead of two rallies in Arizona, said Fauci bombed during TV interviews but that it would be "a bigger bomb if you fire him."

diately respond to a request for comment. Trump said Americans were fed up with pandemic re-'People are saying: 'Whatev-

er. Just leave us alone.' They're tired of it. People are tired of hearing Fauci and all these idiots," said Trump, whose rallies include many supporters not wearing masks and standing shoulder to shoulder, at odds with the guidance of Fauci and other public health experts.

"Fauci is a nice guy. He's been here for 500 years," Trump added. Republican Senator Lamar Alexander issued a statement calling Fauci, who has been director of the National Institute of Allergy and Infectious Diseases since 1984, "one of our country's most distinguished public servants.

"If more Americans paid attention to his advice, we'd have fewer cases of COVID-19, and it would be safer to go back to school and back to work and out to eat," Alexander said.
