JKCA Scam: Dr Farooq Faces 5 **Hour Grilling By ED**

84 Year Old NC Patron Quizzed For Second Time In 3 Days, Party Outraged

SRINAGAR: Former Jammu and Kashmir chief minister Farooq Abdullah, who turned 84 on Wednesday, was questioned by the Enforcement Directorate for five hours in connection with a multi-crore scam in the JK Cricket Association during 2002-11.


The National Conference president drove off after his questioning, for the second time in three days, at the ED office in Rajbagh here without talking to reporters waiting outside, unlike on Monday when he had asserted that he was prepared to answer all questions and was not worried about the case.

He was questioned for over six hours on Monday.

Abdullah's National Conference (NC) criticised the government over his questioning, and said it was "yet another attempt to browbeat" the opposition.

ED officials said on condition of anonymity that Abdullah had been called again on Wednesday to obtain some clarifications. He was questioned for the first time in July last year in Chandigarh after the agency had registered a case under the Prevention of Money Laundering Act in 2018.

The officials said Abdullah's statement was recorded under the Prevention of Money Laundering Act (PMLA) and he was asked about the procedures followed and



NEW DELHI: The Cabinet on Wednesday approved the extension of a scheme under which cooperative NAFED will procure 12 lakh tonne apple in Jammu and Kashmir during the current 2020-21 season.

National Agricultural Cooperative Marketing Federation (NAFED) has also been allowed to use the government guarantee of Rs 2,500 crore for this operation. The losses, if any, will be shared between the Centre and Jammu and Kashmir government on a 50:50 basis. A decision in this regard was taken

Enraged Attendants Ransack Hospital in City

Police Uses Lathi Charge And Teargas **Shelling To Control Situation**

SRINAGAR: Police on Wednesday used batons and fired tear smoke shells after death of a patient due to the alleged negligence of doctors at a private hospital here triggered violent protest by her relatives.

According to reports, protest broke out at the Shifa Hospital in uptown during the intervening night of Tuesday and Wednesday when a young woman identified as Dilshada of neighboring Batamaloo locality died after doctors conducted a sur-

gery on her for gallstones. The attendants of the patient, re-

The RSF statement further said that the government officials evicted journalists from Kashmir Times office and then sealed the premises. The RSF said it was by this 'reprisal' against a leading regional daily. "The eviction was carried out by representatives of the regional government's estates department, who arrived unannounced, expelled the newspaper's employees without presenting any justifying documents, and then placed seals on its entrance," the RSF said.

The RSF statement quoted Kashmir Times executive editor Anuradha Bhasin calling the closure of the newspaper's office as "vendetta for speaking out."

"All our office infrastructure, including computers, printers, generators and so on, are locked inside to prevent us from producing our print edition in Srinagar," she told RSF Bhasin told RSF that she was evicted in a similar manner a few weeks

ago - without being served any cancellation and eviction notices from the apartment the government had allotted to her in 2000. "Locks to my flat were broken, as I was not staying there, and the new

[tenants] were given charge of the place along with my belongings, including valuables and important documents that have not still not been given to me," she said.

According to the RSF statement. Bhasin thinks she was paying the price for her determined defence of a free press in Jammu and Kashmir since the region's autonomy was revoked in August 2019 and, in particular, for the petition she filed with India's supreme court challenging the simultaneous decision to disconnect the region's telecommunications.

"Since then, the state government stopped all advertisements to Kashmir Times, she told RSF.

One of the oldest English-language publications in the Kashmir Valley, the Kashmir Times is widely respected, so its eviction from its Srinagar office had stunned many of the region's journalists, the watchdog said.

"I started my journalistic career at this newspaper, which has traditionally been fiercely independent," Athar Parvaiz told RSF. "The atmosphere encouraging fearless journalism at the Kashmir Times has always been great and I benefited enormously while working there." "Many of the journalists based in Jammu and Kashmir started their careers at the Kashmir Times," said Syed Ali Safvi, another of its former reporters. "Over the years it has given voice to the voiceless and established itself as an institution you could trust. It is really painful to learn that its office has been sealed.'

"A proper system of checks and balances through membership of directly elected members, Block Development Council chairpersons and MLAs in the District Development Council which will ensure that the most genuine demands and needs of people are met," Sinha, as per official spokesperson said.

He said that after the adaptation of J&K Panchayati Raj Act,1989, every district will have a district development council having jurisdiction over the entire district excluding municipal areas.

"Every DDC will now have 14 directly elected members' i.e 280 directly elected BDC members in the whole UT. The Council shall consist of the directly elected members, the Chairpersons of all BDCs and members of the Legislative assembly from the district," the official spokesperson said.

"Moreover, any person whose name is included in the electoral of any Halqa Panchayat of the district can nominate himself as a candidate for election to District Development Council," he added.

After this development, he said every DDC will now have a Chairperson and a Vice-Chairperson who shall be elected by directly elected members of BDC. Further, he said there shall be reservations for SC/ ST amongst the directly elected members on the basis of the proportion of the population. One-third of seats under direct election will be reserved for women.

"Five Standing Committees, one each for Finance, Development, Public Works, Health and Education, and Welfare will now be constituted in every District Development Council," the official spokesperson said, adding "The ADDC will be the CEO of the DDC. The DDC will be responsible for the formulation of development programmes and speedy development and economic upliftment of the area of the district under its authority,"

He further said that the DDC will review the progress and achievements of development plans and schemes in the district and ensure adequate legal backing to devolution of functions to the DDC.

"Specific functions will be assigned to DDC in schedule III of the Act. The DDC will also supervise the functioning of Panchayat Halqas and BDC and will receive and consolidate their plans at the district level,"

Pertinently, the Government of I&K has also notified the rules for the constitution of the DDC and the process of delimitation of constituencies for DDC has already been set in motion in all the 20 districts.

for public purpose and in public interest.

"Disposal of public property partakes the character of a trust. Public purpose would be served only by getting best price for such property so that larger revenue coming into the coffers of the State administration can be utilized for beneficent activities to sub-serve public purpose, namely, the welfare State".

For getting the best price, the court while referring to a judgment by the Delhi high court, said the public property should be put to

public auction or by inviting tender with open participation i.e. ensure maximum public participation and a reserve price. "This also ensures transparency and such an auction would be free from bias or discrimination and thus beyond reproach."

The private negotiations should always be avoided as it cannot withstand public gaze and cast reflection on the Government or its official and is also against social and public interest.

"In exceptional cases, the authorities may depart from public auction or tender process and even dispose of the property at lower price than the market price or even for a token price. However, resort to this process can be taken only to achieve some defined constitutionally recognized public purpose, one such being to achieve the goal set out under Part-IV of the Constitution of India," the court added.

Court orders JKB debtor's arrest

RINAGAR-The additional district judge, bank cases, Srinagar, has ordered the arrest of an alleged debtor of the Jammu and Kashmir bank ltd and recovery of Rs 36,14,943.25 from him. In an order dated October 18, re-turnable on or before November 20,2000, the judge direct-ed the station house officer (SHO), police station, Nishat, to arrest Ghulam Rasool Vakil s/o Munshi Abdul Majid Vakil of Vakil Manzil, 4th bridge, Zainakadal, Srinagar, at present residing at Ishber. Nishat (alongwith two more judgement debtors).

According to the order, Vakil was adjudged by a decree of the court in suit No 84 of 1990 dated 3.6.1999 to pay to the bank Rs 8,67,552.25 which he failed to pay to the decree holder. Adding Rs 27,34,583 as interest from the date of suit till October 20,1999 and Rs 12,808 as costs allowed, the total adds up to Rs 36,14,943.25 now. The judge directed the SHO to bring the debtor before the court unless he pays to him the decree amount.

Lawyer Deepika Rajawat Receives **Death Threats for Rape Cartoon**

Jammu: Deepika Singh Rajawat, the lawyer-activist who shot to fame in 2018 after taking the high profile case of Kathua rape and murder victim, is in the firing line this time for allegedly posting a controversial Navratri cartoon on micro-blogging site twitter.

The lawyer had earlier faced immense hate for representing the 8-year-old victim from the Bakarwal nomad community in Jammu. And now, Rajawat is facing heat for sharing her views on rape during the festival of Navratri.

A section of social media users is demanding the arrest of Rajawat, for posting a controversial cartoon on her Twitter handle on Monday night.

'Irony,' captioned Deepika Rajawat while posting the cartoon showing a man touching the feet of a woman (presumed to be a goddess) during Navratri and the same man holding both the legs of a woman during the rest of the days. The cartoon was simply captioned, "Irony"

The situation became even tenser on Tuesday night when an angry mob reportedly gathered outside Rajawat's Jammu residence and demanded her arrest.

"Alert: Several right-wing organisations have been staging angry protests outside my residence. Law enforcement agencies must intervene immediately to the right wing Hindu parties.

US polls countdown

s countdown begins to US presidential election, the world is sitting with fingers crossed. Though Democratic candidate Joe Biden has some edge over the incumbent Donald Trump, the latter can still emerge as the winner. But the stakes for the US and the world in the win or loss of either of the candidates are too big to not become a subject of global interest. If Biden wins, there are certainly going to be some marked policy readjustments in how the US has dealt with the world under Trump.

In the US, there is now a growing realization that the president's erratic and irrational behaviour is not only creating difficulties for America at home but also making the world a fraught place. The ongoing trade war with China, sudden decisions to pull out troops from Afghanistan and Syria, all have combined to create a very dangerous state of affairs. Also, Trump's antipathy towards multilateral institutions that have anchored the global stability after the second world war, his protectionist approach towards the economy and pursuit of an isolationist policy for America have threatened to unhinge the world.

If re-elected to office, Trump is unlikely to change his course. His approach to China has threatened to start a new cold war. On the other hand, new geo-political alignments are taking place. China and Russia are moving ever more closer and challenging US hegemony. The Trump's combative approach is alienating a lot many countries and allies. This is not a happy state of affairs for the world to be in. And under Trump's presidentship things are unlikely to change anytime soon, if Trump retains presidency.

But as for India, Trump has been invariably good. Earlier this year, Trump's visit kept India riveted to television for three days. It was Trump's second visit to India in five years. And since 2001 when Bill Clinton made his game-changing trip, there have been five US presidential visits to India - including the one by George W Bush - all contributing to a deepening India-US relationship. One of the salient achievements of the Trump's visit was the signing of the \$3 billion worth defence deals, including the purchase of what Trump said were the "most feared weapons"

Interestingly, Trump didn't publicly raise Kashmir as was widely anticipated. In past, the visiting US presidents have often mentioned Kashmir in their interaction with media. So, India would want Trump to win. However, relations with India have become too important to the US to be significantly affected by the change of presidency. But yes, there's a hope that under Biden, the US will reassume its global leadership role. More than anything, the current dire state of global economy needs the major powers to unite rather than drift apart.

Get the vaccine strategy right

ver the past week, India's top leaders and officials have proffered more clues about when and how the country plans to begin vaccinations for Covid-19. Mass volumes are likely to begin shipping around March, if the trial and the approval process follow projected timelines. The first shots will likely be administered as the country heads into the next summer.

Among the clues into India's strategy is a crucial confirmation by Prime Minister (PM) Narendra Modi himself. On Monday, the PM said a vaccine delivery system was in the works and it will utilise the upcoming national digital health ID — an initiative that he first announced during his Independence Day speech. This is crucial for two reasons. First, it appears to address how authorities will administer and track the coronavirus immunisation of possibly each of the country's 1.3 billion-plus citizens. The process, unprecedented in scale for any democracy, needs to be precise, efficient and quick. A viable vaccine is likely to be in two doses, with a predetermined gap in between.

Second, it will mark the rollout of one of the world's most ambitious public health management systems the National Digital Health Mission. The idea behind the programme is to digitise the health records of citizens. Its benefits, especially in the context of the coronavirus immunisation, are clear, for it will provide easy access to standardised data. But its rollout in the context of the pandemic can also be controversial. India is yet to adopt a personal data protection legislative framework, and if access to a Covid-19 vaccine is made contingent on signing up for a national health ID, the programme becomes virtually mandatory. Till now, officials have said that sign-ups are voluntary. To be sure, the specifics of the vaccine delivery are still not final. These details will need to balance legal, ethical and, ultimately, public health considerations before they are set in stone. Getting the vaccine strategy right is critical for the entire edifice of the recovery process from the pandemic.

New Labor Laws

ork is not only part of everybody's daily life but is crucial to one's dignity, well-being and development as a human being. Economic development does not include only creation of jobs but also comprises working conditions in which one can work in freedom, safety and dignity. In order to develop economy, the government (both central and state) had time and again passed, a number of legislations to create new jobs and concomitantly provide favorable working conditions for overall development of the labors. As Labor is a Concurrent Subject and both Central Legislature and State Legislature can make laws, more than forty labor legislations existed in India. Overlapping and confusion was unavoidable in such circumstances

Therefore, in order to lessen complexity, to provide ease of compliance and for accountability and transparency beneficial for both employers and workers, new reforms were long-awaited. Recently, Parliament passed the three labor code bills – the Occupational Safety, Health and Working Conditions Code, 2020; the Industrial Relations Code, 2020; and the Code on Social Security, 2020 – merging 24 central labor laws in a major boost to Labor sector.

The Industrial Relation Code, 2020

This code mostly combines three codes i.e. Trade Union Act, Industrial Employment (Standing Orders) Act, 1946 and Industrial Disputes Act, 1947.

The new laws have allowed companies with up to 300 workers to fire workers or shut plants without the prior approval of the government. Hitherto, prior approval had been required. However, Firms with more than 300 workers need to still apply for approval.

The rules and regulations (also called Standing Orders) with respect to holidays, workers classification, paydays, wage rates etc. was made mandatory for the establishment with up to 300 workers, the number earlier was 100 workers.

New rules for hiring and firing of labor in mid-sized and large industries were introduced, this new legislation makes retrenchment easier. The prior permission of government for retrenchment, layoff and closure applied to establishment with up to 300 workers.

It also declared that Fourteen days' notice before strike should be given by the employee. However, this notice will remain

valid for 60 days. Flash strikes are now outlawed.

This code also prohibits any sort of strike and lockdown during the pendency of matter before any tribunal and also prohibits strike after 60 days of order passed by tribunal.

If there are more than one trade union in any establishment, the Sole Negotiation Union status will be given only to such trade union which comprises the 51% of the employees as members, the number earlier was 75%.

Code on Social Security, 2020

This code combines nine earlier codes which mostly relates to retirement, social Security and employee Benefits i.e. The Employees Compensation Act 1923, the Employees State Insurance Act 1948, The Employees Provident Fund and Miscellaneous Provisions Act 1952, The Employees Exchange (Compulsory Notification of Vacancies) Act 1959, The Maternity Benefit Act 1961, The Payment of Gratuity Act 1972, The Cine Workers Welfare Fund Act 1981, The Building and Other Construc**Code on Occupational Safety, Health** and Working Conditions, 2020

This code replaces 13 labor laws related to Safety, Health and working conditions of labors and alike. Some of the codes replaced were Factories Act 1948, Dock Workers Act 1986, Contract Labor Act 1970, Inter-state Migrant Workers Act 1979 etc. The main aim of this code is not only to regulate employment but also to regulate health, safety and favorable working conditions of employees.

Under this, definition of factory was expanded, now any premises with more than 20 workers (where electricity is used) and 40 workers (where electricity is not used) can be called factory.

Applicable to contractors who employee more than 50 workers, it also removed earlier manpower limit on hazardous conditions. However, Maximum daily work limit was fixed to 8 hours per day. It also states that women can work in any establishment and it's the employer's responsibility to provide adequate safeguard.

Additionally, state and central

tion Workers Cess Act 1996 and the last but not least The Unorganized Workers Social Security Act 2008.

This code for the first time introduced comprehensive social security to workers of Unorganized Sector.

It lays emphasis that the Government from time to time formulate and notify suitable welfare schemes relating to Provident Fund, Employment Injury Benefit, Housing, Educational Scheme for Children etc.

The definition of employees has been expanded to include more workers like, Inter State Migrant Workers, Gig Workers, Platform

Workers, Film Industry Workers etc. New gratuity period for working journalists are now 3 years instead of earlier 5 years.

It also declares that Central government can reduce employer's or employee's contribution (under Provident Fund and Employees State Insurance) for a period of three months in case of a pandemic, endemic and national disaster.

government have to maintain the record of inter-state migrant workers. Workers earning more than eighteen thousand per month can be treated as Inter State migrant workers and can benefit under public distribution system, building cess, insurance and provident fund.

No doubt, the revolutionary majors had been introduced via these legislations, by allowing industries flexibility in hiring and retrenchment. On the one hand, these legislations were introduced to bring ease of compliance to the industry and investment push for India and more importantly to create more jobs when unemployment is on its peak. But on the other hand, these legislations will definitely make industrial strikes more difficult, enhancing a company's powers of retrenchment may push unemployment rates higher, especially at a time when millions of workers have been out of work since the Covid-19 outbreak.

The Poetics of Resistance Music

MC Kash, a young rapper from Kashmir, similarly employs the genre of rap to protest. A particularly suggestive sample of his work is his song 'I protest' which voices the ground level reality of living in a conflict zone. MC Kash exemplifies the tendency of protest music to be resident in a very personalized political experience. The song 'I Protest' for example was written as a response to the 2010 uprising.

'n the recent times, Kashmir has seen a flourishing of artistic expressions, among which music has emerged one of the prominent expressions of a besieged people. Music is one of the most universal forms of expression that transcends the boundaries of nation and region, and has often been employed to crystallize expressions of resistance. Resistance Songs have often been employed to negotiate with power structures in an attempt to make space for the counternarrative. However, Resistance Music is not a linear or a single category as is presumed. Infact, the genre has atleast two paradigms of the genre - the Militant Songs and Protest Songs. The Spanish term 'Nueva Camcion or Nueva Trova' is loosely translatable as militant song.

In her introduction to the book 'Militant Songs Movement in Latin America: Chile, Uruguay, and Argentina', Pablo Vila draws attention to the complexity of the politicized music-making in Latin America in the twentieth century. She draws attention particularly to the term militant suggesting that "because militant prefigures without determining or narrowing it, (it is) a committed political position". She argues that these songs offer a broader paradigm of resistance as they are not merely restricted to adopting an oppositional position. Rather, they performed a broader function including but not limited to offering tidings of a "scientifically secured" better future through Marxism, or asking for concrete political actions like encouraging people to vote for Popular Union's candidates in 1973 Chilean Elections. As Vila notes the songs denounced (in the double sense of making public and alerting about) a situation." (Vila 3). The militant songs incorporate a diversity of subjects, e.g. in the Chilean context openly political songs such as El Pueblo Undo Jamas Sera Vencido (The people united will never be defeated), to combination of political reality with romantic elements, as Recuerdo Amanda. These songs serve as a reminder in popular memory as references to a time in which "dreams of liberty and social transformation confronted military dictatorships throughout Latin America." (Ureva 298). In this category comes, Mehjoor's poem put to music like: Come, O Gardner would be a perfect example of this paradigm, since it imagines a truly postcolonial state where the ideals of freedom and dignity reign supreme.

Protest songs or Protest music, on the other hand, has a restricted scope as it adopts a deliberately confrontational position. There is no universally agreed definition of a protest song, since the genesis and evolution of the song have been frequently entrenched in situational contexts completely diverse and far from each other. Yet, if a definition were sought, it wouldn't be amiss to define a protest song as a "creative endeavor undertaken under the conditions of authoritarianism...... that creates a multitude of cultural clues and points of reference to help define a societal sense of common

identity, the injustice the community suffered, and the need for social mobilization to remedy the undesirable." (Payerhin 6) Byerly reasons that protest songs are able to create this mobilization owing to the immense power manifest in music. She writes:

Music is the ultimate local and international communicator, transcending language barriers and undermining censorship unlike any other medium of protest.... It has the ability to initiate, motivate, collaborate, communicate, instigate, nurture, dispute, repulse, and reconcile. It is an unparalleled site for creativity and expression—containing infinite options for the configuration of melody, harmony, lyrics, languages, code-switching, rhythms, style, genres and forms. It is malleable and transposable, and can transform itself with chameleon-like agility, from being militaristic and confrontational to progressive and inclusive, jarring and accusatory to serene and conciliatory, discordant and dissonant to melodious and harmonious. (Byerly 230-31)

True to the intricate nature of Music, protest music and songs have sprung up in diverse situations across the world. While as protest songs have been sung all over the world, resistance movements for decolonization have found it particularly useful. During the Mau Mau uprising in Kenya against British colonial regime in 1952, several songs were composed that spoke of the Kenyan desire for independence, and the need to rally together. A famous song 'aria meendirie nyumba vaao' (Those who sold their people) by Nyagiko, praises those engaged in the fight against the British and simultaneously denounces the local corroborators who side with the colonists:

> We agreed to carry this log together And when we reached the middle of the river

of the river Those who ran away and sold their people And burnt our houses Now their children are like those of Goliath

Let us praise those of us in Nyandarua forest

Dedan Kimathi and General Mathenge General Kago and General Waru-

Our people have you forgotten The Gikuyu proverb that One cannot eat what he has not sweated for? (Kab ra and M tahi

The song follows all the characteristics typical of resistance poems, outlined by Harlowe, including a simplicity of form, expression and a committed political standpoint. It also functions as a framing device in the sense intended by the social psychologist Bert Klandermans in his essay "The Social Construction of Protest and Multi organizational Fields". He suggests social activism necessitates framing, which he defines as ""assign meaning to and interpret relevant intended to mobilize potential adherents port, and demobilize antagonists." He observes framing occurs through three ways (a) denouncing state of affairs is due to some specific indignation), (b) constructing a politically consciousness or a sense of who "we" are in our affliction), and (c) providing a sense exaggerated - projection of the chances of the movement to succeed." (Klandermans 80). The first stanza reminds the people of their collective resolve to fight, and denounces the betrayal of some local corroborators. The poem uses the term "Goliath" to refer to the children of these 'betrayers' to indicate the ill-gotten wealth acquired by them. However, the term is also a reminder of the failure such collaboration is doomed to suffer, as Goliath eventually lost to the frail David. The final stanza too refers back to the first stanza, reminding the people of the necessity of fighting. The proverb reminds the people that decolonization can only be achieved through a struggle, and fruits of freedom can be enjoyed only by those who strive for it. It can also be read as a warning to the antagonists suggesting they are excluded from collective consciousness since they have made no contribution in its evolution.

MC Kash exemplifies the tendency of protest music to be resident in a very personalized political experience. The song 'I Protest' for example was written as a response to the 2010 uprising. Suvir Kaul comments "MC Kash's combination of protest and remembrance, indictment and memorialization, anger and sorrow, is a powerful testimonial to the Kashmiri suffering that shapes its politics today.' (Kaul 109). The refrain 'I protest' itself acquires a great emotive force since it appears after cataloguing the different manifestations of state tyranny that include targeted killing, suppression of symbolic forms of resistance like stone pelting, and adds to the element of defiance by promising to stand ground, and not flee thereby asserting his belongingness as well as the right to protest. His personal journey is immediately intertwined with the larger historical process external to him, yet thoroughly internalized. Thus, he emerges as a paradigm of protest song. In both forms, thus, resistance music emerges as a natural ally of resistance poetry, and demands that future theorists and historiographers of Kashmir pay as much attention to it, as they do to resistance literature to understand how it contributes to the narratives of resistance.

ave you ever been pushed - really pushed - to achieve something? A grade, a medal, a supply order, a position, a certain number on the scales. The 'top' has always been designated the place 'to be': the ultimate goal. our individual Everests, if you will. But after the celebrations die down and the back-slapping has ceased, there's almost a sense of anti-climax, because what follows is the inevitable question: what next? Where do you go when you're already at the top? Sardonic replies suggest "there's no other way but down, of course" - but consistent achievers beg to differ. To paraphrase Loren Allred in her utterly captivating The Greatest Showman vocal performance, the achiever's bent is this: it's never enough. There's always more that can be done.

ways more that can be done.

US-based Dr Carl Beuke says as much in his Psychology Today post, when he notes that high achievers are "often marked, unsurprisingly, by a strong motive to achieve". It was certainly a unanimous perspective among all the folks we spoke to for this piece: all their lives, they can attest to a constant desire to succeed.

Jordanian expat Helen Al Uzaizi recalls how, even when she was at school, she wanted to "do more" than the other kids and "go beyond what was expected". It might come as a bit of a surprise, therefore, that the CEO of Bizworld UAE (who was also named one of the 50 Most Influential Women in the Arab World by Arabian

Business last year) was an average student who struggled through both school and university. If there's anything she's learnt over the years, it's that attitude is everything. "I don't consider myself to be 'at the top'," she says, self-effacingly. In fact, she adds, throwing in an altogether alternate perspective: "There's no such thing as 'the top'. There's always going to be someone better than you, and the only thing that can keep you grounded, despite achievements, is having the humility to acknowledge that you don't know it all - and that there's always something to learn "

The road to where she is today has been "very twisted, with lots of ups and downs". The 37-year-old says she can't think of a single year that "wasn't a rollercoaster" - but she has learnt to embrace the journey. "When you're younger, the rollercoaster feels like a hurdle. But as you grow and appreciate the learning you get from each experience, you see it as an opportunity to explore something new. Personally, I've come out stronger each time, with a lot more insight into who I am and what I can do to impact the community and society. So, now, I look forward to the next rollercoaster."

No room for fear

4 Habits of Successful People

Baku: The foreign ministers of Armenia and Azerbaijan have arrived in Russia to discuss their countries' dispute over the South Caucasus region of Nagorno-Karabakh, days before heading to Washington for separate meetings with US Secretary of State Mike Pompeo, as heavy fighting over the region is in its fourth week.

The two Caucasian countries said their top diplomats were in the Russian capital, Moscow, on Wednesday.

Azerbaijani Foreign Minister Jeyhun Bayramov arrived in Moscow for "consultations with the Russian side," the Azeri Foreign Ministry said in a statement.

His Armenian counterpart, Zohrab Mnatsakanyan, was set to meet with Russian Foreign Minister Sergei Lavrov "to discuss the situation in Karabakh and the implementation of a ceasefire agreement," said Armenian Foreign Ministry spokeswoman Anna Nagdalyan.

It was not clear if the two diplomats would meet Lavrov jointly or separately.

The pair will also meet Secretary Pompeo in separate meet-

ings in Washington on Friday. They have ruled out a trilateral meeting there.

The US State Department has not made a statement on the meeting.

Russia has so far brokered two humanitarian ceasefires to bring an end to the deadly conflict that erupted over Karabakh in September. Moscow's efforts for peace, however, failed to stop the fighting as both Yerevan and Baku violated the ceasefires.

Russian President Vladimir Putin continues efforts "to prevent further escalation of hostilities and resume talks to settle the Nagorno-Karabakh problem by political and diplomatic means as soon as possible," the Kremlin said on Tuesday.

Putin also discussed the issue in a telephone conversation with his French counterpart, President Emmanuel Macron. "The leaders stressed their

readiness to continue close coordination between Russia and France as co-chairs of the OSCE Minsk Group and within the United Nations Security Council," the Kremlin said, referring to the Organization for Security and Cooperation

At Least 11 Afghan Women Killed In **Stampede Near Pakistan Consulate**

Jalalabad: At least 11 women were killed Wednesday in a stampede at an Afghan football stadium where thousands of people had gathered to apply for Pakistani visas, authorities said.

The incident unfolded at the stadium in Jalalabad city, the capital of eastern Nangarhar province, after large crowds assembled in a bid to

"The embassy remains committed to ensure smooth and effective management of visa applicants at our end," a statement read.

"We seek the understanding and cooperation of Afghan people and authorities for better and secure management of the Afghan visa applicants.'

Thousands of Afghans from Nangarhar and other nearby provinces had arrived since the early morning to apply for medical visas or to visit relatives, and hundreds of policemen had been deployed at the stadium to control the crowds

Hours after the incident, relatives were seen carrying the dead in coffins from a mortuary in Jalalabad.

Many Afghans travel to neighbouring Pakistan every year, often for medical or educational purposes, while millions have taken refuge there over the past few decades to escape war and poverty in conflict-wracked Afghanistan.

US Sues Google In Biggest Antitrust Case In Decades, Explores Breakup

Washington: The US sued Google on Tuesday, accusing the \$1 trillion company of illegally using its market muscle to hobble rivals in the biggest challenge to the power and influence of Big Tech in

The Justice Department lawsuit could lead to the break-up of an iconic company that has

become all but synonymous with the internet and assumed a central role in the day-to-day lives of billions of people around the globe. Such an outcome is far

from assured, however, and the case is likely to take years to resolve

The lawsuit marks the first time the U.S. has cracked down on a major tech company since it sued Microsoft Corp for anti-competitive practices in 1998. A settlement left the company intact, though the government's prior foray into Big Tech anti-trust - the 1974

case against AT&T - led to the breakup of the Bell System. The federal government's complaint against Alphabet Inc's which alleges that Google acted unlawfully to maintain its position in search and search advertising on the internet, was joined by 11 states. "Absent a court order, Google will continue executing its anticompetitive strategy, crippling the competitive pro cess, reducing consumer choice, and stifling innovation," the lawsuit states

The government said Google has nearly 90% of all general search engine queries in the United States and almost 95% of searches on mobile. Attorney General Bill Barr said his investigators had found

Google does not compete on the quality of its search results but instead bought its success through payments to mobile phone makers and others.

"The end result is that no one can feasibly challenge Google's dominance in search and search advertising," Barr said.

When asked on a conference call if the department was seeking a breakup or another remedy, Ryan Shores, a Justice Department official, said, "Nothing is off the table, but a question of remedies is best addressed by the court after it's had a chance to hear all the

Egypt's Al-Azhar Islamic Center, Sheikh Ahmed el-Tavveb. has blasted individuals who link terrorism to Islam, following Islamophobic remarks by French President Emmanuel Macron and the recent murder of a French teacher. According to AhlolBayt

News Agency (ABNA) on Wednesday, Tayyeb tweeted that linking terrorism to Islam was a sign of ignorance. Tayyeb 's statement comes

following the beheading of French school teacher Samuel Paty on Friday after he showed his students blasphemous cartoon images of the Prophet Muhammad (PBUH).

Jamal Khashoggi Fiancee Sues Saudi Prince In US Over Murder

ashington: The fiancee of journalist Jamal Khashoggi sued Saudi Arabia's crown prince and other officials Tuesday in a US court, seeking damages for his brutal murder in Istanbul two years ago.

MAKERS

Turkish citizen Hatice Cengiz and the human rights group Khashoggi formed before his death. Democracy for the Arab World Now (DAWN), is pursuing Mohammed bin Salman and 28 others for damages over the October 2, 2018 killing of the USbased writer.

Cengiz claims personal injury and financial losses over Khashoggi's death, while DAWN said its operations and objectives were hampered by the loss of its founder and central figure.

'The ruthless torture and murder of Mr. Khashoggi shocked the conscience of people throughout the world," the suit said.

'The objective of the murder was clear -- to halt Mr. Khashoggi's advocacy in the United States, principally as the executive director of plaintiff DAWN, for democratic reform in the Arab world."

Khashoggi was killed inside Saudi Arabia's Istanbul consulate and his body dismembered and disposed of by a team of Saudis allegedly directed by right-hand men of



After global expressions of outrage over the case and pressure from the United States and Turkey, 13 Saudis were tried in Riyadh and sentenced to stiff prison terms.

But two top royal aides, deputy intelligence chief Ahmed al-Assiri and the royal court's media chief Saud al-Qahtani, were exonerated, despite links to the murder.

Both of the aides, those convicted in Saudi Arabia for the murder, and others tied to the plot were named in the lawsuit.

Cengiz and DAWN said they filed the suit in Washington federal court because they saw no chance for justice in Saudi Arabia, known for its opaque courts, and Turkish legal experts said the civil case would not go forward while Ankara pursues a criminal case over the murder


Shadowy Al Service Turns Thousands Of Women's Photos Into **Fake Nudes**

n artificial-intelligence service freely available on the web has been used to transform more than 100,000 women's images into nude photos without the women's knowledge or consent, triggering fears of a new wave of damaging "deepfakes" that could be used for harassment or blackmail.

Users of the automated service can anonymously submit a photo of a clothed woman and receive an altered version with the clothing removed. The AI technology, trained on large databases of actual nude photographs, can generate fakes with seemingly lifelike accuracy, matching skin tone and swapping in breasts and genitalia

where clothes once were. The women's faces remain clearly visible, and no labels are appended to the images to mark them as fake. Some of the original images show girls younger

Fast, Cheap Coronavirus Paper Test To Be Soon Available Across India



paper-based coronavirus test will soon be available across India, with scientists hopeful it will help turn the tide on the pandemic in one of the world's worst-hit nations.

India has recorded more than 7.5 million infections, second only to the United States, and the outbreak has spread from densely packed megacities like Mumbai to rural communities with limited medical services.

The locally developed Feluda, named for a detective in a famous Indian novel series, resembles a home pregnancy paper-strip test and delivers results within an hour.

Researchers are optimistic that its low cost and ease of use can help stem the pathogen's spread in poor and remote areas.

"This test doesn't require any sophisticated equipment or highly trained manpower," said co-creator Souvik Maiti, a scientist at New Delhi's CSIR-Institute of Genomics and Integrative Biology (IGIB).

"There are lots of remote parts of India where you do not have any sophisticated laboratories... (The test) will be much

easier to deploy; it will have much more penetration."

India currently diagnoses Covid-19 with either RT-PCR tests, which are highly accurate but require advanced lab machinery, or antigen tests, which can give results in just a few minutes at a limited cost but with significantly lower accuracy.

Feluda, like other inexpensive paper-based tests being developed in other countries, claims to combine the accuracy of the PCR test with the accessibility of the antigen kits.

It uses the gene-editing technique CRISPR-Cas9, which recently earned its inventors Jennifer Doudna and Emmanuelle Charpentier the Nobel Prize in Chemistry.

Feluda has been granted government regulatory approval and Health Minister Harsh Vardhan said last week it could be rolled out in the next few weeks by Tata Group.

If made available within that timeframe, India will be one of the first countries in the world to begin mass use of such a test.

The price has not been released, but some reporters said it could cost around 500 rupees (\$6.80) -- around a fifth of what a PCR test costs in New Delhi.

The current prototype requires a PCR machine for processing, but scientists are working on a saliva or self-swabbing version that can be used at home, cofounder and IGIB scientist Deboivoti Chakraborty said.

1.16 Lakh Infants Died From Air **Pollution In India Last Year: US Study**

NEW DELHI: Air pollution killed 476,000 newborns in 2019, with the biggest hotspots in India and Sub-Saharan Africa, according to a new global study which said that nearly two-thirds of the deaths came from noxious fumes from cooking fuels.

More than 116,000 Indian infants died from air pollution in the first month of life, and the corresponding figure was 236,000 in Sub-Saharan Africa, according to the State of Global Air 2020.

The estimates were produced by the US-based Health Effects Institute and the Institute for Health Metrics and Evaluation's Global Burden of Disease project.

The authors wrote they relied on a growing body of evidence linking mothers' exposures during pregnancy to air pollution with the increased risk of their infants being born too small (low birth weight) or too early (preterm birth).

These conditions are associated with



serious complications and already account for the vast majority of neonatal deaths in both regions.

The new analysis estimated what percentage of those deaths came from ambient and household air pollution.

"An infant's health is critical to the future of every society, and this newest evidence suggests an especially high risk for infants born in South Asia and sub-

Saharan Africa," said Dan Greenbaum, President of HEI.

"Although there has been slow and steady reduction in household reliance on poor-quality fuels, the air pollution from these fuels continues to be a key factor in the deaths of these youngest infants." he added.

Overall, the report found that air pollution led to 6.7 million deaths worldwide in 2019, making it the fourth leading cause of death behind high blood pressure, tobacco use, and dietary risks.

The authors added that while the Covid-19 pandemic had led to significant societal and personal costs, "many countries around the world have experienced blue skies and starry nights, often for the first time in many years" -- but these gains were short lived.

"Nonetheless, the blue skies have offered a reminder of what pollution takes

"Principle Of Self-**Determination Misused": India Slams Pak At UN**

UNITED NATIONS: In a thinlyveiled reference to Pakistan, India said the principle of selfdetermination continues to be "deliberately misinterpreted and misused" by a particular nation and it was not established by the UN to be used as a justification for undermining the territorial integrity of any member state.

"Since the principle of selfdetermination, as considered on the agreed agenda of this committee, continues to be deliberately misinterpreted and misused by a particular delegation, it is pertinent to highlight once again that the United Nations has established the principle as a vehicle for the worthy cause of decolonisation of the 17 Non Self-Governing Territories (NSGTs) on the agenda of this committee, and not as a justification for undermining the territorial integrity of any member state," India said in a statement on "NSGTs and decolonisation.'

India said it strongly believes that pursuing a pragmatic approach towards decolonization would surely lead to fulfilment of legitimate wishes of the people of NSGTs.

"We must also strive to enhance cooperation with international agencies and actors and channelize resources for the 17 NSGTs. This would surely



in their just and noble quest towards achieving long-cherished goals," the statement said.

India said that as a former colony, it has always been in the forefront of the struggle against colonialism and apartheid since its own independence over seven decades ago.

Since the creation of the United Nations, more than 80 former colonies have gained their independence and joined the family of United Nations. "However, the process of decolonization that began with our own independence remains unfinished," it said on Tuesday.

In 2011, the General Assembly had to proclaim the current decade, 2011-2020, as the Third International Decade for the Eradication of Colonialism, a period which is coming to an end this year. India noted that there still remain 17 NSGTs, which are in various stages of the decolonization process on the agenda of this committee.

"We need to step up our efforts to conclude this longdrawn process," India said.

SC To Examine If Educational Institutions, Varsities Fall Under Consumer Law



he Supreme Court has agreed to examine the question as to whether an educational institution or university can be sued under the consumer protection law for deficiency in services, saying there have been "divergent views" of the top court on the issue.

A bench of Justices D Y Chandrachud, Indu Malhotra and Indira Banerjee has admitted an appeal filed by Manu Solanki and other students of a medical course against Vinayaka Mission University at Salem in Tamil Nadu, alleging deficiency in services.

"Since there are divergent views of this Court bearing on the subject as to whether an educational institution or University would be subject to the provisions of the Consumer Protection Act 1986, the appeal would require admission. Admit." the top court said in its order of October 15.

It asked lawyer Soumyajit, appearing on behalf of caveator university, to file the response within six weeks to the appeal filed against a decision of the National Consumer Disputes Redressal Commission (NCDRC).

The university has relied upon apex court judgments in the Maharshi Dayanand University and in the PT Koshy cases to say that these verdicts have held that the education is not a commodity and educational institutions are not providing any kind of service. Hence, in matter of admis-

sion and fees, there cannot be a kind of service and therefore, there cannot be a question of deficiency of service to be adjudicated upon in consumer forum or commissions.

The students, however, cited other judgments in which it has been held that educational institutions would come within the purview of the Consumer Protection Act, 1986. Solanki and eight other students of the a medical course of the university had sought a compensation of Rs 1.4 crore each alleging deficiency in service and on account of "loss of social standing, academic years, career opportunities, mental and physical agony".

They alleged the university induced them to take admission in the course on a false assurance that it had all the requisite approvals from the authorities.

The students were admitted in the offshore programme in 2005-2006 comprising of two year study in Thailand and twoand-a half year study in the university here, the plea said.

The students were assured that they would be getting their MBBS final degree conferred by the university and recognized by the Indian Government and Medical Council of India. However, after two years of study in Thailand, the students were informed that they should continue their course at Thailand and would be conferred a Foreign Medical Degree and should subsequently appear for screening test in India, the plea alleged.

The students said they suffered loss of career opportunities as the National Board of Examination said that their qualification was "not a primary medical qualification since the Degree is not recognized by the Medical Council of India or the Council of Thailand".

The hospital staff asked her to get admitted to the dedicated COVID centre, but she escaped from there, they said. Meanwhile, the woman's husband filed a police com-


