Covid Toll Crosses 1500 **Mark With 12 More Deaths**

SRINAGAR: As many as twelve more people succumbed to coronavirus in Jammu and Kashmir on Tuesday, taking the numbers of deaths in the Union Territory due to the virus past 1500 mark.

Kashmir valley reported eight more deaths while four more people succumbed to the deadly infection in Jammu division, officials said. In Valley, six of the victims were residents of Srinagar city and one each from Anantnag and Kulgam districts of south Kashmir.

The victims from Srinagar include a 45-year-old male from Makhdoom Sahib, a 63-year-old from Shaheed Gunj, an 80-yearold woman from Lasjan, an 80-year-old man from Soura, a 50-year-old man from Rawalpo-

SRINAGAR: In what could be a worrying sign for the educated and jobless youth in Jammu and Kashmir, the unemployment rate in the Union Territory has reached to 25 percent, double than the national average. Jammu and Kashmir Union Ter-

ritory, which was stripped off semiautonomous states by the BJP-led government, last year, has 65 percent population under the age of 35 years. If the official figures are to be believed, 25 percent youth in the Union Territory remain unemployed, despite tall claims of recruitment drives by the successive governments.

Pak Targets Border Posts In Kathua

IAMMU: Pakistani Rangers overnight targeted border out posts (BoPs) and villages at five places along the International Border in Kathua district of Jammu and Kashmir in violation of the ceasefire agreement, drawing strong retaliation from the BSF, officials said on Tuesday.

The unprovoked firing from the Pakistan side in Chandma, Faqeera, Londi, Satpal and Karol Krishna in Hiranagar sector started around 9:45 pm and the exchange of fire between the two sides continued till 4:25 am, the officials said.

There was no report of any casualty or damage on the Indian side. The firing triggered fear among border residents who were forced to spend the night in underground bunkers.

Tracing Missing History In Kashmir's Abridged Archives

uelled by his grandfather's homeland history lessons, Tawqeer recently decided to visit some renowned libraries to unravel the valley's remorseless past. The 22-year-old iournalist was told that the archival data about Kashmir's chequered history calibrated itself among the richest in the world.

It was the crispy cold morning of October 19 and the first stop for the millennial was the Allama Igbal Library located in the footsurrounded by the still surfaced beauty of the Dal-Lake.

With the end of the Chak dynasty's "generous" reign in Kashmir and with the dawn of the Mughal rule in the valley, the chroniclers write, the history of Kashmir transformed into a decades-long conflict and carnage. Kashmir never witnessed a "peaceful reign" after the imprisonment of Yusuf Shah Chakthe last Kashmiri Badshah of Shah Chak dynasty- by Akbar in 1586 AD.

As Tawqeer stepped into the library, the smell of books and outdoor placed archived photos were enough to coerce the young boy hills of the Zabarwan Mountains to hasten towards the capacitated premises of the library. The millen-

historical documentation on Dogra reign in Kashmir. He found only four books in the sea of paper.

After perusing the index of all the four, the only information Tawqeer could perceive was the commerce sector under the Dogra rule.

Notably, the archives on Laws, treatment of Kashmiris, and punishments for crimes were still unfound. Once again the impassioned boy's hasten search for archives flared up.

Except for four books nothing else was available.

The PAGD asked how the Alienation of Land Act could be termed archaic when it prohibited transfer of land to a non-state subject thus protecting the interests of the permanent residents of Jammu and Kashmir and at the same time, made a provision for transfer of land by mortgage to organisations like Industrial Development Bank of India, Industrial Credit and Investment Corporation of India to keep pace with industrial development.

"The repeal of the Act now allows the land to be transferred to nonstate subjects, denuding the residents of Jammu and Kashmir of their land, it is stated, is mere eyewash as the amendment introduced in Land Revenue Act provides for permission to sell the agricultural land almost at mere asking without difficulty.

"The abolition of Big Landed Estates Abolition Act, 1952 and amendments in Agrarian Reforms Act, 1976 is against farmers and to remove the ceiling on acquisition. The changes in Development Act and creation of 'security zones' to avoid adherence to the rules and regulations as regards construction activities in such zones and exclusion of oversight by expert bodies, environmental activists and civil society groups is bound to put at peril ecosystem in fragile environmental areas like Gulmarg, Pahalgam and Sonamarg already under pressure beyond their carrying capacity," the PAGD statement said.

The laws now introduced through amendments are not only "against people of Jammu and Kashmir" but "undemocratic, unconstitutional and backward looking with only aim to disempower people and change the demography," it added.

"The amendments introduced in the Land Revenue Act is unacceptable to people of JK and Ladakh," the party said.

"The laws now introduced were aimed at disempowering people, which is not only unfortunate but a serious matter and must be nullified in order to put an end to the fear and chaos that has struck the people in shape of new land law," it added.

Pakistan's statement came in response to MEA spokesperson Anurag Srivastava remarks, who has said that India opposed any material changes in GB claiming it to be part of Indian territory.

However, Pakistan maintains that the decision is part of what it called longstanding demand of the people of GB.

"Administrative, political and economic reforms were a longstanding demand of the people of GB. Envisaged provincial reforms reflected the aspirations of the indigenous populace of the region." Chaudhri. "Pakistan calls upon India to immediately end its illegal and forcible

Jaipuriar said that the airport authority has roped in a private laboratory, Genestrings Diagnostic Centre Pvt Ltd, for the facility. The laboratory is already empanelled by the Delhi government for Covid testing in the national capital.

DrRajatArora, director, Genestrings, informed that the laboratory will be starting off with one functional set-up including a provision to start the second one immediately, if the demand arises. "Each manned counter can conduct upto 50 registrations per hour, in-

cluding billing & registration. The capacity can be increased by adding a number of billing & registration desks," he said.

"Sample collection booths can collect approximately 120-130 samples per hour. The lab will be getting a disclaimer signed from each passenger at the time of testing, wherein the passenger agrees to take full responsibility to follow all government mandated laws including quarantine, if they are found positive," Arora added.

In September, DIAL had launched the first-of-its-kind on-site Covid-19 testing facility for arriving international passengers. The facility came up in a 3,500 square feet area facility at multi-level car parking (MLCP) of Terminal 3.

Omar Abdullah's Matrimonial Woes

HC Dismisses Plea Challenging Order On Final Hearing

New Delhi : The Delhi High Court Tuesday dismissed former Jammu and Kashmir chief minister Omar Abdullah's plea challenging its circular of April mandating that both parties in a case have to agree for the final hearing to be taken up early via video conferencing mode.

Omar had contended that his matrimonial appeal against a 2016 trial court order, which dismissed his divorce petition, has been listed for final hearing since February 2017.

It was not taken up during the restricted functioning of the courts in view of COVID-19 pandemic as his estranged wife, Payal Abdullah, did not give consent to virtual proceedings.

Due to the lack of cooperation by his estranged wife the matter was getting delayed, Abdullah contended.

A bench of Justices Hima Kohli and Subramonium Prasad, however, declined to grant any relief saying lack of cooperation of his estranged wife was not a ground for challenging the high court's April 26 office order.

"Simply because the respondent 2 herein (Payal Abdullah) was not consenting to an early hearing, can hardly be a ground to assail the office order. The petition is dismissed as meritless," the bench said.

Omar had moved an application seeking early hearing of his appeal in July.

The high court had declined to entertain it saying that its Registrar General has already issued a circular stating that during the restricted functioning of courts due to COVID-19, a request for final hearing of pending matters will be entertained only if both the parties agree.

"In view of the fact that this application is not accompanied by any consent from the other side (Payal) and nor is the counsel for the respondent present in the hearing, though we are informed that an advance copy of the application was served on him, we are not in a position to accede to the prayer made in the application," the high court had said and dismissed the application.

On August 30, 2016, the trial

court had dismissed Omar's plea seeking divorce from Payal saying he had failed to prove irretrievable breakdown of the marriage.

The trial court had said that Omar could not prove his claims of "cruelty" or "desertion" which were the grounds alleged by him for grant of decree of divorce.

"The petitioner (Omar) has not been able to explain a single circumstance to show that the supervening circumstances have erupted which has made it impossible for him to continue his relationship with the respondent (Paval).

"Rather, evidence shows that they were in continuous contact till the filing of the divorce petition," the trial court had said in its order, adding that "there is not an iota of evidence in regard to the circumstances which have prevailed to prompt the petitioner to file the divorce plea".


It had further held that Omar "failed to prove his case for divorce on ground of cruelty".

In his plea seeking divorce, Omar had claimed before the trial court that his marriage had broken down irretrievably and he has not enjoyed a conjugal relationship since 2007 and that the couple, married on September 1, 1994, were living separately since 2009. The couple have two sons who are staying with their mother.

The petition before the trial court had also alleged that Omar was subject to "unreasonable conduct" of Payal, causing pain and harassment to the politician.

The Buildings Bye-laws of Jammu Municipal Corporation (JMC), Srinagar Municipal Corporation (SMC) and other Municipal Bodies were notified in the year 2011. Since then, large scale developments have taken place in the fields of sustainability, Energy Conservation Building Code (ECBC), rain water harvesting, Green Buildings etc. Meanwhile, Bureau of Indian Standards has issued the National Building Code 2016 (NBC) and the Ministry of Urban Development, GoI has issued the Model Building Byelaws 2016. Further, the Bye-laws of 2011 did not provide an elaborate mechanism for building permit process. This has necessitated to revisit the existing Bye-laws to make them more comprehensive and consistent with the state of practice.

Preparation of a uniform building and building bye-laws code ab-initio is an arduous task. The draft "JAMMU and KASHMIR MODEL BUILDING BYE-LAWS AND BUILDING CODE-2020" have been prepared with the assistance of experts / professionals from the relevant fields after taking into account the National Building Code 2016 and Model Building Bye-laws 2016. The new Bye-laws and Building Code are expected to serve twin objectives (i) simplify the procedure for building permits and streamline the entire process and (ii) ease of doing business.

The draft "JAMMU & KASHMIR MODEL BUILDING BYE-LAWS AND BUILDING CODE-2020" are accordingly notified for inviting suggestions / objections from all stakeholderscitizens, developers, builders, government departments, housing cooperatives and other agencies—to enable incorporation of useful suggestions to make the new Bye-laws/ Building Code comprehensive, progressive and relevant to the state of practice. Reports said Agha Mahdi was on his way to Sofi mohalla, Magam, to attend the Walima function of one of his disciples, Ghulam Ahmad Sofi, When his vehicle reached a point near a flour mill between Mazhama and Kawoosa villages, 5 km from the destination, it stumbled on the landmine. In the ensuing blast, Mahdi and others with him were blown, along with the vehicle.

Soon after the news reached nearby Magam, life in the township came to a standstill with shopkeepers pulling down their shutters and people converging on the streets to stage demonstrations, Tension also gripped in Budgam, the district headquarter, and thousands of abated people gathered out-side the residence of slain leaders father, Aga Mustafa.

Reports of angry people taking to the streets have come from various places on Srinagar Baramulla highway. Ac¬cording to CNS, irate mobs at Hartrath Singhpora beat to death one Meraj-ud-din Dar and set ablaze six residential houses. Vehicular traffic on the highway was disrupted for several hours-Reports of stone pelting have also come from Saidakadal and Nigeen areas of the city.

Mahdi shot into prominence in 1997 when he, though a big crowd-puller because of his father's clout, unsuccessfully contested on Congress ticket against the National Conference candidate and chief minister's son, Omar Abdullah. Earlier, he had contested against the Muslim United Front (MUF) can-didate as an independent from Budgam constituency in the rigged 1987 assembly poll. He also fought assembly elections in 1996 as 'Congress candidate but resigned before he contested parliamentary elections in 1998 as an independent candidate

Another prominent pro-India Kashmiri Shiite leader, Maulvi Iftikar Hussain Ansari survived two attempts on his life this year. While Maulvi was slightly injured and three po-lice personnel were killed in a powerful landmine explosion at Matipora village in September in an earlier attack 16 of Maul¬vis followers were killed when a mine exploded in midst of a Majlis Hussayni at Gund Khwaja Qasim in June this year.

Eyes on the US

he US has voted for the election of its next president. And it is not an easy election. Its outcome will not be only about who won or lost but also about the ideological direction America will be taking in the next four years. Though Joe Biden is expected to win he doesn't enjoy any clear lead over the incumbent. Trump and his allies have already made it known thst they will challenge the results of the election if he loses. So, unless Biden wins with a clear majority, Trump seems unlikely to go away quietly.

Import of shift in power in the US can't be overemphasised for the world. Under president Trump American democracy has undergone a drastic turn to the right and an extreme fringe in the US politics has become the mainstream, something that once was thought to be unthinkable. The change has been even more drastic than it was in India. Here the Prime Minister Narendra Modi was a very popular candidate. He had won BJP three successive terms in Gujarat. And his hardline Hindutva politics had already won him a significant number of admirers from across the country.

Trump earned this spurs by pandering to the basest prejudices of the white Americans. This made much of the world including a significant population of America apoplectic. To get a sense of what Trump as US president meant for US and the world can be gauged from his abusive campaign

In his just concluded first term Trump has uninhibitedly aired views that even the radical right in America has traditionally refrained from uttering. His hate against Muslims and non-whites has been in-your-face and unreserved. In power he went a long way to translate his campaign promises into action to stay true to his voters. And it is here that the problem started as it put on line the very idea of America conceived by its founders.

There's now hope that Biden, in case he wins, will make a redeeming difference. He has already been the US Vice President during presidency of Barack Obama. He is expected to bring back Obama's policies. More importantly, his presidency will go a long way to discourage what is called the "pandemic of authoritarianism" in the world. The US under him will again be expected to lead on human rights. And under Trump, on the other hand, it will be more of the same. But until the results are announced we can only keep our fingers crossed.


Guarded optimism

een against the depths to which economic activity had plummeted in the initial phase of the national lockdown, the sequential improvement in economic indicators over the past few months suggests that the process of normalisation of economic activities is well underway.

On the production side, signalling a continuing pickup in the supply side, the Nikkei's manufacturing purchasing managers index, released on Monday, rose to 58.9 in October — indicating the fastest expansion in factory output in over a decade. Similarly, the index of eight core industries in September was almost at the same level as last year, with coal, electricity, and steel swinging into positive territory. On the consumption side, indicating a pickup in demand, the goods and services tax collections for the month of October rose to an eight-month high of Rs 1.05 lakh crore — 10 per cent higher than collections over the same period last year. This sequential improvement in economic activity is also reflected in preliminary results of corporates for the second quarter of the current financial year, which indicate a turnaround in performance after the col-

lapse in the first quarter. Yet, this optimism needs to be tempered. For one, part of the recovery in economic activities can be traced to the ongoing festive season. Whether this momentum sustains, or the extent to which it sustains, beyond the months of October and November remains to be seen. Then, there is the possibility of a surge in COVID-19 infections during the festive season, which could heighten risk aversion. This coupled with continuing income uncertainty could adversely impact the growth trajectory going forward, though its impact will be visible with a lag.

Many shades of Kashmir Normalcy

Fifteen months after Article 370 move, as businesses tentatively re-open and public transport is back on roads, it doesn't mean there's calm

Fifteen months later, as Kashmir anxiously looks forward to future. businesses are tentatively re-opening and public transport is returning to roads following eleven months of siege, five months of them spent under Covid lockdown. Does it mean normalcy? Far from it.

ver since abrogation of Article 370 that granted semi-autonomous status within India, there has been this huge debate about the lack of public protests in the wake of the extraordinary move. A general opinion goes that there were no mass scale protests as were otherwise expected. Over the last year this opinion has not only gained wide currency but is also accepted without any objection. In fact, the Kashmiri politicians who now make up the People's Union for Gupkar Declaration struggle to answer this question. They either unconvincingly talk about the heightened security during the period following the revocation of Article 370 as is contended by Dr Farooq Abdullah or in case of Sajad Gani Lone, the people might choose to come out at the time of their own choosing. Omar Abdullah, on the other hand, has almost blamed people for not protesting at all.

ticle 370 move, Commander of the Army's Chinar Corps Lieutenant General B S Raju has said that the Valley is "past the stage of uneasy calm," meaning the region is perfectly normal.

But are things really so? Or were they so last year? The reality, however, is largely contrary to general perception, much of which has been shaped by the hearsay reinforced by propaganda. When in the wake of the withdrawal of the autonomy, the CPi(M) leader M Y Tarigami was asked why Kashmir hadn't protested against scrapping of Article 370 on the scale it had against the killing of popular militant commander Burhan Wani in 2016, the Valley's major communist party leader answered with a counter question: "Have you ever heard of protests taking place in Tihar

As is obvious, Kashmir, Tarigami meant, was turned into one of India's largest jails and this had made mass scale protests impossible in the newly created union territory. This has certainly been the case: Kashmir had been put under a sweeping security lockdown and a communication blockade that not only barred people from hitting the road but also invisibilized

the protests that took place after

But this isn't entirely how an anticipated revolt in Kashmir following revocation of Article 370 was pre-empted: the lockdown and communication clampdown even though unprecedented in nature, were just the manifest security tactics to deal with a potential eruption. The real work to forestall protests comprised a complex set of actions sequentially performed on many fronts.

As the clock struck midnight hour on August 4, 2019, the day before Article 370 was withdrawn, Kashmir found itself snapped from the world: Kashmiris woke up to no phones and no internet. Not even landlines worked. Almost all major leaders across the mainstream-separatist divide including the three former Chief Ministers Dr Farooq Abdullah, his son Omar Abdullah and Mehbooba Mufti - had been arrested. The arrestees included political activists, youth, among them 956 former alleged stone-throwers and even business leaders. Many of them were shifted to major jails across India and a significant number of them continue to lan-

guish there. When on August 5 at around 11 am the home minister Amit Shah announced the repeal of Article 370 in parliament, Kashmiris, disconnected from one another, could only react to it in disbelief individually. Their ability to organize had been broken. There was no leader still active on the scene, no functional political or social organization which could do this. And even if there were, they wouldn't be able to communicate: for example, the militant leaders who would use social media to

convey their programs. Though newspapers started publishing after a gap of few days, they did so by downloading content at a government run facility for media. And being already disciplined, they published little that concerned the ongoing situation. Chary of having to take a position on the situation, they went without editorials. Their opinion pieces talked of health, environment and international issues.

This razing of Kashmir's political and social organizational structure hardly ruled out spontaneous public mobilizations. So, to pre-empt it, security personnel in significant numbers were stationed along streets and at the entry and exit points of Srinagar and the major towns, within localities

But this still didn't entirely prevent protests. Without anyone calling for it, Kashmir observed complete shutdown for 105 days. Public transport remained off the roads. By government's own admission, there were more than 300 instances of 'law and order issues". One of the biggest protests was taken out by people at Anchar in the outskirts of Srinagar and was participated by around 10,000 people. But it was stopped before it could enter the barricaded densely settled parts of the main city. Subsequent attempts by people at Anchar were similarly thwarted, and so were those from the other areas.

Fifteen months later, as Kashir anxiously looks forward to future, businesses are tentatively re-opening and public transport is returning to roads following eleven months of siege, five months of them spent under Covid lockdown. Does it mean normalcy? Far from it. Kashmir remains without high-speed mobile internet. All kinds of protests are strictly barred including a peaceful silent march. Last year in October around two dozen women who had tried to hold one such protest were quickly hauled off to a lock-up and released only after signing a bond that they won't do so again.

Kashmir has now something resembling a working political organization in the form of PAGD. It is in a position now to articulate the sentiment of the people or formulate a response to the current crisis. But given New Delhi's nervousness about an organized mass resistance to its Article 370 move at a time when the world's attention hasn't veered off from Kashmir, it looks unlikely that the erstwhile state will be allowed to have a normal political and civil society activity anytime soon.

Qasidat Al-Burda of Imam al-Busiri

We've all grown up reciting these popular verses of Qasidat al-Burda,"Maula Ya Sali wa sallim". It is a thirteenth-century ode of praise for the Islamic prophet Muhammad (peace be upon him) composed by the eminent Sufi mystic Imam al-Busiri of Egypt

To this day its verses are recited for protection and as an appeal to the divine for the restoration of health. as well as during the lowering of bodies into their final abodes.

he Burdah of al-B r is from among the most famous poems composed in honor of the Prophet Mu ammad. It has been adored by Sufis who have written commentaries upon it, abridged and augmented it, and composed poems imitating its distinctive rhythmic patterns. Scores of commentaries and books about the Burdah have been composed not only in Arabic but in the diverse languages of the Muslim world.

Among many of the Sufi orders, The Burdah has been adopted as one of the awr d (litanies) recited in the mornings and in the evenings with utmost reverence and with the deepest solemnity. To this day its verses are recited for protection and as an appeal to the divine for the restoration of health, as well as during the lowering of bodies into their final abodes. Meticulous rules have been devised for its proper recitation, such as having wu (ritual ablution), orienting oneself towards the qiblah (i.e. the Ka ba in Mecca), and so forth

Im m Ibn ajar al-Haytam (d. 974/1567)1, a mere couple of generations removed from al-B $\,$ r , wrote of the Burdah that, "its popularity has grown to the degree that people study it in their homes and mosques as they do the Qur n". For this reason famous gatherings were convened to recite The Burdah in the Levant, in Egypt, and in the Maghreb, especially on Thursday nights. During such gatherings, one person would be designated to recite the poem either meter by meter or verse by verse, punctuated by the entire gathering's synchronized recitation, in one voice, of the famous chorus:

"Mawl ya alli wa-salim d im n abad n/ al ab bika khayr al-khalqi kullihimi"

"Our Master, send Your Everlasting, Eternal prayers and salutations/upon Your Beloved, the Best of Creation in all of its entirety"

Indeed, Muslims over the centuries have continued to teach their children the blessed Burdah alongside the noble Qur n in the mak tib (neighborhood schools devoted primarily to the teaching of Arabic and to the memorization of the Qur n). In this way, they sought to fuse in the youngest of minds and in the tenderest of hearts the noble Qur n – which is the fount of all knowledge – with The Burdah, which articulates the purest, most intense feelings of affection towards the Prophet . It was in this fashion that traditional Muslim societies sought to establish the foundations of a firm, unshakeable faith in the hearts and minds of their young – a faith which they well knew could not be established except upon the basis of deep, profound love.

Al-B r studied Sufism with his Shaykh, al-Im m Ab al-Abb s al-Murs , who was the disciple of al-Im m al-Sh dhil , and received instruction alongside none other than Ibn A ill h al-Iskandar (d. 709/1309), who authored the ikam. There was between Ab al-Abb s al-Murs and al-B r a relationship of deep love. Al-B r became famous on account of his broad knowledge of the scriptures of the People of the Book, as he would read extensively from the works of the Chris-



tians and the Jews. This knowledge compelled him to debate their beliefs and doctrines, which he did with great depth and understanding.

Im m al-B r lived through difficult times and endured tremendous tribulations. He was an ascetic from among the people of spiritual aspiration (himma) and worldly contentment (qan ah). He was simultaneously afflicted with severe poverty, a great many dependents, and an ill-mannered and hostile spouse. Nonetheless, he never became exasperated or disheartened because the teachings of the Sufis blocked the windows of despair in his soul and instead opened the doors of hope and of loftier ambitions that transcended worldly motivations and concerns.

Al-B r began his literary life as all poets then did, by endearing himself to those in power and to the affluent, seeking their patronage and benefaction, covetous above all of their attention and support. Once al-B r embarked upon the path of Sufism, however, his soul came to detest this lifestyle, and he instead devoted himself to praise of the Prophet Mu ammad , to praise of the family of the Prophet Mu ammad , and to praise of the Sufis from among his contemporaries and teachers, such as Ab al-Abb's al-Murs and Ab al-asan al-Sh dhil, may God have mercy upon them all.

Al-B r was particularly absorbed by the S rah of the Prophet , reading all available literature on him

- from the short, individual reports conveying the finest of details about the Prophet to the larger compilations aggregating his blessed biography. He committed his energies, and devoted his poetry and artistic mastery, to praising the Prophet. Among his most famous poems is al-Kaw kib al-Durriyyah f Mad Khayr al-Bariyyah ("Celestial Lights in Praise of the Best of Creation"), better known simply as al-Burdah, which is from among the jewels of Arabic poetry and from among the most exquisite poems exalting the Prophet. It is the crown jewel of the vast genre of poetry composed over the centuries in praise of the Prophet Much

posed over the centuries in praise of the Prophet Muhammad, bestowing inspiration upon countless poets over the ages. It is a long poem which spans 160 verses, and its prelude is from among the most striking opening lines of any Arabic poem. It is said that al-B r suffered a stroke which debilitated him, so he composed the Burdah as an appeal to the Divine for the restoration of his health. After composing the poem, al-B r lay down to rest, only to see the Prophet in a dream. After reciting his poem to the Prophet, the Prophet wiped his honorable hand upon al-B r's afflicted body. Al-B r awoke and arose from his sleep to find himself, with the permission of God, completely healed.

Imam al-Busiri passed away in Alexandria in 695 AH/1295 AD at the age of 87. Ra imahu All hu Ta ala.

Remembering Robert Fisk: A mentor The veteran reporter taught me an important

The veteran reporter taught me an important lesson: 'Tell the story, whatever the consequences.'

he only book Robert Fisk ever recommended I read was the satirical journalism novel – Scoop – by Evelyn Waugh – a story about hapless nature writer William Boot who, due to an unexpected turn of events, is sent to the fictional African country of Ishmaelia to report on the conflict there as a foreign correspondent.

When I received the news that he had passed away, scenes of my interactions with him replayed in my mind. Somehow the day he recommended Scoop was one of the brightest memories among them – it has since become one of my favourite books.

The novel is a pure satire that takes aim at the newspaper industry and the journalistic profession. It is a rather interesting read to recommend to an aspiring young journalist. But that in itself is emblematic of how he was as a person, or at least of how I knew him: Kind-hearted with a great, and oftentimes sarcastic, sense of humour; an empathetic, radiant and intelligent man.

I first met Fisk in Beirut in April 2017 when I was in my second year of college and had just completed a journalism internship in Tehran, Iran. I had switched majors to journalism after reading his book, The Great War for Civilisation, and know that I am not the only one to have been inspired to enter the profession by his extensive, award-winning reporting.

In my first year of studying journalism, I knew two things: That I wanted to work in the Middle East and that I wanted to meet Fisk. So when, during my internship in Iran, I managed to find his personal email, I messaged him. I would soon be in Beirut for a week, I wrote; would he be willing to meet?

To my greatest surprise, he replied. He would be happy to, he said, and asked me to call when I arrived. They say, "never meet your heroes". But that is a sentiment I have never subscribed to. As a journalism student and an aspiring journalist, I have reached out to several of mine – asking for advice, a potential interview or just trying to expand my professional network. Most of them quickly set about crushing the idealised image I had constructed of them in my mind.

But Fisk was the very opposite of that – and not just to me. He would often speak highly of junior colleagues he had worked with or met while reporting. And for such an acclaimed veteran reporter, he was surprisingly approachable. No matter how busy he was – reporting, lecturing, writing books – he always made time for me whenever I reached out.

The first time I met him, he invited me along for a coffee with him and a Beirut-based artist he was interviewing for a piece for The Independent at a restaurant on the Corniche in Beirut.

A few days later, when, with very little notice, I asked if I could interview him about US President Donald Trump's policies in the Middle East for a Belgian publication I was freelancing for at the time, he immediately obliged.

Later that year, when he came to Belgium to give a lecture on the refugee crisis, he invited me along and kindly offered his afternoon that day to any questions I had for him. I had four hours' worth of them. And now I realise how many more I have left that I wish I could ask.

When I was trying to find a way to go to Yemen to report on the humanitarian crisis there for my final year thesis, he never invalidated my ambitions. Instead, he advised me on how best to proceed, who to contact and how to stay safe.

He gave me decades' worth of advice that I have taken to heart and always try to apply to the way I work.

Back in 2017, when I had interviewed him for the Belgian news outlet, in an

Italian restaurant located above the water on the Corniche – which has now unfortunately closed – I had weaved into my article his choice of drink. His response: "I am also grateful that, even if I do drink 'gin-tonic' at the restaurant, I am also 'energetic, alert and sharp' – which is true!"

But despite his energy, alertness and humour, there was a cynicism and weariness about him. "I hardly have time to go to Yemen, I'm exhausted," he told me. "I'm still tired from Syria, you know. We all are, it doesn't matter how old we are, we don't have enough reporters."

Fisk thought it was important that journalists should burn with a "rigorous determination to tell the truth" and he was a supportive and understanding

When I struggled to find an outlet for my reporting from Yemen, with some news organisations turning it down citing "security reasons", he wrote in an email: "I'm very sorry to hear of the outrageously poor response to your report on Yemen and can well imagine your disgust with journalism. I need hardly add that everyone feels that way, especially at the start." Although he was from a very different generation of reporters, he understood the difficulties faced by freelance journalists across the world today.

I persevered and the report turned my home nation's attention to the disaster taking place in Yemen. I thanked him for his support in an SMS, to which he did not respond.

When I was doing my internship with Al Jazeera in 2018, he called me a couple of times to ask how it was going. Even though we did not talk often, I tried to stay in touch and write regularly. I would update him on life events – getting a job, being accepted for my master's degree –

and every response from him meant a lot.

"Have not forgotten, Katya – just snowed under with work. Your request is in my diary entries (hand-written of course)," he replied after I had asked him if he would write me a letter of recommendation for law school a few months ago.

He wrote a beautiful letter; a paragraph of which I often reflect on when considering the criticism he faced during the last decade of his life by critics who accused him of siding with the government of Syrian President Bashar al-Assad in his reporting on the war in Syria.

This is what he wrote:

"Especially now – and especially in the Middle East region – journalists experience ever greater pressure to adopt a 'safe' perspective in order to avoid criticism from governments, pressure groups and lobbyists. Ms Bohdan's reporting from Yemen, which required courage as well as great resourcefulness, was proof of her desire to 'tell the story' whatever the consequences."

I cannot be sure, but I suspect this encapsulates what he may have thought of the criticism of him. And although there are points on which he and I openly disagreed, I always found him to be a proponent of healthy dialogue and discussion. He was attentive and I never witnessed him undermine an opposing opinion. I have always thought that the way a senior professional treats a junior colleague is a sign of one's integrity or lack thereof. For

me, his was never in doubt.

He was respectful, responsive, understanding and encouraging. He always gave advice when asked for it, but never offered it unsolicited. He was, in short, a true mentor, although I never told him that – fearing it sounded like too much of a cliche. I really hope he would not mind if I told him now.

Starting Kindergarten On Right Foot May Lead To Better Achievement Over Long-Term

new study led by researchers at Canada's Universite de Montreal and Universite Sainte-Anne advocate that a good start at kindergarten can lead to better achievement over long-term, for a child.

The study was published today in Pediatrics.

'We've known for years that getting off to a good start in kindergarten leads to better achievement over the long-term," said lead author Caroline Fitzpatrick, an assistant professor of psychology at the USA, in Nova Scotia.

"But now with our study, we can really lock in the idea that early childhood skills help you achieve success and adopt a healthier lifestyle in emerging adulthood. And that's promising for society as a whole."

"Many children begin kindergarten inadequately prepared to benefit from classroom instruction," said senior author Linda Pagani, a professor at UdeM's School of Psycho-Education.

"Those who go in unprepared risk struggling throughout their academic journey. They arrive without the necessary tools in terms of cognitive skills. social skills and motor skills from physical activity", added Pagani, who is also Senior researcher at CHU Sainte-Justine pediatric hospital in Montreal.

Math skills important

Fitzpatrick and Pagani examined associations between kindergarten readiness and academic, psychological and health risks that manifested themselves when a child reached the end of high school.

"Kindergarten math skills contributed to better end-of high-school their involvement in physical activity, achievement and a lower dropout and their height and weight. The droprisk, and that was supported by ob- out risk was also estimated for each will promote kindergarten readiness."



servations from teachers, who also participant based on their grades renoted a reduced risk of substance abuse, later on, said Fitzpatrick.

"Kindergarten classroom engagement also predicted involvement in physical activity and a 65-per-cent drop in the risk of a child being over- academic, psychological and health weight by age 17," added Pagani, who worked on the study with UdeM postdoctoral researcher Elroy Boers.

The authors came to their conclusions after examining Institut de la Statistique du Quebec data from a cohort of 2,000 children born in 1997 or 1998 who were part of the Quebec Longitudinal Study of Child Development.

At age 5, trained examiners assessed each child's knowledge of numbers and their receptive vocabulary. Each spring, teachers reported kindergarten classroom engagement, such as how a child did tasks, followed directions and worked with others. At age 17, participants reported on their academic grades, their feelings of connectedness, whether they abused drugs or alcohol,

Chomsky: 'Trump's Victory Could Destroy The Planet'

Washington: Leading American political analyst and philosopher Noam Chomsky has said that US President Donald Trump's denial of climate change represents worse threat to humanity than Adolf Hitler.

In an exclusive interview with The Independent pub-



lished on Sunday, the celebrated linguist and media critic said he believes Trump's victory in the November 3 election could send the planet hurtling further towards environmental catastrophe.

He said the Republican Party is the world's only large conservative political grouping to deny the existence of climate change, adding that he has identified several patterns over the course of the Trump presidency.

"One is to tear up any deals in which he played no part in creating, such as the 2015 Paris Accord to try and limit the planet's warming, which Barack Obama helped to broker, and from which Trump has withdrawn the United States,3 the newspaper reported.

"He didn't create it, destroy it, OK," Chomsky was quoted saying.

Chomsky also made a comparison between Trump and Adolf Hitler, adding that the threat represented by the heating planet is unprecedented.

The facts are pretty straight; there is almost universal consensus among serious scientists that we are racing towards the cataclysm, if current tendencies persist," the 91-year-old said.

"By the end of this century, you might have reached the level three, maybe four degrees Celsius above pre-industrial levels. And every analysis concludes that's a total cataclysm. Organized human societies nothing survives," he said.

"We are moving towards cataclysm. There is one country in the world, the United States, that wants to put its foot on the accelerator," he continued.

The public intellectual and activist, whose many celebrated works include Manufacturing Consent, said the issue of the global coronavirus pandemic can be resolved, but not with "malignant cancer in charge of the policies - someone who moves to destroy anything that doesn't improve his electoral chances"

Tehran: Ayatollah Ali Khamenei reiterated a long-standing Iranian position that it didn't matter whether Trump or Joe Biden wins the vote, but the stakes couldn't be higher for the Islamic Republic.

Tehran: Iran's supreme leader mocked America's presidential election Tuesday in a televised address, quoting President Donald Trump's own baseless claims about voter fraud to criticise the vote as Tehran marked the 1979 US Embassy hostage crisis.

Ayatollah Ali Khamenei reiterated a long-standing Iranian position that it didn't Biden wins the vote, but the stakes couldn't be higher for the Islamic Republic.

Another four years could see Trump's maximum-pressure campaigns further expand as it crushes the Iranian economy and stops Tehran from openly selling its crude oil abroad. Biden meanwhile has said he would consider reentering Tehran's 2015 nuclear deal with world powers, providing possible relief to the beleaguered Iranian rial.

"If you look at their own



situation, it's lovely to watch. The incumbent president, who is supposed to hold the elections, says this is the mostrigged US election throughout history," Khamenei said, not acknowledging that individual US states run the vote.

"Who says this? The sitting president who is arranging the elections himself. His opponent says Trump intends to widely cheat. This is American democracy." Khamenei added that the result of the vote "is none of our business, meaning it won't influence our policy at all. Our policy is clear and well-calculated and people coming and going will have no impact on it." Khamenei, 81, as supreme leader has final say on all matters of state in Iran. He approved the efforts at reaching the nuclear deal, which saw Iran agree to limit its enrichment of uranium in exchange for the lifting of economic sanctions



ISIS Cliams Kabul Varsity Attack, 22 Students

KABUL: At least 22 people were killed when attackers stormed one of Afghanistan's main universities on Monday, detonating a suicide bomb and spraying classrooms with bullets in a brazen hours-long assault claimed by militant Islamic State group.

The attack on Kabul University, which came as violence surges across Afghanistan, marked the second time in less than two weeks that educational institution was targeted in the capital by IS extremists. Survivors described horrific scenes following the incident that unfolded around 11:00am when a suicide bomber blew himself up inside the campus.

Two gunmen then started shooting, officials said, sending hundreds of students fleeing and scrambling over perimeter walls.

Gunman on the run after Vienna 'terror attack' leaves 5 dead

Vienna : Hundreds of police fanned out across Vienna on Tuesday, searching for perpetrators of attacks that left five people dead in the city's centre, after what a government minister said was an "Islamist terrorist" incident.

In an early morning televised news conference, Austrian Interior Minister Karl Nehammer repeated calls for the public to stay off the streets.

Nehammer said police had shot to death one attacker, a man wearing an explosives belt that turned out to be fake, whom authorities have identified as an Islamic State sympathiser.

The attacks, in six locations including near a synagogue in the centre of town, were carried out by "several suspects armed with rifles", police said.

Police said three people had died, with public broadcaster ORF stating one of them was a passer-by.

Vienna mayor Michael Ludwig told ORF that 15 people had been taken to hospital, seven of them seriously wounded.

Broadcaster ORF later said a fourth civilian, a woman, had died. Police stated earlier that an

officer had also been hurt during the assaults. The shooting began just hours before Austria was to re-impose a coronavirus lock-

Armenia calls for probe into 'foreign mercenaries' in Karabakh

Armenia's Yerevan/Baku: prime minister called on Monday for an international investigation into the presence of "foreign mercenaries" in Nagorno-Karabakh after ethnic Armenian forces said they had captured two mercenaries from Syria.

Azerbaijian has repeatedly denied the presence of foreign combatants in the conflict zone. Its ministry of defence was not immediately available for comment.

Fierce battles continued near the front line of the conflict over the mountain enclave and seven surrounding regions in which more than 1,000 people, and possibly many more, have been killed since fighting erupted more

Nagorno-Karabakh is internationally recognised as part of Azerbaijan but is populated and controlled by ethnic Armenians.

The conflict has brought into sharp focus the increased influence of Turkey, an ally of Azerbaijan, in a formerly Soviet region considered by Russia to be in its sphere of influence.

Russia has a defence pact with Armenia.

Armenia's foreign ministry said on Monday the Artsakh Defence Army, its name for the ethnic Armenian forces in Nagorno-Karabakh, had captured a second Syrian combatant over the weekend.

It said the fighter was from Syria's Idlib province. Another fighter, from the city of Hama, was captured on Friday, it said.

Armenian Prime Minister Nikol Pashinyan, in a Facebook post, said the involvement of "foreign mercenaries" was "a threat not only to the security of Nagorno-Karabakh and Armenia but also to international security, and this issue should become a subject of international investigation".

The ethnic Armenian-controlled, Nagorno-Karabakh defence ministry said battles took place overnight along the northwestern part of the front line. It said it had repelled a platoon of Azeri troops in fierce fighting.

Azerbaijan's defence ministry said it had repelled an attack on its positions in the high ground of the Zangilan district, between the enclave and the Iranian border, while army units in the Gazakh, Tovuz and Dashkesan regions also came under fire. Azeri President Ilham

Aliyev wrote on Twitter that Azerbaijan had retaken a further eight settlements in Zangilan, Gubadli and Jabrayil

US Judge Blocks Republican Bid To Void 1,27,000 Votes

federal judge in Texas on Monday denied an attempt by Republicans to throw out about 1,27,000 votes already cast in the US presidential election at drivethrough voting sites in Houston, a Democratic-leaning area.

The plaintiffs had accused Harris County Clerk Chris Hollins, a Democrat, of acting illegally when he allowed drive-through voting as an alternative during the coronavirus pandemic. US District Judge Andrew

Hanen said the plaintiffs lacked standing to bring the case. "I find that when you balance the harms you've got to weigh in favor of counting the votes," he added.

The judge also faulted the plaintiffs for waiting until Oct. 28 to file their case in his court even though drive-through voting was used without challenge in July primary runoffs.

"Didn't we test this in the primaries this summer?," Hanen



said during a three-hour hearing, adding: "Why am I just getting this case?"

Jared Woodfill, a lawyer for the plaintiffs, told reporters they will appeal to the U.S. 5th Circuit Court of Appeals. They will also appeal a similar loss in state court on Sunday to the U.S. Supreme Court, Woodfill said.

Hollins told reporters that drive-through voting sites in Harris County, which includes Houston, would be open on Election Day as scheduled. "This is a huge win for democracy, especially at a time when it appears that democracy itself is on the ballot." Hollins said.

Harris County, home to about 4.7 million people, is the third-most populous county in the United States. It currently has 10 drive-through polling sites available to all voters among 800 total voting places.

ayrakli, Turkey: A three-year-old was pulled from the rubble 91 hours after a powerful earthquake hit western Turkey, killing more than 100 people, officials and AFP reporters at the scene said. "We have witnessed a mir-

acle in the 91st hour," Izmir mayor Tunc Soyer tweeted. "Rescue teams pulled Ayda out alive. Along with the great pain we have experienced, we have this joy as well."

The mayor initially said she was four years old, but Health Minister Turkish Fahrettin Koca later clarified she was three.

Ayda was rescued from a collapsed building in the Turkish town of Bayrakli, the worst affected by the 7.0 magnitude quake which struck Turkey and Greece on Friday afternoon.

ket, she called for her mother, an AFP correspondent said, as the anxious crowd broke into rapturous applause, with some hugging each other and others crying.

She told them before she was saved: "I'm here," Milliyet daily reported, which said her mother still remained trapped underneath the rubble.

The rescue came a day

after a four-year-old and a 14-year-old were found alive in the rubble of collapsed buildings in Bayrakli, providing hope that more people could still be rescued.

The deaths from the quake

rose to 102 in Turkey on Tuesday, AFAD reported, with

1,026 people injured of which 143 remain in hospital. Two teenagers on their way home from school were

also killed in Greece. Turkey has reported over 1,475 aftershocks following the

quake, including 44 that were above four in magnitude. With dozens of buildings damaged and the risk of repeated tremors, thousands of residents were forced to

spend a fourth night in tents in Izmir. The quake is the deadliest in Turkey this year after over 40 people were killed in

the eastern provinces of Elazig and Malatya in January.
