Cop Found Hanging From A Tree

Srinagar: A policeman was found hanging from a tree in Magam area of central Kashmir's Budgam district, hours after he went missing, police said. A police official said that body of the constable was found near BatporaKanihama area of Magam. The slain constable has been identified as Mohammad Ashraf son of Abdul Majeed Rather of ArchanderhamaMagam. Sources said the constable was posted at Parihaspora Pattan and was missing since last night from his home. Further details of the incident are awaited, the official added.

'Stop The Count', Trump Tweets As **Biden Inches Closer to Victory US Presidential**

Election In Limbo

WASHINGTON: Two days after Election Day, the fate of U.S. President Donald Trump and former vice-president loe Biden still hangs in the balance.

Over the last 24 hours, Biden has turned a corner. The Democratic candidate, who has been steeped in American politics for nearly a halfcentury, secured victories in Wisconsin and Michigan and retaining his electoral college vote lead over Trump.

Biden currently has 264 of the 270 electoral votes, while Trump

sits at 214. There are still hurdles to cross. Biden's victory in Michigan means he's technically one battleground state away from achieving his White House hopes, but calls for recounts could further delay determining a president-elect.

Much of the attention has now turned to Nevada, where the Biden campaign is leading slightly. A victory would clinch the state's six electoral votes – and the presidency – for the Democrats.

Trump faces a bigger challenge at this point. To achieve **PAGE 02**

LoC Heats Up In Poonch

JAMMU: India and Pakistani troops traded heavy gunfire and mortar shells ON Thursday along the Line of Control (LoC) in Poonch district of Jammu and Kashmir.

The Pakistan army violated the ceasefire thrice on Thursday by resorting to heavy firing and shelling on forward areas and posts in three sectors along the LoCin Poonch district, officials said.

The Pakistani side also resorted to firing along the International Border (IB), targeting hamlets and border outposts in Hiranagar sector of Kathua district overnight, they added.

"At about 1730 hours today, Pak army initiated unprovoked ceasefire violation by firing with small arms and shelling with mortars along LoC in Shahpur, Kirni and Qasba sectors in district Poonch," a defence spokesman said here. He said the Indian Army

mounted a befitting retaliation. On October 1, an Army jawan was killed and another injured when Pakistani troops resorted to heavy firing and mortar shelling along the LoC in Krishnagati area of Poonch district.

A soldier was killed and two others, including an officer, were injured on September 5 in Pakistani firing and shelling along the LoC in Sunderbani sector of Rajouri district. On September 2, one JCO was killed in another ceasefire violation along the LoC in Keri sector of Rajouri. According to official sources,

2 Civilians Injured In **Ongoing Pampore Encounter**

SRINAGAR: Two civilians were injured, one among them critically in the ongoing encounter between government forces and militants in Pampore town of south Kashmir's Pulwama district, officials said Thursday.

Acting on inputs suggesting presence of militants, army's 50 RR, special operations group (SOG) of police and CRPF appeared in Lalpora village of Pampore and started a cordon and search operation, a police spokesperson said. He said while cordon was being laid, the militants hiding in the village fired "indiscriminately" leaving at least two people injured.

A local news agency KNO identified the two injured civilians as Abid Nabi and Kifayat Ahmad, both residents of Pampore.

Block Medical Officer (BMO) Pampore, Gulzar Ahmad said that two persons—one with head injury and another with thigh injury were received at SDH Pampore and both were referred to Srinagar.

In FOCUS Junked As 'Surplus', Teachers Becoming Tillers In Kashmir

very morning, Arshid Ahmad, a 40-year-old contractual college lecturer readies himself not for his routine classroom teaching session but to work in one of the relative's land as a farm labourer. Soon after the Jammu and Kash-

mir lost its special status on August 5, 2019, Arshid was disowned by the higher education department. Sans job and salary, he was forced to do land tilling to feed his family. Hailing from south Kashmir's Kulgam district, Arshid—a post-graduate in Political Science and National



appointed as a contractual lecturer in 2004 and since then he has been serving the higher education department with a hope that his services

would be regularized one day. "For the first 10 years of my

Eligibility Test (NET) qualifier-was career, I was solely running the department of Political Science," Arshid said. "I was going out of my way to serve the department."

However, after August last year. the department told him that they who've served the department for do not need his services anymore.

"After taking 15-years of services from me, the government has now categorized me as 'surplus candidate' and discarded me as deadwood of the department," Arshid rued, adding that he was left with no option other than to work as a tiller to support his family. "School fee of my children is

pending since March because I've not received my pending salary. What will I feed my family, if I won't work as a tiller now," he lamented. Not eligible for any other job

Arshid is among the 500 seniormost college contractual lecturers nearly two decades and are not eli-

gible for any other job, as they've crossed the upper age limit.

After giving their youth to the department, the government has issued an order categorizing them into "surplus candidates". The order has come as a big blow for these teachers awaiting regularization since years now.

Since 1995, Dr. Fayaz Wani, a senior-most college contractual lecturer, has already served the Arabic Department for 25 years.

Hailing from Magam area of district Budgam, 52-year-old Wani is currently posted at Government Degree College Kansahab. Like others in his contractual **PAGE**
