# **Guns Fall Silent In Pampore** After 18 Hours, 2 Militants Killed

SRINAGAR: Two Pakistani militants of Lashkar-e-Taiba were killed while another laid down his arms during an 18-hour-long encounter with state forces in Pampore town of Pulwama district, officials said Friday.

The anti-militancy operation resumed in the wee hours on Friday after being suspended by the combined forces on Thursday night due to darkness, a police spokesperson said. He said in the firefight that started this morning, one holed-up militant was killed.

"However, the opportunity to surrender was yet again offered to the other trapped militants. as a result of which one of them laid down his arms and surrendered before the joint forces," the police spokesperson said, adding "The militant in injured condition was removed to hospital for treatment."

The police identified him as Khawar Sultan Mir of Drangbal locality of Pampore associated with LeT.

# War With China Can't Be Ruled Out: Rawat

NEW DELHI: China's People's Liberation Army (PLA) is facing "unanticipated consequences" for its misadventure in eastern Ladakh because of the "firm and strong" responses by the Indian armed forces, Chief of Defence Staff Gen Bipin Rawat said on Friday.

In an address at a virtual seminar, Gen Rawat said the situation along the Line of Actual Control (LAC) in eastern Ladakh remained tense and that India's posturing has been "unambiguous".

"The situation along the LAC in eastern Ladakh remains tense and the People's Liberation Army is facing unanticipated consequences for its misadventure in Ladakh because of firm and strong responses by Indian forces," Gen Rawat said.

"Our posturing is unambiguous. We will not accept any shifting of the Line of Actual Control," he asserted. Talking about the overall security calculus, Gen Rawat said border confrontations, transgressions and unprovoked tactical military actions spiralling into a larger conflict

# J&K Bank Posts Rs 50 Crore **Profit In Q2**

Net NPAs Down To 3.03 %, Advances In J&K Up By 15 %

NEW DELHI: Jammu & Kashmir Bank on Friday reported a standalone net profit of Rs 44 crore in the second quarter ended September of the current fiscal year.

The state-owned lender had posted a net loss of Rs 916.81 crore during the same quarter a year ago.

Sequentially, net profit grew multi-fold from Rs 6.50 crore in April-June 2020 quarter.

Total income fell to Rs 2,194.47 crore in July-September from Rs 2,262.94 crore in the same quarter of 2019-20, J&K Bank said in a regulatory filing.

Asset quality improved as gross from 4.48 per cent (Rs 2,942.04 non-performing assets (NPAs) fell to crore) a year ago. »PAGE 02



8.87 per cent of the gross advances at the end of September 2020 from 10.64 per cent at the end of September 2019. In absolute terms, gross NPAs stood at Rs 6,317.09 crore as against Rs 7,473.29 crore a year ago.

**SRINAGAR:** At least five more people succumbed to coronavirus in Jammu and Kashmir on Friday, taking the number of fatalities due to the deadly infection in the Union Territory to 1526.

Kashmir Valley reported three more deaths due to Covid-19, while two others succumbed to the infection in the Jammu division, officials said Friday. The three

victims from the Valley were residents of Srinagar. Among them were a 65-year-old woman from Lal Bazar, 84-year-old from Natipora and 78-year-old from Naseem Bagh here. The two victims from Jammu divi-

sion included one from Kathua and another from Ramban-a 72-yearold from Banihal area of the district.

They said that the civilian namely Abid Ahmad Mir (22 year old) son of Abdul Hamid resident of Meej Pampore succumbed to his injuries this morning at SMHS hospital.

The other civilian namely Kifayat Ahmad, who was also injured at the encounter site, is undergoing treatment at Bone and Joints hospital Srinagar and is stable.

Two civilians were injured during the initial exchange of firing at the encounter site.

**Biden On Verge Of Victory...** The focus on Pennsylvania, where Biden led Trump by nearly 7,000 votes, came as Americans entered a third full day after the election without knowing who will lead them for the next four years. The prolonged process added to the anxiety of a nation whose racial and cultural divides were inflamed during the heated campaign.

With his pathway to reelection appearing to greatly narrow, Trump was testing how far he could go in using the trappings of presidential power to undermine confidence in the vote.

On Thursday, he advanced unsupported accusations of voter fraud to falsely argue that his rival was trying to seize power in an extraordinary effort by a sitting American president to sow doubt about the democratic process.

"This is a case when they are trying to steal an election, they are trying to rig an election," Trump said from the podium of the White House briefing room

Biden spent Thursday trying to ease tensions and project a more traditional image of presidential leadership. After participating in a coronavirus briefing, he declared that "each ballot must be counted."

"I ask everyone to stay calm. The process is working," Biden said. "It is the will of the voters. No one, not anyone else who chooses the president of the United States of America."

Trump showed no sign of giving up and was was back on Twitter around 2:30 a.m. Friday, insisting the "U.S. Supreme Court should decide!'

Trump's erroneous claims about the integrity of the election challenged Republicans now faced with the choice of whether to break with a president who, though his grip on his office grew tenuous, commanded sky-high approval ratings from rank-and-file members of the to hold a convention in Srinagar on November 17.

"I will not die until the rights of my people are given back.... I am here to do something for the people and the day I will finish my work, I will leave this world," the National Conference (NC) president told his party workers who packed the Sher-e-Kashmir Bhawan here ahead of a scheduled meeting of the People's Alliance for Gupkar Declaration (PAGD) on Saturday.

"We will fight for our rights and identity and will not be cowed down," he said and asked "what was our fault?"

Taking a dig at the JK unit of the BJP, he said those setting ablaze his effigies should remember that "it was Farooq Abdullah" who along with BJP stalwart A B Vajpayee represented India in Geneva and silenced the opponents.

"I am not afraid of BIP. I am not armed with lathi or stone, let them come to me and reply to my questions which they will not," he said, adding his party never took decisions on the basis of religion and region.

Continuing his attack, he said "Those who claim to be the champions of Hindu cause and challenging us, let them do a favour to this country by going to the borders and show their power to the enemy rather than to the citizens of the country. We have done it when the NC stood against the tribal raid and saved Srinagar from being captured in 1947."

The National Conference workers, especially the party's youth leader Maqbool Sherwani, had misled the Pakistan Army disguised as tribal raiders in Baramulla to enable Indian Army land in the state.

It was 84-year-old Abdullah's first political meeting in Jammu since the abrogation of Article 370, which accorded Jammu and Kashmir special status, and bifurcation of the state into union territories in August last year.

Mainstream political parties in Jammu and Kashmir, including the NC and the Peoples Democratic Party (PDP), formed the PAGD last month for the restoration of the special status of the erstwhile state as it existed before August 5 last year and also to initiate a dialogue between all stakeholders on the issue

Abdullah, accompanied by his son and former chief minister Omar Abdullah, arrived here this afternoon, their first visit to the region in over a year.

The Abdullahs, along with other political leaders in Kashmir, were detained under the Public Safety Act and released this year.

He accused the BJP of adopting its agenda as the "country's agenda" and said "nation is bigger than the party and don't think that India is yours alone."

He said many governments have come and gone and "you have to go one day as well" and pointed out to the elections in the US.

Abdullah said US President Donald Trump was also making noises and now he is moving to courts to challenged election results.

"He (Trump) is going out and so will be you one day," he said. Abdullah, the sitting parliamentarian from Srinagar, said his party had

never differentiated between Jammu, Ladakh and Kashmir and always considered them a single entity. "We have never thought that Jammu, Ladakh and Kashmir are sepa-

rate from each other. We could not be able to take the people of these regions on board at the time of the formation of the PAGD due to the urgency of the situation and now we are here," Abdullah said.

"we are together and one because of our nation".

He said the BJP cannot be "my master and I am not afraid of them. Asking his party workers to be patient in the face of abuse by opponents, he said they can burn his effigy and abuse him because it is a weapon of the weak and the strong replies with patience and a smile. "As long as your party is strong, nobody can force you down, he said, asking people not to worry though there will be attempts to create confusion and divide them.

"Those who are accusing us of being Pakistanis are in reality the ones who are supporting Pakistan. If something wrong happen, they would be the first to chant Pakistani slogans, he said.

He said National Conference workers do not tear clothes to demonstrate nationalism.

Abdullah also appealed to the people of Jammu not to burst firecrackers on Diwali festival to reduce air pollution amid the COVID-19 pandemic.

Maryland GOP Gov. Larry Hogan, a potential presidential hopeful who has often criticized Trump, said unequivocally: "There is no defense for the President's comments tonight undermining our Democratic process. America is counting the votes, and we must respect the results as we always have before."

But others who are rumored to be considering a White House run of their own in four years aligned themselves with the incumbent, including Sen. Josh Hawley, R-Mo., who tweeted support for Trump's claims, writing that "If last 24 hours have made anything clear, it's that we need new election integrity laws NOW."

Trump's campaign engaged in a flurry of legal activity to try to improve the Republican president's chances, saying it would seek a recount in Wisconsin and filing lawsuits in Pennsylvania, Michigan and Georgia. Judges in Georgia and Michigan quickly dismissed Trump campaign lawsuits there on Thursday, when Trump still held a small edge in Georgia – though Biden was gaining on him as votes continued to be counted. The same was true in Pennsylvania, where Trump's lead had slipped to about 18,000 votes – and the race is destined to get tighter. One reason is that elections officials were not allowed to process mailin ballots until Election Day under state law. It's a form of voting that has skewed heavily in Biden's favor after Trump spent months claiming without proof that voting by mail would lead to widespread voter fraud.

Mail ballots from across the state were overwhelmingly breaking in Biden's direction. A final vote total may not be clear for days because the use of mail-in ballots, which take more time to process, has surged as a result of the coronavirus pandemic.

The Trump campaign said it was confident the president would ultimately pull out a victory in Arizona, where votes were also still being counted, including in Maricopa County, the state's most populous area. The AP has declared Biden the winner in Arizona and said Thursday that it was monitoring the vote count as it proceeded.

"The Associated Press continues to watch and analyze vote count results from Arizona as they come in," said Sally Buzbee, AP's executive editor. "We will follow the facts in all cases."

Trump's campaign was lodging legal challenges in several states, though he faced long odds. He would have to win multiple suits in multiple states in order to stop vote counts, since more than one state was undeclared.

Some of the Trump team's lawsuits only demand better access for campaign observers to locations where ballots are being processed and counted. A judge in Georgia dismissed the campaign's suit there less than 12 hours after it was filed. And a Michigan judge dismissed a Trump lawsuit over whether enough GOP challengers had access to handling of absentee ballots

Biden attorney Bob Bauer said the suits were legally "meritless." Their only purpose, he said "is to create an opportunity for them to message falsely about what's taking place in the electoral process."

He said the parties have joined hands to pitch for the restoration of Article 370, Article 35A and throw away the "black laws" which were implemented in Jammu and Kashmir beyond Lakhanpur -- the gateway to the erstwhile state bordering Punjab.

Referring to him being called as 'Pakistani' and 'Chinese' supporter, Abdullah said it was the National Conference founder Sheikh Mohammad Abdullah who told the people that "this is our way and not that side" while joining India in 1947.

"We joined Mahatma Gandhi's India and not the BJP. The India where all religions are equal and every citizen whether rich or poor gets equal treatment and the only red line is that we have to respect each other, irrespective of our religion and choice of food and drink," he said.

The former chief minister said he had never thought of any other country as his nation. "When I was not here, people started searching me where is Faroog Abdullah who can save IK." he said, referring to him being called to fight elections in 1996 in JK at a time when militancy was at its peak.

"Some used to say that the National Conference was finished but the people knew that it was the National Conference which alone could save JK at that time. Nobody was looking for BJP," he said, amid thundering applause and slogan shouting by party workers.

He said he was not afraid of anyone. We have faced you in the past and ready to face you again and Insha Allah (god willing) we will emerge as victorious.

Referring to the new land laws, Abdullah accused the BJP of making false promises to the people of JK. "Where have your promises of protection to the land and jobs gone after the abrogation of special status. Today, the unemployed are on the roads and so are the daily wagers who are waiting for their services to be regularised," he said.

The NC Patron also accused accused the BJP of using Kashmiri Pandits as vote bank and said the community is still waiting for their return and rehabilitation in the valley.

Abdullah also said that the real development in Jammu and Kashmir would come when there will be a people's government.

"For 28 years, they are saying that Kashmiri Pandits will be taken back to their homes in the valley. They are in power for more than five years but they are still waiting for the day of their return," Abdullah said.

He accused the BJP of spreading hatred among communities and asked "how long will you use them as vote bank".

"You have always used them," Abdullah said.

"People are the real fountain of power. When there will be elections, bring forth the people who can help the masses and are not self-centric, he said, adding the real development will come to J-K when there will be people's government and all rights of the people restored."

Asserting that the National Conference is not "anti-national", he said those who are hurling such wild allegations should check their vision. "We are not the ones whom you could buy or make them to tear apart their clothes," he said, referring to a BJP leader who tore his shirt to claim that he is a nationalist to the core.

"How many more you will buy (in J&K). I know there are some elements in NC as well. I have seen a lot (in politics) and the day is not far when another group will come and they will buy you as well," he said.

He asked the party workers to remain steadfast and united to thwart such conspiracies.

"We have to remain cautious as they are trying to divide us on the basis of religion and region.... This nation is strong as people from different backgrounds, regions, climates and languages are one. A Madrassi, a Bengali, a Maratha who are not habitual to below 30 degrees Celsius is guarding Ladakh sector in minus 30 degrees Celsius," he said, adding

Pakistan in Jammu and Kashmir accompanied by "vicious" anti-India rhetoric have taken the ties between the two countries to a new low. "The surgical strikes after the Uri attack and Balakot air strikes have delivered a strong message that Pakistan no longer enjoys the impunity of pushing militants across the LoC under the nuclear bogey," Gen Rawat said at the seminar organised by the National Defence College.

He said the new Indian template to deal with militancy has injected ambiguity and uncertainty in Pakistan, adding India will confront militancy with a firm hand.

The Chief of Defence Staff said despite internal problems, failing economy, international isolation and vitiated civil-military relations, Pakistan will continue to "profess" that Kashmir is their "unfinished agenda". "And their Army will continue to raise the bogey of an existential threat from India to justify their disproportionately large strength and need for funds to maintain its war fighting capabilities." said Gen Rawat.

## 'IAF Helped India Ward Off...

dissuading the adversary to a large extent, Chief of Air Staff Air Chief Marshal RKS Bhadauria said on Friday.

The Indian Air Force (IAF) chief also said that the Balakot air strikes in Pakistan clearly demonstrated that air power could be put to sophisticated use and create a space for action below the conventional threshold. Air Chief Marshal Bhadauria was speaking at an online seminar organised by the National Defence College.

"Over the past few months, the proactive deployment of our offensive capabilities in response to developments in eastern Ladakh, both in terms of deployment of air assets as well as rapid airlifting of Army combat elements, demonstrated the IAF's operational readiness today, he said without elaborating.

He said the deployment also reflected the capability and the nation's resolve to use air power if the need arises.

"It is our belief that our pro-active action and strong posture was instrumental in dissuading the adversary from making further attempts...We remain hopeful that the peace and stability will be restored along the LAC through ongoing dialogue," he said.

The IAF has deployed almost all its frontline fighter jets like Sukhoi 30 MKI, Jaguar and Mirage 2000 aircraft in the key frontier air bases in eastern Ladakh and elsewhere along the Line of Actual Control(LAC). The newly inducted fleet of Rafale jets has also been carrying out sorties in eastern Ladakh.

On the Balakot strikes, he said militant organisations will have to think "hard" before making any further attempts to carry out attacks.

Indian warplanes pounded a Jaish-e-Mohammad(JeM) training camp on February 26 last year, nearly two weeks after the Pulwama attack in which 40 CRPF personnel were killed.

"The air strikes in February last year by Indian Air Force targeting militant infrastructure at Balakot clearly demonstrated that air power could be put to sophisticated use and create a space for action below the conventional threshold," Bhadauria said.

Talking about the overall security scenario, he said there has been a transformation of the security paradigm in recent years.

"Our definitions of national boundaries have shifted beyond the classical definition of land border, shore lines etc. We cannot remain chained to the old concepts of fronts -- two fronts, one front. The nature and scope of warfare itself has expanded," he said.

In Indian defence parlance, the two front conflict refers to hostilities along the country's western and northern borders.

From KO Archives Probe Ordered In Sikh Massacre OBSERVER NEWS SERVICE

RINAGAR: Jammu and Kashmir government today or¬dered, a judicial probe into the Chittisinghpora massacre in which 35 Sikhs were gunned down during President Bill Clinton's visit to India in last March. This follows in¬dictment of SOG and CRPF personnel by the two commis¬sions that probed the killing of protesters at Barakpora and the massacre of Amarnath vatris at Pahalgam.

Announcing the decision at a crowded press conference at his residence, the chief minister Dr Farooq Abdullah, im-mediately after chairing a cabinet meeting, said here today that the judicial commission headed by Justice

S R Pandian, which probed the Barakpora firing on April 3 on demonstrators protesting the disappearance of five lo¬cal vouths. had indicted three SOG personnel of Jammu and Kashmir police and four CRPF jawans

Similarly, the chief minister said, a three member com¬mission, headed by Lt Gen J R Mukharjee of the XV corps and comprising the principal secretary, home, and the deputy commissioner, Anantnag, which inquired into the shooting incident on an Amarnath pilgrims camp at Pa¬halgam on August 1 in which 23 devotees were among S3 people killed, has indicted five CRPF personnel for using excessive force besides some police officials for derelic-tion of their duty. Dr Farooq said the government had decided to register murder cases against the three SOG personnel indicted by the Pandian commission and a special team would be constituted to prepare cases against them in a court of law. They have been immediatelyplaced under suspension. The cases relating to the CRPF personnel would be referred to the centre for 'appropriate action

The indicted SOG personnel include ASI Ashok Kumar, head constable, Kishen Kumar, and sergeant constable, Chaman Lai. The CRPF personnel indicted are: com¬mandant, RP Roy; besides PC Handi, Sham Kumar and S Limberkar.

Stating that his government has accepted the report of the two panels "in toto', Dr Farooq said it had decided to order fresh probe into the Chittisinghpora massacre and subsequent Pathribal incidents by Justice Pandian. "Since all the three cases are linked to one another, we are going to request Justice Pandian to conduct an in-quiry into Pathribal and Chittisinghpora incidents also," Abdullah said. Law minister, P L Handoo will visit Chen¬nai to request Justice Pandian to investigate the causes that led to the two incidents as he was the right person to head the inquiry. About the recommendation of Justice Pandian commis¬sion for reinstatement of the then senior superintendent of police, Anantnag, Faroog Khan, and the SHO, Achhabal, Gaaanfar All, the chief minister said the matter would be put on hold in view of the inquiry into Pathribal and Chattsinghpora incidents. The inquiry into the latter would also address the apprehensions of the Sikh commu¬nity, he added.

The chief minister said the Pandian report had recom $\neg mended$ compensation of Rs two lakh to next of the kin of each of the dead and an equal amount to the two injured. Others injured have been recommended a compensation of Rs 25,000 and Rs 10,000. He said the next of kin of the dead had already been paid Rs one lakh each and the remaining Rs one lakh would be paid to them soon. (Kashmir Observer, November 07, 2000)

# The Second Sale Deed of J&K

Several other states like Himachal Pradesh, Sikkim and Mizoram enjoy similar protections in the form of several constitutional or statutory safeguards

he recent gazette notification, issued by the Ministry Of Home Affairs (MHA), has in one fell swoop, removed all preconditions for the purchase and sale of land in the Union territory of Jammu and Kashmir.

While the notification has created an uproar in Kashmir, with the Peoples' Alliance for Gupkar Declaration (PAGD) openly castigating the notification as unacceptable and nefarious in nature, Jammu too has expressed grave concerns about this move by the Centre.

Former chief minister Omar Abdullah in an interview went as far as to say, "This adds to the fear of demographic changes. Today's order has made it clear that they want to wipe out the character of a Muslim majority state. The people of Jammu would be more unhappy with this land ownership system. Before it impacts the people of Kashmir, it will impact people in Jammu."

While repealing the J&K Land Alienation Act, 1938 and Big Landed Estate Abolition Act, 1950, the notification makes amendments to the Land Grants Act, 1960 and the Agrarian Reforms Act, 1976 by removing the "Permanent Resident" requirement for the sale and purchase of land in J&K. Repealing the landmark Big Estates Abolition Act was a rather ironic move as the Act, which conferred land rights to the tillers in Jammu and Kashmir, was believed to be one of the most progressive pieces of land reform ever initiated in India.

The prerequisite of being a "state subject" for the sale and purchase of land was the result of a long and pressing demand by the people of Jammu and Kashmir, which the erstwhile maharaja had agreed to, keeping in mind the disadvantaged socio-economic backwardness of the local populace in the region. By scrapping this requirement, the Centre has added insult to the injury already inflicted on the people in the state.



grants were extended to the Punjabis as they were placed on important chairs of trusts. Cementing their influence in areas of authority and occupation of land, the Punjabis began to dominate commerce as well.

Concerned by this wave of immigration and fearing relegation to the margins, Kashmiri Pandits raised a banner of revolt. Their agitation was actively supported by the Hindu Dogras of Jammu as they were the first to reap the benefits of modern education, long before Muslims in the Valley became politically conscious.

While in Jammu, the agitation was more forceful and sprouted into a fullfledged Dogra vs Punjabis controversy, in Kashmir, the Kashmiri Pandits managed to acquire subtle assistance from the British officers in their opposition to 'outsiders'. After a long and arduous agitation Maharaja Hari Singh introduced the state subject law on April 20, 1927. The definition of the term "state subject" was a broad one, which conferred equal representation to all the sections of the population be it the Kashmiris, Dogras or Punjabis. It was this state subject law which manifested in the form of 'permanent residents' after Jammu and Kashmir's accession to India and continued to protect the land and labour rights of the local population. The post-independence period also ushered in new challenges for the local populace which found itself caught in a conflict and earned the unwanted sobriquet of being a "nuclear flashpoint". The prevalence of conflict further buttressed the case for uninterrupted protection of jobs and land rights, as had been granted by the maharaja, keeping in mind the disadvantaged socio-economic position of the state vis-à-vis the rest of the country. The removal of the protection fo land rights that people in the state previously enjoyed might spell

doom and the local population will not be able to fend off the big land sharks from outside Jammu and Kashmir.

Constitutional safeguards other states enjoy

Jammu and Kashmir is not the only state which confers protection to the land and jobs of the local populace. Several other states also enjoy similar protections in the form of constitutional or statutory safeguards.

The state of Himachal Pradesh, under several laws, restricts the sale and transfer of land to its 'bonafide residents' – those who have resided in the state for a period of 20 years. However certain exceptions can be made by the state while making land transfers to outsiders, considered on a case-by-case basis.

In 2019, the Supreme Court, while deciding a petition on the state of Meghalaya, ruled that the indigenous population have full rights over their land and resources and recognised their sole right to grant permission for mining. Like Meghalaya, several other states, under the Sixth Schedule of the constitution, enjoy similar protections with regard to their land rights. Similarly, under Article 371-F of the constitution, the people of Sikkim enjoy discretionary powers with regard to the purchase of the property in the state. The laws are even harsher in the tribal areas of Sikkim, where only tribals can purchase the land falling in these belts. Once again, exemptions can be made for the establishment of designated industrial belts for regulated penetration of benefits of industrialisation. In Nagaland, the people with protections derived from Article 371-A are free to determine the conditions of who can and cannot purchase or transfer land other than its 'indigenous inhabitants'. Likewise, under Article 371-G of the constitution, the Mizoram legislative assembly is conferred with special privileges to restrict and regulate the

ownership and transfer of land rights in the state.

Arunachal Pradesh, Jharkhand and 10 other states falling under the Fifth Schedule of the constitution have been bestowed with discretionary powers with regard to imposing restrictions on the transfer and purchase of the lands in the respective states keeping in view the local tribal populations.

Having said this all, even the newly created Union territory of Ladakh is being considered for special status under the Sixth Schedule, thereby extending constitutional safeguards to its culture, jobs and land ownership rights. All these aforementioned instances provide ample breeding ground for the population of Jammu and Kashmir to be concerned about the selective manner in which the Centre has removed these protections while others continue to enjoy them uninterruptedly.

#### Backtracking on promises

The Centre has argued that these safeguards were roadblocks for peace, progress and development in Jammu and Kashmir.

The Central government has also maintained that the removal of these "impediments" would encourage investment, this even as it, in the same breath, it continues to support these safeguards in states which enjoy constitutional safeguards under Article 371 and several other provisions.

The Centre had previously, on multiple occasions, assured the people of J&K that their jobs and land rights would be protected at any cost and that the state would have a better domicile policy than anywhere else in the country.

Immediately after Article 370 was revoked, PM Modi promised the people of J&K that they would witness the dawn of a new politics, prosperity and development and every commoner in J&K expected him to stick to his words. Propriety and principled statecraft demand that New Delhi refrain from forcing its vision of development on the newly created Union territory as this might lead to instability again, while all other priorities take a backseat. The Centre should instead conduct legislative assembly elections and let people have a say in their future. More than two centuries ago, in 1846, Maharaj Gulab Singh executed the Treaty of Amritsar with the British East India Company, whereby Kashmir was sold to him in lieu of seventy five lakh nanakshahi rupees and he carved out the princely state of Jammu and Kashmir. This treaty is infamously remembered as the "Sale Deed" of Kashmir. Let us hope the Centre rethinks what locals will see as the second sale deed of J&K, where the inhabitants of the land have no say in shaping their destinies.

How the demand for state subjects arose

The incorporation of these protectionist provisions can be traced back to an agitation led by Kashmiri Pandits, who were far more educated and politically conscious in comparison with the Muslim majority community in the princely state of J&K.

The Kashmiri Pandits were opposed to the hiring of Punjabis in the state administration, a trend which had been initiated by the first maharaja of the state, Gulab Singh, when he had appointed a Punjabi khatri named Dewan Jawala Sahai to an important post in his government. Dewan Sahai later went on to become prime minister under the Dogra rule.

During this time, Jammu and Kashmir recorded a massive influx of Punjabis, who started to occupy almost all the high ranking positions in the Dogra government. As their sway in the administrative setup increased, extensive land

# No End in sight for Rohingya crisis

n estimated 730,000 Rohingyas had crossed into Cox's Bazar in Bangladesh three years ago in order to flee persecution in Myanmar's Rakhine State. Although the Rohingyas, who are currently residing in Bangladeshi camps as refugees, wish to return to their homes in Rakhine State, very little has been done to create a safe environment for their return.

The challenges facing the Rohingya people, described by the United Nations as "the most persecuted minority in the world," have unfortunately continued following their arrival in Bangladesh.

#### How it all began

Before their mass exodus to Bangla-

desh in 2017, the Rohingya people were the largest Muslim group in Myanmar. Majority of them used to reside in Myanmar's Rakhine State. According to various estimates, they numbered around one million.

Myanmar's government has dismissed the Rohingyas as a "stateless" people within Myanmar. They have, therefore, been denied citizenship.

Even before the 2017 mass exodus, the Rohingyas had been forced to leave Myanmar in a number of ethnic cleansing efforts by the Myanmar army and extremist Buddhist groups.

However, Myanmar's military and Buddhist extremist groups' efforts to drive the Rohingyas out of Myanmar reached the height in the latter half of 2017. In August of the same year, the military and militias attacked Rohingya villages in Rakhine State. They burnt homes. They brutally tortured and killed

many Rohingya civilians.

Compelled by the circumstances, hundreds of thousands of Rohingyas started to flee their villages. They began their journey to Bangladesh, believing that a foreign land would be safer than Myanmar.

At present, more than a million Rohingya refugees are living in camps situated in Bangladesh, with an estimated average population of 100,000 people per square mile.

Among the refugees living in the camps, almost 50 percent are children and there are more women than men. They have been living in makeshift shelters made of bamboo and plastic sheets. Understandably, any structures made of such materials are likely to be intolerably hot in the summer, exposed to winds and rains during the monsoon season, and extremely cold in the winter. The Rohingyas are bound to work secretly outside the camps, as they are not allowed to legally work and cannot leave the camps without permission.

#### What's next?

Many attempts were made by the Bangladeshi government and civil society groups as well as the international community so that the Rohingyas living in Bangladesh could safely return to their homes. However, these repatriation efforts failed continuously, as Myanmar repeatedly failed to create a safe and secure environment for the Rohingyas on their side of the border.

Many experts strongly believe that Myanmar's military-controlled-government has so far made every effort to discourage the Rohingyas from returning home. Hence, attempts to begin a safe and dignified repatriation process have failed, as refugees refuse to go back, fearing more violence.

In 2019, many local, national, and international non-government organizations called for human rights for all to be recognized in Rakhine State. They also emphasized that the Rohingya refugees should have a role in deciding the conditions for their return to Myanmar. However, there is no end in sight for this crisis and a peaceful solution is unlikely to arrive anytime soon.

# Hues of Muslim Modest Fashion Industry

www.action.com to the end of September. The fashion houses, designers, models and bloggers who spent early autumn at the fashion weeks in Paris and New York, London and Milan, have almost packed up and gone. New collections have been shown and analysed, their offerings seeping into the industry, introducing new trends or building on existing ones.

This year, the modest movement continued to exert its influence both on and off the catwalk, as show attendees found evermore creative ways to cover up.

Modest fashion is a loosely defined look derived from the clothing and style worn by Muslim women. It's a concept with no strict rules beyond the obvious, and differs from individual to individual, depending on how they interpret religious guidelines. Predominant modest styles include layering, loose silhouettes, higher necklines and outfits that don't accentuate the shape of the body. Even though modest clothing has not been a feature of the mainstream fashion industry or of advertising campaigns, Muslims have huge spending power when it comes to clothing.



ion brands, which in turn has influenced how the industry now sells itself.

Dina Torkia, the Cardiff-based author of the recently published Modestly, said in 2016 - just before modest went mainstream - that she "can't help but feel incredibly underwhelmed, possibly even a tiny bit insulted by the [D&G] collection".

She added: "Muslim women in the form of bloggers, designers and stylists have been taking centre stage for a good few years, showing the world that modesty and style can coincide with faith with barely a nod of applaud or recognition, until D&G fancies putting their stamp all over a very traditional Middle Eastern style and claim its originality."

Zavnah, who started posting her modest outfit

According to a report by Thomson Reuters, Muslim clothing and footwear expenditure is expected to reach \$484 billion by 2019, accounting for 14.4 percent of global spending.

But some observers now question the fashion industry's current interest in modest clothing.

#### From street to fashion runway

Modest fashion first emerged in 2011, when Muslim bloggers and influencers, including Dina Torkia and Amena Khan in the UK and Ascia AKF in Kuwait, countered stereotypes of Muslim women as being oppressed and showed that modest dress need not be boring.

The trend had started in Indonesia and Malaysia, where a lucrative market for modest fashion had existed and was showcased as the norm by bloggers such as Dian Pelangi

The profile of the movement is most evident on runways at major shows, where the increasing number of modest influencers, designers and models demonstrate how significantly the market has grown and how it is in turn shaping the mainstream.

One notable presence at New York Fashion Week in early September was IMG Models' Halima Aden, representing Harpers Bazaar and Calvin Klein. The Somali-American model, who was born in a Kenyan refugee camp and has appeared on the cover of British Vogue, initially made headlines for wearing a hijab during a Miss Minnesota beauty pageant.

In New York, Aden wore a striped cape and matching trousers to the Harper's Bazaar Icons party, while at the Calvin Klein show she went with tailored white trousers, paired with a high neck polo knit and a black long-line jacket.

In Milan, where she represented Max Mara, Aden wore a polka-dot trench coat with a matching headscarf and dark sunglasses, tying in with the theme of women and power, inspired by Greek mythology.

Speaking to Vogue Arabia, she said that modest fashion is not just a passing trend. "It's not just a way of dress, it's a way of life... as the origins are often from religious beliefs, it's a

Among fashion show audiences, the number of journalists, influencers and bloggers with an interest in modest clothing has likewise risen.

Zaynah Ahmed, a British-based blogger and modest fashion influencer who boasts more than 100,000 followers on Instagram, says she started posting her looks on social media because she wanted to show people that they don't have to be boring in their fashion choices if they want to be modest. "I wanted to show that it's possible to look good, feel good and still be completely covered up," she says.

According to Ahmed, social media has been a key tool in the increasing access for bloggers and modest fashion influencers on the circuit.

"It's great that we're being recognised in the mainstream industry," she told MEE. "Social media and the rise of modest fashion bloggers has shown the industry how much influence we have, hence they now collaborate with us to reach the Muslim market.

"If it wasn't for the bloggers and social media I don't think we would have that many modest options to choose from in shops. They now cater for us".

Bloggers are also appearing in front of the camera. Dolce & Gabbana announced fashion and beauty blogger Ruba Zai as the face of its new campaign for a collection of luxury abayas and scarves in 2017. Zai, who has amassed more than one million followers on Instagram and is of Afghani descent, shared images of the shoot in Morocco on her social media accounts.

Zai regularly makes videos for her YouTube channel of over 400,000 subscribers, ranging from makeup looks to how to style a hijab.

Speaking to NOS, Zai said: "I received an email from Dolce & Gabbana saying that Stefano likes my style and wants to work with me... it was truly a dream come true.

"For other hijabis, whether they are influencers or not, it shows that anything is possible, even with a hijab"

#### Reclaiming the modest movement

But many bloggers and influencers are wary of the mainstream's embrace of modest. Instead, they want to reclaim a movement they fear is being monopolised by fashion brands as a way of bolstering politically correct credentials and entering into the Muslim market.

The financial potential is there: Middle Eastern visitors to the UK spend more than any other demographic on clothes, the Financial Times reported back in 2014. Visitors from Kuwait averaged £4,000 (\$5,229) per visit while Qatari tourists spent around \$3,920. Most of that money went on high-end fashlooks in 2013, told MEE: "They are cashing in on Muslims as it's a known fact that as a Muslim community we have a large expenditure on fashion and they are taking full advantage of this.

"It feels nice that we can walk into shops and actually find more than one item which is modest, but they're not doing this for us, they're doing this for their profits."

Reina Lewis is Professor of Cultural Studies at London College of Fashion and the author of Muslim Fashion: Contemporary Style Culture. She decided to write about Muslim fashion as she believes that after 9/11 too much media attention focussed on stereotypical orientalist images of Muslim women, such as the mystery behind the veil.

"What I saw was that Muslims were increasingly being asked to declare themselves as good, 'moderate', Muslims, versus bad, 'extremist', Muslims," she told Historie de Mode.

Lewis said that Muslim fashion refers to a particular cohort of young women in Muslim-minority countries who cover their heads, often with a headscarf, and were doing this through participation in mainstream fashion cultures.

She said that Islamic branding and Muslim marketing were now growth areas.

"The fashion industry has disregarded Muslim women as fashion consumers for a long time and it is now beginning to wake up to that. On one hand, Muslims are very pleased to be marketed to, on the other hand I think we are going to see more critical responses to that as well."

#### Stories from Arabia: Bridging the gap

Modest and Arabian fashion influence continued through to London Fashion Week in mid-September, where designers from the Middle East showcased their collections.

Stories From Arabia is a fashion platform: this year it represented eight designers at London Fashion Week, featuring a plethora of embroidered designs, Moroccan-style kaftans, fluid silhouettes and beaded gowns.

Inspirations included the third-century Queen Zenobia of the Palmyrene Empire in modern-day Syria, 17th-century architecture and Moroccan art and textile design.

Jalila Elmastouki, its founder, told Fabuk Magazine earlier this year that the platform "creates that bridge between Arabia and the Western World to change the way people think about the region and to support Arab designers by making their work accessible to a British audience".

# **Study Evaluates Effectiveness Of Different Face Mask Materials When Coughing**

As for homemade masks, those ric were more effective, and those which also incorporated interfacing, which is normally used to stiffen collars, showed a significant improvement in performance. However, this improvement in performance also made them more difficult to breathe through than an N95 mask.

The researchers also studied the performance of different fabrics when damp, and after they had gone through a normal washing and drying cycle. They found that the fabrics worked well while damp and worked sufficiently after one laundry cycle, however, previous studies have shown that and the researchers caution that masks should not be reused indefinitely.

"Fabric masks have become a new

necessity for many of us since the start of the COVID-19 pandemic," said first author Eugenia O'Kelly from Cam-

bridge's Department of Engineering. "In the early stages of the pandemic, when N95 masks were in extremely short supply, many sewers and makers started making their own fabric masks, meeting the demands that couldn't be met by supply chains, or to provide a more affordable option," added O'Kelly.

While there are numerous online resources that help people make their own masks, there is little scientific evidence on what the most suitable materials are.

"There was an initial panic around PPE and other types of face masks, and how effective they were. As an engineer, I wanted to learn more about them, how well different materials worked under different conditions, and what made for the most effective fit," said O'Kelly.

For the current study, O'Kelly and her colleagues built an apparatus consisting of sections of tubing, with a fabric sample in the middle. Aerosolised particles were generated at one end of the apparatus, and their levels were measured before and after they passed through the fabric sample at a speed similar to coughing.

# WHO sees 'explosion' of Covid-19 cases in Europe

COPENHAGEN: The World Health Organisation (WHO) said on Thursday said it was observing an "explosion" of coronavirus cases in Europe and warned of a "tough time" ahead as mortality rates rose.

"We do see an explosion.... in the sense it only takes a couple of days to have over the European region an increase of one million cases," WHO's regional director for Europe Hans Kluge said.

Kluge, who was wearing a mask even as he was interviewed over a webcam meeting, also said the mortality rate could be seen rising "little by little'

"It's going to be a little bit of a tough time, we need to be honest on that," he said.

In spite of the rapidly rising cases, Kluge cautioned that closing schools should be seen as a last resort, especially in light of there being "no reasons to say that schools are a main driver of the transmission".

"We need to keep the schools open really until last because we cannot afford a Covid-19 lost generation," Kluge said

# Aspirin To Be Tested As Potential **COVID-19 Drug In UK Study**

Painkiller aspirin will be evaluated as a possible treatment for COVID-19 in one of Britain's biggest trials, which will assess whether it might reduce the risk of blood clots in people with the disease

The scientists behind the RECOVERY trial, which is looking into a range of potential treatments for COVID-19, said it would include the drug, which is commonly used as a blood thinner.

"There is a clear rationale for believing that it (aspirin) might be beneficial, and it is safe, inexpensive and widely available," said Peter Horby, cochief investigator of the trial. Patients infected with the



Taking to Twitter, Trump said, "Twitter is out of control, made possible through the government gift of Section 230!

In another tweet, he alleged that the observers were not allowed to "do their jobs" and hence the votes cast during this time should be "determined to be ILLEGAL VOTES".

"I easily WIN the Presidency of the United States with LEGAL VOTES CAST. The OBSERVERS were not allowed, in any way, shape, or form, to do their job and

therefore, votes accepted during this period must be determined to be ILLEGAL **VOTES. US Supreme Court** should decide!," Trump said. "So now the Democrats

are working to gain control of the US Senate through their actions on John James, David Perdue, and more. Would end the filibuster, "Life", 2A, and would pack and rotate the court. Presidency becomes even more important. We will win!," he added.

This is not the first time Trump has demanded the votes cast be considered illegal.

During a press conference on Thursday (local time), Trump said: "If you count the legal vote, I easily win. If you count the illegal votes, they can try to steal the election

from us....I have already won many critical states.. massive victories in Florida,

Iowa, Indiana, Ohio, to name iust a few. We won these and many other states despite historic election interference from big media, big money, and big tech... We won by historic numbers."

On Thursday (local time), Trump's election campaign filed a new lawsuit against Philadelphia election officials for allegedly violating their due process rights by blocking the observation of ballots in the city.

Earlier, Trump's election campaign had filed a lawsuit to stop ballot counting in Michigan and Pennsylvania and to prevent the counting of absentee ballots in Georgia that it claims arrived after

## WhatsApp Takes On Google, Alibaba In India's Phone **Payment Battle**

MUMBAI: WhatsApp on Friday entered an increasingly tense battle between multinational giants such as Google and Alibaba for a chunk of India's fast growing digital payments market.

The Facebook-owned firm said it was launching Whatsapp Pay just hours after it was given permission by the country's payments regulator. India is the messenger firm's biggest market with some 400 million users.

Whatsapp Pay -- which allows people to send and receive money through the messaging platform --was launched in Brazil in June but was quickly suspended because of competition objections raised by the central bank. Authorities have since indicated that it will be allowed there.

Facebook chief Mark Zuckerberg said in a video statement accompanying the India launch that the move would boost "innovation" in payments.

Zuckerberg also hailed India's Unified Payments Interface (UPI) which is used in the country of 1.3 billion people to manage payment apps, with more than 140 Indian banks part of the network.

UPI is also used by Alphabet Inc's Google Pay, Walmart's



PhonePe and Alibaba-backed Paytm, which dominate India's digital payments market.


"India is the first country to do anything like this," said Zuckerberg of the network.

India's UPI processed more than two billion transactions in October and 1.8 billion the previous month. The stakes are high for all the competitors as the digital payments market was worth about \$75 billion in 2019 and is expected to rise past \$500 billion by 2025. WhatsApp has linked up with

five Indian lenders including State Bank of India, the largest public sector institution, HDFC Bank, ICICI Bank, Axis Bank and Jio Payments Bank to roll out the service.

The National Payments Corporation of India has put a cap of 20 million users of the Whatsapp service in the first phase. All must have a debit card and a bank account.

The American firm has been waiting for two years to launch its service, testing pilot payments for about a million customers.

Will Continue Our Fight For **Special Status: Omar** 

**JAMMU:** Asserting that the youth joining militancy is much fight for restoration of Article 370 and Article 35A would be taken to a logical conclusion, National Conference vice president Omar Abdullah on Friday accused the BJP of misleading the country over the constitutional safeguards to Jammu and Kashmir.

"This is the fight of all of us and we know some will come in open and some will remain on our back but we will not backtrack and will emerge successful in this fight," Omar said amid thunderous applause by his workers.

The NC leader said if the identity and future of the people cannot be saved, nothing can be left behind.

Attacking the BJP for snatching the rights guaranteed under the Constitution to the people of Jammu and Kashmir, Omar asked, "Where is the promised new phase of development and what happened to the notion that the separatism will finish and all the diseases will be cured."
