NEW DELHI: Coming face-to-face with Chinese president Xi Jinping, albeit virtually, for the first time since the Sino-India border row began in early May, Prime Minister Narendra Modi on Tuesday delivered a stern message during his address at the SCO summit that

there should be respect for sovereignty and territorial integrity among the nations.

In his remarks during the virtual summit, Modi also hit out at those making repeated attempts to "unnecessarily" bring bilateral issues to the Shanghai Cooperation Organisation (SCO) in violation of the bloc's foundational principles. **▶PAGE 02**

Bar Defers Polls After Govt's Notice On Kashmir Status

SRINAGAR: Jammu and Kashmir High Court Bar Association (HCBA) on Tuesday decided to defer its elections, a day after the government asked the layers body to clarify its stand on Kashmir.

"We have decided to defer the elections. New date is yet to be fixed," Election Commissioner of HCBA, Advocate Mudasir said. "New date will be announced after deliberations."

The Bar elections were scheduled to be held today. However, in the meeting held in Srinagar, it was decided to defer the elections for some time.

The development came close on the heels of a notice

issued to J&K HCBA by the district magistrate Srinagar where it was asked to clarify its stand whether it sees Kashmir as "a dispute or an integral part of the country."

Yesterday, a notice sent to the Bar Association read that Jammu and Kashmir HCBA has reportedly circulated a press note convening election for various office bearers of association at Srinagar on November 10.
