IED Defused In Kulgam: Police

SRINAGAR: Government forces on Friday detected and later defused an improvised explosive device (IED) in Kulgam district of Jammu and Kashmir, police said.

An IED fitted in a pipe was detected near a local mosque at Shurat in the south Kashmir's Kulgam district, a police officer said. He said the explosive device was later destroyed by a bomb disposal squad team on the spot without causing any loss.

Burglars Strike Shrines, Loot Cash

SRINAGAR: Unidentified burglars struck two shrines in north Kashmir's Baramulla district and decamped with cash and other valuables, reports said Friday.

Unknown burglars struck a shrine in Delina and another in Rafiabad's Yarbugh village on the intervening night of Friday-Saturday and decamped with the cash and other valuables after breaking the lockers.

Meanwhile, Police have registered formal cases in both the theft incidents and have set investigations into motion.

19 People Stuck On Mughal Road 'Rescued'

JAMMU: Nineteen people who were trapped in snow on the Mughal road in Jammu and Kashmir's Poonch district were rescued by government forces, officials said on Friday.

These people were travelling from Shopian to Poonch when their vehicles got stuck in the snow accumulated on the road at Pir ki Gali on Thursday night, they said.

As soon as the information was received, teams from Army and police launched an operation to rescue the stranded passengers, the officials said. All the persons were rescued and taken to Poshana where they were provided food and other facilities, the

Man Killed in **Bandipora Accident**

SRINAGAR: A middle-aged man on Friday was killed in road accident in north Kashmir's Bandipora district.

55-year-old Ali Mohammad Dar was hit by a motorcyclist on Friday evening in his native village Saraie Dangarpora in Sumbal area of the district, news agency GNS reported. Dut to the impact of the accident, Dar, the report said died while the biker identified as Feroz Ahmad Khandey of Ganderbal sustained injuries.

Khandey, the report said was removed to a nearby health facility for treatment. However, the doctors there referred him to SMHS Srinagar for advanced treatment.

Nearly Million Stranded J&K Residents Evacuated

JAMMU: A total of 9.28 lakh residents of Jammu and Kashmir who were stranded due to the coronavirus lockdown have been evacuated from other states so far, according to official data.

The administration has received 155 special trains at Jammu and Udhampur railway stations with a total 1,40,292 passengers till date, while 7,87,960 people, including 948 from abroad, have been evacuated by road till date, the data said. As per the detailed breakup of the figures, 10,762 stranded passengers have entered through Lakhanpur in

the past 24 hours. All necessary guidelines and standard operating procedures were strictly observed, it added.

Candidates Say, 'Confined To Hotels, **Unable To Campaign'**

SRINAGAR: Murmurs of discontent from candidates rather than speeches can be heard ahead of local body elections in Kashmir with most parties in the fray claiming their leaders are confined to distant hotels in the guise of security and are unable to campaign freely because of the many restrictions imposed on them.

It's just not a level playing field, several candidates said ahead of the November 28 District Development Council polls, the first democratic exercise since Jammu and Kashmir's special status under Article 370 was revoked in August last year and the state was bifurcated into union

But the lack of enthusiasm is evident with political parties accusing the administration of strictly restricting the hours of campaigning and not even allowing their candidates to move

SRINAGAR: At least four more people succumbed to coronavirus in Jammu and Kashmir on Friday, rasing the number of virus related fatalities in the Union Territory to 1622.

Among the victims from the Valley, officials said were a 65-yearold woman from Shahlaal Kupwara and a 67-year-old man from Pran Bawan Anantnag. Two other victims from the Union Territory were residents of Jammu city.

661 More Test Covid-19 Positive

SRINAGAR: Jammu and Kashmir reported on Friday 661 new cases of coronavirus, taking the total number of people infected bythe virus across the Union Territory to 105376.

colleagues termed him a thorough professional and adown-to-earth human being.


A Topper

Candidates Say...Rayees Mattoo, a NC candidate of the PAGD from Khag area of central Kashmir's Budgam district, said he has been put up at a hotel here and candidates of the alliance are not allowed to campaign even while their competitors are freely working in the

Is this the way to hold an election? We are not provided with security or vehicles. I had three meetings scheduled for the day and had conveyed the same to the authorities well in advance. But I was not allowed to move out of the hotel as they say there are not enough vehicles or security available." he asserted.

His party colleague and candidate Mohammad Ashraf Lone said there are only six vehicles for about 40 candidates in the hotel he has been

"How can we all move around in just a few vehicles? The government says new faces should contest the polls and so we did. But if they cannot provide us with the facilities, how can we manage? If they do not want us to contest, let them say it

According to Lone, the candidates were told to use the vehicles to campaign but return before 4 pm. "The journey from our hotel to Beerwah (in central Kashmir's Budgam district) itself takes about two hours. How can we campaign in such a short time," he said.

Sabzar Ahmad, an independent candidate from Dooru area of south Kashmir's Anantnag district, said he has been placed in a hotel in Pahalgam and is not allowed to move out.

"About 25 of us are here and we feel like prisoners. They do not let us move out, while candidates from other parties go out for campaigning," he said.

Another independent candidate, Akhtar Hussain Magray from Beerwah, withdrew his nomination papers, saying the authorities had failed to provide the candidates with security and other

Officials privy to the security plan for the polls said the government does not have resources to cater to the needs of every candidate.

"It is so difficult to manage with the resources that we have. There is more demand for logistics and manpower and it gets difficult to rationalise things," an official said.

Several candidates are being put up in cluster accommodations which are secured and their movement is facilitated so that they are able to reach their constituencies for campaigning.

IGP Vijay Kumar said the candidates are provided escort when they leave and the security forces secure the area for them to visit and campaign. "Whenever any candidate goes out for campaigning, we provide a double escort with him and secure the area for him to campaign," he said.

The PAGD, led by National Conference (NC) president Farooq Abdullah, was formed to seek the restoration of the erstwhile state's special status. But the alliance announced a plunge into electoral politics to keep the BJP away. –PTI

Responding to a letter by CPI(M) leader Mohammed Yusuf Tarigami who had raised the issue of candidates being kept away from their constituencies and not being allowed to campaign, Sinha said he has taken note of the concerns and conveyed "necessary instructions".

Tarigami, a former MLA from the militancy-hit Kulgam district of south Kashmir, had informed the Lt Governor that after filing their nomination papers, the candidates were not allowed to campaign due to "perceived threat to their lives" and had been bundled in "cluster accommodation".

Tarigami said that there had been instances that rival candidates were sent in the same vehicle and asked to campaign together.

"Several candidates from far-off places were sent to hotels in Srinagar soon after they filed the nomination forms last week. Not just the voters, but the families of the candidates are also

concerned," he said. In his response, the Lt Governor said, "I am sure that the coming elections will go a long way in strengthening the Panchavati Rai Institutions."

Tarigami released the Lt Governor's letter. The former MLA said such arrangements were a big concern and there was a lot of dissatisfaction on ground over it.

"Who wins and who loses, the decision must lie on the electorate. Democracy must finally win. For that the process must be made secure and credible. It is advisable not to put avoidable restrictions on the contesting candidates and instead their legitimate movement for the campaigning in their respective areas must be effectively facilitated," he said. The CPI(M) is part of the newly formed People's Alliance for Gupkar Declaration (PAGD) which comprises the National Conference, the PDP and four other local parties. The PAGD was formed to work for the restoration of the special status of

Makroo in his petition had stated that he was initially appointed in 1982 in the Jammu and Kashmir State Industrial Corporation. On the basis of his performance, he said that in 1995 he was sent on deputation in the Bureau of Public Enterprise. Subsequently, he was sent on deputation in the in 1997. Subsequently Makroo was absorbed permanently in the Corporation and promoted as absorption, he said, all the service conditions as applicable to the Government employees of the erstwhile State were made applicable to him and

as a corollary thereof, the Corporation discontinued the contribution of CP Fund of the petitioner and commenced contribution towards the General Provident Fund as per Government rules applicable in the Corporation.

Makroo had retired in 2014. However after his superannuation, the Corporation failed to settle all the post retiral benefits. He had stated that while the corporation released some post retiral benefits in the shape of gratuity, leave salary and GPF accumulations in his favour as per the Jammu and Kashmir Civil Service Rules, they failed to release the pensionary benefits to which he was legally entitled as per the rules pertaining to the other Government employees of the erstwhile State being followed in the Corporation.

He had said that despite repeated requests, the monthly pension as well as arrears were not released in his favour. (Agencies)

Government spokesman Rohit Kansal in a tweet said: "Deeply saddened to hear of the unfortunate and distressing news of the untimely demise of young journalist Mudassir Ali. My heartfelt condolences to the bereaved family." DIPR JK also condoled the sudden death of "young and promising journalist".

"Confining candidates against their wishes has Abdullah, Vice President Omar Abdullah and for the sake telling stories of his people," Tamin party leaders expressed grief and sorrow over the sudden demise of the senior journalist The leaders prayed for strength to the bereaved family to bear the loss and peace to departed, according to a party

Omar in a tweet said that it was a terrible shock to hear of the sudden death of Mudasir Ali.

"He had a bright career as a journalist ahead of him & the fact that he died so young makes his passing even more difficult to comprehend. May Allah grant him Jannat & his family strength at the difficult time," he said, adding, "I've been interviewed by Mudassir a number of times & tried to dodge his tough questions at numerous press conferences. He was a tenacious reporter, always polite but never easy to fob off. He will be sorely missed. God speed Mudassir."

Celebrated journalist MuzamilJaleel in his tribute termed Ali as a wonderful human being. "The hearts of our youthful friends and colleagues are stopping suddenly," Jaleel said.

"There is so much grief in our lives. There is so much unbearable pain that we see and feel every day. Living, working, existing is a never ending struggle. And the good among us, those who aren't numb already, can't take it anymore. When will we start living again, when will our land stop seeing the frail shoulders of parents carrying the coffins of their young children ... when will we resume dying of old age... when will we start telling the happy stories..

"Rest in peace, Mudasir Ali. You kept on telling the stories of our people, of our land till the end. You were a brilliant, hardworking journalist. You were a wonderful human being. You went too soon. We will always remember you."

Another Heart Attack

The terrible year continues to wreak havoc, said TV journalist Mir Fareed.

Young journos dying of heart attack is another shocking thing that we have witnessed this year," Fareed wrote in his social media post.

"Is it to do with a changed work environment post August 5 or Covidrelated financial stress or silent Covid itself? "But it's devastating to see young promising lives ending in such a tragic manner.Mudasir Ali, rest in peace!"

An Untiring Scribe

In his over 15 years of active journalism career, Ali never took rest, said journalist NazirGanaie.

"You were always on the go, working, and overthinking," Ganaie said. "You have now met your last deadline and your new and final journey has begun.'

A Brave Reporter

Ali was among the very few brave reporters at Kashmir's press club reporting about the assault on Kashmir beginning August, 2019, journalist Baba Tamim said in his Facebook tribute

"When most of the reporters were scared and self-censored, he was one among the few on the National Conference President Dr. Farooq streets risking it all, in the information black hole

"I don't know what stressed him but I know for sure most of us in the valley and from the valley have had a depressing life for decades, with no way to let out. And piling expectations to survive through the never ending miseries has burdened our shoulders too much to carry the coffins of our voung brothers."

A Zen Master

In May, wrote Mir Hilal in his tribute to Ali,he thought of doing a story on the ordeal of parents of the militants, whose bodies were not handed to their families and were being buried in Sonmarg.

"The idea was to travel along with one such family. Instinctively, Mudasir came to my mind when I thought of someone with whom I could do this story. I called him. Talking to him always felt like talking to a Zen master. There would be pauses. Being mature beyond his age, he always took time to respond, as if he were weighing every syllable. And he always sounded right. When I told him about the idea, he said, "Gacchavhaez"," Hilal wrote.

Being a grounded reporter who always kept his finger on the pulse, Ali told Hilal if at all they were to do that story, they would have to leave at dawn "because Covid lockdown was also being used to prevent journalists from performing their job".

"Also, he said, they won't let us travel with a

militant's family," Mir said. "So, one day, at 5am, I reached his rented accommodation at Chhanpora. He had barely slept (he worked late into the night and always would be working on a couple of stories for outside portals). Eyes groggy and hastily gorging on two slices of bread and a fried egg, he said he was ready to go. He was right. Hardly any soldier or policeman was manning dozens of checkpoints along the Sonmarg route. At the graveyard, we were in a dilemma whether to take pictures, as this would attract the attention of the soldiers and policemen in the he said, smiling, with the excitement of a contented reporter who had stumbled upon a good story."

On their way back, Hilal said, they stopped in Kangan. "He spoke about how journalism was becoming increasingly a difficult profession, problems at workplace. Then, out of nowhere, he said, "Isn't this story the reward in itself"."

In the murky world of Kashmiri journalism, it is rare to find a journalist who has not dirtied his soul with myriad forms of corruption available to him. Mudasir was one of them."

A People's Journalist

In short, said journalist GowherGeelani, Kashmir on Friday lost a people's journalist in Mudasir Ali. "Mudasir would listen more, understand more, write more. And speak less," Geelani said.



SPOs rape 2 women at gunpoint in Lolab

ARAMULLA: A pair of special police officers assaulted two Dardpora women in Lolab forests last night. The perpetrators, who stalked the victims in the forest where they had gone to collect fire wood, have been identified as Nazir Ahmad Tantray, son of Ghulam Rasool Tantray and Manzoor Ahmad Lone, son of Jabbar Lone, both from Dardpora, Lolab, - the victims' na-tive village. They have been arrested by the police. A NAFA report said in Srinagar that two pro-government

gunmen had entered a Warpora household with the inten-tion of robbery. Finding the two women alone in the house - the rest of the family was away at a wedding - the Ikhwanis assaulted them at gun point and later carried them to the nearby forests to repeatedly subject them to the heinous act. The village was seething with rage after the two traumatized women returned this morning and recounted what had befallen them.

ONS in Baramulla identified the victims as Shafigua. daughter of Ghulam Nabi Mir, and Atiqua wife of Fayaz Ahmad. NAFA, however, said that both were married and Shafiqua was the wife of Ghulam Nabi Mir. The report said the victims as well as the criminals belong to Warpora. The criminals have been arrested by Lalpora police and two AK rifles recovered from

Why Kashmir's 'Pro-Azadi' Camp Isn't Celebrating

ver since its launch three decades ago, All Parties Hurriyat Conference (APHC) has consistently been advocating the idea of 'Kashmir banega Pakistan' (Kashmir will become part of Pakistan). And on this issue, it has the full backing of Hizbul Mujahideen, which is carrying on an 'armed struggle' in Kashmir for the same purpose. Thus, Islamabad's grant of provincial status to Gilgit-Baltistan and holding elections there should have been a cause of great rejoicing, especially since GB (which is part of J&K) now becoming 'part of Pakistan' amounts to a major psychological victory for both the separatist conglomerate and militant groups.

However, instead of celebrations, there's complete silence within APHC, which is a distinct sign that merger of GB with Pakistan has come as a rude shock for the pro-azadi camp in J&K. When Pakistan's Prime Minister Imran Khan proposed grant of provincial status to GB, most people had thought that that this plan would fizzle out, just like it did when it was being considered in 2014 and again in 2016 since there was widespread opposition from APHC leadership Pakistan administered Kashmir (PaK) assembly and even the HM supremo. This makes one wonder as to why the 'pro-azadi' camp and HM, (which owes its existence to Islamabad's support) which opposed this move twice in the past, hasn't it done so for the third time now?

In 2014, when Pakistan's Ministry of Kashmir Affairs and Gilgit Baltistan (KAGB) announced the GB merger plan, the PaK assembly opposed this idea and unanimously adopted a resolution declaring that, "Making Gilgit-Baltistan a fifth province will weaken Pakistan's national stand on Jammu and Kashmir at the international level. "The PaK Assembly logically justified this resolution by mentioning that, "Whenever a plebiscite is conducted the people of GB will also have the right to decide their future with the people of other parts of the State of Jammu and Kashmir" This is a very pertinent view as it fulfils the mandatory condition laid down in the UN resolution on self-determination, which the APHC is fighting for! Since KAGB didn't pursue this proposal any further, it seems that it was convinced by the PaK assembly's views

assembly's views.

Two years later, when the Nawaz Sharif government again announced the GB merger plan, the AHPC opposed it tooth and nail for several extremely valid reasons. In its statement, the joint resistance leadership (JRL) of APHC (represented by SAS Geelani, Mirwaiz Umar Farooq and Mohammad Yasin Malik) reminded Islamabad that, "Any proposal to declare GB as the fifth prov-

ince of Pakistan is unacceptable as it tantamount to changing the disputed nature of Kashmir." The JRL also cautioned Islamabad that, "... any deviation in its stance about Kashmir and its geographical entity is improper and will prove detrimental for Kashmir cause."

For the first time in history, key Hurriyat leaders as well as United Jihad Council (UJC) chief Syed Salahuddin came out unanimously to outrightly condemn a proposal made by Islamabad, a clear sign that the GB merger plan was unwelcome. In his typically blunt and forthright style, Hurriyat (G) leader SAS Geelani hit out saying, "There are no constitutional as well as moral justification in making any decision over any part of this territory without the consent of its people and it is also a clear violation of the UN resolutions on Kashmir." JKLF chief Yasin Malik too wrote a letter to Sharif warning him that, "If Paki-

stan imposes its sovereign writ over GB, India will then have a political and moral right to integrate Kashmir with it. With one stroke, Pakistan will be helping India to consolidate its writ on Kashmir".

'Freedom Party' President Shabbir Ahmed Shah pointed out that, "it (GB merger) will have an adverse impact on the entire Kashmir dispute," as "this will also give India a chance to make a stronger claim for this side of Kashmir and also weaken our case at the UN." He also warned Islamabad that "merger of GB will also have a significant implication on the demand for implementation of the United Nations resolutions which call for referendum in the state as it existed prior to the division in 1947."

Even the HM supremo who generally avoids commenting on political issues, spoke up and said, "Such a step would impact the Kashmir dispute at the United Nations and give India a legal and moral pretext to lay claim on Kashmir" since "such an act on part of Pakistan will have serious ramifications on Kashmir issue as well as Kashmir centric UN resolutions (as) Pakistan's move will give India justification in taking over parts of Kashmir". Due to such strong opposition, the GB merger proposal was shelved once again.

However, the Imran Khan led PTI government has now gone ahead and implemented this plan despite objections from some APHC leaders. However, what's ironic is not that Islamabad disregarded the appeals of APHC, but that the opposition to this plan from those heading the pro-azadi camp including UJC was so subdued that it gave an impression of being just a face-saving act and merely lip-service. This could be the actual reason why despite merger of GB with Pakistan being the very 'first step' towards fulfilling the APHC's 'Kashmir banega Pakistan' dream' is not being hailed or celebrated by the separatist conglomerate. And it is quite likely that on instructions from Islamabad, the separatists are keeping silent and not expressing their true feelings!

However, (like Pakistan Foreign Minister Shah Mahmood Qureshi had told his countrymen before the UNSC meet on Kashmir), let's not live in a fool's paradise. With CPEC running through GB, its merger with Pakistan was bound to happen because for Beijing, ensuring legal safeguard for this project matters more than the Kashmir issue and Islamabad has no other option but to oblige even if it means abandoning the Kashmir cause. This is why Islamabad made repeated to form consensus on GB merger.

This fact was well known to everyone including the APHC leadership right from the beginning and this is evident from the statements made by its leaders in the past. In January 2016, Geelani sahib made it clear to Islamabad that while, "we are not against the economic development and prosperity of the South Asian Region but creating trade routes (CPEC running through GB) on the cost of rights, interests, wishes and sacrifices of Kashmiri nation is injustice and unkind and it is also against the traditional and national Kashmir policy of Pakistan."

Whatever Islamabad may say now to justify GB's merger, the one thing that's now become very clear is that Islamabad has no reply to Geelani sahib's honest observation that "creating trade routes on the cost of rights, interests, wishes and sacrifices of Kashmiri nation is injustice and unkind and it is also against the traditional and national Kashmir policy of Pakistan".

n his election victory speech on 7 November, President-elect Joe Biden promised to "make America respected" again by salvaging its global reputation, which took a steep fall throughout President Donald Trump's tenure and dropped to record lows in 2020.

This represents an astonishing failure for Brand USA, given the dizzying heights to which American soft power had soared by the end of the Cold War, with the high-water mark of the 1992 Barcelona Olympic Games, when the US men's basketball "Dream Team" and Michael Jackson's "Dangerous World Tour" were the hottest tickets on the planet. This was a year or so after Saddam Hussein's forces were removed from Kuwait, and a charismatic and energetic Bill Clinton was en route to the Oval Office.

The world couldn't get enough of anything emotionally and materially attached to Brand USA, from Hollywood films and American pop stars, to Nike shoes, IBM computers, McDonald's and Burger King. If it was American, it was desired. This is why when 19 hijackers brought the Twin Towers in New York City crumbling to the ground in 2001, taking with them thousands of lives, international newspaper headlines read: "We are all Americans."

Sadly, it took President George W Bush all of five minutes to unwind this unprecedented level of global solidarity and goodwill towards the US. The world was repulsed by his buffoonish, cartoonish cowboy swagger, and divided by his false binary of being "with us or against us". Citizens of the world are far more complex and nuanced than the obnoxious and jingoistic "my country, right or wrong" odes sung by US hyper-patriots.

The illegal invasion of Iraq in 2003; the grotesque abuses against detainees at Abu Ghraib, Guantanamo Bay and CIA black sites around the world; the secretive drone wars; and the unrelenting killing of civilians by warplanes carrying the US flag and that

of its allies in Afghanistan, Somalia, Pakistan, Mali, Yemen and elsewhere led around a third of respondents in a 2017 Pew survey to identify the US as a major threat to global peace.

Recommitting to democracy

Needless to say, Biden has an enormously heavy lift to restore his country's reputation to the levels it enjoyed in the post-Cold War and preman Rights Council, Unesco, UNRWA, the World Health Organization, the Iran nuclear deal and the Paris climate accords - and mend damage done by Trump to longtime US alliances, including Nato and the European Union.

Biden should reset the Israeli-Palestinian peace process by promising to act as an honest and impartial broker, ending the uncritical support the Trump administration handed the Netanyahu

 $9/11\ \mathrm{era}$, but there are a number of places where he could and should start.

Biden should recommit the US to the pursuit of global democracy, human rights and international law, while strongly condemning authoritarian regimes, dictators and human rights violators. In the same vein, he should recommit the US to multilateral institutions and treaties - including the UN Hu-

government. He should renounce Trump's "deal of the century", call for an immediate halt to new settlement construction, reinstate the \$200m in Palestinian aid that Trump cut, and renew diplomatic talks with all Palestinian political parties, including Hamas

In addition, Biden should end the Muslim travel ban, which has cruelly deprived Arab American

families of visits to their loved ones for weddings, birthdays, anniversaries, funerals and to see sick relatives. He should give a clear and unambiguous condemnation of white supremacy, white nationalism and other violent, far-right ideologies.

In Yemen, Biden should end US military support for the Saudi-led war, which has claimed more than 100,000 lives and created the world's largest humanitarian crisis. He should end blank-cheque military support for serial human rights violators, including Saudi Arabia, the UAE, Egypt and Israel.

Preserving international law

Biden should end the secretive US drone war, which continues to kill civilians in many parts of the world, including Somalia, Afghanistan and Yemen. He should promise to resolve the conflict in Kashmir and condemn the Indian government for its human rights violations in the Muslim-majority territory.

The incoming president should also recommit to international law as it pertains to the prevention of genocide and ethnic cleansing, and hold accountable those responsible for the persecution of Uighur Muslims in China, Rohingya Muslims in Myanmar, displaced Syrian refugees in Idlib, and others subjected to state terrorism.

On the domestic front, Biden needs to take measurable and meaningful steps to resolve racial injustices and other forms of inequality in the US.

Obviously, the measures identified above are non-exhaustive. There's an array of deeds and words the incoming White House administration could take to salvage the country's tarnished global reputation - but ultimately, the world won't follow or re-follow the US until it once again chooses to lead by example.

Aquatic Orb: Fisheries in J&K

There is an urgent need to sharpen the awareness of the people and encourage them towards aquaculture, while putting a stop to the pollution of water bodies. A comprehensive plan for giving boost to the fisheries sector is needed in J&K

ach year, on the 21st of November, World Fisheries Day is celebrated in order to highlight the importance of the human lives involved in this sector and the water bodies that sustain aquatic lives. This day explores solutions to the increasingly inter connected worldwide problems in the implementation of the sustainable model. This day marks the future goals and milestones, bringing together not just the fisheries department but many other departments which are correlated with fisheries, under one roof. This day serves as an important reminder of the need to change the way we manage the fisheries sector in order to maintain stocks and healthy aquatic ecosystems. Fish diversity, apart from being a crucial source of food and livelihood, determines the health of the water bodies. Fish and Fisheries sector occupy a very important place in the socio-economic development of the state. This realm has been recognized as a powerful income and employment source of cheap and nutritious food, besides being a source of livelihood for a large section of economically backward population of UT of J&K. One in 10 people on the planet rely on fisheries and aquaculture to support their livelihood. In J&K, 93000 people are associated with the fisheries sector. The fisheries sector in J&K is considered as an emerging sector as the domain has an immense potential in to become a world class industry, with a water area as huge as 50000 hectares. The production from this vast water area is just 20000 tonnes per year while the requirement is 1.5 lakh tonnes, which can be easily achieved, provided that ample scientific techniques in culture and capture are used.

Even though the total fish production in J&K has increased a tad bit, as per a research conducted by a research scholar, Rather Tajamul, the fish production in Kashmir has decreased over the years.

The percentage share in total fish production from Kashmir declined from 84.18% in 2000 to 73.21% in 2018, implying a 10.97% decrease in fish production. The decreasing pace of growth of fisheries sector seems to be consistent with the decline in Kashmir's fish production. The deterioration of the fisheries sector is due to less government attention than it calls for, in terms of investment and creating of infrastructure.

The indigenous fish species of Kashmir are at high risk. Out of 13 species, 8 are extinct while remaining are waning. The fisheries code of conduct is not even being followed by licence holders who have been given permission for fishing. People are using chemicals like bleaching powder and dynamite to kill fish, although it is an offence under J&K Fisheries Act 1960. The department of fisheries is not able to put a check on all these offences due to a lack of manpower. J&K department of fisheries is left with just a handful of employees (around 1800 for all the districts and projects in J&K), out of which many are on the verge of retiring in a couple of years. Also, the punishments under J&K Fisheries Act 1960 are lenient. As per this act, if a person is found fishing in a prohibited area, they will be fined Rs 100 or undergo a jail term for 2 months or both and if a person is found using dynamites to kill fish, they will be fined Rs 50 or imprisoned for a month or both. This act had been formulated way back in 1960 and the punishments (as well as their implementation) are so less that offences could be committed repeatedly

In June 2019, K Skandan, the then advisor to the Governor, speaking in a two day conference on Fisheries and climate change in SKUAST K, mentioned that massive fisheries and aquaculture programme has been undertaken by govt. to boost the fisheries industry in J&K. However, till date we have not seen an iota of development on that massive programme. The need of the hour is to overhaul the fisheries sector completely by recruiting the technical staff, using scientific techniques and vouching for a coordination with other concerned departments and academic institutions. Sher e Kashmir University of Agricultural Sciences and Technology has established a separate faculty for fisheries which produces more than 50 fisheries graduates and post graduates per year who are technically sound and trained with scientific aids, specifically in the respective arena. The Government must take steps and utilise the services of these experts for the upliftment of fisheries sector in J&K. There is an urgent need to sharpen the awareness of the people and encourage them towards aquaculture, while putting a stop to the pollution of water bodies. A comprehensive plan for giving boost to the fisheries sector is needed in J&K. Fishing in the breeding season should be banned, leading to some positive help in increasing their number. New legislation which ensures stringent punishment to people for mass killing of fish is needed. The officers of the department should frequently visit villages located near the rivers, nallahs and streams to create awareness among the local people about the misuse of bleaching powder. The social activists from the Department of Environment in Environmental NGO's also have a great role to play in the uprooting of mass slaughter of fish. The directorate also needs to activate its officials, especially the field staff. Until measures are implemented in letter and spirit, the case of restoration of fisheries in J&K will remain an unfulfilled dream.

Let's Be Optimistic, Not Complacent

A vaccine may be on the way, but we shouldn't let down our guard until then


he breakthrough in the development of an effective vaccine against the deadliest virus of the century has so inspired and accelerated our optimism that even the most ardent scientific mind cast away any caution, repudiated by the excitement and enthusiasm.

Professor Sir John Bell, Regius professor of medicine at Oxford University and a member of the UK government's vaccine taskforce, stated with plenteous conviction and confidence that the invention and development of a vaccine, effective for over 90% of people inoculated in preventing Covid-19 infection, would be distributed early, and would be instrumental in returning life to normal by the coming spring.

Professor Bell commented to the members of the UK parliament that normalcy by spring time was a distinct possibility provided the distribution of the vaccine went without any glitch. Professor Bell had to tone down his enthusiasm, as he was muzzled by higher authorities and was obliged to mention that refusal by people to be vaccinated could cause concern, but his enthusiasm continued, and he reiterated his view on returning to normal by coming spring.

Since the race to develop a coronavirus vaccine started, and early trial phases demonstrated encouraging results on safety and immune responses, the real concern for everyone has been if any successfully developed vaccine would be effective in preventing the Covid infection. I only recently mentioned in the Dhaka Tribune's "Surgeon's Note" that research led by Professor David Matthews, from Bristol's School of Cellular and Molecular Medicine, had concluded that the Oxford coronavirus vaccine functions comprehensively in the human body after inoculation and builds strong immunity to Covid-19, preventing the disease and not merely lessening the severity of infection.

The vaccine developed by German company BioNTech and American pharmaceutical company Pfizer is claimed to have outperformed expectations and has demonstrated effectiveness over 90%. The news of the Covid vaccine breakthrough sparked the



tales of a series of financial success-stories too, particularly the personalities steering the development, behind the scene, of not-so-well-known German company BioNTech.

Overnight, the company's value has ascended to a staggering \$22 billion. BioNTech was founded about 12 years ago by German scientists U ur ahin and Özlem Türeci, who with the Austrian oncologist Christoph Huber, developed its vaccine. In contrast to the conventional vaccine that takes genetic information from a virus and cultivates it in a human cell, the mRNA method team led by U ur merely required the virus's genetic code, thus shortening the production process by many months.

Two doses of the vaccine are used at a time difference of three weeks, and provide possible immunity for at least a year. U ur ahin, also the chief executive of BioNTech, firmly believes that the vaccine is capable of halting the pandemic as even prevention of symptomatic infection would dramatically improve the situation. Though the technology of the vaccine by BioNTech is different from that of the Oxford vac-

cine, both are capable of imparting strong immune responses through both antibody and T-cell mechanism.

The jointly developed vaccine candidate had outperformed expectations in its vital phase-3 trial, stopping people from falling ill, but the data has not been peer reviewed and is yet to be published in the scientific journals, and this failure makes it impossible for the scientific community to decide on the acceptability and the authenticity of the claim for the vaccine without reservation.

Information is also not available if the vaccine protects against Covid infection, or allows infection but not development of Covid symptoms. The effectivity of the vaccine in asymptomatic Covid patients is also unknown. There is, however, speculation that if the vaccine prevents infection, by default, it should also prevent transmission of infection between individuals.

But if it allows asymptomatic infection, it may not be effective in preventing transmission of the disease, opening up of all possibilities of the disease manifestations on the newly infected individual. Usually, though the effectivity of a vaccine is less pronounced in the old age group, it is impossible to accurately comment on the effectivity of BioNTech and Pfizer vaccines on the elderly. Analysis of data is also not available, which is essential to deduce the reasons for a proportion of people's failure to respond to the vaccine.

Though enthusiasm provides a healthy buzz through a body's natural endorphins, over-enthusiasm and enthusiasm mistimed or misplaced, often may create the unpleasant emotions of disappointments. In case of Professor Bell, enthusiasm may have been mistimed, particularly when expectation of improvement is not due for another several months and the infection rate and mortality from this deadly virus has exceeded this month those observed in the spring and the summer in many European countries and the US.

In America, the coronavirus surge has shattered daily records for cases and hospital admissions and is set to last longer. It is now being estimated that the daily incidents may exceed a million a day towards the end of the current year. European authorities are especially concerned that the news of the breakthrough in developing a potent vaccine has caused disproportionate and premature enthusiasm regarding expectations of normal life soon, with hope of a near-normal Christmas.

This hope and expectation gravely worried European officials, who believe that such overzealous aspirations would surely bring complacency leading to the ignoring of measures designed to prevent worsening of the winter surge of Covid infection. Their concern is that if people become complacent and decide to ignore lockdowns and public health measures against Covid, many would miss the opportunity to observe the days when our life returns to normal, as a vaccine would not come soon enough for many.

Smartwatches could help detect COVID-19 before symptoms appear: Study



martwatches and other wearable devices that continuously measure vital signs can detect changes in the body up to nine days before COVID-19 symptoms appear, according to a study.

The researchers from Stanford University School of Medicine in the US analysed data from 32 individuals infected with COVID-19, identified from a group of nearly 5,300 par-

They found that 26 of them (81 per cent) had alterations in their heart rate, number of daily steps or time asleep.

The study, published in the journal Nature Biomedical Engineering, found that for 22 cases they were able to detect changes before or at symptom onset, with four cases detected at least nine days earlier. The findings suggest that activity tracking and health monitoring via smartwatches and similar devices may be used for the large-scale, real-time detection of respiratory infections.

Early detection of infectious disease is important to mitigate the spread of disease by increasing self-isolation and early treatments, the researchers said.

Presently, most diagnostic methods involve sampling nasal fluids, saliva or blood, followed by nucleic acid-based tests for detecting active infections or blood-based serological detec-

tion for past infections.

"Although they are highly sensitive, nucleic acid-based diagnostics may require samples gathered several days post-exposure for unambiguous positive detection," the study authors said.

"Moreover, they cannot be implemented routinely at low cost and are constrained by emerging shortages in key reagents," they said. The researchers noted that smartwatches and other wearable devices are already used by tens of millions of people worldwide and measure many physiological parameters, such as heart rate, skin temperature and sleep.

They investigated the use of wearable devices for the early detection of COVID-19 in a retrospective manner, and also present an approach for using wearable device-detected physiological parameters for real-time health monitoring and surveillance.

"Using heart rate and steps data from a large cohort of 5,262 individuals, we show that heart rate signals from fitness trackers can be used to retrospectively detect COVID-19 infection well in advance of symptom onset," the authors said.

"In addition, we developed an online detection algorithm to identify early stages of infection by real-time heart rate monitoring," they



"While acute insomnia, typically triggered by stress or a traumatic event, will often go away on its own. Lam worried that the longer this pandemic drags on, the greater the number of people who go on to develop chronic insomnia," Zitting said.

"And unlike acute insomnia, chronic insomnia can be difficult to treat," she added. (Agencies)



'Take **VitaminD** supplements to reduce cancer risk'

It seems like we have now one more reason to take vitamin D supplements as researchers have found that vitamin D was associated with an overall 17 per cent risk reduction for advanced cancer.



the research team looked at only participants with a normal body mass index (BMI), they found a 38 per cent risk reduction, suggesting that body mass may influence the relationship between vitamin D and decreased risk of advanced cancer.

"The findings suggest that vitamin D may reduce the risk of developing advanced cancers," said study author Paulette Chandler from the Brigham and Women's Hospital in the US.

"Vitamin D is a supplement that's readily available, cheap and has been used and studied for decades. Our findings, especially the strong risk reduction seen." Chandler added.

The researchers conducted the Vitamin D and Omega-3 Trial (VITAL) study, which was a rigorous, placebocontrolled study that took place over a span of more than five years.

VITAL study was designed to test the independent effects of vitamin D and Omega-3 supplements as well as to test for synergy between the two.

Participants were divided into four groups: vitamin D plus Omega-3s, vitamin D plus placebo, Omega-3s plus placebo, and placebos for both. Primary endpoints were major adverse cardiovascular events and the incidence of cancer.

VITAL did not find a statistical difference in overall cancer rates, but researchers did observe a reduction in the cancer-related deaths.

In their secondary analysis, the research team followed up on the possible reduction in cancer deaths with an evaluation of advanced (metastatic or fatal) cancer among participants who did or did not take vitamin D supplements during the trial.

They also examined the possible

modifying effect of BMI. Among the more than 25,000 participants in the VITAL study, 1,617 were diagnosed with invasive cancer over the next five years.

This included a broad mix of cancers (breast, prostate, colorectal, lung and more). Of the almost 13,000 participants who received vitamin D, 226 were diagnosed with advanced cancer compared to 274 who received the placebo.

Of the 7,843 participants with a normal body mass index (BMI less than 25) taking vitamin D, only 58 were diagnosed with advanced cancer compared

with 96 taking the placebo. "Our findings, along with results from previous studies, support the ongoing evaluation of vitamin D supplementation for preventing metastatic cancer -- a connection that is biologically plausible," said Chandler. Agencies

The exchange of territory was originally due to begin on Sunday, with Armenians in the Kalbajar district fleeing en masse before the official deadline for Azerbaijan's takeover. But Azerbaijan's President

Ilham Aliyev postponed the deadline by one week over "humanitarian" considerations. Speaking from Aghdam,



destroying buildings of their headquarters in Aghdam.

In the hours leading up to the handover, residents of the district set their homes on fire, leaving nothing behind for their longstanding rivals.

As part of last week's peace deal, Armenia agreed to return some 15 to 20 percent of the Nagorno-Karabakh territory captured by Azerbaijan in recent fighting, including Al Jazeera's Osama Bin Javaid said the area has become a ghost town.

COVID-19 Reinfection Unlikely For 6 Months, Says Study

London: People who've had CO-VID-19 are highly unlikely to contract it again for at least six months after their first infection, according to a British study of healthcare workers on the frontline of fight against the coronavirus pandemic.

The findings should offer some reassurance for the more than 51 million people worldwide who have been infected with the pandemic disease, researchers at the University of Oxford said.

"This is really good news, because we can be confident that, at least in the short term, most people who get COVID-19 won't get it again," said David Eyre, a professor at Oxford's Nuffield Department of Population Health, who co-led the study.

Isolated cases of re-infection with COVID-19, the disease caused by the SARS-CoV-2 virus, had raised concerns that immunity might be short-lived and that recovered patients may swiftly fall sick again

But the results of this study, carried out in a cohort of UK healthcare workers - who are among those at highest risk of contracting COVID-19 - suggest cases of reinfection are likely to remain

"Being infected with COVID-19 does offer protection against reinfection for most people for at least six months," Eyre said. "We found no new symptomatic infections in any of the participants who had tested positive for antibodies."

WHO Advises Against Remdesivir For

Paris: The anti-viral drug remdesivir should not be used to treat Covid-19 patients no matter how severe their illness as it has "no important effect" on survival chances, the World Health Organization said Friday.

Scratching one of the few treatments that had shown some initial promise in severe patients, a WHO Guideline Development Group (GDG) of international experts said there was "no evidence based on currently available data that it does improve patient-important outcomes"

The United States, the European Union and other countries have granted temporary approval

for the use of remdesivir after ini- vised "against administering remen recovery time in some coronavirus patients.

US President Donald Trump was treated with remdesivir among other medicines after he tested positive for Covid-19 in October.

Friday's WHO recommendation was based on four international randomised trials among more than 7,000 patients hospitalised with the virus.

Publishing updated treatment guidance in the BMJ medical journal, the panel acknowledged that their recommendation does not mean that remdesivir has no benefit for patients.

But based on the latest figures, costs and delivery methods, it adfor the treatment of patients hospitalised with Covid-19, regardless of disease severity".

Manufacturer Gilead said last month that the drug had boosted 2020 third quarter sales by almost \$900 million.

Initially developed as a treatment for the Ebola virus, remdesivir was found in one study published in May to reduce the length of hospital stays for Covid-19 sufferers from 15 to 11 days on average.

A subsequent WHO pre-print however found the drug "appeared to have little or no effect" on mortality or length of hospitalisation among more than 11.000 hospitalised patients across 30 countries.

Iranian Military Adviser: American Attack Risks 'Full-Fledged War'

Tehran: An Iranian military adviser to the country's supreme leader - and a possible 2021 presidential candidate warned that any US attack on the Islamic Republic could lead to a "fully-fledged war."

Hossein Dehghan, a former defense minister under President Hassan Rouhani, and who also served in Iran's paramilitary Islamic Revolutionary Guard Corps (IRGC), struck a familiar hardline tone.

"We don't welcome a crisis." We don't welcome war. We are not after starting a war," Dehghan said in an interview with The Associated Press (AP). "But we are not after negotiations fr the sake of negotations either."

The 63-year-old brigadier general who was formerly the head of the Guard's air force, describes himself as a "nationalist" with "no conventional political tendency.'

With President Hassan Rouhani prevented from running again due to term limits, Dehghan will likely run against a "voung technocrat with ties to Iranian intelligence and former hard-line president Mahmoud Ahmadinejad," cited AP.

He mirrored Avatollah Ali Khamenei's stance when he reiterated that any negotiations with the West could not include Iran's ballistic missiles,

which he described as a "deterrent" to Tehran's adversaries. The timing of Dehghan's warning is not incidental. In-

cumbent US President Donald

Trump was reported to have

met earlier this week with senior military and defense advisers about the feasibility of striking sites linked to Iran's nuclear program.

Having been told that such an action could potentially spiral



out of control and lead to a more extensive conflict, the president nixed the idea and instead continued the successful policy of "maximum pressure" applying further sanctions to the Tehran regime and its leaders.

Iran is clearly attempting to exert its own influence on presumptive President-elect Joe Biden, who has hinted that under his administration, the United States may well rejoin the nuclear deal that his former boss President Barack Obama signed in 2015, but which Trump unilaterally left in 2018.

Dehghan also remarked that Israel's "expanding presence" in the Middle East could turn into a "strategic mistake.' In addition, he maintained that Iran continues to seek the expulsion of all American forces from the region in retaliation for the US drone strike that killed former Quds Force Gen. Qassem Soleimani in January.

Man's "Lie" At Pizza Bar **Led To Drastic 6-Day South** Australia Lockdown

Sydney: South Australia's drastic six-day coronavirus lockdown was triggered by a "lie" to contact tracers from a man who tested positive and restrictions across the state are set to be lifted much sooner than first planned, authorities said

The shock announcement came just two days after the state government ordered people to stay at home and shut many businesses to combat what was considered a highly contagious outbreak of coronavirus.

South Australia state Premier Steven Marshall told a media conference in Adelaide that one man at a pizza bar tied to the outbreak told contact tracers he had only bought a pizza there, when he had actually worked several shifts at the food outlet alongside another worker who tested positive.

Authorities assumed the man, who wasn't named, had caught the virus during a very short exposure, leading them to believe the strain must be highly contagious. "Their (the man's) story didn't add up. We pursued them.

We now know that they lied," Marshall told reporters. "Had this person been truthful to the contact tracing teams, we would not have gone into a six-day lockdown.

"To say I am fuming about the actions of this individual is an absolute understatement. This selfish actions of this individual have put our whole state in a very difficult situation."

While the outbreak was still worrying. Marshall said restrictions would be lifted early with a stay-at-home order ending at midnight on Saturday when most businesses would also be allowed to open.

Asked what punishment the individual might face, Police Commissioner Grant Stevens said there was "no penalty" for lying to tracers under the current law, though that would likely be reviewed.

Scottish writer Douglas Stuart wins Booker Prize

ONDON: Scottish writer Douglas Stuart won the Booker Prize for fiction on Thursday for Shuggie Bain, the story of a boy's turbulent coming of age in hardscrabble 1980s Glasgow.

Stuart, 44, won the prestigious 50,000 pound (\$66,000) award for his first published novel, the product of a decade of work. He was the only UK-born author on a US-dominated list of six finalists for the prize, which is open to English-language novels from around the world.

A fashion designer who is based in New York, Stuart drew on his own experience growing up gay in economically Thatcher-era ravaged Glasgow for the story of young Shuggie and his



relationship with his alcoholic mother, Agnes. Stuart dedicated the book to own mother, who died when he was 16.

"My mother is in every page of this book, and without her I wouldn't be here and my work wouldn't be here," said Bain, who declared himself absolutely stunned to win.

The novel's sweep, vivid characters and unflinching

look at poverty have been compared to the work of Charles Dickens.

Publisher tor Margaret Busby, who chaired the judging panel, said Shuggie Bain was intimate and gripping, challenging but hopeful in its exploration of Shuggie's burgeoning sexuality and the complex but loving relationship between mother and son.

"It's hard to come away from that book without thinking this is going to be a classic," she said.

In contrast to last year, when deadlocked judges split the prize between Canada's Margaret Atwood for The Testaments and Britain's Bernardine Evaristo for Girl, Woman, Other, this year's decision was quick and unanimous.

At least two presidents of Venezuela, one dead and one living, are in on it. Big Tech is in on it; a Web server from Germany is involved (there's always a server involved). Multiple major U.S. cities are in on it, as are decent American citizens who volunteer at polling precincts. Argentina is in on it, too, sort of. Chicago Mayor Richard Daley was in on it back in 1960, when, according to an unproved conspiracy theory, he stole the presidency for John F. Kennedy, thereby launching an ongoing pattern of corrupt cities stuffing or scrapping ballots. The "it" is a massive, premeditated scheme to steal the



election from Donald Trump, according to Giuliani, and it also involved corralling poll watchers at great distances from the ballot counting.

Perhaps a cinematic example would help explain. "Did you all watch 'My

Cousin Vinny?' You know, the movie?" Giuliani asked Thursday. He was sweating at a lectern in the small lobby of the Republican National Comtol Hill. "It's one of my favorite law movies, 'cause he comes from Brooklyn."

About 100 journalists and hangers-on had crammed into this potential coronavirus incubator for a news conference on the perverse legal strategy of President Donald Trump's failed reelection campaign, which Giuliani is trying to hustle toward a twist ending. As the former New York mayor digressed about votes that could've been cast by dead people and Mickey Mouse, Trump campaign officials were at their headquarters in nearby Rosslyn, Va., winding down operations and closing out the budget.

"How many finguhs do I got up?" Giuliani said at the lectern, doing a terrible Joe Pesci, from the scene where he cross-examines an elderly eye-

witness with bad eyesight. Giuliani was trying to analogize the claims of Republican poll watchers, who say they were too far away from ballot counting to adequately observe it. Fifteen minutes later, as he was describing the election results as "a massive fraud," black liquid began to slowly streak from each of his temples, down his cheeks. It might have been perspiration liquefying his hair dye, or sluicing the black polymer off his eyeglasses. One Manhattan stylist told the New York Times that it might've been running mascara; perhaps Giuliani had applied it to touch up the color of his sideburns.

One Trump campaign adviser texted a Washington Post journalist as the black streaks inched toward Rudy's jowls: "Is he deteriorating in real time?"

HC Declares Marriage Between First Cousins Illegal



The assertion came after a 21-year-old man moved HC seeking anticipatory bail



he Punjab and Haryana High Court has said that marriage between first cousins

The court said that marriage which petitioner man wants to perform with a girl, who is his first cousin, was also per se illegal.

"...the submission in the present petition that as and when she (the girl) attains the age of 18 years, they will perform marriage is also per se illegal," the judge said on Thursday while hearing the petition.

The assertion came after a 21-year-old man moved the high court against state of Punjab seeking anticipatory bail in a case registered under Sections 363 (kidnapping), 366A (procuration of minor girl) of the IPC at police station Khanna City-2 in Ludhiana district on August 18. The state counsel, while opposing the bail plea, contented that the girl was a minor and her parents had lodged the FIR as she and the man were first cousins and their fathers were brothers.

The man's counsel told Justice Arvind Singh Sangwan that the petitioner had also filed a criminal writ petition, along with the girl, for protection of life and liberty.

The court file of the criminal writ petition was summoned during the hearing and as per its memorandum of parties, the girl was stated to be 17 years of age and the petitioner man had filed the petition with the submission that both of them were in a "live-in-relationship"

It was stated in the petition that date of birth of the girl was August 2003 and on the date of filing the petition on September 3, 2020, she was of the age of 17 years and 14 days.

Along with petition, a representation was also annexed, in which the girl had stated that her parents loved their sons but ignored her, therefore, she decided to live with her friend (petitioner) and on that account, she was apprehending that her parents can harass them and disturb the peace of their mind.

The court disposed of this petition on September 7. The state was directed to grant them protection if any threat was perceived to the man and the girl. However, the judge made the court to address arguments and the case it clear "that this order shall not be taken to

protect the petitioners (man and the girl) from legal action for violation of law, if any, committed by them".

The judge, after hearing counsel for the parties in the present petition, said, "I find that in the present petition also, the petitioner has not disclosed about the fact that he is first cousin of the girl and, therefore, the submission in the present petition that as and when she attains the age of 18 years, they will perform marriage is also per se illegal."

While opposing the anticipatory bail plea, the state counsel argued "that the girl was aged about 17 years and is a minor, therefore, her parents have got the FIR registered as the youth and the girl are the first cousins as their fathers are real brothers".

"Hence the petitioner has concealed the fact in the petition that they fall in the prohibited sapinda' (which prohibits marriage between two individuals if they have common ancestor) under the Hindu Marriage Act and cannot perform marriage with each other," the state + counsel argued.

"Once the petitioner and the girl are prohibited from performing marriage with each other, there is no question of their being in any livein-relationship, which is per se immoral and not acceptable in the society," it was argued. The counsel for the petitioner has sought time from was adjourned to January next year. (PTI)


