Misfire Injures Cop In Sopore

Drone Movement Seen Along IB: BSF

JAMMU: A drone was spotted flying over the International Border (IB) in Jammu and Kashmir's R S Pura sector, BSF officials said on Thursday.

Alert BSF troops guarding the IB at a border outpost fired on the drone Wednesday night, forcing it to return back, the officials said.

On November 29, security forces deployed on the International Border (IB) with Pakistan spotted a drone in Arnia sector of Jammu district.

On November 21, drone movement was noticed in Mendhar sector along the Line of Control (LoC) amid a surge in ceasefire violations by the Pakistani Army, according to sources.

Two drones were spotted and crossed the IB in Samba sector on November 20.

On June 20, a Pakistani drone loaded with a sophisticated rifle and seven grenades was shot down by the Border Security Force along the International Border in Kathua district of Jammu and Kashmir, officials said.

Take Call On Review Pleas On Dec 21: SC Tells J&K HC

NEW DELHI: The Supreme Court on Thursday asked the Jammu and Kashmir High Court to decide on December 21 the pleas seeking review of its verdict scrapping the Roshni Act which conferred proprietary rights to occupants of State land.

A bench headed by Justice N V Ramana considered the oral assurance of Solicitor General Tushar Mehta, who appeared for the Jammu and Kashmir administration, that no coercive action will be taken against those petitioners who have approached the top court in the matter as they are not "land grabbers or unauthorised people".

8 More Covid-19 Deaths In J&K, **366 New Cases**

SRINAGAR: At least eight more people died of coronavirus in Jammu and Kashmir on Thursday while 366 fresh cases of Covid-19, including seven BSF personnel were detected across the Union Territory during the last 24 hours, officials said.

Among the victims, five were residents of Kashmir Valley and three others from Jammu division, taking the total number of fatalities since the outbreak of pandemic in J&K to 1775, they said. In Valley, the five victims included a 75-year-old man from Awantipora, a 70-year-old man from Budgam, a 75-year-old man from Anantnag, a 70-year old man from Zakura, and an 80-yearold woman from Hawal here.

Regarding the deaths from Jammu, officials said, two were reported from the winter capital of the J&K and one More On P2

Covid Ending 'Trust' Of Dark Eyes In Kashmir

ZAID BIN SHABIR

Before Covid changed the pulse of life in the valley, Mohammad Ashraf Wani was busy organizing psychiatric counseling sessions for pellet survivors of Kashmir grappling with the posttraumatic stress disorder.

These sessions helped these survivors to read just among the normal working class without calling themselves "victims".

"To organise these sessions, our Pellet Victims Welfare Trust (PVWT) would collect funds from public during Friday congregational prayers," Wani, himself a pellet survivor, said. "But after Covid, neither we could col-

lect funds nor organise counselling sessions for our distressed pellet brethren."



BEGINING OF THE TRUST

It was five months after he suffered a pellet barrage on his body including in his eyes that Wani was provoked to

change his tribe's traumatic lives.
"I remember it was March 2017,"
the 24-year-old pellet survivor from Rahmoo Pulwama said. "Before walking inside the SMHS Hospital's Patient-Centred Care Room that day, I saw familiar and friendly faces of six pellet

survivors waiting for their turn." They were anxious, their bodies were shaking bodies, Wani, wearing black glasses, face mask, and mint green Khan dress, recalled.

"Their plight set me thinking," he continued."We were strangers, yet a family sharing the same torment." After his fifteen-minute-long consultation, Wani stepped out

of the room and saw all the six Before injury, my financially-weak family was

dreaming to see me a KAS officer one day"

obscure-looking faces gone. He couldn't make sense of their sudden disappearance.

"Later that evening," Wani re-counted, "I received a call. And what I learned shook me. Those six pellet survivors were planning a mass suicide in Srinagar that day!"

Wani was told that the financial crisis, societal indifference, family pressure, and the mental constraints had coerced those six eldest sonsof their

families towards that extreme step. On his part, Wani had nothing to offer except his consoling >> More On P2

Mehta said that Jammu and Kashmir administration has made it clear that encroachers and land grabbers cannot claim to be exempted from the high court order.

"Land grabbers cannot be spared and simultaneously, the lawful owners have to be saved," he told the bench.

At the outset, senior advocate Mukul Rohatgi, appearing for one of the petitioners, told the bench that the high court "was wrong in scrapping the Act" and a number of Roshni Act beneficiaries have not even been heard by the high court.

"Are you aware that some reviews petitions are pending in the high court and some of them have been protected there," the bench said. The solicitor general sought one-week time from the bench to respond to the appeals.

"The high court has listed the reviews petitions on December 21. And status quo ante has been restored by the high and then the high court has listed the review petitions,' the bench said, asking "how can two parallel proceedings be conducted?"

"The high court is seized of the review petitions," it said.

The apex court observed that the Union Territory's administration has also filed a review petition and it has divided land owners in two categories -- illegal encroachers and real owners.

Rohatgi told the bench that the "idea be-+ hind this appeal was not to throw out the lawful owners from the possession of land".

Senior advocate Arvind Datar, appearing for one of the petitioners, said the verdict does not talk about the authorised owners.

Senior advocate Kailsah Vasudev, representing another petitioner, said that the review is limited to a few people and the apex court should keep this matter in abeyance and "let the review be decided there".

"We are directing the high court to take up the review petitions pending there," the

The top court, while saying that it would list the matter in January, told Mehta that till such time there should be no coercive action.

"I am before the lordships and no coercive action will be taken," Mehta said while requesting that no order to this effect be passed. "Any such order will create confusion," he said, adding that "kindly have it (hear the

matter) on Monday". "I will take instructions. Have it on Monday and I will place the factual position,"

Mehta said. Rohatgi said, "The statement of the solici-

tor general is good enough for me".

The apex court, however, said it will hear the matter in the last week of January.

On December 7, the high court had adjourned till next week the hearing on a petition filed by the administration seeking a review of its earlier order scrapping the Roshni Act in totality.

The petition, filed by Special Secretary in Revenue department Nazir Ahmad Thakur on December 4 for modification of the nearly two-month-old judgment, has pleaded that a large number of common people would suffer unintentionally including landless cultivators and individuals who are themselves residing in dwellings on small areas.

It has said there was a need to distinguish between the common people and the wealthy land grabbers among the beneficiaries, and favoured that landless labourers or those with one house in personal use be allowed to keep the allotted land.

The Roshni Act initially envisaged conferment of proprietary rights of around 20.55 lakh kanals (102750 hectares) to the occupants of which only 15.85 percent land was approved for vesting of ownership rights.

"Jammu division recorded an average voter turnout of 66.67 per cent with Poonch District recording the highest percentage of 71.62 per cent followed by Doda district with 70.95 per cent and 70.83 per cent voting recorded in Rajouri district. The lowest turnout in Jammu division was in Jammu district which recorded 60.24 per cent," the SEC said.

"Kashmir Division recorded 33.57 per cent average voter turnout with Bandipora district recording the highest polling at 56.40 per cent followed by Kupwara District at 52.35 per cent and Budgam with around 45.65 per cent polling," he added.

Giving district wise details, SEC said that in Kashmir Division the polling percentage recorded in Ganderbal was 37.47 per cent, Baramulla 44.31 per cent, Anantnag 21.89 per cent, Kulgam 26.94 per cent, Pulwama 8.12 per cent and 5.52 per cent polling was registered in Shopian.

"Similarly, in Jammu division poll percentage of 64.71 per cent was recorded in Samba, 69.47 per cent in Udhampur, 68.27 per cent in Kishtwar, 67.11 per cent in Ramban, 69.15 per cent in Reasi and 62.36 per cent in Kathua," Sharma said.

Further, the SEC said that counting of votes for Sarpanch and Panch constituencies which went to poll in the 5th phase is being conducted immediately after the close of poll and results shall be declared.

Authorities 'Helping'...

NC vice president and former chief minister Omar Abdullah alleged that the keepers of the law were more than happy to become lawbreakers "if it serves their interest of cosying up to the BJP & it's offshoots in

"The entire machinery of the administration has taken upon itself the responsibility of helping the BJP in the DDC polls," Abdullah

NC spokesperson Imran Nabi Dar said his party leaders were being prevented from campaigning for the DDC polls over the past few weeks in the name of security.

"Our public meeting scheduled for today (Thursday) at Behibagh in Kulgam district was to be addressed by party general secretary Ali Mohammad Sagar and provincial president Nasir Aslam Wani but it was not permitted in the name of security," Dar said.

PDP president and former chief minister Mehbooba Mufti, who was prevented from leaving her house on the previous two days, alleged that armed forces were being used to rig the elections.

"Security forces have cordoned Matribugh in Shopian and are not allowing people to come out to vote under the pretext of inputs about presence of militants," Mufti tweeted.

"In a brazen display of power, armed forces are being used to rig this election and favour a particular party," she said, tagging the Election Commission and the Indian Army.

Mufti also lashed out at the authorities in south Kashmir over the alleged thrashing of three journalists by police while they were covering the elections.

"Three journalists thrashed by security forces in South Kashmir today after interviewing a PAGD candidate who wasn't allowed to cast his vote," she said. "Everything and anything that involves stating the truth is being criminalised in I&K."

People's Conference president Sajad Lone urged State Election Commissioner K K Sharma to investigate the case of alleged money distribution by a relative of a candi-

According to reports, a close relative of a Congress leader was detained by police on Wednesday evening while he was on his way to a village in Uri.

"SSP Anantnag Sandeep Choudhary objected to our coverage of polling station, where people complained that voting has not started even after the scheduled time. When we reminded the officer that we were just doing our duty, he slapped me and my two other journalist friends," Qadri said.

He said that he and two other journalists Junaid Rafiq of TV 9 and Fayaz Lolu of ETV Bharat were bundled in a gypsy and whisked to Srigufarwara police station.

"It all happened after we interviewed PAGD candidate Nisar Ahmad and other voters at the polling station. Polling had not started even an hour and a half after the scheduled time," Qadri said.

He said he and two other scribes were detained at the police station for over 90 minutes during which all their equipment, including cellphones were confiscated by the police.

At the police station, he said, another journalist Junaid Rafig complained of breathlessness following which he was shifted to a local hospital where his oxygen saturation was reading below 64.

Lolu, who works as a stringer with ETV Bharat told journalists that he and two other scribes were beaten up by police while they were discharging their professional duties at a polling station in Lever area of Anantnag on Thursday morning.

Meanwhile, the alleged beating of journalists has evoked sharp condemnation from media fraternity, social and political parties of the Valley.

KPC Condemns ...

In a distress call to the club Fayaz Lolu who works as a stringer with ETV Bharat stringer told the KPC management that he along with two other Journalists Mudasir Qadri (stringer with News 18 Urdu) and Junaid Rafig (TV 9) were "beaten" today while covering the ongoing DDC elections in Srigufwara area of South Kashmir.

He according to KPC also said that their news gathering equipments were also seized by the police. Fayaz Lolu alleged that it was when the SSP of Anantnag arrived on the spot that they were beaten up ruthlessly and taken to the nearest police post. Fayaz further stated that Junaid has been injured and was in hospital.

The KPC terms this incident unfortunate and calls for a thorough inquiry into the incident. We hope strict action against is taken against those found guilty in this act perpetrated in utter disregard of the freedom of the press. The KPC further urges the Chief Electoral Officer to take note of such incidents and initiate action against the concerned police official.

The KPC further urges that the authorities should ensure that an enabling atmosphere is created for the free and fair functioning of the media in Kashmir.

Covid Ending...

After a four-hour-long motivational conversation, his words did the trick.

"Those six survivors," he said, "gave up the idea of suicide forever."

However, Wani said, they were not the only ones in desperate need of support. Many 'silent types', like Adil Hussain Dar of Shopian, needed the same treatment. The 22-year-old was called the "Tendulkar

of welding" for his monumental work. But during the 2016 protests, Dar lost his eyesight to pellet assault. There was no end to his miseries, as he was forced to halt work, which created family crisis for him.

"The medical expenses put the pellet victims' family in such deep debt that it forces them to give up on their own children," Dar lamented over his fate.

As the majority of the pellet survivors in ashmir belong to humble families theyoften gave up on their medical treatment as the sense of failure in fulfilling their family obligation takes a mental toll on them.

These crisis-ridden cases eventually motivated Wani to institutionalize Pellet Victims Welfare Trust (PVWT) on August 25, 2017. And since its inception, the trust has already helped the survivors in overcoming their traumatic behaviours.

"I established the trust with the support of five other survivors," Wani said. "I was hit by a bullet in the back which pierced my liver and came out through the chest and then after 2 months I was fired 635 pellets. My conscience wasn't allowing me to let anybody else experience the same mental stress that I did after all these injuries.'

Currently, some 1200 pellet survivors, including Shabroza from Rahmoo Pulwama, are registered with Wani's PVWT.

A DISARRAYED DREAM

The 18-year-old class topper was preparing for her board exams when the deadly pellets pierced her left eyeduring 2016 protests.

"Before injury, my financially-weak family was dreaming to see me a KAS officer one day," Shabroza said. "But that dream will only stay a dream now."

It was Wani's Trust, which became a much-needed moral support for Shabroza during her distress. "Pellet survivors aren't always in dire need

"If they (government) can hold DDC elections during the Covid times, I appeal and demand holding of assembly election in Jammu and Kashmir soon, and put in place an elected government. They should do it. It is our demand," Patil told reporters here. Patil is the only national leader of the Congress to have hit the campaign trail for the DDC elections in Jammu and **Kashmir**

She criticised the government for holding the polls at a time when the COVID-19 situation is still not under control. "They took a wrong decision to hold these polls now. Our several top leaders were infected with COVID-19, including youth and women Congress unit heads and former ministers. It is difficult to campaign," Patil said.

On the withdrawal of security and vehicles of several Congress leaders including himself, Mir said, "Life and death is in the hands of Almighty. They withdrew the security of our leaders, former ministers and former legislators during this period. It is clear that they want us restricted to our homes.'



American FBI team arrives in Sgr

EW DELHI: A two-member team of US Federal Bureau of Investigation (FBI) today left for Srinagar in connection with the mys¬terious disappearance of the four foreigners kidnapped in 1995, official sources said. The sources said this was a routine visit by the FBI officials as per the requirement of the United States laws where they have to submit a report every quarter.

Six foreigners — John Childs and Donald Fred Hutchings (both US nationals), Paul Wells and Keith Mangan (UK nationals), Dirk Hasert (German) and Hans Christian Ostro (Norwegian) — had been kidnapped in July 1995 from Pahalgam hills in South Kashmir.

The group responsible for kidnapping identified itself as Al-Faran. While Childs managed to give a slip to his abductors, the head of Norwegian abductee was found severed near Anantnag in August 1995.

The fate of other four hostages despite hectic search operation carried by the government and later by German and British po¬lice remains unknown

Address Fears Of Farmers

rotests by farmers in the country is showing no signs of ending with successive talks between the government and farmers' leaders leading nowhere. The farmer unions have rejected the latest proposal by the government to amend controversial new farm laws and have warned they will intensify their protests if their demand for rollback of the new farm laws was not met. The centre on Wednesday had sent a written proposal to the unions, laying out a series of amendments including written assurances for Minimum Support Price (MSP), one of the key demands of protesting farmers. The government had also proposed the scrapping of the Electricity Amendment Bill opposed by farmers. Besides, the agriculture minister Narendra Singh Tomar also held out assurance that the Agricultural Produce Market Committee (APMC) Mandis will not be dismantled.

But the farmers are not ready to budge. They want the three farm laws passed by the union government that deregulate crop pricing withdrawn. They argue that the laws will only hurt their livelihoods and will only benefit large corporations. The situation remains deadlocked. The farmers, meanwhile, have laid a siege to New Delhi, blocking its main entry points. The government, it seems, has now fewer options left but to accede to farmers' demands. If this happens this will be the first time that the Modi government will be forced to withdraw any of the laws it has passed so far.

One of the biggest charge against the BJP-led union government is that it is unilaterally passing the farreaching laws with a bearing on the lives of the millions of people. This started with sudden demonitisation of Rs 1000 and Rs 500 notes in November 2016 that plunged the country into a virtual chaos. People thronged the banks to either exchange or deposit their old currency. Long queues of people, a significant number of them senior citizens, appeared outside the banks and ATMs to deposit their cash. Scores lost their lives in the process. Then followed the GST reform which crushed the small businesses. This was followed by the revocation of Article 370 that granted J&K its semi-autonomous status within Indian Union. The move's disruptive fallout is still playing out in J&K and Ladakh, the former parts of J&K state, now downgraded into two union territories. Following this, the centre came up with Citizenship Amendment Act that ensured that only non-Muslim refugees from the neighbouring countries are entitled to Indian citizenship. Though the CAA was also resisted by people, the outbreak of Covid-19 pandemic ended the protest. Now the farmers protest is taking place despite the pandemic. And it remains to be seen how the central government responds to it. The best course for the government is to address the anxieties of the farmers and do everything to assure them that their livelihoods will not be threatened.

Honey trap

weetness can leave a bitter taste in the mouth. Researchers from the Centre for Science and Environment have alleged that the honey produced by major Indian brands is adulterated with sugar syrup. That is not all; there appears to be a discrepancy in the results of different tests geared towards the same purpose. The environment watchdog had selected 13 popular honey brands to assess the purity of the product. Curiously, while the samples of almost all the big brands tested at the Centre for Analysis and Learning in Livestock and Food in Gujarat were found to be 'pure', 10 of the same brands failed the Nuclear Magnetic Resonance test, which is conducted by a specialized laboratory in Germany and is used globally to check for the use of modified sugar syrups. It stands to reason that assessment standards vary. If the NMR test detected adulteration that the checks in Gujarat could not identify, ought not the Central government to adopt the more stringent assessment model for domestic testing since the matter concerns public health?

Making the waters murkier are revelations of the import and use of Chinese sugar syrups that are 'designed' to avoid detection in tests. The CSE has said that its investigators received a shipment of samples containing syrup from a Chinese company that sought to evade the honey testing protocols mandated by the Food Safety and Standards Authority of India. In the wake of the recent border hostilities, the Union government tom-tommed its ban on a series of Chinese mobile apps as an economic 'surgical strike'. Yet, it is evident that Chinese syrups continue to be imported by firms; traders even claim that Chinese companies have helped set up sugar syrup factories in India. It appears that the Centre's economic surgical strike against China may have missed a few targets. The main worry, however, concerns regulatory oversight. The history of weak implementation of adulteration laws in India does not help either; Maggi was banned by the FSSAI in 2015 for allegedly selling lead-laced instant noodles before the government allowed the brand to return to the market. The battle against food fraud must be fought on two fronts. First, there is a case for raising public awareness so that citizens know that the products they are consuming are safe; second, institutional assessment protocols must be uniform to avoid conflicting results. There is also the additional imperative of assisting beekeeping communities — the maulis of the Sunderbans are an example — whose livelihoods have been decimated by the pandemic.

Disowning Our Women — Again

hen it comes to feeling collectively enraged on the issues of sexual assault and violence against women, we have developed an infamously thick culture of silence.

The recent rape case of a 21 year old woman who eventually succumbed to her injuries has yet again resurfaced our criminal culture of silence. The 21-year-old. breathed her last on November 27 after being abducted and raped by two men in an orchard in Ashmuji village of Kulgam. The woman fought grave injuries at the hospital for over a month, but could not make it. The Doctors said she was badly injured. As the initial report goes, she was hit on her head which caused traumatic brain injury. She had strangulation marks on her neck. The final autopsy report is yet to come, yet the level of violence inflicted on the deceased

As per the statement given the deceased's aunt, she was not only raped but ruthlessly tortured. The skin around her eyes was found torn, she had marks around her neck suggesting that the culprits attempted to choke her to death.

No matter how graphic the details of the case are, our society has decided to stay firmly indifferent on the matter. As in this case, rape is often accompanied by assault and violence wherein use of sharp objects is made to inflict additional pain. While psychoanalysts would read such violent behaviour as a form of 'womb envy', it is also reflective of how toxic masculinity is emboldened by our collective silence.

While we as a society should be protesting against such crimes and demanding punishment for the culprits, we rather choose to dig our heads into the sand. "Social fabric" and "righteousness" in other words, are kept intact by choosing the easy path of denial. No wonder

the brutal rape case has failed to shake the spirits of the valley. The criminal culture of silence and the doctrine of denial have thankfully fortified our collective conscience from the bruises of guilt and freed us from the responsibility to act. The rightful sentiment of informed rage is insanely and maddeningly absent in our context.

The whole process begins with a misplaced assumption that we inhabit the Reshi Waerr / Land of Sufis and therefore are immune to aberrations on these lines. If at all any such aberrations do take place they are immediately attributed to "foreign nfluences" on "indigenous" culture.

Both the statements do hold an element of truth but are largely redundant and evasive since, yet again, there is no space left for collective introspection and interrogation of structures that lead to crimes against women. Such thinking imagines the members of society as passive adherents absolving them of any action. Evil has always formed an integral part of every society and shying away from recognising it is a bigger evil.

Unknowingly, our indifference and our unwillingness of engagement with the issues related to sex education sets a cycle of violence into motion which engenders more violence at each level. Such topics are deemed downright subversive to collective piety and social equilibrium.

The incident serves as a reflection of how patriarchal systems are inherently disempowering and limiting, particularly for women. When the entire society should be up in the arms against the culprits, it strictly adheres to its notion of taboo.

Stigmatisation is yet another criminal factor attached. Culprits may be recognised and may face collective ridicule from the society. yet the victim is put under unbearable pressure. Victim-blaming is still a norm. This results in shrinking spaces for reporting the rape cases which further emboldens the criminals and sponsors silence.

Even as there is still disagreement over how rape culprits must be dealt with. One view is that violence cannot be stopped by inflicting more violence. Therefore, the paths of re-socialisation and counselling should be taken on board in dealing with the culprits. While such debates will continue to happen, steps for the security of women must be taken right from the beginning.

We must realise that even as we may debate and discuss the merits and demerits of retributive justice, it is also important to see how our own society feeds rape culture. An inconsequential nostalgia is rarely the way forward. Until and unless, we see women as agential beings and do not reduce them to objects, violence against women is inevitable. We need to acknowledge how rape is not merely a sexual crime but a crime that emanates from a position of power

When we "reason" with rape, it only promotes rape culture. Our discussions about rape and how to avoid them need to shift the entire focus to grooming potential culprits rather than bickering about all that's wrong with women which is nothing but rape apologia.

Patriarchal structures are impartial to gender differences when it comes to fuelling and enforcing silences vet women in our society are at a particular disadvantage given the complex and intersectional positions they are placed at. The fact that our society has forgotten and disowned its women perhaps serves as pointer of who the real culprits are when such dehumanising crimes take place.

nternet services were snapped last year with the abrogation of Article-370, only to be resumed after months at 2g speeds. Different sectors including health, education and businesses which are in this age heavily dependent on internet suffered severe losses. While the internet services were resumed at throttled speeds. The world has already been accustomed to new working models which are heavily based on internet usage. Going with the tradition of moving forward, instead of going back in time, it becomes imperative on the authorities to lift the constraints on high speed internet.

The telecommunication companies have been charging for 4g plans

A Special Mother

Disability is more of a dysfunction of society collectively, rather than just the impairment or sickness of a person. We have to realise what actually makes a person disabled is the lack of acceptance and inclusivity from society

n eleven-year-old child, Yafi, comes running towards the potwhere I had kept my mobile phone, ignoring my greetings and wishes for his birthday which I had come to know from his mother Rosy (name changed) just minutes before visiting her maternal home.

Despite meeting me for the first time, Yafi didn't hesitate to place his head in my lap comfortably, pulling my fingers indicating to unlock the phone for him. As I did, he tapped the screen several times until I heard videos playing on You Tube. Well, it's a norm for children born in 2000s but, not for children like Yafi.

Yafi is a child with disability. While he was busy playing the loop, his mother Rosy with all smiles tells me he is a music lover.

Rosy is a woman in her forties and a mother of two children. She looked pale and flushed as she had recently lost her mother. While lamenting the sudden demise of her mother, I couldn't stop my memories travel back to my college days when she had been my English teacher. She used to be so vibrant and cheerful that it seemed almost impossible for me to recognise her now. She looked totally strange and different now.

Being a mother of a special child, parenting has been quite toilsome for her. "Most of the time, child is not cooperative", says Rosy when asked about her experience as a special mother. "They need more care and attention than a normal healthy child. I have to take care of everything, even simple task like wiping his nose. As a mother I know it's not his fault, he has this condition"

Yafi's disorder was detected late. A family friend,doctor by profession,had suggestedto undergo certain tests as he observed some dimorphic features in the child.

She began to recall the day when reports confirmed her child with disablity."My whole world imploded. What is more painful for a mother than knowing that her child is not so-called normal!"

With Yafi in her lap, she had cried and wailed while sitting on a footpath.At that moment, her child had passed her an innocent smile. "That smile gave me strength to get up and work for his well-

Life for Rosy and Yafi was not the same after the diagnosis. Apart from frequent visits to doctors, attitude of society and people around also began to change. Different tags were attached, mostly, from her own relatives.

As such, her child showed delayed development milestones. She felt disheartened seeing her sonunable to walk while other children of his age had began to run. She chose not to sit and curse her fate. But rather work for her child's betterment.

However, being a teacher it was difficult for



her to manage work as well as a child who needed special attention. But somehow, not losing her willpower, she gave exercising sessions (as prescribed by the doctors) to Yafi before and after leaving for work.And her hard work paid off. Her eyes welled up with tears recalling the moment when Yafi took his first step at the age of 6. "What a moment it was, I can hardly describe that happiness and bliss when I saw him walking", says Rosy.

She says raising a special child, indeed, is a very challenging task. But, being a mother she doesn't have an option to give up."If I would, who else would take care of him"

Well, the person before being disabled is a human being and hence, an integral part of the society. Therefore, disability is a responsibility of a society as a whole and not of a parent or family associated. He/she is also entitled to the rights and privileges society assures to everyone. Why do we make disability an exception? What if we try to mitigate the gap just by a single gesture of acceptance?

More than reservations, now the society has to realise that we have to become more inclusive towards them and widen their sphere. Let them also

go to school, have more accessibility, more choices and above all, a good satisfied life.

Let us include them, and not dictate them to do things in our way.Let them do things in their own way.Let us be compassionate enough to give them

As Rosy says, apart from parenting, society is a big challenge for us. Where the world has started to create avenues for their inclusivity, Kashmiri society is still far behind terming the lot as me'at (insane), out of ignorance.

Disability is more of a dysfunction of society collectively, rather than just the impairment or sickness of a person. We have to realise what actually makes a person disabled is the lack of acceptance and inclusivity from society. And it can be done by assuring basic ADL(activities of daily living) to build whole infrastructure, assuring dignified lives for persons with disablity.

t used to be said that the difficulty with parenting is that no-one gives you a manual, but you could argue that adage is no longer true.

From "tiger mums" to "attachment parents", countless manifestos offer advice on how to successfully raise a child. In fact, there's so much parenting advice around that firsttime parents (in particular) car struggle to trust their own instincts and knowledge

While book sales may be up, is there any scientific evidence to suggest better outcomes for children raised in any of these pop-culture parenting styles?

Hovering around

Most parenting research centres on "helicopter" parenting. Helicopter parents are so named because they hover above their children at all times, regularly swooping in to protect them from challenges and harm.

Anecdotes and media data don't always present helicopter parents in the most flattering light, and the limited scientific research available appears to confirm this view.

One study found that, by adulthood, children of helicopter parents perceived poorer quality of communication with their parents compared with those whose parents were less helicopter-like. It also found these children had a heightened sense of personal entitlement.

Another study of college students found that those who reported helicopter parenting had lower levels of overall well-being and were more likely to be medicated for anxiety or depression, or both.

In contrast, a third study of young adults found the children of overly involved parents had better well-being scores than others. But their parents reported reduced life satisfaction due to their now-grown children still requiring intensive support.

Ploughing through

A close relative of the helicopter parent is another piece of parenting heavy machinery, the "snowplow" parent. This parent diligently removes all obstacles from their child's path, eliminating challenge and hardship as best they can.

The idea is that by removing all obstacles, the child is free to focus on success and not be inhibited by

failure. While the helicopter parent operates out of fear of something happening to their child, the snowplow parent just wants to make their child's path in life easier.

There appears to be no empirical research on snowplow parenting yet, but both parenting styles could be defined as versions of over-protective parenting, about which there is some evidence.

Protection and over-protection

Research shows that children of over-protective parents are shyer toddlers, have more behavioural problems in childhood, higher depression scores in adolescence, and increased anxiety in adulthood.

Research also points to helicopter and over-protective parenting as being symptomatic of a family unit that is

otherwise experiencing problems, which could include communication problems and broader unhappiness within the home.

A propensity to over-parent is associated with higher maternal anxiety; it can mean that the longterm relationship between parent and child can be damaged due to constant intrusion; and it may be difficult to sustain a healthy relationship between parents when so much focus is on the child.

Although this all sounds fairly dismal, it's important to note that helicopter and snowplow parents behave in the way they do because they want the very best for their child. And this is a vitally important element of child development and well-being.

It's just that, in their anxiety to ensure their child's future success,

these parents end up doing everything for their children instead of allowing them to develop independence and autonomy by doing tasks themselves.

If all this over-parenting sounds a little too intense, the "free range" parenting style may be the one for you. This is the parenting philosophy coined by Lenore Skenazy, who became known as "America's Worst Mum" after publishing an opinion piece disclosing that her nine-yearold son was allowed to catch the New York subway on his own.

Like their chicken counterparts, free range kids are allowed to roam, unsupervised and outdoors. Skenazy argues that we live in safe times, the potential for harm to our children is far less than we perceive, and that it's important for children to learn responsibility and independence early.

So at what age can children safely play outside alone? Answering that question gets to the heart of the difficulty with all these parenting styles and philosophies.

Every child is different, and each will develop requisite responsibility at a different rate. Each parent is different, and some will feel at home with their children playing somewhere down the street where others will only feel comfortable when they can see their child at all times.

Heart disease now killing more people than ever before: WHO

of death at the global level for the last 20 years, is now killing more people than ever before, according to the World Health Organization.

The WHO said diabetes and dementia are also among the world's other reminder that we need to top 10 causes of death.

The WHO's 2019 Global Health Estimates, released on Wednesday, said non-communicable diseases now make up 7 of the world's top 10 causes of death, an increase from 4 of the 10 leading causes in 2000. The new data cover the period from 2000 to 2019.

"Heart disease has remained the leading cause of death at the global level for the last 20 years. However, it is now killing more people than ever before," the organisation said.

Heart disease now represents 16 per cent of total deaths from all causes and the number of deaths from heart disease increased by more than two million since 2000 to nearly 9 million in 2019. Diabetes and dementia enter the top 10 causes of death.

Alzheimer's disease and other forms of dementia are now among the top 10 causes of death worldwide, ranking 3rd in both the Americas and Europe in 2019. Women are disproportionally affected: globally, 65 per cent of deaths from Alzheimer's and other forms of dementia are women.

Deaths from diabetes increased by 70 per cent globally between 2000 and 2019, with an 80 per cent rise in deaths among males. In the Eastern Mediterranean, deaths from diabetes have more than doubled and represent the greatest percentage increase of all WHO regions.

The WHO said the estimates reveal trends over the last 2 decades in mortality and morbidity caused by diseases and injuries, clearly highlighting the need for an inten-sified global focus on preventing

While more non-communicable diseases are now causing deaths worldwide, there has been a global decline in deaths from communicable diseases, which however still remain a major challenge in lowand middle-income countries.

In 2019, pneumonia and other lower respiratory infections were the deadliest group of communicable diseases and together ranked as the fourth leading cause of death.

to the 19th in 2019, reflecting the success of efforts to prevent infection, test for the virus and treat the disease over the last two decades. While it remains the fourth leading cause of death in Africa, the number of deaths has dropped by more than

half, falling from over 1 million in

2000 to 435 000 in 2019 in Africa.

WHO said Tuberculosis is also no longer in the global top 10, falling from 7th place in 2000 to 13th in 2019, with a 30% reduction in global deaths. Yet, it remains among the top 10 causes of deaths in the African and South-East Asian regions, where it is the 8th and 5th leading cause respectively.

The new projections state that people are living longer - but with more disability.

The estimates further confirm the growing trend for longevity: in 2019, people were living more than 6 years longer than in 2000, with a global average of more than 73 years in 2019 compared to nearly 67 in 2000. But on average, only 5 of those additional years were lived in good health. Disability, however, is on the rise.

"To a large extent, the diseases and health conditions that are causing the most deaths are those that are responsible for the greatest number of healthy lifeyears lost. Heart disease, diabetes, stroke, lung cancer and chronic obstructive pulmonary disease were collectively responsible for nearly 100 million additional healthy life-years lost in 2019 compared to 2000," WHO said.

Injuries are another major cause of disability and death, with the African region recording a significant rise in road traffic injuries

Globally, deaths from road trafc injuries are 75 per cent male.

Assistant Director-General for the Division of Data, Analytics and Delivery for Impact at WHO Dr Samira Asma said robust health data are critical to address inequalities, prioritize policies and allocate resources to prevent disability and save lives.

"We call upon governments and stakeholders to urgently invest in data and health information sys-

Study suggests exercise may protect bone health after weight loss surgery

Although weight loss surgery is a highly effective treatment for obesity, it can be detrimental to bone health. A new study published in the Journal of Bone and Mineral Research suggests that exercise may help address this shortcoming.

The study randomised 84 patients undergoing weight loss surgery to an exercise group or a control group for 11 months. The exercise group performed a high impact, balance, and resistance exercises three times per week. Twelve months after surgery, participants in the exercise group had higher bone mineral density measurements at the lumbar spine and the forearm compared with those in the control group. In the new test, the Cas 13 protein is combined with a reporter molecule that becomes fluorescent when cut, and then mixed with a patient sample from a nasal swab, the researchers said.

The sample is placed in a device that attaches to a smartphone. If the sample contains RNA from SARS-CoV-2, Cas13 will be activated and will cut the reporter molecule, causing the emission of a fluorescent signal, they said.

The smartphone camera, essentially converted into a microscope, can detect the fluorescence and report that a swab tested positive for the virus, according to the researchers. They say that the assay could be adapted to a variety of mobile phones, making the technology easilv accessible.

When the scientists tested their device using patient samples, they confirmed that it could provide a very fast turnaround time of results for samples with clinically relevant viral loads. The research found that the device accurately detected a set of positive samples in under 5 minutes.

For samples with a low viral load, + the researchers said, the device required up to 30 minutes to distinguish it from a negative test. -PTI

Studying individual differences in language skills



Although most people learn to speak participants. In addition, the brains of their mother tongue fluently, native speakers differ in their ability to use language. Adult language users not only differ in the number of words they know, they also differ in how quickly they produce and understand words and sentences. In a recent study, researchers find how do individuals differ across language tasks and what are individual differences in language ability related to general cognitive abilities.

Such questions can only be answered by testing large numbers of individuals on a large number of language and cognitive tests. Lead author Florian Hintz and his team designed such a test battery, with the aim of using it in a larger study. In the larger 'IndividuLa' study (funded by the Language in Interaction consortium), the team will be combining test performance data with DNA from a thousand about 300 of the 1,000 participants will be scanned. However, the authors first needed to pilot the test battery with a smaller number of participants. "Previous individual-differences studies have often focused on a limited set of skills," says Hintz. "The present dataset goes one step further and provides a comprehensive overview of language users' linguistic and non-linguistic skills, with multiple tests per skill".The researchers invited 112 participants with ages ranging from 18 to 29 and mixed educational backgrounds to the lab in Nijmegen. Participants completed the battery of 33 tests twice, to establish the reliability of the new measurements, with one month in between test sessions. Testing took about eight hours per participant.

The battery included three types of tests: (1) tests of linguistic experience

such as vocabulary size, (2) tests of general cognitive skills such as processing speed or working memory capacity, and (3) tests of linguistic processing skills, measuring production and comprehension of words and sentences. Apart from well-known standardised tests (such as Raven's matrices), the battery included newly developed tests (such as a test on idiomatic expressions and a test on normative rules of Dutch grammar). The majority of the tests proved to be

reliable and suitable for the Individual main study, which is currently ongoing. The team is still recruiting participants for the main study, so native Dutch speakers (between 18 and 30) are invited to take part.

The authors decided to share the data from their pilot study, which is freely available at the UK Data Service data archive. The team encourages other researchers to use the database for new analyses, "Individual-differences studies are rarely conducted, as these studies are time-consuming and expensive," says Hintz. "Especially in the current situation, where in-person testing isn't always possible, this resource may provide alternative routes for conducting research".

"The database is valuable to any researcher, clinician, or teacher interested in investigating the relationships between linguistic skills, non-linguistic skills and linguistic knowledge", Hintz concludes. "Ultimately, using this dataset, one may take a first step towards addressing the question 'What makes someone a good language user?"

How much plastic are you eating?


What's for dinner? Lego sushi, credit card burgers, or a well-done piece of PVC

These examples may sound extreme, but can easily represent over time the cumulative amount of microscopic pieces of plastic we consume every day.

People could be ingesting the equivalent of a credit card of plastic a week, a 2019 study by WWF International concluded, mainly in plastic-infused drinking water but also via food like shellfish, which tends to be eaten whole so the plastic in their digestive systems is also consumed.

Reuters used the findings of the study to illustrate what this amount of plastic actually looks like over various periods of time.


UK Issues Allergy Warning On Pfizer Vaccine After Adverse Reactions

London: Britain's medicine regulator said anyone with a history of anaphylaxis to a medicine or food should not get the Pfizer-BioNTech CO-VID-19 vaccine, giving fuller guidance on an earlier allergy warning about the shot.

Starting with the elderly and frontline workers, Britain began mass vaccinating its population on Tuesday, part of a global drive that poses one of the biggest logistical challenges in peacetime history.

The Medicines and Health-



The fuller guidance, clarifying that the main risk was from anaphylaxis specifically, was issued after consulting experts on allergies. The MHRA had initially advised anyone with a history of a "significant allergic reaction" not to take the shot.

Pfizer and BioNTech said they were supporting the MHRA's investigation.

Last week, Britain's MHRA became the first in the world to approve the vaccine,



care Products Regulatory Agency (MHRA) said there had been two reports of anaphylaxis and one report of a possible allergic reaction since rollout began.

"Any person with a history of anaphylaxis to a vaccine, medicine or food should not receive the Pfizer BioNTech vaccine," MHRA Chief Executive June Raine said in a statement.

"Most people will not get anaphylaxis and the benefits in protecting people against CO-VID-19 outweigh the risks... You can be completely confident that this vaccine has met the MHRA's robust standards of safety, quality and effectiveness."

Anaphylaxis is an overreaction of the body's immune developed by Germany's BioNTech and Pfizer, while the U.S. Food and Drug Administration (FDA) and European Medicines Agency (EMA) continue to assess the data.

A top U.S. official said on Wednesday that Americans with known severe allergic reactions may not be candidates for Pfizer's COVID-19 vaccine until more was understood about what had happened.

Canada's health ministry said it would look at the reported adverse reactions in Britain, but said adverse events were to be expected and would not necessarily change the risk/benefit of the shot, after the country approved the vaccine.

Pak, China Began Joint Air Exercise Shaheen (Eagle)-IX On Wednesday

Islamabad: The air forces of Pakistan and China on Wednesday commenced a joint exercise designed to deepen practical cooperation and improve the actual-combat training level of the two sides.

The joint air force exercise "Shaheen (Eagle)-IX" started on Wednesday at an operational air base of the Pakistan Air Force (PAF) in Sindh province.

A contingent of the People's Liberation Army Air Force (PLAAF), comprising combat pilots, air defence controllers and technical ground crew, participated in the exercise, the PAF said in a statement.

The opening ceremony of the exercise was jointly witnessed by Deputy Chief of Air Staff (Operations) Air Vice Marshal Waqas Ahmed Sulehri and Assistant Chief of Staff, PLAAF, Major General Sun Hong, it said.

"The joint exercise will improve the actual level of combat training and strengthen practical cooperation between the two air forces," Major General Sun Hong said.

Welcoming the Chinese contingent, Air Vice Marshal Sulehri said, "The joint exercise will provide an opportunity to further enhance interoperability of both the air forces, thereby fortifying brotherly relations between the two countries."

Shaheen-IX is the ninth in the series of Joint Air Exercises which is conducted each year in both countries on alternate basis. The first such drill was held in Pakistan in March 2011.

China and Pakistan share close military ties. China helps Pakistan to jointly produce JF-17 fighter jets and other armaments.



ICC Drops Probe Into Alleged UK War Crimes In Iraq Despite 'Reasonable' Evidence

Baghdad: Despite finding "reasonable basis" for allegations of war crimes against British soldiers in Iraq, an International Criminal Court (ICC) prosecutor dropped a preliminary investigation, citing the UK's own efforts to investigate the conduct of its troops in the war.

In a statement released on Wednesday, prosecutor Fatou Bensouda acknowledged the fact that the probe did not lead to the prosecution of any suspects, but stressed that the outcome of the investigation does not mean war crimes did not occur.

"There is a reasonable basis to believe that members of the British armed forces committed the war crimes of willful killing, torture, inhuman/cruel treatment, outrages upon personal dignity, and rape and/or other forms of sexual violence," Bensouda said.

"The Office [of the Prosecutor] has identified a confined number of incidents to reach this determination

which, while not exhaustive, appear to correspond to the most serious allegations of violence against persons in UK custody."

The ICC statement also refuted claims that legal proceedings made on behalf of Iraqi victims of alleged war crimes were all "vexatious" or spurious, as stated by former British Prime Minister Theresa May and other UK government ministers.

The UK's Service Prosecution Authority threw out hundreds of claims brought on behalf of Iraqis against the UK Ministry of Defence for alleged abuses.

"The Office has found untenable the proposition that these various processes all arose from vexatious claims," the ICC prosecutor said in her statement, adding that the lack of prosecutions "has deprived the victims of justice".

Rupert Skilbeck, director of legal firm Redress, which brings legal cases on behalf of victims of torture, said: "Survivors of torture and ill-

treatment will be profoundly disappointed that the ICC Prosecutor will not now be pursuing her investigation against the UK.

"The prosecutor is clear that there was strong evidence of war crimes - including the use of the 'five techniques' [of physical and psychological abuse] - and identifies numerous concerns with the UK investigations, not least that there were no prosecutions despite such a large number of accepted claims."

In an accompanying report, the prosecutor detailed alleged incidents committed by UK armed forces against "civilians or hors de combat" at detention facilities in Iraq between 2003 and 2009.

The report speculated that the Iraq Historic Allegations Team (IHAT) and later the Service Police Legacy Investigations (SPLI) - which led internal UK probes - did not press charges against soldiers because of a lack of evidence or because they were not confident in securing convictions.

Iran Afghanistan inaugurate crucial rail project

TEHRAN: Iran and Afghanistan on Thursday inaugurated the Khaf-Herat 220-kilometer (136 miles) railroad project, in presence of the presidents two countries.

As part of the large eastwest railway corridor extending to China and Europe, this new railway track connects Iran's eastern city of Khaf with Afghanistan's western city of Ghorian.

During the virtual inauguration ceremony, Iran's President Hassan Rouhani termed it a "historic day" in the relations between the two neighboring countries.

He said the rail route, which is Iran's sixth border railroad with neighboring countries, will "strengthen the bond" between Iran and Afghanistan.

Under construction since

2007, the project worth 28 trillion rials (\$700 million) consists of four sections. Three sections of the route were funded by Tehran and the fourth section by Kabul.

The three sections, covering 140 km (86 mi) from Khaf in Iran to Roznak in Afghanistan's Herat province, were put into operation on Thursday.

Ahead of the ceremony, a trial freight train delivered 400 tons of cement from Iran to Afghanistan last week. A passenger train also took Iranian officials to Afghanistan for a meeting.

According to Iran's Minister of Roads and Urban Development Mohammad Eslami, the railroad can transport one million passengers and six million tons of goods a year.

Rouhani, speaking through video link, said the culture and history of the two countries are intertwined, so the economy and markets should also be linked.

"Our victory is your victory and your happiness are our joy," he said, addressing the people of the neighboring country.

"We are proud to have hosted millions of Afghans over the past 40 years," he added.

Afghan President Ashraf Ghani in his speech expressed happiness over the operationalization of what he described as a "historic and vital project." He hoped the project will lead to an "economic leap" of the region.

US Senate backs massive arms sales to UAE after Trump veto threat

Washington: The United States Senate has defeated an effort to block the Trump administration's sale of \$23bn in advanced fighter jets and drones to the United Arab Emirates.

President Donald Trump had issued a formal threat to veto congressional efforts to block the planned weapons transfer, which is tied to the UAE's normalisation of ties with Israel under the "Abraham Accords".

Two procedural votes failed to gain a majority of the 100-member Senate, effectively stopping the effort to block the sale of advanced F-35 fighter jets and Reaper drones.

Senate Republican leader Mitch McConnell said the resolutions seeking to block the arms sale fell far short of the two-thirds support that would be needed to overcome a presidential veto.

"It's a little baffling to suggest that, now of all times, a protest gesture with no chance of obtaining a veto-proof majority is a valuable use of the Senate's time," McConnell said in Senate floor remarks.

Backers of the sale described the UAE as an important US partner in the Middle East. Opponents criticised the UAE for its involvement in the war in Yemen, a conflict described by the United Nations as one of the world's worst humanitarian disasters.

The Trump administration told Congress on November 10 that it had approved the sale to the UAE of weapons made by General Atomics, Lockheed Martin Corp and Raytheon Technologies Corp.

The deal includes the F-35, the world's most advanced fighter jet; more than 14,000 bombs and munitions; and the second-largest sale of US drones to a single country.

The White House said the sales directly support US foreign policy and national security objectives by "enabling the UAE to deter increasing Iranian aggressive behaviour and threats" in the wake of its recent deal with Israel.

The veto threat was expected. US law requires congressional review of major arms deals, and lets senators force votes on resolutions of disapproval.

Facebook Faces US Lawsuits That Could Force Sale Of Instagram, WhatsApp

Washington: Facebook Inc could be forced to sell its prized assets WhatsApp and Instagram after the U.S. Federal Trade Commission and nearly every U.S. state filed lawsuits against the social media

company, saying it used a "buy or bury" strategy to snap up rivals and keep smaller competitors at bay.

With the filing of the twin lawsuits on Wednesday, Facebook becomes the second big tech company to face a major legal challenge

this year after the U.S. Justice Department sued Alphabet Inc's Google in October, accusing the \$1 trillion company of using its market power to fend off rivals.

The lawsuits highlight the growing bipartisan consensus to hold Big Tech accountable for its business practices and mark a rare moment of agreement between the Trump administration and Democrats, some of whom have advocated breaking up both Google and Facebook.

The complaints on Wednesday accuse Facebook of

buying up rivals, focusing specifically on its previous acquisitions of photo-sharing app Instagram for \$1 billion in 2012 and messaging app WhatsApp for \$19 billion in 2014.

Federal and state regulators said the acquisitions should be unwound - a move that is likely to set off a long legal challenge as the deals were cleared years earlier by the FTC. "For nearly a decade, Facebook has used its dominance

and monopoly power to crush smaller rivals, snuff out competition, all at the expense of everyday users," said New York Attorney General Letitia James on behalf of the coalition of 46 states, Washington, D.C. and Guam. Alabama, Georgia, South Carolina and South Dakota did not participate in the lawsuit.

James said the company acquired rivals before they

could threaten the company's dominance.

Facebook's general counsel Jennifer Newstead called the lawsuits "revisionist history" and said antitrust laws do not exist to punish "successful companies." She said WhatsApp and Instagram have succeeded after Facebook invested billions of dollars in growing the apps.

China Tells Airline Crew To Wear Diapers On Risky Covid Flights

hina's aviation regulator is recommending cabin crew on charter flights to high-risk Covid-19 destinations wear disposable diapers and avoid using the bathroom to reduce the risk of infection.

The advice comes in a 38-page list of guidelines for airlines to prevent the spread of coronavirus. The sixth edition echoes similar instructions in previous, less lengthy versions.

The Civil Aviation Ad-

ministration of China said the recommendation applies for charter flights to and from countries and regions where infections exceed 500 in every one million people.

The diaper advice is in a section on personal protective equipment, which also recommends the following

Other advice for the flights includes dividing the cabin into "clean area, buffer zone, passenger sitting area and quarantine area," separated by disposable curtains. The last three rows should be designated as an emergency quarantine area, said CAAC. CAAC declined to disclose any more details on the

guidelines.

China's aviation market was hit hard at the onset of the outbreak in Wuhan and subsequent spread around the country. But it has recovered -- on the domestic front at least -- to close to prepandemic levels, while other regions such as Europe and the U.S. struggle to bring Covid-19 under control.

laying ceremony for the new Parliament building on Thursday, Prime Minister Narendra Modi declared the building would "witness India becoming atmanirbhar (self-reliant)".

The Central Vista project, of which the new Parliament is a key part, has been a major project of the Narendra Modi government. Not surprisingly, it has been opposed bitterly by opposition parties such as the Congress. The current Parliament, built by the British, was inaugurated in 1927.

Congress MP Jairam Ramesh was seemingly not impressed by the design for the new Parliament. Ramesh tweeted it bore an "eerie likeness" to the Pentagon, the US Department of Defense's headquarters.

tweeted, "Well, the existing Parliament building built by the Brits bears a remarkable similarity to the Chausath Yogini Temple in Morena in Madhya Pradesh, while Twitter handle alleged the Modi the new 'atmanirbhar' Parliament building bears an eerie likeness to new Parliament stemmed from the Pentagon in Washington DC."

Manish Tewari, a Congress Lok Sabha MP, tweeted, "Why has the new Parliament building been modelled on the Pentagon? Coincidence -deliberate or default?"

However, Ramesh himself

posed Parliament had a triangular shape.

For instance, Savio Rodrigues, the editor of Goa Chronicle, tweeted, "Jairam, it is my honest advice because you are normally intelligent, please get your eyes checked. Pentagon is a Pentagon structure, in what way does the new Parliament building look like a Pentagon. In fact, the structure is more in keeping with our Vedic structures."

The Congress party's opposition to the new Parliament extends to more than just aesthetics. Senior Congress spokesperson Randeep Singh Surjewala tweeted, "Dear PM, Parliament is not mortar & stones. It envisions Democracy, It imbibes Constitution, It is Economic-Political-Social Equality, It is Ramesh, a Rajya Sabha MP, Compassion & Camaraderie, It is aspirations of 130 Cr Indians. What would a building built upon trampling of these values represent?"

London: The UK Foreign Office is closely following the protests by farmers in India, a government spokesperson said on Thursday as it clarified that Prime Minister Boris Johnson had "clearly misheard" a question in Parliament when he responded with Britain's stance on the India-Pakistan dispute instead.

The gaffe occurred during the weekly Prime Minister's Questions (PMQs) session in the House of Commons on Wednesday, when Johnson reiterated that any dispute between India and Pakistan was for the two countries to settle bilaterally in response to a question by Opposition Labour MP Tanmanjeet Singh Dhesi about conveying British Sikh "anxieties" over the ongoing protests against agricultural reforms in India.

A UK government spokesperson said: "The Prime Minister clearly misheard the question in Parliament. The Foreign Office are following the issue of protests in India closely.

Dhesi, who has been very vocal on the protests by farmers against India's agricultural reforms, had raised the issue of the footage of "water cannons, teargas and brute force" being used against the peaceful protesters.

'Ŝo, will tĥe Prime Minister (Johnson) convey to the Indian Prime Minister (Narendra Modi) our heartfelt anxieties, our hopes for a speedy resolution to the current deadlock and does he agree that everyone has a fundamental right to peaceful

protest," he questioned Johnson.

The British Prime Minister, in his brief response, seemed to be addressing the Kashmir ispute instead.

"Our view is that of course we have serious concerns about what is happening between India and Pakistan but these are pre-eminently matters for those two governments to settle and I know that he appreciates that point," said Johnson.

A perplexed Dhesi took to social media immediately to brand Johnson as "absolutely clueless" and was joined by scores of fellow Labour politicians and others in expressing shock at the gaffe.

"The incompetence from this government continues. The foreign secretary Dominic Raab has failed to brief the PM on one of the largest protests the world has seen," said fellow British Sikh Labour MP Preet Kaur Gill.

"It would seem our Prime Minister (and former Foreign Secretary) doesn't know the difference between Punjab and Kashmir. Why are we not surprised," added Emily Thornberry, Labour MP

and former shadow foreign secretary. The Foreign, Commonwealth and Development Office (FCDO) has refused to be drawn into British politicians' representations seeking UK government intervention in the matter, stating that "the police handling of protests are a matter for the government of India".

Thousands of farmers are currently staying put

at Delhi's borders with Haryana and Uttar Pradesh in protest against the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020, the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020 and the Essential Commodities (Amendment) Act, 2020.

They have expressed apprehension that these laws would pave the way for the dismantling of the minimum support price system, leaving them at the "mercy" of big corporations.

However, the government has maintained that the new laws will bring farmers better opportunities and usher in new technologies in agriculture.

There have been multiple rounds of talks between representatives of the protestors and the government but the logjam continues. PTI
