#### Two Booked For 'Manhandling' **KPDCL Team**

**SRINAGAR:** Two people have been booked by police for allegedly manhandling an inspection team of Kashmir Power Development Corporation Limited (KP-DCL) officials in Chanpora area of the city, reports said Friday.

After receiving complaints of power theft, a team of KPDCL officials headed by the Junior Engineers on December 15 went to the spot inspection in Khan Colony, Chanpora where they came under attack, an official said. The team, he said, was manhandled and abused by the 'miscreants' who were actively involved in power theft by means of directly tapping to the LT service lines which are in close proximity to their residence.

### **Poonch Rattles** With Cross-LoC **Shelling**

SRINAGAR: India and Pakistani troops on Friday traded heavy gunfire along the Line of Control (LoC) in Poonch district of Jammu and Kashmir

"At 1740 hours today, the Pakistan army initiated unprovoked ceasefire violation by firing with small arms and intense shelling with mortars along the LoC in Mendhar and Balakote sectors in district Poonch," defence spokesman said.

The spokesman said the Indian army retaliated at both the places befittingly.

The LoC has witnessed heavy firing and shelling during the last few weeks, resulting in an increased number of casualties and triggering a fear psychosis among the residents of border areas.

On December 1, the Pakistan army violated the ceasefire by shelling forwards posts in Rajouri sector along the LoC. A BSF sub-inspector was killed in the shelling.
On November 27, two sol-

diers of the Indian Army were killed when Pakistani troops opened heavy fire and shelled forward posts in Sunderbani sector in Rajouri district.

## **Kashmir Freezes As Night Temperature Dips**

SRINAGAR: Kashmir continued to reel under freezing night temperature on Friday even as there was a marginal increase in the minimum temperature in Srinagar city and Gulmarg tourist resort, the meteorological department said.

Srinagar - the summer capital of Jammu and Kashmir - and the famous ski-resort of Gulmarg in north Kashmir were the only places in the Valley where the night temperature improved Thursday night, it said.

## Militant Injured In Anantnag Dies At SMHS

**SRINAGAR:** A Hizbul Mujahideen militant, who was critically injured in a shootout with state forces in south Kashmir's Anantnag district on Thursday, succumbed to his injuries at a hospital here on Friday.

Zahoor Abbas Lone of Inder Pulwama, who was undergoing treatment for gunshot wounds in his abdomen after Thursday's gunfight with the government forces in Naina area of Sangam, passed away at the SMHS hospital here, reports said.

Lone's death comes a week after his wife Rozy Jaan died after suffering a cardiac arrest. Lone's brother Nisar was also a militant and was killed in an encounter with government forces in 1999.

According to a police spokesperson, Lone was arrested at a checkpoint laid during the intervening night of December 16-17 near Gund Baba Khaleel along Sangam Naina road on the basis of a specific input.

#### Last Phase of DDC ...

He said that a total of 1703 polling stations have been designated with 1028 in Kashmir division and 675 in Jammu division.

About the by-polls to Panchayats, the SEC said that of 165 Sarpanch vacancies notified in the 8th phase, 43 have been elected unopposed.

"There shall be a contest in 84 constituencies and 249 candidates including 52 females are in fray," he said.

"Similarly, out of the total 1457 Panch vacancies notified in this phase, 496 have been elected unopposed while 285 constituencies will go for elections with 596 candidates contesting the elections including 156 female candidates," he added.

The SEC said that all the requisite arrangements for this phase are in place including man power, election material and security arrangements in all the poll going areas.

Referring to the arrangements in place in view of the Covid-19 pandemic, Sharma said sanitizers, thermal scanners and face masks have been arranged at the polling stations to ensure that SOPs issued by the concerned authorities, including wearing face masks and maintaining social distancing, are strictly followed.

**Getting Vaccinated ...**as this will help in developing a strong immune response against the disease.

It also said that protective level of antibodies generally develop two weeks after receiving the second dose.

The ministry listed a series of frequently asked questions (FAQs) on COVID-19 vaccine on Thursday night and responded to questions like if taking a vaccine was mandatory, how long does it take for the antibodies to develop and if it was necessary for a COVID-19 recovered person to take the vaccine.

"Vaccination for COVID-19 is voluntary. However, it is advisable to receive the complete schedule of the vaccine for protecting one-self against this disease and also to limit the spread of this disease to the close contacts including family members, friends, relatives and co-workers," the ministry said in response to a question on if it is mandatory to take the shot.

The ministry said that vaccine trials are under different stages of finalisation. The government is geared to launch a vaccine for COVID-19 soon, it said.

Six vaccines - one developed by Bharat Biotech in collaboration with ICMR, second one developed by Zydus Cadila, third one by Gennova, Oxford vaccine, trial of which is conducted by Serum Institute of India, Sputnik V vaccine which is being manufactured by Dr Reddy's Lab, Hyderabad, in col-+ laboration with Russia's Gamaleya National Centre and the sixth one manufactured by Biological E Ltd, Hyderabad, in collaboration with MIT, USA are undergoing clinical trials in India.

On whether a vaccine will be safe as it is being tested and introduced in a short span of time and what can be the possible side-effects, the ministry said vaccines will be introduced in the country only after the regulatory bodies clear it based on its safety

"COVID-19 vaccine will be introduced only when the safety is proven. As is true for other vaccines, the common side effects in some individuals could be mild fever, pain. etc. at the site of injection," the ministry said

It said states have been asked to start making arrangements to deal with any vaccine-related side-effects as one of the measures towards safe vaccine delivery.

Two doses of vaccine, 28 days apart, need to be taken by an individual to complete the vaccination schedule, it stated.

The ministry said anyone taking medicines for illnesses like cancer, diabetes, hypertension etc, can take the COVID-19 vaccine as persons with one or more of these comorbid conditions are considered high-risk category and they need to get

In response to a question on whether the vaccine will be given to everyone simultaneously, the ministry said that based on the potential availability of vaccines, the government has selected priority groups to be vaccinated as they are at higher risk.

In the initial phase, COVID-19 vaccine will be provided to the priority group- health care and front-line workers. The 50 plus age group may also begin early based on vaccine

The eligible beneficiaries will be informed through their registered mobile number regarding the health facility where the vaccination will be provided and the scheduled time. This will be done to avoid any inconvenience in registration and vaccination of beneficiaries, the ministry said in the FAQs.

On why healthcare providers and frontline workers are being chosen for receiving the COVID-19 vaccine, the ministry said the government has prioritised the most at risk/ high risk groups which will get the vaccine

Healthcare providers have led the battle against COVID-19 from the front. The government wants them to be able to continue your work, without the fear of risk associat-

ed with the virus. "Therefore, healthcare and frontline workers are among the first group of people

to be vaccinated," it said. The ministry said registration of a beneficiary is mandatory for vaccination for COVID-19. Only after registration the information on the session site to visit and time

will be shared. Following online registration, beneficiary will receive SMS on their registered mobile number on the due date, place and time of

ID with Photo such as driving license, Mahatma Gandhi National Rural

Employment Guarantee Act (MGNREGA) job card, PAN Card, passbooks issued by Bank/ Post Office, passport Pension Document , service identity card issued to employees by Central/ State Govt./ Public Limited Companies and voter ID may be produced at the time of registration.

On getting due dose of vaccine, the beneficiary will receive SMS on their registered mobile number. After all doses of vaccine are administered, a QR code based certificate will also be sent to the registered mobile number of the beneficiary, the ministry said.

On preventive measures and precautions, the ministry said, "We request you to rest at the vaccination centre for at least half an hour after taking the COVID-19 vaccine.

"Inform the nearest health authorities/ ANM/ASHA in case you feel any discomfort or uneasiness subsequently. Remember to continue following key COVID Appropriate Behaviours like wearing of mask, maintaining hand sanitization and physical distance."

#### 7 More Deaths...

Among others, the victims included a 52-year-old woman from Bemina, a 55-yearold man from Lal Bazar, a 62-year-old woman from Budgam, a 66-year-old from Sainik Colony and a 74-year-old man from Talab Tillo Jammu.

With these deaths, the total fatality count in J&K reached 1833-1164 in the Valley and 669 in the Jammu region.

Srinagar district with 441 deaths tops the list followed by Jammu (342), Baramulla (170), Budgam (106), Pulwama (88), Kupwara (88), Anantnag (82), Doda (60), Bandipora (57), Udhampur (55), Kulgam (53), Rajouri (54), Kathua (47), Ganderbal (42), Shopian (37), Samba (34), Poonch (22), Ramban (21), Kishtwar(21), and Reasi (13).

Meanwhile, four minors and twenty-one travellers were among 388 fresh cases of coronavirus detected in J&K during the last

In Kashmir division, 225 more people tested Covid-19 positive while the remaining 163 were confirmed infected by the officials from Jammu division.

Giving a district-wise break up of cases, officials said Srinagar reported 82, Baramulla 14, Budgam 15, Kupwara 13, Pulwama 33, Anantnag 36, Bandipora 7, Ganderbal 18, Kulgam 4, Shopian 3, Jammu 92, Udhampur 10. Rajouri 7, Doda 8, Kathua 16, Kishtwar 8, Samba 11, Poonch 2, Ramban 5 and Reasi 4 new cases of Covid-19.

Moreover, officials said, 464 more patients have recovered and were discharged from various hospitals- 213 from Jammu Division and 251 from Kashmir Valley. (With GNS inputs)

#### Kashmir Reels ...

Srinagar recorded a low of minus 6.0 degrees Celsius, up from the previous night's minus 6.4 degrees Celsius which was the coldest night of the season.

"However, it has been observed that the officers/officials of various Departments proceed on study leave for pursuing higher studies in institutes within the Country and even abroad, pending formal sanction/approval of the Competent Authority, as a consequence of which these cases are placed for approval before authorities on post facto basis," reads an order.

"The Lieutenant Governor has desired that in future no Government employee shall proceed on leave without prior permission of the Competent Authority," it said, adding, "Accordingly, It Is Impressed upon all Administrative Secretaries to ensure that the study leave cases are forwarded to General Administration Department In advance, so that the same are decided within the stipulated time frame and no officer/official shall be allowed to proceed on study leave without prior approval of the Competent Authority." #### Security Guard ...

During the course of investigation, the police spokesperson said, the scene of crime was minutely examined and it was found that ATM Machine was locked as usual without any mark of damage to it.

"It also surfaced that cash of the ATM Machine has been stolen by using the code of the machine, which raised suspicion that the theft has been carried out by the person having knowledge of the affairs of the bank code and other procedures related to opening and closing of ATM," he said.

"During investigation all the persons having acquaintance have been put to the sustained questioning and finally the bank security guard Javaid Ahmad Malla was zeroed down and put to sustained questioning," he added.

The police spokesperson further said that during questioning, Malla confessed to the crime and on his disclosure a cash of Rs 8,90,600has been recovered from the attic of the bank building.

"The accused has been arrested in the instant case," he added.

#### 3 Held For Selling ...

Upon this information, he said, a preliminary investigation was carried out which revealed that some persons in the Awantipora area are involved in selling stolen vehicles to the customers at cheaper rates and are getting the stolen vehicles from other states of the country.

"Upon preliminary investigation report Case FIR No. 188/2020 under section 379,420,467,468,471,120 B IPC was registered at police station Awantipora and accordingly three persons were arrested in the said case," the spokesperson said. He identified the arrested persons as Mohammad Shafi Dar, Shameem Ahmad Bhat, and Abdul Rashid Bhat.

He said three stolen vehicles, including a Scorpio and two Alto K10 were recovered from the arrested persons.

"The modus operandi of the arrested persons was to get vehicle(s) lifted, put fake number plates on the vehicle which normally is existing number plate of the same type of vehicle which is with some genuine person and to make them appear similar to existing registered genuine vehicles so as to misguide the law enforcing agencies as well as general public.'

Further investigation into the matter is in progress and more arrests are expected, the police spokesperson said.

## **Apni Party Not B-Team** Of BJP: Bukhari

JAMMU: Jammu and Kashmir's Apni Party is often accused of being the B-team of the BJP but on the contrary it was the PDP and the NC which had allied with the saffron party in the past, its chief Altaf Bukhari said on Friday.

He said the party does not believe in dynastic politics.

He said the Apni party is against dynastic politics espoused by the Peoples democratic Party, which is dominated by the Sayeed family, the National Conference, which is dominated by the Abdullah family and the Indian National Congress, which is dominated by the Nehru-Gandhi family.
"We are often accused by oppo-

nents of being the B-team of the BJP. But let me ask her (Mehbooba Mufti). When she was enjoying the chair of chief minister being in coalition with BIP, wasn"t she then the B-team of the

saffron party," Bukhari said.
"Did the NC not ally with the BJP for a ministerial berth in the government. So, how is our party, which talks about protecting the rights of the people and blames the NC, the PDP and the Congress equally for the loss of our special status, a B-team of BJP?" Bukhari asked.

He was responding to J-K Congress president Ghulam Ahmad Mir and NC spokesperson Imran Nabi Dar who accused the Apni Party of being the B-team of the BIP.

Mir said the real motive of the Apni Party would be exposed soon.



fron party aimed at creating chaos and divisions in the political system of J-K. People would soon give a befitting reply to this new formation," he said.

**SRINAGAR** – After the return of physical exotic range of hand-made products. fairs at Noida Haat with Diwali Utsav last month, Kashmir craftsmen are now participating in a 11-day long Shilp Utsav from December 17 to 27 in the third and final leg of fairs which will culminate with the Christmas festival and the advent of New Year celebrations.

Amidst the Covid-19 pandemic restrictions which have adversely impacted the sale of famed handicrafts and handloom products from the Valley, the Government is making strenuous efforts to provide marketing linkages to the business stakeholders to sell their product line which has assured domestic and international market. The artisans and weavers from Kashmir had earlier participated in the Diwali Utsav at Noida, which was the first physical fair after a string of lockdowns outside Jammu and Kashmir for selling their

In a press statement issued here today, Director, Handicrafts & Handloom, Kashmir, Mussarat Islam, stated that

while efforts were on to provide digital platforms like virtual fairs and e-marketplaces to craft entrepreneurs to connect to online buyers, the Government will continue to facilitate their participation in physical fairs in view of the surge in demand for hand-made woollen products from Kashmir in winters. "There is a huge demand for Pashmina and Kani shawls and stoles, rugs and carpets, crewel, tweed and the traditional designer Kashmiri long robe, the Pheran, in winters. ## **PM Modi Offered Condolences To Sharif On Mother's Death: Report**

The letter was forwarded to Nawaz Sharif's daughter and Pakistan Muslim League-Nawaz (PML-N) Vice President Maryam Nawaz by the Indian High Commission in Islamabad last week with a request to be conveyed to her father, who has been residing in London since last year, Dawn newspaper reported.

Lahore: Prime Minister Narendra Modi wrote a letter to PML-N supremo Nawaz Sharif last month, extending "heartfelt condolences" to Pakistan's former premier over his mother's death on November 22. a Pakistani media report said on Thursday.

The letter was forwarded to Mr Sharif's daughter and Pakistan Muslim League-Nawaz (PML-N) Vice President Maryam Nawaz by the Indian High Commission in Islamabad last week with a request to be conveyed to her father, who has been residing in London since last year, Dawn newspaper reported.

In the letter dated November 27, Prime Minister Modi conveyed his "heartfelt condolences" to Mr Sharif over his mother's death.

"Dear Mian Sahib, I am deeply saddened to learn about the demise of your mother Begum Shamim Akhtar on November 22 in London. My heartfelt condolences are with you in this hour of intense grief," PM Modi wrote in the letter, which was also released by the PML-N on Thursday.

Prime Minister Modi recalled his interaction with Mr Sharif's mother during his brief surprise visit to Lahore in 2015, saying: "Her simplicity and warmth was

indeed very touching. "In this moment of profound grief, I pray to the Almighty to bestow strength upon you and your family to bear this irreparable loss," he added.

In a separate letter sent to Ms Maryam on December 11 at her Lahore residence, Indian Charge d'Affaires Gaurav Ahluwalia requested her to convey the condolence message to Nawaz in London, the paper said.

Mr Sharif, three-time former prime minister who is entangled in a number of corruption cases, has been in London since November last year after the Lahore High Court granted him permission to go abroad for four weeks for treating the heart disease and an immune system disorder.

Mr Sharif's mother Begum Shamim Akhtar died in Britain on November 22. Her body was later flown to Pakistan and she was buried at the family's Jati Umra estate in Lahore.

In December 2015, Modi had paid a brief surprise visit to Lahore on his way back to India from Afghanistan. He was received by Sharif and both leaders had flown to Raiwind from Lahore airport in a helicopter. PM Modi then briefly attended Mr Sharif's grand daughter's wedding ceremony at his residence and held a brief meeting with his Pakistani counterpart at the time before departing for New Delhi.

This was the first time an Indian premier visited Pakistan in more than a decade.

Ties between India and Pakistan nosedived after a terror attack on the Pathankot Air Force base in 2016 by terror groups based in the neighbouring country. Subsequent attacks, including one on Indian Army camp in Uri, further deteriorated the relationship.

The relations between the two countries further deteriorated after India scrapped Jammu and Kashmir's special status on August 5, 2019 and bifurcated it into two union territories.

MG Hector is available in both petrol and diesel options along with the option of a 48V hybrid variant. The petrol version also comes with a DCT (dual-clutch transmission).

**SRINAGAR:** As Kashmir valley that winter brings elevated blood is reeling under an intense cold wave with temperatures dipping below freezing point, Doctors Association Kashmir (DAK) on Friday said that the chill of winter puts people at greater risk of high blood pressure.

"Frigid temperatures cause a hike in blood pressure which increases the risk of fatal heart attacks and strokes," said DAK President Dr Nisar ul Hassan.

"When winter arrives and temperature drops, there is one place where the mercury actually rises, that is in blood pressure gauges," he said.

DAK President said high blood pressure is harder to control in winter. Even healthy people aren't off the hook. They also tend to have high blood pressure in winter.

Reduce your salt intake, take a healthy diet and don't forget to take your vitamin D. If you are on a blood pressure lowering pill take it regularly and at bedtime," advised Dr Nisar.

# **Global Pandemic and Pervasive Subjugation**

Critcism must be intensified towards the Buddhist-majority Sri Lankan Government's mandate that anyone who dies of COVID-19 must be cremated - a practice forbidden in Islam

fter the Covid-19 outbreak, a wave of crisis engulfed the entire globe which left every nation affected by the infection. Its arrival not only marked the exposé of an ill planned medical treatment mechanism in major countries, but also exposed the totalitarian and discriminatory malice of the governments against its own people. Covid-19 outbreak was also greeted by the resurgence of a rebranded and more intense reactionary international block which included countries from India

Governments of such countries had an important job at hand: when the crisis arose for the first time, they went on a rampage of pummeling conspiracy theories to thwart the damages inflicted by Covid-19. How they handled this exigency in their respective countries is something which came under severe criticism from different quarters including the WHO (World Health Organization). We saw people die in apathy and negligence, every affair pertaining to living and dead became an issue of debates and discussions.

Some large and powerful states around the globe also used this opportunity to further "discipline" their citizens, awarding their forces and governments with arbitrary powers, while nothing serious was being done to uplift the standards of healthcare. A discriminatory approach was also adopted by many states when the Covid-19 spread was associated with different linguistic religious and social groups. In India, there was a islamophobic smear campaign which scapegoated a muslim preaching group called Tablighi Jamaat. The contagion was falsely attributed to them and was used as yet another excuse to marginalise muslims.



A similar news article surfaced from Sri Lanka recently, it reported that Sri Lankan authorities cremated the bodies of Muslim Covid-19 patients against the wishes of the community.

If we go back in history of Sri Lanka, ever since it gained her freedom from colonialism, it initiated a series of discriminatory measures against the Tamil minority of Sri Lanka. Tamils were pushed against the wall, their political rights were denied to them, their identity was snatched away from them and their religious identity also came under threat when the Sri Lankan government made it legal for the State to promote Buddhism, a religion of Sinhala majority. In return, the Tamil leaders pitched for the inclusion of their social identity, restoration of their political rights and autonomy for regions inhabiting Tamils. None of the demands were met by the Sri Lankan government; a brazen display of a stubborn and a majoritarian government was in practice in full public glare. This finally culminated into a violent civil war with LTTE coming into exis-

tence amid demands of a separate Tamil State. The decades followed years of bloodshed, it saw killings and destruction of both the majority Sinhala as well as the minority Tamil community in Sri Lanka. After LTTE leader Prabhakaran was killed in 2009, they established a Truth and Reconciliatory Commission to settle the crisis which was a result of their own stubbornness and discriminatory majoritarianism.

More than a decade has passed since then, and the very country is faced by a challenge as a result of an ensuing global pandemic. This time they are forcing the Muslims residing in Sri Lanka to cremate their dead bodies, disregarding their aspirations and religious obligations. In a blatant abuse of power and discrimination against a community, the Lankan au thorities first profiled the Muslims racially, and declared the Muslims living in Sri Lanka the most affected Covid-19 community in Sri Lanka. Adding to the woes of the community, the relatives of the victims are forced to bear the costs of the cremation of their loved ones

whose bodies are desecrated in front of their very eyes. Sri Lanka is among those rare nations around the globe who have called for the cremation of those who die because of Covid-19 contraction. There are more than 185 countries which allow both burials as well as cremation of such bodies. WHO also holds both the ways as feasible to perform the last rites of Covid-19 affected bodies. This is so reminiscent of the days when Sri Lanka first started a majoritarian campaign of discrimination against the minorities living in their country and the ugly violence which erupted as an aftermath.

These times are abnormal and in such an exigency, if global leaders embark on a journey riding high on the horses of conspiracy theories and superstitious, spurious methods to tackle such a situation can only invite an apocalyptic tragedy. In such times, instead of strengthening the health sectors and educating the citizenry, if a state focuses on exercising maximum arbitrary powers on them then it can only end up inviting a wrath of divisive political instability along-with a deadly pandemic. It should be understood by the governments and leaders that the basic human rights and dignity of an individual remains intact in the absence or the presence of an epidemic. These rights, aspirations and will of the people need to be respected and acknowledged. No room should be left for another Fascist Italy or Nazi Germany to flourish.

#### he verbal fireworks and street power unleashed by Pakistan's opposition alliance has put Prime Minister Imran Khan's crisisprone government on the defensive. Casting the spotlight on Khan's unfitness to rule and on the interference of the powerful military and intelligence services in the political process is a bold but risky strategy by the opposition.

The opposition can tap the misery and disillusion felt by many Pakistanis because of a slowing economy, high inflation, growing unemployment, and spiking poverty to build a case against Khan's leadership. But it is much harder to gain political mileage from denouncing the military establishment for political engineering in Khan's favor. That is because opposition leaders themselves have gained from military tutelage in the past.

#### **Making Progress**

To his credit, Khan came to power in 2018 without carrying the baggage of corruption. His rallying cry was to bring about seismic change, good governance, and end political patronage. He pledged to create an Islamic welfare state to address endemic poverty. But governance crises and partisan politics have taken a toll on Khan's government. As the anemic economy deteriorates, Khan obsesses over the perennial issue of Kashmir with India and with Islamophobia in the West (the latest flap with France is an example).

In the effort to sway public sentiment to get rid of Khan, the opposition has to present itself as a credible alternative. But it is hard for the opposition to get rid of the view, held by many, that they are a motley group of failed politicians dogged by corruption scandals. Based on its record, it is in no position to promise better governance and decisive reform that the country desperately needs.

#### **Dysfunctional Democracy**

However, any opposition is better than none. Despite its dysfunction, Pakistan has enjoyed blips of genuine democracy. The sizeable crowds in opposition show that there is little support for turning Pakistan into a "pseudo-democracy", a de facto one-party state with stability based on soft authoritarianism. Furthermore, charges that the ruling establishment is undermining democratic institutions, restricting free and fair elections, and attempting to gag the

It is hoping that the military, sensitive to shifting public sentiment, could decide to abandon Khan. But by naming and shaming the military brass for political maneuvering and bringing up human rights abuses attributed to the military in the sensitive province of Baluchistan, the opposition risks increasing the ire of the military es-

While the military wants to avoid the succession of past military takeovers, a short period of direct

military rule is possible to find a suitable civilian replacement if Khan fails to deliver. To avoid this grim scenario, democratic leaders must choose the route of dialogue, consensus, and compromise over confrontation, chaos, and violence. Unfortunately, they have failed this test in the past.

#### **Current Scenario**

Despite the latest political challenge, the most likely scenario is that the system of hybrid democracy in Pakistan will muddle along. It works in a manner: establishment approved politicians with limited power take turns as leaders, elite manipulation and corruption are widespread, vision-less bureaucrats advise on domestic economic policies and oversee a bankrupt economy with a bloated defense budget and heavily dependent on foreign loans, and the military keeps a lid on domestic unrest and controls security and foreign policies.

However, just muddling along isn't the long-term solution for a strategic nuclear-armed, medium-sized country of over 200 million people, with a fast-growing population. Rising poverty, low tax generation, the lack of basic services, the unfairness of the elite system, and the unresponsiveness of public officials increase the divide between the 'haves' and the 'havenots' that extremists will exploit.

The fact is that Pakistan needs: more authority to elected politicians, less military meddling, less dependence on patrons like the United States and China, better relations, and more trade with Asian neighbors, particularly India, a reversal of elite capture, an independent civil society, and more power to voters.

Whether it is a success or failure, the opposition challenge is an essential part of a vibrant democratic process. Moreover, the re-invigoration of democracy by strengthening political and judicial institutions and not more authoritarian measures are the key to combating rising religious intolerance and national

Preserving and strengthening democracy in Pakistan is vital for peace in the region and beyond.

His belief in the potency of a revived Islamic civilization in the face of European domination fundamentally impacted the development of Muslim thought in the nineteenth and early twentieth centuries. He recognized the match of Western education, however, accentuated that Muslims should grasp it to improve their parcel and afterward reverse the situation against Western imperialism by ousting it and setting up a worldwide Islamic caliphate. Al-Afghani held that Hindus and Muslims should work together to overthrow British rule in India. He worked to transform Islam into a lever against western imperialism. Afghani was the prototype of the modern fundamentalist. Like Sir Syed, he also had been influenced by western rationalism and the ideological mode of western thought. Afghani welded a traditional religious

hostility towards unbelievers to a modern critique of western imperialism and an appeal for the unity of Islam, and while he inveighed against the west, he urged the adoption of those western sciences and institutions that might strengthen Islam. Afghani saw Western innovation as a solution to recover regenerate the Muslims, not as an approach to assist them in discovering a spot inside colonial settings yet to completely comprehend and afterward eradicate imperialism. Afghani was rather progressive and modernistic in his thinking. A contemporary English admirer described Afghani as the leader of Islam's liberal religious reform movement. The pan-Islamist thought which he spearheaded esteemed the significance of changing and reforming the Muslim mentality through modern scholarly methods, and afterward utilizing the transformed as a weapon against the political incomparability of

Another prominent sage of the modern Muslim intellectual movements of the time was Justice Ameer Ali. His History of the Saracens and Spirit of Islam enjoyed a wide readership both in India and Britain, but his target audience was the Western public. He wished to familiarize this public with the history and religion of Islam, and he was successful at that. He accepted that there were issues that made it problematic for his Western contemporaries to appreciate Islam as a religion suited to the needs of the modern world, but he remained unapologetic on central Islamic beliefs. Chiragh Ali (1844–95), a lawyer from Hyderabad, argued for the reform of Muslim civil law and the establishment of a humane Islamic law based on the Quran rather than on later accretions and interpretations. Altaf Husain Hali's The Musaddas described the drama of Islam, its glories and its tragedies, in simple, sensuous, and passionate poetry; and, at the same time, he highlighted the need for the reform of Muslim society. The Musaddas became a best-seller in Urdu-speaking India, and it is still read and enjoyed by thousands even today. The scope and spirit of Urdu literature augmented during this period. Akbar Allahabadi (1846-1921), acclaimed for his gnawing parody, censured Sir Sayyid Ahmad Khan's zing for Western culture and analyzed Muslims aping Western ways of life as 'playing out monkeys' for their British coaches. The Urdu weekly by Agra Akhbar, distributed by Khwajah Asif Ali denounced the Muslim Anglo-Oriental University conspire at Aligarh as 'eccentric and illusory'. Much good Urdu prose was being written in this period; however, three specific improvements significantly advanced its reach and quality. The first one was the development of journalism. Despite the fact that the Urdu press returns to the late eighteenth century, it started genuinely to thrive and flourish from the 1870s onwards. Papers like Akhbar-e Am in Lahore (1870), Oudh Punch in Lucknow (1877-1936), and Paisa Akhbar in Delhi (1888) revolutionized journalism by receiving new patterns, for example, eye-getting features, notices, modest value, newspaper design, alongside the publication aptitudes of ironical composition, spontaneous extemporization, and powerful questioning. Hostile to British assessments were regularly communicated in such political papers as the Zamindar of Lahore, the Al-Hilal, and Al-Balagh, began by Maulana Abul Kalam Azad in 1912 and 1915, and the Hamdard edited by Muhammad Ali. The second significant advancement in Urdu writing was the introduction of the novel. Finally, we must record the rise of Urdu drama in this period.

To sum up, Sir Syed received harsh criticism. His religious naysayers remained positioned in their mosques and madrassahs. Thus, the greater part of his religious adversaries couldn't discover a spot in the school that he set up in Aligarh. This school evolved into becoming a college and then an institution which began to produce a specific Muslim world-class and metropolitan bourgeoisie who might go on to dominate Muslim nationalist thought in India and eventually decide the cours in 1906 when the consciousness of Muslim nationalism took practical form when a deputation of Indian Muslims - Shimla Deputation - held a meeting with the Governor-General Lord Minto in Shimla and secured the viceroy's consent in respect of separate electorate for Muslims.

# Modern Myth: The Moderate Muslim

everal qualitative analyses by MediaTenor, an international research institute, reveal that over 80% of Islam-related media coverage is negatively biased. Jaded notions of the "Moderate Muslim" attempt to subvert such rhetoric, but serve as a funnel for orientalist-driven thought, where Muslims only exist on a manufactured scale of terror to "terror-hating." The question itself of who is a Moderate Muslim assumes an inherent relationship between terrorism and Islam, whereby a Muslim, without a modifier, is naturally too extreme.

Such preconceptions fuel the public's need to assign what is outside its social norms and characteristic of Islam and Muslims to this scale of moderation, where outwards practice of Islam in any degree warrants suspicion, purportedly emblematic of a "natural inclination towards violence." Dr. Khaled Beydoun, an Associate Professor of Law at the University of Detroit Mercy School of Law, writes,

The hegemony of the evil or 'bad Muslim' has entirely eclipsed illustrations of 'good Muslims,' and in instances where the latter are the subject of focus, are engaged in stifling terrorist acts, or stopping radicalization.

Islam encompasses theology, sociopolitics, and economics and legislates disciplined practices that acknowledge current and evolving climates. The discrepancy lies in what moderation looks like to the outside, thus yielding the concept of the Moderate Muslim: an invention of a global system of capital and political hegemony to further its own power.

Rejection of the desire to be limited to such a scale is equalized to harboring terrorist sympathies. The Moderate Muslim may wear a headscarf or have a name that leaves tongues tied, but accepts in its entirety the lifestyle of non-Muslims, rendering them different from the average non-Muslim only in the superficial matters of human existence, and thus reducing Islam to unfamiliar foods, clothes, and some stylized phrases. Mainstream Western political forces prescribe a maximum standard of practice, where one

can be the face of change without radically challenging the status quo. Any public visibility of the practice of the religion is equated with extremism. This definition is characterized, not by principle, but by what serves the interests of Western political forces. Muslims are left to ricochet within a dichotomy that either imposes a narrow definition of what the West deems acceptable in its modern cultural hegemony or to breach it with the risk of social ostracization, loss of livelihood, and frequently, deportation or imprison-

"Moderate Muslim" attempt to subvert such rhetoric, but serve as a funnel for orientalist-driven thought, where Muslims only exist on a manufactured scale of terror to "terror-hating." The question itself of who is a Moderate Muslim assumes an inherent relationship between terrorism and Islam, whereby a Muslim, without a modifier, is naturally too extreme

ment without due trial.

Such a dichotomy determines the humanity of Muslims not in reference to their own religious framework, but rather by evaluating how Muslims yield to the demands of a hegemonic modern society. The secular world believes itself to have implemented a universally applicable standard – as though it arose from a vacuum devoid of contextual beliefs - with the slightest deviation from it inviting skepticism and fear, and in doing so, it maintains an orientalist cognitive lens that measures civility by contextual ideals. As ideals evolve, Muslims are left to play catch-up with a culture that feigns unity in "diverse" and "moderate" autonomies, when in reality the freedom of practice exists among a set of pre-defined options.

This isn't unique to America, as it is a continuation of what has existed in colonial states globally to maintain the pacification of people who refuse to submit to modernity. My work with Muslims Condemn was not seen as a challenge to the Good Muslim/Bad Muslim narrative of the Western elite, but as an example for other Muslims to continue in "engaging dialogue" built on faulty grounds, directly assigning to Muslims the responsibility to assuage irrational fears for an everchanging standard of approval.

Ugandan academic and political commentator Mahmoud Mamdani refers to

this phenomenon as "culture talk," characterizing public discourse about Islam as akin to reading about "museumized peoples," whose culture has no rich history nor tradition of its own, but exists in relation to the West and their trajectory to assimilate. He mentions that part of the solution towards peace and countering such talk is to break out of this victim role and reclaim historical consciousness.

Our acclimation to the binary mentioned by Dr. Beydoun renders us as political footballs, constricting the ability of orthodox Muslims to shape conversations about Islam. Muslims must be willing to deconstruct the underlying principles on which problematic notions like this originate. Half-hearted acceptance from various ideological groups does not matter in the re-prioritization of subservience to God. This is imperative. In seeking to reject the idea of moderation, Muslims affirm the immoderation of our mizaan (spiritual scale); the quest of Islam is not a balance in deeds, but for the good to overwhelm the bad.

### Cyberattack On US **Government, Companies Poses** "Grave Risk": Security Agency

Agencies

Washington: A sophisticated cyberattack on US government agencies and private companies that was revealed this week poses a "grave risk" and thwarting it will be "highly complex," the US computer security agency said Thursday.

President-elect Joe Biden expressed "great concern" meanwhile over the computer intrusion and said cybersecurity would be a "top priority" of his administration.

The US Cybersecurity and Infrastructure Security Agency (CISA) said US government agencies, critical infrastructure entities, and private sector organizations had been targeted by what it called an "advanced persistent threat actor."

CISA did not identify who was behind the malware attack

intrusions began in at least March 2020 and the actor behind them had "demonstrated patience, operational security, and complex tradecraft.

This threat poses a grave risk," CISA said in a statement. "CISA expects that removing this threat actor from compromised environments will be highly complex and challenging for organizations.

Biden, who is to be sworn in as president on January 20, said the breach affected "potentially thousands of victims, including US companies and federal government entities."

"My administration will make cybersecurity a top priority at every level of government - and we will make dealing with this breach a top priority," he said in a statement.

"We need to disrupt and deter our adversaries from under-

### Top US General Meets Taliban, Afghan **Leader Ahead of Pullout; Calls For** "Reduction Of Violence"

Washington: The top US military officer met separately this week with the Taliban and Afghanistan's president to push for a negotiated solution as the United States pulls out, the Pentagon said Thursday.

Meeting the Taliban in Qatar, General Mark Milley, "discussed the need for an immediate reduction of violence and (to) accelerate progress towards a negotiated political solution which contributes to regional stability and safeguards US national interests," spokeswoman Commander Sarah Flaherty said

The chairman of the Joint Chiefs of Staff, who was meeting for the second time with Taliban representatives, also held talks in Kabul with President Ashraf Ghani, she said.

The trip comes as outgoing President Donald Trump speeds up the US withdrawal, part of his effort to wind down "endless wars."

President-elect Joe Biden has long agreed on the need to end America's longest war but it remains to be seen if he sticks to Trump's timeline, and he has called for a residual force to remain in Afghanistan for counterterrorism operations.



Under a February 29 agreement reached in Doha, the United States set in motion a withdrawal and the Taliban agreed not to let Afghanistan be used by extremists -- the original reason for the US invasion following the September 11, 2001 attacks.

The Taliban have since held fire on US troops but not on Afghan forces, although the Islamist militants have also for the first time opened talks with the internationally recognized government, which it considers illegitimate.

The talks recently managed to clear a key sticking point on the nature of the negotiations but there has been no progress on substantive matters

The Afghan talks are on hiatus until January 5, with the government team returning to Kabul for the new year to consult.



## **Outrage In Sri Lanka Over Cremation Of Muslim Covid Victims**

Colombo, Sri Lanka – Muslims in Sri Lanka are outraged over the forced cremation of a 20-day-old COVID-19 victim last week against the family's wishes, the latest in more than a dozen such cremations in the Buddhist-majority country since the pandemic erupted.

Ignoring the World Health Organization's (WHO) guidelines which permit both burials and cremations. Sri Lanka in March made cremation mandatory for people who die or are suspected to have died from the coronavirus infection.

On December 9, baby Shaykh was forcibly cremated in a cemetery in Borella, the largest suburb of Sri Lanka's capital, Colombo the youngest among 15 Muslims to be cremated, thereby denying them Islamic funeral rites.

### **Google Hit With Third Antitrust Lawsuit Over Search Monopoly**

San Francisco: Dozens of US states on Thursday hit Google with its third antitrust suit in as many months, accusing the internet giant of abusing its internet search dominance to eliminate competition.

The suit by antitrust enforcers from 38 US states and territories is in line with, but goes beyond a case filed by the US Justice Department against Google earlier this year.

'Google's anticompetitive actions have protected its general search monopolies and excluded rivals, depriving consumers of the benefits of competitive choices, forestalling innovation, and undermining new entry or expansion," said Colorado attorney general Phil Weiser.

The suit came a day after a group of states led by Texas filed a separate antitrust in a post that the lawsuit 'seeks to redesign search in ways that would deprive Americans of helpful information and hurt businesses' ability to connect directly with customers.'

Cohen said the complaint see to require Google "to prominently feature online middlemen in place of direct connections to businesses.

Nebraska attorney general Doug Peterson called the antitrust assault on Google historic, saying the combined suits represented the biggest alliance since a case against Microsoft decades ago.

## Irritated by loss, Trump hunkers down at the White House and avoids talk of future

ashington: Hunkered down in what one former White House official called the "presidential man cave" of the Oval Office, President Donald Trump does not want to talk about what lies ahead once he leaves office next month.

Several people familiar with the situation say he knows his time is up even as he presses the fight against the election outcome, despite having failed in a series of court challenges to overturn the results of the November 3 election that made Democrat Joe Biden President-elect.

With Monday's Electoral College vote certifying Biden's win, White House staff members are looking for jobs and planning their post-administration futures. First lady Melania Trump has



looked for a school in Florida, where the couple is expected to reside, for their son Barron, People magazine reported.

A source close to Trump says he does not want to talk about the future beyond his remaining days in office. Any suggestion that he begin laying the groundwork for another run for president in 2024 is

shunted aside, at least for now. "He wants no conversation

about what he's going to do when he leaves the building. the source said, asking for anonymity to speak candidly. "He's convinced he's leaving but he compartmentalises things. As long as he's the President, he wants to be the President," the source added.

Although an extrovert through his four years in office, Trump has largely closed himself off from the public in recent weeks, communicating mostly through tweets. He has done little to show he is focused on governing other than speaking at an event to highlight the speed of coronavirus vaccine development.

He has not played a significant role in responding to the computer hack that targeted the US government, one administration official said, adding: "This is not his wheelhouse and it also involves the Russians. which complicates things."

Trump confers with a coterie of advisers, including Vice President Mike Pence and chief of staff Mark Meadows, who update him on vaccine distribution and stimulus talks under way in Congress.

The six farmers, who were served notices, include Bharatiya Kisan Union (Asli) district president Rajpal Singh Yadav and farmer leaders Jaiveer Singh, Brahmachari Yadav, Satendra Yadav, Raudas and Veer Singh. They have been organising protests in the district over the Centre's three contentious farm legislations.

"We've got a report from the Hayatnagar police station that some persons are inciting farmers and there can be breach of peace, and they should be asked to fill personal bonds of ₹50 lakh each," Subdivisional

Magistrate Deependra Yadav said.

The farmers said the amount was too much, following which the police station incharge gave another report and they were asked to submit personal bonds of ₹50,000 each, according to Mr Yadav.

The notices have been issued under Section 111 (magistrate order against any person who is likely to commit breach of peace) of the Code of Criminal Procedure on the basis of a report submitted by police, the official said.

"Yesterday, it came to our notice that the prime minister's office here has been put up on sale on OLX website. An FIR was immediately lodged at the Bhelupur police station, and the matter is being investigated," Pathak said.

"Four people involved in the case have been taken in custody," the SSP said, adding that the person who took the picture and put it on the website is among them.

Giving a comprehensive presentation on the progress of eVIN in the UT, Dulloo, the official spokesperson said, informed the LG that the Metadata Collection of Cold Chain Points (CCPs) and uploading of data in eVIN cloud server has been completed. He also said that training of 689 Cold Chain Handlers and uploading of data of 585 Cold Chain Points has been done and all districts have gone LIVE in eVIN.

While highlighting some of the key features of eVIN, the LG, he said, was apprised that this unique web-based system consists of mobile and webbased application for cold chain handlers which embraces technology to effectively manage real-time stock inventory, maintenance of temperature at formed that Jammu and Kashmir is all levels of cold chain hence maintaining the potency of the vaccines.

"This application also helps in accessing vaccine requirement, emergency management of vaccine logistics, route planning of vaccines, and stock reallocation," he added.

According to the official spokesperson, it was also informed that a total of 20 Vaccine Logistics & Cold Chain Managers (VCCMs) have been appointed in each district of Jammu and Kashmir, 2 Project Officers and 1 Senior Project Officer is in place post-induction.

"Vaccine audit has already been conducted for the past 2 years in Jammu and Kashmir by SPO with field inputs from VCCMs which identified the gaps in vaccine inventory and data recording in a few districts. Health Management Information Systems (HMIS) target calculation and data bank of all districts has been completed with the help of VC-CMs," he said.

Besides, the official spokesperson said, it was also informed that standardized stock and distribution registers have been distributed across all districts and robust data entry both in eVIN and registers have been going on, currently, the focus of eVIN is rationalisation of vaccine distribution across the UT- with identification of zero stocks, shipment of excess stock across the Cold chain points and rationalization of stock flow.
