Sexagenarian Woman Dies Of Burns

SRINAGAR: A sexagenarian woman died of burn injuries at a hospital here on Tuesday, a week after she allegedly set herself ablaze in central Kashmir's Budgam district.

The 65-year-old woman from Soibugh area of Budgam district succumbed to her injuries at Srinagar's SMHS hospital, news agency KDC reported Tuesday. The sexagenarian, the report said, was undergoing treatment at the hospital for burn injuries which she had suffered after allegedly setting herself ablaze at her home in Chan- Mohalla village on Tuesday last.

Quoting unnamed officials, the report said that a case under various sections of law has been registered and further investigation is going on in this regard.

As per the data, the newly setup Apni Party bagged 11 seats followed by seven seats by J&K Peoples Conference, five seats by CPIM, three seats by J&K People's movement, two each by Jammu and Kashmir National Panthers' Party (JKNPP) and the Peoples Democratic Front (PDF) and one seat by the BSP

BJP won 13 of the 14 constituencies in Kathua district. Several former ministers and legislators - Tai Mohideen, Aijaz Khan, Gharu Ram, Abdul Gani, Jagjeevan Lal won the DCC elections.

Aijaz Hussain won the Khonmoh-II by a huge margin.

SRINAGAR: Police on Tuesday claimed that two Lashker-e-Taiba (LeT) militants laid down their arms during a gunfight with government forces in south Kashmir's Kulgam district.

Acting on a specific input about presence of militants, police, army's 34 RR and the personnel of CRPF 18 battalion laid a siege around Tungdano village in the wee hours Tuesday and launched a search operation, a police spokesperson here said. The militants hiding in the village, he said, fired a few rounds towards the search team.

Instead of returning fire, the police spokesperson said, the joint forces showed "utmost restraint" and offered surrender opportunity to the holed-up militants. >> More On P8

J&K Logs Six **Covid-19 Deaths**

SRINAGAR: Coronavirus claimed lives of six more people in Jammu and Kashmir on Tuesday, even as the Union Territory reported 308 new cases, including four-

teen travellers during the last 24 hours. Among the six victims, officials said, included a resident of Kashmir Valley-a 65 man from Kupwara besides five persons from Jammu division—a 61-year-old man Naseeb Nagar Jammu, an 80-year-old man from Bhalwal Jammu, a 78-year-old man from Vijaypur Samba, a 58-year-old woman from Doda and a 45-year-old man from Reasi.

With these deaths, the total fatality count in J&K reached 1850-1169 in the Valley and 681in the Jammu region.

MeT Predicts Snowfall In Kashmir Over Weekend

SRINAGAR: Cold conditions prevailed in and Kashmir recorded a low of minus 5.2 mained below the freezing point across the valley on Tuesday, even as the MET Office said the weather is likely to remain dry and cold till the weekend when a spell of light to moderate snowfall is possible at widespread places.

The weather remained dry across Kashmir on the second day of 'Chillai-Kalan' -- the 40-day harshest winter period when the chances of snowfall are most frequent and maximum, officials said.

They said while the valley continued to reel under sub-zero night temperature, there was slight improvement in the mercury at a few places.

Kashmir as the minimum temperature re- degrees Celsius down from the previous night's minus 4 degrees Celsius, they said.

The mercury in Pahalgam tourist resort in south Kashmir also went down from the previous night's low of minus 4.6 degrees Celsius to settle at a low of minus 5.8 degrees Celsius, the officials said. They said Gulmarg recorded a low of mi-

nus 5.8 degrees Celsius up from Monday's minus 6.4 degrees Celsius. Qazigund the gateway town to the valley

xposure to metals such as nickel, arsenic, cobalt and lead may disrupt a woman's hormones during pregnancy which may lead to children's later health and disease risks, savs a new study.

Exposure to metals has been associated with problems at birth such as pre-term birth and low birth weight in babies, and pre-eclampsia

However, little is known about how metals exposure can lead to such problems.

This new research, published in the journal Environment International, shows that some metals may disrupt the endocrine system, which is responsible for regulating our body's hormones.

These disruptions may contribute to children's later health and

"A delicate hormonal balance orchestrates pregnancy from conception to delivery and perturbations of this balance may negatively impact both mother and foetus," said lead author Zorimar Rivera-Nunez, Assistant Professor at the Rutgers University in the US.

The researchers analysed blood and urine samples from 815 women enrolled in the Puerto Rico Test site for Exploring Contamination

Threats (PROTECT) study.

Initiated in 2010, PROTECT is an ongoing prospective birth cohort studying environmental exposures in pregnant women and their children around the northern karst zone, which include urban and mountainous rural areas of Puerto Rico.

They found that metals can act as endocrine disruptors by altering prenatal hormone concentrations during pregnancy. This disruption may depend on when in the pregnancy the mother was exposed.

Among pregnant women, metal exposure is higher in those living in Puerto Rico than in those in the continental United States.

This is important because, compared to the US overall, women in Puerto Rico have significantly higher rates of preterm birth (nearly 12 per cent) and other adverse birth outcomes," Rivera-Nunez said.

BioNTech says can make mutation-beating vaccine in 6 weeks

Tech said on Tuesday it was "highly likely" that its vaccine against the coronavirus works against the mutated strain detected in Britain, but it could also adapt the vaccine if necessary, in six weeks.

Scientifically, it is highly likely that the immune response by this vaccine also can deal with the new virus variant," said Ugur Sahin.

But if needed, "in principle the beauty of the messenger technology is that we can directly start to engineer a vaccine which completely mimics this new mutation -we could be able to provide a new vaccine technically within six weeks.

Sahin said the variant detected in Britain has nine mutations, rather than just one as is usually common.

Nevertheless, he voiced confidence that the vaccine developed with Pfizer would be efficient because it "contains more than 1,000 amino acids, and only nine of them have changed, so that means 99% of the protein is still the same."

He said tests are being run on the variant, with results expected in two weeks.

"We have scientific confidence that the vaccine might protect but we will only know it if the experiment is done... we will publish the data as soon as possible," he added.

Earthlings treated to rare alignment of Jupiter and Saturn

he evening sky over the Northern Hemisphere treated stargazers to a once-in-a-lifetime illusion on Monday as the solar system's two biggest planets appeared to meet in a celestial alignment that astronomers call the "Great Conjunction."

The rare spectacle resulted from a near convergence of the

At the point of convergence, Jupiter and Saturn appeared to be just one-tenth of a degree apart, roughly equivalent to the thickness of a dime held at arm's length. In reality, of course, the planets remained hundreds of millions of miles apart, according

A conjunction of the two planets takes place about once every



orbits of Jupiter and Saturn that 20 years. But the last time Jupiter day's winter solstice, the shortest day of the year.

For those able to observe the alignment in clear skies, the two frozen-gas spheres appeared closer and more vibrant - almost as a single point of light - than at any time in 800 years.

Jupiter - the brighter and larger of the pair - has been gradually nearing Saturn in the sky for weeks as the two planets proceed around the sun, each in its own lane of an enormous celestial racetrack, said Henry Throop, an astronomer at National Aeronautics and Space Administration headquarters in Washington.

No Israel recognition until resolution of Palestine issue: Pakistan to UAE

Islamabad: Pakistan's Foreign Minister Shah Mahmood Qureshi says he has informed the United Arab Emirates of Islamabad's "steadfast" policy towards Israel, noting that the country will refuse to recognize the occupying regime until the issue of Palestine is resolved.

"I categorically presented Pakistan's stance on Israel to the UAE's foreign minister that we will not and cannot establish a relationship with Israel until a concrete and permanent solution to the Palestine issue is found," he told reporters in the central city of Multan on Monday.

Qureshi's visited the UAE a few days earlier, amid speculations that Islamabad, under pressure from Riyadh and Abu Dhabi, was on the path to entering normalization with Tel Aviv.

Last week, Israeli news outlets reported that a senior advisor to Pakistan's Prime Minister Imran Khan had secretly traveled to the occupied territories in November -- a claim rejected by Islamabad as "fake news."

Khan had earlier revealed that Pakistan was "under pressure from friendly countries to recognize Israel," giving assurances, however, that Islamabad

Egypt's Al Azhar bans joining **Muslim Brotherhood**

bu Dhabi: Al Azhar, the highest authority in Sunni Islamic thought and Islamic jurisprudence in Egypt, said joining the Muslim Brotherhood, which is blacklisted by Egypt, is forbidden according to Shariah law and that Almighty Allah has forbidden division and disagreement.

Al Azhar's renowned fatwa center, in its edict, added Almighty Allah forbids people from pursuing any path that distracts them from following the truth, explaining that keeping to the Qur'an and the Sunnah, in accordance with Shariah, was the only way to please Almighty Allah.

"It is clear to the public what these groups have done in distorting some texts, cutting them out of their context, and using them to achieve personal goals or interests and corrupting the land," the center said in the fatwa.

"Membership in these extremist groups is considered forbidden by Shariah," it add-

Egyptian authorities have labeled the Muslim Brotherhood as a terrorist group since November 2014.

Hundreds of members and leaders of the organisation are being tried on charges related to inciting or committing violence.

In mid-November, Saudi Arabia's Council of Senior Scholars had also blacklisted the group.

"The Muslim Brothers' Group is a terrorist group and [does not] represent the method of Islam, rather it blindly follows its partisan objectives that are running contrary to the guidance of our graceful religion, while taking religion as a mask to disguise its purposes in order to practice the opposite such as sedition, wreaking havoc, committing violence, and terrorism," the council said.

In 2014, Saudi Arabia and UAE officially designated the group as a terrorist organisation "to keep sedition at bay." Bahrain and Egypt soon followed suit.

The countries have urged the public to stay away from the organisation and not sympathize with its actions.

Khaled Al Jundi, a preacher and member of Egypt's Supreme Council for Islamic Affairs, said that the Islamic world has long awaited Al Azhar's edict.

Cyberattack hit key US **Treasury systems**

Washington: Hackers broke into systems used by top US Treasury officials during a massive cyberattack on government agencies and may have stolen essential encryption keys, a senior lawmaker said

Senator Ron Wyden, who sits on both the Senate Intelligence and Finance Committees said after a closed-door briefing that the hack at the US Treasury Department "appears to be significant."

"Additionally, the hackers broke into systems in the Departmen-



tal Offices division of Treasury, home to the department's highestranking officials," said Wyden.

"Treasury still does not know all of the actions taken by hackers, recisely what information was st

The US government admitted last week that computer systems in multiple departments were penetrated by attackers who hacked in through widely used security software made by the US company

Members of Congress briefed by US intelligence, as well as Secretary of State Mike Pompeo and Attorney General Bill Barr, have all said Russians were behind the back So far officials have said the hackers broke into computers at

the State Department, Commerce Department, Treasury, Homeland Security Department, and the National Institutes of Health. But experts have said they fear far more of the government could

be affected, including US intelligence bodies, given the ubiquitousness of the SolarWinds security software.

Wyden said that the Internal Revenue Service had said there was no evidence that they had been compromised or data on taxpayers taken.

But he sharply criticized the government for not taking stronger measures to protect its systems.

Trump orders neo-classical design to be adopted for new federal buildings

ashington: US President Donald Trump, with only a month left in office, issued an order Monday that future federal buildings must be "beautiful" and preferably built in the Greco-Roman classical style.

The executive order stopped short of an earlier draft that drew the ire of some architects in seeking to ban construction not done in the neo-classical style, typified by the White House, Capitol and Lincoln Memorial in Washington.

Instead, the order on "promoting beautiful federal civic architecture" decrees that classical and "other traditional" styles "should be encouraged instead of discouraged.

Trump's order takes aim at federal buildings built



after the 1950s, saving that the capital Washington, now features a "discordant mixture" and that the government has "largely stopped building beautiful buildings.

While Trump's order is welcomed by traditionalists who favor the iconic columned buildings dotted around Washington and replicated in many states, the American Institute of Architects said it "unequivocally opposes" the initiative.

"Communities should have the right and responsibility to decide for themselves what architectural design best fits their needs," the institute's CEO Robert Ivy said in a statement, vowing to work with incoming President-elect Joe Biden.

"Though we are appalled with the administration's decision to move forward with the design mandate, we are happy the order isn't as far reaching as previously thought.'

Trump, a real estate developer before becoming president, is primarily associated with construction of modern buildings using glass, steel, and gold-tinted decor.

New Virus Strain

nion Health Minister Dr. Harsh Vardhan has assured the nation that the government was on alert about the new strain of coronavirus that has emerged in the United Kingdom. He has asked people not to panic. The new mutant has prompted several countries including India to stop incoming flights from the UK. In India, Delhi Chief Minister Arvind Kejriwal has raised concern, so has Rajasthan Chief Minister Ashok Gehlot. The new variant was first detected in the UK in September. By November around a quarter of cases in London were linked to this variant. It has caused 1,100 new infections in 60 areas in Britain. The strain code-named as B.1.1.7 is more than 70% more transmissible than existing strains.

This has also raised questions about the efficacy of the vaccines in infections caused by the mutant. At the same time, the medical experts are still studying the new strain. There is so far no evidence that the new variant causes disease which is any different from that caused by previous variants. Though the mutation in the virus appears to be significant, experts have not found any reason to suggest that it would affect the vaccination. The vaccines, it is said, can be tweaked to be effective on new virus strain.

Unlike countries like the UK, the US and Canada, India has yet to roll out the vaccination on a large scale. On a positive note, the number of infections in India has drastically reduced since the peak of summer when the tally had touched around one lakh. Similarly the mortality rate has gone down in India in the last few days. Some experts are thus even suggesting that India shouldn't be in a hurry to go for vaccination and wait for the virus to self contain itself as is the case now.

That said, the virus mutant remains a cause of global alarm. On Monday, the stock market in India crashed by 3 percent on new virus fears. This was the first such deep correction since the steep fall in March. If the new mutant triggers a fresh wave of infections, which, in turn, could lead to further economic disruption, this could once again lead to a deeper correction in the stock market.

India did well by banning flights from the UK. It is important that this strain remains confined to the Britain and is treated there. World cannot afford a fresh massive wave of the Covid-19 infections and the consequent lockdowns. Much of the global economy is in recession and further disruption will inflict a bigger blow to already battered businesses. More so, at a time when the economy is showing signs of looking up again.

he summer of 36 will not be forgotten, but will certainly be forgiven. Though the nature of the implosion was shocking for a team of proven pedigree and credentials, and would remain an all-time low, none of the 11 players would be condemned by what would be the equivalent of the devil's number in Indian cricket. It would be a memory that would be tough to erase from the mind of these cricketers as well as the audience, there would be frequent reminders in the form of banter, sledge or genuine malice, but it would cease to be a crushing burden as time rolls on. It was no ordinary batting line-up that England skittled out in London, featuring as it did Sunil Gavaskar, Gundappa Viswanath, Farokh Engineer and Ajit Wadekar. But decades later, when their careers are assessed, that hour of ignominy is seldom recalled. Gavaskar went onto become an all-time great most reputed for his all-condition technique. Viswanath is often remembered as the most aesthetic of Indian batsmen, a matchwinner on difficult tracks. Engineer made England his home and went on to become a county legend. Wadekar's leadership skills are still praised and he later enjoyed successful stints as India coach.

Sport, thus, forgets and forgives. It offers a chance for redemption. There are numerous examples. Stuart Broad was struck for six sixes in an over by Yuvraj Singh, yet he is set to end up as one of the all-time great bowlers, scaling more heights than Yuvraj could even imagine. Usain Bolt was eliminated in the first round of the Athens Games, before he clocked the Olympic record in Beijing four years later. Shane Warne was plundered for 150 runs in his debut Test against India, but went on to pick 708 wickets. So India could take lessons from history and fight back.

SIC's closure makes RTI redundant in J&K

ushtaq Ahmad Lone from a remote Batwodder hamlet in Chadoora tehsil of district Budgam has been trying to access information related to COVID-19 expenses. He used the Right to Information Act (RTI) seeking information from Deputy Commissioner (DC) office Budgam. On September 2nd 2020, he sent the application via speed post, but even after 3 months, Mushtag hasn't been provided the information which otherwise should have been made available proactively as per the provisions of section 4 (1) (b) of RTI Act 2005. This was not the case more than a year back. Mushtaq says that he would get the response within 30 days only. He now feels frustrated and infuriated. The Assistant Commissioner Revenue (ACR) Budgam, who is the designated PIO in the office of DC Budgam seems to have taken a pledge not to respond to any RTI applicant, says aggrieved Mushtaq. On September 19th this year Mushtaq filed one more RTI application in the same office seeking details related to money spent on the power sector in Budgam. This application was also not responded to by the office of Deputy Commissioner

Hiding the facts

With an aim of getting information on Pradhan Mantri Awas Yojana Gramin (PMAY-G) and Rural Sanitation under Swachh Bharat Mission (SBM) Mushtaq filed an application under RTI Act 2005 in the office of Rural Development and Panchayati Raj Department Civil Secretary Srinagar on September 1st 2020 . The PIO in the administrative department also didn't respond to him until Mushtaq filed 1st appeal more than 50 days back. The appeal was also not adjudicated by the First Appellate Authority (FAA). The PIO has only now recently responded to Mushtaq by sending him a rejection letter dated October 8th 2020. The letter sent via ordinary post has been dispatched around December 10th, but with an aim of hiding the facts, the October 8th date has been mentioned in this letter. Mushtaq's RTI application was rejected on the plea that he hasn't

paid RTI application fees. ' I had annexed a copy of my BPL ration card with the RTI application and I am exempted to pay the RTI application fees of Rs 10. It seems PIO who is the Deputy Secretary in Rural Development Department Civil Secretariat isn't aware of this. He has sent the letter via ordinary post so as to hide the facts related to date of posting of the letter. They are misleading me but I will knock the doors of Central Information Commission" said Mushtag

R&B Baramulla

This is not the case with Mushtag only, who is a noted social activist of his area but there are dozens of such cases wherein Government officers are not responding to RTI applicants. Sirajuddin Salam an anti -corruption crusader from Baramulla has been denied information by Executive Engineer R&B division Baramulla for the last 6 months or more. In Spite of the fact that Lt Governor's office and Chief Engineer PWD (R&B) Kashmir directed the Executive Engineer R&B Baramulla to provide the information, the officer who is the designated PIO is adamant on not revealing the facts. Sirajudin wanted funds spent on construction of a road in the Baramulla town in Shalimar colony. Local residents allege that sub-standard material was used for this road construction early this year, but the details have not been revealed yet.

When I analyze this all, I have come to the conclusion that Government officials are not worried about RTI implementation as the nerve center of this law in J&K was shut down post abrogation of Article 370. By the "nerve center" I mean the J&K State Information Commission (SIC) which was constituted under J&K RTI Act 2009. The JK SIC was shut down when J&K RTI Act 2009 was repealed.

Deprived of SIC

After extending RTI Act 2005 to J&K, we got deprived of the State Information Commission (SIC), like Territories (UTs) are not entitled to have a separate Information Commission. 2nd appeals under RTI Act 2005 are now filed before the Central Information Commission (CIC) New Delhi. All the pending appeals in erstwhile J&K State Information Commission (JKSIC) have been transferred to CIC New Delhi, but in the last 1 year not even a single appeal filed by me and my colleagues has been listed for hearing. This was not the case in the past.

People from far off villages have stopped using RTI. They hardly know how to file an appeal before CIC. The online procedure is very technical and ordinary people can't do this job. Mushtag has now filed 2nd appeal before the Central Information Commission (CIC). I am sure if Mushtaq had not been associated with Jammu & Kashmir RTI Movement, it would have been impossible for him to file 2nd appeal in CIC as the online appeal process is too technical

Appeal disposal at SIC

Aggrieved people in Jammu & Kashmir who were not provided a reply or were given incomplete information under RTI Act would get justice from J&K State Information Commission (SIC) within a few

months only. Under RTI Act 2009, the J&K SIC was supposed to dispose off RTI appeals within 60 to 120 days only. Under RTI Act 2005 there is no such legal binding. It takes months and years to get justice from the Central and State Information Commissions in India.

Some months back, RTI activists in Maharashtra served a legal notice to their State Information Commission asking it to lay out a roadmap to ensure timely disposal of appeals. More than 58000 RTI appeals are pending before Maharashtra State Information Commission (MSIC) This was not the case in J&K before 370 abrogation as the time bound disposal of RTI appeals made erstwhile J&K RTI Act 2009 more progressive than RTI Act 2005. For more than a year now, RTI Act 2005 (central law) is applicable in J&K, but as a longtime RTI campaigner, I get regular calls and messages from aggrieved information seekers who complain that Government departments are reluctant in providing information. Ironically, not even a single awareness programme has been held during the last 1 year or more by the Government for the designated officers after they were tasked to implement the new RTI law. Training could have been given through virtual mode also amid COVID 19, but nobody has even thought about it. Under RTI Act 2005 Govt has to create awareness for the citizens, disadvantaged communities as well. Section 26 of RTI Act 2005 explains this in detail but the Government seems to be least bothered about it.

Conclusion

RTI applicants feel disillusioned in J&K post article 370 abrogation. Repealing J&K RTI Act 2009 was like a personal loss for me. I along with my colleagues had worked a lot for its enactment more than 11 years back. Instead of getting empowered with the applicability of RTI Act 2005, information seekers, journalists, RTI campaigners and transparency activists feel people disempowered and demoralized as the institution of RTI has almost collapsed and crumbled in Jammu & Kashmir . SIC's closure has made RTI redundant and the only way out is to establish a Circuit Bench of Central Information Commission (CIC) at Srinagar and Jammu on the pattern of Central Administrative Tribunal (CAT).

Structural Violence: Violence in the normality of things

We need the term structural violence, to designate forms of injury inflicted in ways that do not meet the criteria of the spectacle and that therefore do not register as violence

he divide between rich and developing countries combined with vociferous social forces in the West, such as the radicalization of black consciousness, the anti-Vietnam movement, student protest, and industrial unrest, which brought in a sharp rise in civil dissent. In the wake of dissatisfaction and frustrations of the sixties, Johann Galtung in 1969 articulated the notion of structural violence. In his seminal article "Violence, Peace, and Peace Research," Johan Galtung pitched the term "structural violence" as a counterpart to "direct" and "personal" violence. "Structural violence" is defined as an injury that is not immediately attributable to an acting subject but is "built into the structure" and manifests itself as inequality of power, resources, and life opportunities. Structural violence consists of inegalitarian and discriminatory practices causing human misery like poverty, hunger, repression, and social alienation. Structural violence is apparent social systems maintained by exploitative means. Hoping to overturn conventional thinking, Galtung tried to widen our comprehension of brutality, not to weaken our capacity to consider people liable for their activities, but instead to improve our capacity to recognize all the more unmistakably the manners by which solidness and serenity cover further and more inescapable savagery. This idea gives us an absolutely revolutionary new comprehension of violence. Galtung argues that violence is built into the unequal, unjust, and unrepresentative social structures and should hence be defined as a situation in which actual realizations of human beings are below their potential realizations. He draws our attention to violence in the normality of things, and through Galtung's analytical lens, peace may very well be sustained by highly destructive forms of structural violence. Johan Galtung describes the mechanisms, and the forms of structural violence, which are: exploitation, penetration, segmentation, marginalisation, and fragmentation. Given its indirect and insidious nature, structural violence most often works slowly in eroding human values and short-

Structural violence is a vital idea in the harmony hypothesis. It is ambiguous, no uncertain, and precarious to utilize, yet its focal thought of a savage social request is upheld by overpowering real factors. The term structural violence may be rejected, but its content will reappear under other names: discrimination, exploitation, injustice. In short, the concept of structural violence is intended is intended to inform the study of the social machinery of oppression. Oppression is a result of many conditions, not the least of which reside in consciousness. We will therefore need to examine, as well, the roles played by the erasure of historical memory and other forms of desocialization as enabling conditions of structures that are both "sinful" and ostensibly "nobody's fault. Eradicating history is maybe the most well-known logical skilful deception depended upon by the designers of structural violence. Deletion or mutilation of history is essential for the cycle of desocialization, vital for the rise of authoritative records of what occurred and why. Haiti as Mintzas showed, serves as the most painful example of this erasure and why it matters. If we cannot study structural violence without understanding history, the same can be said for biology. The distribution of AIDS and tuberculosis—like that of slavery in earlier times—is historically given and economically driven. What regular highlights support the difficulties of over a wide span of time hundreds of years? Social imbalances are at the core of structural violence. Structural violence is the natural expression of an apolitical and economic order that seems as old as slavery. This social web of exploitation, in its many different historical forms, has long been global, or almost so, in its reach. Indeed, one could argue that structural violence now comes with symbolic props far more powerful—indeed, far more convincing—than anything we might serve up to counter them; examples include the discounting of any divergent voice as "unrealistic" or "utopian," the dismal end of the socialist experiment in some (not all) of its homelands, the increasing centralization of command over finance capital, and what some see as the criminalization of poverty in economically advanced countries. Structural violence, measures the distance between an actual society and a potential one, one without structures of violence. With structural violence, there are no. Rather we notice an expansion in futures when we go from the actual to the potential state. The natural measure of structural violence is along these lines the death toll years.

Now it is important to mention the concept of cultural violence and how it legitimizes structural violence in society. In the 1990s, Galtung supplemented his violence typology with another category and introduced the concept of cultural violence. By cultural violence. Galtung means 'those aspects of culture, the symbolic sphere of our existence - exemplified by religion and ideology, language and art, empirical science and formal science - that can be used to justify or legitimize direct or structural violence'. The guidelines, regulations, social codes, and standards that together make up the association of social orders, and that are generally underestimated, are naturally violent. They are, however, often not recognized as such. The mindboggling multifaceted nature of social life, and the person's double primary function as both player and creator of the game, notwithstanding, implies that the individual is up to speed in a Gramscian authoritative restricted state of focus, where one cannot see out of

Other dimensions of structural violence can be in the form of economic and social violence, the first one is rooted in the structure of the production relationships and its consequences for workers and consumers, and the second one is an important consequence of the abuse of political and economic powers. Systematic structures of society lead to endemic global sexism that is termed patriarchy, which in turn brings in the patterns of violence, discrimination, and exclusion towards women. The linkages between hegemonic masculinity and structural violence may almost be self-evident. Both refer to institutionalized forms of social, cultural, and political dominance, which work to systematically oppress those groups who find themselves powerless in the face of both patriarchal and economic domination.

In spite of the fact that we owe the term to Johan Galtung, this line of thought can be followed back at any rate similar to Karl Marx, who lifted the veil of free and equal exchanges between capital and labour in the marketplace to expose capital's exploitation of labour in the factory. In a connected vein, Antonio Gramsci featured the assembling of well-known agree to the course forced on society by the fundamental class. Herbert Marcuse investigated the oblivious delights restricting customary individuals to abusive modern social orders, and Frantz Fanon foreseen that the bare savagery of European expansionism would offer an approach to neo-colonial relations between free states. Even Michel Foucault, who repudiated all master/slave and surface/depth dualisms, differentiated between overt and covert strategies of power when he juxtaposed the voluptuous brutality of monarchical sovereign power with modern normalizing practices sculpting responsible selves.

Galtung makes violence rather non-events, and his triadic theory of conflict involves attitudes, behaviours, and contradictions: conflict = A (attitudes) + B (behaviours) + C (contradictions). Conflict can begin at any point on the spectrum and can flow in all directions. Aside from Galtung, we have James Gilligan, an American psychiatrist, most popular for his series of books entitled Violence, in his book Violence: Reflections on a National Epidemic, defines structural violence as the 'expanded paces of death and handicap endured by the individuals who possess the base rungs of society, as standing out from the moderately lower demise rates experienced by the individuals who are above them'. Another American psychiatrist Bandy Xenobia Lee with Yale University, her scholarly work includes the writing of a comprehensive textbook on violence. She wrote in her book Violence: An Interdisciplinary Approach to Causes, Consequences, and Cures, 'structural violence alludes to the avoidable impediments that society puts on gatherings of individuals that compel them from meeting their fundamental necessities and accomplishing the personal satisfaction that would some way or another be conceivable. These constraints, which can be political, financial, strict, social, or lawful in nature, typically start in organizations that control activity over specific subjects.

If we try to connect the concept with the case of India, Akhil Gupta in his book, "Red Tape: Bureaucracy, Structural Violence, and Poverty in India", gives us a sense of the massive and largely underestimated tragedy of poverty in India. Furthermore, in this manner, he puts under investigation and re-examines – in principle, and practice - the function of the state, and of its different mechanical assemblies, in permitting the awfulness of destitution to be depoliticized and to enter the domain of normality. These are some of the ways in which the state apparatus in India perpetrates such forms of violence in the everyday life of the poor. Gupta portrays a system in which violence is constant, rather than episodic, and in which the victims are easily identifiable, while the perpetrators are much more impalpable.

For quite a long time, structural violence characterized southern Kyrgyzstan, where Kyrgyz controlled political assets and Uzbeks controlled monetary assets. This arrangement of fractional control separated when an adjustment in force elements arose as Bakyev presented a forceful Kyrgyz patriot plan that started a flood of political association among Uzbeks. I would also like to connect the concept with the case of Kashmir, the structures of violence in Jammu and Kashmir are a complex interplay of army camps, intelligence agencies, and numerous other armed groups. It is necessary now to understand the violence that is happening in Kashmir, not as sporadic and occasional but as the consequence of an infrastructure. Whether as part of counterinsurgency or otherwise, the violence is deliberate, consistent, and a consequence of a system that is in place

The ideals of Galtung's concept of structural violence is that it opens up the category of violence so as to include poverty, hunger, subordination, and social exclusion. We need the term structural violence, to designate forms of injury inflicted in ways that do not meet the criteria of the spectacle and that therefore do not register as violence. Thus, Structural violence is a useful theory to locate the origins of structural violations of human rights, that cause human insecurity, which ultimately leads to crime, military conflict, group violence, non-peaceful transfers of governmental power, diseases, and public health problems, acute environmental disasters, floods, droughts, earthquakes, environmental changes, global warming, water shortage, pollution, and economic crises.

Explainer: Do New Coronavirus Strains Pose Concern For Vaccines?

eports from Britain and South Africa of new coronavirus strains that seem to spread more easily are causing alarm, but virus experts say it's unclear if that's the case or whether they pose any concern for vaccines or cause more severe disease.

Viruses naturally evolve as they move through the population, some more than others. It's one reason we need a fresh flu shot each year.

New variants, or strains, of the virus that causes Covid-19 have been seen almost since it was first detected in China nearly a year ago.

On Saturday, Prime Minister Boris Johnson announced new restrictions because of the new strain. Several European Union countries and Canada were banning or limiting some flights from the UK to try to limit any spread.

Here's what is known about the situation.

What's concerning about the recent strain found in England?

Health experts in the UK and US said the strain seems to infect more easily than others, but there is no evidence vet it is more deadly.

Patrick Vallance, the British government's chief scientific adviser, said that the strain "moves fast and is becoming the dominant variant," causing over 60 per cent of infections in London by December.

The strain is also concerning because it has so many mutations — nearly two dozen - and some are on the spiky protein that the virus uses to attach to and infect cells. That spike is what current vaccines target.

"I'm worried about this, for sure," but it's too soon to know how important it ultimately will prove to be, said Dr Ravi Gupta, who studies viruses at the University of Cambridge in England. He and other researchers posted a report of it on a website scientists use to quickly share developments, but the paper has not been formally reviewed or published in a journal.


How do these new strains occur? Viruses often acquire small changes of a letter or two in their genetic alphabet just through normal evolution. A slightly modified strain can become the most common one in a country or region just because that's the strain that first took hold there or because "super spreader" events helped it become entrenched.

A bigger worry is when a virus mutates by changing the proteins on its surface to help it escape from drugs or the immune system.

"Emerging evidence" suggests that may be starting to happen with the new coronavirus, Trevor Bedford, a biologist and genetics expert at the Fred Hutchinson Cancer Research Centre in Seattle, wrote on Twitter. "We've now seen the emergence and spread of several variants" that suggest this, and some show resistance to antibody treatments, he noted.

What other strains have emerged?

In April, researchers in Sweden found



a virus with two genetic changes that seemed to make it roughly two times more infectious, Gupta said. About 6,000 cases worldwide have been reported, mostly in Denmark and England, he said.

Several variations of that strain have now turned up. Some were reported in people who got them from mink farms in Denmark. A new South African strain has the two changes seen before, plus some others.

The one in the UK has the two changes and more, including eight to the spike protein, Gupta said. It's called a "variant under investigation" because its significance is not yet known.

The strain was identified in southeastern England in September and has been circulating in the area ever since, a World Health Organisation official told the BBC on Sunday.

Will people who had Covid-19 from an old strain be able to get the new one?

Probably not, former US Food and Drug Commissioner Scott Gottlieb said Sunday on CBS's "Face the Nation."

"Unlikely," Gupta agreed.

President-elect Joe Biden's surgeon general nominee, Vivek Murthy, said Sunday on NBC's "Meet the Press" that there's "no reason to believe that the vaccines that have been developed will not be effective against this virus as well."

Vaccines produce wide-ranging responses by the immune system beyond just those to the spike protein, several experts noted.

The possibility that new strains will be resistant to existing vaccines are low, but not "inexistent," Dr Moncef Slaoui, the chief science adviser for the US government's vaccine distribution effort, said Sunday on CNN's "State of the Union."

'Up to now, I don't think there has been a single variant that would be resistant," he said. "This particular variant in the UK, I think, is very unlikely to have escaped the vaccine immunity."

Bedford agreed.

"I'm not concerned" because a lot of changes in the genetic code would probably be needed to undermine a vaccine, not just one or two mutations, Bedford wrote on Twitter. But vaccines may need to be fine-tuned over time as changes accumulate, and changes should be more closely monitored, he wrote.

Murthy said the new strain doesn't change the public health advice to wear masks, wash hands and maintain social distance.

The Majority of the 14 seats in the district witnessed a neck-toneck fight mostly between the BJP and the National Panthers Party. So far, BJP has won six seats and NPP bagged one.

Hans Raj of Congress defeated IP's Saniay Kumar by 99 votes in Drabshalla-B constituency in Kishtwar district after securing 2,621 votes, while BJP's Sharda Bhau won from the highest margin of 8,880 votes against Congress rival Anuradha Sharma from Akhnoor constituency of Jammu district. Since a ULIP plan also includes investments in different funds, the amount payable to the nominee can be the fund value too. The fund value is the total monetary worth of the policyholder's units at a given time. Whether it is the fund value that is payable or the sum assured depends on which amount is higher at the time of claim filing.

How is Sum Assured in ULIPs Calculated?

Let's take Aman's example, who has purchased a ULIP plan with a sum assured of Rs. 10 lakhs. The annual premium payable for the ULIP plan of 20 years is Rs. 50.000. If we assume that half the premium that is Rs. 25,000 goes into securing life coverage and a half for investment purposes, then the following scenarios are applicable:

Case 1 - If an unfortunate incident resulted in Aman's demise within the first five years of the ULIP plan, the nominee would be liable to receive only the sum assured. Simply put, they would receive financial compensation of Rs. 10 lakhs.

Case 2 – In case of Aman's demise between the 5th and 10th year of the ULIP plan, the nominee would receive the sum assured or the fund value, whichever is higher. The fund value is calculated as the product of the Net Asset Value (NAV) of each unit on a particular day and the number of total units.

Case 3 - In case of Aman's demise after ten years of the ULIP plan term, the nominee is liable to receive both

the fund value and the sum assured. Case 4 – If Aman were to survive the entire ULIP plan term, he is eligible to receive the full fund value.

However, the sum assured is not payable to him. A noteworthy fact is that the sum assured and the premium amount are directly related. The higher the paid premium amount. the greater will be the sum assured. 

It also said that 1.7 million deaths (18 per cent of the total deaths) in the country were attributable to air pollution last year.

According to scientific paper on health and economic impact of air pollution published in Lancet Planetary Health on Tuesday, household air pollution decreased in India resulting in 64 per cent reduction in the death rate attributable to it from 1990 to 2019, whereas the death rate from outdoor ambient air pollution increased during this period by 115 per cent.

The findings highlight that "lost output from deaths and diseases due to air pollution led to a loss of 1.4 per cent of the GDP of the country". India has a good economic and

According to the paper, the economic loss due to air pollution as a percentage of the state GDP was higher in the northern and central India states, with the highest in Uttar Pradesh (2.2 per cent of GDP) and Bihar (2 per cent of GDP).

Gold To Be Investors Focus As Global Uncertainties Continue: Millwood

nvestment consulting firm Millwood Kane International on Tuesday said that investments in gold gave gains of nearly 28 per cent in rupee terms during 2020 and will remain in focus for investors in the coming year.

"The yellow metal has had a phenomenal year with gains of nearly 28 per cent in rupee terms. After a double-digit gain in 2019, this will be the second year in a row that gold will be posting a stellar rise," said Founder and CEO Nish Bhatt.

Gold prices posted marginal gains in first two months of the year due to concerns of a slowdown in economic growth. A major uptick was seen in prices of gold from mid-March when COVID-19 hit the stage at a global level.



The gains were more in the month of August when MCX Gold hit an all-time, said Bhatt.

The outbreak of pandemic and a spurt in number of cases led to economic uncertainties. The excess liquidity injected by global central banks to boost growth led to investors flocking to gold which is considered a safe haven.

Bhatt said gold prices have shed nearly 10 per cent gains from their life-high levels as a vaccine was discovered which will help contain the virus and reduce global uncertainties. "As we approach 2021, gold will

remain in focus for investors as central banks across the globe have pledged to keep rates low and ease iquidity to aid growth," said Bhatt.

The latest installment of stimulus package from the US government will add to the existing dollar liquidity in the system and may end up weakening the greenback. A weak dollar may push up gold prices.

"The efficacy of the vaccine, proper implementation of the vaccination process in developing countries, low-interest rate regime, and the global central banks' stance on liquidity will guide gold prices in 2021," said Bhatt.

SCREEN TIME, MENTAL **HEALTH ARE PARENTS CONCERN FOR CHILDREN DURING PANDEMIC**

A new national poll gives a glimpse into parents' greatest concerns about their kids in the pandemic-era with the top concerns being screen time, unhealthy eating, and depression.

igh on the top 10 list: overuse of social media and screen time, internet safety, unhealthy eating, depression and suicide, and lack of physical activity.

Almost half of the parents also describe Covid-19, the disease itself, as a "big problem" impacting kids, coming in at No.10, according to the C.S. Mott Children's Hospital National Poll on Children's Health at Michigan Medicine.

"This is an especially challenging time for families, with many children experiencing significant changes in routine that may negatively impact their health and wellbeing," said Mott Poll co-director and Mott paediatrician Gary Freed, M.D., M.P.H.

"Parents' biggest concerns for young people seem to be associated with changes in lifestyle as a result of the pandemic. COVID-19 has turned the world of our children and teens upside down in many ways and this is reflected in how parents rate health issues in 2020," added Mott.

But there are key racial and ethnic differences among families when it comes to worries about children's health, according to the report.

Black parents rate racism as their No.1 health concern for children and teens, with Covid-19 coming in at No.2. Racism ranks sixth among Hispanic parents, with Covid-19 at No.8.

Racism does not make the top 10 health issues for U.S. children among white parents and Covid-19 much lower on among their concerns.

These differences are likely due to African-American and Hispanic communities being disproportionately impacted by Covid-19 in the U.S., Freed says.

People from minority groups have been more likely to contract Covid-19, gotten sicker and died of the virus at significantly higher rates than white individuals.

Systemic racism has also been a national focus, as massive demonstrations protesting racial injustice swept the country over recent months. Black parents are also the only group that rates gun injuries and unequal access to health care as a top 10 concern. Meanwhile, white parents are the only group to rate lack of physical activity in the top 10.

"Families' backgrounds and experi-

they prioritize as most pressing for American children today," Freed said.

The nationally-representative report is based on responses from 2,027 parents with children ages 18 and under.

A closer look at top health concerns highlighted in the report:

Screen time

Freed says it's not surprising that the top three issues on parents' list of concerns are related to screen use. Children are spending more time online because of virtual school or not being able to spend time with friends in person.

But he says parents should worry less about the amount of time children are using devices and more on how they are using the technology.

"It's important for children and teens to maintain social and family connections that we know are critical for their emotional well-being, especially during a time when they are feeling stressed or isolated," Freed says. "Technology may be an important vehicle for those connections."

Still, parents should set clear ground rules and boundaries about how and ences likely shape what health concerns when children can use devices to

ensure it's not disrupting sleep habits, replacing healthy habits like physical activity, and that children's privacy is protected. They should also watch for any signs of cyberbullying and other types of online abuse, which also made

"Parents need to have ongoing conversations with their children and teens to guide them on safe internet practices," Freed says.

Emotional and physical health

Some parents reported great concern about kids experiencing increased negative emotions such as stress, anxiety, or depression, which may be related to or exacerbated by lifestyle changes caused by Covid-19.

"Parents may notice changes, such as increased behavioural issues in younger kids or more moodiness or lethargy from older kids and teenagers," Freed said.

In these situations, parents should encourage children and teens to talk about their feelings, and find healthy outlets to help them cope.

Changes in routine and social isolation from COVID-19 may also affect a

child's physical health. Inconsistent sleep habits may particularly increase the potential for unhealthy eating and reducing outside physical activity---all issues parents identified as top health

Families should try to maintain routines, especially keeping regular sleep schedules and helping teens resist the temptation to go to bed much later than usual and sleeping in later, Freed said. Mott experts also recommend intentional "unplugged" times to spend together as a family and getting outside daily, even for a brisk walk, as much as

But parents should also look for red flags that kids need more help to manage feelings, such as comments about how they might hurt themselves or experiencing dramatic shifts in usual mood, appetite or sleep. In these cases, families should reach out to paediatricians and consider enlisting the help of therapists or other health professionals.

Children who have lost family members to Covid-19 may also need special attention and mental health services solution," he said.-Agencies

Racism

Families should recognize the emotional toll of racism on children and teens. The impact of racism may be reflected in physical problems, such as disparities in the rates of diseases among different populations, and also in children's mental health. Children targeted by racism have higher rates of depression, anxiety, and behaviour problems, research shows.

"Although racism directly affects specific populations, its impact on children's health is a societal concern. It's important for parents to recognize the detrimental consequences of racism for children in our communities," Freed said. Finding ways for young people to get involved either through safely participating in protests or supporting groups or causes that aim to fight racism can be valuable, Freed says.

"Racism can instill a sense of helplessness in both children and teens. When young people are empowered to stand up to racism, it can make a big difference by showing them they can be part of a

Climate risks to health set to worsen inequity, harm children



ising global health risks driven by from climate change "boil down to maclimate change will hit the poorest, most vulnerable people the hardest and failure to prepare for those threats will mean more deaths and suffering, according to a leading environmental health scientist.

From impoverished families living in flood-prone homes to women whose cultures require them to stay covered in extreme heat, climate impacts on health have "a strong equity component", said Kristie Ebi, a professor at the University of Washington's Center for Health and the Global Environment.

Besides hiking dangers from deadly heat and spreading diseases, climate change will fuel a rise in basic health problems - from diarrhoea to poor nutrition - that will affect the poor most and likely widen global inequalities, she said.

"Future health risks will be determined not just by the hazards created by a changing climate but also by the sensitivity of individuals and communities exposed to these hazards," she noted in an article published this month in the iournal Health Affairs

ternal and child health issues", said Ebi, who has helped countries plan how to adapt to climate-linked health threats from Africa and Asia to the Pacific and Central America. Children face particular risks, she said. Because they breathe in more air for their body size than adults. for instance, they are particularly susceptible to air pollution, such as from worsening global wildfires, she noted.

"They handle it much more poorly than adults do," Ebi told the Thomson Reuters Foundation in an interview. High levels of child stunting and wasting, as extreme weather destroys crops and hits food security for many families, also will drive lasting health problems, she said.

"Without sufficient food, brain development is affected. Children end up learning less and earning less," said Ebi, who has led many national and international climate assessments.

Health issues can feed on each other too, she said, with hunger increasing vulnerability to malaria and more frequent diarrhoea exacerbating malnourishment.

coming threats will be crucial to avoid the worst impacts - but both richer and poorer countries are spending too little on that, she added. Globally, less than 0.5% of international climate finance goes to efforts to address climate-related health concerns, the journal article noted.

The U.S. National Institutes of Health, for instance, spends under 1% of its research budget on climate issues, Ebi said.

"It's laughably small," she said of global funding to research and deal with climate-related health concerns.

Such limited funding means measures that could help stem worsening health risks - from better early warning systems to mental health support for those who suffer catastrophic losses - are not being put in place fast enough.

Progress on tackling shifting health threats is also hampered because experts on related issues - from water and agriculture to nutrition and diseases - do not work together often enough, Ebi said.

A study published by researchers in the University of Birmingham's School of Sport, Exercise and Rehabilitation Sciences showed that short term 'prehabilitation' strength exercises, undertaken pre-surgery, are insufficient to prevent

In the study, the researchers asked a group of older adults to perform four sessions of weight lifting exercise over one week. The participants did the exercises using only one leg, while the other leg did no exercise at all.

After completing the prehabilitation, the participants underwent five days of d-rest - a typical length of stay in hos pital for an older patient. Although the researchers expected to find that the leg which had undergone the exercise would experience less muscle loss than the other leg, in fact they found muscle loss was about the same in both legs.

The team's detailed analysis showed that, while short-term exercise prehabilitation does enhance the body's musclebuilding processes, thigh muscle-wasting was about 3-4 per cent in both legs - roughly equivalent to what older adults would typically lose over 3-5 years of ageing.

The researchers recommend that one approach to protect older muscle from wasting during hospitalisation is to perform longer-term strength exercise prehabilitation beforehand.

"Although short-term prehabilitation offers a cost-effective and easy-to-implement strategy, it does not prevent muscle wasting among older adults undergoing bed-rest," Dr Leigh Breen, the study's corresponding author, said.

Covid-19: Heart disease avoidable deaths caused due to rare hospital visit

A new study led by UCL researchers has found out that during the initial phase of the Covid-19 pandemic, lower rates of hospital attendance for urgent heart problems may have contributed towards avoidable deaths in England.

In this study, published online in the journal Circulation cardiovascular quality and outcomes, researchers at UCL's Institute of Health Informatics estimated the effect of reduced ED visits for suspected cardiac disease on non-Covid-19 related cardiac mortality in England.

In the wake of the Covid-19 pandemic, a marked decline was observed in visits by patients to the Emergency Departments (EDs) in England and the US, including for people with heart problems. To quantify the number of

excess deaths due to cardiac disease, the team used mortality counts from the Office of National Statistics (ONS) for England. To quantify the change in daily ED visits, researchers used data from the Public Health England (PHE) Emergency Department Syndromic Surveillance System (EDSSS): a network of sentinel EDs across England. To explore how the reduction in ED visits may

have affected cardiac mortality, researchers implemented causal inference methodology. Lead author Dr. Michail

Katsoulis (UCL Institute of Health Informatics) said: "During the initial phase of the pandemic, between March 12** and April 15, 2020, there was an estimated fewer ED visits of 2,750 per week for suspected cardiac disease; this is around a 35% decrease compared to the pre-pandemic period this year.

"Our analysis suggested that one cardiac death might have been prevented or delayed for every additional 12 ED visits for suspected cardiac conditions. We

estimated that the excess cardiac mortality due to non-attendance at EDs, during the initial phase of the pandemic, may have been as high as 232 deaths per week."

Senior author Dr Tom Lumbers (UCL Institute of Health Informatics) said: "While the decline of patients accessing hospital care during the pandemic has been well documented, here we provide an estimate of the health consequences of this change in healthcare utilization.

"The public health messaging to protect the NHS may have led to patients not attending ED out of fear or public-mindedness or difficulty accessing services due

to the pandemic.

"Our results suggest that the pandemic response may have led to the under-treatment of non-Covid-19 diseases, including heart conditions, with important impacts on the excess mortality observed during this period."

Dr. Lumbers added: "These results provide evidence of the stark indirect effects of the Covid-19 pandemic on mortality in England. There is a need to better understand how the pandemic response resulted in a decline in attendance to EDs with suspected cardiac disease and other serious medical conditions to inform future strategies to

mitigate both the direct and indirect effects of the pandemic." **STUDY LIMITATIONS**

The research team's estimates rest upon the assumption that the Covid-19 pandemic only affects excess deaths from cardiac disease through the reduction in ED admissions, and not as a result of other factors, such as increased stress and anxiety.

Another potential limitation of this study is the possible misclassification of cardiac deaths as not related to Covid-19 since SARS-CoV-2 viral infection was excluded on clinical grounds and not through systematic viral ribonucleic acid testing. -Agencies
