### **New Covid-19 Variant Detected In Pakistan**

ISLAMABAD: Pakistan on Tuesday confirmed its first case of the new coronavirus variant found in the UK after it identified the strain that spreads at a much faster pace in three samples taken from passengers who had

returned from Britain. The health department in Sindh said the samples of 12 returnees were taken for genotyping, out of which six tested positive.

"Samples of 3 UK returnees show a 95 per cent match to the new coronavirus variant from the UK in the first phase of genotyping," it said in a tweet.

# **Encounter Rages On In Srinagar Outskirts**

### Traffic Diverted On Srinagar-Baramulla Highway

SRINAGAR: An encounter broke out between militants and government forces in the Lawaypora area of the city outskirts on Tuesday evening prompting the authorities to divert traffic on the busy Srinagar-Baramulla highway.

Police, army's 2 RR and CRPF launched a joint cordon-andsearch operation in Lawaypora Hokarsar area of the city outskirts on Tuesday evening amid specific information about the presence of the militants, news agency GNS reported.

As the joint team started advances, the report said, the hiding militants fired upon them in a bid to escape from their dragnet. The joint team, reports said, returned the fire setting off an encounter.

"Essential traffic coming from Baramulla, Sopore, Gulmarg towards Srinagar is diverted via Magam- Budgam to Srinagar and vice versa in view of a security situation, inconvenience is regretted," police said in a tweet.

### **Injured CRPF Officer Dies**

**SRINAGAR:** An Assistant Sub Inspector of Central Reserve Police Force (CRPF) died at a hospital here on Tuesday, six days after suffering grave injuries in a grenade attack in central Kashmir's Ganderbal district.

ASI Nitra Pal Singh succumbed to the injuries at SKIMS Soura, taking the death toll in last Wednesday's grenade attack to two, officials said Tuesday. Earlier on December 24, a constable Mritun Joy succumbed to the wounds at the tertiary care hospital here.

Besides the two slain CRPF men, four others, including a policeman and an RDD official were injured when suspected militants lobbed a grenade towards the joint team of CRPF and police in Tawheed Chowk area of Ganderbal town on Wednesday last.

About one in 100 children has a common brain disorder called Chiari 1 malformation, but most of the time such children grow up normally and no one suspects a problem. But in about one in 10 of those children, the condition causes headaches, neck pain, hearing, vision and balance disturbances, or

other neurological symptoms. In some cases, the disorder may run in families, but scientists have understood little about the genetic alterations that contribute to the condition.

"A lot of times people have re-

current headaches, but they don't realize a Chiari malformation is the cause of their headaches," Haller said. "And even if they do, not everyone is willing to have brain surgery to fix it. We need better treatments, and the first step to better treatments is a better understanding of the underlying causes."

If people start experiencing severe symptoms like chronic headaches, pain, abnormal sensations or loss of sensation, or weakness, the malformation is treated with

surgery to decompress the Chiari malformation.

"There's an increased risk for Chiari malformations within families, which suggests a genetic underpinning, but nobody had really identified a causal gene," said senior author Gabriel Haller, PhD, an assistant professor of neurosurgery, of neurology and of genetics. "We were able to identify two causal genes, and we also discovered that people with Chiari have larger head circumference than expected. It's a significant factor, and easy to measure. If you have a child with an enlarged head, it might be worth checking with your pedia-

To identify genes that cause Chiari 1 malformation, Haller and colleagues sequenced all the genes of 668 people with the condition, as well as 232 of their relatives. Of these relatives, 76 also had Chiari 1 malformation and 156 were unaffected. The research team included first author Brooke Sadler, PhD, an instructor in pediatrics, and coauthors David D. Limbrick, Jr., MD, PhD, a professor of neurosurgery and director of the Division of Pediatric Neurosurgery, and Christina Gurnett, MD, PhD, a professor of neurology and director of the Division of Pediatric and Developmental Neurology, among others.



# UK plans to ban unhealthy buy 1 get 1 free' food promos as part of anti-obesity drive

**LONDON:** The UK government has set out plans to ban unhealthy promotions on food and drinks high in fat, salt or sugar from April 2022 as part of a wider anti-obesity drive.

The new rules, confirmed on Monday, will prohibit retailers from offering multibuy promotions such as "buy one, get one free" or "3 for 2" offers on these products. Unhealthy promotions will also no longer be featured in key locations, such as at checkouts, store entrances, aisle ends and their online equivalents.

"We know families want to be presented with healthier choices. This is why we are restricting promotions and introducing a range of measures to make sure the healthy choice is the easy choic said UK Public Health Minister Jo Churchill. "Creating an environment which helps everyone eat healthier foods more regularly is crucial to improving the health of the nation," she said.

The Department of Health and Social Care (DHSC) said that promotions often appear to help

shoppers save money. However, data shows that these deals actually increase purchases of promoted products by almost 20 per cent. They encourage people to buy more than they need or intended to

In the New Year, Public Health England's Better Health Campaign will also run new adverts on TV and online to inspire and support people to maintain a healthy weight, the DHSC said.

# Lying about Kashmir

story published in a magazine Sunday Guardian on December 27 about a marriage between a J&K girl Suman Devi and a Maharashtrian Army man Ajit Patil has claimed that before the scrapping of Article 370 no Kashmiri girl could marry outside the former state and that "only Pakistani and Kashmiri boys were allowed to marry Kashmiri girls". The story adds that Devi and Patil are now man and wife, "but that wouldn't have been possible if Article 370 wasn't scrapped from Jammu and Kashmir". Ajit is also hailed as the "first son-in-law of Kashmir". Nothing can be farther from the truth and that a magazine would give this patently fake news a pride of place on its website is deplorable. A formal publication is expected to give their readers a rigorously fact-checked story. It is not social media where every account holder is a publisher and can post anything. But stories like the one about the marriage between Devi and Ajit and using it to peddle a patent lie on Kashmir is a graver violation of ethics and professionalism than even the fake news on social media.

As for the truth about the marriages between Kashmiris and outsiders, they used to took place always. And even the consequent loss of family property by a woman marrying outside J&K, a line of argument against Article 370 plied by a vocal section of opinion in India, is not based on fact. The truth is that the woman didn't lose property rights. This is something that the J&K High Court had settled a long time ago. The former chief minister Omar Abdullah is on record to have said that his sisters, who are married outside the state, own property in Kashmir as much as he does.

According to the High Court order in 2002, the Kashmiri women would not lose their residency rights if they marry a man from another state. Also, a Pakistan man wouy not get Kashmiri citizenship if he married a Kashmiri woman. The case titled State and others vs Dr Susheela Sawhney and others was settled by a full bench of High Court in October 2002 by striking down the provision of the permanent residency law whereby the women marrying outsiders would lose their permanent resident status. The judgement read: In view of the majority opinion, we hold that a daughter of a permanent resident marrying a non-permanent resident will not lose the status of permanent resident of the state of Jammu and Kashmir.' Later the judgement was reproduced in the document prepared by the Lok Sabha Secretariat.

But despite these facts, a narrative persists that Kashmiri women lost their right to property when they married non-state subjects. The reason for this is the propaganda designed to achieve political ends and the false reporting carried by a section of media that manipulates and shapes a hostile public opinion about the region. It is thus important that such false reporting about Kashmir is called out.

## No room for complacency

n the past week, India has, on average, reported 292 new Covid-19 deaths every day, and 21,072 new infections daily — both the lowest in around half a year. Since the peak of India's first wave in mid-September, both these numbers have dropped nearly 80%. Also in the last week, the positivity rate — the proportions of samples tested that return positive for Sars-CoV2 — is at the lowest ever. This is a key metric key in determining how widespread the virus is in a community. According to the World Health Organization, if the positivity rate remains five per cent or below for two weeks, a region can be said to be keeping its outbreak under control. India's positivity rate has been below this threshold for 45 days now — a remarkable feat for a country of this size.

On the other hand, the grand exercise to vaccinate more than 300 million people by summer appears to be only days away with drug regulators expected to soon take a decision on emergency approvals for vaccines. On Monday, officials in four states carried out vaccination drills, testing arrangements for the first phase of the drive. The calm waters that India's outbreak is in right now should not be taken as a sign that the tide has turned in the battle against the disease. States are tracking down passengers who have recently returned from the United Kingdom (UK), where a new and more transmissible virus variant has been discovered.

On Monday, it emerged that some of them have tested positive for the variant. This serves as a warning sign to not let the guard down. Even if 300 million people are vaccinated by summer in India, it would mean that 75% of the country's population remains vulnerable.

ne of the reasons given by the Narendra Modi government for making Article 370 redundant was that the "special status" had deprived the people of Jammu and Kashmir of various rights that the rest of India enjoyed, as central laws were not applicable in the state which is now a Union Territory (UT). It is now more than a year since several central laws have been extended to Jammu & Kashmir but people are yet to get the benefits of these laws especially those laws which are very progressive and pro-people.

Through this piece I will explain in detail how liberal and pro-people legislations like Right to Fair Compensation and Transparency under Land Acquisition Rehabilitation and Resettlement Act (RFCTLARR Act 2013), Forest Rights Act (FRA 2006), Scheduled Castes and Tribes (Prevention of Atrocities) Act, 1989 or even Right to Information Act (RTI) are not implemented on the ground.

More than 7 years back, when the Congress led UPA-II came up with Right to Fair Compensation and Transparency under Land Acquisition Rehabilitation and Resettlement Act (RFCTLARR Act 2013), it was neither extended to J&K nor was a similar law enacted by JK Govt. From 2013 onwards, the ultimate sufferers have been people of J&K especially those agrarian families whose land and property was acquired for various developmental projects like highways, road widening, construction of dams, power projects, defence estates etc

### Successive Governments also Responsible

Affected people in towns, cities and villages whose land, commercial establishments and residential houses came under alignment of various developmental projects have been demanding fair compensation for the last many years but successive Governments in J&K were adamant to replace the J&K Land Acquisition Act 1934 for unknown reasons. I am not only blaming the present BJP lead Modi Govt for this as successive state Govt's in J&K are also very much responsible for not repealing JK Land Acquisition Act 1934 in past. Affected farmers protested over this several times but nobody paid any attention towards them. J&K RTI Movement too has been advocating for a robust land acquisition law in J&K right from 2012 onwards, when center was drafting the RFCTLARR Bill. I have written almost two dozen columns on this subject during the last 8 years, but neither NC-Congress Govt nor PDP- BJP Government took steps to extend RFCTLARR Act 2013 to J&K nor was similar state law enacted by J&K legislature. I even met with the former Chief Minister Mehbooba Mufti when she

### 86 year old law repealed

The archaic J&K Land Acquisition Act 1934 enacted during Maharaja Hari Singh's period got automatically repealed after abrogation of Article 370. The benefits of this law are vet to reach the affected people of J&K. Government is denying acquiring land under new law in Budgam district where farmers are losing 3700 kanals (480 acres) of agricultural land. The same is coming in the alignment of Srinagar Ring Road project. In most of the cases due to efflux of time, the notification issued under JK Land Acquisition Act 1934 almost 4 years back stands lapsed. This has been authenticated by the Deputy Commissioner Budgam as well in his official communication with Divisional Commissioner Kashmir in May this year vide letter No: DCB/LAS/20/300-10 Dated: 18.05.2020. Nobody is ready to listen to the affected farmers while on the other hand Government claims to be saviors of farmers and kissans. J&K Govt wants to conclude the land acquisition proceedings under an outdated and repealed law which doesn't apply to J&K anymore. This is unacceptable to affected farmers.

### Ring Road Project

PM Narendra Modi in May 2019 inaugurated two Ring Road projects in J&K aimed at decongesting traffic in Jammu and Srinagar cities. In Jammu, around 400 acres (3200 kanals) of land has already been acquired for a 58-km highway. The

work on the project has been going on. Affected farmers have been denied fair compensation as the proceedings were undertaken under JK Land Acquisition Act 1934 plus the stamp rates in Jammu district were very low. The land acquisition process has been completed there. For Srinagar Ring Road, 600 acres (4800 kanals) of agricultural land is going to be acquired for 62-km highway connecting Pulwama with Ganderbal via Budgam. Srinagar Ring Road will cross through Pampore, Wathoora Chadoora, Budgam, Dharmuna, Narbal and then pass via Srinagar's western outskirts in Rambir Garh and enter Ganderbal after crossing the Srinagar Bandipora road. Affected people, especially the farmers in Budgam and some other districts under the banner of Ring Road Land Owners Welfare Committee have been demanding fair compensation from 2017 onwards. There were legal issues in the past but now the Government can invoke the fair compensation law but they seem to be reluctant

### Old Notification has lapsed

Massive urbanization and population growth have led to shrinking of farmlands in Kashmir. The land which was sold for Rs 80 lakhs an acre (Rs 10 lakhs / kanal) a decade back is now sold @ Rs 5 to 6 crores / acre. The land rates around Budgam district have gone very high due to its better connectivity with Srinagar city. The authorities on the other hand are trying to acquire the same for a meager compensation. After abrogation of article 370, we lost several state institutions and good laws like J&K RTI Act 2009 but Right to Fair compensation, Forest Rights Act (FRA-2006) and SC ST prevention of atrocities act 1989 are few central laws that could have been beneficial to us. It seems authorities at helm don't want to give the benefits of these laws to people.

In Jammu, district land for Jammu Ring Road project has already been acquired for peanuts and some months back, one affected land owner. Harbans Lal committed suicide at Bishnah. People are losing apple orchards, plum orchards, paddy fields and vegetable farms in Budgam. In other districts like Pulwama and Srinagar authorities have almost completed the land acquisition proceedings for Srinagar Ring Road project. In these districts, the affected farmers were not much in number, but in Budgam district this got delayed and final awards of many villages have not been finalized and thus the Government could not take possession of the land. During the same time J&K's Land Acquisition Act 1934 got repealed post article 370 abrogation and from October 31st 2019 Right to Fair Compensation and Transparency under Land Acquisition Rehabilitation and Resettlement Act (RFCTLARR Act 2013) got applicable in J&K.

The authorities want to take possession of the land by invoking provisions of old law (JK Land Acquisition Act 1934). This is a completely ridiculous and unfair practice which the affected farmers are opposing. In some cases the High Court of J&K has stayed the land acquisition proceedings and Government has been directed through an interim order to issue fresh notification in case farmers continue to be in possession of land. The respondents are not even filing the counter statement before the High Court especially in cases of Ali Mohammad Akhoon V/S State of J&K and Abdul Salam Bhat V/S State of J&K.

### Awards to be made within 2 yrs

Many affected families in Budgam have been paid some part of the compensation by the district collector in past but this is an advance money which can be paid to affected persons as per the repealed JK Land Acquisition Act 1934. Authorities call it a tentative award, but there is no mention of this word in any land acquisition law. Award means final award only which was awaited but has got automatically lapsed even under the provisions of section 11-B of erstwhile J&K Land Acquisition Act 1934 samvat 1990 which reads as

"Collector shall make award under section 11 within a period of 2 years from the date of the publication of the declaration". In case of Budgam it is almost 4 years now since the land acquisition notification under section 4 and 6 was published (March 2017, August 2017 re-

spectively) Taking this into consideration, land acquisition proceedings in almost 20 villages have lapsed and the Deputy Commissioner has sent a detailed list to the Divisional Commissioner Kashmir. Section 24 sub section 1 & 2 of Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act -RFCTLARR Act 2013 also has a similar provision which reads as:

"Notwithstanding anvthing contained in this Act, in any case of land acquisition proceedings initiated under the Land Acquisition Act, 1894, — (a) where no award under section 11 of the said Land Acquisition Act has been made, then, all provisions of this Act relating to the determination of compensation shall apply.

Pertinently, the 1894 land acquisition act was applicable across India (except J&K) prior to enactment of 2013 Right to Fair compensation law. In our case, 1894 law can be equated with J&K Land Acquisition

There are some villages where not even a single penny has been taken as compensation by the farmers like villages of Wathoora and Buchroo and in such cases Government has to invoke the new land acquisition act by issuing a fresh notification but it seems Government isn't ready to do that. On the other hand. Financial Commissioner Revenue some months back okayed the awards sent by the present DC Budgam which is completely illegal as the awards have lost their validity due to time efflux, plus JK Land Acquisition Act 1934 having been repealed.

### Termination of Contract

Infrastructure company namely M/S RAMKY Infra was allotted the contract for Srinagar Ring Road project after necessary bidding process. The Letter of Award (LoA) was issued to them on March 5th 2018 by National Highways Authority of India (NHAI) which is the intending agency. On December 7th 2019, M/S RAMKY Infra gave Termination of Contract (ToC) notice to NHAI as the Government failed to acquire the land from the farmers especially in Budgam district. As mentioned above, the then Deputy Commissioner Budgam has clearly intimated the Government that notification issued in 2017 has lapsed in case of almost 20 villages as final awards could not be finalized even after more than 3 years which otherwise has to be completed within 2 years as per section 11-B of JK land acquisition act 1934 (now repealed).

The Govt instead of issuing sh notification for Srinagar Ring Road under Right to Fair compensation law, is adamant to conclude land acquisition proceedings under an outdated and repealed law (JK Land Acquisition Act 1934). This is completely unjust and a legal fraud which is unacceptable to people. Similarly, before rolling out Forest Rights Act 2006 (FRA) in J&K, Government wanted to evict forest dwellers by invoking Indian Forest Act of 1927 which is a 93-year-old law. FRA 2006 ensures scheduled tribes and other traditional forest dwellers living in a forest area for 3 generations or more to get right over the forest land for agriculture and allied activities but before this law could be enforced on ground Forest officials started issuing eviction notices to people living near forests especially in district Budgam. In village Kanidajan, 10,000 apple trees were axed and till date no action has been taken against the accused. Action could have been taken against accused officials under the Scheduled Castes and Tribes (Prevention of Atrocities) Act. 1989 popularly known as Prevention of Atrocities Act (POA) but this law is all not being rolled out. In case of RTI Act 2005, the Public Information Officers (PIOs) continue to deny information to applicants and the Govt has not even held a single training workshop for officials. Aggrieved have now moved to Central Information Commission (CIC) against PIOs of DC office Budgam Rural Development Department Civil Secretariat and Services Selection Board (SSB) as JK State Information Commission (SIC) was shut down post 370 abrogation.

# **Can Academics Afford Political Neutrality?**

Participation in the political debate is not the academic merit of a researcher or a professor in the eyes of the employer. Rather, those academics who openly express their views on politics are often seen as intellectual lightweights by their peers and as troublemakers by their superiors

he year 2020 has come to an end. It has been an incredibly harsh year, the world is not only facing a once-a-century pandemic, but also a collapsing global economy, an increasing number of armed conflicts, political instability, and many popular protest movements in different parts of the world.

Pandemic enforced global lockdown has however some unintended positive side effects. One of them is that many home-confined academics have become more active than before in participating in public debates by writing opinion pieces and blogs, increasing their media appearances and using social media to voice their views, and regularly contributing to podcasts and vlogcasts.

#### Greater research-policy interface

For some time, there has been an increasing societal expectation of a greater research-policy interface. While taxpayers demanding to get a certain direct return for the money they are paying to academic institutions, university administrations are also encouraging their professors and researcher to actively take part in the public discourse and policy dialogues to fulfil their 'contributions to society' objectives.

Despite all these, there is no such official incentive to do this as to get the promotions and tenures, academics are invariably judged by their classroom teaching and publications in research journals, not for their contributions to the policy community or participation in public discourse.

In the absence of any direct benefit from the workplace, some academics do engage with the policy community as it helps to raise additional research funding and get consultancy assignments from the government, nongovernment and intergovernment agencies.


These implicit incentives have helped somewhat to increase the involvement of academics in policy-making platforms in areas like development, environment, education, climate change, migration, public health, and gender, etc. The year 2020 has surely witnessed an upsurge in this trend.

### Reluctance to join political debates

While the hesitation to participate in policy debates has been melting gradually, academics are still reluctant to join the political debates. Unless an academic has political ambition, the disincentives are too many for her or him to enter the political-debate minefield.

Participation in the political debate is not the academic merit of a researcher or a professor in the eyes of the employer. Rather, those academics who openly express their views on politics are often seen as intellectual lightweights by their peers and as troublemakers by their superiors.

Established profiling of an academic lead to this unfortunate conclusion as they are expected to behave in a certain manner, and maintaining a façade of intellectual neutrality is a very important trait in that. Taking part in political debate not only gets construed as being politically partisan but also it opens up these opinionated academics



to criticism, abuse, and even threats from the supporters of the opposite political spectrum.

While ruling establishments are generally nonchalant over what gets published as 'scientific' publications, but they can be very vindictive if academics express their critical opinions by writing opinion pieces or giving media interviews, or using social media platforms.

Academic institutions, though formally encourage their employees to participate in public debates they lack resources as well as willingness to protect politically opinionated professors and researchers from motivated criticisms and retributions.

### Silence in the name of academic neutrality

Remaining silent in the name of academic neutrality is probably fine as long as the politics and politicians are adhering to established norms of governance and respecting constitutional proprieties, but not when ethno-nationalist populists are on the rampage and polarising the societies and countries to capture or remain in power.

Those are wrong who expect universities to be 'free from politics' and only become 'sites of learning' when the country is going through a political metamorphosis. Is it acceptable for a political scientist to remain silent in the name of academic neutrality while the political establishment is openly and systematically destroying the basic principles of liberty, equality, and justice in a country?

Or, for a historian to keep quiet when a politi-

cal group is manufacturing history not based on historical evidence but for its narrow divisive politics? Or, for a scientist to look the other way when the government is actively undermining scientific inquiry and forcing the people to accept national and sectarian myths as science?

Or, is it OK for a professor of medicine to be tongue-tied when a ruling dispensation openly promotes 'voodoo' medicines while belittling the contributions of medical science and its breakthroughs.

Political discourse is too important to be left to a group that makes a profit out of it. While in many countries media is not free and independent, the political debates and discussions are limited to politicians and professionally biased political commentators.

Thus, society needs its academics to take part in political discussion and education, using whatever platforms available to them to be able to present an independent as well as impassive analysis of it.

If the politics of a country goes seriously wrong, all other contributions academics are making or hoping to make by maintaining so-called academic neutrality will become useless.

Thus, even if it is time-consuming and perilous, academics should rather respect their moral and professional conscience and actively contribute to the political debate of the country.

What's the significance of this new discovery? The Conversation asked Lucy van Dorp, a microbial genomics researcher and an expert in the evolution of pathogens, some key questions about what we know at this point in time.

### What do we know about this new variant?

The new UK variant, known as VUI–202012/01 or lineage B.1.1.7, was first announced by Matt Hancock, the health secretary on December 14. It was subsequently confirmed by Public Health England and the UK's COVID-19 sequencing consortium. Screening back through databases of SARS-CoV-2 the first sample was taken in the county of Kent on September 20.

The variant carries 14 defining mutations including seven in the spike protein, the protein that mediates entry of the virus into human cells. This is a relatively large number of changes compared to the many variants we have in circulation globally.

To date, genetic profiles – or genomes – of this variant have been largely sequenced and shared from the UK but include some in Denmark and two cases in Australia. There have also been reports of a case in the Netherlands. These countries all have very large genome sequencing efforts and it is very possible that these observations do not reflect the true distribution of this variant of the virus, which could exist undetected elsewhere. We will know more as more genomes are generated and shared.

# Coronavirus new variant genomics, researcher answers key questions

results in the UK, it seems that this variant is now starting to dominate over existing versions of the virus and that it may be responsible for an increasing proportion of cases in parts of the country, particular in regions where we also have rapidly expanding case numbers.

It is always very difficult to disentangle cause and effect in these cases. For example increases in the appearance of certain mutations can be due to viral lineages carrying them rising in frequency just because they happen to be the ones present in an area where transmission is high, for example due to human activities or choice of interventions.

Though this is still a possibility, there are clearly enough concerning observations so far for this variant to warrant very careful characterisation, surveillance and interventions to curb transmission.

### Is it more dangerous?

Chris Whitty, the chief medical officer, stated clearly that there was no evidence to date that this variant alters disease severity, either in terms of mortality or the seriousness of the cases of COVID-19 for those infected. Work is underway to confirm this.

### How do virus mutations happen?

Mutations are a natural part of virus evolution. In the case of SARS-CoV-2, these mutations may arise due to random errors during virus replication, be induced by antiviral proteins within infected people, or via genetic shuffling – known as recombination. Though signs of recombination are not currently detected in SARS-CoV-2.

Most viral mutations are expected to have no impact. For example, when our team assessed individual mutation replacements in more than 50,000 genomes from the first wave of the pandemic, we detected none that significantly altered viral fitness – the ability of the virus to survive and reproduce.

However, every so often a mutation, or in this case a particular combination of mutations, may strike lucky and offer the virus a new advantage. Viruses carrying these combinations of mutations may then increase in frequency by natural selection given the right epidemiological environment.

### Where did the variant come from?

Right now, we don't know. To date, scientists have not identified any closely related viruses to support the theory that the variant had been introduced from abroad. The patterns of mutations observed are

more supportive of an extended period of adaptive evolution most likely in the UK based on current data.

Similar patterns of mutation to these have been observed in the evolution of SARS-CoV-2 in chronically infected patients with weaker immune systems. The current hypothesis is that such a scenario of chronic infection, in a single patient, may have played a role in the origin of this variant. This will continue to be investigated.

### How many variations of SARS-CoV-2 have we found?

There are many thousands of lineages of SARS-CoV-2 which differ on average by only a small number of defining mutations. It remains true that SARS-CoV-2 currently in global circulation have little genomic diversity. Subtleties in the mutations carried in different lineages can, however, be very useful for reconstructing patterns of transmission.

As an example, work early in the pandemic used lineage assignments to identify at least a thousand introductions of SARS-CoV-2 into the UK.

### Why is this one different?

It is important to note that many of the mutations defining the UK variant have been observed in SARS-CoV-2 before and even sometimes quite early in the pandemic.

Yet the UK variant, or lineage, is defined by an unusual number and combination of mutations. One of these mutations, N501Y, has previously been shown to increase binding of the virus to receptors in our cells. N501Y was first sequenced in a virus in Brazil in April 2020 and is current-

ly associated with a SARS-CoV-2 variant also rising in frequency in South Africa – an independent lineage from B.1.1.7 that is also warranting concern.

The particular deletions identified in the spike protein of B.1.1.7 have appeared in multiple other lineages of the virus at increasing frequency and are also observed in chronic infections where they may alter antigenicity - recognition by immune antibodies. These deletions may also be associated with other mutations in the binding region of the coronavirus spike protein, including those observed in infections among farmed mink and a mutation shown to play a role in the virus's ability to evade the immune system in humans. B.1.1.7 also harbours a truncated ORF8 gene, with deletions in this region previously associated with decreased disease severity.

The functional effect of these mutations and deletions, particularly when in the combination reported in B.1.1.7, are still to be determined. The high number of mutations and the recent increase in prevalence of this particular variant, together with the biological relevance of some of the mutation candidates, emphasises the need for in-depth study.

### What does this mean for the vaccine?

At the moment we don't know. Though we should be reassured that vaccines stimulate a broad antibody response to the entire spike protein, so it is anticipated that their efficacy will not be significantly hampered by mutations. This is already being tested.

However, there is an increasing body of evidence that other species of seasonal coronaviruses exhibit some ability to escape immunity over longer time periods.

It is therefore conceivable that we may reach a point where we are required to update our COVID-19 vaccines, as we do for influenza, to reflect the variants in circulation at the time. It's too early to say if this will be the case now, but extensive genome sequencing, data sharing, and standardised reporting of variants will be vital to inform these efforts.

Celsius in Drass to scanty average precipitation of 10 centimetres annually, which makes the region a distinct cold desert, he said.

Ladakh also experiences various kinds of extreme weather events like cloud bursts, flash floods, glacial lake outbursts, avalanches and drought.

"To avert losses due to such weather events in the future, the Government of India felt the need to establish a meteorological Centre at Leh to strengthen weather-related early warning system in Ladakh. At 3,500 metres, Meteorological Centre, Leh, will be the highest meteorological centre in India," Vardhan said.

The centre will also give weather forecasts about tourist places such as Nubra, Changthang, Pangong Lake, Zanskar, Kargil, Drass, Dha-Baima (Aryan valley), Khalsi, he said.

Some important services are highway forecast. forecast for mountaineering, trekking, agriculture, flash flood warning, information on gusty winds, low and high temperatures.

"Keeping in mind the geo-strategic importance, harsh environment, changing climate and vulnerabilities to various natural hazards and disasters affecting the region adversely, the government felt the need to open a stateof-the-art meteorological centre in Leh," the Union Minister added.

IMD Director General Mrutunjay Mohapatra said the new centre will help augment the weather services.

Ladakh has four Automatic Weather Stations (AWS), two each in Leh and Kargil, of which one is at Drass, the coldest place in India.

To improve the network of observations, IMD plans to install more AWSs next year at the remotest of places like Nubra, Zanskar, Changthang, Parkachik and others, thus covering the whole of Ladakh, Mohapatra said.

To begin with, the India Meteorological Department established a surface observatory at Leh for reporting daily meteorological parameters like pressure, humidity, temperature, snowfall, etc. With the availability of quality data from Ladakh, IMD will generate city-specific forecasts based on numerical models, the MeT department said.

High speed internet on mobile devices remained suspended in most parts of Jammu and Kashmir even after passage 16 months since abrogation of Article 370 as the administration still feels that allowing the service poses a threat to sovereignty and integrity of India. On the administration front, BJP leader

Manoj Joshi replaced Girish Chander Murmu as the Lieutenant Governor of Jammu and Kashmir amid rumours of a rift between the latter and Chief Secretary of the union territory B V R Subrahmanyam.

But the successful conduct of the DDC elections was the highlight of 2020.

However, within hours of final results being declared, opposition parties charged the union territory administration of luring independents to support the BJP or its proxies.

Seven mainstream political parties - NC, PDP, People's Conference, Awami National Conference, People's Movement CPM and CPI – cobbled an alliance under the name of People's Alliance for Gupkar Declaration (PAGD) with Farooq Abdullah as its head.

The main purpose of forming the alliance was to strive for restoration of the special status of Jammu and Kashmir. Even before the alliance could take baby steps, the DDC elections were announced and the PAGD was expected to boycott. But the alliance took the electoral plunge as a grouping.

The results were along the expected lines with minor surprises here and there. The PAGD bagged 110 seats. Kashmir predominantly voted for the PAGD candidates with BJP bagging three of the 140 seats while April Party of Altaf Bukhari winning few others. However, the three wins for BJP were a massive shot in the arm for the saffron party as it marked its first victory in any election where the National Conference and the PDP were also taking part.

On the other hand Hindu-dominated districts in Jammu region and Doda district gave a resounding mandate to the BJP. In fact, 63 of the 75 seats won by the BJP came from six districts of Jammu, Kathua, Samba, Udhampur, Reasi and Doda.

However, the BJP faced a blank in Poonch and managed just three seats each in Rajouri, Kishtwar and Ramban districts - a performance below par compared 2014 assembly

"The administration has now taken on the

responsibility of trying to collect independent candidates for the BJP and its recently formed subsidiary," National Conference leader Omar Abdullah said.

"It seems the government does not have enough to do and has branched out in to this line of work as well," Omar said about wooing of independent DDC members.

Independents emerged as the third largest entity in the DDC polls, bagging 50 seats. The BJP with 75 seats and the National Conference with 67 were the top two parties.

"There are some disturbing reports about interference in democracy, in peoples' verdict, wherein the government of the day is acting in a partisan manner... facilitating moves by some people to attract independents towards them," PAGD spokesman and Peoples Conference chairman Sajad Lone said.

Lone said the government should desist from humiliating the "great verdict" of the people of Jammu and Kashmir.

"History is replete with examples that those who tried to humiliate the verdict of the people, they end up with a disaster," he added.

While DDC elections in the rest of the country have become a norm for a long time now, residents of Jammu and Kashmir had their first experience of directly electing district-level

However, the process of election - mainly campaigning - was marred by allegations of favouritism towards BJP and its allies while the opposition parties' leaders were prevented from campaigning.

The sudden announcement of DDC elections in the newly-carved union territory caught most of the regional parties off-guard.

The National Conference and People's Democratic Party (PDP) did not take part in the panchayat elections in 2018 due to apprehensions that the BJP-led government at the Centre was planning to tinker with the special status of Jammu and Kashmir. The result of the boycott was that BJP for the first time won any kind of election in the valley.

The CCG letter further demanded that the "illegal ordinance" be withdrawn forthwith and those Indians that have suffered from its "unconstitutional enforcement be suitably compensated".

"The policemen who were responsible for allowing this must be called to account under the law, suitably investigated at a senior level of the magistracy and if found to have facilitated the death of the unborn infant, be put to trial under the IPC," the CCG said.

"Moreover, the entire police force of Uttar Pradesh needs to be trained without delay in respecting the rights of all citizens; and the politicians of UP, including yourself, need to re-educate vourselves about the provisions of the Constitution which you and other lawmakers have sworn to uphold. While our past communications to you give us little reason to expect that your government will take corrective action to uphold the rule of law, we do hope this letter will contribute to mobilising informed public opinion against these developments and that the Courts will take notice and intervene to stem the rot," it added.

The officials said the ski-resort of Gulmarg in north Kashmir recorded seven inches of fresh snowfall, while Pahalgam resort in the south and Sonamarg resort in central Kashmir received around three to four inches of snow

The account had turned a non-performing asset in 2017, the officials had said.

In the chargesheet filed before the Special Court, Jammu, the CBI has also named the then heads of Land K Bank, New University Campus branch, Iqbal Singh and Arun Kapoor

The CBI has alleged that Hilal entered into a criminal conspiracy with the then officials of the Bank to get loans of Rs 177.68 crore (approx) in violation of the rules and guidelines.

'The loans that were sanctioned for construction of flats were allegedly diverted and misappropriated by the accused using the bank accounts of his employees. It was further alleged that the accused submitted forged certificates and bills to the bank," a CBI spokesperson had said.

On August 6, the Enforcement Directorate (ED) launched multiple raids at 16 locations in Kashmir, Jammu, Delhi and Ludhiana in connection with the money laundering case linked to the bank fraud probe against Hilal. The ED had filed a money laundering case

against Hilal and others, under the Prevention of Money Laundering Act (PMLA), taking cognisance of a CBI FIR and Income Tax Department probe against him in the alleged bank fraud scam.

The allegations were denied by Hilal's family after the agency filed an FIR in the case.

A statement issued by Hilal's legal counsel had earlier claimed that having failed in its primary task of holding public officials accountable, the agency (ACB) was trying to give a different colour to the case by resorting to "canards and false accusations". (PTI)

# **Study Finds Music-Induced Emotions Can Be Predicted From Brain Scans**

esearchers at the University of Turku have discovered what type of neural mechanisms are the basis for emotional responses to music.

Altogether 102 research subjects listened to music that evokes emotions while their brain function was scanned with functional magnetic resonance imaging (fMRI). The study was carried out in the national PET Centre.

The researchers used a machine-learning algorithm to map which brain regions are activated when the different music-induced emotions are separated from each other.

- Based on the activation of the auditory and motor cortex, we were able to accurately predict whether the research subject was listening to happy or sad music. The auditory cortex processes the acoustic elements of music, such as rhythm and melody. Activation of the motor cortex, then again, maybe related to the fact that music inspires feelings of movement in the listeners even when they are listening to music while holding still in an MRI machine, says Postdoctoral Researcher Vesa Putkinen.

The researchers also discovered which brain regions are activated when the research participants watched videos that evoke strong emotions and tested whether the same regions were activated when the participants were listening to music that evokes emotions.

The results suggest that the emotions evoked by films and music are partially based on the operation of different mechanisms in the brain.

- Films, for instance, activate the deeper parts of the brain that regulate emotions in real-life situations. Listening to music did not strongly activate these regions nor did their activation separate the music-induced emo-

tions from each other. This may be due to the fact that films can more realistically copy the real-life events that evoke emotions and thus activate the innate emotion mechanisms. As for the music-induced emotions, they are based on the acoustic characteristics of music and coloured by cultural influences and per-

Traditionally, music-induced emotions have been studied through classical instrumental music.

We wanted to use only instrumental music in this study as well so that lyrics did not impact the emotions of the research subjects. However, we included film music and songs by the guitar virtuoso Yngwie J. Malmsteen, notes Putkinen.

# New mammal reference genome helps ID genetic variants for human health

he rhesus macaque is the most widely studied nonhuman primate in biomedical research. A genome sequencing project for this species, led by a team of researchers has created a new framework for the study of this important primate.

Research published in the journal Science has established a new reference genome assembly and identified more than 85 million genetic variants in the rhesus macaque, the largest database of genetic variation for anyone nonhuman primate species to date.

"This is a major step forward in the amount of information we have about genetic variation in the rhesus macaque," said Dr. Jeffrey Rogers, associate professor at the Human Genome Sequencing Center and Depart ment of Molecular and Human Genetics at Baylor and one of the corresponding authors of the study. "We have actually identified thousands of new mutations in the population of research animals. Now colleagues all over the country who are investigating various aspects of health and disease using rhesus macaques can begin to make use of that information.'


Dr. Wesley C. Warren at the University of Missouri and Dr Evan Eichler at the University of Washington, both corresponding authors of the study, used a combination of several advanced technologies to substantially improve the rhesus macaque reference genome assembly first created in 2007. The new reference genome published today provides a more complete and accurate picture of the rhesus macaque DNA sequence. This improvement can support more sophisticatand more detailed analyses of fundamental

"When we coupled this higher quality genome reference with a broader sequencing of expressed genes, our team discovered gene structures unique to macaque as well as specific repeat sequences undergoing deletions that suggest evolutionary competition to suppress these elements from expanding continues today," said Warren, professor at the University of Missouri's Bond Life Sciences Center.

Researchers at Baylor's Human Genome Sequencing Center sequenced the genomes of 853 rhesus macaque from research institutions around the country and compared them to the new reference genome. The genome analysis showed that rhesus macaque have more genetic variants per individual than humans. Among the millions of genetic variants identified, researchers found several damaging mutations in genes known to cause genetic disorders in humans, including autism, inherited blindness and several others.

'We can find naturally occurring models of genetic disorders by surveying the rhesus macaque population," Rogers said. "We will find animals that naturally carry interesting and useful genetic mutations that can help us understand genetic variation and susceptibility to disease in humans. Rhesus macaques are also widely studied by primatologists and evolutionary biologists, so this new reference genome will also provide new insight into the evolution of the nonhuman primate and human genomes.

# WhatsApp To Stop Working On These Devices From Jan 1, 2021

illions of smartphone users won't be able to access WhatsApp from January 1, 2021, onwards as their devices will no longer remain compatible with the messaging app. WhatsApp has yet again announced that is withdrawing support for certain older devices which are currently compatible with the messaging app.

Some users of older devices will still be able to access WhatsApp by updating to the latest software. However, for some devices, WhatsApp will become permanently inaccessible from January 1, 2021, onwards.

Dropping support for older devices is a regular exercise for WhatsApp. This time it is dropping support for any iPhone running on software older than iOS9. Users with these phones won't be able to use WhatsApp from January 1, 2021, can all be updated to iOS9, hence

The WhatsApp announcement

means that the iPhone 4 and models will not be able to access the messaging app from the beginning of next year. iPhone 4S, 5, 5S, 5C, 6 and 6S

they will be able to support WhatsApp once updated.

Android phone users have not been spared either. WhatsApp will no longer work on Android devices running on devices running Android 4.0.3 or older versions of the operating system. If users have such phones that are no longer compatible with WhatsApp then they must back up their chats before January 1, 2021, if they want to retain them.

They can do so by going to Chat backup' option under Chats section in Settings. Aside from backing up their chats, users of old devices should also start looking for smartphones that are compatible with WhatsApp if

they want to use the messaging app in the future.
