Man Charged For Duping Job Aspirant

Srinagar: The Crime Branch Kashmir on Thursday filed charge sheet against a resident of Bandipora for duping a person on the pretext of providing him a government job in the Forest Department.

The Challan in case (FIR No. 30/2019) under section 420,468 RPC was filed against the accused, Farooq Ahmad Bhat of Malangam Bandipora, before the Court of Chief Judicial Magistrate Bandipora, an official of the CBK said.

Drug Peddler Held In Budgam: Police

SRINAGAR: Police on Thursday claimed to have arrested a notorious drug peddler and recovered contraband substance from his possession in central Kashmir's Budgam district.

According to a police spokesperson, Abdul Rashid Rather of Nusrullapora was intercepted by police at a checkpoint established at Mirgund. During checking, he said, 90 grams of charas, 43 tablets of banned drugs and 2 plastic syringes were recovered from his possession.

"He has been arrested and shifted to Police Station where he remains in custody. Accordingly, a case under FIR number 471/2020 under relevant sections of law stands registered at Police Station Budgam and further investigation has been initiated," the police spokesperson said.

Jeweller Shot Dead By Gunmen In Saraibala

CRPF Officer Injured In Sangam Militant Attack

SRINAGAR: Unidentified gunmen on Thursday shot dead a jeweller in Saraibala area of this capital city, while a CRPF officer was injured in a militant attack in south Kashmir's Anantnag district, officials said.

Satpal Nischal, owner of Nischal Jewellers was shot at and critically injured by unknown gunmen inside his shop in the bustling Saraibala locality of the city on Thursday evening, officials said. The gunmen fled from the spot after leaving the jeweller in a pool of blood.

The jeweller, officials said. succumbed to his injuries on the way to Srinagar's SMHS hospital.

Medical Superintendent, SMHS, Dr Nazir Choudhary told Kashmir Observer that the jeweller was brought dead to the hospital.

"He had already passed away. He had three bullet wounds in chest," Choudhary added.

According to the reports, Satpal was currently putting up at Indira Nagar area of the city. Soon after the attack, a large

contingent of police and CRPF personnel reached Saraibala and launched search opera-

Condemning the 'cold blooded murder' of Satpal, Apni Party president Syed Mohammad Altaf Bukhari said that the culprits involved in the gruesome killing should be booked and given a stern punishment as warranted under law.

"Such inhuman and barbaric incidents are abhorred and unacceptable to any civilized society in the world and the same should be condemned by one and all," Bukari said in a statement issued here.

He also expressed solidarity with the bereaved family and prayed for eternal peace to the departed soul and courage to his family, relatives and friends to bear this irreparable

Meanwhile, minutes after Saraibala shootout, suspected militants attacked a C company of 89 battalion of the Central Reserve Police Force (CRPF) at Sangam in Anantnag district leaving an officer injured, a police official said.

The official said sub-inspector Hardayal Yadav was injured in the firing.

The government forces have cordoned off the area and launched a search operation to track down the militants, he added. (With PTI inputs)

Kashmir Reels Under Intense Cold

Srinagar Freezes At Minus the coldest recorded place in **5.9 Degree Celsius**

SRINAGAR: The cold wave sweeping Kashmir intensified on Thursday as the mercury fell several notches to settle well below the freezing point across the valley, officials said here.

Srinagar city -- the summer capital of Jammu and Kashmir -- recorded a low of minus 5.9 degrees Celsius, which was over three degrees below the previous night's minus 2.2 degrees

Gulmarg tourist destination in north Kashmir recorded 10.4 degrees Celsius as against the previous night's low of minus 11

Leh Highway Closed For Winter

SRINAGAR: The 434-km strategic Srinagar-Leh highway, connecting Ladakh region with Kashmir, has been officially closed from Friday for winter months to avoid any accident following slippery road conditions due to the freezing temperature.

"Ŵe have closed the highway from today as per orders by the Divisional Commissioner, Kashmir," police sources said Thursday.

They said the road has become very slippery particularly at Zojila, Meenmarg, Zero-Point, India Gate and other places, where mercury remains below minus during the night and sub

Shells Rain On Houses, Mosque In Tangdhar

SRINAGAR: Several houses and a mosque were damaged as India and Pakistani troops traded heavy gunfire and mortar shells along the Line of Control (LoC) in Tangdar sector of north Kashmir's Kupwara district, officials said Thursday.

Pakistani troops opened fire and shelled mortars in unprovoked violations of a ceasefire agreement along the LoC in Kupwara district, they said.

In the Tangdhar sector of Kupwara, Pakistani troops specifically targeted mosques and houses in border villages, an Army official said in Srinagar.

"Pakistan initiated an unprovoked ceasefire violation along LoC in Tangdhar Sector, Kupwara by firing mortars and other weapons yesterday evening," the official said.

According to a local news agency KNS, five houses belonging to Altaf Ahmad Tanoli, Nazir Ahmad Tanoli, Zahir Ahmad Tanoli, Nisaar Ahmad Tanooli and Imtiyaz Ahmad Tanooli, all residents of Sadhpora were damaged in the shelling. The report also claimed that a Mosque was also partially damaged in the LoC flare-up.

Meanwhile, the two armies also exchanged gunfire along the LoC in Rajouri district of Jammu division.

In the Nowshera sector of Rajouri, Pakistan Army personnel engaged in heavy firing and mortar shelling on forward posts.

3 More Corona Deaths, 227 Cases In J&K

SRINAGAR: At least three more people succumbed to coronavirus infection in Jammu and Kashmir on Thursday, while 227 fresh cases of virus, including ten security personnel were reported in the Union Territory during the last 24 hours.

Among the victims, one was from Kashmir Valley—a 70-yearold man from Lal Bazaar Srinagar while two others were from Iammu division—one each from Doda and Kathua districts respectively, officials said.

son's shifting behavior had to do with the absence of the larger familial support system."

Back in 2009, the cloth merchant had decided to walk away from

his ancestral joint family living in Downtown Srinagar's Nawab Bazar area. He had come to reside in what was then the "fad and fashionable" Hyderpora locality of Srinagar—housing nouveau riche, including officials, business class, and 'migrants' from different parts of the valley.

But in that sprawling urban neighbourhood, his son mostly grew as a captive at home.

At times, Khan's son would cry his heart out, alone, after being bullied at school. He had no shoulder to cry on, and no agency More On P8

Security forces officials said that shelling and firing by Pakistani troops was "very heavy" in 2020, virtually making the 2003 India-Pakistan border truce "redundant".

"Pakistani troops repeatedly targeted forwards posts and villages along the Line of Control (LoC) and the International Border (IB) to create a fear psychosis among the people and destabilise the peace along the borderline," a senior police officer said. (With PTI inputs)

The PDP president said the use of the ED against political opponents is not an unknown device for a party in the power at the centre. "I wish to notify you that as a responsible citizen and politician, a former chief minister and Members of Parliament, and daughter of one of the most illustrious public personalities in this country, I am ready and willing to face any questioning by any agency. But, I will insist upon the legitimacy of the process," she said.

zero during the day. The mercury would witness further drop during the coming winter days.

The Srinagar-Leh highway has been closed for winter months, DSP Traffic Rural Ganderbal, Faheem Ali told news agency KNT.

Divisional Commissioner P.K. Pole also confirmed closure of the strategic highway for winters following slippery road conditions.

"We have withdrawn all our personnel deployed on the highway between Sonamarg and Drass, on the other side of

the Zojila pass to regulate traffic," he said. Pertinently, Beacon on the intervening night of December 31, rescued 300 passengers and 106 vehicles, stuck at Zojila Pass due to the slippery road

conditions. The official said that traffic police and local administration on both sides of the Zojila had made all efforts to clear vehicles to their respective destinations before its closure. The strategic highway remains closed from about four to five months every year. Meanwhile, metrological department has predicted moderate to heavy snowfall from Monday.

Authorities across the Kashmir valley have geared up all resources to

meet any challenge following the prediction of moderate to heavy rain and snow in Kashmir.

Intense Cold Wave ...

The chances of snowfall are most frequent and maximum during this period and most areas, especially in the higher reaches, receive heavy snowfall, the officials said.

While 'Chillai-Kalan', which began on December 21, will end on January 31, the cold wave continues even after that in Kashmir with a 20-day-long 'Chillai-Khurd' (small cold) and a 10-day-long 'Chillai-Bachha' (baby cold). (PTI)

On Wednesday, a police spokesman had said that though the three killed militants "were not mentioned in our list of militants, yet two of them were hardcore associates of militants (overground workers)" and had added that of the two, one was a relative of top Hizbul Mujahideen commander Rayees Kachroo, who was killed in 2017.

He had also said that it is suspected that the third might have joined militant ranks very recently.

However, family members from south Kashmir's Pulwama and Shopian districts, during a protest in Srinagar on Wednesday had claimed that the slain youths had no connection with militancy and that two of them were students

The slain youths were Athar Mushtaq and Aijaz Maqbool, both students, and Zubair Ahmad was a carpenter, said the

On the families' claims, DGP Singh said that "about yesterday's operation, what you have referred to... parents don't know about the whereabouts of their children. The families of two slain youths claimed that their children had gone to submit forms at a university. I want to ask them what were their children were doing at the encounter site if they had gone to submit forms."

"We will look into the statements of the parents. If there is any truth in it, we will act accordingly. My initial impression of this operation is that the operation has been conducted in the right manner," he said.

The youths' families had staged the protest outside the Police Control Room (PCR) in Srinagar, stating that their "wards were not militants but students." PTI

Giving district wise details, the officials said that Srinagar reported 51, Baramulla 16, Budgam 11, Kupwara 12, Pulwama 19, Anantnag 10, Bandipora 2, Ganderbal 7, Kulgam 4, Jammu 70, Udhampur 3, Rajouri 5, Doda 1, Kathua 10, Kishtwar 1, Samba 3, Poonch 1 and Ramban 1 new case of coronavirus.

The government orders follow reprimand by the high court earlier this year, saying that adhocism is resorted to despite depreciated by the Supreme Court way back in 2000.

"What is seen in the then State of J&K and now the Union Territory of J&K is that the judgment of the Supreme Court is being complied with less and violated more, as practically in all the departments, promotions are being made on incharge basis," the court had said, adding, "This practice is prevalent more in Engineering Department. The reasons therefore are not unknown."

How an employee, who is substantively working on the lowest post, can be given the charge of a highest post in the department without there being regular promotions, the court had questioned. "No one knows their seniority position.

It is the local adjustment made claiming that he is senior most available and there being a vacancy, he should be given charge of that," the court had said, stressing that these employees continue working on that post for years together and whenever any transfer is sought to be made, they approach the court and persuade to grant interim relief and as a result of that, continue on the same position for years together.

"This course adopted by the different departments is generating avoidable litigation as many of the employees approach the court raising the plea that they are senior to the person who has been given charge of some higher post," the court said, adding, "Not only this such a course also demoralizes other employees in the department. This is resulting in adhocism in the working of different departments of the government." The court had said that the Supreme Court in 2000 ordered the constitution of a High Level Committee to be appointed to examine the entire issue. (GNS)

'225 Militants ...

Addressing the annual press conference of Jammu and Kashmir Police, Singh said, "We undertook over 100 successful operations in J&K. Ninety operations took place in Kashmir and 13 in Jammu. As many as 225 militants were killed -- 207 in Kashmir and 18 in Iammu division."

He said that among the slain militants, 47 were top commanders belonging to various outfits. "Today, all top commanders of various outfits have been eliminated," he added.

The DGP said 16 Jammu and Kashmir Police personnel -- 15 in Kashmir and one in Jammu -- and 44 security personnel -- 42 in Kashmir and two in Jammu -- were killed while fighting militancy this year.

Singh said that police and security agencies have cracked down on overground workers (OGWs) of militant outfits, who throw grenades or work as messengers and couriers.

"As many as 635 OGWs were arrested and 56 out of them were booked under the Public Safety Act (PSA)," he said.

During the year, 299 militants and their associates were arrested and 12 militants surrendered, he said. The police chief said that 426 weap-

ons, over 9,000 ammunition and magazines, and a huge cache of explosive material were recovered and seized during anti-militancy operations. There has been a decrease in the

number of civilian killings this year. "As many as 38 civilians were killed this year as compared to 44 last year,' Singh said.

He, however, said that there has been a slight increase in militant recruitment this year as compared to last year. "But 70 per cent of them have either been eliminated or have left militant outfits and returned. As many as 46 militants have been arrested and 76 have been killed (among new recruits). Their shelf life is very less," the DGP said.

He said that there is a large scale decrease in the level of infiltrations this year. Due to the strong anti-infiltration grid, the infiltration is down, he said.

Singh said that Pakistan is trying to increase the arch of militancy Jammu region and foment communal trouble here.

"There were a dozen militants active in the Jammu region, the number has reduced to three now. They are in Kishtwar district, we are tracking them." Singh said.

The police chief further said that despite several attempts by Pakistan, cases of infiltration this year is the lowest in the last three-four years.

"So. they (Pakistan) had to rely on local recruits and they tried to supply weapons, explosive materials and cash to them through drones, most of these were foiled," he said.

"The best thing is that the trend of local youths joining militant groups is constantly decreasing," he added.

Monolith surfaces in Ahmedabad, but sans mystery

Ahmedabad, Dec 31 (PTI) A 'monolith', the likes of which have appeared and vanished in different parts of the world since November, has now emerged in a garden in Ahmedabad city, Gujarat. This is the first appearance of a monolith, a structure made of shiny steel sheets, in India. However, unlike in other parts of the world, the mystery around the object did not last long as it was disclosed that a private company has installed it.

The triangular prism-shaped structure, around seven feet tall, became a hit among city dwellers after it was spotted in a garden on SG Highway on Thursday morning.
The garden is jointly managed by the

Ahmedabad Municipal Corporation and Symphony Ltd. Situated near Gurudwara in Thaltej area, it was one of the attractions inaugurated by Chief Minister Vijay Rupani recently "The monolith has been placed there by the Symphony Ltd which takes care of the garden. The structure has been installed by the company for the visitors. People can see their reflection on the shiny surfaces of the structure and take selfies too," said Director, AMC's Garden Department, Jignesh Patel.
The first such three-sided steel monolith

appeared and disappeared after a few days in a remote desert of Utah, United States. Later, similar structures were spotted in around 30 countries.

The monolith was installed at Symphony Forest Park on December 29, but it gained popularity on Thursday with people flocking

Apparently to keep mystery alive, the company did not make any announcement except sharing some photos of the structure on the Forest Park's Facebook page on December 29.

"This is really amazing that the monolith actually appeared in our city. Since these structures tend to disappear in some time, I have come here with my friends to click selfies," said one youngster.

CBSE board exams from May 4 to June 10 next year, results by July 15: Education Minister

New Delhi, Dec 31 (PTI) The Central Board of Secondary Education (CBSE) will conduct board exams for classes 10 and 12 physically from May 4 to June 10 next year, Union Minister of Education Ramesh Pokhriyal 'Nishank' announced on Thursday. Practical examinations will be conducted by schools from March 1. The results of the board exams will be announced by July 15, he added. Salahuddin Wants All 7 in Pak

Hizb Cautions APHC Of Trap

MUZAFFARABAD -The Hizbul Mujahideen group has maintained that the proposed visit of the All Parties Hurriyet Conference leaders to Pakistan to prove an "exercise in futility" if all the seven member of alliance's executive council were not included in the delegation.

"If some (leaders) are allowed and some are barred from travelling to Pakistan), Nit will create doubts about the APHC. Rather, it can create an impression that the alliance is divided into moderate and extremist people," said group's supreme commander Syed Saiahuddin, in an interview to Dawn.

He said, it would be New Delhi's big trap to create misgivings and strengthen the impression about division in the ranks of the APHC. The APHC leaders must show farsightedness and diplomatic efficiency to send the impression that New Delhi and not they themselves are constituting their delegation for Pakistan" Salahuddin's remarks came in the wake of reports that the travelling documents to Syed Ali Shah Geelani, a hard-liner in the alliance, were not being issued by New Delhi.

Indian officials had claimed that they had not received the application of Mr Gilani for the same. A Hurriyet leader, Abdul Ghani Lone, rejected the claim as lie and told an Indian channel that he had himself submitted Gilani's papers. I will advise the (APHC) leaders to avoid visit to Pakistan unless all of them are allowed to travel. And if all of them get permission, then they should first sit together and evolve an agenda in consensus with each other for the tour."

Salahuddin said Pakistan was already on the back of the Kashmiris and had been extending all out political, moral and diplomatic support to them all along the past 53 years of their struggle. But the thing that needs to be settled with New Delhi is how sincere and serious she is in resolving the festering issue, he added "If the APHC does not get any assurance from the Indian government before hand then their journey will prove an exercise in futility," the Hizb supremo said.

Mr Salahuddin recalled that the Hizbul Mujahideen and all other freedom fighting organizations had unanimously termed the cease-fire a "trap" and said it was aimed at releasing pressure and giving a respite to the physically and mentally exhausted Indian troops besides winning the sympathies of the Muslims in India and elsewhere.

On the one hand it (Indian government) paints itself a champion of peace and on the other hand there is no letup in killings and atrocities at the hands of its' soldiers in Kashmir, he added.

"We believe the APHC cannot suggest the mujahideen to respect the so-called cease-fire because it does not have any mandate for that," he said, and added that the cease-fire was worthless unless India made a categorical declaration that "Kashmir is a disputed territory and she is ready to resolve it through meaningful tripartite talks. Till that happens, the operations of the mujahideen against the occupation forces would continue. Rather we would intensify and stretch them," he declared.

He said, the cease-fire was not a pre-requisite for the resolution of the issue through meaningful talks. In this connection, the Hizb chief cited the examples of Afghanistan Northern Ireland and Vietnam where, according to him, talks and militancy ran simultaneously. "Dialogue is a separate process and (freedom fighters') actions are a separate thing, 'he said.

He said the mujahideen were not interested in holding talks by themselves. But, he added, they (the mujahideen) wanted to ensure that the negotiators (from the Kashmiris' side) must enjoy their trust, "The negotiators stand should reflect the aspirations of the people of Kashmir. They would not be allowed to take any short cut," said the Hizb supremo, without elaborating.

He was of the view that the mujahideen who in fact were offering their blood in the battlefield had full rights to "monitor" the talks. "We have trust in the recognized leadership of Kashmir but the people who shed their blood have right to hold talks either by themselves or through any other person(s).

Hokersar killings

ours after security forces claimed to have killed three militants near Hokersar on the outskirts of Srinagar on Wednesday, the families of those killed alleged that the slain youth were not militants. The families who protested outside the police control room said the youth had left home just a day before the encounter. Two of the three, according to them, were students who had come to Srinagar for admission in an institution. The development has come as a throwback to the aftermath of the encounter at Amshipora in Shopian three months ago, where also the security forces had claimed to have killed three militants but who later turned out to be innocent labourers when their families protested. However in case of Hokersar encounter, the Army is holding its ground saying the three youth were militants and were planning a big attack along Srinagar-Baramulla highway. Similarly police has said that although the three youth were not listed as militants in police records, they were part of the militancy. So far no probe has been initiated into the incident as demanded by National Conference and the PDP. After the families had cast doubt about the identity of the youth killed in the encounter, the probe was in order.

That said, the killing of three more youth, one of them studying in Class 11 is tragic. Such killings have become a routine affair in the Valley, almost being pursued for their own sake. There's now no effort to address this hopeless state of affairs. The central government has long given up on a political outreach to the Valley. Under Lieutenant Governor's rule, the security agencies are in the thick of an all-out operation against militancy. The objective of the campaign is to eliminate insurgency by attempting to kill all the militants within a specific timeframe. Viewed from that perspective, the security agencies have been exceptionally successful over the last several years. An average of over 200 militants have been killed every year. It is expected that the killings of the militants at this rate could drastically reduce their number. This, in turn, is expected to alter the political dynamics in the Valley and usher in peace. But the deeper factors underpinning the current state of affairs will linger on and can be expected to create conditions for yet another phase of violence and unrest. This has been the case over the past three decades. The militancy has gone through its crests and troughs but never been wiped out.

What does the near future, therefore, hold for Kashmir? A lingering uncertainty. Security experts hope that should the current uptick in the killings continue, they would have substantially reigned in the militancy in a given time period. But killings have hardly been a deterrent in the Valley. Though local recruitment could be expected to dwindle somewhat, it is unlikely to stop. And for that to happen, Centre will have to reach out.. But is New Delhi even interested in such an approach? It isn't. Kashmir needs a drastic shift in mindset in New Delhi about Kashmir. One hopes such realization dawns sooner than later.

Vaccine Rollout Lessons

In the fortnight between December 14, when the first American received a coronavirus vaccine, and December 29, the United States vaccinated 2.13 million people. The country has done more vaccinations than any other across the world, and its tally represented close to 50% of the inoculations carried out globally till Tuesday. In itself, reaching 2.13 million people over 14 days is not a small order – but it is one that falls short of expectations. American authorities expected to vaccinate 20 million people by the end of 2020. Instead, rollout has been hobbled by time lost in quality checks, managing vaccination reporting tools and planning distribution flows.

The first month of vaccine rollout has not been smooth elsewhere too. In Germany, delays were reported at several sites after temperature logs showed some of the vaccine boxes did not maintain the temperatures required for the Pfizer-BioNTech dose – potentially damaging stocks. In Canada, which approved two vaccines, supplies came in a slow trickle. In the United Kingdom, where Pfizer estimated four million doses were made available, only 800,000 have been administered. Teething troubles are not uncommon in any exercise with such a number of moving parts — the factory-to-syringe process includes a range of people and modes of transportation — but they can be costly

at a time when we are racing against the pandemic. These experiences hold important lessons for India. The country did well to begin mock drills, giving its digital management platform as well as human resource training an early shakedown. The exercise covered seven districts in four states and exposed crucial areas that need improvement well in time. But, in a country over 1.3 billion people, such dry runs must quickly be replicated in more districts. Officials must look at the experiences in other countries and keep open the scope to tweak or overhaul protocols, including how India selects and prioritises the groups of people who are first in line for a dose. Just like its early legwork on the delivery side, the government must now intensify efforts to ensure supplies by announcing its first purchase deals. Regulatory processes are expected to reach crucial breakthroughs shortly (a key meeting was scheduled for Wednesday afternoon), which should give the government the confidence to commit to purchases.

inters are at its peak in the northern region of India and the effects of climate change are being felt in the mountains too. According to an International study (Importance and vulnerability of the world's water towers - published on December 09, 2019), 1.9 million people are at risk of water supply problems as mountain glaciers, snow-packs and alpine lakes are run down by global heating and rising demand. As a result, in northern India, falling snow levels and glacial retreat is impacting livelihoods and access to water.

As per NITI Aayog's working group on "Inventory and Revival of Springs of Himalaya for Water Security" report of August 2018, half of the mountain springs in the Himalayan region are drying up. "Nearly 60% of low-discharge springs that provided water to small habitations in the Himalayan region have reported a clear decline during the last couple of decades,".

Over a billion people across Asia rely on Himalayan water. There are five million springs in India, of which close to three million are in the Indian Himalayan Region - which is spread across 12 states and is home to over 50 million people. These springs are the primary source of water for rural households in the region and, for many, the only source. A number of urban communities too depend on these water bodies. The drying up of springs will affect the flow of these rivers. The drying springs will further add to the work hurden of wom en since they are forced to manually carry water from springs below their village during the lean season. Destinations such as Shimla, Mussorie, Nainital and even Gangtok often face acute water crisis.

acute water crisis.

Indus is the most important and vulnerable "water zone" due to runoff from the Karakoram, Hindu Kush, Ladakh, and Himalayan mountain ranges, which flow downstream to a densely populated and intensively irrigated basin in Pakistan, India, China and Afghanistan.

Recently, International Union for Conservation of Nature (IUCN), a membership Union composed of both government and civil society organisations, has taken an initiative to promote the significance of springs in the Indian Himalayan Region and undertook pilot to recharge and revive springs with the technical support of CHIRAG (rural development organization based in the Kumaun region of Uttarakhand in India) under the National Mission of Himalayan Studies (NMHS) supported project entitled 'Coping with Uncertainties: Building Community Resilience and Ecosystem Based Adaptation to Climate Change in the Indian Himalayan Region'.

Recent decades have seen a drastic decline in snowfall, with glaciers across the Himalayas losing a total of 8 billion tons of ice every year. The ice on the mountain is getting smaller and summers are getting longer. There is less water.

Reduced snowfall and receding glaciers are a phenomenon impacting the whole of the Hindu Kush Himalayan region. A recent report of June 14, 2019 from the Intergovernmental Panel on Climate Change (IPCC) projects that in lower altitude mountainous regions such as Spiti. "glaciers will lose more than 80% of their current mass by 2100." The report further predicted that even if global warming is limited to 1.5 degrees Celsius above pre-industrial levels as set out in the Paris Agreement, over one-third of glacial ice in the region will have disappeared by the end of the century, with the most negative scenarios in the eastern Himalaya pointing towards a near-total loss of glaciers.

In Ladakh, water shortages have already caused a few villages to migrate. The inhabitants of Kumik in Zanskar were forced to relocate in 2014 after the river which they depended on for water dried up. Agriculture is the main source of income here and If the situation continues then yes, there would be villages which would migrate out. The only temporary solution is pumping up river water and preventing run-off, however, it might not be a sustainable solution.

Shimla, the capital and the largest city in Himachal Pradesh and a tourist haven, is facing a water crisis of gigantic proportions. The crisis is especially acute in towns that bear the strength of summer tourist traffic, as well as towns that are in the path of religious pilgrimages and tourism. What used to be difficult to access locations are much easier to get to, and most of the existing infrastructure is not adequate to cope with this demand.

A new study by `Springer Nature' on August 24, 2020, has revealed that glaciers in Kashmir have receded by 28 percent in the last four decades. The study used a series of satellite images (1980-2018) to determine the glacier health, which is critical for nurturing and sustaining the rivers that originate from the area. It has been found that glaciers have reduced from 101.73 km square in 1980 to 72.41 km square in 2018 showing a recession of about 28% during the last four decades. The findings of the study indicated that there is a strong influence on altitude, aspect, slope, and climate on glacier recession in the Kashmir Himalaya.

So, if the shrinking of glaciers continues in the future, it will adversely affect the availability of water in the valley, especially during the summers.

As far as government's effort is concerned, in 2014, the National Mission for Sustaining the Himalayan Eco-System, under India's National Action Plan on Climate Change, had suggested a state-wide programme for rejuvenation of Himalayan springs and protection of high-altitude lakes. It had also suggested creating an inventory of mountain springs—active and dormant—along with detailed geological mapping to identify the spring recharge zone.

"Pani Pahar- Waters of the Himalayas", a collaborative research project and a curriculum has also been initiated between the University of Cambridge, The Centre for Ecology Development and Research in India (CEDAR) and South Asia Institute for Advanced Studies in Nepal (SIAS) for for students and teachers across India. This collaborative project explores the changing landscapes and escalating water crises of the Indian Himalayas.

The curriculum will help students understand water resources, sustainability, and how these are affected by climate change. The lessons have been planned in a way to help students reflect on and research the human causes of water scarcity and effects of environmental change of humans and our shared resources.

So, I personally feel that it is high time that these issues be communicated more widely. The broad objective should be to depict water through the landscape, from source to tap, and the really different communities that come into contact with it, take from it and modify it, in order to bring attention to long-term questions around the sustainability of water sources and their use in the Himalayas.

Remember, successful solutions almost always derive through community participation and stakeholder engagement. Solutions that come from a community perspective, for example, rejuvenation of springs (where communities are using some of their knowledge and coming together to do something collectively), always work.

Thus, Himalayan region has the diversity of these very productive natural landscapes. But if managed badly, they can become a curse.

Largest Study Of Asia's Rivers May Help Predict Changes In Region's Water Cycle: Scientists

the past have often simultaneously hit sites that are currently home to power production along Asian rivers, says the largest study of the continent's river systems which may help predict long term changes in the region's

The study, published in the journal Water Resources Research, noted that the findings have important implications for water management and power production, especially when a country's economy depends on multiple river basins

"Our records show that 'mega-droughts' have hit multiple power production sites simultaneously, so we can now use this information to design a grid that is less vulnerable during extreme events," said study co-author Stefano Galelli from Singapore University of Technology and Design (SUTD).

According to the research, rivers in Asia behave in a coherent pattern, with droughts stretching as far as from the Godavari in India to the Mekong in Southeast Asia, explained study first author Nguyen Tan Thai Hung from SUTD.

As the region is home to many populous river basins which provide water, energy, and food for more than three billion people, the scientists said it is crucial to understand past climate patterns in the Asian Monsoon region to better predict long term changes in the water cycle and its

impact on the water supply.

Following two years of analysing tree rings to reconstruct the courses of streams in the continent, the scientists produced data on 813 years (from 1200 to 2012) of annual river discharge at 62 stations in 41 rivers flowing through 16 countries, including India.

The researchers also obtained data from a previously published study of an extensive network of tree ring data sites in Asia and prehistoric drought record called the Monsoon Asia Drought Atlas (MADA).


Based on an analysis of the underlying tree ring data, the scientists extracted the most important climate signals that influence river discharge in the continent.

While earlier research had already found that droughts in Asian rivers are influenced by temperatures of the Pacific, Indian, and Atlantic Oceans, the new study revealed that this ocean-river connection is not constant over time.

According to the researchers, rivers in Asia were much less influenced by the oceans in the first half of the 20th century compared to the 50 years before. and 50 years after that period.

"This research is of great importance to policymakers -- we need to know where and why river discharge changed during the past millennium to make big decisions on waterdependent infrastructure." Galelli added.

New Research May Explain Severe Virus Attacks On Lungs

n some cases, immune cells in the lungs can contribute to worsening a virus attack. In a new study, researchers at Karolinska Institutet in Sweden describe how different kinds of immune cells, called macrophages, develop in the lungs and which of them may be behind severe lung diseases.

The study, which was published in Immunity, may contribute to future treatments for COVID-19, among other diseases.

The structure of the lungs exposes them to viruses and bacteria from both the air and the blood. Macrophages are immune cells that, among other things, protect the lungs from such attacks. But under certain conditions, lung macrophages can also contribute to severe lung diseases, such as chronic obstructive pulmonary disease (COPD) and COVID-19.

opment of human lung macrophages has been limited.

Macrophages can have different origins and develop, among other things, from white blood cells, monocytes, that are divided into different genetically determined main types. In humans, two of these are "classical" CD14+ monocytes and "non-classical" CD16+ monocytes.

In a new study at Karolinska Institutet, researchers have used a model to study the development of lung macrophages directly in a living lung. This has been combined with a method to study gene activity in individual cells, RNA sequencing, and thereby discovered how blood monocytes become human lung macrophages.

"In our study, we show that classical monocytes migrate into airways and lung tissue and are converted into macrophages that protect the health and function of the lungs. We have also identified a special kind of monocyte, HLA-DRhi,



which is an intermediate immune cell between a blood monocyte and an airway macrophage. These HLA-DRhi monocytes can leave the blood circulation and migrate into the lung tissue." says Tim Willinger, Associate Professor at the Department of Medicine, Huddinge, Karolinska Institutet, who led the study

The non-classical monocytes, however, develop into macrophages in the many blood vessels of the lungs and do not migrate into the lung tissue.

"Certain macrophages in the lungs probably have a connection to a number of severe lung diseases. In respiratory infections, for example, monocytes in the lungs develop into macrophages, which combat viruses and bacteria. But a certain type of macrophage may also contribute to severe inflammation and infections," says the study's first author Elza Evren, a doctoral student in Tim Willinger's research team.

In infection with the novel coro-

navirus, SARS-COV-2, which causes COVID-19, researchers believe that protective, anti-inflammatory macrophages are replaced by pro-inflammatory lung macrophages from blood monocytes.

"The existence of these blood monocyte-derived macrophages has been shown in other studies to correlate with how severely ill a person becomes in COVID-19 and how extensive the damage to the lungs is. Patients with severe COVID-19 also have fewer HLA-DRhi monocytes in their blood, probably because they move away from the blood into the lungs. Given their important role in rapid inflammatory responses, our results indicate that future treatments should focus on inflammatory macrophages and monocytes to reduce lung damage and mortality from severe COVID-19." says Tim Willinger.

Scientists Explore Deficits In Processing Speed In Individuals With Spinal Cord Injury

team of rehabilitation researchers has studied processing speed deficits in individuals with spinal cord injury (SCI). They found that the SCI group and older controls had similar activation patterns, but the SCI group differed significantly from their age-matched controls.

The scientists have compared SCI patients and their brain activation patterns with those of healthy agematched controls, and older healthy individuals.

The article, 'The neural mechanisms underlying processing speed deficits in individuals who have sustained a spinal cord injury: A pilot study' was published by Brain Topography. The authors are scientists with expertise in research in cognitive rehabilitation and SCI rehabilitation: Glenn Wylie, DPhil, Nancy D. Chiaravalloti, PhD, Erica Weber, PhD, Helen Genova, PhD, and Trevor Dyson-Hudson, MD, from Kessler Foundation, and Jill M. Wecht, EdD, from the James J. Peters VA Medical Center.

Individuals with chronic SCI have an increased risk for cognitive deficits that resemble the deficits associated with the aging process, giving rise to the theory of accelerated cognitive aging by this team, the deficits affect processing speed, new learning and memory, and verbal fluency, which are the domains affected during aging. This study is the first to examine the neural mechanisms of higher order cognitive tasks of individuals with SCI. The focus was on processing speed, which is known to be affected by SCI and aging, and is integral to cognitive function and everyday life activities.

The 30 participants were participants of a larger

study who underwent optional neuroimaging studies at the Rocco Ortenzio Neuroimaging Center at Kessler Foundation -- 10 individuals with cervical SCI, 10 age-matched controls, and 10 healthy older individuals. In addition to traditional neuropsychological testing methods, processing speed was tested in the scanner, using timed letter comparison tasks during functional magnetic resonance imaging (fMRI). This study was the first to use the modified letter comparison test.

Significant differences in brain activation were found between the SCI group and the age-matched control group, but the SCI and older groups had similar patterns, including activation of the hippocampal, frontal and parietal areas. "This suggests that individuals with SCI are compensating for deficits in processing speed by relying on the areas of the brain involved in executive control and memory," noted Dr. Chiaravalloti, "which supports the theory of accelerated brain aging after SCL.

Despite the limitations of sample size and level of injury, the study is an important contribution to our understanding of the impact of SCI on cognition, according to Dr. Wylie, director of the Ortenzio Center, "Our abil ity to observe brain activation while the individual performs specific cognitive tasks provides new information on the mechanisms that underlie the cognitive deficits that we now know affect a substantial proportion of the SCI population," Dr. Wylie said. "Developing treatments targeted to these deficits depends on our pursuit of this line of research, which may benefit other populations affected by delayed processing speed."

PESHAWAR, PAKISTAN: At least temple and the tomb of the two dozen people, including several Muslim clerics, were detained Thursday after a mob attacked and set fire to a Hindu temple in northwest Pakistan, police said.

temple -- which was destroyed in similar circumstances in 1997 -- after staging a protest against renovations at an adjoining building owned by Hindus.

The temple is located in a remote village in Karak district, some 160 kilometres (100 miles) southeast of Peshawar.

"We have arrested 26 people including local clerics for destroying a place of worship and inciting people to riot", local police official Fazal Sher told AFP.

He added police were looking for a further 50 people identified from videos of the attack.

Discrimination and violence against religious minorities are commonplace in Pakistan, where Muslims make up 97 per cent of the population and Hindus around two percent.

Irfanullah Khan, the district police chief, also confirmed the arrests.

He told AFP that a house adjacent to the temple was recently bought by the Hindu community and was being renovated, which offended locals.

China Deploying "En Masse" Underwater

Drones In Indian Ocean: Report Agencies

NEW JERSEY: China has deployed a fleet of underwater drones called Sea Wing (Haiyi) glider in the Indian Ocean, which can operate for months on end and make observations for naval intelligence purposes, according to defence analyst HI Sutton.

Writing for the Forbes ma zine, HI Sutton said that these sea gliders, which the Chinese are deploying "en masse", are a type of Uncrewed Underwater Vehicle (UUV) which were launched in mid-December 2019 and recovered in February after making over 3,400 observations.

Citing the government sources, HI Sutton in his report said that these gliders are similar to those deployed by the US Navy, one of which was seized by Beijing in 2016 to ensure "safe navigation of passing ships."

PARIS: The father of British Prime Minister Boris Johnson said on Thursday he was in the process of applying for a French passport to maintain his ties with the European Union after Brexit.

Stanley Johnson, a former member of the European Parliament who voted Remain in Britain's 2016 referendum, told RTL radio he wanted to become a French citizen because of strong family links to France.

"If I understand it correctly, I am French. My mother was born in France, her mother was totally French as was her grandfather. So for me it is about reclaiming what I already have. And that makes me very hap-



speaking in French.

"I will always be a European, that's for py," said the 80-year-old Johnson, who was sure. One cannot tell the British people: you

are not Europeans. Having a tie with the European Union is important," he added.

Former Umpires Sue ECB Over **Alleged Racial Discrimination**

LONDON: The England and Wales Cricket Board (ECB) has been sued by former umpires John Holder and Ismail Dawood for alleged racial discrimination during their time in the board's employment, a report said.

The duo had accused the ECB of insitutional racism and demanded an independent inquiry into the lack of match officials from ethnic minority groups in the country last month.

"Holder lodged his claim at the London central office of the employment tribunal two days before Christmas," according to a report in 'The Guardian'.

A former Hampshire cricketer, Holder has officiated in 11 Tests and 19 ODIs in a career spanning almost three decades. "The legal action against the ECB relates to his employment as a first class umpire between

"Holder was dropped from the ECB's Test match list in 1991, were all of a sound manner and

Holder and former U-19 cricketer Dawood "are seeking compensation and a recommendation on the ECB's future conduct under s.123 (3) (b) of the 2010 Equality Act." Dawood, who has played

"As I could see it, my son had become cheerless and withdrawn. Those signs worried me. As someone who grew up in the harshest lockdown of nineties. I never had these issues."

But then, unlike his kid, Khan was living in a packed house where everyone his uncles, aunts and cousins-would share each other's sorrows and joys.

In that amiable setup, Khan always had a shoulder to cry on and agency to share his anguish with. That empathetic joint family system of Kashmir has since then disintegrated into now normalized nuclear families.

"In most of these homes, children are left at the mercy of caretakers, as many working parents don't have much time to attend to them," says Salika Hameed, a sociology teacher from Sopore.

"Even in countryside, nuclear homes have multiplied now, and with them. the growing social seclusion has come to haunt children."

In Srinagar, Malik Siraj happens to be an avid scholar studying the behaviour changes in kids. His previous findings make one believe that children from nuclear families are more vulnerable to delinquency, drug abuse and dependency personality.

"Let's understand this fix with a simple example," Siraj, an eloquent scholar, tries to explain the nuclear family impact on children. "In the name of freedom, when you leave your kid behind four-walls, it grooms him in a different manner. It makes him sullen, sad and sentimental. So freedom, in this case, comes with the fear of deviation and unregulated behaviour."

But in the joint family system, the core family values and ethics would act as behavior filters, the scholar says, and groom children for "Do's and Don'ts" in life.

"Contemporary Kashmir might claim to be progressive in life, but we are only becoming digital-driven cavemen in reality," Siraj says with a smirk. "In the name of privacy, we are simply raising kids bereft of street logic and larger identity consciousness. Even if many of these kids turn out to be sharp and smart later on, but what about the silent majority grappling with the nuclear family complexities?"

In fact, he says, raising kids by feeding them YouTube cartoons right from childhood can give parents some moments

only makes children oblivious of the real world in the long run.

The immediate upshot of such 'private parenting', as Siraj calls it, is the mush-rooming of half-baked behavioral beings—who often find themselves at the crossroads in their careers and lives.

"On the contrary, children from joint "I never bothered about his behav- families grew up as sharp and directional many Indian journals, Amin has adopted search. "They may not always be prospering professionals, but they mostly are sound personalities, street-smart and crisis managers."

But, he rues, such is not the case with the children of nuclear families.

"They are being raised as some factory-line products, wherein thrust is given on their careers rather than their cultural values," Siraj says. "And this is the reason why most of them remain oblivious of their roots and cultural moorings."

Siraj's words find resonance with the case of Misbah Hameed.

For most of her life, Misbah couldn't know her cousins and uncles. Given her father's bent for seclusion way of life, this commerce graduate grew up as aloof and "Life has always been about books and

grades," Misbah, an introvert girl, says. "After living a withdrawn life from my large clan, I'm not able to relate with my aunts and cousins now, especially during those special family occasions." Such cases don't surprise someone

like Mohsin Mehraj, who's doing his research on the impact of nuclear families in Kashmiri society. "Most of the kids from these fami-

lies don't relate with the larger society," Mehraj says. "They live in a manicured setup where their worldview is shaped through a selective caretaking and grooming process."

To further understand the impact of such family setups on Kashmiri children. I met Saima Mufti, a social-care professional working on the child and women welfare issues.

"The celebrated hospitality trait in Kashmiris was there for a reason," Mufti told me in her Srinagar office.

"Most of us would watch each other's back in the joint family. We always had someone to counsel and correct us. This would create a compassionate ecosystem in our homes.

"But now, we don't have many people to rely on in the nuclear families fighting their own demons today. I think that's the reason why sense of care and compassion is faltering today."

Even scholars and sociologists say that joint Kashmiri families were more resil-

"Many big families in Kashmir take pride in the fact that they could exist due to joint family culture during the harsh-

report his case-after his parents, one of respite, but this "mindless parenting" est periods of persecution, poverty and plagues," Irtiza Amin, a sociology lecturer from Anantnag, says.

"Besides grooming young lots for tackling the emergency situations in their homeland, these joint families would serve as the primary learning centres for

In her research papers published in the chronological phases of family research in Kashmir as the mode of presentation. She attributes fast disintegration of the social setup in Kashmir to the blind pursuit for nuclear families in the name of "seeking privacy and staying away from the so-called prying eyes in the joint setups".

But unlike the larger Indian society, where family plurality has been an essential feature, Kashmiri, she argues, had a strong sense of shared family values.

"For the region infested with the foreign domination throughout its history, the natives had a strong sense of togetherness," Amin says.

"So, in a way, Kashmiri households were the mini-resilient fronts against the enforced offensive in their backvard from time to time.'

While much of that shared spirit has waned now, many don't seem to complain as they call it the need of the hour. When Hilal Dagga started living with his wife and two children in a separate house

in Srinagar's Habak area some decade back,

he says, he finally breathed easy. Before that, he had lived forty years of his life in his ancestral house shared by his three other siblings along with their

own families. "In think there comes a time when even cavemen move out of their cave in search of a better space and shelter," Dagga, a government official, says. "And I don't think it creates any different in children's lives and mindsets. Change has to

happen and that's how we grow in life." Seconding Dagga, Rifat Altaf argues that nuclear families are better childcare units.

"There aren't much hassles and interventions in nuclear families," Rifat, a nurse by profession, says. "Children from such families are more focused, ambitious and practical. Had it been such a problematic thing to have a nuclear family setup, then westerners wouldn't have let their children to live their own lives after they turn 18. This practical approach of life is the reason why they're progressing in every sphere of life."

But then, many say, such societies have their own depravities and underbellies, too. Among them is Mushtaq Khan, the cloth merchant of Hyderpora.

"This Covid lockdown might have created havoc in the world, but for me, it has come as a blessing in disguise," Khan says. "It has made me better father, who's aware of his child's needs today."
