Budgam Scholar Dies Of Cardiac Arrest

Srinagar: A PhD scholar died of a cardiac arrest on Tuesday in central Kashmir's Budgam district. Shakeel Ahmad Dar, a resident of Wathoora village suffered a massive cardiac arrest on Tuesday morning at his home, news agency KDC reported. He was immediately rushed to the nearby hospital where doctors declared him brought dead. Shakeel had completed his PhD from SKUAST University.

Hunter Injured As Gun Goes Off

Srinagar: A hunter was injured on Tuesday when his gun went off accidentally in Ganderbal district of central Kashmir. 33-year-old Gulzar Ahmed Gaabru was hunting in Rabitar area of the district on Tuesday when his 12 bore file accidentally went off leaving him injured, police sources said. The injured hunter was removed to district hospital Ganderbal for treatment. However, the doctors there referred him to Srinagar's SKIMS for specialised treatment. Heavy Snowfall Batters Kashmir

Major Roads And Highways Closed, Air Traffic Suspended; Avalanche Alert Renewed

SRINAGAR: Several residential houses were damaged as Kashmir valley witnessed widespread snowfall for the third straight day Tuesday, bringing normal life to a grinding halt.

Nearly 4500 vehicles, mostly trucks carrying essentials to the valley, are stranded along the highway at various places.

The Jammu-Srinagar National Highway is closed due to accumulation of snow at many places, especially around Jawahar Tunnel," an official of the traffic control department said.

He said snow clearance operations were in full swing and efforts were on to restore movement of stranded vehicles along the 260 kilometre road.

Mughal Road, which connects the valley to Jammu division through Shopian-Rajouri axis, has been closed for several days due to heavy snowfall in the region.

The flight operations to and from Srinagar remained suspended for third consecutive day, the officials said.

They said that no flight could take off or arrive at the Srinagar international airport due to poor visibility.

The airlines have already cancelled or rescheduled the flights and as per the officials, it was highly unlikely for any operation to take place at the airport in wake of the snowfall.

The officials said south Kashmir's Kulgam district received highest snowfall with three to four feet of snow accumulated at some places. Anantnag district has also re-

ceived heavy snowfall, they said. The officials said that Srinagar received 8cms of snowfall in the last 24 hours till 0830 hours while Qazigund, the gateway town of Kashmir, recorded the highest depth in the plains across Valley—29.8cms—during the time and 80cms (32inches)

Shopian Woman Delivers Baby On Stretcher

SRINAGAR: Contrary to the claims of government that they were fully prepared to meet any challenge arising out of the heavy snowfall, a pregnant woman on Tuesday delivered a baby on a make-shift stretcher before she could be taken to a hospital in the snowbound Keller belt of south Kashmir's Shopian district.

Akhter Jan, wife of Papa Poswal of Zrakan Keller gave birth to a baby on a make-shift stretcher as the villagers were carrying her to a hospital for delivery, news agency KNO reported Tuesday. The villagers, the report said, were carrying the woman on cot amidst the heavy snowfall as the roads blocked by the snow were not cleared.

"The lady developed labour pain following which the locals put efforts to shift her to SDH Keller, which is around 10 km from Zrakan village," Choudhary Showkat Shabir, a local said.

"However, before she could be taken to the hospital, the woman delivered on a make-shift stretcher. The condition of both baby and mother is stable at SDH Keller," he added.

500-Year-Old Spade Still Calling A Spade In Snowbound Kashmir

s snowfall began blanketing Budgam's Mujhpathri area on January 3, Chowdhary Manzoor came out with a unique and rustic wooden spade locally called "Fueh" to clear paths.

With an imposing figure, Manzoor stood in the backdrop of mounds of snow holding his ancestral article with pride.

"This is how my forefathers would come out and clear paths during the harshest winters in Kashmir." said Manzoor, holding the legacy spade in his hand. "This exceptional piece has witnessed vagaries of weather

and is still working just fine."

Every winter as it snows, Manzoor uses his inherited shovel only for emotional means to clear snow. "I feel the presence of my father

while using it," he said. "It seems as if he is just observing me from behind." Once done with snow-clearance, Manzoor properly cleans the spade, before putting it back in the

room filled with his family relics. Manzoor received this antique spade from his father, late Mohammad Shafi Chowdhary, who had inherited it from his father, Lal Sheikh, who in-turn had received it

from his father, Raj Sheikh. "I only know three generations of



my family who has inherited it [the spade] but there's a story my father had told me." Manzoor recalls.

"My forefathers had taken it some 100 years already. And since from someone 400 years ago, and then, we have been using it every that person had been carrying it for winter as a snow-clearing object."

"It's not just a tool to clear snow but an article that carries emotions and memories. I'm preserving it so that someday I can tell this story to my children and hand it over to them so that they carry

For kids with behavioural issues, focusing on diversion yields positive results: Study

The majority of justice-involved youth have a history of mental health and/or substance use issues, and have experienced a great deal of trauma



esearchers found that focusing on diversion -- instead of detention -- yields positive results for youth with behavioural health issues.

Of the 5,300 children enrolled in the Ohio Behavioral Health Juvenile Justice Initiative since 2006, 21 per cent reported that someone close to them had been murdered in the past year. Nearly half of the boys and more than a quarter of the girls in the program have both substance abuse and mental health dis-

But there's good news, too: From 2017 through 2019, 81% of the participants -- aged 10 through 17 -- successfully completed the state's juvenile diversion program, and data indicated that 79% of youth reduced their contact with police while in treatment.

Those findings are from a new detailed evaluation of the Ohio Behavioral Health Juvenile Justice Initiative (BHJJ) by researchers at the Jack, Joseph and Morton Mandel School of Applied Social Sciences at Case Western Reserve University.

The key conclusion: Many youthful offenders can benefit from community-based diversion programs designed to address mental health and substance use issues in lieu of commitment to local or staterun detention centres.

"The majority of justice-

involved youth have a history of mental health and/ or substance use issues, and have experienced a great deal of trauma," said Jeff Kretschmar, co-author of the study and the research associate professor at the university's Begun Center for Violence Prevention Research and Education, "However, local jurisdictions are often illequipped to accurately assess youth for behavioural health problems and provide appro-

priate treatment. Ohio's Behavioral Health Juvenile Justice Initiative was intended to transform and expand the local systems' options to better serve these youths.

The report focused on youth currently enrolled in the program rather than retrospectively, Kretschmar said, to "identify emerging behavioural health trends and better understand the effectiveness of the model as it operates across Ohio today."

Report highlights include: -Youth reported a significant decrease in trauma symptoms and problem severity from intake to termination, and a significant improvement in functioning.

-Since 2015, only 3.8% of youth enrolled in BHJJ were committed to a state-run detention facility after enroll-

-BHJJ costs about \$5,200 per child, compared with \$196,000 per child who enters a state-run detention facility.

"The breadth of the data provides us with an opportunity to examine outcomes for youth in BHJJ from a variety of angles and provides practitioners with enough information to match programming with behavioural health needs," said Fredrick Butcher, research assistant professor at the Begun Center. -

How scientists studied coughs to model COVID-19 spread

pandemic struck the world, IIT-Bombay Professor Rajneesh Bhardwaj was studying how droplets evaporated for applications in spray cooling and inkjet printing, and his collaborator Amit Agarwal was working on point-of-care medical devices and electronic cooling.

But once it became clear that the pandemic was mainly spreading through cough and sneeze aerosols from infected individuals, the duo began applving their knowledge to understand the evaporation of respiratory droplets from surfaces and the spread of cough clouds.

"Our plans were to continue in the domain of thermal and fluid engineering. However, the pandemic came as an opportunity to diversify and explore other research areas. We thought of extending and applying our knowledge to several unanswered questions in the context of COVID-19." Agrawal, Institute Chair Professor from the Department of Mechanical Engineering, IIT-Bombay, told PTI.

Bhardwaj and Agrawal, both experts in the field of fluid mechanics, said their understanding of the motion of fluids helped them model how the novel coronavirus spread.

"Air and water are the most common fluids, and also the carrier of most viruses and bacteria, it is not that surprising that the subject is playing an

important role in understanding and managing the current pandemic," Bhardwaj told PTI.

Numerous studies, over the course of the COVID-19 pandemic, applied principles of fluid mechanics to provide scores of important insights about the distance over which different size respiratory droplets travel, the safe distance between people, and the efficacy of various types of masks in reducing the transfer of contaminated droplets.

Scientists also probed into the process by which larger droplets underwent evaporation and subsequently precipitation to turn into microdroplets called aerosols.

"During this process, big droplets settle on the ground after a short distance in flight while the smaller ones remain airborne for a longer period forming aerosols," explained Saptarshi Basu, from the Indian Institute of Science (IISc), Bengaluru.

In short, the entire story of droplets leading to infections is a fluid dynamics problem," Basu, Chair Professor in the Department of Mechanical Engineering, told PTI.

Two studies by Basu and his team, both published in the journal Physics of Fluids, applied fluid dynamics experiments to show how the respiratory droplets dried and formed aerosols. and how virus particles are distributed within them.

Scientists discover novel film that evaporates sweat six times faster, holds 15 times more moisture

team of researchers from the National University of Singapore (NUS) has created a novel film that is very effective in evaporating sweat from our skin to keep us cool and comfortable when we exercise. The moisture harvested from human sweat can be used to power wearable electronic devices such as watches, fitness trackers, and more.

Sweating is a natural process for our body to reduce thermal stress. "Sweat is mostly composed of water. When water is evanorated from the skin surface, it lowers the skin temperature and we feel cooler. In our new invention, we created a novel film that is extremely effective in evaporating sweat from our skin and then absorbing the moisture from sweat. We also take this one step further - by converting the moisture from sweat into energy that could be used to power small wearable devices," explained research team leader Assistant Professor Tan Swee Ching. who is from the NUS Department of Material Science and Engineering.

The main components of the novel thin film are two hygroscopic chemicals - cobalt chloride and ethanolamine. Besides being extremely moisture-absorbent, this film can rapidly release water when exposed to sunlight, and it can be 'regenerated' and reused for more than 100 times.

To make full use of the absorbed sweat, the NUS team has also designed a wearable energy harvesting device comprising eight electrochemical cells (ECs), using the novel film as the electrolyte. Each EC can generate about 0.57 volts of electricity upon absorbing moisture. The overall energy harvested by the device is sufficient to power a lightemitting diode. This proof-of-concept demonstration illustrates the potential of battery-less wearables powered using human sweat.

technological break-This through was reported in the September print issue of the scientific iournal Nano Energy.

Absorbing moisture for personal

Conventional hygroscopic materials such as zeolites and silica gels have low water uptake and bulk solid structures, making them unsuitable for absorbing moisture from sweat evaporation. In comparison, the new moisture-absorbing film developed by NUS researchers takes in 15 times more moisture and do this 6 times faster than conventional materials.

In addition, this innovative film shows a colour change upon absorbing moisture, from blue to purple, and finally nink This feature car be used an indicator of the degree of moisture absorption.

The NUS team packaged the film into breathable and waterproof polytetrafluoroethylene membranes, which are flexible and commonly used in clothing, and successfully demonstrated the application of the moisture-absorption film for underarm pad, shoe lining and shoe insole.

Power Supply Restored To All Essential Depts: Govt

SRINAGAR: The administration today said power supply has been restored to all essential departments amid the snowfall. Likewise, 95 percent water supply has been also restored .

Giving details an official spokesman said this was revealed at a video conferencing which LG's advisor Baseer Khan held with district administrations of Kashmir and Jammu divisions.

Khan asked them to work 24×7 and with unflinching commitment to ensure that 100% power supply is restored and roads are cleared of snow across the entire Union Territory.

Deputy Commissioners of Kashmir division and Ramban district, Chief Engineer KPDCL, Chief Engineer PWD (R&B) Kashmir, Chief Engineer PHE Kashmir, Chief Engineer (Mechanical) Kashmir and other officers attended the meeting through video conferencing.

The concerned DCs said that they are continuously monitoring the situation and are taking steps as the situation is unfolding.

The details with regard to restoration of power supply, essential supplies to hospitals, road clearances and position of supplies were given by the Deputy Commissioners of both the divisions.

DCs apprised that restoration efforts are in full

swing to restore power supply and restore other essential supplies in their districts affected by snowfall. They informed that teams of line departments are being deputed to different locations to address the grievance of people on real time basis. They informed that majority of the feeders and receiving stations have been restored.

Regarding response of the district administration with regard to health emergency, DCs informed that power is being restored in the essential institutions and expecting pregnant women are being evacuated in advance to the health in-

DC Srinagar informed that all 36, 33 KV lines stand restored and 246 out of 258 11 KV feeders also stand restored adding that only 7 distribution transformers have been damaged out of 6505.

In Budgam, all the 10, 33 KV lines stand restored and out of 93, 11 KV lines, 55 stand restored while as DC Ganderbal informed that all the 08, 33 KV lines stand restored and out of 43 feeders, 33 stand restored.

Baramulla informed that all 17 (33 KV) lines stand restored and 140, 11 KV feeder out of 157 have also been restored. Out of 5081, only 12 transformers have been damaged while in Kupwara all 08, 33 KV lines stand restored and 50, out of 68 11 KV lines have been restored.

Founded by Nobel Laureate Professor C V Raman, the Indian Academy of Sciences is an autonomous institution under the Department of Science and Technology, Government of India.

Congratulating Romshoo on behalf of the university for this great achievement, KU Vice-Chancellor Prof Talat Ahmad said he was glad to see Prof Romshoo being

recognised by the Indian Academy of Sciences for his profound and sustained contributions to the promotion of science in the country.

His research has produced crucial information for choosing policy and management options for sustainable use of depleting water resources and for meeting the Indus Water Treaty (IWT) obligations, and to deal with impacts of climate change in the basin, the waters of which are shared between India and Pakistan.



Prof Ghani wants passports for all

NEW DELHI - Caught in a cleft stick over the choice of a Hurriyat Conference team to visit Pakistan, [its chairman, Abdul Ghani Bhat, today said the Centre should give passports to all the' seven executive members of the amalgam to make the dream of peace initiatives between India and Pakista

'We trust the Government Issue passports in favour of all the seven members of the executive council with a view to helping the process to move forward in the right direction/Bhat told PTI over phone from Srinagar.

With consensus elusive on the composition of the team, Bhat has been authorised to nominate the team to hold talks with militant leadership and

other Pakistani officials. Insiders say Bhat will have to do a tight rope walking as it would be difficult for him to choose a team in the wake of statements by Hizb-ul-Mujahideen asking them to include firebrand Jamaat-e-Islami leader Syed Ah Shah Geelan

in the team travelling to Pakistan. Bhat would be waiting for a goodwill gesture from Geelani like the one from Abdul Ghani Lone, who on January 1 said he would opt out of the team if it was required for consensus.

When it was pointed out to Hurriyat chairman that Geelani and another senior Hurriyat leader Sheikh Abdul Aziz had not applied either in writing or verbally for passport, Bhat said probably it should be taken in the larger inter-

est as a request for the issuance of the passports to them too.

However, the Centre, which is understood to have given clearance for issuance of travel documents to Bhat, Lone, Shia leader Moulana Abbas Ansari and providing new travel document to JKLF leader Yaseen Malik (who applied in September last year), has not given a go ahead for passports to Geelani and Informed sources said that since these two had not applied for the same, a

decision could not be taken.

Brexit: Finale at Last

The British public will have to face the repercussions of the sordid Brexit saga, mostly based on lies, during the pandemic times

n 31 December 2020, at 11 pm UK time and 12 pm Brussels time, four years, 27 weeks and two days after a referendum that split the UK almost down the middle in 2016, the curtains on the Brexit saga, finally came down, as the UK left the embrace of the European Union (EU) in a departure that was notably low key.

Most observers view the Brexit campaign, which claimed the job of two British prime ministers in its wake, as one built on lies and deceit. With the public being misled and fed wrong and inflated information, the result was in favour of some politicians who acceded to the chair at No. 10, like Boris Johnson.

In his New Year message, British prime minister Boris Johnson largely ignored Brexit, an issue he arguably shaped more than any other politician. Instead he preferred to focus on the toll of Covid-19 and what he called "the grimness of 2020". It seemed a far cry from his 2019 message, when after his recent election victory, he had promised "a fantastic year and a remarkable decade for our United Kingdom".

He described the moment as 'amazing', citing what he said were boundless possibilities with trade and innovation, and the UK was now "free to do trade deals around the world, and free to turbocharge our ambition to be a science superpower". He added: "We have our freedom in our hands and it is up to us to make the most of it."

Politicians' Reactions

Politicians in Britain and the EU expressed both triumph and bitter regret after the UK's Brexit transition period ended on New Year's Eve. Though, most of the Conservative leaders and politicians like Nigel Farage exulted in their messages.

However, across the Channel, the French president Emmanuel Macron in

his new year's address, expressed regret. "The United Kingdom remains our neighbour but also our friend and ally," he said. "This choice of leaving Europe, this Brexit, was the child of European malaise and lots of lies and false promises."

Nearer home in Scotland, which had voted 'Remain' strongly in the 2016 Brexit referendum, the pro-independence Scottish first minister, Nicola Sturgeon, promised to continue the Scottish independence drive, she tweeted: "Scotland will be back soon, Europe. Keep the light on." In a retort Johnson said the Scots could continue to dream, as this one will not be fulfilled during this generation.

Nigel Farage, who played a key role in the 2016 referendum, tweeted: "25 years ago they all laughed at me. Well, they're not laughing now." The UK's chief Brexit negotiator, Lord Frost, said the UK had a "great future before us" with the chance to "build a better country for us all". The Conservative MP Bill Cash, who has campaigned for Brexit for decades, said it was a "victory for democracy and sovereignty."

UK Media Coverage

Britain's Eurosceptic newspapers, after decades of bashing Brussels, celebrated victory in the year's first day editions after the Brexit transition period ended, but pro-EU outlets dwelt on a "day of sadness".

The Guardian's headline focused on Britain finally quitting the EU in the midst of a "crisis, without fanfare", an editorial called Brexit a "tragic national error". The Times splashed Johnson's "upbeat new year's message" celebrating an "amazing" future for the UK. The online Independent ran a satirical cartoon portraying leading Brexiteers as various species of fish. The front page of the Daily Express showed a picture of the White Cliffs of Dover and the headline "Our future. Our Britain. Our destiny". The Sun relegated the Brexit story to a

Several European commentators weighed in on what Britain's departure from the EU means. Most viewed its reputation for pragmatism and probity shredded by a campaign which they saw as profoundly populist and dangerously dishonest, and predicted an uncertain future for the UK

front-page box headlined "PM: Britain Brexpects", reporting Johnson's words that Brexit marked a moment for national renewal in which the country would "turbocharge" scientific innovation. "Welcome to 2021 – and two reasons to hope for a much brighter future," ran the Daily Telegraph headline, where Johnson made his name as a Brussels-bashing Europe correspondent in the 1990s. The Daily Mail preferred to focus entirely on the pandemic-related news, coolly ignoring Broxit

Several European commentators weighed in on what Britain's departure from the EU means. Most viewed its reputation for pragmatism and probity shredded by a campaign which they saw as profoundly populist and dangerously dishonest, and predicted an uncertain future

for the UK

The Guardian reported Rem Korteweg, of the Clingendael Institute think tank in the Netherlands, as saying "For us, the UK has always been seen as like-minded: economically progressive, politically stable, respect for the rule of law – a beacon of western liberal democracy, ... which has been seriously hit by the past four years. Brexit is an exercise in emotion, not rationality; in choosing your own facts. And it's not clear how it will end."

Britain's long-polished pragmatic image had been "seriously tarnished", Nicolai von Ondarza, of the German Institute for International and Security Affairs told The Guardian. But trust in the UK, too, had taken a heavy battering on the Brexit rollercoaster, he added.

The "sovereignty" in whose name Brexit was done remained, essentially, a myth, Jean-Dominique Giuliani, of the Robert Schuman Foundation in France, told The Guardian. "Take back control" is a nationalist, populist slogan that ignores the reality of an interdependent world. Our maritime neighbour will be much weakened." he added.

The German historian Helene von Bismarck doubted whether Brexit would end what she described as a very British brand of populism. "British populism is a political method, not an ideology, and it does not become redundant with Brexit.' she said. She identified two key elements in this method: an emotionalisation and over-simplification of highly complex issues, such as Brexit, the Covid pandemic or migration, and a reliance on bogeymen or enemies at home and abroad "Populists depend on enemies, real or imagined, to legitimise their actions and deflect from their own shortcomings,' she said. If the EU has been the "enemy abroad" since 2016, it will steadily be replaced by "enemies within".

Elvire Fabry, of France's Institut Jacques Delors, told The Guardian that the past four years had shown Europeans and Britons "just how little we really knew each other". They had also revealed, she said, the fragility of a parliamentary system seen by many on the continent as a point of reference.

In Der Spiegel, Nikolaus Blome opined that there was "absolutely nothing good about Brexit ... which would never have happened had Conservative politicians not, to a quite unprecedented degree, deceived and lied to their people".

Meanwhile, the UK has now signed trade agreements with 62 countries, the latest one with Turkey, after agreements with Japan, Canada, Switzerland and Norway were secured earlier.

Also the news of the British prime minister's father Stanley confirming that he is applying for a French passport came as a shot in the arm of anti-Brexit lobby. Stanley Johnson described himself as a French not a British, he was one of the first UK civil servants to work in Brussels after Britain joined the European Economic Community in 1973.

The critics are also warning of how the individuals and businesses both in the UK and beyond may face a dizzying new array of red tape, a good deal of it still to be worked out. In addition, the parting of ways could also have major constitutional repercussions for the United Kingdom. Northern Ireland, which shares a border with EU member the Republic of Ireland, remains more closely tied to the bloc's economy under the divorce terms, a status some fear could pull it away from the rest of the UK, just like Scotland, which is clamouring for independence, and if any of them succeed, then the United may fall like a house made of play cards.

n a 2012 lecture at the Institute of Advanced Studies, the late Danish-American historian Patricia Crone described Omer Saeed Sheikh as an "acculturated native" who had rebelled against his adopted cultural mores.

Sheikh is a British citizen who was arrested in Pakistan for his role in the kidnapping and murder of American journalist Daniel Pearl in 2002. Sheikh was born in London to Pakistani parents who had migrated to England in 1968. They quickly adopted British cultural norms and established a successful clothing business there. Sheikh was enrolled at a prestigious private school in London and was then sent to Lahore's equally prestigious Aitchison College.

He returned to England and enrolled at the famous London School of Economics. But he soon dropped out and travelled to a war-torn Bosnia in the early 1990s. This is when Sheikh threw himself completely into becoming a radical Islamist.

According to Crone, acculturated natives embrace cultural norms of their adopted societies. They do so to advance their status in these societies. These natives may be living in regions where they do not have ancestral roots, or in their ancestral regions that have been colonised by foreign powers. But when, despite integrating the foreign cultural ethos, they feel that their progress is being restricted by the producers of these ethea, they walk out from their acculturated selves, rebel against it and adopt their ancestral culture.

But what they believe is their 'authentic/ancestral culture' is often a romanticised concoction, or even an unintentional caricature. In their rebellion against their former acculturated selves, they may begin to dress in the manner they believe

people in their ancestral culture do (or ought to), or they may begin to follow their religion in a more overt manner.

To Crone, the acculturated non-European native's anger, triggered by his inability to achieve prestige and success despite adopting the ethos of a dominant western culture, is a rebellion against modernity. On the other hand, according to Crone, it is also a failure of Western modernity. The failure in this respect is its inability to hold on to non-Europeans who had willingly adopted modernity but then walked out to rebel against it. Crone says this is because of a fear within the purveyors of modernity that their positions of power might be usurped, by those who had adopted their ideas but were not from its race of origin.

To Crone this is not an irrational fear, but one that an idea needs to let go of if it is to retain converts and grow. In her 2014 book The Nativist Prophets of Early Islamic Iran, Crone writes that one of the main reasons behind the rapid growth of Islam was the fact that its purveyors had made it ex-

tremely simple to convert to the new faith.

The faith's first century was dominat-

ed by Arabs who lived in garrison cities, away from the natives they had conquered. But the natives could enter the garrison cities and enjoy all of its perks and power by adopting Islam. The acculturated native, in this context, did not face any hindrances to progress or rise to a position of power. According to Crone, this is why the native retained his acculturated self and did not walk out or rebel against it, despite his dislike of Arab hegemony. He may have rebelled against the Arabs but not the idea that he had converted to.

Indeed, the had converted to.

Indeed, the huge influx of non-Arab natives into the fold of Islam consequently overthrew the hegemony of its original purveyors (the Arabs) — especially after the Abbasid Revolution in 750 CE. But the faith continued to grow. In Pakistan, however, from the mid-1970s onwards, certain political and constitutional developments have led to the growth of a particular noninclusive strand of Islam, alienating those who may follow a different strand or may belong to a different faith.

They believe that, even if they acculturate themselves with this dominant strand, they will not be able to achieve the kind of success or position that those who were born into this strand can. They are thus more likely to walk out and leave the idea of nationhood based on this

strand vulnerable to contraction. And it has been contracting.

From the 18th century onwards, Islam as an imperial power began to stagnate. Its nemesis was the Muslim community's slide into myopia. It was eventually overwhelmed by European colonialism, powered by economic, militarist, political and social modernity based on the principles of the 'Age of Enlightenment' i.e. rationalism, science, democracy, secularism and capitalism.

This saw vast sections of colonised Muslims acculturating themselves to this modernity, so that they were not left behind. But because of reasons pointed out by Crone, many walked out of it, giving birth to radical Islamist ideas based on romanticised notions of their faith and its history.

Interestingly, according to the British academic Jonathan Israel, in the anthology The Secular State and Islam in Europe, Muslims who had adopted modernity were actually integrating ideas that were originally inspired by ancient Muslim rationalists. This was also often pointed out by 19th century Muslim modernists such as Sir Syed Ahmad Khan and Muhammad Abduh.

Israel writes that, as the seeds of the Enlightenment were being sown in Eu-

rope, there were European thinkers who were challenging monarchism and the Church by debunking their hostile perceptions of Islam, and informing their audiences that Islam was a rational and inclusive faith.

According to Israel, not all purveyors of the Enlightenment agreed. But 18th century Enlightenment philosophers such as Pierre Bayle, Henri de Boulainvilliers and Denis Diderot presented Islam as a rational and tolerant faith. Israel writes that these men were inspired by certain ancient Muslim thinkers, and their ideas seeped into the overall construct of Enlightenment philosophies, producing modernity.

Muslim modernists have often reiterated this narrative, pointing out that, by adopting Western modernity, Muslims were simply acculturating themselves with an Islamic past that had been repressed by conservatives. Sir Syed understood this as a battle between agal (reason and logic) and naqal (tradition and ritual). According to the 20th century Islamic modernist and scholar the late Fazal-ur-Rahman Malik, Islam's rational past does not fit the world view of 'fundamentalists' and radicals who, to challenge modernity, have constructed a largely romanticised past to tout their disposition as being 'authentic.'

In other words, those who rejected acculturation (to modernity) by claiming it was alien, were rejecting a repressed Islamic tradition that had inspired this modernity, and falling back on a mythical understanding of the faith's history to justify their rebellion.

Long COVID: who is at risk?

or most people, infection with SARS-CoV-2 – the virus that causes COVID-19 – leads to mild, short-term symptoms, acute respiratory illness, or possibly no symptoms at all. But some people have long-lasting symptoms after their infection – this has been dubbed "long COVID".

Scientists are still researching long COVID. It's not well understood, though our knowledge about it is growing. Here I take a look at what we've learned about it so far – who is at risk, how common it is and what its effects are.

In defining who is at risk from long COVID and the mechanisms involved, we may reveal suitable treatments to be tried – or whether steps taken early in the course of the illness might ameliorate it

Broad vulnerability

Long COVID is characterised by a constellation of symptoms, including – variably – shortness of breath, marked fatigue, headache, and loss of ability to taste and smell normally. A relatively large study of 384 individuals ill enough to be admitted to hospital with COVID-19 showed that 53% remained breathless at a follow-up assessment one to two months later, with 34% having a cough and 69% reporting fatigue.

Indeed, early analysis of self-reported data submitted through the COVID Symptom Study app suggests that 13% of people who experience CO-VID-19 symptoms have them for more than 28 days, while 4% have symptoms after more than 56 days.

Perhaps unsurprisingly, people with more severe disease initially – characterised by more than five symptoms – seem to be at increased risk of long COVID. Older age and being female also appear to be risk factors for having prolonged symptoms, as is having a higher body mass index.

Those using the app tend to be at the fitter end of the population, with an interest in health matters. So it is surprising that such a high proportion have symptoms one to two months after the initial infection. Generally, these aren't people who are highly vulnerable to COVID-19.

Another piece of early research (awaiting peer review) suggests that SARS-CoV-2 could also have a long-term impact on people's organs. But the profile of those affected in this study is



different to those reporting symptoms via the app.

This research, which looked at a sample of 200 patients who had recovered from COVID-19, found mild organ impairment in 32% of people's hearts, 33% of people's lungs and 12% of people's kidneys. Multiple organ damage was found in 25% of patients.

Patients in this study had a mean age of 44 years, so were very much part of the young, working-age population. Only 18% had been hospitalised with COVID-19, meaning organ damage may occur even after a non-severe infection. Having a disease known to lead to more severe COVID-19, such as type 2 diabetes and ischaemic heart disease, wasn't a prerequisite for organ damage either.

Finding out what's going on

There are many reasons why people may have symptoms months after a viral illness during a pandemic. But getting to the bottom of what's going on inside people will be easier for some parts of the body than others.

Where symptoms point to a specific organ, investigating is relatively straightforward. Clinicians can examine the electrical flow around the heart

if someone is suffering palpitations. Or they can study lung function – tissue elasticity and gas exchange – where shortness of breath is the predominant symptom. To determine whether kidney function has deteriorated, components in a patient's blood plasma are compared to those in their urine to measure how well the kidneys are filtering waste products.

Rather harder to explore is the symptom of fatigue. Another recent large-scale study has shown that this symptom is common after COVID-19 – occurring in more than half of cases – and appears unrelated to the severity of the early illness.

What's more, tests showed that the people examined didn't have elevated levels of inflammation, suggesting that their fatigue wasn't caused by continued infection or their immune system working overtime. Risk factors for long-lasting symptoms in this study included being female – in keeping with the COVID Symptom App study – and, interestingly, having a previous diagnosis of anxiety and depression.

While men are at increased risk of severe infection, that women seem to be more affected by long COVID may reflect their different or changing hormone status. The ACE2 receptor that SARS-CoV-2 uses to infect the body is present not only on the surface of respiratory cells, but also on the cells of many organs that produce hormones, including the thyroid, adrenal gland and ovaries.

Some symptoms of long COVID overlap with menopausal symptoms, and hormone replacement using medication may be one route to reducing the impact of symptoms. However, clinical trials will be essential to accurately determining whether this approach is both safe and effective. Applications to launch such research have been made.

With so much having happened over the last year, we will need to tease apart which impacts stem from the virus itself versus which might be the consequence of the massive social disruption wrought by this pandemic. What is clear, however, is that long-term symptoms after COVID-19 are common, and that research into the causes and treatments of long COVID will likely be needed long after the outbreak itself has subsided.

Nutrition can substantially influence the development and health of brain structure and function. It provides the proper building blocks for the brain to create and maintain connections, which is critical for improved cognition and academic performance. Previous evidence has shown that long-term lack of nutrients can lead to structural and functional damage to the

brain, while a good quality diet is related to larger brain volume. Therefore, whatever your age, remember to eat a well-balanced diet, including fruits and vegetables.

4. Keep socially connected

Loneliness and social isolation is prevalent across all ages, genders, and cultures - further elevated by the Covid-19 pan-

demic. Robust scientific evidence has indicated that social isolation is detrimental to physical, cognitive, and mental health.

One recent study showed that there were negative effects of Covid-19 isolation on emotional cognition, but that this effect was smaller in those that stayed connected with others during lockdown. Developing social connections and alleviating loneli-

ness is also associated with decreased risk of mortality as well as a range of illnesses.

Therefore, loneliness and social isolation are increasingly recognized as critical public health issues, which require effective interventions. And social interaction is associated with positive feelings and increased activation in the brain's reward system.

In 2021, be sure to keep up with family and friends, but also expand your horizons and make some new connections.

5. Learn something new

The brain changes during critical periods of development, but is also a lifelong process. Novel experiences, such as learning new skills, can modify both brain function and the underlying brain structure. For example, juggling has been shown to increase white matter (tissue composed of nerve fibers) structures in the brain associated with visuo-motor performance.

Similarly, musicians have been shown to have increased grey matter in the parts of the brain that process auditory information. Learning a new language can also change the structure of the human brain.

A large review of the literature suggested that mentally stimulating leisure activities increase brain-reserve, which can instil resilience and be protective of cognitive decline in older adults -- be it chess or cognitive games.

6. Sleep properly

Sleep is an essential component of human life, yet many people do not understand the relationship between good brain health and the process of sleeping. During sleep, the brain reorganizes and recharges itself and removes toxic waste byproducts, which helps to maintain normal brain functioning.

Sleep is very important for transforming experiences into our long-term memory, maintaining cognitive and emotional function, and reducing mental fatigue. Studies of sleep deprivation have demonstrated deficits in memory and attention as well as changes in the reward system, which often disrupts emotional functioning. Sleep also exerts a strong regulatory influence on the immune system. If you have the optimal quantity and quality of sleep, you will find that you have more energy, better well-being and are able to develop your creativity and thinking.

Qazigund recorded a minimum of minus 0.2 degrees Celsius, Kupwara, in the north, minus 0.7 degrees Celsius and Kokernag minus 1.0 degrees Celsius.

The MET Office said moderate to heavy snowfall, with isolated very heavy snowfall, was most likely to take place, especially in south Kashmir, Gulmarg, Banihal-Ramban, Poonch, Rajouri, Kistawar and Zanskar, Drass as well as on the higher reaches of Ladakh UT, over next 24 hours.

Kashmir is currently under the grip of 'Chillai-Kalan' -- the 40day harshest winter period when a cold wave grips the region and the temperature drops considerably leading to the freezing of water bodies including the famous Dal Lake here as well as the water supply lines in several parts of the valley.

The chances of snowfall are the most frequent and maximum during this period and most areas, especially in the higher reaches, receive heavy snowfall.

Thousands Stranded On...

Kashmir valley were also cleared before the traffic was again halted at around 8 pm on Monday, the officials said, adding all the vehicles reached their destination safely.

Dozens of passengers, including three cancer patients, were provided food and shelter by the local residents of Tathaar-Nowgam village of Banihal before they were allowed to move towards their destination by the authorities.

The officials said a mud-slide which had struck the highway near Samroli in Udhampur district due to overnight rains was cleared around 2 pm Tuesday, thus paving the way for resump-

tion of traffic on Jammu-Kishtwar-Doda highway. Despite inclement weather, they said the road clearance agencies concerned are working to ensure early reopening of the Jammu-Srinagar national highway.

The highway is blocked at multiple locations, especially between Panthiyal to Ramsu, due to land and mudslides along with heavy accumulation of snow in Jawahar Tunnel-Qazigund stretch. Efforts are on to restore the highway as soon as possible, a traffic department official said.

He said there are over 4,500 vehicles, mostly trucks, stranded on either side of the highway and these vehicles would be cleared first before allowing fresh traffic after the restoration of traffic. The Meteorological department has predicted improvement in the weather from Wednesday morning.

The prevailing weather condition is likely to continue till late tonight or early tomorrow (Wednesday). We are expecting a sig-nificant improvement in weather from Wednesday across J&K, a spokesman of the MeT department said, predicting cold wave conditions from January 7.

Meanwhile, Jammu and other plains were lashed by heavy rains, while high altitude areas in the region experienced intermittent snowfall for the third day on Tuesday.

Jammu recorded 32.4 mm of rains during the past 24 hours ending 8.30 am Tuesday, the spokesman said, adding the city recorded a minimum of 11.9 degrees Celsius which was 4.6 degrees above normal during this part of the season.

Bhaderwah in Doda ditrict, Banihal and Batote in Ramban district experienced 4 cm, 3.2 cm and 0.5 cm of snowfall during the same period, the spokesman said.

Covid Vaccines' Speedy Distribution Major Challenge For World: WHO Experts

THIRUVANANTHAPURAM: As India launched the world's most ambitious and biggest vaccination drive against COVID-19, the country will encounter the formidable challenge of rapidly scaling up distribution of its entire population, two prominent Indian scientists at WHO have said.

This daunting challenge is not only for India but also for all the governments across the globe as they start inoculating their populations to tackle the pandemic, noted Dr Soumya Swaminathan, Chief Scientist of WHO, and Dr Hamsadvani Kuganantham, Consultant, WHO.

On Sunday, the Central Drugs (CDSCO),India's drugs regulator, had approved Oxford vaccine Covishield, manufactured by the Serum Institute of India (SII), and Covaxin of Bharat Biotech for restricted emergency use for the frontline warriors and senior citizens in the country.

Currently, there are 45 candidate vaccines in clinical evaluation and 156 candidate vaccines in pre-clinical evaluation, the WHO scientists said. COVAX,a ground-breaking global collaboration to accelerate the development, production, and equitable access to COVID-19 treatments and vaccines, is jointly led by the Coalition for Epidemic Preparedness Innovations (CEPI), Gavi (the Vaccine Alliance set up by The Bill & Melinda Gates Foundation), and the World Health Organisation (WHO). 
"It is the only global initiative that is working with governments and manufacturers to ensure COVID-19 vaccines are available worldwide to both higher-income and lowerincome countries," they wrote in an article for Manorama Yearbook 2021.

"The goal of COVAX is to deliver two billion doses of safe, effective vaccines that have passed regulato-Standard Control Organisation ry approval and/or WHO prequalification, by the end of 2021.

These vaccines will be offered equally to all participating countries, proportional to their populations, initially prioritizing healthcare workers, then expanding to cover vulnerable groups, such as the elderly and those with pre-existing conditions," the scientists pointed out. Further doses will then be made available based on a country's need, vulnerability and CO-VID-19 threat. The scientists said it is equally important to ensure sustained

surveillance, tracing, test and treat. "Vaccines will help us achieve herd immunity but, until then we need to keep practicing the nonpharmacological measures to prevent infection and spread," said Dr

Trump Says He'll 'Fight Like Hell' To Hold On To Presidency

DALTON (US): With mounting desperation, Donald Trump has declared he would "fight like hell" to hold on to the presidency and appealed to Republican lawmakers to reverse his election loss to Joe Biden when they convene this week to confirm the Electoral College vote.

Electoral voters won by President-elect Biden were "not gonna take this White House!" he shouted as supporters cheered at an outdoor rally in Georgia on Monday night.

Trump's announced purpose for the trip was to boost Republican Senate candidates in Tuesday's runoff election, but he spent much of his speech complaining bitterly about his election loss — which he insists he won "by a lot".

Earlier, in Washington, he pressed Republican lawmakers to formally object Wednesday at a joint session of Congress that is to confirm Biden's victory in the Electoral College, itself a confirmation of Biden's nationwide victory November 3.

Though he got nothing but cheers on Monday night, Trump's attempt to overturn the presidential election is splitting the Republican Party.

Some GOP lawmakers backing him are rushing ahead, despite an outpouring of condemnation from current and former party officials warning the effort is undermining Americans faith in democracy.

All 10 living former defence secretaries wrote in an op-ed that "the time for questioning the results has passed".

It is unclear the extent to which the GOP leaders in Congress will be able to control Wednesday's joint session, which could drag into the night, though the challenges to the election are all but certain to fail. Trump himself is whipping up crowds for a Wednesday rally near the White House.

Vice President Mike Pence, who is under pressure to tip the results for Trump, will be closely watched as he presides in a ceremonial role much publicly on it.

LONDON: British Prime Minister Boris Johnson announced on Monday a w national lockdown for Englan until at least mid-February to combat a fast-spreading variant of the coronavirus, even as Britain ramped up its vaccination programme by becoming the first nation to start using the shot developed by Oxford University and drugmaker AstraZeneca.

Johnson said people must stay at home again, as they were ordered to do so in the first wave of the pandemic in March, this time because the new virus variant was spreading in a frustrating and alarming way.

"As I speak to you tonight, our hospitals are under more pressure from Covid than at any time since the start of the pandemic," he said. Under the new rules, which are set

to come into effect as soon as possible, primary and secondary schools and colleges will be closed for face to face learning except for the children of key workers. University students will not be returning until at least mid-February.


