Pak Summons Indian Envoy

Islamabad: Pakistan on Tuesday summoned a senior Indian diplomat to register its protest over alleged ceasefire violations by Indian forces along the Line of Control (LoC). The Foreign Office alleged that a 10-year-old boy sustained injuries due to the firing in the Nezapir Sector on Monday. The Indian side was called upon to respect the 2003 Ceasefire Understanding; investigate this and other such incidents of ceasefire violations and maintain peace along the LoC and the Working Boundary, it said in a statement.

CDS Rawat, LG Discuss Security Situation

Jammu: Chief of Defence Staff, General Bipin Rawat and Lieuten ant Governor, Manoi Sinha on Tuesday discussed the present security situation in the Union Territory of Jammu and Kashmir. 2 Porters Injured After Falling Off Hill

Srinagar: Two army porters were injured on Tuesday after they slipped from a hill in Uri area of Baramulla district.

17-year-old Mohammad Rameez Poswal and 21-year-old Mohammad Ramzan Poswal slipped from the hill when they were taking some load towards the army's forward in village Nawarunda Uri, reports said Tuesday. Both the youth, reports said, sustained injuries due to the fall. They were shifted to sub-districthospital (SDH) Uri for treatment, reports said. However, the doctors there referred them to GMC Baramulla for specialized treatment.

Bus Mows Down Student In Bandipora Srinagar: A teenage student on

Tuesday was crushed to death by of Bandipora district. 15-year-old Liyagat Ahmad of Chak Garoora area was critically injured when a bus (JK13-3813) hit his motorbike at Saderkoot Payeen area on the Srinagar-Bandipora highway on Tuesday afternoon, news agency KDC reported. The bus driver, the report said, managed to flee from the spot while the injured student was rushed to CHC Sumbal. where doctors declared him dead. Meanwhile, police have filed a case FIR no 05/2020 under section 279-337 and 427 of Indian Penal code at the police post Aias and started further investigations in this regard.

SRINAGAR: The traffic authorities on Tuesday said that the restoration work on the portion of damaged road along the Srinagar-Jammu highway might take nearly ten days to make the strategic surface link motorable.


'Jammu-Srinagar National Highway shall remain closed due to sudden collapse of retaining wall of a bridge near Kela Morh, Ramban on January 10 at 6:20 p.m. Repairing by concrete filling and settling of the concrete for making it motorable may take approximately 10 days as per NHAI," a statement issued by traffic police headquarters read.

It further said that in the interim, to restore connectivity a Bailey bridge is being launched by the border roads organisation (BRO).

The statement further said that Jammu-Doda-Kishtwar, Jammu-Ramban, Gool Sangaldan, Magerkot-Banihal, and Banihal-Qazigund stretches are open for local traffic.

The 270-kilometre Jammu-Srinagar highway was closed for traffic after a portion of the road caved in near Ramban town on Sunday, hours after it was thrown open for traffic after remaining closed for seven days.

Court Charges Yasin Malik, 9 Others In 31-Year-Old Case

IAMMU- A special TADA court has framed charges against Jammu and Kashmir Liberation Front (JKLF) chief Mohammad Yasin Malik and nine others in a 31-yearold kidnapping case involving Rubaiya Sayeed, the daughter of then union home minister Mufti Mohammad Sayeed.

Malik is presently lodged in Tihar jail, Delhi, after he was arrested by the National Investigation Agency (NIA) in April 2019 in connection with an alleged militant funding case, a month after his group was banned by the central government.

In March last year, the special TADA court had framed charges against the JKLF chief and six others in another case related to the gunning down of four IAF personnel on the outskirts of Sri-

Special TADA judge Sunit Gupta on Monday ordered framing of charges against Malik and nine others -- Ali Mohd Mir, Mohd Zaman Mir, Igbal Ahmad Gandroo, Javed Ahmad Mir, Mohd Rafiq Pahloo, Manzoor Ahmed Sofi, Wajahat Bashir, Mehraj-ud-Din Sheikh and Showkat Ahmad Bakshi.

The 10 are among two dozen accused named by the CBI in its charge-sheet filed before the TADA court. Among the others, Mohammad Rafiq Dar and Mushtag Ahmad Lone -- both top commanders of JKLF-- are dead and 12 others are absconding.

The absconders include Halima, Javed Iqbal Mir, Mohammad Yaqub Pandit, Riyaz Ahmad Bhat, Khursheed Ahmad Dar, Basharat Rehman Noori, Tariq Ashraf, Shafat Ahmad Shangloo, Manzoor Ahmad, Gulam Mohammad Taploo, Abdul Majeed Bhat and Nissar Ahmad Bhat. ▶PAGE 06

PLA Has Not Pulled Out Troops From Frontline: Army Chief

NEW DELHI: Army chief Gen MM Naravane on Tuesday hoped for an amicable resolution of the military standoff with China in Ladakh through talks and based on "mutual and equal security" even as he said the collusive and potent threat from China and Pakistan to India cannot be "wished away".

Gen Naravane at the same time prepared to deal with any eventuality along the Line of Actual Control (LAC) and will hold their ground as long as it takes to achieve the "national goals and objectives."

The Chief of Army Staff was ad-



dressing a news conference here asserted that Indian troops are fully ahead of the Army Day on January 15.

On increasing security challenges at the LAC, he said a need was felt about "rebalancing" of troops along the northern borders and subsequently steps have been taken to put adequate focus on the borders with China.

'Looked Like A Fool' Australia Captain **Tim Paine Apologises For Sledging Ashwin**

SYDNEY: Australian captain Tim Paine on Tuesday apologised for his on-field behaviour during the drawn third Test against India here, saying that his leadership wasn't good enough and he ended up "looking like a fool" by sledging Ravichandran Ashwin.

Paine has come under fire for a verbal duel with Ashwin when the Indian held vigil with an injured Hanuma Vihari to eke out a draw for his team, which was chasing a mammoth 407 for a win. Paine said he was "distracted, agitated and a bit grumpy at times" during the game.

"I spoke to him (Ashwin) really quickly after the game yesterday, as I said to him, look I ended up looking a fool, didn't I? You open your mouth and then you drop a catch and had a bit of laugh about that," he said at a virtual press conference, which he wasn't even scheduled to attend.

He said he decided to speak

to the media to "address some things" after having defended his behaviour in the postmatch presser on Monday.

"...I do want to apologise for the way I went about things yesterday on someone who prides himself on the way I lead this team and yesterday was a poor reflection of that," Paine said.

The 36-year-old wicketkeeper dropped three catches during the match, including of Vihari after the confrontation with Ashwin. Paine conceded that it was the pressure of the game that got to him and that affected his mood.

"My leadership wasn't good enough, I let the pressure of the game, I suppose get to me and it sort of affected my mood and then from there affected my performance," he elaborated.

"So, yesterday when I came off the ground, my reflection was purely on my wicket-keeping...I think I said to my players, I had a really poor game as a leader, not so much as a captain, but certainly as a leader.

Paine also admitted that on Monday he fell short of his own standards and expectations in terms of playing the game by certain ethics. "I always talk to our players about playing this game on skill and not on emotion and yesterday as I said I fell short of my own standards. and own expectations.

'...but at the same time, bit of self-reflection, being able to learn from it, being able to move on after the (Sydney) Test was important.

"I again apologise to our fans and people who heard some of the things I said yesterday, it wasn't good enough particularly from the leader of this team, said Paine, who used an abusive word to unsettle Ashwin during their chatter.

BCCI Forced To Intervene After Team India Denied Basic Facilities In Brisbane Hotel

BRISBANE: The Indian cricket team, which landed in Brisbane for the fourth and final Test against Australia, was in for a shock on Tuesday as it was lodged at a hotel which "lacked basic facilities", prompting an intervention from the BCCI top brass.

It is understood that BCCI president Sourav Ganguly, Secretary Jay Shah and CEO Hemang Amin have all got in touch with their Cricket Australia counterparts after complaints reached them and have been assured that the Indian contingent will be made to feel comfortable from here on. The series is tied 1-1 currently.

"There was no room service or house keeping facilities. The gym is very basic and not of international standards and the swimming pool can"t be accessed. This wasn't what they were promised when they checked in," a senior BCCI source told PTI on conditions of anonymity

India will be playing the fourth Test in the Queensland capital from January 15 where the surge of COVID-19 cases and a border lockdown with New South Wales has led to a strict hotel quarantine for the Ajinkya Rahane-led team

Asked if the players were being allowed to mingle, the Board source said: "Yes, they have been provided with a team room and are allowed to meet each other inside the hotel."

When asked whether the team had protested with the hotel authorities, the source said: "When the manager enquired about how these things are not being taken care of, all they said was, "the rule applies to both Indian and Australian teams. There is no one team that has been subjected to hard quarantine rules."

However, the Indian contingent is confident that both Ganguly and Shah will be able to amicably resolve the matter as the injury-ravaged team prepares for the series-

AUS Vs IND 4th Test

Bumrah Ruled Out While Ashwin And Agarwal Join India's Growing Injury List

SYDNEY: The injury-ravaged Indian team was dealt another telling blow on Tuesday as pace spearhead Jasprit Bumrah was ruled out of the fourth Test against Australia due to an abdominal strain.

If that wasn't enough, Mayank Agarwal -- tipped to be Hanuma Vihari's replacement in the playing XI in Brisbane -- has sustained a knock on the hands and it could be a hairline fracture.

To make matters worse, Ravichandran Ashwin's back spasms have aggravated after battling for three hours on the final day, leaving little options for India on the bench.

Bumrah, key to India's attack, sustained the strain during the drawn third Test in Sydney.

It has been learnt that Bumrah's scan reports showed a strain and the Indian team management does not want him to aggravate the injury, keeping in mind the upcoming four-Test series against England.

"Jasnrit Rumrah suffer Sydney. He is going to sit out of the



Brisbane Test but is expected to be available against England," a BCCI source told PTI.

While the Indian team management is heaving a sigh of relief that Bumrah hasn't sustained a tear but wants to be on the side of caution as playing in Brisbane and breaking down in the middle of the Test match could have an even more adverse effect on the team.

"If we take the risk of him playing at 50 percent, what if the injury aggravates and he breaks down in the middle of the match and then ruled out for better part of England series?

"England is the last series which will decide the qualification for World Test Championship final and abdominal strain while fielding in we are in contention and would require a fit Bumrah," the senior BCCI

The only two available batsmen are two out of form openers in Prithvi Shaw and Mayank Agarwal.

It remains to be seen if India, knowing their depleted strength and long tail, decide to take the conservative route of playing four bowlers and six batsmen with Rishabh Pant as the wicketkeeper.

If Agarwal's scans reveal that it's a bruise and not a fracture, then it could well be Prithvi Shaw batting at number three followed by Chetesh war Pujara, Ajhinkya Rahane, and Agarwal himself at number six.

LAWDA Acts After 8 Years, Demolishes Illegal Structures From Nigeen West

Srinagar: Lakes and Waterways Development Authority (LAWDA) finally acted on the repeated complaints of residents and environmentalists and partially demolished a private hut in the tourism park on the West side of Nigeen Lake on Tuesday.

The demolition was however stopped after the owner of the hut, an influential businessman along with officials from the tourism department intervened and stopped LAWDA workers from razing it to ground, alleged head of an NGO which spearheaded the campaign for encroachment free Nigeen.

According to residents, the Tourism Department acquired 176 kanal and 18 marla of land on the Western shores of Nigeen Lake in early seventies for building a public park.

However it was only in 2008 the land was converted into Joggers Park and named Cherry Park. However the entire front end of the lake remains under oc-

cupation of houseboats marooned along its banks.

'We cannot even touch the water while inside the park. The entire stretch has been fenced by houseboat owners which is illegal, said Aftab Ahmad, a regular at the park.

"Some people have erected sign boards of 'Private Property' in the park and have raised illegal constructions. We have been asking authorities to take action for a long", ``said Nasr Ahmad Naikoo, local councillor. He has even shot a letter to Director Tourism seeking his intervention.

"Ironically some of the encroachers are running an NGO for the conservation of the Nigeen Lake. They are in cohorts with some officials of the Tourism Department and that is why tourism officials intervened today and stopped LAWDA workers from the demolition", alleged a resident who was present at the site when the demolition squad arrived sparking an angry reaction by the inmates.

Director Tourism when contacted told Kashmir Observer that his team accompanied LAWDA for demolition of the structures today that were built 17 years back. " No one will be allowed to breach the law". Director Nisar Ahmad said. He parried a question when asked how was a private hut standing on tourism property for so many years?

He however said it is now upto LAWDA to check and demolish any illegal structure raised near the water bodies.

Residents said action was taken only after they approached Divisional Commissioner P K Pole who issued prompt orders for eviction of encroachers. However they appealed to him to monitor the entire process till all encroachments around the park are removed.

Divisional Commissioner Pole told Kashmir Observer that he had asked the tourism department to take action against the illegal structure, since the area pertains to the department. Pole further said he has asked for a time bond action taken report regarding the case from the department and is aware of the case

Lone's shocked reaction to Z-security report

YEW DELHI- On Tuesday, Abdul Ghani Lone went to a favourite C-grade barber shop in Delhi to have his beard trimmed. He picked up a leading newspaper and saw a care \neg fully placed front-page story which said that the senior leader of Kashmir's All Parties [Hurriyat Conference (APHC) was now covered by 'Z' cat¬egory security by the govern¬ment, a category Just below the prime minister's

"I died in my boots, Lone told this correspondent. "The lipoor barber was so rattled by my shocked reaction that he nearly nicked my throat with the razor. Of course that story is bilge," thundered the 68-year-old veteran of Kashmiri politics known for his angry outbursts.

On Saturday the editor of another major Indian daily was advising Prime Minister Atal Behari Vajpayee in a signed article on the urgent need to avoid saddling Lone with too many responsibilities in seeking a breakthrough over Kashmir. The article warned that Lone would run the risk of becoming Harchahd Singh Longowal, the moderate Sikh leader who was assassinated by hardline Sikh insurgents-.

"Lone as Longowal is a scary thought," the article said: If that was not enough, two internet news agencies, usually fairly reliable, filed stories on Sunday from Srinagar on how Lone's house had been surrounded by elite commandos.

"Rubbish!" said the be¬spectacled leader. "I just spoke to my family in Srinagar. There's not a soul there. As for the second charge, I am not fighting for Kashmir's free¬dom to please India. Do the media want me to get killed?"

For the record, Lone was emphatical that he would refuse any Indian security even if it was offered to him. "I have lived dangerously, but I am not a fool. I belong to the times of Sheikh Abdullah, when I used to take him on in the state assembly, call ing him a traitor to Kashmir when others would have trembled in his presence.

Lone said he did not take lightly recent threats from hardline Kashmir groups targeting him as a renegade. Lone's recent remarks addressed to Mujahideen groups may have contributed to his difficulties with Kashmir's armed organizations. Dawn

Return the bodies

amilies of the three youth killed in an encounter on the outskirts of Srinagar on December 30 have been demanding their remains. They are also demanding probe into their killing in what they have alleged was a fake encounter. The demand of the families makes sense in the wake of the killing of three labourers from Rajouri in an encounter at a Shopian village in July last year that later turned out to be fake. This too happened after the labourers' families protested and forced the army to order a probe. And to Army's credit, it was quick to indict its own soldiers. This came as a pleasant surprise to people. Army chose to voluntarily dispense justice in a case where its personnel had in the words of Army itself "exceeded" the powers vested under the AFSPA. Later the police accused an army officer and two associates of planting weapons on the bodies of three slain labourers Captain Bhoopendra Singh who is now in military detention, has been charged with murder, conspiracy and other offences. Similarly the two civilian "sources", who were with him at the time, are in police custody.

At the recent Srinagar encounter too, the families are saying their wards had left for Srinagar on the day they were killed. One among the three youth Ather Mushtaq was just sixteen years old. Families are unwilling to believe the three were militants oroverground workers or had gone to join the ranks of militants. Significantly, police has said the three youth were not a part of its list of militants, even though Army has insisted that the three were not civilians. In a statement, the Army has said that the three had been given the opportunity to surrender but they refused.

That said, it is important that the Army follows the example of the Shopian encounter and holds a transparent probe. Both the families and the people have a right to know what happened on the day. Also, the government should sympathetically consider the demand of the families for the return of the bodies. It iss heartbreaking to see the video of the father of Ather Mushtaq himself digging the grave for his slain son in his ancestral gravevard and asking for the body to be returned to him. The government's reason for not returning the bodies has been to prevent the massive funerals in view of the ongoing Covid-19 pandemic. And second, according to the Inspector General of Police, Kashmir, Vijay Kumar, this is to stop the glamourization of the militancy. On closer examination, the two arguments hardly seem to hold water. With vaccines for Covid-19 having been approved, there's no reason that the bodies can't be handed over now. And as far the glamourization, a sincere and serious political outreach would be far more helpful to arrest the ongoing recruitment into militancy

A big Test

India's vaccination drive against COVID-19, targeting 3 crore healthcare personnel and frontline workers, will commence from January 16. Coordination systems between 20 ministries are reportedly being put in place and the government has framed a set of guidelines for the rollout that deal with logistics, human resources and monitoring systems to report adverse events. Dry runs have been conducted in more than 700 districts to acquaint the administrative agencies and vaccinators with some of the challenges that lie ahead. These exercises have shone a light on the gaps that must be plugged before the first shots are administered.

Digital systems have a key role in the vaccination plan. Nearly 80 lakh beneficiaries in the first priority list have reportedly registered on the Centre's COVID Vaccine Intelligence Network (Co-WIN) system — "a digitalised platform to track the enlisted beneficiaries for vaccination on a real-time basis". The challenge now is to make the manual interventions to this platform foolproof and user-friendly for ASHA and other healthcare workers involved in the last-mile delivery of the vaccine. Care must also be taken to obviate server malfunctioning that has been a longstanding bane of IT-enabled services in the country. There have been reports of the Co-Win app not performing as per plans during the mock drills officials in several parts of the country have complained that the platform did not show the names of all the targeted beneficiaries. Also, last week, this paper reported that codes of some villages in Andhra Pradesh, Punjab, Gujarat and Assam were not mapped on the Co-Win platform. Experts have rightly warned that such snags could prevent intended beneficiaries from keeping their date with the vaccine, and even more worryingly, erode trust in the inoculation process. The Union Ministries of Health and Information Technology are reportedly collaborating on bolstering the IT infrastructure and have sought inputs from private players.

The government plans to administer the vaccine to 30 crore people in the first two phases of the inoculation drive. According to current plans, each person will be administered two doses of a vaccine. In other words, 60 crore shots will be administered in the next six to eight months. Nearly one lakh vaccinators will be involved in the process. The dry runs have bared the inadequacies, especially in reporting adverse events. Healthcare officials have also expressed apprehensions that such a large-scale project, involving conversion of PHCs into vaccination points, could result in the disruption of regular health services, including routine immunisation programmes and institutional deliveries — already there are concerns that the country's TB control programme has suffered a setback because of resources being diverted for COV-ID-19 control. The coming months could be exacting for the country's healthcare system. How it steps up to the demands of the moment will be watched.

Forest Department is a Respondent Party under FRA

Involve SDM's, DPOs, Tehsildars, BDO's and NGOs in awareness building

ecently, the Deputy Commissioner Anantnag with an aim of implementation of the Forest Rights in district issued a circular on 4.01.2021 asking forest officers to create awareness on the Forest Rights Act (FRA) . Yet again, a mistake that was committed in other states in the past is being repeated in J&K. The Forest Department is a Respondent Agency when it comes to implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 commonly known as Forest Rights Act or FRA. How can an organization that is holding title of a land give away the same to the tribals and traditional forest dwellers living around forest areas?

With an aim to ensure justice delivery vis a vis Forest Rights Act (FRA) , the Tribal Affairs Ministry was made the nodal agency for implementation of this pro-poor and pro tribal law at national level. In states and UTs, the respective Tribal Affairs Departments are the nodal departments to implement FRA. Rural Development and Revenue authorities also have a great role. But in the case of Jammu & Kashmir, the Govt seems to be ignoring them and involvement of forest officials is given more focus. If this is a deliberate attempt then that needs to be exposed but if it is done due to lack of awareness around this law, the same needs to be rectified.

It is not wise to call upon Divisional Forest Officers (DFOs) through an official circular to carry out awareness and information education and communication (IEC) programmes among forest dwelling communities. Will DFOs , Range officers or Foresters or even Forest guards in Anantnag dare to tell forest dwellers or gujjar population living around Kokernag , Pahalgam, Breng , Gadole or other forest areas that

"We will be surrendering our land that is under your possession very soon in your favour. You will be its owner and can carry out your agriculture and other activities on it ". They can't tell them and this will kill the essence of this law.

The Deputy Commissioner could have instead directed the SDMs, District Panchayat Officers (DPOs), Tehsildars or Block Development Officers (BDO's) to do this work or involved some reputed NGOs as well . Even the Government at top level is giving the role and responsibility of FRA implementation to the Forest Department while the Tribal Affairs Department JK Government or even Panchayati Raj Department are completely sidelined. During the last two weeks, several workshops were held across J&K on FRA, and in most of these programmes, Forest Department officials were either giving powerpoint presentations (PPTs) or were involved in other activities related to FRA. I am not against what they are doing. Their intentions might be good but as per the law they have a limited role as FRA goes against their interests. As FRA is in its infancy and has been recently rolled out by the J&K Government recently, I am trying my best to make Govt officials aware about this historic legislation through my regular columns. I have already written a lot of 10 articles on FRA in other media outlets. Through this media platform I want to continue with my advocacy and activism on the Forest Rights Act. This piece explains the role of Govt departments and preamble of FRA.


Preamble of FRA

The preamble of Forest Rights Act calls for recognizing and vesting the Forest Rights to the tribals and traditional forest dwellers. The preamble reads as

"An Act to recognize and vest the forest rights and occupation in forest land in forest dwelling Scheduled Tribes and other traditional forest dwellers who have been residing in such forests for generations but whose rights could not be recorded; to provide for a framework for recording the forest rights so vested and the nature of evidence required for such recognition and vesting in respect of forest land "

Explaining the background of this legislation plus aims and objectives to enact Forest Rights Act, the preamble further reads as:

"Whereas the forest rights on ancestral lands and their habitat were not adequately recognized in the consolidation of State forests during the colonial period as well as in independent India resulting in historical injustice to the forest dwell-

ing Scheduled Tribes and other traditional forest dwellers who are integral to the very survival and sustainability of the forest ecosystem and whereas it has become necessary to address the long standing insecurity of tenurial and access rights of forest dwelling Scheduled Tribes and other traditional forest dwellers including those who were forced to relocate their dwelling due to State development interventions "

Explanatio

A large population living in and around forests especially the scheduled tribes (Gujjars, Bakerwals in case of J&K) and other traditional forest dwellers (Kashmiris, Pahadis or even Dogri speaking people of J&K) have lived in these areas for a long period in symbiotic relationship. This relationship has led to formalized or informal customary rules of use and extraction, often governed by ethical beliefs and practices that have ensured that forests are not too degraded.

During the British rule colonial the focus shifted from the forests being used as a resource base for sustenance of local communities to a State resource for commercial interests like setting up of dams, railways and mining and development of land for agriculture. Several Acts and policies such as the Indian Forest Acts of 1865, 1894 and 1927 of the Central Govt and some state forest Acts curtailed centuries old, customary use rights of local communities. This continued even after independence till much later until enactment of The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. FRA was enacted in 2006 and rolled out in 2008 across India except J&K.

This law was not ratified by the JK legislature which it could have. Even the former Forest Minister Lal Singh claimed 370 was an impediment in extending FRA in J&K, but that should not have been the problem as Lal Singh was not in favour of giving rights to Gujjars and Bakerwals of J&K. There are several laws like GST which were ratified by J&K legislature in recent past and even central laws like Armed Forces Special Powers Act (AFSPA) or even NREGA were extended to J&K in-spite of article 370 having been in force that time. The Govt of J&K could have even enacted a similar law of its own in the past but even the Forest Ministers from Kashmir like Mian Altaf Ahmed also failed to do that. I believe he was not well advised by the Forest Bureaucracy in the past. After abrogation of article 370 the FRA got automatically extended to J&K, but from Oct 31st 2019 till December 2020 Govt failed to roll out this law. After Govt issued eviction notices by invoking an obsolete Indian Forest Act 1927, it infuriated the tribals and we also tried our best to impress upon the Govt to implement FRA 2006. The Govt started rolling out the law after the Chief Secretary himself made announcement of this news. The way law is being rolled out violates the basic principles and preamble of Forest

Rights Act (FRA). This needs to be looked into. As I said in the past, authorities also need to learn from the mistakes that were committed in other states during FRA implementation.

What experts say?

Veteran Forest Rights activist, researcher and columnist Y Giri Rao who heads Bhubaneswar based NGO Vasundhara while having an informal conversation with the author said that Forest Department is like an accused party under the Forest Rights Act, and it is not ethically right to involve them in awareness and implementation of the Act. "How can the petitioners get justice from respondents?" he questioned. Giri Rao says that mistakes being committed during the past across several Indian states should not be repeated in Jammu & Kashmir.

"If there are no officials of Tribal Affairs department available at Sub Division or Block level , let the Tehsildars and other officers be given a role like in case of Himachal Pradesh. For training Director Tribal Affairs J&K Govt and Director Panchayati Raj and District Panchayat Officers (DPOs) must play their role. In addition the elected panchayat representatives, village forest rights committee like BDC members , DDC members and even District Development Council Chairperson have a great role. They must understand their roles and responsibilities "said Giri Rao"

Conclusio

The aim of this article is not to undermine the forest officers. The land title in forest areas where tribals and traditional forest dwellers claim the rights is registered in the name of the forest department. Will the forest department allow free use of their land by such people? No they won't as this is a natural phenomenon. Let the law be implemented without any interference of the Forest Department. Axing of 10,000 apple trees by forest officials on November 18th 2020 at Kanidajan Budgam is a clear example before us that the forest department won't allow tribals and forest dwellers to claim the rights over the land that is under their possession. I appeal to the Chief Secretary to involve the Tribal Affairs Rural Development and Panchayati Raj Departments in FRA implementation. SDM's, District Panchayat Officers (DPOs), Block Development Officers (BDOs) and Tehsildars who already have a role under FRA need to be involved more for creating mass awareness on this law. FRA is not a rocket science, even a simple graduate if trained properly can become a master trainer "

PDD Employees on the Frontlines

and heavy snowfall several essential services are interrupted annually here in Kashmir. During these harsh colder months we also observe a department facing enormous flak from the people for not being able to ensure their services to the subscribers. which to an extent is completely understandable and justified. Yes, I am talking about the Jammu and Kashmir Power Development Department, a department which always remains on the receiving end of the blows from the people for providing erratic power supplies to Jammu and Kashmir, when a major proportion of it is being produced here and more production avenues are being explored and worked on. Although this is an ac-

ceptable fact that the higher officials of this department face genuine criticism but, there is a section of employees who are paid meagre amount of wages after months while they leave no stone unturned to discharge their duties. Pictures of daily wage workers of the PDD department surface on the internet often, showing them on the top of electric Iron poles in snow and rain trying to restore the power in areas affected by snow. Another side of these pictures is their financial sustenance, serious injuries and even deaths of such workers while fulfilling their duties due to electric shocks. Unpaid wages and the lack of regularisation of their jobs, and the Minimum Wage Act not being implemented, is hurting casual labourers in Jammu and Kashmir, especially those in the

PDD. They not only suffer due to the apathy they receive from the government alone, their families also have to go through an enormous amount of pain and trauma at a time when such a hard-working daily wage worker is rendered physically disabled for life or if such a worker dies on the field. A person employed as a casual labourer is entitled to receive a meagre amount of Rs 225 as their daily wage, many workers have a disdain towards the government claiming that their meagre wages are paid to them after months in installments. Meanwhile, the government's promise of implementing the Minimum Wage Act in the UT of J&K has not seen the light of day. PDD workers have been demanding the implementation of SRO 381 (part of Recruitment Rules) which

promises the regularisation of daily wagers who have completed seven years in the department.

Around one lakh casual labourers – daily wagers, need based workers and others – have been engaged in different departments including PDD

The Minimum Wage Act if implemented in Jammu and Kashmir will ensure an amount of Rs 520 on a daily basis to the workers. These unsung heroes deserve appreciation and acknowledgement of their efforts from us, while the government should also acknowledge their high risk job and implement The Minimum Wage Act which can raise their wages and ensure some sort of financial stability of their household.

COVID Vaccine: Is it Halal or Not?

The approved COVID-19 vaccines have been met with a mixed response from the Islamic theological community, halal associations and halal pharmaceutical experts as to whether the vaccine is halal, despite various governments' approval, including those of many **Muslim-majority** countries.

ven before the COVID vaccination process starts in India. The Indian Muslims have courted another controversy. The question is whether they'll be amenable to get vaccinated or not, as there are reports that the proposed vaccines may not be halal as per the Islamic dietary laws.

Muslims, Jews and even Hindus have questioned the composition of the proposed vaccines developed by Pfizer, Moderna, AstraZeneca and Bharat Biotech's Covaxin. Even as India is scrambling to start the coronavirus vaccination drive, Muslims have raised concern over the use of pork products – forbidden in Islam and Judaism, while the Hindus have questioned the inclusion of cow's blood in the vaccine.

Halal or haram

The vaccine manufacturers – Pfizer, AstraZeneca and Moderna – have rejected in vain the allegations of using pork gelatine. The manufacturers have clarified that pork products are not part of the vaccines, though pork-derived gelatine is known to be used as a stabiliser for safe storage and transportation of the vaccines.

The approved COVID-19 vaccines have been met with a mixed response from the Islamic theological community, halal associations and halal pharmaceutical experts as to whether the vaccine is halal, despite various governments' approval, including those of many Muslimmajority countries.

In the UK, the Pfizer-BioNTech vaccine, which is being given to the public, was approved by the British Islamic Medical Association (BIMA) and other Islamic scholars, stating the vaccine was halal "based on the information available."

According to the British government, the vaccine does not contain any components of animal origin, which has been a concern for Muslims as porcine, which is haram (non-permissible), or non-halal slaughtered beef could have been used

However, the Standards and Metrology Institute for Islamic Countries (SMIIC), a unit of the Organisation of Islamic Countries (OIC), has so far, not officially stated that the vaccine is halal or not halal. Ihsan Ovut, the Secretary General of SMIIC, in an email to an Islamic website, said there is "no specific standard developed on the halal-ness of COVID-19 vaccines."

A halal pharmaceuticals expert says the vaccine cannot be claimed as halal if they are not halal-certified. But this No is on technical grounds. According to Dr. Mohammed Ali Al Sheikh, who works at SMIIC, the halal certification has to be carried out by a competent third-party and can not be claimed by a manufacturer itself, which Prizer did. It is an opinion seconded by the World Ha-

Acceptance by Muslim countries

However, in spite of these flimsy or technical objections, Bahrain, Saudi



Arabia, Bangladesh, Malaysia, Indonesia, the UAE and Pakistan, countries which claim to be Islamic or are Muslim-majority countries, have approved the Sinopharm vaccine, while Singapore's government has authorised the Pfizer-BioNTech vaccine for use in the country. This step must have been taken after considering the religious sensibilities and analysis of the composition of these vaccines

In Singapore, which has a sizeable Muslim population, the Office of the Mufti of the Islamic Religious Council of Singapore (MUIS), stated on its website that the COVID-19 vaccine is "a basic necessity (daruriyyat)" as it is a life-saving inoculation. In Indonesia, the government has already said it will include the Muslim clerical body in the COVID-19 vaccine procurement and certification process.

Indian Ulema's view

In India, the controversy was stoked last week by Mumbai's Raza Academy, a Barelvi outfit, seeking details about all the vaccines being developed and whether they contain pork extract, from the WHO.

The Indian Islamic scholars, as usual are divided on the issue with the majority of them citing verses from the Holy Quran (Surah Nisa and Surah Baqara) to advocate for the vaccine, but not giving a clear-cut guidance to the Muslim populace.

Leading Islamic scholar Akhtarul Wasey, former professor of Islamic Studies at Jamia Millia Islamia, trying to put at rest the whole issue, opines that for Muslims pork and alcohol are not permissible for eating and drinking purposes, but if a part of these is used for medicinal purpose then it is allowed in Islam, as that medicine will be taken for the express purpose of saving life, which

is allowed in Islam. Furthermore, he asserted that according to Islamic jurists a person suffering from hunger for more than three days and nearer to death is also allowed to eat the meat of a dead animal, in order to survive.

Prof. Wasey urged the Muslim Ulema to be more proactive in this regard and appreciated the stand taken by Deoband and Nadwa, the two leading Islamic seminaries in this regard. He also reiterated the fact that the Polio drive in India was completed successfully and the scourge of Polio in India was wiped out after the intervention of Indian Ulema. In fact, Jamaat-e Islami Hind (JIH) has become the first Muslim body in India to categorically state that Muslims are permitted to use the Coronavirus vaccines, even if they contain pork extracts, as it sought to dispel all rumours suggesting otherwise

In an advisory, the Shariah Council of the JIH said, "Islam gives great importance to human life and also emphasises on its protection." It added: "If an impermissible object is transformed into another thing, totally different in properties and characters, it may be considered as clean and permissible. On this basis, the use of Gelatine derived from the body part of a haram animal has been considered to be permissible by Islamic jurists. Same is the opinion of some jurists about pork Gelatine."

It is not just Muslims in India, who were concerned about the composition of the vaccines. Swami Chakrapani, president of the Hindu Mahasabha, had written to President Ram Nath Kovind demanding that the government and pharmaceutical companies clarify whether Covid-19 vaccines contain cow's blood or not. But the Indian media coolly overlooked this letter.

There's a similar assessment by a broad consensus of religious leaders

in the Orthodox Jewish community as well. Rabbi David Stav, chairman of Tzohar, a rabbinical organisation in Israel, said, "According to the Jewish law, the prohibition on eating pork or using pork is only forbidden when it's a natural way of eating it. If "it's injected into the body, not (eaten) through the mouth," then there is "no prohibition and no problem, especially when we are concerned about a well-weepen."

Nonetheless, the Indian Muslims concerns as to whether the vaccine is halal or not, might be a challenge to convince people to be inoculated in addition to the anti-vaccination phenomena proliferating in many countries.

Meanwhile, there are reports that a halal-certified vaccine may however be on the horizon. Malaysia's MYEG inked a deal with China's Anhui Zhifei Longcom Biopharmaceutical to conduct Phase-3 clinical trials in Malaysia and to obtain halal certification, based on Malaysia's DSM standards for a COVID vaccine. Indonesia's state-owned PT Bio Farma, which is working with China's Sinovac Biotech Ltd, has also confirmed that it is seeking halal certification for the COVID-19 vaccine.

In the given circumstances it would be pertinent for Indian Muslims to decide for or against the vaccine, as per the conditions. Even the Indian government has not made the vaccination mandatory, so far. So it seems it would be better to err in fayour of caution and need.

The Div Com, he said, directed concerned to ensure land acquisition process is completed with release of compensation to the land losers at the earliest.

"The Div Com also reviewed the status of various other projects including approach roads of Srinagar-Zojila and Kargil, Gulmarg-Baramulla Highway, Vailoo-Donipawa Ashajipora Alstop besides various other proposed road projects in Kashmir," he said, adding "Div Com directed concerned to put all men and machinery into service and expedite the work process,"

As per the official spokesperson, the meeting was informed that the deadline for the tunnel is December -21, 2023 however, a bonus upto Rs 400 crores shall be provided to the concerned agency if the project is completed before it's set deadline.

Among others, the meeting was attended by Executive Director, NHIDCL, Anand Pahal, Commandant HAWS, CE Beacon and other concerned. While DC Kargil and ADC Ganderbal other concerned also attended the meeting through videoconferencing.

Night Temperature

from minus 9.6 degrees Celsius the night earlier. Gulmarg was the coldest recorded place in the valley. Pahalgam tourist resort in south Kashmir, recorded a low of minus 5.3 degrees Celsius, down from minus 4.6 degrees Celsius a night earlier.

Qazigund recorded a minimum of minus 1.4 degrees Celsius, Kupwara, in the north, minus 1.8 degrees Celsius and Kokernag minus 3.9 degrees Celsius. The weatherman has predicted generally dry

weather over the next few days. Kashmir is currently under the grip of 'Chillai-Kalan' -- the 40-day harshest winter period when a cold wave grips the region and the temperature drops considerably leading to the freezing of water bodies, including the famous Dal Lake here as well as the water supply lines in several parts of the valley.

The chances of snowfall are the most frequent and maximum during this period and most areas, especially in the higher reaches, receive heavy snowfall.

Farmers Refuse To

the government said the order to stay the implementation of three new farm laws is against its wish but the direction of the apex court is 'sarva-manya' (acceptable to all) and welcomed the composition of an "impartial" committee to resolve the deadlock.

In an interview to PTI, Minister of State for Agriculture Kailash Choudhary made these remarks and also said he is confident that whatever decision is taken by the court, that will be "taken to ensure that the laws are kept the way they are.'

While opposition parties like NCP and DMK welcomed the SC order and hoped that it will help in resolving the deadlock, the Congress leaders expressed apprehensions over the members chosen for the committee, saying they are known for their support to the three Acts and the agitating farmers.

In a statement, All India Kisan Sangharsh Coordination Committee (AIKSCC) said,"it is clear that the court is being misguided by various forces even in its constitution of a committee. These are people who are known for their support to the 3 Acts and have actively advocated for the same.'

Congress leader Rahul Gandhi also raised questions over the formation of the committee, asking can justice be expected from people who have given written support to the "anti-agriculture laws". "This struggle will continue till anti-farmer-worker laws are repealed. Jai Jawaan Jai Kisaan," he tweeted.

Addressing a press conference, Congress' chief spokesperson Randeep Surjewala said the party welcomes the Supreme Court's concern over the farm laws, but the party has issues with the composition of the committee formed by it.

He said the members of the committee have already expressed their views in the past favouring the new laws "so the question arises in our minds that how justice will be done to farmers by their hands".

Asserting that any order of the Supreme Court has to be complied with by all the concerned parties, BJP spokesperson Nalin Kohli attacked the Congress for its criticism of the court-appointed committee.

The Congress' stand and conduct on the agricultural laws is a "classic testimony towards its duplic-

ity and opportunistic politics practised since 2005". The BJP has said the Congress-led UPA government had supported farm reforms but the opposition party has now taken a U-turn due to political reasons.

While staying the laws, the top court set up a fourmember committee to resolve the impasse between the Central government and the farmers' unions protesting at Delhi's borders over the legislations.

The four members of the committee are Bhupinder Singh Mann, President of Bhartiya Kisan Union; Anil Ghanwat, President of Shetkeri Sangthana, Maharashtra; Pramod Kumar Joshi, director for South Asia, International Food Policy Research Institute, and agriculture economist Ashok Gulati.

Addressing a press conference at Singhu (Delhi-Haryana) border, farmer leaders claimed the members of the committee formed by the top court are "pro-government".

"The members of the SC-appointed committee are not dependable as they have been writing on how agri laws are pro-farmer. We will continue our agitation," farmer leader Balbeer Singh Rajewal told the press conference. "We are against the committee on principle. It is the government's way to distract attention from the protest," he said.

The farmer leaders also said the Supreme Court can repeal the farm laws suo motu.

"We welcome the court's order to stay the implementation of the farm laws, but we want a complete repeal of these laws, which is our main demand," said Abhimanyu Kohar, a senior leader of the Sankyukt Kisan Morcha (SKM), an umbrella body of around 40 protesting farmer unions.

Another farmer leader, Harinder Lokhwal, said the protest will continue until the contentious farm laws are repealed. Senior Congress leader P Chidambram said the concern expressed by the Supreme Court over the farmers' protests is "justified and welcome in the situation created by a stubborn government".

"The decision to form a Committee to help find a solution is well-intentioned. However, the composition of the four member committee is puzzling and sends contradictory signals," he said on Twitter.

Another Congress spokesperson Jaiveer Shergill tweeted, "After Supreme Court stay order, Agriculture Minister must resign as it is the total incompetence, irrational & irresponsible behaviour of the BJP Govt due to which Judiciary had to step in-Stay Order is a tight legal slap on BJP dictatorial law making and imposing mechanism."

Nationalist Congress Party Chief Sharad's Pawar also welcomed the apex court's decision to put on hold the implementation of three farm bills and set up the committee to resolve the issues.

"It is a big relief for farmers and I hope that a concrete dialogue between the Central government and farmers will be initiated now, keeping the farmers interests and wellbeing in mind," he said.

Echoing similar views, DMK chief M K Stalin also welcomed the decision of the Supreme Court, saying

this is a victory for farmers protesting across India. "I once again urge the Union government to commit to repealing the farm laws in the next Parliament Session," he said.

Meanwhile, Punjab Chief Minister Amarinder Singh has asked the state Advocate General to examine in detail the Court order and called a meeting of his cabinet to discuss it, the CM's media advisor said.

The top court has sought the cooperation of the protesting farmers and made it clear that no power can prevent it from setting up a panel to resolve the impasse over the controversial farm laws.

Thousands of farmers, mostly from Haryana and Punjab, have been protesting at several border points of Delhi since November 28 last year, demanding a repeal of the three laws and a legal guarantee to the minimum support price (MSP) system for their crops.

Enacted in September last year, the three laws have been projected by the Centre as major reforms in the agriculture sector that will remove middlemen and allow farmers to sell their produce anywhere in the country.

However, the protesting farmers have expressed their apprehension that the new laws would pave the way for eliminating the safety cushion of the MSP and do away with the "mandi" (wholesale market) system, leaving them at the mercy of big corporates.

Court Charges Yasin

Rubaiya Sayeed was kidnapped by JKLF members on December 8, 1989, from Srinagar to ensure the release of their associates lodged in different jails.

From the confessional statements of the accused persons recorded, either under Section 164 CrPC or under Section 15 of TADA Act, supported with the statements of the abductee Rubaiya Sayeed and other prosecution witnesses, it has been prima facie proved that the accused persons have hatched a criminal conspiracy to kidnap the abductee with sole objective to get their persons released from the custody after having negotiation with the Government of I&K as well as Government of India and the accused persons had also succeeded in their nefarious designs and got their persons released from the custody.

I am of the considered view that sufficient grounds are existing for drawing prima facie presumption that the accused persons namely Malik, Ali Mohd Mir, Jobal Ahmed Gandroo, Manzoor Ahmed Sofi, Mehrai-u-Din Sheikh and Rafiq Ahmed Pahloo have committed offences under Sections 364/368 /120-B RPC, 3/4 TADA Act & 27 IA Act, whereas, the accused persons namely Mohd Zaman Mir, Javed Ahmed Mir, Wajahat Bashir and Showkat Ahmed Bakshi have committed offences under Sections 120-B read with Sections 368 RPC and Section 3/4 of TADA Act, the Special Judge said.

Hence, the court said, the charges are required to be framed against each of the accused persons, separately, for the delineated offences. During the investigation, accused Ali Mohammad Mir had voluntarily made the confessional statement under Section 164 CrPC before the Magistrate, whereby, he had admitted his role in the commission of offence as well as disclosed the role played by the other accused persons.

Another accused Mohammad Zaman Mir had in the same manner made a confessional statement under Section 164 CrPC before the concerned Magistrate and had disclosed his own role and the roles of other accused persons in the commission of the offence, the court said.

It said the accused, Iqbal Ahmed Gandroo, had also made a confessional statement admitting his guilt and role played by him in the whole occurrence. Besides, the accused persons namely Rafiq Pahloo, Wajahat Bashir, Manzoor Ahmed Sofi and Showkat Ahmed Bakshi had made their confessional statements before Prakash Mishra SP CBI, which is found to be admissible in evidence under Section 15 of TADA Act, the court added.

Since the accused persons besides admitting of their own guilt have also narrated about the participation of other accused persons namely Yaseen Malik, Javed Ahmed Mir and Mehraj-U-Din Sheikh, which can also be used against them as one of the pieces of evidence, the court said. It said the investigating agency has also conducted Test Identification Parade of the accused persons, Ali Mohd Mir, Mohd Rafiq Dar and Mohd Iqbal Gandroo, as per the provision of Section 9 of the Evidence Act and during that proceedings the abductee had identified them and disclosed about the individual participations of each of the accused persons in the commission of offences.

"We are prepared to hold our ground as long as it takes to achieve our national goals and objectives. The Army chief said the Indian troops are maintaining a high level of alertness all along the LAC and not just in Ladakh.

"Our operational preparedness is of a very high order and the morale of the troops is high. Whatever has transpired in the last year has highlighted the need for us to restructure and for us to enhance our capability," he added.

Asked about the actual situation in eastern Ladakh, Gen Naravane said it remains the same that was prevailing last year, and there has been no change in status quo. To another question on the same issue, he said the situation remains the same whatever existed earlier.

India and China are locked in a military standoff in eastern Ladakh since May 5 last year. Referring to the overall security challenges facing India, he said Pakistan and China together form a

potent threat to national security. "There is no doubt that Pakistan and China together form a very potent threat and there is an aspect of collusivity which cannot be wished away. That is also very much part of our strategic planning and calculus when we are formulating our plans," he said.

Gen Naravane said there has been an increasing cooperation between China and Pakistan in both military and non-military sectors and the possibility of a twofront threat is something India should be prepared for.

When queried on China's mobilisation of troops in May last year, the Army chief said it was not new as they came to the region for training and India was monitoring them. However, he added the Chinese Army had the "first mover advantage". "We had the first mover advantage in August as they did not know we will surprise them," he said, in an apparent reference to Indian Army capturing a number of strategic heights along the Pangong lake in August last year. Gen Naravane also said China has withdrawn some troops from depth areas on conclusion of training and noted there is no reduction in deployment of personnel at the frontline.

"Every year PLA (People's Liberation Army) troops come to traditional training areas for training. With the onset of winters and completion of the training period, the training areas have been vacated and since these training areas have been vacated, it is fair to assume that those troops who were in depth areas on the Tibetan Plateau have gone back to their garrison," he added.

"However there is no decrease in strength either on their side or on our side as far as friction points are concerned." On Pakistan, Gen Naravane said the country continues to use "terrorism" as an instrument of state policy and India will continue to confront the menace effectively.

"Pakistan continues to embrace terrorism as an instrument of state policy. However, we are very clear that we have zero-tolerance for terror and we reserve our right to respond at a time and place of our own choosing and with precision. This is a clear message that we have sent across," he added.

Gen Naravane said the Army is carrying out restructuring with an aim to transform it from manpower-driven force to technology-intensive force, adding it is looking at application of high-end technologies like big data, artificial intelligence and quantum computing. He also said the Army is fully committed to tri-services jointness and proposals on having integrated commands.

and intimidating altitudes to keep communication lines opened. "Winter snow clearance task this year has been particularly more challenging considering the altitude, extreme weather and the heavy deployment of the troops along the LAC," a senior BRO official said.

Officials said that BRO personnel deployed at altitudes ranging from 16,500-18,000 feet are relentlessly executing the winter snow-clearance.

They said the strategically important road axes and prominent mountain passes where the snow-clear ance operations are carried out include Changla, Warila, Marshimikla , Kajukondla, Kassangla, Umlingla, besides the Durbuk-Shyok-Daulat Beig Oldie Road.

During the winters, the only existing road axis connecting DBO in Sub Sector North, Hot Spring and Chushul in Eastern Ladakh, and gateway to Changthang Sector of Ladakh (via Changhla and Warila passes) gets blocked due to heavy accumulation of snow.

Officials said that to provide sustenance to troops deployed in these areas amid the tension with China, road construction companies are working tirelessly to keep the roads open and ensure connectivity all through the winter.

"To keep the roads open, meticulous planning and resources mobilisation were undertaken and adequate advance winter stocking including that of equipment spares and winter diesel was done," one of them said.

who was flanked by senior party leaders from both Kashmir and Jammu regions, told reporters here after felicitating party candidates and independents who successfully contested the recently held District Development Council (DDC) elections.

He said the prime minister made a promise about the restoration of the statehood to the JKAP delegation when they called on him after formation of the party last year.

Criticising the opponents, he said, Our detractors attacked us for our meeting with the prime minister and home minister. There were some who were thinking that statehood will be restored in due course of time but we know it is a hard battle and we have to work jointly to achieve this.

On August 5, 2019, the central government scrapped the special status of J-K under Article 370 and bifurcated it into union territories.

We take the credit for restoring politics in J-K. Politics was said goodbye on August 5, 2019 (when the majority of the leaders including three former chief ministers were detained). We came forward though the decision of August 5 was not in good taste for us as well. The people want restoration of statehood and safeguards for their land and jobs, he said.

Referring to the various PIL's pending in the Supreme Court challenging the Centre's move, Bukhari said they are expecting a decision form the Supreme Court which is in accordance with the heart-beat of the people of J-K.

Batting for early assembly elections after the successful conduct of the recently held DDC polls, the JKAP leader said the people want a popular government so that their problems get solved.

We want assembly elections to be held sooner even before the completion of the delimitation process. The delimitation process can complete its work of creating seven more seats. We used to nominate two seats, let it be seven this time around as you have already changed so much and this will make no difference, he said, adding at least people will get a popular government which is responsive, responsible and answerable to them. He claimed that the present administration is paralysed and both the regions are facing a lack of developmental work and administration inertia.

You (Prime Minister) are told that a lot had happened in J-K over the past two and a half years. For God's sake, send a team which does not restrict itself to computer presentations and can see practically whether anything had happened, he said.

Bukhari said, We do not see any development taking place in any of the two regions. Development has come to a grinding halt and the administration is paralysed and restricted to advertisements only. People are facing a lot of problems. He also demanded a probe into the frequent closure of the Jammu-Srinagar national highway and the ongoing four-laning project.

Jammu-Srinagar highway is the lifeline as far as national security is concerned. Why there should be no CBI probes against engineers and contractors who vandalised the hills overlooking the strategic highway. They should be booked under national security act, he said, adding there was no preparedness of the administration to tackle the situation in the aftermath of the snowfall which is a regular feature during winters.

Referring to the continued snapping of 4G mobile internet services in most of J-K post-August 5 development, he said there is a lot of improvement as far as security scenario is concerned as militancy-related incidents had come down and there was a peaceful DDC election as well so there is no justification in the ban.

Our children are suffering because they are unable to attend online classes. Prime Minister, you are very brave and have a lion's heart so please give them 4G as they are the future of this country, the JKAP leader said.

He also demanded the release of youth undergoing detention and said now is the time for normalcy and reconciliation. Those who have gone astray are coming back and need a rehabilitation package, he said and called for a stipend of Rs 10,000 for unemployed educated youth and said they cannot wait for three to four years for reaping the benefits of the recently announced industrial package. Bukhari also demanded covering of the old unit holders in the new industrial package

"The criminal proceedings can be quashed only when the matter that is essentially of civil in nature has been given a cloak of criminal offence," the court said, adding, "From the perusal of allegations it is not made out that civil dispute has been camouflaged as criminal dispute. So this contention also deserves to be rejected.

as physical checkups in Kashmir? No, only 15 to 20% Kashmiris are mindful of the need of regular eye-checkups to prevent ailments. Are there any eye conditions which are stigma

tized in our society? Many, actually. And one of the most common stig-

matized disorders is the refractive errors among girls. If girls are wearing thick glasses, it becomes a problem at the time of their marriage. So in order to get rid of the glasses, we do offer them a number of treatments like Lasik laser or a refractive lens exchange. With advanced technology, we can get rid

of eyeglasses, up to a power of minus 25. Other than that, squint patients face a lot of challenges. For that as well, we've a full-fledged department. We counsel the patients and their parents to

seek treatment.

With the unavoidable usage of smart gadgets and screens, our eyes have become more vulnerable to problems. What are the tips that you would like to give to people to take care of their eve health?

People using gadgets should take a break every 20 minutes for 20 seconds. We call it 2020 rule. They should just look toward the far-off objects or keep their eyes closed. Also, people using gadgets for a longer period of

'This Is Apartheid': Rights **Group Slams Israeli Rule**

leading Israeli human rights A group has begun describing srael and its control of the Palestinian territories as a single "apartheid" government, using an explosive term that the country's leaders and their supporters vehemently reject.

In a report released on Tuesday, B'Tselem said Israel has created a system in which Jewish citizens enjoy full rights, but Palestinians living in Israel's four areas of control have different levels of rights – depending on where they live - are always below the Jewish people.

"One of the key points in our analysis is that this is a single geopolitical area ruled by one government," said B'Tselem director Hagai El-Ad. "This is not democracy plus occupation. This is apartheid between the river and the sea.'

The report said Israel seeks to advance and cement Jewish supremacy throughout the entire area between the Jordan River and the Mediterranean Sea.

"To that end, it has divided the area into several units, each with a different set of rights for Palestinians - always inferior to the rights of Jews," the report said.

As part of this policy, Palestinians are denied many rights, including the right to self-determination, the report added.

The four areas of Israeli control are the occupied West Bank where Palestinians live in dozens of disconnected enclaves under rigid military rule; occupied East Jerusalem where Palestinians are permanent residents but not citizens; the blockaded Gaza Strip which Israel continues to control externally; and Israel itself.

Israel has long presented it-

self as a thriving democracy and purported that its Palestinian citizens, who make up about 20 percent of its population of 9.2 million, have equal rights.

However, these Palestinians suffer from being treated as second- or third-class citizens at the institutional level, with some 60 laws that actively discriminate against them in sectors such as housing, education and healthcare.

The report went on to describe four methods used by Israel to advance Jewish supremacy: freedom of movement, political participation, exclusive immigration, and expropriating land for its Jewish citizens while crowding Palestinians in enclaves.

Israel's harshest critics have used the term "apartheid" for decades, evoking the system of white rule and racial segregation in South Africa that was brought to an end in 1994. The International Criminal Court defines apartheid as an "institutionalised regime of systematic oppression and domination by one racial group".

"There is no country in the world that is clearer in its apartheid policies than Israel," said Nabil Shaath, a senior adviser to Palestinian Authority President Mahmoud Abbas. "It is a state based on racist decisions aimed at confiscating land, expelling indigenous people, demolishing homes and establishing settlements."

Itay Milner, a spokesman for Israel's consulate general in New York, dismissed the B'Tselem report as "another tool for them to promote their political agenda," which he said was based on a "distorted ideological view". He pointed out that Arab citizens of Israel are represented across the government, including the dip-



Gold Mine Explosion In China Traps 22 Workers Underground

hinese authorities have sent rescue workers to a gold mine in ►the country's northeast after 22 workers were trapped underground following an explosion, the Xinhua news agency reported on Tuesday. The accident happened on Sun-

day in Xicheng Township, located in eastern Shandong province. In a social media post, the state-

run Global Times newspaper cited Shandong authorities as saying that rescue workers had so far been unable to contact the trapped miners. According to Xinhua, the blast

damaged the communication signal system underground, preventing communication.

Xinhua says the mine is owned by Shandong Wukailong Investment, which is named by Zhaojin Mining, China's fourth-biggest gold miner, as a related party or "subsidiary of an associate" in its 2019 annual report. China's mines are among the world's deadliest.

In December, at least 18 people also died after being trapped in a mine in China's southwestern city of Chongaing, the region's second such accident in just over two months.

The dead were among 24 people trapped underground by excessive levels of carbon monoxide gas at the Diaoshuidong coal mine.

In September, at least 16 were killed after high levels of carbon monoxide trapped miners at the Songzao coal mine in Chongqing.

Turkish TV Preacher Jailed For 1,000 **Years Over Sex Crimes**

ISTANBUL: A Turkish court on Monday sentenced a Muslim televangelist who surrounded himself with scantily clad women he called "kittens" to more than 1,000 years in jail for sex crimes.

Adnan Oktar preached creationism and conservative values while women in revealing outfits - many of whom appeared to have had plastic surgery — danced around him to upbeat music in the TV studio.

The bearded 64-year-old was detained in 2018 along with more than 200 other suspects as part of a crackdown on his group by the financial crimes unit of the Istanbul police.

He was sentenced to 1,075 years for crimes including sexual assault, sexual abuse of minors, fraud and attempted political and military espionage, the private NTV broadcaster reported.



The court also sentenced two executives in Oktar's organisation, Tarkan Yavas and Oktar Babuna, to 211 and 186 years, respectively.

The official Anadolu news agency reported that Oktar was additionally found guilty of aiding a group led by US-based Muslim preacher Fethullah Gulen that Turkey blames for staging a failed coup attempt in 2016.

While there was a single pro-Trump protester in evidence, two counter-protesters appeared to applaud Twitter's decision to deplatform the outgoing president, reports The Verge.

Twitter's San Francisco headquarters was empty, with employees working from home during the

ongoing pandemic. There was still a heavy police presence and at last 30 police officers were present at the site to

protect against mob violence.

Angry at Twitter which perturned up during a pro-Trump rally manently removed Trump from its platform following the Capitol chaos last week, his supporters planned a rally at the company's headquarters on Monday.

The posts on a popular internet forum for Trump supporters called for the President's adherents to protest his Twitter ban outside of the company's headquarters.

Posts on TheDonald.win, an independent far-right internet forum, called for supporters to gather outside of Twitter's headquarters in

San Francisco to protest the ban. A Twitter spokesperson had said that the company's highest priority was workers' safety.
