Union Minister of State for Home G Kishan Reddy said the government of Jammu and Kashmir has reported that in view of the constitutional changes effected by the Parliament with regard to the erstwhile state of Jammu and Kashmir in August 2019, various measures were taken in the interest of security and public order which included preventive detention of certain persons.

"Since August 1, 2019, 627 people including separatists, over ground workers, stone pelters etc., were detained at various points of time.

Out of these, based on regular review and ground situation, 454 persons have been released till date," he said in a written reply to a question.

In Conversation With Farah Bashir

arah Bashir's new book, Rumours of Spring, is a memoir of a teenaged girl, who grew with the turmoil. It will be out in April 2021.

She talks to Kashmir Observer in an exclusive interview. YASH DAIV (YD): Rumours of

Spring is a voice that is never-before heard: That of a teenage girl. What prompted you to write this memoir?

FARAH BASHIR (FB): To articulate the silences of a young girl who is navigating her life in a war and confronting it when all she wanted was

YD: In your mind, what is the first picture of the siege? What did you see and how did you understand that something was not right?

FB: The year was 1989 and I was a few months away from becoming a teenager. It was on the eve of Eid. The day that started on a happy note ended in an interminable night. The opening chapter of my book comprises that memory.

My sister and I had gone to a salon to get a haircut and by the time we came out, the world as we knew it had completely transformed. The celebratory air had turned funereal. A strange bluish hue had descended upon the city; there were shards of glass and squished toys on the streets. Streets were deserted as a curfew had been announced.

After that metamorphic hour, the years that followed became a series of sharp contrasts: of love and loss, life

and death, uncertainty and hope. **YD:** What were the little changes you had to make when Kashmir was militarised? How did it invade your domestic space?

FB: The memoir documents most changes, both internal and external, that were brought about by the insurgency and dense militarisation.

Parts of our home became inaccessible, bunkers became the new landmarks, the way young girls dressed was no longer the same, some food habits changed, the games that we played as children changed too. Newer rituals were formed in homes.

Old ones vanished.

The book documents juxtaposition of the old and new realities.

YD: As a teenage girl, what fears did

FB: The fear of returning home to a dead family member loomed at large. It had happened to a few friends of mine, who lost their parents and grandparents to stray bullets or to motivated assassinations.

That fear of losing a loved one at any time, brutally, cast a shadow even before I had turned thirteen.

I grew up on a bustling street in the old city of Srinagar that was rarely quiet. When the night curfew was imposed for nearly a decade, I struggled to fall asleep to the • More On P10

APPEAL TO GENERAL PUBLIC

Poplar tree or 'Safeda' locally called as "Frass" in Kashmir, is a tall tree grown across the Kashmir valley mainly by farmers on their farm lands. This tree could be male as well as female. It is only the female poplar trees which produce seeds enveloped in a cottony fluff which is released during the months of April-May along with seed. This cotton fluff which is also called as Russi is taken as nuisance and is disliked in general due to various reasons for the purpose of seed dispersal.

To overcome the issue of cotton shed by female poplar trees in the months of April -May, people in general, farmers and private nursery owners in particular are requested to note and follow the information/ suggestions given below and cooperate in dealing with the problem:

- Cotton is produced only by female poplar trees for seed dispersal. No cotton at all is produced by male poplars.
- 2. Female poplars must not be planted near or around homes, along banks of streams, rivers, near or around places of public importance like schools, hospitals . This is as per the directions of Hon'ble High Court.
- All such female poplars who have attained a girth of four feet and above must be harvested in phased manner and same be replaced by planting alternative trees but not female poplar.
- Raising and planting of male poplars be followed. 4.
- 5. Farmers and private nursery owners are advised to stop raising and planting of female poplars as well as selling the same in open market.
- Lopping of female poplars must be done upto 2/3rd height in the beginning of April every year or before the onset of flowering season. Identification of female poplars can be done on the basis of colour of catkins which are large and greenish in female poplars. Technical guidance in this regard can be sought from Social Forestry Department.
- 7. People must use face mask in the months of April and May as a precautionary measure.
- There is no link between cotton fluff from female poplars and pollen, as pollen is produced by male poplars and is invisible to human eye. Please note that the general perception that cotton produced by female poplars is pollen, is totally baseless and a myth only.

Srinagar: Asking the administration to ensure availability of mutton, Kashmir Traders Alliance Tuesday expressed concern over the shortage of mutton amid a tussle between the administration and mutton dealers over meat prices.

Ajaz Shahdhar, president of Kashmir Traders Alliance, said that the government had increased the price of meat by Rs 35 per kg in just four months, but the stubbornness of the butchers is a concern.

"If selling meat at government prices by butchers and wholesalers is proving to be a loss to their business, how can kababs and roasted meat be

available on roadsides, apart from restaurants and hotels,' Shahdhar questioned.

He said that apart from the sick and needy, meat is not being made available to the marriage functions and is being provided to hotel owners at extra prices. Shahdhar also demanded from the administration to start a massive crackdown on those who sell meat in the black market.

President of the alliance said that he was ashamed that meat was not available to the people of the valley on a holy festival like Miraj-ul-Alam, and it was not only a matter of concern for the administration and mutton dealers, but also a sense of embarrassment for them.

US Presents Warring Afghan Sides With Draft Peace Agreement

¬rustrated by a stalled peace process and escalating violence, the US has presented an eight-page draft peace agreement to Afghanistan's warring sides for review

The US told the parties to come to Turkey in the coming weeks ready to move on it, according to Afghans on both sides of the table

The draft was obtained by The Associated Press on Monday. The document outlines the terms of a cease-fire and its enforcement, calls for the protection of the rights of women, children and minorities and envisions a truth and reconciliation commission aimed at healing 42 years of conflict.

US State Department spokesman Ned Price would not confirm the draft, saying It's often important for our diplomatic efforts that we're able to conduct them in private." The Taliban received the draft and were reviewing it, said spokesman Mohammad Naeem. There was no immediate comment from Afghan President Ashraf Ghani on the draft proposal or a sternly worded letter from US Secretary

troops, saying it would cause chaos. She confirmed that all sides had received the US-crafted draft agreement.

One thing that is important is that Afghan ownership and Afghan leadership must be respected, she said in a phone interview from Doha.The process should not be rushed.

Blinken's letter proposes a revised plan for a 90-day reduction in violence that would prevent the start of a spring offensive by the Taliban and would be followed by a permanent cease-fire laid out in the draft peace agreement.

Both sides would stop fighting within hours of the agreement being signed, according to the draft. The Taliban would remove all its military and military structures from neighbouring countries a reference to Pakistan, where the leadership currently resides. The draft agreement also calls for an independent commission to oversee cease-fire violations.

The preamble of the U.S. document says the draft peace agreement is intended to jumpstart negotiations.

It sets forth principles for governance, security, and rule of law and presents options for power



of State Antony Blinken.

In the letter, Blinken said Washington wanted to see progress on peace talks and mentioned the draft peace agreement, which calls for a new, inclusive government which Ghani has resisted. In recent speeches, Ghani has said no interim government would be formed as long as I am alive.

But Blinken was uncompromising in his letter, which was released by Afghanistan's TOLO TV. I am making this clear to you so that you understand the urgency of my tone regarding collective work, he wrote.

In the letter, Blinken said a May 1 deadline for a final withdrawal of US troops stipulated in a Taliban-US deal last year is still on the table. Even with America's \$4 billion in aid to Afghanistan's National Security Forces, a US withdrawal could mean quick territorial gains for the Taliban.

Ghani's first vice president, Amrullah Saleh, said the president had received the letter and was unmoved by its contents. He said Ghani was not ready to embrace the secretary of state's accelerated pace toward a settlement.

We are neither concerned about the letter nor has it changed our position, Saleh said. He thanked the US for its sacrifices and financial assistance over the past 20 years but said the Afghan government won't succumb to dictation.

"We will make peace with dignity, but never . . . an imposed peace, he said at a ceremony on the anniversary of the death of a former defense minister. Ghani has been accused by his political opponents of trying to cling to power at all cost.

Fawzia Koofi, one of only four women at the negotiation table in Doha, warned against haste and a May 1 withdrawal of US

sharing that could help the two sides reach a political settlement that ends the war, it says.

The preamble portrayed the draft as a compilation of ideas and priorities of Afghans on all sides of the political spectrum.

The draft lays out an ambitious road map that protects the rights of all, guarantees elections, demands transparency and a fight against corruption and the illicit drug trade. It demands guarantees of noninterference from Afghanistan's neighbours and guarantees from Afghanistan that the country won't be used to attack or interfere with another.

It proposes the establishment of a peace government that would oversee the writing of a new constitution and elections held immediately afterward. The new constitution is to protect the rights gained in the last 20 years since the toppling of the Taliban.

According to the draft, the peace government would include separate, but equal branches, including the judiciary, and executive branch.

The draft also said there will be one national government, no parallel governments and no parallel security forces, which would mean an end to Taliban fighters and the many militias loyal to warlords holding sway in Kabul.

It promises to protect Islamic values and while an independent iudiciary would have the ultimate authority, the High Council for Islamic Jurisprudence would have an advisory role.

The new peace plan offers a chance for a ceasefire, it offers a chance to bring the Taliban from the battlefield to the talks table to discuss thorny issues of religion and its role in (the state), without giving them all the power, said Torek Farhadi, former Afghan government adviser.

US Vows To Defend Saudi Arabia After **Attack On Key Oil Site**

The United States said its commitment to defend Saudi Arabia is "unwavering" after oil infrastructure in the kingdom came under missile and drone attack.

"The US embassy condemns the recent Houthi attacks on the kingdom of Saudi Arabia," the American mission in Riyadh said via Twitter.

'The heinous attacks on civilians and vital infrastructure demonstrate their lack of respect for human life and their lack of interest in the pursuit of peace."

The attacks on Sunday were intercepted, Saudi Arabia said, and oil output appeared to be unaffected. But the latest in a spate of assaults claimed by Iran-backed Houthi rebels in Yemen briefly

pushed oil prices to above \$70 a barrel for the first time since January 2020.

The attacks are the most serious against Saudi oil installations since a key processing facility and two fields came under fire in September 2019, cutting production for about a month and exposing the vulnerability of the kingdom's petroleum industry.

'Begged Them Not To Shoot Children': Nun Kneels In Front Of Myanmar Police To Stop Violence

Video showed Sister Ann Rose Nu Tawng in a white robe and black habit kneeling on a street in the town of Myitkyina on Monday, speaking to two policemen who were also kneeling.

"I said, I don't want to see any trouble here and can't leave if police don't leave," she said. "I begged them not to shoot the children.'

Tawng and one of the policemen then touched their foreheads to the ground. At least two protesters were



killed by gunshots at the head and three others were injured in the town on Monday, witnesses said.

Tawng had also come between protesters and police lines late last month, pleading for peace, local

media reported.

Summers In Northern Hemisphere May Last Half The Year By 2100: Study

ummers in the Northern Hemisphere may last for six months by 2100 without efforts to mitigate climate change, which could have far-reaching impacts on agriculture, human health and the environment, says a study. The research, published in the

journal Geophysical Research Letters, found that the Mediterranean region and the Tibetan Plateau have experienced the greatest changes to their seasonal cycles. The researchers noted that the four

seasons arrived in a predictable and fairly even pattern in the Northern Hemisphere during the 1950s.

However, climate change is now driving dramatic and irregular changes to the length and start dates of the seasons, which may become more extreme in the future under a businessas-usual climate scenario, they said. "Summers are getting longer and

hotter while winters shorter and warmer due to global warming," said lead author Yuping Guan from the Chinese Academy of Sciences.

The researchers used historical daily climate data from 1952 to 2011 to measure changes in the four seasons" length and onset in the Northern Hemisphere.

They defined the start of summer as the onset of temperatures in the hottest 25 per cent during that time period, while winter began with temperatures in the coldest 25 per cent.

The team used established climate change models to predict how seasons will shift in the future.

The study found that, on average, summer grew from 78 to 95 days between 1952 to 2011, while winter shrank from 76 to 73 days. Spring and autumn also contracted from 124 to 115 days, and 87 to 82 days, respectively.

Accordingly, spring and summer began earlier, while autumn and winter started later. If these trends continue without any effort to mitigate climate change, the researchers predict that by 2100, winter will last less than two months, and the transitional spring and autumn seasons will shrink further as well

"Numerous studies have already shown that the changing seasons cause significant environmental and health risks." Guan said.

The researchers said, for example, birds are shifting their migration patterns and plants are emerging and flowering at different times.

These phenological changes can create mismatches between animals and their food sources, disrupting ecological communities, they said.

Seasonal changes can also wreak havoc on agriculture, especially when false springs or late snowstorms damage budding plants, according to the researchers. With longer growing seasons, humans will breathe in more allergy-causing pollen, and diseasecarrying mosquitoes can expand their range northward, they said.

US CDC Unveils Guidance For Fully Vaccinated People



WASHINGTON: The US Centers for Disease Control and Prevention (CDC) issued its first set of recommendations on activities that people who are fully vaccinated against Covid-19 can safely resume. They can visit other fully vaccinated people indoors without wearing masks or staying 6 feet apart, according to the guidelines issued on Monday.

Fully vaccinated people can also visit unvaccinated people from another household indoors without wearing masks or staying 6 feet apart if everyone in the other household is at low risk for severe disease, Xinhua news agency quoted the CDC as saying. Meanwhile, fully vaccinated

people can refrain from quarantine and testing if they do not have symptoms of Covid-19 after coming in contact with someone who is infected. The CDC defines people who

are fully vaccinated as those who are two weeks after receiving the last required dose of vaccine. "There are some activities that

fully vaccinated people can begin to resume now in their own homes. Everyone, even those who are vaccinated, should continue with all mitigation strategies when in public settings," said CDC Director Rochelle Walensky.

"As the science evolves and more people get vaccinated, we will continue to provide more guidance to help fully vaccinated people safely resume more activities," she said. A growing body of scientific

evidence suggests that fully vac-

cinated people are less likely to have an asymptomatic infection and are potentially less likely to transmit SARS-CoV-2, the virus that causes Covid-19, to other people, according to the CDC.

The agency encourages people to get vaccinated with the first available Food and Drug Administration (FDA)authorised Covid-19 vaccine to protect themselves and to help bring the pandemic to a close. There are three vaccines

currently authorised for emergency use in the US by the FDA The FDA authorized the one de-

veloped by American drugmaker Pfizer in partnership with German company BioNTech, and another by American drugmaker Moderna, in December 2020, Johnson & Johnson's vaccine was approved for emergency use on February 27. It is the first single-dose vaccine authorized in the United States.

The vast majority of people need to be fully vaccinated before Covid-19 precautions can be lifted broadly. Until then, it is important that everyone continues to adhere to public health mitigation measures to protect the large number of people who remain unvaccinated, said the CDC. Over 116 million vaccine

doses have been distributed across the US as of Monday, and more than 92 million doses have been administered according to the latest CDC data.

Just 9.2 per cent of the US population has been fully vaccinated with a Covid-19 vaccine, the CDC estimated.

Britain's Royals Silent As 'Megxit' Crisis **Rages After Bombshell Interview**

LONDON: Britain's monarchy kept its silence on Tuesday, after Meghan and Prince Harry sparked a crisis by alleging that a family member made a racist remark about the colour of their son's skin and that she was alienated to the point of contemplat-

ing suicide. The family, led by Queen Elizabeth, 94, was grappling with how to respond to Oprah Winfrey's TV interview, in which Harry also said that his father, heir-to-the-throne Prince Charles, had let him down.

"Worst Royal Crisis in 85 Years." read the front page of the Daily Mirror newspaper, while the Daily Mail's cover asked "What Have They Done?" and The Sun columnist Trevor Kavanagh questioned if the interview meant the end for the royals.

"It could hardly be more damaging to the royal family, not least because there is little it can do to defend itself," The Times said in a lead article under the title "Royal Attack".

But the gravity of the claims raised uncomfortable guestions about how the British monarchy, which survived centuries of revolution that toppled their cousins, could function in a meritocratic world.

Meghan, 39, whose mother is Black and father is white, said she had been naive before she married into royalty in 2018, but that she ended up having suicidal thoughts and considering self-harm after pleading for help but getting none.

Meghan said her son Archie, who turns two in May, had been denied the title of prince because there were concerns within the royal family "about how dark his skin might be when he's born".

Markle's Explosive TV Interview LONDON: Oprah Winfrey's two-

hour prime-time interview with Prince Harry and Meghan, the Duchess of Sussex, contained revelations and allegations that have left Britain's royal family reeling, painting a picture of racism, insensitivity and deep-rooted dysfunction.

The palace has not responded to the interview, broadcast in the US on Sunday night, which has made headlines and sparked debate around the world. Meghan, who is biracial, said

before the couple had their son Archie, there had been "concerns and conversations" between Harry and the family "about how dark his skin might be when he's born."

Harry confirmed there was a conversation about "what will the kids look like." He said he would never reveal who was involved, but Winfrey said he told her it was not his grandparents, Queen Elizabeth II and Prince Philip.

Meghan also said she was treated differently by the British media compared to Prince William's wife Catherine, who was also followed closely by the press and even dubbed "Waity Katie" on account of the couple's long courtship.

"While I imagine that was really hard—and I do, I can't picture what that felt like-this is not the same," Meghan said.

"And if a member of his family would comfortably say, we've all had to deal with things that are rude' rude and racist are not the same." Meghan said her isolation and

unhappiness inside the royal family grew so bad that "I just didn't want to be alive anymore." "And that was a very clear, and

real, and frightening, constant thought," she said. So she said she sought help from the palace's human resources department, but did not receive it.

"I went to the institution and I said that I needed to go somewhere to get help. I said that I've never felt this way before, and I need to go somewhere," she said. "And I was told that I couldn't, that it wouldn't be good for the institution.

Harry said that, through his relationship with Meghan, he realized that he and his family were all trapped inside an oppressive system.

"I was trapped, but I didn't know I was trapped," he said. "My father and my brother, they

are trapped. They don't get to leave.' He also claimed there was a toxic relationship between the royals and the media and that Britain's royal family was afraid of the tabloid press "turning on them."

"There is a level of control by fear that has existed for generations," he

Harry revealed a breakdown in his relations with his father Prince Charles, who is heir to the British throne, and elder brother Prince William, the second in line.

He said at one point Charles stopped taking his calls, and there was still "a lot to work through" in their relationship.

While reviewing the situation, the Principal Secretary to the PM appreciated the efforts of the Union Ministry of Health and Family Welfare, State/UT Governments, respective Health Departments and the medical field staff for the successful phase-wise roll-out of the COVID-19 vaccination. It was informed that, till date, more than 2.4 million people have been vaccinated across India in one of the world's largest

vaccination drives.

It was informed that the COWIN Portal is hosting geo-tagged locations of all the vaccination centres along with the data on vaccine availability and supply chain management, which can be used by the States/UTs to facilitate vaccination-related planning and monitoring. Stress was laid on gradual ramping up of the vaccination related facilities to organise gross root drives for inclusive and equitable coverage of population.

The States/UTs were asked to lay special focus on sharing the vaccination schedule across respective vaccination centres over the next 15 days, efficient monitoring of the supply chain management of vaccines to reduce wastage on account of expiration, a gradual increase in the number as well as the capacity of vaccination centres, crowd management at vaccination sites, and general promo-

tion COVID appropriate behaviour. The States/UTs were also asked to

ensure a multi-sectoral response in addition to swift vaccination drives to prevent subsequent waves of infection especially in the wake of the emergence of mutant strains of the virus. They were advised to ardently promote COVID appropriate behaviour, improve the rate of testing especially in districts that are falling short of target quotas, increase the share of RTPCR tests viza-viz RATs, monitor mutant strain for early hotspot identification, adopt refocused & stringent containment strategies and undertake priority vaccination with provisions of geographically targeted vaccination in clusters witnessing a surge in COVID cases.

In Jammu and Kashmir, COVID-19 vaccination drives are being held across 2834 COVID Vaccination Centres (CVCs) including 34 private centres. The vaccines are being administered free of cost at all government CVCs and at private centres against the payment of Rs. 250 per dose.

DDCs take centre stage

he Jammu and Kashmir administration has placed recently elected District Development Council (DDC) chairpersons at serial number 26 in the new warrant of precedence which among others includes Divisional Commissioners, Inspector Generals of Police, joint secretaries to the union government and officers of equivalent rank besides the administrative secretaries and officers of the rank of Major General or equivalent rank. The DDC vice-chairpersons have been placed at serial number 27, equivalent to the vice-chancellors of universities.

Similarly, the DDC members along with Block Development Council members and president of municipal councils and municipalities will enjoy the protocol like that of district magistrates, officers of the rank of Brigadier and equivalent, major heads of departments and district and session judges.

With the warrant of precedence being set, the DDCs are bound to take centre stage in J&K even as Assembly polls and statehood remain elusive. The People's Alliance for Gupkar Declaration, a grouping of Kashmiri parties seeking restoration of J&K autonomy, won 110 out of 280 seats in the DDC elections. This made it a favourite to gain power in 12 districts. But it ended up controlling just eight districts - five in Kashmir Valley and three in Jammu. On the other hand, the BJP won the posts of chairpersons in six districts, the BJP allied Apni Party in two and the People's Conference in one. The other three districts were won by the independent candidates. Among the PAGD's eight seats, the NC candidates won six and the PDP and the Communist Party won one each.

Congress has been the biggest loser. It controls no district despite winning 26 seats. It, however, managed to win the vice-chairperson posts in Kishtwar and Rajouri districts with the support of the PAGD. This is a sad turn of events for a party that was a major political player in J&K before 2014. It was a part of the two successive governments, one with the PDP and another with the NC.

Be that as it may, the DDCs are all that J&K has in terms of democratic governance in the absence of assembly elections. With the J&K administration extending the time of the Delimitation Commission by one more year, there is no way elections will be held in the next one and a half. So, people will have to make do with the DDCs only. But their function will be strictly developmental in nature. They have no political role. This makes the DDCs an extension of the bureaucracy. For a real democracy to work it has to give voice to the political aspirations of the people. And for that to happen the government should work towards holding assembly elections in right earnest.

Heavy is the head that wears the crown

The interview that the Queen's grandson and his wife, the Duchess of Sussex, gave to their friend Oprah Winfrey painted a picture of a Britain under a thin aristocratic crust that was wreathed in a "toxic atmosphere" in which the Windsors were either willingly or unwillingly trapped. Royal life, the couple said, was stalked by the fear of the tabloid press. These charges cannot be treated lightly. Prince Harry is the ultimate palace insider, with a ringside seat at the royal circus for decades.

The monarchy's soft power rests upon the great social - and political - pressure not to embarrass the Queen. The royal family has been obliged to protect her interests and shield her from criticism, aware that their fortunes are tied to preserving the monarchy's hold over people. Prince Harry has broken this rule, and he seems to care little that he has done so. Like his mother, Diana, Princess of Wales, he outmanoeuvred the palace because he was willing to bare his soul in public. Princess Diana's fury with her husband and his betrayals did not threaten "the firm" until she died. The prince has fired a missile from California at the heart of the establishment while very much alive.

This is no accident. In speaking to Ms Winfrey, whose secular authority is greater than any US politician, the Duke and Duchess of Sussex are signalling that the English-speaking world now has two royal households to choose from and identify with. One appears to trade in the politics of emotion, feeling people's pain just as they felt theirs. The other, if one accepts the Sussexes account, is flawed and cruel - and unable to cope with mental suffering.

The rule that embarrassment to the Queen should be avoided at all costs only applies if you wish to play the game. The Sussexes have been financially cut off by the royal family. In telling their side of the story they have boosted their global celebrity, and almost certainly their popularity, on which their income depends. Media deals have reportedly made them multimillionaires. They were frozen out after the palace decided that one could not represent the Queen at public engagements while making money from such self-promoting business activities.

Yet l'affaire Sussex is more than about money. In the UK, the monarch has the final power of decision and retains that right because they refrain from political manoeuvring. Even if this were true - and given this paper's revelations about Queen's consent suggest it is not - the monarch's desire to be above the fray today looks like royal disdain for social movements such as Black Lives Matter and #MeToo that the Duchess of Sussex has promoted.

The Sussexes have vividly dramatised the real challenge of staying out of politics for the monarchy. A grouse-shooting, landowning ruling caste is likely to support certain political ideas, but to ensure its popularity it remains silent on the big issues. What the Sussexes show is that being relatable and relevant as royals was impossible because it would come into conflict with the monarchy's very real powers. Whether a hereditary head of state is required today ought to be considered in a programme of reform that the British state clearly – and urgently – needs.

The Trash Towns of Jammu & Kashmir

Implement MSW Rules 2016 in toto. Why collect tax from commercial vehicles when people don't get any service?

henever we enter any town, we often see barricades erected by the local municipality. This is known as Chungi in local language which during the days of yore was called Gurzar waan or octroi post. A certain amount of tax is collected from every commercial vehicle ranging between Rs 20, 30 or even Rs 50 depending upon the type of vehicle (small, medium and large). The money collected on account of tax by the local municipality is supposed to be spent on welfare measures especially sanitation. In almost all the towns of Jammu & Kashmir, majority of this tax money is paid as salaries to the employees of Municipal Councils and Committees. Not even 20 % of the amount is spent on the upkeep of town or municipal solid waste management. Leaving aside Srinagar or Jammu city, every town of Jammu & Kashmir has become a trash town as heaps of municipal solid waste can be seen on roadside, open plots or around rivulets and other water-bodies. The law enforcers who were supposed to implement and enforce the Municipal Solid Waste Rules 2016 (MSW Rules) are themselves violating these rules. The violations are so gruesome that it is simply a criminal offence but who will take action against the municipal institutions? On the other hand, municipal institutions also have some challenges which the Government is not addressing and the ultimate sufferers are the citizens.

MSW Rules 2016

In 2016, the Union Ministry of Environment, Forests and Climate Change came up with the new Solid Waste Management Rules also called Municipal Solid Waste Rules 2016 (MSW Rules). These rules are the sixth category of waste management rules and do not include plastic, e-waste, biomedical, hazardous and construction and demolition waste. As per these new rules 'waste' is defined as solid waste alone which is generated by all the households, hospitality industry, big and small market vendors. These rules are applicable beyond municipal areas and extend to urban agglomerations, census towns, notified industrial townships. The 2016 rules call upon waste generators to start segregating their waste into three categories - Biodegradables, Dry Waste (Plastic, Paper, metal, Wood) and Domestic Hazardous Waste (diapers, napkins, mosquito repellents, shaving kits, cleaning agents) before they hand it over to the collectors. The MSW Rules 2016 says that waste generators will have to pay some amount to the waste collectors for activities like collection, disposal, and processing of waste. The municipal bodies in India have the authority to decide the 'User Fees.'The rules also stipulate zero tolerance for throwing, burning or burying the solid waste generated on streets, open public spaces, water bodies, etc. "Spot Fines" are also introduced under these new rules which means if someone is found littering or disobeying the guidelines, then local bodies have the authority to fine them.

Unfortunately, in our towns and even cities, the waste is burnt and thrown into water bodies by municipal employees and sanitation workers as well. I won't blame them because the Government has miserably failed to provide them land outside the town for creating a scientific landfill site. MSW Rules 2016 make it mandatory that no non-recyclable waste having calorific value of 1500 K/cal/kg or more shall be disposed of in the landfills. That waste can either be utilised for generating energy or can be used for preparing refuse derived fuel (RDF). J&K Government in fact took many cement plant owners from Kashmir on a field trip to Karnataka a few years back to show them how RDF works in cement kilns, but the Srinagar Municipal Corporation (SMC) didn't carry forward this programme as RDF was to be supplied by SMC to cement factories.2016 MSW Rules say that landfill site should be 100 metres away from a river, 200 metres from a pond, 500 metres away from highways, habitations, public parks and water supply wells and 20 km away from airports/airbase. In Kulgam and Poonch towns, both the landfill sites are near the banks of rivers and

during rainfall and floods the entire municipal solid waste is washed away and the same water is supplied by the Public Health Engineering (PHE) department to people after mere chlorination or sedimentation.

UNDP report on solid waste disposal

The United Nations Development Programme (UNDP) in one of its reports published some years back said that the second most serious problem that city dwellers face (after unemployment) is insufficient solid waste disposal. Whenever there is a discussion on waste Management, the municipal authorities raise an issue about non availability of garbage dumping sites. This is a very valid reason. Our towns and cities have been choked and land availability is very less. So creating new garbage dump sites or even scientific landfills is a challenging task for Government agencies. For decades, authorities in J&K state have not devised any mechanism to treat the garbage in cities and towns. The Municipal Solid Waste (MSW) is simply lifted from one place and then dumped at another site. Our Urban Local Bodies are merely re-locating the waste and not treating it and there are many municipal institutions who do not even relocate the waste as these municipalities don't have a land to dump the municipal waste.

Role of Deputy Commissioners

Under Rule No 12 of Solid Waste Management Rules 2016 Deputy Commissioners / District Magistrates have an important role to play, but in view of their other priorities, most of the DCs don't take the issue of solid waste management seriously. The Deputy Commissioners are supposed to work in close coordination with the Administrative Secretary of Housing & Urban Development Department (HUDD) vis a vis identification of land for creating scientific landfill sites, setting Jammu & Kashmir. The Municipal Council Udhampur, Municipal Committee Magam (Budgam) , Municipal Committee Kulgam , Municipal Committee Bandipora, Municipal Committee Ramban etc are grossly violating the MSW Rules by dumping municipal waste in lakes, wetlands and rivers. In Udhampur town, the municipal waste is dumped inside a forest area on Jammu -Srinagar highway (NH 44). In Magam town, the garbage is dumped by local municipality on the banks of Ferozpur nallah ,Kulgam Municipality dumps the solid waste on the banks of Vishaw river, Municipal Committee Bandipora dumps it near the banks of famous Wullar lake at Zalwan village and Municipal Committee Ramban dumps all the trash including dead animals near the banks of Chenab river.

While on my visit to Poonch in 2018, I found Municipal Council Poonch dumping all its solid waste including biomedical waste on the banks of Poonch river. I can't blame only municipal officers as they don't get cooperation from higher authorities or local Deputy Commissioners. The Deputy Commissioners are themselves unable to address this menace as the situation is very complex plus land availability is very meager in J&K. Monthly meetings on implementation of SWM Rules are hardly held and even if the meetings are held it ends with no positive outcome because the issue is very complex in nature. To address these complexities, authorities need to take various stakeholders on board and hold roundtables with technical organizations and individuals involved in waste management work. The administrative department is not showing seriousness on the issue. In past Govt invited tenders under PPP model for waste management in towns by clubbing the towns into clusters. This was a flawed model which had no takers and till date the fresh tenders have not neither been invited nor has the Govt rectified that tender document (NIT).

For decades, authorities in J&K state have not devised any mechanism to treat the garbage in cities and towns. The Municipal Solid Waste (MSW) is simply lifted from one place and then dumped at another site. Our Urban Local Bodies are merely re-locating the waste and not treating it and there are many municipal institutions who do not even relocate the waste as these municipalities don't have a land to dump the municipal waste

up solid waste processing and disposal units. This was to be done within one year from the date of notification of SWM Rules 2016. More than 6 years have passed and most of the DCs in J&K are yet to identify the suitable land for creating landfill sites for the municipal committees or councils in their respective districts. There is not even a single municipal committee or council where the solid waste is being treated on scientific lines.

In Municipal Council Budgam, a successful pilot work was taken up in 2016-2017. The private enterprise which was executing the work on a no-gain-no-loss basis was composting the biodegradable waste at a designated site and making compost out of it. The said site is now abode for dogs as the working has been stopped due to noncooperation from the administrative department. In-spite of allotment of work for another one year through a proper tender process the work could not be executed as the Government said they don't have any budget for carrying the work forward. When there was no budget for the same why did the authorities tender out the work? Pertinently, the financial implication for this door to door collection and treatment plus segregation project was mere 15 to 17 lakhs a year which could have been generated by the local municipality by collecting sanitation fees collected from local households. When people will get proper service they won't hesitate to pay Rs 50 or even Rs 100 per month to local municipal institutions.

Enforcers turning Violators

I have written a lot about unscientific disposal of solid waste with practical instances from different districts. Irony is that municipal bodies who are supposed to implement and enforce the SWM Rules 2016 are themselves grossly violating it. The disturbing situation is that the municipal solid waste is being dumped either inside or near the water bodies by most of the municipal bodies in

The municipal institutions under Urban Local Bodies (ULBs) were hardly serious about sanitation and addressing solid waste issues in the past. They had been busy only with executing the civil works and making backdoor appointments. In 2012, I sought information from Municipal Committee Chadoora under RTI Act which revealed that out of Rs 1 crore revenue generated from tax collection, 90 lakhs was spent on salaries and administrative expenses. The town has no official landfill site and with the result waste is either dumped on the banks of Doodh Ganga river or thrown around various locations.

It is not the year 2016 when solid waste rules were brought in for the first time in India. More than 20 years ago, the Government of India came up with MSW Rules in 2000. The 2016 rules is sort of an amendment to Solid Waste Rules of 2000. The 21 year old rules also focused on source segregation of waste plus its processing, but the J & K Government never implemented them on the ground and now after two decades people are made to suffer. Had our policy makers and politicians been visionary the situation would not have been alarming. The J&K Pollution Control Board (PCB) has also been mum over this issue, with the result managing solid or liquid waste has become a challenging task for municipal institutions. Government on the other hand is acting like an ostrich and not taking unscientific waste disposal seriously thus putting the lives of citizens at risk.

The Colonial Crown

he most explosive element of the Sus-sexes' highly anticipated interview with Oprah Winfrey was the claim that someone within the royal household had "concerns" over how dark-skinned the couple's son Archie might be.

While Winfrey later clarified neither the Queen nor the Duke of Edinburgh were behind the remark, Meghan also suggested their son was denied the title of prince because of his mixed race.

The interview points to a larger issue of racism in the British monarchy, both contemporary and historical.

When the couple began dating, some hoped it would usher in a period of royal renewal. Meghan, who has an African-American mother and a white father, was presented as a symbol of the modern, inclusive monarchy. These hopes were gradually dashed with consistently negative media coverage, including unfavourable comparisons with Meghan's sister-in-law, Kate Middleton, the Duchess of Cambridge.

Meghan revealed to Winfrey that the pressure to perform official duties in the face of mounting criticism led to depression and suicidal thoughts. The couple lamented the lack of support they received from the royal family.

It is a tragic story at an individual level but it also points to a history of structural racism within the monarchy. Harry noted that the press attacks on his wife had "colonial undertones", which the royal family refused to address. These are part of a longer history of colonialism and racism in which the Windsors are entangled.

The Queen's distant ancestor, Elizabeth I, was integral to establishing the British slave trade. One of the founders of the trade in the 16th century, Sir John Hawkins, impressed Elizabeth by capturing 300 Africans. His biographer Harry Kelsey calls him "Queen Elizabeth's Slave Trader" and notes that she contributed her ship, Jesus of Lubeck to his next voyage in 1564.

In 2018, Prince Charles denounced Britain's role in the slave trade as an "atrocity" but there have been calls for the Queen also to apologise on behalf

Republican campaigner Graham Smith has led the charge noting that the current royals "are sitting on a hugely significant amount which was acquired from slavery and empire".

A colonial mindset

The British empire contracted after the World Wars and eventually dissolved in 1960s. Nevertheless, a colonial mindset has persisted. This has been regularly demonstrated by the casual racism of Prince Philip. Visiting Australia in 2002, he asked an Aboriginal Australian if they were "still throwing spears

In 1999, he mused that an old-fashioned fuse box must have been "put in by an Indian". In 1986, he warned British students in China that they would become "slitty-eyed" if they stayed too long. Australia, China, and India, are just three of dozens of countries touched by British colonisation.

While the Prince's comments — and many others — are often dismissed as "gaffes" or poor jokes, they tie into a culture war, suggesting colonialism

was ultimately a net good and Britain was spreading civilisation throughout the world.

Journalist Peter Tatchell has argued that the institution of monarchy is itself inherently racist as there have only been, and likely will only ever be, white monarchs. He notes,

A non-white person is [...] excluded from holding the title of head of state, at least for the foreseeable future. This is institutional racism.

While this could change, of course, the treat ment of Meghan and the alleged concerns over her son's skin colour suggest the privileging of whiteness is deeply ingrained.

Being seventh in line to the throne, there was never a realistic chance Archie would become king. The notion that his mere proximity to the throne has sparked concerns, and the failure to defend Meghan from racist attacks, again points to a structural issue.

The marriage of Harry and Meghan in 2018 by charismatic African-American Bishop Michael Curry, serenaded by a gospel choir, was a public relations coup for the royals. The Sussexes' exit from royal life after such a short period, and the reasons why, is highly damaging.

The monarchy has remained largely silent on

the history of racism in Britain and how the royal family has benefited from racism and colonialism.

After the death of George Floyd sparked the Black Lives Matter movement, thousands across Britain were quick to show their support and solidarity. So strongly did the movement resonate, in 2020 the English Premier League had the words Black Lives Matter printed on players' shirts, opening matches with players taking a symbolic knee.

The royal family said nothing. By protocol, the monarchy does not comment on political issues but its role is to offer moral leadership. Without explicitly endorsing Black Lives Matter, the Windsors could have contributed to the zeitgeist by offering statements condemning all forms of racism and visibly championing anti-racism charities.

As a society, Britain is having a difficult national conversation about its imperial past. Statues of slave owners are being torn down and attempts to decolonise the curriculum are gathering pace.

If the royal family is not able to make similar attempts to confront the racism in its past and present, it risks falling ever further out of touch with the people it is supposed to represent.

ONDON - I was recently approached about setting up my own "special purpose acquisition company" (SPAC), which would allow me to secure financial commitments from investors on the expectation that I will eventually acquire some promising business that would prefer to avoid an initial public offering. In picturing myself in this new role, I mused that I could be doubly fashionable by also jumping into the burgeoning field of cryptocurrencies. There have been plenty of headlines about striking it big, quickly, so why not get in on the action?2

Being a wizened participant in financial markets, I declined the invitation. The rising popularity of SPACs and cryptocurrencies seems to reflect not their own strengths but rather the excesses of the current moment, with its raging bull market in equities, ultra-low interest rates, and policy-driven rallies after a year of COVID-19 lockdowns.

To be sure, in some cases, pursuing the SPAC route to a healthy return probably makes a lot of sense. But the fact that so many of these entities are being created should raise concerns about looming risks in the surrounding markets.

As for the cryptocurrency phenomenon, I have tried to remain open-minded, but the economist in me struggles to make sense of it. I certainly understand the conventional complaints about the major fiat currencies. Throughout my career as a foreign-exchange analyst, I often found that it was much easier to dislike a given currency than it was to find one with obvious appeal

I can still remember my thinking during the run-up to the introduction of the euro. Aggregating individual European economies under a shared currency would eliminate a key source of monetary-policy restraint - the much-feared German Bundesbank – and would introduce a new set of risks to the global currency market. This worry led me (briefly) to bet on gold. But by the time the euro was introduced in 1999, I had persuaded myself of its attractions and

changed my view (which turned out to be a mistake for the first couple of years, but not in the long term).

Similarly, I have lost count of all the papers I have written and read on the supposed unsustainability of the US balance of payments and the impending decline of the dollar. True, these warnings (and similar portents about Japan's long-running experiment in monetary-policy largesse) have yet to be borne out. But, given all this inductive evidence, I can see why there is so much excitement behind Bitcoin, the modern version of gold, and its many competitors. Particularly in developing and "emerging" economies, where one often cannot trust the central bank or invest in foreign currencies, the opportunity to stow

one's savings in a digital currency is obviously an inviting one.

By the same token, there has long been a case to be made for creating a new world currency - or upgrading the International Monetary Fund's reserve asset, special drawing rights - to mitigate some of the excesses associated with the dollar, euro, yen, pound, or any other national currency. For its part, China has already introduced a central bank digital currency, in the hopes of laying the foundation for a new, more stable global monetary system.

But these innovations are fundamentally different from a cryptocurrency like Bitcoin. The standard economic textbook view is that for a currency to be credible, it must serve as a means of exchange, a store of value, and a unit of

account. It is hard to see how a cryptocurrency could meet all three of these conditions all of the time. True, some cryptocurrencies have demonstrated an ability to perform some of these functions some of the time. But the price of Bitcoin, the canonical cryptocurrency, is so volatile that it is almost impossible to imagine it becoming a reliable store of value or means of exchange.

Moreover, underlying these three functions is the rather important role of monetary policy. Currency management is a key macroeconomic policymaking tool. Why should we surrender this function to some anonymous or amorphous force such as a decentralized ledger, especially one that caps the overall supply of currency, thus guaranteeing perpetual volatility?

At any rate, it will be interesting to see what happens to cryptocurrencies when central banks finally start raising interest rates after years of maintaining ultra-loose monetary policies. We have already seen that the price of Bitcoin tends to fall sharply during "risk-off" episodes, when markets suddenly move into safe assets. In this respect, it exhibits the same behavior as many "growth stocks" and other highly speculative bets.

In the interest of transparency, I did consider buying some Bitcoin a few years ago, when its price had collapsed from \$18,000 to below \$8,000 in the space of around two months. Friends of mine predicted that it would climb above \$50,000 within two years - and so it has.

Ultimately, I decided against it, because I had already taken a lot of risk investing in early-stage companies that at least served some obvious purpose. But even if I had bet on Bitcoin, I would have understood that it was just a speculative punt, not a bet on the future of the monetary system.

Speculative bets do of course sometimes pay off, and I congratulate those who loaded up on Bitcoin early on. But I would offer them the same advice I would offer to a lottery winner: Don't let your windfall go to your head.

Fully Vaccinated People Can Gather Without Masks Indoors, Should Still Avoid Travel: US

Tashington: People who have been fully vaccinated against COVID-19 can meet without masks indoors in small groups with others who have been inoculated but should avoid non-essential travel and continue to wear face-coverings in public, the Biden administration said on Monday.

In a long-awaited update of its guidance for behaviours to prevent the spread of the coronavirus, the U.S. Centers for Disease Control and Prevention (CDC) said fully vaccinated people could also meet in small groups with unvaccinated individuals deemed at low-risk for severe COVID-19 from one other household without masks.

The slight lifting of restrictions represented a still cautious approach to public health

guidance despite the quickly growing number of vaccinated people. President Joe Biden has urged Americans to remain vigilant and continue to follow CDC guidelines to prevent another surge of cases

The CDC said fully vaccinated people should continue to follow many precautions such as avoiding big in-person gatherings, wearing masks when visiting with unvaccinated people from multiple households or wearing masks when with people at risk for severe COVID-19.

CDC Director Rochelle Walensky told reporters it was important to protect those who have not been vaccinated and remain vulnerable while some 60,000 new coronavirus cases occur every day.

"We remain in the midst of a serious pandemic, and still over 90 percent of our population is not fully vaccinated," she said. "Therefore, everyone whether



vaccinated or not, should continue to avoid medium- and large-sized gatherings as well as non-essential travel.

More than 525,000 people have died of COVID-19 in the United States, Biden, who took office on Jan. 20, has encouraged Americans to wear masks for

his first 100 days as president, a contrast from the approach by former President Donald Trump, who downplayed the pandemic and eschewed masks. Some states have begun to lift restrictions on a large scale

Many Americans eager to get back to their pre-pandemic

way to do that. Businesses, particularly in the travel and hospitality industry, are hopeful that a growing number of vaccinated people will feel comfortable flying and dining out again.

"An Important First Step"

The new guidelines address how vaccinated people can safely resume some more normal activities and contacts with those outside their households while the coronavirus is still widely circulating, but they did not represent a large shift.

"Today's action represents an important first step. It is not our final destination." Walensky said. "As more people get vaccinated, levels of COVID-19 infection decline in communities, and as our understanding of COVID immunity accrues, we look forward to updating these recommendations to the public.'

Undocumented Indian Immigrants Hold USD 15.5 Billion In Spending Power



migrants to the US, numbering over half a million, hold a collective spending power of USD15.5 billion and contribute USD2.8 billion to the federal, state and local tax revenue, says an American think-tank report.

Using the latest available American Community Survey data from 2019 in its latest research, the new American Economy think-tank said undocumented Indian immigrants are the top third contributor to the US economy among other undocumented immigrants.

There are 4.2 million immigrants from Mexico who lack doc-

Together, they make up more than 40.8 percent of the 10.3 million undocumented immigrants in the United States.

In 2019 alone, they earned almost USD92 billion in household income and contributed almost USD9.8 billion in federal, state and

Mexican undocumented immigrants held more than USD82.2 billion in spending power, money that often goes back into local economies as they spend on housing, consumer goods and services, the report said.

In terms of the number of undocumented immigrants, Mexico is followed by El Salvador (621,000, or 6.0 percent of all undocumented immigrants), India (587,000, or 5.7 percent), Guatemala (5.4 percent, or 5.4 percent), and Honduras (416,000, or 4.0 percent).

With its USD15.5 billion of spending power, India, however, holds the second position, followed by El Salvador (USD11.5 billion), Guatemala (US9.1 billion) and Honduras (USD6.4 billion).

They also make significant contributions to the federal, state and local tax revenue: India (USD2.8 billion), El Salvador (USD1.4 billion), Guatemala (USD1.1 billion) and Honduras (USD778 million),

NEW DELHI: Saudi Arabia's push to restrain oil supply to buoy prices is spurring India to speed up plans to diversify its crude sources and pursue alternative energy, the chairman of one of the nation's biggest refiners said.

The world's third-biggest oil importer was already trying to cut its dependence on Middle Eastern crude, with American oil rising from 0.5% of total purchases to 6% over the past five years, Mukesh Kumar Surana, chairman of state-owned Hindustan Petroleum Corp, said in a Bloomberg Television interview.

Oil minister Dharmendra Pradhan has repeatedly called for Opec+ to pump more crude to stop prices from rising too high. However, his pleas fell on deaf ears in Rivadh when the alliance, which is dominated by Saudi Arabia and Russia, decided to hold output steady last week. The decision and an attack on an export terminal in the kingdom pushed Brent above \$71 a barrel on Monday.

"Higher prices make the future of oil as a commodity in the energy basket more detrimental," Surana said. "It pushes people to look for more alternative resources in the energy basket," he said, adding that India would prefer an oil price in the \$50 to \$60 a barrel range.

Around 86% of Indian oil imports last year were from Opec+ members, with 19% coming from Saudi Arabia, according to government data. Indian refiners are watching Iran's possible re-entry into the oil market closely, Surana said.

Higher oil prices are also likely to add more impetus to India's push for cleaner sources of energy. Prime Minister Narendra Modi said last month that the country is targeting for 40% of its energy needs to come from green sources by 2030.

Brent oil's surge of around 30% so far this year is already crimpand is threatening India's recovery from its worst recession since the 1950s. "Higher prices push up inflation and that is not good for the economy," Surana said.

Govt Has No Plans To Impose New Cess On Petrol, Diesel: Anurag Thakur



The central government has no plans to impose any new cess on petroleum products, said minister of state for finance Anurag Thakur in the Rajya Sabha on Tuesday. At present, petrol and diesel in the country attract road and infrastructure cess, special additional excise duty and agriculture infrastructure and development cess (AIDC). Apart from these charges, basic excise duty is also levied on fuel products.

In Budget 2021, finance minister Nirmala Sitharaman announced an agriculture cess on petrol and diesel at 2.5 /litre and 4 /litre respectively. Following the imposition of this new cess, the basic excise duty

(BED) and special additional excise duty (SAED) rates were reduced on fuel prices to ease the additional burden on consumers.

Answering to the question whether government has any plant to bring petroleum products under the purview of Goods and Service Tax (GST), Anurag Thakur said, "As per the section 9(2) of the CGST Act, inclusion of these products in GST will require recommendation of the GST Council. So far, the GST Council has not made any recommendation for inclusion of petrol and diesel under GST."

Sitharaman earlier said that the decision to bring the fuels under GST will have to be taken by the GST Council. "Whenever the GST Council decides to take up this issue, they are well

within their interest to take it up and discuss. It's a call which the Council has to take." she had mentioned last week.

The petrol and diesel prices touched record high in February. However, there has not been any revision in fuel prices in March. The rates kept unchanged across the four metro cities for the tenth consecutive day on Tuesday. Indian Oil Corporation, the country's largest state-run oil refiner, had last hiked the petrol on 27 February to an all-time high of 91.17 in Delhi.

Meanwhile, the price of petrol in Delhi stands at 91.17 per litre while diesel is available for

81.47 on Tuesday. In Mumbai, petrol is priced at 97.57, while diesel costs 88.60, according to Indian Oil Corporation's website.

As is evident, OMCs have not revised fuel prices for the last 10 days even though the global oil market remained firm with crude hovering close to \$70 a barrel. In fact, since the beginning of February crude has gained more than \$7 per barrel that pushed OMCs to increase fuel prices on 14 occasions raising the prices by Rs 4.22 per litre for petrol and by

Rs 4.34 a litre for diesel in Delhi. On Tuesday, the OMCs continued with their pause drive started 10 days back keeping fuel prices static. So, petrol continues to be priced at Rs 91.17 a litre and diesel Rs 81.47 a litre in the national capital on Tuesday.

Across the country as well

the petrol and diesel prices remained unchanged.

Sources said that by keeping prices unchanged even during times when a cut in petrol and diesel prices was required, OMCs have built a buffer that will help them keep fuel prices stable for a longer time even though global product prices rise. However, a fall in the global oil market could see a cut in petrol and diesel prices immediately.

The increase in the previous weeks has taken petrol to cross historic high levels of Rs 100 a litre in several cities across the country.

The netrol and diesel price have increased 26 times in 2021 with the two auto fuels increasing by Rs 7.46 and Rs 7.60 per litre respectively so far this year.

Trai Suspends New SMS Regulations For 7 Days As Customers Face Issues



o improve end-user experience and eliminate spam and fraudulent commercial communication, the Telecom Regulatory Authority of India (TRAI) implemented its template registration and scrubbing regulations. However, due to inadequate preparations by telecom companies as well as service providers, this has hit the financial customers hard. Many financial consumers are finding it difficult to receive SMS, especially the one-time passcode (OTP) for transactions. Following furore on social media about the hasty implementation, the telecom regulator decided to defer the regulations for next seven days.

Media reports say the new regulations have affected receiving OTPs for bank transactions, CoWin registrations, and Aadhaar updates, among other things.

In a release, TRAI says, "It has been observed that some of the principal entities have not fulfilled the requirements as envisaged in Telecom Commercial Communications Customer Preference Regulations 2018 (TCCCPR). As a result, their SMS were getting dropped after implementation of the scrubbing of SMS by telecom service providers. In order to protect the interest of consumers, it has been decided that scrubbing of SMS by TSPs shall be suspended temporarily for seven days to enable the principal entities to register the template of SMS so that no inconvenience is faced by the customers."

A report from Economic Times, had mentioned that out of one billion average daily commercial SMS deliveries, around 40% traffic was disrupted till Monday evening and among top private and public sector banks, the failure rate was over 25%.

Even BSE StAR MF cautioned its members about issues in receiving SMS and advised them to use alternate methods like email to receive the OTP for authentication

As per the revised guidelines, entities that want to communicate through SMS with their customers will now have to register themselves with telecom operators. As per the guidelines, these entities and bulk SMS service providers will be accountable to telcos, who will be directly accountable to TRAL The system will be governed through distributed ledger technology (DLT) or blockchain and all the entities listed on this platform will be interlinked with each other.

The regulations by TRAI man-

date registration of transaction and service-related OTP templates. Every content template that is being registered by a principal entity (telco) is required to contain a 'brand name' or complete business name, brand name and trademark in the content field. Any entity which does not have registration and sender ID approved by telcos, will find that its SMSes are not being processed and would fail to deliver to the intended recipient.

From 8 March 2021, this process, known as template registration and scrubbing, has gone live. However, it resulted in customers not receiving OTPs.

According to the ET report, both telcos and financial service providers like banks are blaming each other for the mess. While banks are holding hasty implementation responsible for this, telcos say service providers failed to register sender ID and template required for the distributed ledger technology (DLT) scrubbing platform.

'The Indian Banks' Association (IBA) earlier in the day reached out to both the TRAI and Reserve Bank of India (RBI), seeking an immediate postponement of the regulation. But an official at the telecom regulatory body said constant reminders were sent to banks regarding the impending deadline for the past 15 days," the report says.

Quoting sources from banking and payment service providers, the report says, "The first day of these new rules saw transaction services across the board being disrupted including unified payments interface (UPI), Aadhaar enabled Payments (AePS), netbanking and credit card payments due to lack of registration of sender ID and content.

Under the new regulations, SMSes are categorised in three activities, transactional, promotional and service, including implicit and explicit. Transactional category is reserved for banks for sending OTPs. Service related informative messages will fall under the implicit category. If a customer has opted to receive promotional SMS from a particular entity then it will be come under the explicit category. General promotional SMS including offers, discounts will be delivered only to subscribers who have not opted for do-not-disturb (DND) or do-not-call (DNC).

Earlier, in September 2020, the Delhi High Court had asked the te com regulator to act in accordance with the law against unregistered entities and against those persons not complying with its regulations, to curb the problem of UCCs.

Biden Admin Reimposes Sanctions On Israeli **Mining Magnate**

The United States on Monday revoked a sanctions waiver for Israeli mining magnate Dan Gertler that was issued in the last days of the Trump administration.

The Treasury Department said exempting Gertler from sanctions was "inconsistent with America's strong foreign policy interests in combating corruption around the world," specifically in the Democratic Republic of the Congo (DRC).

The action came after Congolese and international human rights groups and several US legislators last month called on the Biden administration to reverse a lastminute move by Biden's Republican predecessor, Donald Trump.

The Treasury imposed the sanctions in December 2017 and June 2018, accusing Gertler of using his friendship with Democratic Republic of the Congo's former president, Joseph Kabila, to win sweetheart mining deals

worth more than a billion dollars. The Trump administration eased the sanctions in a secret action in

its last week in office in January, a licence granted by the Treasury Department showed. While the licence did not remove Gertler, an associate and more than 30 of his companies from the sanctions list, it authorised, until January 31, 2022, "all transactions and activities" otherwise prohibited by sanctions against them.

The original designation of Gertler under the Magnitsky Sanctions programme made clear "Mr Gertler engaged in extensive public corruption," the Treasury said in a statement on Monday.

The sanctions had prohibited Gertler from doing business with US citizens, companies or banks, effectively barring him from doing transactions in dollars. Gertler has denied wrongdoing and argued that his investments in the DRC bolstered the country's development.

Democratic Senator Ben Cardin, the lead author of the Global Magnitsky Human Rights Accountability Act, said Gertler should not have been granted "an eleventh-hour permit" to do business with US banks and companies.

reporters at Sopore, Senior Superintendent of Police (SSP) Sopore, Javaid Iqbal said that a militant was killed in the operation that was launched on the basis of a specific input.

Today's gunfight between militants and the government forces comes almost after two week lull.

On February 24, police had claimed to have killed two unidentified militants in an encounter in a forest area in south Kashmir's Anantnag district

Meanwhile, a police spokesperson in a statement issued here said that Khawaja was involved in dozens of militancy related and other crime cases, including attacks on security forces and civilian atrocities. The Al-Badr chief, he said, was also the main recruiter of innocent youth into militant

Divulging details of cases registered against him, the police spokesperson said that Khwaja was responsible for a grenade blast in October 28, 2019 at the bus stand Sopore in which 19 civilians sustained injuries. In the same year in March, he said, Khwaja had carried out a rifle grenade attack on police Post Warpora, in which two police personnel.

"He also attacked a joint naka party of Police and CRPF at Bismillah-Colony, Model-Town Sopore, in which four CRPF personnel got seriously injured and one among them while being evacuated to hospital succumbed to injuries. In the incident one civilian identified as Bashir Ahmad Khan was also killed by the bullets fired by militants on July 1, 2020," he said.

Besides it, the police spokesperson said that the killed Al-Badr chief was also involved in an attack on a CRPF party at Ahad-Baba crossing in Noorbagh on April 18 last year in which 3 CRPF personnel were killed and two seriously injured.

He further said that Khwaja also had a hand in the killing of a civilian Danish Manzoor Najar of Bomai Sopore and attack on police party at Warpora Chowk, in which one SPO and one civilian were killed and another SPO got injured on 04-03-2020.

"He was also involved in killing of civilians and grenade attacks on Police/SFs establishments. He was also involved in providing arms and ammunition to militant associates for carrying out subversive activities in the area," the police spokesperson said, adding that the killed militant was operating in Langate, upper and lower Oaziabad, Handwara, Sopore, Zainageer, Tujiar, Barahampora and other areas of north Kashmir.

"Incriminating materials including arms & ammunition were recovered from the site of encounter. All the recovered materials have been taken into case records for further investigation and to probe his complicity in other crimes." he said.

He further said that the last rites of the killed militant shall be performed after conducting his medico-legal formalities and his nearest family members shall be allowed to participate in the last rites.

"In this connection a case under relevant sections of law has been registered and investigation has been initiated. People are requested to cooperate with police till the area is completely sanitized and cleared of all the explosive materials, if any," the police spokesperson

The leaders of Gilgit-Baltistan on Tuesday demanded that the government of Pakistan give the region provisional provincial status and provide it with representation in Parliament and other constitutional bodies.

However, they boycotted the programme and staged a massive protest in the lawns against the administration demanding better protocol and monthly honorarium, including ministerial status for the DDC chairperson and minister of state (MoS) status for vice chairperson.

As per the government order, the DDC chairpersons would get monthly honorarium of Rs 35,000 including Rs 1.500 travel allowance and Rs 500 telephone charges. Vice chairpersons will get Rs 25,000 including Rs 1,500 travel allowance and Rs 500 telephone charges and members will get Rs 15,000 including Rs 1,500 travel allowance and Rs 500 telephone charges.

Secretary Rural Development and Panchayati Raj Sheetal Nanda made repeated attempts to hold dialogue with the slogan-shouting protesters, who termed the government order as "crude joke" with them and sought the intervention of the central government and the Lt Governor.

"We have unanimously decided to boycott this programme and lodge our protest. We want the administration to review its wrong decision and accord ministerial status to the chairperson, MoS status to vice-chairperson and members to a status as given to MLAs," DDC chairperson and senior BJP leader Bharat Bushan told reporters.

DDC chairperson from Budgam Nazir Ahmad Khan said the government has played with their honour by lowering their status and left them red faced before their

"The Ladakh Autonomous Hill Development Council (LAHDC) chairpersons are conferred with the cabinet status and members are enjoying MOS status. The Srinagar and Jammu mayors also enjoy the MoS status, while as we are representing the entire district and given a status of an administrative secretary," he said.

Khan said the government issued the order of precedence deliberately ahead of the training programme to put a seal on it.

"We will not accept it...the situation in Kashmir is grave where we have to live under constant threat and accompany by our personal security officers (PSOs) and feed them as well. We spend Rs 3,000 to Rs 4,000 per day," he said, adding this is not an issue of any party but "we have joined hands to protect our honour"

Another DDC chairperson Ghulam Mustafa Khan said. "If we were not given our rights, how come we protect the rights of our people who have voted for us. The government has disgraced us and by this order of precedence conveyed a message that we have no importance which is not acceptable to us."

He said the monthly honorarium announced by the government would encourage corruption.

DDC member Taranjeet Singh demanded the immediate intervention of the central government and the Lt

The graph maintained by the Ministry of Home Affairs (MHA) reveals that between 2015 to 2019 highest number of 109 cases were registered in 2019 while no case was registered in 2017 throughout the year.

The MHA informed that the State Governments are competent to deal with such offences under the extant provisions of laws, "National Crime Records Bureau (NCRB) compiles and publishes statistical data on crimes in its publication "Crime in India". Published reports are available till the year 2019. Analysis of this data for cases registered under various crime heads on crimes against children does not show any uniform trend", the MHA said.

It said that the Government has approved setting up of 1023 Fast Track Special Courts (FTSCs) including 389 exclusive POCSO Courts for expeditious trial and disposal of cases related to rape and to POCSO Act.

England lost the four-match Test series 1-3 after going down in the final match by an innings and 25 runs last week.

"Players are totally committed to England and I think that was emphasised last week when a few of us went down with illness that made operating in 41 degree heat particularly taxing," Stokes told UK's 'Daily Mirror'.

"I lost 5kg in a week, Dom Sibley 4kg and Jimmy Anderson 3kg among others. Jack Leach was ducking off the field in between bowling spells and spending more time than is ideal in the toilet."

Rishabh Pant and Washington Sundar scored 101 and 96 respectively to guide India to 365 in their first innings. The hosts then returned to dismiss England for 135 to win the match.

"This is in no way an excuse, because everyone was ready to play, and India and Rishabh Pant especially produced a terrific performance, but I take off my hat to the effort that was put in by players who gave everything they had to try and win for England," said Stokes.

ing their performance in the Test series but Stokes said it was important to shut that out to focus on improving the game.

"I think he is a great addition and I hope they don't judge him by one or two innings because if you're keeping in mind the world cup, it can be a long rope. Once he has the security, we know that he can win matches just by himself.'

Pant cracked a breathtaking 101 off 118 balls to help India score 365 in the fourth Test, be-

sides scoring a 97 at Sydney and an unbeaten 89 at Brisbane that led India to a historic series win against Australia in January.

India will be taking on England in a five-match T20 International series, starting on March 12.

Laxman, a veteran of 134 Tests, feels Pant can fulfil the finisher's role in the team along with Hardik Pandya and Ravindra Jadeja.

"In this situation, it could just strengthen the finishers in the Indian team because over the last one and half years, we are overly dependent on Hardik Pandya and (Ravindra) Jadeja when he comes in at No. 7," said Laxman.

"But if there is one batsman in the Indian batting line-up who from the first ball can play those shots it is Pandya. Pant with the kind of form and maturity...it's not only about the form but the maturity with which he's batted in Test matches, I think he (Pant) will be a match-winner."

Laxman also had words of praise for Mumbai batsman Suryakumar Yadav, who has earned his maiden national callup for the T20 series against England, starting March 12.

"He deserves it, I think he (Suryakumar) is a great role model for youngsters, especially in India," said Laxman.

Kane Williamson To Miss New Zealand Vs **Bangladesh ODI Series**

WELLINGTON: Captain Kane Williamson will miss New Zealand's three one-day internationals against Bangladesh later this month with an elbow injury.

In a statement New Zealand Cricket medical manager Dayle Shackel said Williamson has a small tear in his left elbow tendon that requires immediate treatment.

"Kane's been managing the elbow injury to varying degrees this summer and unfortunately it hasn't improved," Shackel said.

"He obviously has a high volume of training and playing across the three formats which has inhibited his ability to recover.

"We believe he now needs a period of rest and rehabilitation to get the injury right.'

Williamson is now unlikely to play for New Zealand at home again during the southern hemisphere summer.

The one-day internationals will be played on March 20, 23 and 26. Williamson will also likely miss three Twenty20 internationals against Bangladesh on March 28 and 30 and April 1 while traveling to the Indian Premier League.

He will rejoin New Zealand for its two-test series against England in May before the World Test Championship final against India at Southampton from June 18 to 22.

Mortal Remains Of Athletics Coach Nikolai Snesarev Taken To His Home Country

NEW DELHI: The mortal remains of India's middle and long-distance coach Nikolai Snesarev was on Tuesday taken to his home country Belarus, four days after he was found dead in his hostel room at the National Institute of Sports at Patiala.

The dead body was first taken to Dubai by a 'flydubai' flight from the Indira Gandhi International Airport at around noon en route to Belarus capital Minsk.

Snesarev's mortal remains, to be taken by another flight from Dubai, is expected to reach Minsk on Wednesdav. This after the officials of the Athletics Federation of India completed the formalities to transport the coffin to Minsk.

"The coffin containing the dead body was sent from Patiala on Mon-



day night and was received by AFI officials here. All the formalities were finished in the morning today and handed over to the concerned airlines for transportation to Minsk," an AFI official told PTI.

"We have handed over all the relevant papers from the police, hospital and accepting party in Minsk. We have also spoken to Mrs Nikolai and have sent the flight details and other information to her."

The AFI official said that the postmortem report only mentioned "natural death" of Snesarev. His dead body was earlier sent to a government hospital in Patiala for post-mortem.

The 72-year-old Snesarev, who returned to India after a gap of two years to be at the helm till the end of September, was found dead when the coaches at the NIS broke his room door after he did not report for the Indian Grand Prix 3 held on Friday last.
