



NEW DELHI: A plea has been filed in the Supreme Court seeking immediate release of detained Rohingya refugees in Jammu and restrain the Centre from implementing any order deporting them.

An intervention application has been filed in the pending matter before the top court, which also sought direction to Ministry of Home Affairs to expeditiously grant refugee identification cards through the Foreigners Regional Registration Office (FRRO) for the Rohingyas in the informal camps.

The application filed by Mohammad Salimullah, Rohingva refugee through advocate Prashant Bhushan, said that it is filed in the public interest in order to secure and protect the right against deportation of the refugees in India.

The plea said that it is filed

to protect rights guaranteed under Article 14 and Article 21, read with Article 51(c) of the Constitution, against the

n his celebrated anthology, The Veiled Suite: The Collected Poem, Agha Shahid Ali details his grandmother's "bleeding heart"-which ensured the educational empowerment of the masses in the valley.

Shahid's poem, Prayer Rug in her memory, became a token introduction of "the lady with a lamp" – Begum Zaffar Ali.

In the sweeping accolades being showered on the lockdown-hit girls whose recent grades once again made them the shining stars of Kashmir's dented academia, Begum Zaffar Ali found a glorious mention for inspiring generations of girls in the valley.

'My mother-in-law was one of the first Kashmiri girls whose grit made her a beacon of educational excellence," Shaheena continues.

"An untiring activist, Begum Zaffar helped Kashmiri women in one way or another. I take inspiration from her."

In her 60s, Shaheena first met Begum Zaffar as a 26-year-old woman, when she married the celebrated educationist's eldest son, Agha Nasir Ali, in 1986.

Study finds that misleading people are often easily misled by others It probably seems intuitive to believe that you can't bullshit a bullshitter, but our

research suggests that this isn't actually the case

he findings of a new study from the University of Waterloo suggests that individuals who frequently try to persuade or impress others with misleading exaggerations and distortions, often themselves are much likely to be fooled by impressive-sounding misinformation.

The researchers found that people who frequently engage in "persuasive bullshitting" were actually quite poor at identifying it. Specifically, they had trouble distinguishing intentionally profound or scientifically accurate facts from impressive but meaningless fiction. Importantly, these frequent BSers are also much more

likely to fall for fake news headlines. The study was published in the British Journal of Social Psychology. "It probably seems intuitive to believe that you can't bullshit a bullshitter, but our research suggests that this isn't actually the case," says Shane Littrell, lead author of the paper and cognitive psychology PhD candidate at Waterloo. "In fact, it appears that the biggest purveyors of persuasive bullshit are ironically some of the ones most likely to fall for it." The researchers define "bullshit" as information designed to impress, persuade, or otherwise mislead people that are often constructed without concern for the truth. They also identify two types of bullshitting-- persuasive and evasive. "Persuasive" uses misleading exaggerations and

embellishments to impress, persuade, or fit in with others, while 'evasive' involves giving irrelevant, evasive responses in situations where frankness might result in hurt feelings or reputational harm. In a series of studies conducted with over 800 participants from the US and Canada, the researchers examined the relations between participants' selfreported engagement in both types of BSing and their ratings of how profound, truthful, or accurate they found pseudo-profound and pseudo-scientific statements and fake news headlines. Participants also completed measures of cognitive ability, metacognitive insight, intellectual overconfidence, and reflective thinking. "We found that the more

frequently someone engages in persuasive bullshitting, the more likely they are to be duped by various types of misleading information regardless of their cognitive ability, engagement in reflective thinking, or metacognitive skills," Littrell said. "Persuasive BSers seem to mistake superficial profoundness for actual profoundness. So, if something simply sounds profound, truthful, or accurate to them that means it really is. But evasive bullshitters were much better at making this distinction." The research may help shed

light on the processes underlying the spread of some types of misinformation, which could have important implications for the fight against this growing problem

"Except in the case of Non-Clinical Departments of Anatomy, Physiology, Pharmacology, Bio-Chemistry and Micro-Biology, where non-medical Teachers to the extent of 30% may be appointed to posts other than the head of the departments (who must necessarily hold a recognized medical qualification), all other teachers must possess the following basic qualifications in addition to the Post graduate qualification mentioned in the above schedule, namely:-

Recognized qualifications included in the First or second Schedule; or Part-II of the Third Schedule (other than licentiate qualification) to the Indian Medical Council Act 1956. Holder of Educational qualifications mentioned in Part-II of the third Schedule should fulfil the conditions stipulated in sub-section (3) of section 13 of the Indiar Medical Council Act, 1956.

However, a Non-Medical Teacher in Bio-Chemistry in a Medical College Doctorate Qualifications in Bio-Chemistry may also be considered for the post Head of the Department of Bio Chemistry.

Non-Medical M.Sc qualification also be considered as sufficient for the junion posts in the subject (like Lecturers/Demonstrators). For promotion to higher posts they must acquire the Ph.D degree in the subject"

Whereas, the Health & Medical Education Department further intimated that out of the seven (07) faculty members in the discipline of Bio-Chemistry at present in Government Medical College, Jammu, three (03) are from Medical side and Four (04) are from non-Medical side. This would indicate that the non-Medical faculty members are in the ratio of more than 30% of the prescribed upper limit. Twitter now tests better image previews for your photos

witter has announced it is running a test with select iOS and Android users to give people an accurate preview of how their images will appear when they Tweet a photo.

Currently, Twitter algorithms automatically crops images to make them display in a more condensed way in the timeline. Going forward, people in the test will see that most Tweets with a single image in standard aspect ratio will appear uncropped when posted. "People will see exactly what the image will look like in the composer tool before it's posted. Very wide or tall images will be center-cropped," Dantley Davis, Chief Design Officer at Twitter said late on Wednesday.

Twitter's automatic image cropping has been a problem for photographers and artists. "With this test, we hope to learn if this new approach is better and what changes we need to

make to provide a 'what you see is what you get' experience for Tweets with images," Davis said in a tweet.

Twitter's algorithm decides which part of an image will get the focus and this has create problems in the past.

The algorithm once prioritised white faces over Black ones in its image preview. It once cropped out former US president Barack Obama in one person's tests.





AMMU - Government is strictly gauging the performance of teachers in various government schools and 'punitive action, which may include premature retirement, demotion to the next lower post, withholding of increment, etc. is being taken against the teachers whose result performance remains repeatedly unsatisfactory.

This was stated by Minister for Education Harshdev Singh in reply to a question in the House today. He said government have taken several measures for promoting the Equality of education in the state, which include introduction of Kindergarten system, for the first time in the government I schools. He said minimum age limit for admission in government schools has been reduced from 6 to 4 years and English language introduced as a compulsory subject from first primary. He said school curriculum at secondary and senior secondary levels have been revised so as to catch up with the contemporary needs besides trying to bring it at par with the CBSE syllabi Some text books upto class 8th have been revised so as to get them in tune with National curriculum framework. Other measures taken up by the government to improve education standard include introduction of new subjects like Biotechnol ogy Bio-chemistry. Environment science, functional English. Islamic studies, Vedic studies besides introduction of vocational subjects at the +2 stage. The Minister said that the slate institute of education is projected to be upgraded to the State Council of Educational Research and Training (SCERT) while the Stale Institute of Educational Management and training is also being set up.

Stones Pelted On SMC's Enforcement Team During Demolition Drive

Srinagar: The Enforcement team of Srinagar Municipal Corporation (SMC) was allegedly pelted with stones during a demolition drive at Ahmad Nagar, 90 ft. area of Soura in the outskirts of Srinagar city on Thursday afternoon.

Reports said that a team of Enforcement wing Thursday afternoon initiated a demolition drive near Al-Khuddam in 90 ft. area of Soura.

Soon after getting a whiff, several people, which only swelled in proportion with time, started to hinder the drive and later on

pelted stones on the team. During the pelting, glass panes of several vehicles got damaged, with the officials however barely managing to escape unhurt.

When contacted Ghulam Rasool Dar, Chief Enforcement Officer SMC confirming the incident, said that glasses of several vehicles including that of a JCB and his own vehicle were damaged during heavy pelting by the people present there.

"We were there for a demolition despite an official holiday", he said adding that "However we couldn't do much with forceful restrain shown by the public there.



There was no reported injury to any official or employee in the incident, as per the official.

The official in the meantime said that they have sealed a huge illegal structure at Bota Kadal at Moulvi Stop in Lal-Bazar during the ongoing drive. According to the official,

it has been getting a bit tough for them 'to manage the things without any support from police'. "We had forty police personnel at our help during such drives, however they were withdrawn by the department concerned for their own pre-occupations for two years now", he said adding that "We have as such made a fresh request to Commissioner concerned to allocate us at least ten police personnel for smooth conduct of such drives." Before Thursday's advocacy group, the Assistance Association for Political Prisoners, had said more than 60 protesters were killed and about 2,000 people detained by security forces since the February 1 coup against Suu Kyi's elected government. Amnesty International accused the army of using lethal force against protesters and said many killings it had documented amounted to extra-judicial executions. "These are not the actions of overwhelmed, individual officers making poor decisions," Joanne Mariner, Amnessaid ty's director of crisis response. "These are unrepentant commanders already implicated in crimes against humanity, deploying their troops and murderous methods in the open." Junta spokesman Brigadier General Zaw Min Tun told a news conference the security forces were disciplined and used force only when necessary. The unrest was not a situation



that should be of concern to the international community and the West was making assumptions that were incorrect, he said.

The military has previously said it is acting with utmost restraint in handling what it describes as demonstrations by "riotous protesters" whom it accuses of attacking police and harming national security and stability.

JAKARTA: A tourist bus plunged into a ravine on Indonesia's main island of Java after its brakes apparently malfunctioned, killing at least 27 people and injuring 39 others, police and rescuers said on Thursday.

The bus was carrying a group of Islamic junior high school students, teachers and parents from the West Java province town of Subang when the accident happened on Wednesday night on a winding road, said local police chief Eko Prasetyo Robbyanto.

He said the bus was on its way back to Subang from a pilgrimage site in the province's Tasikmalaya district when it plunged into the 20-metre-deep ravine after the driver lost control of the vehicle in an area with a number of sharp declines in Sumedang district.

Police were still investigating the cause of the accident, but survivors told authorities that the vehicle's brakes apparently malfunctioned, Robbyanto said.

Malaysian Court Rules Non-Muslims Can Use 'Allah'

KUALA LUMPUR: A Malaysian court ruled on Wednesday that non-Muslims can use the word "Allah" to refer to God, in a major decision in a divisive issue for religious freedom in the Muslimmajority country.

The High Court decision squashed a 35-year-old government ban on the usage of Allah and three other Arabic words by Christian publications, deeming the ban unconstitutional, said the plaintiff's lawyer, Annou Xavier.

The government has previously said Allah should be reserved exclusively for Muslims to avoid confusion that could lead them to convert to other religions, a stance that is unique to Malaysia and hasn't been an issue in other Muslim-majority nations with sizeable Christian minorities.

Christian leaders in Malaysia say the ban is unreasonable because Christians who speak the Malay language have long used Allah, a Malay word derived from Arabic, in their Bibles, prayers and songs.

The high court ruling appeared to contra-



dict an earlier decision by the country's Federal Court in 2014 that upheld the government ban following a legal challenge by the Roman Catholic Church, which had used the word Allah in its Malay-language newsletter.

'The court has now said the word Allah can be used by all Malaysians," Xavier said. "Today's decision entrenches the fundamental

freedom of religious rights for non-Muslims in

Malaysia" enshrined in the constitution, he added. Muslims account for about two-thirds of Malaysia's 32 million people, with large ethnic Chinese and Indian minorities. Christians comprise about 10 per cent of the population.

Most Christians in Malaysia worship in English, Tamil or various Chinese dialects, and refer to God in those languages, but some Malayspeaking people on the island of Borneo have no other word for God but Allah.

Three other words - "Kaabah" or Islam's holiest shrine in Mecca, "baitullah" or house of God, and "solat" or prayer, were also banned in the 1986 government directive.

Government counsel Shamsul Bolhassan was quoted by The Star newspaper as saying that the four words can be used in Christian materials according to the court's ruling, as long as there is a disclaimer saying it is intended for Christians only and a symbol of a cross is displayed.

The ruling was a result of a long legal challenge by a Christian woman whose religious materials containing the word Allah were seized by authorities at the airport when she returned home from Indonesia in 2008.

The controversy over the usage of Allah has provoked violence in Malaysia. Anger over a lower court ruling against the government ban in 2009 led to a string of arson attacks and vandalism at churches and other places of worship. That ruling was subsequently overturned by higher courts.

16 Injured As Tribal Groups Clash Over Offensive Tiktok Videos In Pakistan

Karachi: At least 16 people have been seriously injured in Pakistan's Sindh province after two tribal groups clashed over "offensive TikTok videos",

ing "offensive" clips on the videosharing platform, officials said.

All the 16 injured persons have been shifted to Karachi for treatment, eight of them are said to be in critical condition, a local official said. "The dispute started three days

ago, when youths from the two tribes uploaded videos on TikTok.



This led to tension between the groups," he said, adding that attackers used bamboo sticks with iron hooks and axes in the fight.

Pakistan in October last year had banned TikTok, citing "immoral" content. However, the ban was lifted in just ten days after the Chineseowned company promised to moderate its content. Several youths have lost their lives trying to shoot daring videos on the platform. TikTok has nearly 20 million users in Pakistan.

Parliamentary Panel Seeks Special Budgetary Provisions For Road Connectivity In J&K

SRINAGAR: A parliamentary panel has recommended the Union government that it must keep special focus on the maintenance of roads in the Jammu & Kashmir region.

In its report, the department-related parliamentary standing committee on Transport, Tourism and Culture has recommended to the Ministry of Road, Transport and Highways to ensure sufficient budgetary provisions for road connectivity in Jammu & Kashmir Union Territory

"The Committee is of the considered view that the Ministry must place special focus on the maintenance of roads in the Jammu and Kashmir region, since the region needs good connectivity throughout the year, from both economic as well as strategic viewpoint. A well-connected, well maintained road network would spur economic activities and further the tourism prospects of the

region. The Committee, therefore, recommends the Ministry to ensure sufficient budgetary provisions for this purpose and in case any shortage is felt in this regard, the same may be communicated to the Ministry of Finance at the Revised Estimates (2021-22) stage," reads the report.

The report was tabled in both Houses of the Parliament on Tuesday. The panel headed by MP T.G Venkatesh made the recommendation after his recent visit to Kashmir where he interacted with different stakeholders on issues related to road, travel & hospitality sectors.

He also heard the officials of Ministry of Road Transport and Highways, National Highways Authority of India AI and Government of Jammu & Kashmir on 'role of highways in nation building' with reference to the status of national highways/ state Highways in Jammu and Kash-mir–(KNO)

After initiating the blast, the Div Com reviewed the process of ongoing work at


the site. He was briefed about the progress made on various works of Z-Morh tunnel including construction of approach roads, lanes, protective walls, drains besides other affiliated works of the project.

KO VIEW After ceasefire

he re-affirmation of the 2003 ceasefire agreement along the Line of Control will go a long way to ease the life along of the border dwellers on both sides of the border. Since 2010 when violations of 2003 agreement became common, hundreds of civilians and security personnel have been killed on both sides. What is more, the border residents have had to suffer displacement forcing New Delhi to build concrete bunkers for them away from the border. The situation had become worse since the revocation of Article 370 in August 2019. According to data provided by the Ministry of Defence in Parliament recently, there were 5133 instances of ceasefire violations along the LoC and other areas in Jammu, resulting in 46 fatal casualties, and 3,479 ceasefire violations in 2019. Similarly, according to data from Pakistan, there were 3,097 ceasefire violations in 2020 leading to death of 28 people on Pakistani side and injuries to 257 others. Also, figures from reports in Pakistani press say there have been over 13,600 ceasefire violations since 2003.

So, a halt to the frequent firing exchanges will make a redeeming difference to the lives of lakhs of border residents on both sides of the Line of Control. But it won't change anything as far as the situation in the Valley where militancy continues to reign supreme. In 2020, the number of recruits joining militancy saw a 22 per cent rise to 174 in 2020 from 143 in 2019. Last year also as many as 225 militants were killed by security forces - 207 of them in Kashmir Valley and 18 in the Jammu region.

The issue of militancy can be addressed if India and Pakistan go back to dialogue. Talks could go a long way to reduce the tension between the neighbours. The calm borders had become an important factor in the normalization of the relations between the neighbours, enabling them to start one of the most promising dialogue processes through 2003-2007 which by accounts of the top leaders of the two countries who were at the helm of it was close to a breakthrough on Kashmir.

But the challenge for the two countries would be to sustain a dialogue should it start. In past many such attempts have been aborted by a major attack in India traced to elements in Pakistan or sometimes the rigid negotiating positions of the two countries. It would be interesting to see how the two countries negotiate their respective conditionalities before reaching out to each other. Here's hoping that the anticipated fresh engagement between the parties reaches its logical conclusion in a resolution of all the issues dividing the two countries for the past seven decades.

Food wastage and hunger

closer look at the cause of human suffering can yield shocking revelations. The United Nations's Food Waste Index Report 2021 showed, for instance, that in 2019, an estimated 931 million tonnes of food were thrown away by households, restaurants and other food services around the world. This, at a time when hunger and malnourishment are global concerns. It is often believed that hunger is the result of inequitable access to food or its underproduction. The UN report, however, tells a different tale. In India, the food wastage per person in a year was estimated to be 50 kilogrammes. One of the consequences of such waste is there for all to see; in last year's global hunger index, India ranked 94 out of 107 nations and was bracketed in the 'serious' hunger category.

The report underscores the need to view hunger holistically: lack of access to food, faulty distribution, chronic poverty, conflict, populous societies and, significantly, food wastage all play a part in aggravating the problem. While the Food Safety and Standards Authority of India launched an initiative to encourage saving and sharing food that might have been wasted, it is unlikely to yield far-reaching results without governments conducting targeted awareness campaigns to sensitize households to the need to cook and consume according to their needs. There is an additional — moral — issue that must not be ignored. The excessive purchase, stocking and consumption of food is increasingly being projected as a signifier of wealth, ostentation and power. According to one estimate, about 10 to 20 per cent of the food at the Great Indian Wedding — and, possibly, at other such social occasions - is wasted. Such pandering to excess, mostly by the rich, in a country that accounted for 22 per cent of the global burden of food insecurity — the highest for any nation — in 2017-19 is shameful. China has launched the 'clean plate' campaign under which efforts are being made to reduce food wastage. Similar policies to curb criminal wastage elude India. In 2018, the Delhi government told the Supreme Court that it was considering imposing restrictions on the number of guests at "extravagant" weddings to minimize food wastage; it is unclear whether the policy has fructified. Meanwhile, there is a push to reduce food subsidies with the Niti Aayog recently recommending the reduction of the rural and urban coverage under the National Food Security Act. In a nation floundering under the weight of starvation, a concerted public campaign fortified with a legislative framework must be in place to prevent and penalize food wastage

Attention Deficit Hyperactivity Disorder (ADHD): Types, Causes and Treatment

ttention Deficit Hyperactivity Disorder ADHD is a complex brain disorder that impacts how you pay attention, sit still, and control your behavior because of its impairing effect on the development of the brain's executive functions.

ADHD is one of the most commonly diagnosed mental disorders in children with boys more likely to get diagnosed for it than girls. It's usually identified during the early school years, when a child begins to show problems in paying attention.

It is important to mention that ADHD can't be prevented or cured, but early identification, in addition to having a good treatment and education plan, can help a child or adult with ADHD handle their symptoms.

What are the symptoms of ADHD? ADHD Symptoms in children:

Symptoms are grouped into three

types:

Inattentive.

A child with ADHD:

- gets easily distracted Doesn't usually follow directions or finish tasks
- Seems lost somewhere
- Doesn't pay attention and makes careless mistakes
- Forgets about daily activities Has problems in organizing daily
- tasks Often loses things
- Tends to daydream

2. Hyperactive-impulsive.

A child with ADHD:

- Often fidgets, or bounces when sitting
- Doesn't stay seated
- Has trouble playing quietly Is always moving, such as running or climbing on things.
- Talks excessively
- Is always "on the go," as if "driven by a motor"
- Has trouble waiting for their turn Blurts out answers before listen-
- ing to the complete question Butts into conversations of other people

3. Combined type.

This involves signs of both types discussed above.

Symptoms in adults

Symptoms of ADHD may change as a son gets older. They include:

- Trouble concentrating when reading
- Mood swings
- Depression
- Relationship problems

Causes:

Experts aren't sure what causes ADHD. Several things may lead to it, including:

- Genes. ADHD tends to get inher-1. ited and run in families.
- Chemicals. People with ADHD 2 may have an imbalance in their brain chemicals.
- Brain changes. Children with ADHD have less activity in the areas of brain that control attention.
- 4. Poor nutrition, infections, smoking, drinking, and substance abuse during pregnancy can affect a baby's brain development leasing to ADHD.
- Toxins, such as lead may affect a 5. child's development of the brain.
- Damage to the frontal lobe can cause issues in controlling impulses and emotions.

ADHD Diagnosis and Testing:

Psychologists/Psychiatrists Clinical diagnose ADHD in children and adolescents after discussing symptoms in depth with the child, parents, and teachers, and then clinically observing the child's behaviors.

To confirm a diagnosis of ADHD or learning differences, a clinical psychologist may perform a battery of tests to check the neurological and psychological status of the child's condition.

The tests may include:

- A medical and social history of 1. both the child and the family. 2.
 - An evaluation of intelligence, aptitude, personality traits etc. These are often done with input from the parents and teachers if the child is of school age.

ADHD Treatment

There are several approaches to treating ADHD. But research suggests that for many children, the best way to manage symptoms is a multimodal approach involving multiple methods of treatment that work together. Many symptoms of ADHD can be managed with combination of medication and therapy. Close cooperation among Clinical Psychologists, Psychiatrists, teachers, and

parents is very important. Medication. They can help control

Parenting a child with ADHD isn't like traditional childrearing as usual rulemaking and household routines can become almost impossible, depending on the type and severity of your child's symptoms. Thus you'll need to implement different approaches. It can become maddening to deal with some of the behaviors resulting from your child's ADHD, but there are ways to make life easier.

By following these guidelines, you can limit destructive behavior and help your child overcome self-doubt and improve his or her self esteem and self efficacv

- Encourage and reward good behavior 1. (positive reinforcement) and remove rewards by following bad behavior with appropriate consequences, leading to the extinguishing of bad behavior
- Define the rules, but allow some flex-2. ibility: Don't be too strict while consistently rewarding good behaviors and discouraging destructive ones as children with ADHD may not adapt to change as well or as quickly as others. Allow them to make mistakes as they learn. Accept odd behaviors that aren't detrimental to your child or anyone else as part of your child's individual personality. Discouraging and rebuking your child for every odd behavior (just because you felt that they are unusual) may prove more harmful than the consequences of that odd behavior.
- 3. Manage aggression: Try to ignore mildly disruptive behaviors as a way

such as having a particular meals time, study time, play time etc. can provide essential structure to the child's daily life.

Break tasks into manageable pieces: Everyday tasks should be broken down into small discrete tasks. E.g., if a child has been asked to clean their room, it may be helpful to break this task into smaller tasks, by instructing him to make the bed, put any toys on the floor back into cupboard, or fold their clothes. Similarly break study time into slots. Don't expect your child with ADHD to go for a marathon study time. Allow the child to have regular breaks after every 10 minutes during the study time. Limit distractions: Since a child with ADHD gets easily distracted, creating a special, quiet space for your child to read, do homework, and take a break from the chaos of everyday life may help reduce unnecessary distractions. Things that can cause distraction and encourage impulsive behaviors such as television, mobile, video games, computer etc. should be regulated. Your child can have a better outlet for pent-up energy if you decrease their time with electronics and increase their time doing engaging activities outside the home. Outdoor activities can also help them develop better social skills if properly guided.

Encourage exercise: Physical activity burns excess energy in healthy ways. It also helps a child focus their attention on specific movements. This may decrease impulsivity Exercise

- Keep it interesting: Complex tasks usually attract and interest children with ADHD and they are less likely to get distracted during such tasks. Such children often get distracted if a task is not challenging enough. So if a child enjoys challenging activities and can focus while doing them, it is worth encouraging them to continue.
- 10. Remember that all children misbehave: Don't label every act of your child as a part of his or her ADHD. Remember that all children misbehave sometimes. Learn which behaviors need supervision, and which ones are normal parts of their childhood.
- 11. Accept the fact that your child like all children — is imperfect: Try to love your child unconditionally irrespective of the mistakes he or she does on daily basis. It may help the child feel less guilty and encourage him or her to work on their issues.
- 12 Be kind to yourself and your partner: Be kind to yourself while helping vour child. Blaming yourself or your partner for the problems your child has is not going to help.
- 13. Take breaks: Tending to the needs of the child with ADHD can be very draining task and can lead to building up of frustrations. So you'll need your own breaks to ease out. Scheduling alone time is important for any parent.
- Good break options include:
- going for a walk
- going to the gym
- taking a relaxing bath
- 14. Calm yourself: In order to help your child with ADHD, you need to compose your behavior. Children imitate the behaviors they see around them, so if you remain calm and controlled during an anger outburst, it will help your child to do the same. Take time to breathe, relax, and be thoughtful before trying to pacify your child. The calmer you are, the calmer your child will become.

Understanding your child with ADHD and tending to their needs is an uphill task, but a team effort between Clinical psychologists, Psychiatrists, Teachers and Parents can turn the tables and facilitate the child with ADHD to live a productive and purposeful life. Let us join hands and make it happen!

rinagar City, the summer capital of Kashmir is famous worldwide for its natural environment, gardens, waterfronts, and houseboats. Emperor Jahangir (a Mughal king in the 17th century) said, if there is a heaven on earth, it's here, it's here, it's here. But that is history today Kashmir is not what it used to be. In the latest government's "Ease of living index" Srinagar ranked at the bottom in Indian's most liveable cities. There are many factors responsible for Srinagar's poor performance; mismanagement of garbage is the most important one. Srinagar City produces 400 metric tons of waste each day. The real problem is not generated waste but poor management of waste. After collecting waste from house's hundreds of SMC sweepers empty their trolleys at open temporary sheds which mostly include Srinagar's busy roads, piles of garbage are formed and these piles of garbage stay there for hours until finally cleaned and transported to landfills. This method of collection and transportation of waste seems a much-uncivilized thing to do, but in this part of the world, this is normal. 2020, taught humans the true value of the clean environment and sanitation, but in Kashmir even during the pandemic, this piling of garbage on streets was practiced. During the rush full morning hours, when streets are jammed with traffic, people rush to offices, children's going to their schools, etc. SMC workers throw their collected waste on the streets which is not only ridiculous to watch. But in the summers it becomes almost impossible to breathe there due to production of gases from decomposing organic waste, decomposing organic wastes are also hotspots of microbial growth, which makes people and animals living around these areas' vulnerable to disease. Lack of exercise linked to depression risk amid pandemic

R xercise has for long been recommended as a cognitivebehavioural therapy for patients of depression, yet new evidence suggests that the Covid-19 pandemic changed the nature of the relationship between physical activity and mental health.

The study of college students, conducted before and during the

pandemic, revealed the average steps of subjects declined from 10,000 to 4,600 steps per day and rates of depression increased from 32 per cent to 61 per cent.

The research, published in the Proceedings of the National Academy of Sciences, also revealed short-term restoration of exercise does not meaningfully improve mental well-being.

"This raises many possible explanations, including that the impact of physical activity may require a longer-term intervention," said co-author Sally Sadoff from the University of California - San Diego.

"At the same time, our results clearly show that those who maintained physical exercise throughout the pandemic were the most resilient and least likely to suffer from depression," Sadoff added.

For the study, the team used a longitudinal dataset linking biometric and survey data from several cohorts of nearly 700 young adults before and during the Covid-19 pandemic.

In addition to filling out surveys, participants received wearable devices that track their activity levels.

Among the subjects, sleep increased by 25 to 30 minutes per night, time spent socializing declined by more than half (less than 30 minutes per day), and screen time more than doubled to five or more hours per day.

The researchers found large declines in physical activity during Covid-19 was most strongly associated with higher rates of depression.

Those who experienced declines of one to two hours of physical activity per day were most at risk for depression during the pandemic. While participants who were able to maintain their daily habits were at the lowest risk for depression, the team said.

Study finds new way to halt excessive

Study unveils association between gender assumptions and climate adaption

inflammation in body

Researchers at the Royal College of Surgeons in Ireland (RCSI) have discovered a new way to 'put the brakes' on excessive inflammation by regulating a type of white blood cell that is critical for our immune system.

The discovery has the potential to protect the body from unchecked damage caused by inflammatory diseases.

The paper, led by researchers at RCSI University of Medicine and Health Sciences, is published in Nature Communications.

When immune cells (white blood cells) in our body called macrophages are exposed to potent infectious agents, powerful inflammatory proteins known as cytokines are produced to fight the invading infection. However, if these cytokine levels get out of control, significant tissue damage can occur.

The researchers have found that a protein called Arginase-2 works through the energy source of macrophage cells, known as mitochondria, to limit inflammation. Specifically

they have shown for the first time that Arginase-2 is critical for decreasing a potent inflammatory cytokine called IL-1.

This discovery could allow researchers to develop new treatments that target the Arginase-2 protein and protect the body from unchecked damage caused by inflammatory diseases.

"Excessive inflammation is a prominent feature of many

diseases such as multiple sclerosis, arthritis and inflammatory bowel diseases. Through our discovery, we may be able to develop novel therapeutics for the treatment of inflammatory disease and ultimately improve the quality of life for people with these conditions," commented senior author on the paper Dr Claire McCoy, Senior Lecturer in Immunology at RCSI.

The study was led by researchers at the School of Pharmacy and Biomolecular Sci-



ences, RCSI (Dr Claire McCoy, Dr Jennifer Dowling and Ms Remsha Afzal), in collaboration with a network of international researchers from Australia, Germany, and Switzerland.

The research was funded by Science Foundation Ireland, with initial stages of the research originating from a grant from the National Health Medical Research Council, Australia.

study led by Dr Jacqueline Lau from the ARC Centre of Excellence for Coral Reef Studies at James Cook University (Coral CoE at JCU) and WorldFish, suggested that gender -- alongside other identities like race, class, and age -- has a powerful influence on people's experience of, and resilience to, climate change.

The findings claimed that outdated assumptions regarding gender continue to hinder effective and fair policymaking, along with the action for climate mitigation and adaptation.

She said the four most common and interlinked assumptions found are: women are innately caring and connected to the environment; women are a homogenous and vulnerable group; gender equality is a women's issue and; gender equality is a numbers game.

"Although there is a global mandate to work towards gender equality in climate change mitigation and adaptation, efforts are hindered by a set of assumptions about gender, long critiqued in development studies," Dr Lau said.

The study draws on post-2014 gender and climate change literature, to give an overview of how the gender assumptions manifest across recent work in adaptation, mitigation, and broader climate change policy, practice, and research.

The review of the literature takes a closer look at how these assumptions narrowly diagnose the causes of gender inequality.

"As a result, we see too many strategies that have unintended-

-and even counterproductive--consequences," said Dr Pip Cohen, from WorldFish.

"For instance, strategies that target women only may overburden them, cause a backlash, or obscure the vulnerabilities of other groups."

The study offers lessons for a more informed pursuit of gender equality in climate change research, policy, and practice.

The authors said progressing gender equality means breaking down stereotypes and prejudices about gender-creating environments to enable all people to exercise their agency to cope, change and adapt.

Dr Lau said she was surprised to find so many examples of gender assumptions in climate change practice. She explained that a first step in disrupting these assumptions is to lay them bare and explain why development research has found them to be problematic.

"The social and cultural expectations about what it is to be a woman or a man in any given society will shape people's wellbeing," Dr Lau said.

She said alongside efforts to dismantle broader barriers to gender equality, better and more coordinated efforts are needed from practitioners and researchers to disrupt and counteract unhelpful assumptions.

"Pursuing gender equality in climate change policy and practice is critical, and decades of experience in development offer lessons for how to do it well," Dr Lau said.

"Ultimately, we want to see equitable opportunities for all people to realize their full potential. Where no one is left behind."

Study says, attitudes based on feelings, emotions can stand test of time

ashington : Depending on the topic, people's attitudes can change frequently or last a lifetime. New research drove by Association for Psychological Science reveals that attitudes based on feelings and emotions can also stand the test of time.

Past studies have demonstrated that opinions based on hard facts and data can remain constant over time, but new research published in the journal Psychological Science reveals that attitudes based on feelings and emotions can also stand the test of time. This research has implications for both predicting whose attitudes are fixed versus fleeting and how to nudge people to form more long-lasting opinions.

"We have known that encouraging people to think carefully and rationally can produce attitudes that change less in the future," said Matthew Rocklage, a researcher with the University of Massachusetts, Boston, and co-lead author on the paper. "Our research, however, shows that opinions based on people's emotional reactions can be particularly long-lasting as well."

As part of their study, the researchers asked more than 1,000 people to what extent they believed attitudes based on feelings or emotional reactions were more stable over time than those based on thinking and rational analysis. Only 15 per cent expressed

any belief that attitudes based on emotion would be more stable over time.

To test the role that emotion plays in forming long-lasting attitudes, the researchers conducted seven independent studies involving more than 20,000 participants in a variety of real-world situations.

The first survey, which was conducted the day after Christmas, measured feelings about recently received gifts. The timing of this survey allowed the researchers to measure real-world reactions to a relatively newly formed attitude.

The participants were given a list of adjectives to describe their attitudes toward their gifts. Adjectives like "worthwhile" were associated with a practical reaction to the gift, whereas words like "delightful" were more strongly associated with an emotional reaction.

One month later, the participants completed a follow-up survey to test the endurance of their opinions. The results showed that the stronger the initial positive emotional reaction, the more likely that opinion remained fixed one month later.

The researchers conducted similar tests using virtually the same procedure but involving other scenarios, such as how much the participants supported consumer brands over time and how favorable their online restaurant reviews were between visits.

5500 Hectares Of High-Density Plantation To Come Up In J&K

IAMMU: The Administrative Council under the chairmanship of Lieutenant Governor, Manoj Sinha approved the implementation of high-density plantation scheme in the horticulture sector with the support of the National Agricultural Cooperative Marketing Federation of India Ltd (NAFED). The step will go a long way in enhancing the quality and quantity of horticul-ture produce and doubling the farmer's income.

The farmer-centric scheme will be implemented for apple, walnut, almond, cherry, litchi, and olive among others over an estimated area of 5500 hectares of suitable agro-climatic zones for 6 years with effect from March 2021 to March 2026.

The new high-density plantation scheme has provisions to provide 50% subsidy to orchardists for the establishment of high-density orchards accompanied by a loan facility for raising 40% of remaining capital.

The scheme will also provide subsidies to the growers on account of expenditure related to micro-irrigation, plant material, and anti-hail nets. Under the scheme, preference will be given to farmers with landholdings of less than 4 kanal.

The high-density plantations are expected to make horticulture profitable through superior yields, higher yields per hectare, early harvest, and introduction of insect and pest resistance varieties thereby saving the expenditure on disease and pest control.

The scheme will be implemented with the support of NAFED which will provide end to end support to the growers and will assess the suitability of available land for undertaking high-density plantation.

NAFED will also install a hightech laboratory for certification of the horticulture produce on international standards, virus indexing laboratories, and will arrange for imports of the specified qualities and species from identified countries.

Google Pay To Give Users More Control Over Their Data

New Delhi: Google on Thursday said it will offer users of Google Pay enhanced privacy features, allowing them to take control of their own transaction data.

Google Pay is rolling out an update to the app from next week that will provide users with more controls to decide how their Google Pay activity is used to personalise features within the app.

All users will be asked to choose whether they would like to turn the control on or off as soon as they upgrade to the next version of the Google

"Privacy is already a key priority for us... If you do anything on Google Pay, it stays on Google Pay – and that's the state today. What we are saying now is we are creating new controls for managing your Google Pay activity, even on Google Play. So if you're doing something on Google Pay, we want you to be in control of say-

ing – should this activity be used or recorded for use for personalising a feature," Google Pay vice president – product Ambarish Kenghe told PTI.

He cited an example of using Google Pay for recharges of mobile phone services and said users can now choose whether this data can be used for providing offers and rewards to the users.

"Turning on 'Personalisation within Google Pay' will provide users with a more tailored experience within Google Pay. Even with this setting turned off. Google Pay will continue to work just as well - only without personalisation," he added.

Users will also be able to view and delete individual transactions and activity records that they don't want used to personalise the Google Pay experience.

"The transaction history will still be there for regulatory purposes (which mandates transaction data be stored for the operator for a period of time) but it will not be used for personalisation," Kenghe said.

These steps will also help the tech giant in allaying fears of customers and regulators about the misuse of the financial data of users.

Google Pay supports UPI payments as well as contactless card transactions through tokenised debit or credit cards linked to users' smartphones.

While the company does not provide country-specific user numbers, globally it has over 150 million monthly

active users of which India accounts for a large share. don't "We take users' trust for granted, and

work hard to ensure that people are able to understand and manage their data and make privacy choices that are right for them. We do this by putting our users in the driver's seat to manage their data and privacy with easy-to-use privacy features and controls," he said.

Kenghe emphasised that the financial and transaction information on Google Pay is never sold to a third-party, and the transaction history is not shared with any other Google product for targeting ads.

According to Google Pay India, users anytime can also deselect transactions, which they wouldn't like Google Pay to use for providing a personalisation experience.

These privacy features will be shown upfront for new users before they sign up for the app, while old users will get a pop-up when they upgrade their existing app. Users can also review these from the setting tab. –PTI

Apple Starts Assembling Its Flagship Smartphone iPhone 12 in India

NEW DELHI: Apple Inc has started the assembly of iPhone 12 in India, the U.S. tech giant said, as the company ramps up manufacturing operations in the world's second-biggest smartphone market.

"We are proud to be starting production of iPhone 12 in India for our local customers," Apple said in a statement on Thursday, without naming the supplier

India's Growth **Positive For World Economy: IMF's Gita Gopinath**

NEW DELHI: Strong economic growth in India has positive implications for the global economy and the country stands out for its vaccine policy, which is playing a key role in helping the world deal with the Covid-19 crisis, International Monetary Fund (IMF) chief economist Gita Gopinath said on Monday.

"India makes up about 7% of world GDP based on purchasing power parity terms. So, when you are that large, what happens in India has implications for many other countries in the world, especially countries in the region," Gopinath said.

Gopinath said India, which typically grows 6%, was hit very hard by the pandemic and it is forecast to contract 8% in the current financial year that ends in March. But now recovery was under way as economic activities have restarted.

"So, we have indeed projected a growth of 11.5% this year (2021-22). Now, because of its size when you have India growing, it increases demand for goods from other parts of the world and that's a big positive," Gopinath said.

Gopinath said better economic opportunities and equal pay for women not only lowers gender inequality but also lowers income inequality.

Pakistan Ready To Host SAARC Summit: FO

ISLAMABAD: Pakistan said on Thursday that it was ready to host the long delayed summit of the South Asian Association for Regional Cooperation (SAARC), which is an important organisation for regional cooperation.

"Pakistan is committed to its process

and to hold the SAARC summit...It believes that all artificial obstacles in the way of long overdue SAARC summit should be removed," Foreign Office spokesperson Zahid Hafeez Chaudhri told reporters during his weekly media briefing here. The last SAARC summit was held in

Kathmandu in 2014. The 2016 SAARC summit was to be held in Islamabad. But after the attack on an Indian Army camp in Uri in Jammu and Kashmir on September 18 that year, India expressed its inability to participate in the summit due to "prevailing circumstances".

The summit was called off after Bangladesh, Bhutan and Afghanistan also declined to participate in the Islamabad meet.

SAARC summits are usually held biennially and hosted by member states in alphabetical order. The member state hosting the summit assumes the Chair of the Association.

In his message on the occasion of the 36th charter day of SAARC on December 8 last year, Prime Minister Narendra Modi said the full potential

of the eight-member bloc can only be realised in an atmosphere free of terror and violence.

On December 8, 1985 at the first SAARC Summit in Dhaka, the leaders of the seven South Asian states - the Maldives, India, Bhutan, Pakistan, Nepal, Bangladesh and Sri Lanka signed a charter to establish the bloc. Afghanistan became the eight SAARC member in 2007. During Thursday's foreign office media briefing, Chaudhri also rejected the reports that Pakistan is importing COVID-19 vaccine from India.

"Pakistan has not entered into any bilateral procurement agreement for COVID-19 vaccine from India," he said in response to a question.

records for further investigation and to probe his complicity in other crimes," he added.

According to the police spokesperson, the encounter broke out on Wednesday evening when the state forces launched a cordon and search operation (CASO) on the basis of specific input generated by police regarding presence of militants in the village.

"During the search operation, as the presence of militants got ascertained they were given opportunity to surrender, however, they fired indiscriminately upon the joint search party, which was retaliated leading to an encounter," he said.

"Due to darkness the operation was suspended however the cordon remained intact throughout night," he added.

The police spokesperson further said that the last rites of the killed militants shall be performed after conducting their medico-legal formalities and their nearest family members shall be allowed to participate in their last rites.

"In this connection a case under relevant sections of law has been registered and investigation has been initiated. People are requested to cooperate with police till the area is completely sanitized and cleared of all the explosive materials, if any," he added.

Charges Filed

Divulging details of the case, he said, police and army on September 14 last year busted Hizbul Mujahideen module and arrested 3 militant associates identified as Arshid Ahmad Khan of Wayil, Majid Rasool Rather and Mohd Aasif Najar, both residents of Beehama Ganderbal for hatching "criminal conspiracy for militant acts, harbouring militants and giving support to the proscribed militant organisations".

The police spokesperson said that the investigations revealed that the arrested trio had came into contact with a Pak based Kashmiri militant Fayaz Ahmad Khan of Gutlibagh and were being handled by him from across to take up various militant and subversive activities in the district.

Referring to recent media reports, which said that nearly 150-170 Rohingya refugees in Jammu have been detained, the plea said that new circumstances have arisen even when the matter is pending before the court.

"This follows after the Union Minister Jitendra Singh's statements two months ago that the Rohingya (identified as Muslim refugees by the government) wouldn't be able to secure citizenship. These refugees have been illegally detained and jailed in the Jammu Sub Jail which has been converted into a holding centre with the IGP (Jammu) Mukesh Singh stating that they face deportation back to Myanmar following verification by their embassy," the plea said.

The plea claimed that most of the Rohingya refugees have cards issued by the UN High Commissioner for Refugees (UNHCR) acknowledging their status as refugees and granting them protections.

According to official documents from the office of deputy commissioner of Jammu, there are 6,523 Rohingya in Jammu, it said.

On January 10, last year, the top court had said that it would hear in detail, a batch of pleas challenging the Centre's decision to deport illegal Rohingya Muslim immigrants to Myanmar.

The top court is also seized of petitions which support the government's stand to deport over 40,000 Rohingyas, who fled to India after violence in the Western Rakhine State of Myanmar and are settled in Jammu, Hyderabad, Haryana, Uttar Pradesh, Delhi-NCR and Rajasthan.

One of the intervention application is filed by the United Nations special rapporteur saying that the Centre's decision for mass deportation of the Rohingya as being "impermissible under international human rights law", and India should ensure that the Rohingyas enjoy "equality before the law and equal access to judicial remedies and individualised forms of due process".

Initially, two Rohingya immigrants --Mohammad Salimullah and Mohammad Shaqir, who are registered refugees under the UNHCR, had moved the apex court in 2017 challenging the move to deport to Rohingyas on various grounds including that it violated international human right conventions.

The Centre had questioned the bona fides and motives of the NGOs and individuals seeking facilities for the Rohingya refugees, and stated that there is no discrimination between Indians and outsiders in providing health and education facilities.

The apex court had on October 13, 2017 said he Rohingva refugee problem was of "great

After "public outcry and protests by the family members", the petitioners say that the District Magistrate on 17 September 2020 passed an order under section 176 CrPC, ordering Additional District Magistrate to conduct a magisterial enquiry so as to ascertain causes and circumstances leading to Irfan's death. "It was provided that the Enquiry Officer shall submit his report within a period of 20 days."

Also, the family says, a complaint was filed on 02 October 2020 before the National Human Rights Commission and in view of the seriousness of the allegations, the DGP was directed to file a detailed report in the matter including inquest, Post-mortem and Viscera reports and the video CD of the post-mortem examination with final cause of death and the magisterial enquiry report conducted in the matter along with explanation as to why the case of "custodial death" was not reported to the Commission within 24 hours.

"The DGP has neither submitted the report nor explained his position in the matter till date," the family says.

The family also claimed that Police Department did not cooperate with the Enquiry Officer so as to "sabotage" the enquiry into the killing. Meanwhile, the family said, the Enquiry Officer finally concluded the enquiry in the matter and submitted report to District Magistrate Baramulla.

"The petitioners (family members) are of reasonable belief, given the statements of witnesses before the Enquiry Officer, that the enquiry report has indicted the Police personnel for killing (Irfan) in custody and has ruled out the theory of the police that the deceased while fleeing from custody fell into a stone query resulting in his death." mother-in-law. "By then, she had already retired, but I was instantly moved by her illustrious persona."

Begum Zaffar can be easily identified as one of the most influential and meticulous women of her times. Her life, Shaheena says, was that of extraordinary persistence and intellect which brought girl education to the forefront and dispelled illiteracy and ignorance.

"As a champion of women rights, her tireless and unwavering contribution to social changes and reforms pertaining to girl education in the valley and upliftment came at a time when society was predominantly patriarchal and orthodox in its outlook and question of women liberation and education were still widely restricted," Shaheena says.

Begum Zaffar Ali was born in 1900 in the distinguished Agha family of Srinagar with her maiden name, Syyeda Fatima Hussain. She was the eldest daughter of Khan Bahadur Aga Syed Hussain, the first matriculate of Kashmir.

Along with her siblings, she was homeschooled by a European Home Coverness While pursuing her education, she was married to her cousin, Agha Zafar Ali Qazalbaash, a scion of Afghan family. She continued her education after marriage.

"Back then, parents were still debating whether to give only religious teachings to their girl child or give them modern education," says Rameez Kashani, a history lecturer.

"To uplift Kashmiri women and free them from their ignorance and religious and social conservatism, Begum Zaffar led the movement of women emancipation in the valley where she could encourage girls to come forward and educate themselves.

Later she was appointed as the Inspector of Schools in Kashmir and was the first Muslim in her administrative capacity, who went on delivering lectures in colleges and social gatherings.

As a great orator and popular figure, Begum Zaffar was a key member behind the foundation of Teachers Club and Ladies Club, whose members included Tara Devi, queen of Kashmir's last monarch. Hari Singh.

"The club was central to bringing reform changes and participation in the lives of the Kashmiri women," Kashani says.

Before the bloodcurdling fall of 1947, Begum Zaffar had served as the secretary of the All India Women's Association but later resigned due to her displeasure with the association's nationalist fervour.

Back in 1944, she had famously hosted Mohamad Ali Jinnah and his sister, Fatimah Jinnah at Srinagar. She had organised a meeting of Kashmiri women with the stalwart's shadow sibling at present day Lawns of Secretariat.

In her lifetime, Begum Zaffar held various offices and with her intellectual ability and leadership, she was the first Muslim in Kashmir to become a director in the Department of Education.

In her later days, she was also member of the Social Welfare Advisory Board, Jammu and Kashmir, and even became a legislator.

At personal level, Begum's three sons went on to have distinguished public profiles. Her two sons, Agha Nasir Ali and Agha Shaukat Ali were civil bureaucrats.

While Agha Nasir retired as Labour Secretary of India in 1977, Agha Shaukat Ali, moved to Pakistan and joined Civil Services. Her youngest son Agha Ashraf Ali followed her footsteps and went on to become a top academician and educationist of the valley.

"It was Begum Zaffar Ali whom Sheikh Abdullah approached to convince her son, Agha Shaukat Ali to come back from Pakistan and join his cabinet," Shaheena says. "During her lifetime, she longed to meet the same son when he moved to Pakistan. But New Delhi never granted a visa to her for meeting her son in the neighbouring country."

When the same government awarded Padma Shri to her in recognition of her outstanding contribution to the field of social welfare in 1987, Begum famously declined the award in a televised Doordarshan interview.

'The Indian state excesses and gross human rights violations in Kashmir was the reason behind the non-acceptance," historian Kashani In her later years, the top educationist had been shuttling between Srinagar and Washington, to be with her exiled son. In 1999, when she was staying with Agha Shaukat in the United States, the whole family, including her great grandchildren, had planned to celebrate her birthday as she was turning 100 year old.

"In terms of section 12 (5) and 12 (6) of Kashmir and Jammu universities act, 1969, the chancellor University of Jammu has been pleased to order the following terms and conditions of appointment of professor Manoj Kumar Dhar VC University of Jammu. "Instead of registering the FIR upon presentation of a written complaint the family members of the Irfan Ahmad Dar were called to the Police Station and informed that Irfan Ahmad Dar escaped from custody in village Tujar Sharief and his body has been found in a deep gauge/stone query," the family says, adding, The fact of the matter is that (Irfan) was subjected to worst kind of physical torture while in llegal custody which resulted in his death and his body was thrown in a stone query.

The family alleged that a story was "cooked up" that Irfan died after he escaped from Police Custody while he was being taken for making recovery of some illegal ammunition in village Tujar Sharief. The family says that Police Station Bomai registered an FIR (No. 71/2020) under Section 224 IPC (Resistance or obstruction by a person to his lawful apprehension) to this extent.

The family says that Irfan's death took place in highly "suspicious circumstances" and "he bore visible torture marks all over his body including head, chest and limbs. There were visible and apparent burn injuries over the body of the deceased."

"All this strengthens the belief of the (family)

While being a mother to three, she went ahead taking revolutionary strides and efforts which would go on to change the face of women's emancipation and education in the valley and inspire thousands of young girls for years to come.

In 1925, Begum Zaffar was invited to teach in a Girls Missionary High School run by Miss Mallinson and Miss Bose in old Srinagar's Fateh Kadal area.

"During those times, being a teachress was seen as a stigma but nevertheless she joined the school to serve the cause of education," lecturer Mehmood continues.

"Her door-to-door campaigning for education in an era of subjugation and poverty makes Begum one of the most unsung educationists of the world. Her academic pursuits and ambitions to bring social changes heralded a new hope.

Such was the zeal and determination of Begum Zaffar that she simultaneously started philanthropy work towards the poor girl of the school and looked after their hygiene and overall development.

"She even encouraged both young and elderly women to seek education and personally volunteered to teach them," says Mubashir Hussain, a social activist from Srinagar.

"Through the good offices of her father who was then Home and Judicial Minister in Maharaja's regime, grants were sanctioned for the schools. Begum managed to get an extra sum of Rs 10 sanctioned for the maintenance of girls every month besides meals."

Impressed by her progress in studies, her children's home tutor encouraged her to sit for the matriculation examination as she, by then, had been teaching girl students of tenth standard for five years.

Begum Zaffar was reluctant initially as no woman from the valley till then had passed the matric exam. She finally broke the jinx by becoming the first matriculate woman of Kashmir in 1930 and went on to complete her graduation in Domestic Science and Liberal Arts from Lady Mclegon College, Lahore in 1938.

"But sadly," Shaheena says, "she passed away

'KL Rahul And Rohit Sharma Will Start As Opening Pair,' Says Captain Kohli

AHMEDABAD: India captain Virat Kohli on Thursday said that Rohit Sharma and KL Rahul will be the team's opening combination in T20 cricket going ahead as it geared up for a five-match series against England starting in Ahmedabad on Friday.

Kohli also made it clear that Ravichandran Ashwin will not be in the white-ball scheme of things till Washington Sundar is performing.

India will start their preparations for the T20 World Cup, to be held in India later this year, with the series against England and the skipper did give some indications about how the core combination would look like.

"If Rohit plays, then it's simple. KL (Rahul) and Rohit have been performing consistently at the top of the order for us and those two will start," Kohli was unambiguous in his reply that the seasoned Shikhar Dhawan will have to wait.

"In a situation, Rohit takes rest and KL has a niggle or something, Shikhi (Dhawan's nickname in team) obviously comes in as the third opener but the starting composition, Rohit and Rahul will be the ones who will start."

However, Kohli was trifle annoyed with a question on India's no.1 Test spinner Ashwin's chances of making a comeback looking at his impressive IPL form last time when he got some big names including the India captain cheaply.

"Washington has been doing really well for us. So you cannot have two players of the same discipline, playing in one spot. So (this will not happen) unless Washy has drastically horrible season and things go south for him," Kohli said about the young all-rounder.

Washington has an impressive economy rate of less than 7 per over (6.95) in 26 games for the country. Kohli made it pretty clear that the question didn't amuse him one bit.

"I mean the question has to be asked with some kind of logic as well. You suggest where you would add Ash, and play him in the team?" he countered. "Washington already does that job for the team. It's easy to ask a question but you should have a logical explana-

tion to it yourself." No space for compromise on fitness: Kohli on Varun Chakravarthy Mystery spinner Varun Chakravarthy's repeated fitness test failures have raised quite a few eyebrows and the Indian captain sent a message loud and clear that anyone aspiring to play for India should abide by certain fitness standards.

Chakravarthy, an IPL sensation for Kolkata Knight Riders, was first picked ahead of the Australia tour only to be found out later that he was hiding a shoulder injury back then.

He did his rehabilitation at the NCA but hasn't played any national level competitive match and again failed the YoYo (17.1) and 2km (8 minutes) fitness test after Chetan Sharma's

Coach Koeman Hopes His New-Look Barcelona Can Convince Messi To Stay

BARCELONA: A friendly chat with Kylian Mbappe. A quick hug with Mauricio Pochettino. A kiss on the forehead from Ángel Di María.

The signs were all there at Parc des Princes for paranoid Barcelona fans who fear Lionel Messi will follow the path of Neymar and bolt for Paris Saint-Germain once the season ends.

Barcelona coach Ronald Koeman. however, is confident that he has done all he can to convince Messi to continue his career with the Spanish club, despite another disappointing Champions League campaign.

"Leo has to decide his future, nobody can help him do that, (but) I think that he has seen for some time now that this team is on the right track and has a future. I don't think that he can use that as a reason not to stay," Koeman said after Wednesday's 1-1 draw at PSG eliminated Barcelona from the competition.

Koeman, who instead of titles promised a rejuvenation of the team when he took over last year, has Barcelona play-

ing well again. The team fought back to beat Sevilla in the Copa del Rey semifinals last week and has closed the gap on Spanish league leader Atlético Madrid to six points.

Barcelona is unbeaten in 16 league games – with 13 wins and three draws - before it hosts last-place Huesca on Monday. Atlético visits Getafe on Satout rounds. The humiliating 8-2 debacle against Bayern Munich last season prompted Messi to say he wanted to leave the club he has been a part of for two decades. Since then, he has kept quiet about his plans, except to say that he will decide when his contract expires at the end of the season.

Swayed by his past relationship with Messi, Joan Laporta was elected as president again last weekend by club members. Laporta claimed he was the best man to talk Messi into remaining at the Camp Nou.

But until Messi actually signs a new deal, all eyes will be on possible suitors. And PSG is a leading candidate since it is one of a handful of clubs that could possibly afford a player who currently makes 138 million euros (\$167 million) per season.

Pochettino, the PSG coach, said his hug with Messi after Wednesday's match was "just to say hello" to a player who he coached against when he was at Espanyol. Di María, who pecked Messi on the head after the final whistle, is a teammate on Argentina's national team.

While Mbappe's future is also in doubt with his contract set to expire, Neymar could be a lure for Messi. Neymar, whose contract is also up after the season, has repeatedly said he would love to remake the partnership he shared with Messi at Barcelona.

But Koeman hopes he can offer Messi a team on the up thanks to his bold moves to remake a squad that had once won it all, only to slowly lose its competitiveness in Europe. Out went Luis Suárez, Arturo Vidal and Ivan Rakitic last offseason, and in came 18-yearolds Pedri González, Ansu Fati and Ilaix Moriba, among other promising talents.

For Koeman, the main thing that Barcelona lacked against PSG was the finishing touch provided by Mbappe, who scored four goals in the aggregate 5-2 victory.

"I think everyone can be proud of the image we have shown," Koeman said. "Once again this team showed that it has a great future."

Now the question is whether pride and promise are enough for Messi, now 33, to stay put.

5 Years After Return From Pakistan, Geeta May Have **Finally Found Her Family**

o DNA test has been conducted yet but for 29-yearold Geeta, who returned to India from Pakistan in 2015 after going there when she was nine, the search for her biological mother may have ended, an NGO says.

Geeta, who returned to India on October 26, 2015 after intervention by then External Affairs Minister Sushma Swaraj, was initially lodged at a facility of a hearing and speech impaired institute run by an Indore-based NGO. The over five-year-long search to find Geeta's family led to Parbhani in Maharashtra, where she is now being trained in sign language by Pahal, an NGO working for the hearing and speech impaired.

Speaking to PTI, Dr Anand Selgaokar of Pahal said Geeta was handed over to Anand Services Society, another Indore-based NGO, on July 20, 2020 and Gyanendra Purohit of that NGO first came to Parbhani in December last year.

The search in the last five years involved screening process of at least a dozen families from Uttar Pradesh, Bihar, Telangana and Rajasthan after claims that they were Geetas blood relations. Purohit said the search led the NGO to Meena Waghmare (71) who lived in Jintur in Parbhani district, when her daughter Radha (Geeta)

went missing "Meena told us that her daughter has a burn mark on her stomach and when we checked, it turned out to be true," Purohit said.

Geeta's father and Meena's first husband Sudhakar Waghmare died some years ago and she now lives near Aurangabad with her second husband, Purohit said.

Tears rolled down Meena's eyes as she met Geeta for the first time, he said. Geeta did not understand a word of what Meena said as being speech and hearing impaired, she communicates only through sign language.

It is likely that Geeta reached Parbhani and boarded the Sachkhand Express to Amritsar and later boarded the Delhi-Lahore Samjhauta Express, Selgaonkar said. Geeta has now spent around a month-and-a-half in Parbhani and often meets with Meena and the latter's married daughter, who also lives in the Marathwada region.

"It is for the government authorities to decide on when to conduct a DNA test. Till then Geeta will continue to receive training at Pahal," Selgaonkar said. Pakistani media reported that Geeta, who was rescued by a social welfare organisation in Pakistan after she mistakenly ended up in that country before being sent back to India in 2015, has been reunited with her real mother in Maharashtra.

Bilquees Edhi the wife of late Abdul Sattar Edhi, who now runs the world famous Edhi Welfare Trust and who developed a close bond with Geeta said the Indian girl had finally been reunited with her real mother in Maharashtra state, Dawn newspaper reported. "She has been in touch with me and this weekend she finally told me the good news about meeting

her real mother," Bilquees said. Bilquees said they had found Geeta when she was around 11-12 years old at a railway station and gave her shelter at their centre in Karachi.

"Somehow she strayed into Pakistan and was shelterless when we found her in Karachi," she said.
