Centre Unveils Over Rs 1Lakh Crore Budget Of J&K For 2021-22

Each DDC To Get Rs 10 Cr Development Fund, BDC Rs 25L

SRINAGAR: Union Finance Minister Nirmala Sitharaman on Wednesday unveiled Rs 1, 08,621 crore budget of Jammu and Kashmir Union Territory for 2021-22 in the Lok Sabha.

The budget document reveals that its focus is on good governance, socio-economic development of the people, infrastructure building and generation of employment.

'The budget for 2021-22 for J&K shall again cross Rs.1 lakh crore mark, an indicator or our commitment to make J&K a model of development," reads the budget documents.

Budget figures:

The total budget estimates for the next fiscal is Rs 1,08,621 crore. Of which Rs. 39,817 are earmarked capital expenditure and Rs 68,804 crore for revenue expenditure.

This means 37 % of the earmarked budget shall be spent on development and infrastructure projects.

Key announcements:

For the first time, the government has earmarked development funds for district development councils and block development councils.



in 2021-22. Similarly, Rs 71.25 crore have been proposed as 'development fund' for 285 block development councils. This means each BDC will get Rs 25 lakh as development.

been earmarked for DDCs in

The government has also proposed to spend Rs 30 crore for establishment of DDCs/ BDCs offices in 2021-22. Around Rs 1313 crore have been provisioned for PRIs/ULBs for rural and urban infrastructure, the documents reveal. In the budget, Rs 400 crore

has been provisioned for GST reimbursement to ensure timely reimbursement of the claims. Around Rs 200 crore has been set aside for the "Mission Youth programme".

The government has also kept a budgetary pro-vision of Rs 800



Kashmiri Students, Travellers 'Barred' From Visiting Pak

SRINAGAR: Protest broke out Wednesday at the Wagah border in Punjab after dozens of Kashmiris, including travellers and students were allegedly barred from visiting Pakistan despite possessing all travel

According to reports, hundreds of people, including Kashmiris had converged near the Wagah since Tuesday to cross over to the neighbouring country. However, dozens of Kashmiris, including students, travellers and elderly who were scheduled to visit their relatives on the other side were prevented from crossing over, while Pakistani travellers

were allowed to return. "I had to visit my sister who

is currently pursuing MBBS in Pakistan. However, when I reached the border this morning, we were told that Kashmiris can't be allowed to go to Pakistan," Hamnah Parvez, a protester said.

"Another family stranded with me has a daughter who has to appear in exams. If she can't make it soon, she will have to drop a year," she added.

A medical student wishing not to be named alleged that the officials at the Wagah were continuously changing their statements causing distress among the Kashmiris. "They told us that the proce-

Cancer patients less protected after first COVID vaccine jab, UK study finds

ancer patients may not be protected to the same degree as the rest of the population after they receive their first of two doses of a COVID-19 vaccine, a new UK study has found on Thursday.


A team of experts from King's College London and Francis Crick Institute found in the first real-world study of its kind that a shorter than the stipulated 12week gap between the two vaccine doses for such patients appeared to be the answer.

The study's senior authors, Dr Sheeba Irshad and Professor Adrian Hayday, believe that there should be urgent re-evaluation of UK policy for the dosing interval for all cancer patients, and likewise for many other high-risk groups of immuno-suppressed patients.

Our data provides the first real-world evidence of immune efficacy following one dose of the Pfizer vaccine in immunocompromised patient populations, said Dr Sheeba Irshad, a senior clinical lecturer from the School of Cancer and Pharmaceutical Sciences at King's College London.

We show that following the first dose, most solid and haematological cancer patients remained immunologically unprotected up until at least five weeks following primary injection; but this poor one dose efficacy can be rescued with an early booster at day 21, she said.

Data from the world's first reported trial to examine the level of immune protection after the Pfizer/BioNTech vaccine in cancer patients has found that anti-SARS-CoV-2 the virus which causes COVID-19 antibody responses at week three following the first dose of the vaccine were only 39 per cent and 13 per cent in



the solid and haematological cancers, compared to 97 per cent in those without cancer.

The preprint study, which is to be peer-reviewed, also reports that when the second dose of the vaccine was given three weeks after the first dose, the immune response improved significantly for solid cancer patients with 95 per cent of them showing detectable antibodies to the SARS-CoV-2 virus within just two weeks.

By contrast, those who did not get a vaccine boost at three weeks did not see any real improvement, with only 43 per cent of solid cancer patients and 8 per cent of blood cancer patients developing antibodies to the Pfizer vaccine at five weeks compared to 100 per cent of healthy controls.

The evidence of vaccine responses in cancer patients shows that a gap of 12 weeks between doses of the Pfizer-BioNTech vaccine could leave many cancer patients vulnerable to serious CO-VID-19, the study finds.

Prof. Adrian Hayday from King's College London and the Francis Crick Institute said: Cancer patients should be vaccinated and boosted quickly and their responses, particularly those of blood cancer patients, should be intensively monitored so that those who mix with family, friends and carers can be confident of their environment.

Dr Simon Vincent, Director of Research, Support and Influencing at Breast Cancer Now, called on the Joint Committee on Vaccination and Immunisation (JCVI), which determines the UK's vaccine rollout cohorts. to urgently review the evidence and to consider adapting its strategy to ensure that cancer patients can receive both the first and second dose of the Pfizer/BioNTech COVID-19 vaccine within a three-week timeframe

to minimise their risk of both contracting and becoming seriously ill with coronavirus.

Worryingly, this study suggests that people affected by cancer, including breast cancer, get little protection against the virus when they only receive a single dose of the Pfizer COVID-19 vaccine, and then do not receive their vaccine boost in the following three weeks, he said.

But Cancer Research UK said the small study had not yet been reviewed by other scientists and people undergoing cancer treatment should continue to follow the advice of their doctors, while the government said that antibody response "was only part of the protection provided by the vaccine".

Meanwhile, the UK study will continue to follow cancer patients after their vaccinations for up to six months

Old City's Gani Memorial Stadium In Shambles, Locals Rue Govt Apathy

Srinagar: The Gani Memorial Stadium situated right in the heart of the old Srinagar City's Rajouri Kadal mocks at the indifference of the government. The waterlogged stadium where Jammu Kashmir State Sports Council (JKSSC) installed 8 poles of floodlights with an estimated cost of Rs 1.24 crore in July 2019 narrates a woeful tale. Majority of these flood lights have become defunct while no efforts are being made to drain the water from the stadium which is completely in shambles, the locals alleged.

They welcomed the recent visit of Secretary Sports Council Nusrat Gul along with a team of Engineers to the stadium and hoped things will change for better but till date neither the stagnated water has been drained nor garbage removed.

"It is stinky. We don't enter into this stadium now. Heaps of garbage, water logging, and uneven field are some of the 'salient' features of this solitary stadium that exists in old Srinagar city," said a cricketer.

He said it is not the rain water

only that gets accumulated in the stadium but the water flowing from adjacent drains also gets logged here. "The stadium lacks drainage system. It needs technical expertise to frame a strategy to drain the water from the sports ground in order to make it playable for local youth," he suggested.

Players blame Sports Council authorities for the miserable condition of the Stadium.

"Players are suffering immensely. So many promises were made, but not fulfilled. No turf was made available Flood lights installed in the stadium are mostly non-functional. A team of efficient and dedicated engineers can change the face of the stadium,' Manager Mehboob-ul-Alam Cricket Club and Captain Ghani Memorial Reds (cricket) said.

Meanwhile, scores of youth mostly cricket lovers staged a protest outside SP College here in Srinagar urging upon authorities to complete the undergoing construction work at SP College Ground as early as possible. They said the college ground has been bulldozed to the extent that no sports activity is possible there. (KNT)

Shopian encounter

wo militants including Jaish commander Sajad Afghani were killed and five houses were gutted in the three day encounter at Rawalpora in Shopian. The firefight which also witnessed protests and stone pelting by the people trying to help militants escape left behind a trail of destruction. The videos and the pictures of the smoky rubble of the buildings went viral on social media reminding people across India of the grim nature of the situation in Kashmir. Afghani had been active in the area for close to three years and his killing is seen by the security agencies as a big jolt to the militancy in the Valley. At the same time, the encounter and the devastation wrought by it reveals that the normalcy in the Valley is still a long way off, more so in South Kashmir where the militancy stays strong even five years after the killing of Burhan Wani, who had revived it in 2014-15.

Last year's recruitment gives no cause for confidence. According to the data, over 170 local youth picked up arms last year. They have more or less replenished the killings of 225 militants in 2020, which is the largest number of such killings in the preceding decade. What's more, most of these killings were of the local youth. And if we go by the estimate of the security agencies, the number of militants this year remains more or less the same as last year or as their average number over the last five years.

The existing troubled situation is likely to continue unchanged. And Burhan still looms large in the Valley as some kind of an inspiration for the new militants who continue to join the ranks of Hizbul Mujahideen and the other outfits. But centre still feels the runaway situation can be reigned in by an iron fist approach which has now been extended to separatist political leaders.

As the situation of the past three decades testifies, the killings of the militants have neither deterred more youth from joining the militancy, nor ushered Kashmir back to peace. And nor, if this long duration is any guide, will it in future. A slain militant commander continues to be succeeded by another. The militancy and the state's response to it goes on. True, the state tackles the unfolding violence institutionally, so will not tire of it, but this unrelenting state of affairs is taking a massive toll on the people of the state, our new and the future generation. The most rational and effective response to the lingering turmoil is to address the factors which keep it going. But this is something that is and has been last on the minds of the ruling leadership of the country. One can only hope that the things change for the better in future on this score.

Social media's exaggerated "revolutionary" role

n discussing Facebook's positive contribution to the wider world, its role during the uprisings which began in 2011 in West Asia is frequently mentioned.

While Facebook was utilized, it was one of many tools used by the oppressed people in West Asia.

When analyzing the tools and tactics of the Islamic Awakening of 2011, Muslim analysts and media outlets tend to quickly adopt the default narratives of Western institutions. This is primarily because their narrative gets the widest me-

Attributing exaggerated importance to Facebook when it comes to grassroots events in the Muslim world is one of those

Regarding the events of 2011, it should be noted that the vast majority demonstrating against NATO installed dictators in Tu-

nisia, Egypt and to a lesser degree in Bahrain, were rural masses with poor internet connectivity and low-level IT skills Facebook played minimal or no role in the rural lifestyle.

People in Tunisia and Egypt bracing Western supplied live ammunition, tear gas and other police brutality tools were most likely influenced to come out on the streets by their local mosques, than Facebook or any other Western tool.

Don't expect the corporate media to highlight this because it disrupts the West's narrative. They push the notion that Muslims of West Asia desire to

adopt secularism as their political ideology. People in the developing world often cannot afford the re-

quired gadgets and internet costs for Facebook to become their central means of voicing discontent.

Also, Facebook and other mainstream Western technology organizations have a long track record in assisting Western backed autocratic regimes.

For example, Facebook has a long history of shutting down popular Palestinian pages upon requests of the US and Israeli regimes. In November 2020, Middle East Eye reported that Facebook took down "alleged Muslim Brotherhood accounts sharing 'inau-

thentic' information.'

The Forever Struggle

Thousands of women from around the world have been sharing information about just how unsafe they feel in public spaces, how they are followed, harassed, stalked and subjected to catcalls iust because they dare to exist. The streets are not safe for them when there is a pandemic and the streets are not safe for them when there is none

NYWHERE one casts a glance, women are in turmoil. Even in the year 2021, where DNA is revealing the secrets of human illness, where internet connections can allow people to communicate over thousands of miles, where we can see live images from Mars, women's lives are as endangered, as misunderstood and as constrained as ever.

Indeed, where the lives of women, their choices, their welfare, their health are concerned, a kind of worldwide primitivism prevails. The world may be virtual but women's physical bodies suffer in ways that men's never do. The experience of the world, of walking down a street, of going to a shop, of enjoying the weather, of meeting a friend, all of it, each and every moment of existence is rendered somehow dangerous by the very fact of being a woman.

This year too many in Pakistan pounced on the women who dared participate in the Aurat March 2021. In a country where women are kidnapped and raped and killed without anyone batting an eyelid, this one act by women wanting to celebrate themselves was, yet again, labelled as vulgar. The organisers of the march, sadly used to getting threats every year, faced their detractors yet again. This year, the critics increased in number and became even more vicious and venomous. Photos from the march were photoshopped and circulated, and videos were dubbed to underscore the thinking that women have no right to occupy public space or to make their own choices and tell their own stories.

For its part, the government has chosen to speak out of both sides of the mouth. On the one hand it has launched an investigation into the march, suggesting some illicit involvement, while on the other, it says it is looking at the origin of the doctored video clips and photoshopped pictures (that tried to link the march with blasphemy) whose creators may also face punishment. The TTP too threatened the marchers and women. In sum, they all came together to tell those Pakistani women who want a different future that their goal was simply impossible. If Pakistani women are angry these days, they have good reason to be.

Global primitivism prevails where the lives, welfare and choices of women are concerned.

It is not just Pakistani women though. In the United Kingdom, thousands of women across the country defied the lockdown to protest against the killing of a young woman named Sarah Everard. Last week, Everard had been walking home from her friend's house after the two had dinner together, when she disappeared. Her remains were found in another part of the country and were in such a condition that she could not be immediately identified.

A police officer from the Metropolitan Police, a

man who guarded diplomatic properties in London, has been arrested as a suspect. So it is that the very police that is supposed to ensure that the streets of London are safe for women, had one of its own arrested as a suspect in the murder of a young and innocent woman who was simply walking home.

In the aftermath, thousands of women from around the world have been sharing information about just how unsafe they feel in public spaces, how they are followed, harassed, stalked and subjected to catcalls just because they dare to exist. The streets are not safe for them when there is a pandemic and the streets are not safe for them when there is none.

Over in the United States, the governor of New York, Andrew Cuomo, is alleged to have sexually harassed young women in his employ. The allegations range from forcible kisses to inappropriate comments, many made in a professional venue. Even as the number of allegations increases and more and more women emerge as having suffered harassment allegedly at the hands of the most powerful man in New York, the governor has refused to resign. He could be removed by impeachment but current counts of the votes do not show enough support to remove him from office. The lesson is simple: women suffer and men survive.

These are just some cases. The pandemic has affected men and women unequally, and the latter's poor access to health, their inordinate burden of childcare and all sorts of other factors combine to make them even more vulnerable than they were before. At one point in time, transnational bodies like the United Nations could have been counted on as a platform

where a united agenda for the safety of women could have been urged. The UN that exists sold itself long ago to the misogynistic whims of countries that have thrown money at the organisation in exchange for international leverage. The radical potential of female solidarity is no longer something that the UN seems to be interested in.

So women everywhere are on their own, fighting alone but together. In their favour is the promise of emerging generations who bring with them new ideas about connectivity and collaboration. Technology can help, even though it cannot be counted on as the magic solution to the victimisation of women. In addition to public marches, which are unavailable to some women owing to their family situation or their work situation, consumer boycotts can be added to the activist arsenal.

When male money is threatened, male behaviour is likely to change. Finally, some attention can also be paid to change among women. It is women who are the bosses of millions of domestic workers in the country. Perhaps they can sign charters that protect the dignity of those women. These sorts of actions will not solve the problems that face Pakistani women, who are made to bear the brunt of all the insecurities and inferiorities that are faced by Pakistani men, but they will make a difference. In the meantime, whether it is in Pakistan or the UK or some other place, the struggle goes on, at least for one half of the world.

The Safety Conundrum

arlier this month, Sarah Everard was allegedly abducted and killed while walking home from a friend's house in London. In response to her disappearance, women were reportedly advised to avoid going out alone. Yet at the same time, the Metropolitan Police commissioner, Cressida Dick, sought to reassure women that incidences of abduction and murder are rare.

Heavy police presence and use of force during a recent gathering to remember Everard also raised issues about the way women are treated by authorities when demonstrating against sexual harassment and violence. It's an issue which, in some circles, has led to demands for police reform and Dick's resignation as commissioner. As one popular argument goes, penalising and physically handling women at a vigil didn't just ignore some women's fears of authorities, it suggested that women shouldn't be speaking out at all.

shouldn't be speaking out at all.

These contradictory messages underscore the problems surrounding discussions about violence against women. On one hand, sexual harassment and violence by men is viewed as inevitable and we're conditioned to believe the fear we live with is normal. On the other, women are often told they're overreacting and that violence is rare. But how helpful are these approaches in terms of eradicating systemic violence against women? And do they keep us safer?

Police advice

Just two years ago the police issued similar safety advice to women in response to a number of sexual assaults in London. They were told to avoid wearing headphones or using mobile phones in order to be "alert" in their surroundings. But this advice ignores that reality that many women already do this, and more, to avoid harassment and violence from men.

Recent research has documented the different types of "safety work" women routinely undertake to avoid the everyday



intrusions from men in public. As a result of these precautions, women pay a price, a form of gender-specific tax—they must trade-off their freedom in exchange for safety.

In reality, there is very little evidence that individual strategies reduce sexual violence. Nevertheless, failure to follow the safety advice almost inevitably means a woman is held at least partially responsible – the idea being that if she'd listened to advice, changed her behaviour or stayed home, she would have been safe.

The social media response

As news spread of Everard's case, thousands of women took to social media to share the extensive precautions they make on a daily basis to avoid risks – including avoiding dark streets, not wearing headphones when out alone, crossing the road to get away from individual or groups of men, and holding keys in their hands should they need to defend themselves or open their front door quickly.

This practice of taking responsibility to protect oneself is nothing new. Women are

told of the dangers in public places from a young age and that they should manage the risks that men pose by adapting their behaviour and restricting their movements accordingly. It's advice that women internalise, becoming hypervigilant of themselves, and others, in public spaces.

When women do speak out, they often experience aggressive backlashes, primarily from men who often argue that #NotAllMen engage in such behaviour. This common response to women's experiences of harassment and violence serves to undermine their accounts, dismiss them, or suggest that it is they who are sexist by suggesting all men behave in harassing or violent ways. Yet the evidence indicates that harassment and violence by men in public spaces is disturbingly prevalent, some of which has come to light in recent years through the #MeToo and #EverydaySexism movements.

Although the more extreme physical manifestations of violence such as abduction or murder are relatively rare, almost all women experience sexual ha-

rassment in public spaces, and a significant proportion report being sexually assaulted. And when women are subjected to serious physical violence or murder, it is overwhelmingly men who perpetrate it. This is often despite extensive safety work from women.

These conflicting messages leave women in a paradoxical situation whereby they have to change their behaviour to avoid the risk of harassment or violence, while also trying not to overreact to dangers they're often told do not exist or aren't common. They must have, what my colleague Fiona Vera-Gray has termed "the right amount of panic". Because of this, the focus is always on what women do and do not do – and the problem of male violence remains obscured.

Women need men to change their behaviour

While it's true that not all men engage in these behaviours, if they do nothing about them, they are complicit in a society that normalises them. Safety advice rarely tells men not to harass or rape women. And if they do, they're protected by the focus on what the woman failed to do to protect herself.

Following the outpouring of women's stories on social media in response to Everard's death, many men have acknowledged the privileges they enjoy in public spaces – such as freely being able to walk the streets at night without fear of sexual harassment or assault – things women cannot take for granted.

Some asked what they could do to help. Popular responses include giving women space, dropping back while walking behind a woman on her own or, ideally, crossing the road and walking ahead of her to reduce her sense of unease. Others involve men calling out sexual harassment when they see it or asking a woman if she's OK if it appears that she's being subjected to unwanted attention. Much of this advice comes from women, who yet again carry the burden of educating men.

If anything is going to change, a dramatic culture shift is needed. The widespread prevalence of violence and harassment also needs to be acknowledged – and challenged – without putting the responsibility on women. We don't need more safety advice, nor do we need telling the risk to us is low. What we need is for men to change their behaviour and for society to hold them accountable.

Centre Says COVID Vaccine Wastage In India At 6.5 Pc, Calls For Optimal Utilisation Of Doses

NEW DELHI: The average COVID-19 vaccine wastage in India is at 6.5 per cent, with Telangana and Andhra Pradesh being on the top with 17.6 and 11.6 per cent wastage respectively, the Centre said on Wednesday as it called for optimal utilisation of the doses.

A total of 3,64,67,744 vaccine doses have been administered till now in the country, which includes 1,48,60,930 beneficiaries aged 45-60 years with specific comorbidities and senior citizens who have been given the first dose.

At a press conference, Union Health Secretary Rajesh Bhushan said that Monday, 8.34 million COVID-19 vaccine doses were administered worldwide, of which India alone administered 36 per cent of the doses.

Bhushan said COVID-19 vaccine wastage in five states --Telangana, Andhra Pradesh, Uttar Pradesh, Karnataka and Jammu and Kashmir -- is higher than the national average of 6.5 per cent.

"The message we have shared with states is that vaccines are invaluable commodities. They are public health goods and

therefore vaccines have to be optimally utilised.

'Vaccine wastage has to be drastically reduced. Any reduction in wastage means that you end up inoculating more people and therefore the chances of disrupting the chain of infection grow that much more," he said.

On an average 13,12,215 vaccine doses are being administered daily with Rajasthan providing the most jabs on an average, Bhushan said.

About the increase in daily COVID-19 cases, Bhushan said from March 1-15, about 70 districts in 16 states have registered more than 150 per cent increase in active cases while 55 districts in 17 states have registered a 100-150 per cent rise in cases.

Most of these districts are in west and north India.

Elaborating on the rise in cases in states, he said, "If we look at Maharashtra, 60 per cent of all active cases and 45 per cent of new deaths are concentrated there."

"On March 1, 7,741 new cases were being reported on an average. By March 15, it stood at 13,527. The positivity rate, which was 11 per cent on March 1 rose to 16 per cent by March

Noting that the high positivity rate is a matter of concern, Bhushan said the number of tests is not increasing in tandem with the COVID-19 positivity rate. "So, our advice to the states, especially Maharashtra, is that there is a need to increase the testing rate, especially the RT-PCR ones," he said.

In Punjab, on March 1 an average of 531 new cases were being reported. By March 15, the number increased to an average of 1,338. The positivity rate has doubled and the share of RT-PCR total tests conducted was 89 per cent, he said.

"We would want a distinct increasing trend of tests in which RT-PCR share is substantially higher," Bhushan said.

In Chattisgarh, on March 1 an average of 239 new cases were being reported. By March 15, the number increased to average 430. The positivity rate increased from 1.4 per cent to 2.4 per cent and RT-PCR share in tests conducted is 34 per cent.

In Gujarat on March 1, an average of 398 new cases was being reported. By March 15, the number increased to 689. The

positivity rate increased from 2.4 per cent to 4 per cent and RT-PCR's share in COVID-19 tests was 50 per cent.

Karnataka had 443 cases on average on March 1. In a fortnight, the number increased to an average of 751. The positivity rate increased from 0.8 per cent to 1.3 per cent and RT-PCRs' share in COVID-19 tests is 93 per

In Madhya Pradesh, an average of 334 new cases were being reported on March 1. By March 15, the number increased to 564. The positivity rate has increased from 3.1 per cent to 7.4 per cent and RT-PCR share in tests was 65 per cent.

As for Haryana, an average of 151 new cases were being reported on March 1. By the middle of the months, the number increased to 374. The positivity rate has increased from 1.2 per cent to 3.3 per cent and RT-PCR's share in tests was 93 per cent.

In Delhi, on March 1 an average of 198 new cases were being reported. By March 15, the number increased to 371. The positivity rate has increased from 0.4 per cent to 0.6 per cent and RT-PCR's share in tests is 64 per cent.

CBI Books Cadbury India Pvt Ltd For 'Fraudulently' Availing Area-Based Tax Benefits in Himachal

NEW DELHI: The CBI has Cadbury Private Limited (now known as Mondelez Foods Private Limited) for alleged corruption and misrepresentation of facts to fraudulently avail areabased tax benefits in Baddi, Himachal Pradesh, officials

said on Wednesday.
After registering the FIR, the
Central Bureau of Investigation (CBI) carried out searches at 10 locations in Solan, Baddi, Mohali, Pinjore and Mumbai, they said.

The FIR is an outcome of a preliminary enquiry registered by the agency, which showed that the company allegedly "paid bribes, misrepresented facts and manipulated records to fraudulently avail area-based exemption benefits (central excise and income tax) in Baddi, Himachal Pradesh, knowing fully well that it was not entitled to avail area-based tax exemption benefits", the officials said.

"For availing the same, some members of the executive board of the company, along with key managers, collectively decided to manipulate records, engage intermediaries to route bribes and cover up all

the evidence that had surfaced during the internal investigation," the CBI has alleged.

Besides the company, the agency has booked a total of 12 individuals, including two the then Central Excise officials, the then Cadbury India Limited (CIL) vice-president (finance and compliance) Vikram Arora and its directors Rajesh Garg and Jailboy Phillips.

CIL had set up a manufacturing unit at Sandholi village for manufacturing malt-based food (Bournvita). The unit started commercial production from May 19, 2005, the CBI has alleged in its FIR.

Two years later, CIL proposed to expand production by setting up another unit for its products "5 Star" and "Gems" as the second unit on the land acquired from Barmalt in 2007 in Baddi to avail an exemption from excise duty and income tax for 10 additional years, it has alleged.

The company decided to expand its capacity and avail tax benefits from May 19, 2005, for which it applied for an amalgamation of the two units, stating that it has decided to have its second unit as a composite in the existing facility, the CBI

The approval was granted on

March 7, 2008 by the Directorate of Industries, it added.

About 15 months later, the company said its second unit has started production, for which it should be given tax benefits, which was not possible as the company had already stated that it would be a composite unit of an already existing factory, which was getting tax benefits from 2005, the agency has said.

The company again applied for deamalgamation and sought to set up the second unit as a different company -- Cadbury India Limited Unit II -- on March 29, 2010, two days before the cut-off date to avail the exemption, the CBI has alleged.

The agency has alleged that senior executives of the company conspired with private individuals and made payments to get necessary approvals for setting up the second unit as a separate company to avail tax benefits for which it was not eligible.

The CBI has found details of various payments made to camouflage alleged bribes and commissions to get the work done, the FIR alleges.

The agency has alleged that the DGCEI had also probed the matter and slapped a fine of Rs 241 crore on the company.

"India's engagement with China is complex. The two sides agree that the future direction of India China relations should be built upon respecting each other's sensitivities, concerns and aspirations," he said on the overall ties.

"The two sides have also agreed to manage their differences and not allow differences on any issue to become disputes," Muraleedharan added.

On the border row, the minister said the two sides have maintained communication through both diplomatic and military channels to ensure complete disengagement from all friction points and full restoration of peace and tranquillity in the border areas.

"The two sides were able to reach an agreement on disengagement in the North and South Bank of the Pangong Lake, which has been completed. There are however still some outstanding issues with regard to deployment and patrolling at some other points along the LAC in eastern Ladakh," he said.

The border standoff between the Indian and Chinese militaries erupted on May 5 last following a violent clash in the Pangong lake areas and both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

As a result of a series of military and diplomatic talks, the two sides completed withdrawal of troops and weapons from the North and South banks of Pangong lake in line with the agreement on disengagement last month.

The 73-year-old season politician was conferred the third-highest civilian award — the Padma Bhushan by Modi-led BJP government in January last year, when most of the mainstream leaders, including his own party President and two other former Chief Ministers Farooq Abdullah and his son Omar were under detention.

Administrative Council Approves Ratle Hydro-Electric Power Corporation

JAMMU: The Administrative Council (AC), which met under the chairmanship of Lieutenant Governor, Manoj Sinha, Wednesday approved the incorporation of the Joint Venture Company (JVC) under the name Ratle Hydro-electric Power Corporation to implement the 850 MW Ratle Hydro-Electric Project (HEP) on river Chenab at Drabshala in Kishtwar, Jammu and Kashmir. The proposed JVC will have authorised capital of Rs. 1600 Crore with initial paid up capital of Rs. 100 Crore, out of which the JKSPDCL will

contribute Rs. 49 Crore as an initial equity. The Memorandum of Understanding (MoU), to execute the project, was signed between the Government of Jammu & Kashmir, JKSPDCL and NHPC on 03.01,2021 in the august presence of the Lieutenant Governor of UT of J&K and Minister of State,

Incharge Power, Government of India. On the basis of the MoU already signed, the Administrative Council ap-

proved the Promoters' Agreement for the JVC between Government of J&K, NHPC, and J&K State Power Development Corporation Ltd.
