

J&K Reports 172 Fresh Covid-19 Cases

Over 100 Infections Reported For 9th Connective Day

SRINAGAR: Covid-19 cases continued to show worrying upward trend as 172 more people were confirmed to have been infected with the virus, taking the total case tally to 129203 in Jammu and Kashmir officials said on Thursday. It was for the ninth consecutive day that more than a hundred cases were recorded in the J&K.

The officials said that among the 172 new cases including 46 travelers, 41 were from Jammu Division and 131 from Kashmir Valley.

Giving the district-wise details, the officials said that Srinagar reported 65 cases including 25 travelers, Baramulla 30, Budgam 16, Pulwama Kupwara Anantnag Bandipora Ganderbal Kulgam 0, Shopian 2, Jammu 34(5 travelers), Udhampur 0, Rajouri 0, Doda 2, Kathua 3,

Samba 2, Kishtwar 0, Poonch 0, Ramban 0, and Reasi 0. A number of these cases were confirmed at diagnostic laboratories of SKIMS Soura, CD hospital and GMC Anantnag.

NEW DELHI: The Chinese military on Thursday said the situation at eastern Ladakh has "eased distinctly" thanks to the joint efforts with India on the disengagement of troops from the Pangong Lake area but gave no indication about when the pull out will take place from the remaining areas along the Line of Actual Control (LAC)

As a result of a series of military and diplomatic talks, the two countries had completed withdrawal of troops and weapons from the North and South banks of Pangong Lake last month in line with an agreement on disengagement.

But the disengagement is yet to take place in remaining areas along the LAC. The Indian Army has been pitching for a faster disengagement process in areas like Hot Springs, Gogra and Depsang to bring down tension in the mountainous region.

At present, China and India have disengaged front-line troops in the Pangong Lake area and both countries have positively commented on the current moves, • More On P10



KASHMIR In Capital: 'Shahnama' Of Legacy Shawl

When the Shaw Brothers split into separate entities during the 'Quit Kashmir" era, it was more devastating for the group that had to leave the glorious name behind. However, rather than falling despair, they chose to make their way through the mountains and now sits comfortably in a marvelous shop at one of New Delhi's commercial hubs.

Sounding like a sage, Syed Masood Ahmad Shah is trying to secure a commercial call that since decades has created his cult in Delhi's shawl syndicate. Along with his son, Mohsin

the popular showroom—Shah Arts Emporium—that stands tall in the Adchini business locality of New "It's not the same anymore,"

says Masood while handing over his loyal clients to his son Mohsin. "I get tired too early now, and find it hard to work in this scorching heat of March."

Masood is the third generation Shaw scion and a man who frequented the Indian capital from 1962 to 1984 just to master the art of business. He got immense yet tiring success in establishing a powerful foundation in the name of his "blessed forefathers" for the

next 20 years. Now, at 81, Masood, a native



of Ishber Nishat area of Srinagar, hopes to carry forward the Shah legacy in his own exquisite style.

It's majorly his work now," says the octogenarian in an impressive yet pale voice while signalling towards his son. "I've done my part." Masood traces his trade evolution from the classic cashmere split of 1944, when the seven brothers of the Shah clan divided

into a group of four and three.



Noorbagh-Qamarwari Bridge To Be Operational By Year-End

Srinagar: After missing several deadlines in the past nearly one decade, the much-awaited Noorbagh-Qamarwari Bridge is all set to be completed by the end of this year.

Noorbagh-Qamarwari Bridge popularly known as the "Cement Bridge" has historical importance in the Valley as it was the first bridge over the river Jhelum, which was constructed in concrete.

However, the present bridge at the place, as per the commuters has been giving tough times to them as the bridge is almost completely damaged. "The pivotal bridge has developed huge potholes, thus simultaneously not only affect the passage of the vehicular movement but also damaging the vehicles as well, the commuters said

Notably, the bridge is an important link as it connects the Old City, Soura and other areas with North Kashmir.

The construction of the new bridge was started in the year 2011, but in the last nearly one decade, it missed several deadlines, sources said, adding that most of the time, the construction was stopped as there were several reasons behind the stoppage of the work and that took long to remove the bottlenecks.

Initially, the bridge was scheduled to be completed in the year 2014. Later, the deadline was extended upto March 2017 and then upto December 2018.

Chief Engineer, Roads and Building department, Er Showkat Jeelani Pandith said it is expected that the bridge is completed by the end of this year (2021).

"There were several issues, which took long to be rectified," he said, adding that the land issue was among the main bottlenecks that halted the work for a longer period.

"Many structures are to be removed and we are already on it," he said

Pertinently, the area where the bridge is being constructed is a congested place, thus simultaneously witness frequent traffic mess—(KNO)



Homeless Take Over School

RINAGAR A village hard by last month's heavy snowfall and avalanches in south Kashmir is facing another problem - classes in the local school have stopped as it is being used as a makeshift camp for the homeless.

The bad weather and resultant avalanches claimed some 350 lives across the state, including hundreds killed in the Waltango area in south Kashmir February 19.

Families who lost their homes in the massive avalanches are currently living in the government-run school building at Yari Khushipora village of Anantnag district. 73 km from here, occupying all its classrooms and laboratories.

Thish resulted in a piquant situation. Teachers posted at the school come simply to mark their attendance in the morning and without biking classes - simply because there is no available space for classes.

"We can only start classes after the homeless people are shifted." said a teacher.

The school building in Yar Khushipora also housed a private school that has now begun conducting classes in the

The suffering of the survivors of the avalanches is now spilling over into the lives of hundreds of others whose children have been unable to attend school

"The government must immediately arrange the permanent rehabilitation of these survivors as their stay in the school building is threatening the careers of our children." said a parent in Yar Khushipora. The homeless too are embarrassed because of the tension

their continued presence in the school building has been creating in the village. "We are unfortunate victims of a natural disaster but this should not create undeserved hardships for other people hi the vil-

lage." said Bashir Ahmad., a homeless man living in the school. (Kashmir Observer, 26 March, 2005)

China Says It Will Safeguard Iran Nuclear Deal

hina will make efforts to safeguard the Iran nuclear deal and defend the legitimate interests of Sino-Iranian relations, the commerce ministry said on Thursday.

Ministry spokesman Gao Feng told a news briefing in response to a question from the media that China has not received notices of sanctions on Iranian oil from the Biden administration.

China's comments came after Reuters reported that Iran has "indirectly" moved record volumes Tehran insists be lifted before negotiations resume.

The United States and the other Western powers that signed up to the 2015 deal appear to be at odds with Tehran over which side should return to the accord first, making it unlikely that U.S. sanctions which have crippled Iran's economy can be quickly removed.

However, the OPEC member's oil exports climbed in January after a boost in the fourth quarter, despite US sanctions, in a sign that the end of Donald Trump's term as US president may be changing buyer behaviour.



of oil into China in recent months, marked as supplies from Oman. the UAE and Malaysia, even as China customs data showed that no Iranian oil was imported in the first two months this year.

The increase in Iranian supplies has partly contributed to a drop in Brent crude prices from \$70 a barrel in mid-March.

US President Joe Biden has sought to revive talks with Iran on a nuclear deal abandoned by former President Donald Trump in 2018, although harsh economic measures remain in place that

Iranian crude oil exports remain at elevated levels in March compared to last year, tanker tracker Petro-Logistics said on Tuesday, adding to signs of a recovery in the shipments.

The sanctions caused a precipitous drop in Iranian exports to China, India, Japan and South Korea since late 2018. Those measures, and output cuts by fellow OPEC+ producers, have led to tight supplies of Middle East sour crude in Asia, the top global oil market. Asia imports more than half of its crude from the Middle East.

Sri Lanka Navy Arrests 54 Indian Fishermen, Seize 5 Trawlers

The Sri Lankan Navy has arrested at least 54 Indian fishermen and seized five trawlers for allegedly poaching in the country's territorial waters, an official statement said on Thursday. The Navy arrested the fishermen on Wednesday off the coast of northern and northeastern areas.

Having considered the impact of foreign fishermen poaching in Sri Lankan waters on the local fishing community and the sustainability of fishery resources of Sri Lanka, the Navy is conducting regular patrols to curb illegal fishing activities in Sri Lankan waters, the Navy said in the statement.

The Navy nabbed a large Indian fishing vessel with 14 personnel on board, about 3 nautical miles off the coast of Kovilan in Jaffna.

Two more Indian fishing vessels with 20 personnel for engaging in trawling were arrested about 7 nautical miles off Pesalai, Mannar and 5 nautical miles off the Iranativu Island, the statement said.

Two more Indian fishing vessels with 20 personnel were arrested about 7.5 and 8.5 nautical miles off Mullaitivu. The two vessels had trespassed into Sri Lankan waters about 62 nautical miles, crossing the International Boundary Line (IMBL) when the apprehension was made, the Navy said in a statement.

The Navy said it had previously informed the Indian authorities when similar incidents of trawling by Indian fishermen were reported. The illegal entry of foreign fishermen into Sri Lankan waters and the use of prohibited fishing methods like bottom trawling to catch even very small fish has seriously threatened the marine ecosystem and endanger the livelihood of fishermen in the northern part of the island.

In January, the Sri Lankan Navy arrested nine Indian fishermen and seized one mechanised boat for allegedly fishing in that country's waters.

IMF Approves \$500 Million Disbursement To Pakistan

WASHINGTON: The International Monetary Fund said on Wednesday it approved a \$500 million disbursement to Pakistan for budget support after the IMF Executive Board completed delayed reviews of Pakistan's \$6 billion loan programme.

The IMF said in a statement that the latest payment brought total disbursements under the Extended Fund Facility to \$2 billion since the programme was first approved in July 2019.

"The Pakistani authorities have continued to make satisfactory progress under the Fundsupported program, which has been an important policy anchor during an unprecedented period," IMF Deputy Managing Director Antoinette Sayeh said in a statement.

"While the Covid-19 pandemic continues to pose challenges, the authorities' policies have



been critical in supporting the economy and saving lives and livelihoods," she said.

The disbursement was made after Pakistan cleared up an issue with data on government guarantees dating back to the 2016 fiscal year that had been reported inaccurately and put the government in non-compliance with the program.

The IMF said Pakistani authorities had taken strong corrective actions to address institutional shortcomings, including a lack of interagency coordination, to correct the issue.

Chinese Hackers Used Facebook To Spy On Uighurs Abroad

₹acebook Inc says it has **◄** blocked a group of hackers in China who used the platform to fool Uighurs living abroad into clicking on links to malware that would infect their devices and enable surveillance.

The social media company said on Wednesday that the hackers, known as Earth Empusa or Evil Eye in the security industry, sought out activists, journalists and dissidents who were predominantly Uighurs, a largely Muslim ethnic group facing persecution in China.

Hamas Calls On Saudi **Arabia To Release Senior Figure Over His Worsening Health Condition**

he Palestinian Hamas resistance movement has called on Saudi authorities to immediately release its highranking official Muhammad al-Khudari, whose health has been deteriorating over the nearly three years he has been in prison in the kingdom.

Moussa Mohammed Abu Marzouk, a member of Hamas political bureau, in a post published on his Twitter page on Wednesday, expressed serious concerns over further deterioration in the health of the 83-year-old Palestinian.

He asked Saudi officials to urgently free Khudari and his son, Hani, along with all other Palestinians being incarcerated in Saudi jails.

Moreover, Hamas spokesman Hazem Oassem said Khudari "suffers from serious health problems while being kept in detention in Saudi Arabia."

He told the Arabic service of Turkey's official Anadolu news agency that the high-ranking Hamas official is being detained without "any charge and irrespective of the fact that he has not committed any offense. The Hamas spokesman called

on Saudi authorities to "immediately release Khudari and all other [Palestinian] detainees."

Dr. Khudari and his son Hani were arbitrarily arrested on April 4, 2019 and remained in detention without charge until March 8 last year. Both men were forcibly disappeared for one month after their arrest, and held incommunicado and in solitary confinement for the next two months of their detention.

A month into the senior Hamas official's detention, his wife received a phone call from authorities in the maximumsecurity Dhahban Prison near the Red Sea port city of Jeddah requesting his medical records. Two weeks prior to his arrest, Dr. Khudari had undergone surgery.

Dr. Khudari is currently being held in al-Hai'r Prison in Riyadh, while his son is detained in Dhahban Prison.

Khudari has been living in Saudi Arabia for over 30 years, and represented Hamas between mid-1990s and 2003 in Saudi Arabia.

His son is a university professor and has no political affiliation.

China Attacks Foreign Clothing, Shoe Brands Over Xinjiang

hina's ruling Communist Party is lashing out at H&M and other clothing and footwear brands as it retaliates for Western sanctions imposed on Chinese officials accused of human rights abuses in the northwestern region of Xinjiang.

The attacks began when the party's Youth League on Wednesday called attention on its social media account to an H&M statement in March 2020 that it would stop buying cotton grown in Xinjiang. The Swedish retailer said it was "deeply concerned" about reports of forced labour there.

On Thursday, a party newspaper, the Global Times, cited Burberry, Adidas, Nike and New Balance as having made "cutting remarks" about Xinjiang cotton as early as two years ago. Celebrities including Wang Yibo, a popular singer and actor, announced they were breaking endorsement contracts with H&M and Nike. Beijing often attacks foreign clothing, auto, travel and other brands for actions by their governments or to pressure companies to conform to its official positions on Taiwan, Tibet and other sensitive issues.

Companies usually apologise and change websites or advertising to maintain access to China's populous market. But Xinjiang is an unusually thorny issue. Western brands face pressure at home to distance themselves from possible abuses.

More than 1 million people in Xinjiang, most of them from predominantly Muslim ethnic groups, have been confined to work camps, according to foreign researchers and governments. Beijing denies mistreating them and says it is trying to promote economic development and stamp out radicalism.

On Monday, the 27-nation European Union, the United States, Britain and Canada jointly announced travel and financial sanctions on four senior Chinese officials blamed for abuses in Xinjiang.

Beijing retaliated by saying it would impose unspecified penalties against European legislators and a German researchers who has publicized information about the detention camps.

H&M's statement last March cited a decision by the Better Cotton Initiative, an industry group that promotes environmental and labor standards, to stop licensing Xinjiang cotton because it was "increasingly difficult" to trace how it was produced. In September. H&M announced it would stop working with a Chinese manufacturer that was accused of using forced labour in a unit unrelated to the Swedish brand.

In January, Washington imposed a ban in January on cotton from Xinjiang, a major supplier to clothing producers for Western markets.

China's official outrage has so far focused on Europe, possibly because relations with the EU were relatively amicable amid rancor with Washington over trade disputes and accusations of spying and technology theft.

Official criticism of H&M reflected that tone of grievance at being hurt by a friend.

The bereavement allowance, passed unanimously in parliament late on Wednesday, gives employees three days leave when a pregnancy ends with a stillbirth without having to tap into sick leave.

Awantipora: Even after 15 years, a vital bridge on river Jehlum at Dogripora in Awantipora area of South Kashmir's Pulwama district is awaiting completion.

Locals said that the foundation of the bridge was laid in the year 2006 during the PDP-Congress regime, however, 15 years have passed but not even 40 per cent of the construction work has been completed vet.

Shahid Ahmad, a resident of Dogripora village, said that over the years, many people have drowned while crossing Jehlum through a boat in absence of the bridge.

"Such accidents wouldn't have happened had this bridge been completed on time," he said, adding that this bridge would connect dozens of villages with the highway at Pujteng Sethar and over 50 villages with railway station Panzgam Pulwama.

Shahid said that the project is under **IKPCC** and every year they hardly work for 15 to 20 days and left it halfway, "due to which we are facing a lot of problems".

Locals said that they have knocked the doors of every authority in this regard but on the ground nothing happened.

"We have met Governors and their advisors as well, who assured that work will start soon, however, their promises like officials also proved hoax on the ground," they said.

Deputy Managing Director JKPCC Er Masood Ahmad said the bridge was kept in languishing projects and got administrative approval and technical sanction recently.

"The material is being brought by the contractor from outside valley and in coming days the work will start on the bridge," he said. "The project will be completed up to March 2022."—(KNO)

"After the reorganisation of the erstwhile State of Jammu and Kashmir, The Indian Evidence Act, 1872 was also made applicable in the newly constituted UT of Jammu and Kashmir and UT of Ladakh with effect from the notified appointed date i.e. 31st October 2019 as per Table 1(SI. No. 44) of the Fifth Schedule of the Jammu and Kashmir Reorganisation Act, 2019", the Minister said in the reply.

The reply said that subsequently, on March 18th,2020, the Jammu and Kashmir Reorganisation (Adaptation of Central Laws) Order, 2020 was published.

Walking the talk

he Prime Minister Narendra Modi's letter to his Pakistani counterpart Imran Khan on the occasion of Pakistan's Republic Day, calling for "cordial relations" between the two neighbors has pushed the renewed bilateral engagement a bit further. The PM called for creation of an environment "devoid of terror and hostility". Earlier, the PM had wished Khan a speedy recovery from the Covid-19 infection. These messages have added to the credibility of the ongoing attempts to institute a fresh dialogue between the two countries. After the re-affirmation of the 2003 ceasefire agreement, the two neighbours have restored sporting ties and also held talks on sharing of waters. Now there's talk of holding a cricket tournament and planning a SAARC summit in Pakistan. That will be a major boost for the ties between the two countries. A summit will also give a chance to the PM Modi and Khan to meet on the sidelines and take the dialogue forward.

There are huge expectations on both sides of the border about the talks. At the same time, there is a huge constituency that is not happy with the engagement. There's also a significant population that is cynical about the prospect of dialogue leading to some positive outcome. There's a reason for this: India and Pakistan have so often engaged and so invariably failed to take the talks to their logical outcome that it seems improbable that they can do it this time. More so, when the differences and the bitterness run deeper than they ever did before. Following New Delhi's revocation of Article 370 on August 5, 2019, the relations between India and Pakistan have fallen to their lowest. But as the reiteration of the ceasefire along the Line of Control has shown, the two countries have shown a capacity for returning to engagement sooner than later. Between 2003 to 2007, the neighbours had engaged sustainably and nearly worked out a framework agreement to resolve the issue of Kashmir. This framework for solution came to be known as the Four Point formula. But the Mumbai attack in 2008 and the exit of the then Pakistan president General Parvez Musharraf aborted the dialogue. Could the two countries go back to this framework agreement this time around? There's very certainly a possibility for this. But for that to happen the two neighbours will need to build confidence and safeguard the engagement from the spoilers. And this is very much possible if there's political will and honesty on both sides.

No to Lockdown

he first 'anniversary' of the lockdown should be an occasion of sombre reflection. It is now generally agreed that the hastily planned lockdown imposed in March last year had crippled the economy. Job losses, the loss of demand, disruptions in supply chains, unprecedented sufferings of migrant workers, the limited reach of India's social welfare mechanism — the lockdown bared many a wart. It is to be hoped that if a lockdown — national or local — were to be imposed again, these mistakes would be rectified. The lockdown, in spite of its debilitating impact, was deemed necessary to break the chain of infection. It was not conceived as a cure; merely a precaution. India then went on to unlock itself in phases, and near-normalcy was restored.

Worryingly, there is some apprehension that the country could be locked up again. This speculation can be attributed to the anxiety over the rising number of Covid-19 infections – apparently, the second wave is here. India added nearly 50,000 new cases on Tuesday. This spike is the sharpest since November. Worryingly, contagious strains have been found. A significant number of the samples tested in Punjab were of the UK strain; poll-bound Bengal, too, has discovered some cases with the UK and South African variants. As many as 24 states and Union territories have witnessed a surge in cases with Maharashtra, once again, shouldering a disproportionately high burden. A national lockdown, unless absolutely necessary, must be avoided. The economic cost and the consequent social unrest would cripple the nation. Some essential steps must be taken to keep India away from another lockdown. The vaccination drive must be expedited with vulnerable constituencies prioritized on a war footing. The decision to permit all citizens above 45 to receive vaccination from April 1 is a welcome step. But India should not lose sight of other, relevant challenges. There has been some concern with vaccine wastage, with even the prime minister cautioning the states. India's healthcare network must be prepared to meet a rush of not only patients but also a far greater number of citizens seeking the jab. The paucity of trained health workers — the number of active health workers, a study now says, could be half of the government's estimate — is another concern. But the most formidable of challenges remains growing public apathy towards safety measures. A concerted drive must be launched by administrators to penalize those refusing to wear masks or maintaining social distance. The government must show the way by discouraging mass gatherings for social, religious and even political functions.

India-Pakistan Peace: Will the deal prevail?

Ceasefire is a great opportunity to open a more serious, sustained Indo-Pak dialogue

n a rare joint press release on February 24, the Director Generals of Military Operations (DGMO's) of India and Pakistan said that the two sides had agreed to observe a ceasefire along the Line of Control (LoC). The two armies exchanged heavy artillery fire in recent months that

led to casualties on both sides. "Both sides agreed for strict observance of all agreements, understandings and cease firing along the Line of Control and all other sectors with effect from midnight of February 24/25," said the joint statement.

The abrupt ceasefire statement came two weeks after People's Liberation Army of China (PLA) and the Indian Army began disengagement in eastern Ladakh after many months of eyeball to eyeball build-up that turned bloody at least once when the two armies confronted each other with clubs and rocks in Galwan Vally which led to the death of twenty Indian soldiers including a colonel. Indian media claimed heavy casualties on the Chinese side as well.

A battle of unequals?

The massive power gap between India and China is unbridgeable till foreseeable future. So, at the very outset, the LAC flare-up was seen as a battle of unequals.

In the latter part of 2020, India was keen on watering down its rhetoric and send out reconciliatory signals to China. Highly placed sources revealed that the Trump administration warned India not to show any signs of rapprochement. But with Biden coming into office, it was easier for India to seek disengagement along LAC.

"I'm not going to do it the way Trump did. We're going to focus on international rules of the road," Biden said in a CBS interview while talking about US' engagement with China. He said that "we need not have a conflict."

Media, think tankers and observers in India generally find it hard to wrap their heads around Sino-Pak interoperability. You can't be friends with China and hostile to Pakistan at the same time.

Regional geostrategic equation

That's how the regional geostrategic equation has panned out over the last decade or so. But if the LAC disengagement and the LoC ceasefire are an indication that India has started waking up to the reality, it must be seen as a welcome development.

Despite its myriad problems, Pakistan remains a military might that doesn't hesitate in flexing its muscles as and when needed. While the ceasefire is no guarantee that peace will prevail, it could be a great opportunity to open a serious, sustained dia-

There are speculations that the two countries might upgrade diplomatic ties and bring back high commissioners in New Delhi and Islamabad. Also, China is keener than ever on Kashmir after India struck down Articles 370 and 35-A and downgraded the state of J&K to two union territories on August 5, 2019.

Within days of the revocation of Articles 370 and 35A of the Indian Constitution, Chinese government's media organ Global Times wrote in an editorial: "Reckless India's unilateral decision on Kashmir is a geopolitical trickery that may have actual consequences that India can't control.'

A few months later LAC happened. Those who know China know that its territorial claims are sacrosanct to it and not just a bargaining chip.

According to sources, in one of the initial meetings during the LAC standoff between the commanders of the two sides, PLA made it clear that China wasn't at all amused by India's August 5 move.

So intertwined are China's interests with Pakistan that it can't afford to allow India an upper hand over its 'iron brother',

diplomatic ties and bring back high commissioners in New Delhi and Islamabad. It's said that India wants Pakistan to take the initiative since it was the latter that downgraded diplomatic ties in response to what happened on August 5, 2019.

If Pakistan agrees to it, it might have to face a lot of opposition at home and from Kashmir's resistance leadership.

How Parents Can Help Their Children with Managing Anxiety Disorders?

hen a child does not outgrow the fears and worries that are typical in young age, or when there are so many fears and worries that they interfere with school, home, or play activities, the child may be diagnosed with an anxiety disorder. Different types of anxiety disorders include separation anxiety, social phobia, specific phobia, generalized anxiety, panic disorder, obsessive compulsive disorder etc.

The following are different tips on how parents can help their child to overcome anxiety:

- Encourage regular sleep routine, healthy eating and regular exercising.
- Try not to become overprotective or anxious yourself. Model healthy ways of coping with anxiety, as children learn the most via observational learning.
- Sit with them and offer physical reassurance/support. Feeling you nearby, holding your hand or having a cuddle can make them feel calm and secure.
- Reassure them that the anxiety will pass, and they will be okay soon. Spend quality time with your child as a family. This will help divert their attention from all their
- Discuss about your child's worries and scary thoughts and how to deal with them. Ask them how it feels inside their mind and body. It is very important to empathize with their experience, accept and validate their
- Help your child learn about signs of anxiety so that they can recognize when they are feeling anxious. This way they will know when to ask for help or help themselves. Knowing this beforehand can make the experience less overwhelming/ frightening.
- You can explain about anxiety to your child through story telling- example: The Story of the Caveman
- This story is useful to help your children understand where anxiety comes from and it can be adapted depending on the age of the child. Back in the distant past, when we were still cavemen walking around in furs, we came across many dangers, like dinosaurs and sabre tooth tigers. Our bodies (naturally wanting to protect us from danger) designed a special alarm inside us that was set to go off whenever danger was present. This alarm gave us the ability to fight the danger, or run away by increasing our heart rate, and supplies of blood to our muscles- making us breathe faster. It also made us think more quickly, and be on the alert for dangerous situations. It worked brilliantly! However, as we don't have dinosaurs or sabre tooth tigers on the planet anymore, we don't need the special alarm as much. Unfortunately we can't turn it off, and some peoples' alarm system gets stuck in 'on' mode, which causes them to feel ready for danger at all times. This is what anxiety is
- Teach easy relaxation techniques such as deep breathing, rainbow breathing. Breathe slowly and deeply together. Ask them to think of a safe/relaxing place. It could be their grandfather's bedroom, their last holiday destination, a nearby park. Sometimes holding a memento (e.g., shell, pebble etc.), souvenir, or photograph of a relaxing place can help. Making them draw and name their safe place is also helpful.

Rainbow breathing:

Have your child gently close her eyes and imagine that she is lying under a rainbow. Tell her that you are going to practice breathing the colours in out while thinking certain thoughts. Encourage her to allow her/his body to relax and let go of any tension in her/

You can give your child instructions.

Breathe in the colour green and think, "I am feeling

Breathe out the colour yellow and think, "I am feeling

Breathe in the colour blue and think, "I am feeling

Breathe out the colour orange and think, "I am cre-

Breathe in the colour purple and think, "I am wise" Breathe out the colour red and think, "I am safe" Repeat this several times. As he/she is lying there breathing, imagining the colours gently flowing in and out, you can speak these thoughts out loud as he/ she practices breathing.

- **5-4-3-2-1 Grounding technique** Try using all five senses together. Connecting with what they can see, touch, hear, smell and taste can bring them closer to the present moment and reduce the intensity of their anxiety symptoms. You can together identify five things they can see, four things they can touch, three things they can hear, two things they can smell and one thing they can taste.
- Encourage your child to do any activity they enjoy and which makes them feel happy. For e.g., gardening, sketching, painting, watching favourite animated movies or reading a short story.
- Make a Worry Box with your child:

A worry box basically helps symbolise the idea that feelings of anxiety are simply thoughts that we can distance ourselves from. It's a great way for

young kids to start understanding and identifying their emotions, and dealing with them in a purposeful and productive way. Create and decorate a small box, such as a tissue box or a small cardboard box. Then, perhaps each night before bed, write down the child's worries onto a piece of paper. or if your child can write then it's better to make the child write down or draw his/her worries.

Have them fold the piece of paper and put it in the box. The next day - take the notes out of the box and ask your child if they still have those worries. If they do, place them back in the box; if they don't, have them rip up the paper and throw it in the dustbin." The worry box serves the important purpose of 'externalising' your child's anxieties. It's more helpful for them to have something age appropriate they can actively do to process their anxieties. So instead of reassuring our children about their anxieties, we should rather be helping them to process them in age-appropriate ways. The worry box is particularly

from the family (and school if appropriate). You can assess when a child or young person's anxiety drops by getting them to rate it on a scale of 1-10. When that number drops below 2 in the situation, you will be ready to move on to the next step.

Social Phobias (in other words, being afraid of social situations or being watched by others)

- At home, do role plays and practice how to interact with others.
- Practice situations such as asking questions in class, ordering food in a restaurant, buying a pack of chips from the departmental store, answering a phone call, talking to a friend/neigh-
- Arrange frequent, short play dates for young children. For older children, ask them to carry out at least two social activities. Example- calling a friend, visiting a nearby neighbor, review-

Becoming comfortable with some uncertainty

Because children with GAD feel anxious whenever things are uncertain, a good way to fight back worries is to help your child become more comfortable with uncertainty. Do this by deliberately taking action when they are not sure what will happen. Like any tool that involves facing a fear, it is important to start small. The following are some exercises vour child can do:

- Completing homework without asking family whether it was done correctly (or only asking
- Calling a friend spontaneously and asking him or her to come over to play without making plans in advance
- Deliberately making a small mistake on homework so that it isn't perfect (crossing something out; making it a little messy).



Each step should be decided in agreement with the child and the parent, and plenty of praise / rewards should be used as the child or young person moves through the ladder. beneficial for young children, because it helps them to understand their thoughts and feelings, and give them control over them. The symbolic nature of the worry box helps to show kids that their thoughts are just - thoughts - and negative ones won't have an impact on their future. The act of decorating and creating the box shows the child that they can have ownership and control over their thoughts and feelings.

The ritual of writing the worries down helps them to acknowledge and address those feelings. And the disposing of the worries helps to symbolise their release of those problematic emotions. The worry box is an easy and helpful solution for trying at home.

More suggestions for parents on how to help their children deal with specific kinds of anxiety dis-

SPECIFIC PHOBIAS (in other words, fear of certain situations, places or things)

Practice graded exposure at home- Exposure/ fear ladders. For example, if the child is extremely fearful of dogs, one can follow the steps explained below.

First teach the child any easy relaxation technique and explain to them that they will jointly work on getting rid of his fear of dogs. Any time during the process if the child gets emotionally overwhelmed then he/she should be instructed to use the relax-

- Start with showing the child a drawing of a dog.
- Then make him/her look at the picture of dogs in magazines/books.
- Watch funny dog movies (animated) Watch videos of people petting dogs.

the same for some seconds.

- Go to a pet store to watch puppies/dogs from a distance. Visit a friend/relative who has a pet dog and
- watch them playing. Pet your friend's dog and make your child do
- Each step should be decided in agreement with the child and the parent, and plenty of praise / rewards should be used as the child or young person moves through the ladder. If the child or young person becomes distressed or does not feel they can manage the next step, then make the step smaller. ing homework with a friend. Practice assertiveness skills. These include: speaking up for oneself, asking others for help, saying no to something they are not comfort-

able with, expressing one's opinions.

Separation Anxiety (in other words, severe distress about being away from home or apart from people who are important to them)

- Make sure that the child sleeps in his/her own bed. Use rewards and praises to reinforce this desirable behavior.
- Make the child often spend a short duration of time away from parents. For example, a mother can go for an evening walk everyday while the child stays at home with his grandparents.
- Gradually increase the length of time they are apart and use different situations.
- Help a child to cope with stress in uncomfortable situations like school, camps, staying overnight at a friend's place or at some relative's

Panic Disorder (in other words, severe and unexpected attacks of fear that also cause physical symptoms)

Panic disorder can cause physical symptoms like increased heart rate, feeling dizzy and stomach aches, breathlessness etc.

- Parents can make sure that a child understands that panic attacks are safe, painless, and private (nobody else can see them), and they only last a few minutes
- Different relaxation/ mindfulness/ grounding techniques need to be practised.

Generalised Anxiety Disorder (in other words, frequent, intense worry about many things, such as school, the safety of their family, or world events)

Explain to the child or teen that worry is not useful. What works better is to try to solve the problem. For example, ask what he or she could do to make sure that the scarv situation doesn't happen. Remember not to encourage their reassurance seeking repeatedly. Encourage your child to ask you fewer questions like 'What's going to happen?' If you've already answered the question, encourage your child to think about the situation, come up with the answers, and rely on her own judgment.

- Coming to school a few minutes late. Talking to someone in school without planning
- the conversation. Saying "I don't know" when the teacher asks a
- question. Looking out the window for a few seconds when
- the teacher is talking.

Obsessive Compulsive Disorder (OCD): (in other words, thoughts, images, ideas or impulses that are not welcome and that interfere with their lives.)

- Children with OCD usually need the help of a trained therapist.
- However, parents can support the treatment in a number of ways:
- Help the child or teen deal with the worries or obsessions that they fear by rating the levels of distress associated with each fear. Examples of worries are : contamination by dirt or germs and anxiety about whether something is turned
- Once the worries are organized they can be put into 'fear ladders' that arrange the worries from those that are feared the least to those that are feared the most.
- Coach the child through exposure to the feared situations or events. When you do this, make sure the child or teen cannot reduce the anxiety this causes by using OCD behaviours such as rituals of washing, checking or 'fixing'. If this behaviour is allowed it will undo any gains that have been made. Parents should make sure not to involve in their child's compulsive rituals.
- Exposure should happen every day and should be practiced. Start with low-level exposure and gradually build up.
- Give rewards to help motivate the child or to progress.
- Reassure the child that they are not "freaks/ abnormal/crazy". Tell them that one out of every 50 kids in their school has OCD. To get a concrete number, ask them about how many kids are in their school and then work out how many may have OCD. This will help normalize the experience.

Overhearing negative claims about social groups may influence development of bias in children: Study

study led by researchers at the Society for Research in Child Development revealed that overhearing a stranger's negative claims about a social group, even in a brief comment, can have a lasting influence on children's attitudes towards the group.

The findings were published in a Child Development article, written by researchers at Vanderbilt University.

"Findings from our work suggest that overhearing a negative conversation about an unfamiliar social group may influence intergroup biases among older children," says Emily Conder, the study's lead author and doctoral candidate at Vanderbilt University.

"Caregivers should consider what is said around children and regulate the media they consume, as what children overhear about groups of people can influence their attitudes and behaviours."

The study included 121 children from primarily White, middle-class families in Nashville, Tennessee , 48 percent of who were female, and who were recruited from local charter schools or through Tennessee state birth records.

Consent forms were required for participation and were completed by a diverse group of parents who self-reported identify ing as: White (67 percent), Black (19 percent), Asian (3 percent), or as multiple races or ethnicities (11 percent). Demographic data were not collected from or about child participants.

Participating children met individually with a female experimenter. With parental consent, the sessions were recorded with a camera hidden either in decorative plants or a pencil box. The procedure included the following:

Children played an unrelated game while they overheard an experimenter receive a pre-recorded Skype video call from either a child or adult caller.

During the pre-recorded video conversation, the researcher mentioned one of two novel groups, "Flurps" or "Gearoos."

Each participant was randomly assigned to a message condition (negative-message vs. no message) and a caller condition (adult vs. child). In the negative-message condition, the caller briefly provided negative information about the new group, such as "The Flurps are bad people. They eat disgusting food and they wear such weird clothes.'



Children's attitudes about the group were measured immediately after the call, and their attitudes were measured again two weeks later, by a different researcher.

At the conclusion of the 2-week study. children were debriefed by a researcher and were told that "Gearoos" and "Flurps," "were not real groups of people, but if they were real, they would probably be very nice people."

Later, researchers analyzed the following measures of children's attitudes about the novel group:

1. Goodness evaluations: children's evaluation of the group's "goodness"

2. Cultural engagement: children's willingness to engage with elements of the group's culture (for example, to eat their food or wear their clothing).

3. Friendship decisions: children's willingness to be friends with someone from the group

4. Social distance: children were asked to draw themselves and a "Flurp" or "Gearoo" person while the experimenter pretended to check her email on a laptop to limit influence. Larger distances between drawings were interpreted as indicating stronger, negative attitudes toward the group.

5. Resource allocation: children's willingness to share stickers with the group.

Older children (7-9 years) who overheard the negative messages drew themselves further from the new group member, were less willing to be friends with someone from the group, rated the group as being less good, and were willing to try fewer elements of the group's culture than children who heard no claims about the group.


These effects lasted for at least 2 weeks after children heard the messages. The messages had little to no effect on younger children (4-5 years), perhaps indicating that younger children find this type of social information less interesting or relevant. Climate Change May Hurt Indian Manufacturing Sector Due To Heat Stress On Workers

ne-degree Celsius rise in annual temperatures may lead to two per cent drop in productivity levels of industrial units and climate change may hurt the Indian manufacturing sector owing to heat stress on workers, a new study has said.

The study by the Energy Policy Institute at the University of Chi-



tute at the University of Chicago. Dr Sudarshan co-authored this



cago used several high-frequency micro-data sets of worker output and a nationally representative dataset of more than 58,000 factories across India.

The researchers found that there is around two per cent drop of productivity for every one-degree rise in annual temperature.

"The greatest declines ocin labour-intensive plants," the study said.

This multi-year study indicates that climate control in the workplace removes productivity declines but not absenteeism, presumably because workers remain exposed to high temperatures at home and outside. And the fact that climate-control is expensive, makes its use limited, it said.

"The effect of high temperatures on lower crop yields has been previously established. This paper shows that rising temperatures can also hurt economic output in other sectors by reducing study with researchers E Somanathan of the Indian Statistical Institute. Delhi. Rohini Somanathan of the Delhi School of Economics, and Meenu Tewari of the University of North Carolina at Chapel Hill.

Talking about how the future look like, Somanathan said it is entirely possible that the industrial sector might respond to high temperatures by increasing automation and shifting away from labour-intensive sectors in hot parts of the world.

"These adaptive responses may negatively influence wage inequality," Somanathan added

"The Indian agriculture sector can utilise the potential of AI's transformative capabilities through effective data practices.' Debjani Ghosh, President, Nasscom, said in a statement.



"The Netherlands is a stellar example of effective AI adoption in agriculture. With just a small arthe world's 2nd largest exporter of agricultural products by value leveraging technology and AI.

"For India to realise the full potential of AI, a coalition of government, industries, and startups in providing necessary infrastructure and policy support, enabling AI innovation across sectors, and mentoring and providing financial support to startups is imperative," she said.

Leveraging macro as well as farm-level data collected through sensors could help maximise yields and optimise the use of available resources, said the report.

Several AI-led use cases, such as precision agriculture and farm management, agricultural robots, automated weeding, crop quality and readiness identification, pest prediction and prevention, livestock monitoring and management, crop yield estimation, etc. can solve improving farm productivity.

Petrol, Diesel Prices Fall For 2Nd Consecutive Day

NEW DELHI: Consumers can heave a sign of relief as oil marketing companies (OMCs) have finally relented and started reducing the retail price of petrol and diesel after keeping them steady for 24 days in March.

This is the second reduction in petrol and diesel prices in as many days in 2021.

Petrol price fell by 21 paise per litre and diesel by 20 paise per litre in Delhi on Thursday. This has brought down the retail price of petrol to Rs 90.78 and diesel to Rs 81.10 a litre respectively in the national capital.

Across the country as well the petrol and diesel prices fell with the quantum varying depending on the level of local levies in respective states.

In Mumbai and Kolkata, the retail price of petrol fell by 21 and 20 paise per litre respectively and in Chennai by 18 paise per litre on Thursday. For diesel, the prices fell by 19 paise, 20 paise and 22 paise per litre respectively in Chennai, Kolkata and Mumbai.

In Mumbai, petrol is now priced at Rs 97.19 a litre from previous days' price of Rs 97.40 and diesel in the city is now priced at Rs 88.20 a litre from previous price of Rs 88.42 a litre. Premium petrol, however, continues to remain over Rs 100 a litre in the city as is the case with several cities across the country.

The latest price cuts on auto fuel have come after OMCs kept oil prices steady for the last 24 days. Petrol and diesel prices were last revised upwards on February 27 and ever since

then retail prices remained unchanged even though during the period crude jumped to over \$70 a barrel only to start falling and is

now slightly up at \$63.5 a barrel. Sources said that oil companies took time to revise petrol and diesel prices downwards as they were covering up for losses incurred on its sale when crude was high and retail prices remained static. Some indications suggest that there was a loss of Rs 4 and Rs 2 per litre on the sale of diesel and petrol respectively earlier that had now been more or less covered.

The current reduction in retail prices has not helped in bringing down fuel prices that have crossed Rs 100 per litre (petrol) mark in several parts of the country and continues to remain above the levels even now.

Since the beginning of February crude has gained more than \$7 per barrel that pushed OMCs to increase fuel prices on 14 occasions raising the prices by Rs 4.22 per litre for petrol and by Rs 4.34 a litre for diesel in Delhi.

Crude has now slipped around 9 per cent in the last eight days and is now sitting at a tab lower around \$63.5 a barrel on the back of rising US inventory and concerns on demand squeeze over the new wave of the pandemic.

The petrol and diesel prices have increased 26 times in 2021 with the two auto fuels increasing by Rs 7.46 and Rs 7.60 per litre respectively so far this year.

Officials in public sector oil companies said that retail prices may rise again if crude and product prices pick up but for now it will fall over the needy few days.

'Work From Home Jobs' Searches In 2020 Surged 140% In India

NEW DELHI: With remote working becoming a norm during the initial phase of the Covid-19 pandemic, there was 140 per cent growth in "work from home jobs" searches from across India in 2020 over 2019, new data from a Google report showed on Thursday.

With health becoming a forenost concern. Indians adopted a new willingness to try new things online with "online doctor consultations" searches growing at 300 per cent growth in the last one year led by Manipur, Bihar and Karnataka, said the Google's annual "Year in Search" report for the past year.

The combination of the uncertainty of 2020 and the accelerated digital adoption in the year saw Indians leverage their time spent online for the determined pursuit of progress. The Search data in the report, titled "India's determined progress", also confirms the geographical expansion of new digital users in tier 2/3/4 locations and rural India. This has led to an increase

in the importance of the 3Vs -voice, video and vernacular -- a trend that was first established in 2017, for a wider variety of uses, underpinned by a preference for the mother tongue.

One of the clear shifts in user behaviour is demonstrated in a never-before upsurge in queries

for "learn", up more than 30 per cent year-on-year, said the report.

This, "Learning anything, anywhere", is one amongst the three major changes in user behaviour that have emerged based on search trends spanning Search and YouTube in 2020, Google said. The searches for learning went

beyond academics, and focused on learning for career progression, upskilling entrepreneurship and supplementary income, with four in five people coming to YouTube to learn something new, Google said. "It has also been a catalyst for

massive changes, both in consumer behaviours online and in how businesses have pivoted to digital," Sanjay Gupta, Country Head and Vice President, Google India, said in a statement.

"The momentum has now been set for expanding and deepening this transformation, and to rethink our business models, approach, solutions, marketing, and distribution to keep pace with India's fast growing digital users."

The second big theme "Local first" highlights the increase in the demand and consumption of both local language content and local information.

Consequently, the year saw Google Translate being used over 17 billion times to translate web pages into Indic languages, said

Majority Of Smokers Don't Support Proposal To Ban Sale Of Loose Cigarettes, Smoking Areas: Survey

NEW DELHI: An overwhelming majority of smokers do not support the proposal to ban the sale of loose cigarettes and designated smoking areas under the amendments in the law on cigarettes and other tobacco products, according to a study.

A survey conducted across 14 cities, including Delhi-NCR, Mumbai, Chennai, Bengaluru, Kolkata, Guwahati and Vadodara, interviewing 1,986 people by non-commercial entity PRAHAR also found that 78 per cent of respondents do not support an increase in age for tobacco consumption from 18

years to 21 years. "The survey found that 87 per cent of the participants do not support the proposal to ban the sale of loose cigarettes. They be-

tobacco consumption may instead force smokers to buy full packs which will make cigarettes readily available in their hands leading to an increase in consumption of tobacco," PRAHAR (Public Response Against Helplessness and Action for Redressal) said in a statement. Further, 57 per cent of consumers

lieve that this decision to reduce

buy loose cigarettes "as it helps them to smoke less", while only 19 per cent go for it because it is cheaper. "Only 7 per cent of respondents

felt that a ban on the sale of loose cigarettes will make them smokeless," it said adding 82 per cent of respondents did not support the ban of designated smoking areas.

On disallowing branding of tobacco products at the point of sale, 76 per cent of respondents said they do not support this proposal, with 55

per cent of the opinion that it would "limit their fundamental right to make an informed decision as branding is a reinforcement of the legality of the product they are buying". "This is particularly relevant be-

cause the market is flooded with illegal and smuggled products. 25 per cent of the consumers feel that the move will encourage unscrupulous retailers to promote products that give them more margin," PRAHAR said.

When it comes to increasing the age for tobacco consumption from the current 18 years to 21 years, 78 per cent of respondents said that they do not support the move and 37 per cent believed that it is their fundamental right to decide whether to consume tobacco or not.

"This perhaps is the reason that it took them two years for them to find out anything and now they question about the land for graveyard of my father and secret funds meant for widows and who were the beneficiaries," he said as per news agency, adding, "I myself and my party, the PDP, will continue work on our agenda and will continue to seek resolution of the Kashmir issued."

Mehbooba, who was released last year after more than a year in detention following the scrapping of Jammu and Kashmir's special status, was served a notice to appear at the ED headquarters in New Delhi.

On March 19, the Delhi High Court had refused to stay summons issued to her after she moved the court seeking quashing of the summons in the case.

Earlier, 61-year-old appeared before the ED here in connection with a money laundering case and reached the ED office in Rajbagh at 11 a.m. in connection with the case.

Mehbooba did not appear before the ED in

Delhi on Monday, citing she had prior commitments that could not be cancelled. Later, her request to ED officials that she be questioned in Srinagar instead of Delhi was accepted.

The ED, which had earlier summoned her on March 15, did not insist on her personal appearance at that time.

her passport application. Mehbooba had applied for a fresh passport in December last year after the previous one expired on May 31, but the application has not been cleared till date in the absence of a police verification report.

The officials said that "an adverse report" has been filed against her by the Criminal Investigation Department (CID), but refused to elaborate saying the matter would be taken up before the high court.

Hearing the petition on March 23, Additional Solicitor General T M Shamsi, representing the Ministry of External Affairs and the Regional Passport office, sought a short adjournment after the counsel representing the Jammu and Kashmir CID informed Justice Ali Mohammed Magrey that the verification report on her passport application had been submitted on March 18.

However, Shamsi informed the court that he had received a communication from the Passport Officer in Srinagar on March 22 and the contents "reveal that the verification of the petitioner is under process and as soon as verification process is completed, the requisite report will be submitted immediately for further

"Communication further reveals that CID verification report in respect of the petitioner is still awaited from the JK CID. Copy of communication so produced by Shamsi...is taken on record," Justice Magrey said while posting the matter for further hearing on March 29.

The counsel for Mehbooba had submitted that the stand taken by the Regional Passport Officer, Srinagar with reference to non-availability of report from the JK CID, has delayed issuance of passport in favour of the petitioner.

In the petition, Mehbooba said her passport expired on May 31 last year and accordingly she applied for issuance of a fresh passport before the authorities concerned on December 11,

Mehbooba's counsel submitted that according to instructions issued by the Ministry of External Affairs, the passport of an individual is to be issued within 30 days but in the instant case, despite lapse of three months, passport has not been issued to the petitioner due to the pending police verification.

The 61-year-old politician was put under preventive custody on August 5, 2019, the day the central government revoked the special status of Jammu and Kashmir under Article 370 and bifurcated the erstwhile state into union territories.

She was released in October last year after the Union Territory administration revoked the charges under the Public Safety Act against her.

In many areas of Jammu, Kathua, Samba and Udhampur districts of Jammu region, he said, the water level has come down and "we have to work to increase the water level in such areas".

The melting of Himalayan glaciers has started at a significant rate since the beginning of the 21st century due to global warming, leading to weakening of glaciers and increasing the water level in various water bodies.

If the boundaries of water bodies in upper reaches are breached, it can lead to large amounts of water rushing down to nearby streams and rivers and creating flash floods.

In May 2015, the flash flood triggered by the bursting of the 15-kilometre-long lake in Zanskar area of Ladakh, damaged several bridges and buildings while more than 3000 people were shifted to safer places.

'Can't Plan So Far Ahead, I Take It One Series At A Time,' **Misbah On Contract Extension**

KARACHI: Pakistan head coach Misbah-ul-Haq on Thursday made it clear he doesn't want to look too far ahead and is taking one series at a time, saying the decision to give him an extension lies solely with the PCB.

Misbah's three-year coaching contract will expire just before the T20 World Cup in India later in the year.

"I always say that one can't plan so ahead as far as my coaching is concerned. I take it series to series. When the time comes it is time for the PCB to decide what is best for Pakistan cricket," he said in a virtual press conference.

Misbah said the selectors and team management are on the same page on selection matters, making it clear that he doesn't want to dwell on tainted T20 opener Sharjeel Khan's selection.

"I had to say this is a Pakistan team because such things appear in the media and an impression is created that there is discord among team management and selectors over selection matters. But I say everything is done collectively," he said.

"I don't know why Muhammad Asif or Salman Butt were not selected after completing their bans but what I know is that until there is a law that bars us from selecting a player after he has served any ban we can't keep anyone out."

The Pakistan coach said Sharjeel has been selected because of his form and he has been told that he has time before the T20 series in South Africa to achieve

his fitness "... he has to work hard and meet the required fitness standards of the team. He has to reach a certain level where there are no compromises," Misbah said.

"We will see how he progresses and improves his fitness without damaging his skill levels."

Chief selector Muhammad Wasim had recently said that fitness benchmark was being brought down to occupy more skilful players.

Misbah said: "We have had a detailed discussion on the fitness issue and we are trying to simplify the process for players by introducing parameters for players on which there will be no compromise.

"But also relate it to performances on the ground by the players. We are giving targets to players depending on their requirements.

"We are not reducing the fitness benchmarks of the team. We are trying to relate it to match and ground fitness. It is not that we will reduce the benchmark of Yoyo tests from 18 to 15 marks."

Pakistan will leave for the twin tours of South Africa and Zimbabwe on Friday after all the 22 members of the squad and 13 officials tested negative for CO-VID-19 on Thursday.

Pakistan will play four T20Is and three ODIs in South Africa starting next month and Misbah said it would be challenging going and playing the ODI series without any practice games.

PUNE: The immensely talented Suryakumar Yadav is likely to get a chance to showcase his '360 degree' hitting skills when a rampaging Indian team takes on a rather clueless England, aiming to seal off another series victory in the second ODI in Pune on Friday.

Shreyas Iyer's dislocated shoulder has once again brought Yadav in focus and his ODI debut, after a blockbuster T20 first outing, looks imminent after an all-round show by the hosts ensured an easy victory in the first game.

Iyer has been one of India's most prolific 50-over batsman before the COVID-19 enforced lockdown but such is the team's strength that a debutant looks more formidable for a world champion opposition, who are no less menacing but seem utterly confused at this point.

Being spoilt for choices is always a good headache to have for the think-tank and skipper Virat Kohli will be more pleased than anyone else.

Kohli has not had Ravindra Jadeja's services for close to three months but neither Axar Patel in Tests, and now Krunal Pandya in the ODIs, have let the team miss their maverick from Rajkot.

Prasidh Krishna, already a household name due to IPL, looked completely at home on his ODI debut, hurrying batsmen for pace in the absence of Jasprit Bumrah and Mohammed Shami.

And come to think of it, once Jadeja and Bumrah are back, a Krunal or Krishna will either cool their heels in the dug-out or even worse, not find a place in the squad, which is a testimony to India's unimaginable depth of talent pool.

The biggest positive during the opening game was Shikhar Dhawan's return to form with a match-winning 98. He was under pressure after being benched for a large part of the T20 series. The elegant southpaw would be

raring to go one more time.



Rohit Sharma had sustained a blow to his elbow during the first match but is expected to be fit in time for the second game.

In case India want to give Rohit a short break, then Shubman Gill can open alongside Dhawan with KL Rahul coming in at his usual middle order slot.

TOKYO: The torch relay for the postponed Tokyo Olympics began its 121day journey across Japan on Thursday and is headed toward the opening ceremony in Tokyo on July 23.

in the Japan team that won the Women's World Cup in 2011. Wearing a white track suit, she carried the torch out of the J-Village indoor soccer training center and was surrounded by 14 other members of that 2011 World Cup squad and coach

Homare Sawa, the biggest star on the 2011 team, missed the ceremony. She is being treated for a condition affecting her inner ear and had to withdraw from the event.

Fans were told to social-distance along the roadside as the torch passes, and they were to refrain from loud cheering. Organizers have said they will stop or reroute the relay if crowding becomes a problem during the fourmonth parade. Spectators cooperated in Naraha Town, just down the road from where the torch started its trip. A few hundred people stood on the road-

side and were safely spread out. "At first I didn't think much of it," said 20-year-old Takumu Kimura. "But when I actually saw it, it felt like: – yes, it's the Olympics."

Setsuko Hashimoto, a 63-year-old local resident, was emotional as the torch passed.

"Ten years ago there was a nuclear accident so (seeing the torch) it felt like I could really look forward to something and live," she said. "When you become my age, this is the last Tokyo Olympics and it's here. It was very touching.'

Prime Minister Yoshihide Suga chimed in from Tokyo with a statement.

"The Olympic torch relay starting from today is a valuable opportunity for the people to get a real sense of the Olympics and Paralympics that are approaching," Suga told reporters.

Local organizers and the International Olympic Committee hope the relay will turn public opinion in Japan in favour of the Olympics. Sentiments expressed in polls in Japan so far are overwhelmingly negative with about 80% suggesting another delay or cancellation.

The relay and the Olympics both stir fear that the events could spread the virus. There is also opposition to the soaring cost of staging the Olympics, now put officially at \$15.4 billion. Several audits suggest it's twice that much and a University of Oxford study says these are the most expensive Olympics on record.

The relay is a big test for the upcoming Olympics with fear among the public that the event could spread the virus to rural and more isolated parts of the country. Vaccinations have not been rolled out yet in Japan to the general public. About 9.000 deaths in the country have been attributed to COVID-19.

About 10,000 runners are ex-

pected to take part, with the relay touching Japan's 47 prefectures.

After the postponement a year ago, there was early talk of eliminating the relay to save money. However, that idea was quickly dropped with the relay heavily sponsored by Coca-Cola and Toyota.

Kumbh Duration Curtailed To 1 Month For First **Time; Pilgrims Must Show** 'Negative' COVID Test Report

DEHRADUN: The duration of Kumbh Mela in Haridwar has been curtailed to just one month for the first time in its history in view of a recent surge in COVID-19 cases and it has been made mandatory for pilgrims to have a "negative" RT-PCR test report to attend the mega congregation.

According to a notification, the congregation on the banks of the Ganges in Haridwar in Uttarakhand will take place from April 1 to 30, with three "shahi snan" (major bathing) dates on April 12, 14 and 27.

Thousands of dedip in the holy river during the mela with their number increasing manifold on the days of "shahi snan". Authorities also expect heavy turnouts on the occasions of Chaitra Pratipada on April 13 and Ram Navami on April 21.

Held once in 12 years, the congregation usually lasts three-and-a-half months. Its last edition was held in Haridwar from January 14 to April 28 in 2010.

According to the notification issued on Wednesday, the Kumbh Kshetra (area) covers Neergarh, Tapovan, Bitthal Ashram Marg to Muni-Ki-Reti Road and Rishi-Haridwar bypass in the north, and Narendra Nagar-Rishikesh bypass, the forest checkpost on Rishikesh-Dehradun Road, Rishikesh-Haridwar bypass, Mansa Devi, Billkeshwar Mandir, Tibri Mohand, BHEL residential buildings, Roorkee-Bahadarabad road and up to 13 km on Haridwar-Delhi road in the west. In the south, the congrega-

tion area will extend from Bahadarabad-Haridwar bypass to Siddha Sot Setu and from Siddha Sot Setu to Neelkanth Mahadev temple in the east.

A "negative" RT-PCR test report, not older than 72 hours before arrival, has been made mandatory for devotees by the Uttarakhand High Court. Devotees who have taken the COV-ID-19 vaccination will have to upload their certificate in an official

portal and follow the guidelines. After the Centre called for stringent measures to control the spread of COVID-19 during Kumbh, the Uttarakhand government had asked people to strictly follow COVID-19-appropriate behaviour during the congregation in view of the fresh surge in infections in various

parts of the country.

In the light of guidelines issued by both the central and state governments in the past for surveillance, containment and caution, Chief Secretary Om Prakash on Monday asked the district administrations, various state and central government organisations and other stakeholders to take all necessary measures to ensure wearing of face mask, maintaining hand hygiene and social distancing by people.

These measures are also included in the national directives for COVID-19 management which have to be strictly followed throughout the state, he said.

Union Health Secretary Rajesh Bhushan had recently written to the Uttarakhand Chief Secretary underlining the need for taking strict measures to check the spread of the pandemic, especially during the congregation.

Bharat Bandh On Friday; Rail, Road Transport Likely To Be Affected, Markets To Remain Shut

Rail and road transportation services are likely to be affected and markets may remain closed in parts of the country on Friday as farmer unions protesting against the three agri laws have called a complete 'Bharat Bandh'. However, the bandh will not be observed in four poll-bound states and Puducherry.

According to the Samkyukta Kisan Morcha, the nationwide shutdown will start at 6 am and it will be in force up to 6 pm across the country on March 26 which marks four months of the farmer agitation on Delhi's three borders—Singhu, Ghazipur and Tikri.

Senior farmer leader Balbir Singh Raiewal said road and rail transport will be blocked, claiming that markets will also remain closed. The Morcha, which is an umbrella

body of protesting farm unions, said that the 'bandh' will also be observed in the national capital. Rajewal said trade unions from organ-

ised and unorganised sectors, and transport and other associations have extended their support for the 'Bharat Bandh' call of farmer organisations on March 26. "Farmers will block rail tracks in

various places. Markets and transport services will be closed during 'Bharat Bandh'," Rajewal told PTI.

He said however, emergency services like ambulance and fire will be allowed during the nationwide shutdown.

Thousands of farmers, mainly from



Punjab, Haryana and western Uttar Pradesh, have been camping at Singhu. Tikri and Ghazipur demanding a complete repeal of the three farm laws and a legal guarantee for the minimum support price on their crops.

Mosques In Shahjahanpur To Be Covered Before Holi **Procession To 'Maintain Peace'**



round 40 mosques in the town of Shahjahanpur are Lead being covered with plastic sheets ahead of Holi to prevent miscreants from throwing colour on the structures and disturbing communal harmony, a senior official has said.

Continuing an 18th century tradition, Holi in this Uttar Pradesh town begins with revellers hurling footwear at a 'Laat Saab' procession featuring a buffalo cart and a hapless man personifying a Britisher.

The mosques are located along the route of the procession, the official said, adding that a thick security blanket will be thrown across the town where the law and order machinery will be under the charge of 225 magistrates.

According to Shahjahanpur City Superintendent of Police, Sanjay Kumar, the mosques along the procession route are being covered with plastic sheets from top to bottom to ensure people do not throw colour or any objectionable object at the structures and disturb communal amity.

"The mosques will be covered before Holika Dahan (March 28). Some of them have already been covered." Kumar said.

"The façade of the mosques have been covered with hoardings. Some of the roads, which fall on the route of the procession, have been barricaded and will be closed a day in advance, so that no anti-social element can disturb the procession," he added.

Kumar said preventive action was initiated against 200 people while CCTV cameras have been installed along the route of the procession while drone cameras will also be used to monitor the crowd.

Elaborating on the history of the procession of 'Laat Saab', Vikas Khurana, the head of History department of Swami Shukdevanand College, had told PTI. "On the day of Holi, the procession of 'Bade Laat Saab' is taken out on a buffalo cart with Holi revellers hurling jutas (footwear) at him."

The Holi tradition dates back to the early 18th century during the time of Nawab Abdullah Khan, the last emperor of the dynasty that founded Shahjahanpur, who was popular among both Hindus and Muslims.

The tradition of people taking out a procession with the nawab seated on a camel continued till 1857.

However, this event symbolising the Hindu-Muslim unity was not liked by the British, and in 1858. Mardan Ali Khan, the commander of Bareilly's military ruler Khan Bahadur Khan, attacked the revellers, and both Hindus and Muslims were killed in the violence.

In 1859, when the Nawab took out the procession on Holi, footwear were hurled at it on the instigation of the British rulers.

After Independence in 1947, the tradition was revived and the administration changed the name of the procession to 'Laat Saab' to symbolise the oppressive British regime. Since then, it is known by this name.

The celebrations have two parts: The processions of 'Bade Laat Saab' and 'Chhote Laat Saab'. The procession of 'Bade Laat

Saab' begins from Phoolmati Devi Mandir and proceeds towards Baba Vishwanath Mandir. Similarly, the procession of

'Chhote Laat Saab' begins from Ram Chandra Mission ke Sarai and culminates there itself after a short march.

All Eyes On Bengal: Ahead Of Assembly Elections, **State Tops In Facebook Political Ad Spend Over Others**

KOLKATA: Among the four states and one union territory that are going to polls from March 27, West Bengal emerged as the topper in spending for political advertisements on Facebook this year, according to data available with the social media platform.

Besides West Bengal, assembly elections will be held in three other states Assam, Kerala and Tamil Nadu and in the union territory of Puducherry.

The Facebook ad spend of the Trinamool Congress which seeks to return to power in West Bengal for the third consecutive term, exceeds that of the BJP, the main rival of the Mamata Banerjee-led party, in 90 days till March 22, the data revealed.

During the period, political parties of

West Bengal spent about Rs 3.74 crore on poll-related campaigns which fall under Facebook's advertisement category of 'social issues, election or politics'. In ad spend under this category, West Bengal is followed by Tamil Nadu (Rs 3.3 crore), Assam (Rs 61.77 lakh), Kerala

(Rs 38.86 lakh) and Puducherry (Rs 3.34 lakh) during the period, as per the data. The Trinamool Congress has spent the maximum amount among parties, around Rs 1.69 crore, of West Bengal during the

period on campaigns such as "Banglar Gorbo Mamata" (Bengal's pride Mamata). It also has constituency level versions such as "Dum Dum-er Garbo Mamata".

The TMC's digital advertisements are handled by the Indian Political Action Committee (I-PAC) which runs other campaigns also for the party on the social media platform.

During the period under review, another Facebook page run by the name of "Khotikarok Modi" (Harmful Modi), has spent Rs 33.12 lakh in political ads, according to the data. The state BJPs Facebook ad spend is

around Rs 25.31 lakh. It is advertising campaigns such as

Amar Paribar BJP Paribar (My family is BJP family) and Aar Noi Annay (No more injustice). The Facebook page of the TMC has 1.3 million followers while that of the West Bengal BJP has 1.7 million followers. The state Congress spent around Rs 5 lakh in advertisements on Facebook while the amount spent by Left parties is negligible.

According to an analyst, the total spending on digital advertisements of political parties would be more as they do not always pay directly for campaigns.
