**NEW DELHI:** Describing Prime Minister Narendra Modi's meeting with top political leaders from Jammu and Kashmir as a "very positive step", veteran Congress leader and former J&K governor Karan Singh on Fridav said statehood must be restored before holding assembly polls there and asserted that such a move would go a long way in helping to "heal the wounds" of the people.

Singh, the son of Maharaja Hari Singh who signed the terms of Kashmir"s accession in 1947, also said his personal opinion is that prima facie the revocation of special status

under Article 370 seems "irreversible" but asserted that the matter was before the Supreme Court and it must be decided by the top court.

In an interview with PTI, the last Sadr-e-Riyasat and first governor of the erstwhile state also demanded that the Centre must provide a "financial-cum- developmental package" to the people whose livelihoods were badly affected during the last two years following the Centre's move to bifurcate Jammu and Kashmir into two Union Territories and revoke its special status.

# 'He Was Fighting For His Family's Survival'

SRINAGAR: In the last 24 hours, Umer Nazir Bhat's brother has torn his three shirts in despair and distress.

The shattering act ceased when a relative gave him his slain sibling's T-shirt.

"The whole family was dependent on Umer," the family relative said. "I don't know how they will survive now!"

On Wednesday evening, Umer, 28, was shot inside his mobile shop in Srinagar's Habba Kadal area. He was immediately rushed to SMHS Hospital where the doctor declared him dead.

Following the incident, police registered a case under relevant sections of law. It was the third killing from the past week in Srinagar city.

"Despite assurances by the government, sadly the killings of civilians have not stopped. It is concerning and needs

Vaccine Shortage Blamed For Cattle Deaths, **Officials Pass the Buck**

SRINAGAR: The outbreak of footand-mouth disease (FMD) due to alleged inaction of authorities has consumed nearly 200 cattle, mostly sheep across several parts of the Kashmir Valley leading to strong resentment and anger among the farmers.

According to the farmers, the FMD outbreak among the domestic cattle has been reported in Bijbehara, Budgam, Bandipora and Baramulla areas, leaving close to 200 cattle, most of them sheep dead. Central Kashmir's Budgam district tops the list with 96 deaths due to FMD.

Mehraj-ud-din, a farmer from Central Kashmir's Budgam

told Kashmir Observer that his area witnessed 12 deaths of cow and sheep from the last ten days due to the disease.

"The Animal husbandry department failed to do the vaccination on time, as a result we could save the lives of our livestock." he said.

is to make children happy while they are undergoing cancer treatment.

# **The Chilling Effect of Patent Rights on COVID-19 Vaccines**

**To assert patent** rights over scientific innovations resulting from the collective processes and majorly public funding to command the pace and price of production is the motive that underscores the stated maximalist IP regime, acting as a chilling effect on the public good and access to healthcare and medicine

he on-going dearth and undersupply of vaccines is the cumulative effect of a maximalist IP regime (patents, in this case) that gives its countenance to the system to manoeuvre monopoly rights to hegemonize the pace and production of the pharmaceuticals (vaccines). The result is a chilling effect on the mass production of the vaccines, followed by a major health and economic crisis. "The ability of a handful of powerful companies ... to claim property rights over innovations resulting from the collective processes of modern science, and to use those rights to control the pace of manufacture and thus the price of pharmaceutical products, is not an unfortunate side effect of this system but its goal," Anne Orford, a professor, wrote recently.

This principle of IP rights maximisation perturbed me for a reason, that the principal objective, that of providing access to healthcare (in this case, the vaccine) to the maximum people, appears to be so low down the priority in the current IP regime.

#### **Factual Premise**

When I posed the question why, one of the responses that appeared before me was the "Tragedy of the Anticommons". Its definition, simplified, is: "[It] is a type of coordination breakdown, in which a single resource has numerous right-holders who prevent others from using it, frustrating what would be a socially desirable outcome.'

What is at issue here is the content of the right to health under Article 21 of the Indian constitution. The Spicy IP blog, in a chain of posts, has discussed IP and political facet of this issue. I, on the other hand, intend to highlight some constitutional concerns based on factual premises.

To begin with, I embark on two premises: the first premise being that under the present IP regime, accessibility of vaccines is an affair of consequential ordeal for an uncommon number of people. The claim, of course, is subject to proof, which would require a detailed number of variables and indicators; for the sake of argument, let us have it as given. Of course, if

The government today is morally bound to invoke the process of compulsory licensing to protect the people's right to health, at a time where vaccines' production are being hampered because of the various IP obligations. Conversely, the constitutional courts too are duty bound as a sentinel to protect the

# The Neighbourhood Factor In J&K Talks

t is ironic that the mainstream political leadership of the erstwhile state of Jammu and Kashmir, which was most strongly derided and incarcerated by the ruling dispensation in the wake of the constitutional changes of August 5, 2019, has been invited by Prime Minister Narendra Modi to initiate the political process in the Union territory the talks were held on Thursday. This development concerns only Indian politics, just as the constitutional changes were within India's domestic jurisdiction. However, J&K has an external dimension from India's viewpoint because of Pakistan's illegal and forcible control over Indian territory. Pakistan considers J&K as disputed and irrationally went all out to build international opinion against the constitutional developments but with practically no success. At the same time, there was disquiet, even if muted, in some global quarters at the administrative steps that accompanied the constitutional changes

In sum, therefore, Modi's step to talk to the mainstream political players of J&K will attract favourable attention in the West and will be welcomed by the Biden administration. More importantly, the point for consideration is if it is a part of the quiet and out-of-sight contacts between India and Pakistan which resulted in the February ceasefire along the Line of Control and the international

border in J&K. The ceasefire has held and it would seem that infiltration levels are down. Further, while both countries have been reiterating their known positions on long-standing as well as current issues, both governments are taking care to tone down the rhetoric. Particularly significant is that Pakistan Prime

While there have been no indications in the Indian media on the substance of current Indian-Pakistani contacts, there have been reports based on leaks in the Pakistani press. Some of these indicate that the pro-contact elements in the Pakistani army, including army chief General Qamar Javed Bajwa, and Imran Khan want India to take some steps in J&K to show to their critics – and there is disquiet in sections of the army as well as the political class — that their endeavours with India are yielding results. At a minimum, they want the restoration of statehood to J&K and an indication that India has no intention to change the demographic character of the Kashmir Valley. The question is if this would be enough for them to override the objections of the critics to reverse some of the steps they took in the wake of the constitutional changes. Obviously, pro-contact elements would be aware that there cannot be a return to the status-quo-ante

The Modi's government's preferred option is for Pakistan to turn its back on terrorism. Unless Pakistan does so, it is impossible for a peaceful and stable

relationship to be established. The current ceasefire along the LOC and the border in J&K is important for it has brought relief to those living in border areas and led to a fall in infiltration levels too. But as army chief General M M Naravane recently said, there is no indication that Pakistan is winding up the infrastructure of terror. It does not appear that this will stand in the way of the Modi government agreeing to a return to the bilateral India-Pakistan situ-

ation that existed prior to August 5, 2019.

What may, therefore, take place in the coming months, if not earlier, is a return of high commissioners and the restoration of some elements of bilateral trade. There may also be movement on restoring visits to the Kartarpur Sahib gurdwara and an easing in some areas of visa restrictions. The restoration of sporting contacts may be more difficult, for they arouse passions that both governments may wish to avoid. Certainly, it would be extremely difficult for Modi to think of the resumption of a structured dialogue as long as Pakistan holds on to the instrument of terror. For Bajwa and Imran Khan, the absence of a reversal of all steps taken on August 5, 2019 will invite the charge of a complete sell-out to India, which neither can afford.

While bilateral issues are under discussion in the quiet conversations between the two sides, it is not known if they are also focussing on the Afghanistan situation. Traditionally, Pakistan has been averse to talking about Afghan developments with India. It desires that India's role be curtailed to the economic sphere only. This point has been recently reiterated by Pakistan foreign minister Shah Mahmood Qureshi. It is also reported that it has been advising the Taliban against meaningful contacts with India at a time when Delhi is showing interest in talking to them. It is a different matter that Indian diplomacy was truly flat-footed on openly holding talks with the Taliban, even when the group was gaining global legitimacy. It is also known that it was signalling its interest in contact with India but at that stage, Delhi was rigidly glued to President Ashraf Ghani. A cruel price has always to be paid for diplomatic obduracy.

Pakistan is currently riding high on Afghanistan. It is a crucial player in the unfolding Afghan situation and it clearly wants the Taliban to be in the driver's seat in Kabul. It certainly does not wish for a return to the 1990s situation for that may destabilise the arrangements it has made in the erstwhile Federally Administered Territories (FATA), which have been amalgamated with the Khyber-Pakhtunkhwa province as well as Balochistan, which is restless as it is. It would be prudent for Pakistan to look at Afghanistan with fresh eyes, especially if, as Bajwa said, it is giving priority to geoeconomics. If that were the case, it should seek to reach out to India on Afghanistan and recognise that this country has major security and economic interests there. It should not forget that all Afghans want their country to have good ties with India. That said, there is no indication that there is any fresh thinking in Rawalpindi on India's role in Afghanistan.

Some movement on India-Pakistan ties is on the anvil but not a change in its basic postulates.

accines are our beacon of hope to bring back some semblance of our previous ways of living, Getting fully vaccinated doesn't make us invincible but it offers adequate protection to combat the life-threatening risks posed by this deadly coronavirus that has plagued the entire world and altered our lives completely. The chances of contracting the virus after getting fully vaccinated are reduced substantially and the severity of the disease and the fatalities are minimized to a great extent. Several health professionals from around the world have underscored the need to ramp up the vaccination process to halt the rampant spread of the virus and the emergence of new variants. Dr. Fauci, who is the health advisor to the US president in a recent press conference stated that" expediting the vaccination process could help us stay ahead of the virus, particularly the more infectious variants.' One major obstacle for mass vaccination to thwart the spread of the virus is the "vaccine hesitancy" among people. The development of the coronavirus vaccines in a record time has led to the circulations of several speculations about its safety claims. Most of the rumours regarding its shortterm and long-term repercussions are unfounded, as far as the fears about the development of blood clots are concerned, health experts and medical professionals have time and again addressed those apprehensions. The Rise Of The Deep State

utin's People: How the KGB Took Back Russia and Then Took on the West by Catherine Belton is a book about how a shadowy establishment within an unstable country used political turmoil to empower and enrich itself to the point that it now controls most of the state and the country's economy. This is very much a story of our times and, as such, serves as a warning from history to Pakistan.

Putin's People is ostensibly about the rise of Russian strongman Vladimir Putin and the economic and political system — "Putinism" — he and his allies created over the past 25 years or so. But Putin here stands as a figure representative of the reach and power of the main security agency of the Soviet Union, the Komitet Gosudarstvennoy Bezopasnosti, better known as the KGB.

This is a story, then, about the power of the deep state, and how it weaves that power through visible state institutions, non-state actors, personal networks and, ultimately, brute force. This is also a story about the use of wars, the threat of violence, appeals to nationalism and patriotism and unfettered corruption. It is, ultimately, about the precariousness of democracy and the corrupting nature of power in the modern state.

The book begins — like many good stories — with a tumultuous storm. In this case, the storm is the 1989 people's uprising in East Germany. Huge crowds march on state buildings in cities across the country, tearing down symbols of the oppressive state, including, most symbolically, the wall separating East from West Berlin. These crowds also arrive at the doorstep of the local KGB office in Dresden, looking to break in and destroy all traces of the Soviet spy agency then working hand-in-hand with the hated East German secret police, the Stasi.

Putin — at the time a middling KGB operative at the agency's Dresden office — is forced to hastily destroy the agency's records and then flee to a nearby Soviet military base. Shocked at the crumbling of the East German state and its eventual obliteration, by absorption into West Germany, Putin vows to never allow such a fate for his homeland.

An eye-opening book, currently the best study on Putinism and the politics of the Russian industrial oligarchy, offers a warning from history

However, the Soviet Union did, in fact, follow suit. It crumbled soon after its eastern German satellite, and split into a number of constitutive states, the biggest of which was Russia. In this turmoil, the old Russian order was abandoned by the new government headed by Boris Yeltsin. Communism was disavowed, democracy instituted and a free market economy embraced.

Those associated with the old order lost power, too. Mikhail Gorbachev, who had done so much to usher in the end of the Soviet Union, was himself removed from the presidency. The Communist Party was banned, and leading figures in the KGB lost their jobs. The once all-powerful agency was split into four separate organisations.

Through interviews with some of the leading figures of those years, as well as her intimate knowledge of the politics of Russia, journalist Belton explains how the KGB, in fact, did not simply disappear.

Although the agency was dismantled, many of its senior and middle-ranking officials re-emerged during the Yeltsin years to reassert their power and bring back much of the culture and prerogatives of their former employer. Belton's book is a history of this KGB-ism, an afterlife of the organisation that materialised through Putin and his supporters.

The backdrop to the rise of this KGBism is the dire shape of the Russian government's finances soon after the shift to a market economy in January 1992. the new powerbrokers during Yeltsin's reign. By one estimate, nearly 50 percent of the country's wealth was in the hands of just seven business tycoons by the time Yeltsin left office.

Economic problems continued to pile on Yeltsin, however, and he became increasingly beholden to these newly emergent oligarchs. A disastrous currency devaluation in 1998, followed by a default on government debt and a subsequent war in Chechnya, forced Yeltsin to step down and install a figure who would be acceptable to his growing critics, and yet could also be controlled by him and his family. Mistakenly, he thought Putin was such a man, and Putin was appointed acting president on New Year's Eve in 1999.

Putin was a popular choice. Following his return from East Germany, he had eventually ended up running the remnants of the KGB in Moscow, and later taken a leading part in the muscular Russian response to Chechen separatism. The strongman appealed to a population tired of political and economic turmoil.

"To the Russians", writes Belton, "it seemed like a breath of fresh air. Compared to the sick and ailing Yeltsin, suddenly they had a leader who was in charge." An election was soon called, and Putin was emphatically elected as the president of Russia in March 2000.

Putin brought several former KGB men into his administration and, through him and his supporters, the agency was finally able to take revenge for being shut out of power during the Yeltsin years. Seeing themselves as guardians of the nation — and the oligarchs as a threat — Putin and his guard set about curbing the power of the new billionaires. Yeltsin's oligarchs were threatened, blackmailed and bribed into handing their industries over to Putin's allies.

Once the old billionaires were subdued, Putin and the new oligarchs who now controlled Russian industry turned to expand their influence overseas through investment and the raising of foreign capital. In 2005 alone, they raised more than \$4 billion in share sales in London, compared to \$1.3 billion in all markets in the 13 years after the Soviet collapse. The London establishment, in turn, met Putin's oligarchs with open arms. The Russian share listings earned huge profits for London's bankers, lawyers, consultants and public relations firms.

The path to acceptance was paved with public relations coups, such as Putin's close confidante Roman Abramovich's purchase of the London-based Chelsea Football Club in the summer of 2003. London newspapers "marvelled at Abramovich's private Boeing 767 as he swooped into London to inspect his new club. They devoted copious column inches to his luxury yachts, including the world's biggest, the Eclipse, a 168-metre floating palace kitted out with two helicopter pads and its own submarine ... Few asked where his money came from."

London became the new oligarchs' playground, known to Russians as "Londongrad", or "Moskva-na-Thames" (Moscow on the Thames). "In London, money rules everything," boasted one Russian tycoon. "Anyone and anything can be bought."

Even American real estate tycoon Donald Trump was pulled into Putin's orbit. With the possibility of a lucrative Trump Tower in Moscow as bait, Trump emerged as an empathetic supporter of Putin in the 2000s, and their support for each other during Trump's election campaign and then presidency is, of course, well known.

Trump is now gone, but Putin and his deep state remains. Democracy in Russia is in tatters, and a state-withina-state controls the country's economy, military and foreign policy. Its reach and influence extend beyond the country into international financial and political centres of power such as London and Washington, DC.

Putin's People is an eye-opening book, and currently the best study we have on Putinism and the politics of industrial oligarchy and the KGB during Putin's reign. Although many of the processes described are particular to Russia, the book nevertheless stands as a warning about the fragility of democracy and the dangers of the deep state.

According to the report, Mehbooba accused BJP of portraying an opposite situation prevailing in Jammu and Kashmir. The report also quoted her saying that "there is so much of oppression in Jammu and Kashmir that people are unable to even breathe"

When asked why she was invited to the PM's meet even though she was blamed for being a militant sympathiser, Mehbooba said that this is something only the Prime Minister or Home Minister would be able to answer.

"They (the centre) have realised that things have not gone as they had planned, and maybe out of little empathy that they had left, they decided to meet us. We went out of respect for the office of the Prime Minister," she said.

"Do you really believe that if the situation on ground was all hunky-dory, then the centre would have invited the Gupkar alliance for a talk? Things are clearly not how they intended it to be. They know that they need Gupkar to reach out to the people; hence they are now meeting us," she added.

The PDP President however acknowledged that the meeting was held in a cordial atmosphere and the Prime Minister and Home Minister heard what she had to say. She also termed the invitation by PM as a welcome measure.

"What one can hope for is that when the Prime Minister says Dil ki dooriyaan kam karni hai that he means it," she said, adding "

The former CM reiterated her vow that she will not contest elections till the government of India reverses August 2019 move and restore Article 370 and Article 35A.

"I will not contest the elections. I will do this because otherwise people will feel that the resolution of Article 370 is just a slogan for me and I am just doing politics over it. That is not the case; hence, I will personally not contest any election till it's reversed," she said.

"Article 370 and 35A were a means for us to have job security and also our identity of being from J&K. So, these are important to us. And that is why you must have seen that J&K was India's most prosperous state," she added.

Speaking about the fallout of special status revocation, the ex-Chief Minister said that since the day Article 370 and 35A were scrapped, the people fear that the demography will be changed, so the centre needs to address these fears.

"Another thing is that jobs must be secured for the local youth. For confidence-building measures, they need to do much more. They need to release many other prisoners apart from our party leaders," she said.

"If the siege is lifted, people are not harassed, students and journalists are not harassed, people are not picked up...These confidence-building measures must be undertaken," she added.

Mehbooba also defended her party's youth wing president Waheed Para saying that the allegations that he gave Rs5 crore to Geelani's son to instigate stone-pelting in J&K in 2016, when her government was in power was absurd and nonsense.

Talking about militancy, the PDP president said that though data might suggest that militancy has come down, there is still disquiet in the region.

"When a local youth picks up a gun and then they get killed, the flag on their grave becomes a Pakistani flag. Once militants get killed, they become Pakistani," she said.

She also pointed out the alleged harassment of journalists by government forces for their reporting. **Govt Putting**

that Terror Financing (TF) investigations and prosecutions target senior leaders and commanders of UN designated terrorist groups," an FATF statement said.

The UN designated terrorists include Jaish-e-Mohammed (JeM) chief Azhar, Lashker-e-Taiba (LeT) founder Saeed and its 'operational commander' Zakiur Rehman Lakhvi.

The FATF said Pakistan should continue to work to address its strategically-important deficiencies by enhancing international cooperation by amending its anti-money laundering law and demonstrating that assistance is being sought from foreign countries in implementing UNSC Resulution1373 designations.

Pakistan should also be demonstrating that supervisors are conducting both on-site and off-site supervision commensurate with specific risks associated with Designated Non-Financial Businesses and Professions (DNFBPs), including applying appropriate sanctions where necessary.

Pakistan has also been asked to ensure that proportionate and dissuasive sanctions are applied consistently to all legal persons and legal arrangements for non-compliance with beneficial ownership requirements, demonstrating an increase in money laundering investigations and prosecutions and that proceeds of crime continue to be restrained and confiscated in line with Pakistan's risk profile.

This included working with foreign counterparts to trace, freeze, and confiscate assets and demonstrating that DNFBPs are being monitored for compliance with proliferation financing requirements and that sanctions are being imposed for non-compliance, it said.

The FATF also referred to the high level political commitment made by Pakistan in 2018 to work with the FATF and Asia Pacific Group to strengthen its anti money laundering and combating the financing of terrorism.

With Pakistan's continuation in the grey list, it is increasingly becoming difficult for the country to get financial aid from the International Monetary Fund (IMF), World Bank, Asian Development Bank (ADB) and the European Union, thus further enhancing problems for the neighbouring country which is in a precarious financial situation

Pakistan needed 12 votes out of 39 to exit the grey list and move to white list.

Islamabad has been avoiding black list, for which it needs support of three countries. China, Turkey and Malaysia are its consistent supporters. Pakistan was placed on the grey list by the FATF in

June, 2018 and was given a plan of action to complete it by October, 2019. Since then the country continues to be in that list due to its failure to comply with the FATF mandates.

The FATF is an inter-governmental body established in 1989 to combat money laundering, terrorist financing and other related threats to the integrity of the international financial system.

The FATF currently has 39 members including two regional organisations -- the European Commission and Gulf Cooperation Council.

India is a member of the FATF consultations and its Asia Pacific Group.

"I believe everybody spoke their mind very frankly and the prime minister listened very attentively to everybody. Three and a half hours of the meeting was there and my own view is that it is a very positive move because something was needed to break the ice." the former Union minister said.

The whole situation after the change of status had become "ossified politically", Singh said, adding that the meeting was the start of a political process that is to be welcomed.

Asked about the demand of most Jammu and Kashmir leaders for restoration of statehood, he said it was a unanimous view because after being in special status for 70 years suddenly to be demoted to not even a state down to a Union Territory is "something nobody in Jammu and Kashmir has appreciated".

"So statehood is a universal demand, the question is timing. Now as I understand the situation, the first step now is delimitation. The delimitation commission is already working, they should submit their report very soon. After delimitation then the next step is elections. My own view is that...we should have elections as a full state," Singh said.

He asserted that full statehood for Jammu and Kashmir should definitely be restored before assembly elections because if it goes to polls as a Union territory and then becomes a state, that would not make any sense because the situations are different with difference in status.

"As soon as possible, we should get statehood, I mean if we get it tomorrow there is nothing like it but in any case when we fight the next elections we must fight them as a full-fledged state," the 90-yearold leader said.

Singh also lamented that it was a "strange irony" that his father signed the instrument of accession for the whole state and "today we are having to fight for statehood".

Asked if statehood could reduce "dil ki doori" -- a term used by Prime Minister Modi at the meeting, Singh said restoring statehood will go a long way to help "heal the wounds".

"By itself, it won't be enough but it would definitely be a major step," he added.

Asked about calls from a section for restoring Article 370 provisions that granted special status to J&K and were abrogated in 2019, Singh said, "My personal belief in this is that it seems to me prima facie that the changes are irreversible but the matter is before the Supreme Court so we shouldn't unnecessarily make any detailed comment on it what should be done and what should not be done."

The veteran Congress leader urged the Supreme Court to take up the matter soon, asserting that it was a very crucial and important issue that should be given priority. Asked about divergent views struck by Congress leaders on the Article 370 issue, Singh said he was not a Congress spokesperson and would not want to speak on behalf of the party. "I expressed my personal view that it did not seem to me that Article 370 can be restored...My view may be slightly divergent from others. But the consensus is what Ghulam Nabi (Azad) said" and the matter is before the Supreme Court and they will decide on it.

Director, Sheep Husbandry, Bashir Ahmad Khan told Kashmir Observer that the disease used to be mainly found in cows and bedfellows. However, it was found in small animals like sheep as well.

The Director passed the buck when asked why the department failed to procure the vaccine.

"It was the domain of Animal husbandry to procure the vaccines under the Centre's program. You can ask them," Khan said.

He said the longer strategy formulated by Pakistan is to use killing of militants during encounters to fuel anti-national sentiments.

"When you kill a Kashmiri youth who has been a militant for five-six months, a family is established against our country, it becomes unhappy. Giving more details, the Corps Commander said only two foreign militants were killed in Kashmir this year.

"Our counter-infiltration grid has been very strong for the last few years, which means that less number of foreign militants were able to infiltrate , he said.

He also said the security situation in the Kashmir Valley of the last few years cannot be compared with that of the last two to three decades.

"It (security) has improved much. There are many things to it - abrogation of (Article) 370, development, having a good control and other things. But, an important aspect is the presence of foreign militants - which are all from Pakistan and it is not like a mix from some other countries, he said. and Kashmir into two UTs and revocation of its special status, Prime Minister Narendra Modi on Thursday held talks with top political leaders from the erstwhile state, and said the Centre's priority is to strengthen grassroots democracy there for which delimitation has to happen quickly so that polls can be held.

Union Home Minister Amit Shah, who was also present at the meeting, had said that the delimitation exercise and holding of peaceful elections in the Union Territory are important milestones in restoring statehood as promised in Parliament.

#### Modi's Meet

Centre's priority is to strengthen grassroots democracy there for which delimitation has to happen quickly for polls to be held.

This was the first interaction between the top leadership of the Union government and mainstream parties in J&K since August 5, 2019, when the Centre revoked its special status provided under Article 370 and bifurcated the border state into Union Territories of Jammu and Kashmir and Ladakh.

"In my view it was a drama and why was it a drama? Because at best it could be called a public relations exercise but nothing was achieved," Qureshi said a day after the high-level meeting on Jammu and Kashmir in New Delhi.

Qureshi said the Kashmiri leaders at the meeting "unanimously demanded full-fledged restoration of statehood".

"The leaders were not given any solid reply to their demand and instead told that a decision about restoration of the special status of Kashmir will be taken at an appropriate time, which is an ambiguous statement," he said.

He pointed out that the All Parties Hurriyat Conference (APHC) leadership was not invited to the meeting.

Tensions between India and Pakistan have spiked since New Delhi abrogated the Article 370 of the Constitution to revoke the special status of Jammu and Kashmir on August 5, 2019.

India's decision evoked strong reactions from Pakistan, which downgraded diplomatic ties and expelled the Indian envoy.

Qureshi claimed that India was trying to bring demographic changes in Kashmir which was worrying for Pakistan as it would have long term implications.

To a question about back-door diplomacy with India, he said no such communication was going on with India but confirmed intelligence-level contact.

There is no back-door channel but there is contact on the regional situation at an intelligence level but there is no back-door channel," he said.

Talking about the Afghan peace process, Qureshi said he was not aware of the deployment of a UN peacekeeping force in Afghanistan but Turkey was expected "to maintain security responsibilities at police spokesperson said.

He identified the killed militant was Murtaza of Samboora in Awantipora and associated with Lashkar-e-Taiba.

"As per police records Murtaza was also involved in several militancy crime cases including attacks on security forces and civilian atrocities," the police spokesperson said.

He further said the family members of another holed-up militant were brought to the encounter site to again persuade him to lay down arms.

"It was due to the great efforts and utmost patience of police, security forces and repeated surrender appeals with the help of his family members, the trapped militant Sahil Ramzan Dar of Beminipora ultimately surrendered before the joint forces," the police spokesperson said.

Dar, he said, was an active militant of LeT since March 2021.

"Incriminating materials, arms & ammunition including 1 AK-56 rifle, 1Pistol, 3 AK-magazines, 2 grenades were recovered from the encounter site/ possession of surrendered militant. All the recovered materials have been taken into case records for further investigation," he said.

"In this connection, Police have registered a case under relevant sections of law and investigation has been initiated. People are requested to cooperate with police till the area is completely sanitized and cleared off of all the explosive materials, if any," he added.

Meanwhile, IGP Kashmir, Vijay Kumar once again reiterated his appeal to all "misguided youth" who have joined militancy to shun the path of violence and return to mainstream.

"He also said that police are committed to accept them with open arms as society needs them the most, especially their parents," the police spokesperson said.

Kumar, he said, also complimented police and central forces for showing utmost patience and exhibiting professionalism by taking surrender of active militants during live encounters, thus saving a precious life.

#### **Anti-Militancy Ops**

Replying to a question about the total number of militants active in Kashmir valley and targeting of civilians and police officers by them, Singh said, "It is not a one sided battle. When more than 200 armed militants will be present in an area, it is not that they will continue to die, when you (security forces) fight them (during gun battles)".

"It is not that they will not resort to any unholy act. Our endeavour is to put an end to their activities and curb militancy", he said.

Asked about 'Operation All-Out', he said the already-taken measures will be intensified to strengthen the battle against militants and curb heinous activities of militants. Asked what were his expectations from the Centre on J&K going forward, Singh said he expected that they would move forward as they say on delimitation, elections and statehood.

Demanding a financial-cum- developmental package for the people of J&K, Singh said for two years the state suffered very heavily.

"The whole Kashmir Valley, the horticulture was destroyed, tourism which is our mainstay was destroyed so tens of hundreds of crores of losses were suffered," he said, adding that in Jammu also heavy losses were incurred.

"So they should first compensate those people who lost during those two years," he said.

Modi's J&K outreach saw the prime minister conveying to the 14 political leaders from the union territory during their face-to-face meeting here that he wanted to end the "Dilli ki Doori" as well as "Dil ki Doori" (distance from Delhi as well as the distance of hearts) with Jammu and Kashmir, which has witnessed a prolonged spell of militancy and unrest.

The four former chief ministers of the erstwhile state who participated in the discussions were Farooq Abdullah and his son Omar Abdullah of the National Conference, Congress' Ghulam Nabi Azad and PDP chief Mehbooba Mufti.

Four former deputy chief ministers were in attendance too - Congress' Tara Chand, People's Conference leader Muzaffar Hussain Baig and BJP's Nirmal Singh and Kavinder Gupta.

CPI-M leader Mohammed Yusuf Tarigami, Jammu and Kashmir Apni Party (JKAP) chief Altaf Bukhari, Sajjad Lone of the People's Conference, J-K Congress head G A Mir, BJP''s Ravinder Raina and Panthers Party leader Bhim Singh also formed part of the delegation.

Stressing on enforcing containment measures at micro-level, the LG, he said, directed for declaring

livestock diseases, especially foot and mouth disease (FMD) and brucellosis, in the next five years. The total outlay of Rs.13, 343.00 crore for five years (2019-20 to 2023-24).

However, the farmers said, the sheep and animal husbandry department failed to procure the free vaccination under this program. The disease is taking a heavy toll on the affected farmers financially amid the prevailing COVID-19 pandemic.

"We have already suffered due to back to back lockdowns. Now the disease will dent our business completely," said another farmer, Aijaz Ahmad Shah from north Kashmir's Bandipora.

Shah says, the district animal husbandry got active after several cattle were found dead in the district.

Following the disease, the government of Jammu and Kashmir issued an advisory and asked the sheep farmers to adhere to several recommendations to safeguard their livestock in view of the occurrence of FMD.

The advisory stated that the farmers need not to panic as FMD in sheep causes negligible mortality.

"Separate the affected animals from the apparently healthy animals. Restrict the movement of in contact animals to prevent the spread of the disease and don't allow animals for grazing at common place. Keep newly purchased animals under quarantine for 14 days before including them in the herd," reads the advisory.

It reads that spray 4 per cent Sodium Bicarbonate solution around the farm premises daily to prevent its spread.

"Feed soft and palatable feed/fodder to the affected animals. Wash /rinse the ulcerated vesicles found on mouth, tongue, hoof, teeth etc with 1 percent potassium permanganate solution at least once a day and apply boro-glycerine (1 part of boric acid and 9 percent parts of glycerin) on the mouth lesions."

It further read that look out for any FMD signs/ Symptoms in your flock viz high fever blisters erosions on mouth and feet and lameness.

The advisory has also asked the sheep farmers to contact the concerned veterinarian of the block/SEC and follow his/her advice.

An official from the Animal and sheep husbandry department, however confirmed to Kashmir Observer that the department couldn't procure the vaccination on time.

"Yes, because of the covid-19 pandemic, we couldn't procure the vaccine on time. But as soon as we got reports of the disease outbreak, we started procuring the vaccine on our own funds and our staff is on the field to do it," said the official, wishing not to be named.

He however said, the department may not be able to cover all the livestock as the number is very huge. "We have over 17 lakh populations of sheep and it will be difficult for us to procure the number of vaccines. Still we are trying our best," he added. that," he said. Asked if the withdrawal of foreign troops from Afghanistan was a cause of concern in respect of the security situation in Jammu and Kashmir, Lt Gen Pandey said the situation here has changed from the past 30 years.

"I think there are two options, maybe some people will come here, but I assure you that whenever anyone tries to come, the control of J-K Police (over the situation) is very strong, and no wrong act will be allowed in Kashmir, he added.

#### NIA Charges

explosives into India with the help of handlers based in Pakistan-controlled Kashmir (PcK).

The charge sheet was filed before a special NIA court in Jammu on Thursday against Mohd Mustafa Khan, Mohd Yaseen, Mohd Farooq, Mohd Ibrar, Mohd Javid Khan, Sher Ali (based in Kuwait), and Mohd Rafiq Nai alias Sultan (based in PcK).

They have been charged under various sections of the Arms Act, Explosives Act and the Unlawful Activities Prevention Act or UAPA.

The NIA had taken over probe in this case in March this year after the Jammu police filed an FIR in December last year relating to the arrest of Mohd Mustafa Khan and recovery of six hand grenades along with "incriminating documents" from his residence.

The probe found, the NIA alleged, that the seven accused named in the charge sheet "were part of a deep-rooted criminal conspiracy by Pakistan-based handlers of TuM and their militant associates based in Poonch and Kuwait to execute militant activities and wage war against the Indian state."

An absconding accused in the case, Rafiq Nai, and other handlers based in PcK, with assistance of Sher Ali based in Kuwait and the other accused living on the Indian side of Line of Control (LoC) in Poonch "smuggled" arms, ammunition, explosives, narcotics etc into the Indian territory, the central probe agency said.

"They were taking advantage of the geography, affinities of religion, culture and other ties cutting across both sides of the LoC."

"During the course of investigation, a large cache of arms, ammunition, explosives, narcotics along with flag, posters and other incriminating material belonging to militant outfit TuM, which was hidden at different places in Poonch was recovered," the NIA said.

Further investigation in the case is continuing, it said.

# Ayatollah Ali Khamenei Receives Made-in-Iran **COVID-19 Vaccine**

TEHRAN: Iran's supreme leader Ayatollah Syed Ali Khamenei Friday received the first coronavirus vaccine developed by the Islamic Republic. Iran leader called the development of the vaccine a point of "national pride".

"Some insisted from a while ago that I use a vaccine," the 82-yearold, who has had a string of previous health problems, said after receiving the first dose of the jab called COVIran Barekat.

"I didn't want to use a non-Iranian vaccine. I said we will wait until, inshallah, the local vaccine is produced and we can use our own vaccine," he said.

The supreme leader had in January outlawed the use of United States and United Kingdom-made

under the supreme leader that is in charge of developing the vaccine, has said it now produces three million doses per month and will soon boost production to 11 million doses a month to become the largest vaccine manufacturer in the Middle East.

While the vaccine's detailed scientific data have not been made public yet, its developers have claimed it was 93.5 percent effective among individuals 18 to 75 in its second phase of human trials.

They have also claimed 12 countries from Asia, South America and Europe wish to buy the vaccine. without naming them. Besides CO-VIran Barekat, several other locally developed vaccines are in various stages of development.

A vaccine developed by Iran's Pasteur Institute in collaboration



vaccines, notably those developed by Pfizer and Moderna, as he said they "cannot be trusted".

Human trials on the COVIran Barekat vaccine began in late December and about 24,000 volunteers received jabs as part of its third phase of trials that recently concluded.

The vaccine received an emergency use authorisation earlier this month and is expected to be rolled out on a large scale in the coming weeks. Iran's local vaccine research has gained urgency as heavy American sanctions have hampered the Islamic Republic's mass inoculation efforts.

**48 Delta Plus Covid Variant Cases Detected In** India; Maharashtra With Highest Cases: Centre

NEW DELHI: Forty-eight coronavirus cases of 'Delta Plus' variant have been detected from 45,000 samples sequenced so far in the country, with Maharashtra reporting the highest number of such cases at 20, the Centre said on Friday.

It said nine cases of Delta Plus variant were found in Tamil Nadu, seven cases in Madhya Pradesh, three in Kerala, two each in Punjab and Gujarat, and one case each in Andhra Pradesh, Odisha, Rajasthan, Jammu and Karnataka. The Union government maintained that 90 per cent of the

The head of Israel's pandemic response taskforce, Nachman Ash, said the rise was likely due to the Delta variant, adding that the increasing cases were not yet matched by a parallel rise in hospitalisations or deaths.

Vaccination rates rose sharply this week after the centre made shots free following a devastating pandemic surge in April and May. The police in Mumbai said that around 2,000 people who thought they were being vaccinated were in fact injected with a saline solution.

Ten people have been arrested including two doctors at a private hospital in Mumbai, the police said, with the scammers targeting residents of an upscale hous-

ing complex in one case. "We (then) discovered that eight more camps were organised by this syndicate," said Vishwas Patil, joint commissioner of police (law and order

division). The police have recovered 1.24 million in cash which was "fraudulently obtained" by the accused. The police in Kolkata, meanwhile, have arrested a man posing as a civil servant with a master's degree in genetics who reportedly ran as many as eight spurious vaccination camps.

The police said at least 250 disabled and transgender people were injected at one site. and that in total nearly 500 people may have been given counter-

feit jabs across the city. Kolkata official Atin Ghosh

said that the seized vials were falsely labelled as containing the AstraZeneca coronavirus vaccine Covishield.

"It was found that the Covishield label was stuck over another label, that of Amikacin Sulphate 500 mg, an antibiotic used to treat bacterial infections of the urinary tract, bones, brain, lungs and blood among others," Mr Ghosh said.

The scam came to light after an actress and politician, Mimi Chakraborty, who received a shot at one of the camps to raise awareness, became suspicious and alerted the police.

The police seized fake ID cards from the suspect, one of an information ministry official and another as a municipal commissioner. His car sported Kolkata govern-

ment stickers. Debashis Barui, a Kolkata health official, said

that many of those who had been injected were now "panicking" about the possible side effects. "If any emergency arises, civic authorities will organise medical camps in the area to take care of those who have had fake shots," Mr Barui said.

One of them, Ruma Sikdar, 35, said that she had been feeling drowsy and had discomfort in her arm. "What I am 10ml worried about is how to get the real dose before the third wave hits," the home-maker said. "We didn't think that this could happen when the

world is battling the pandemic," said student Debjit Majumdar, who also received the fake jab.

# ICJ Bill Giving Kulbhushan Jadhav Right To Appeal Presented In Pakistani Senate Agenceis

The International Court of Justice (Review and Reconsideration) Bill, meant to provide the right of appeal to Indian national Kulbhushan Jadhav, was presented in the Senate on Thursday, after being passed by the National Assembly on June 10.

Minister of State for Parliamentary Affairs Ali Muhammad Khan introduced the bill in the House, after which the Senate Chairman Sadiq Sanjrani referred the bill to the Standing Committee on Law and Justice, reported Geo News.

The bill seeks to provide a further right of review and reconsideration in giving effect to the judgment of the International Court of Justice. It was adopted by the National Assembly on June 10 after approval from the 21-member standing committee.

According to the bill, the High Court has the power to review and reconsider where the ICJ concerning a foreign national passes an order in respect of rights under the Vienna Convention of Consular Relations or a foreign national is aggrieved in respect of the rights available under the same.

However, India recently expressed that it is not convinced



with Pakistan National Assembly passing a bill to give the right of appeal to Kulbhushan Jadhav in Pakistani high courts.

India says the bill is full of shortcomings and is a breach of the ICJ judgment.

Ministry of External Affairs (MEA) spokesperson Arindam Bagchi said at a weekly media briefing that the bill does not create machinery to facilitate effective review and reconsideration of the case as mandated by the judgment of the ICJ

"We have seen the news reports relating to the Review and Reconsideration Bill 2020

that has been passed by the National Assembly of Pakistan. The Bill codifies into law the earlier Ordinance- with all its shortcomings. It does not create a machinery to facilitate effective review and reconsideration of Shri Jadhav's case, as mandated by the judgement of the International Court of Justice," Bagchi said.

The ICI has ruled that Pakistan was in breach of its international obligations because of the failure to provide consular access to Jadhav.

Bagchi said the ordinance, now the Bill, invites the munici-

pal courts in Pakistan to decide whether or not any prejudice has been caused to Jadhav on account of the failure to provide consular access.

"We call upon Pakistan to take appropriate steps to address shortcomings of the bill and to comply with the judgement of ICJ in letter and spirit," he added.

India has slammed Pakistan for adopting a "farcical" approach in denying available legal remedies to Kulbhushan Jadhav against his death sentence in contravention of the ICJ order. (ANI)

NEW DELHI: The Union Health Ministry on Friday said that pregnant women can be vaccinated against Covid-19. While addressing a press conference on behalf of the Union Health Ministry, Indian Council of Medical Research (ICMR) Director-General Dr Balram Bhargava said, "The Ministry of Health has given guidelines that the vaccine can be given to pregnant woman." "The vaccine is useful for the

pregnant women and it should be given," Dr Bhargava said. Dr Bhargava said that in terms

of administering Covid-19 vaccines to children is still debatable until relevant data is available.

"There is only one country that is giving vaccines to children at the moment. Whether very small children will ever need vaccines, is still a question. Till such time, we have more data on vaccination of children, we would not be in a position to vaccinate children at large," the ICMR director said.

"However, we have started a study on children between 2 years to 18 years and we will have a result on it by September," he added. During the conference, Director of the National Centre for Disease Control (NCDC) Dr SK Singh informed that a total of 48 cases of Delta Plus variant of Covid-19 have been detected in the country so far.

Dr Singh said, "Eight states are important where we have found more than 50 per cent of the variant of concern. These are Andhra Pradesh, Delhi, Haryana, Kerala, Maharashtra, Punjab, Telangana, and West Bengal."

"Covishield and Covaxin work against the variants of SARS CoV 2 -alpha, beta, gamma as well as delta. Delta Plus is present in 12 countries. As many as 48 cases have been identified in India but more importantly, they have been very localised," Dr Bhargava said regarding the Delta Plus variant of Covid-19.

Delta Plus or AY.1 will always remain a variant of concern (VoC) as it is mutated from the Delta variant (B.1.617.2), which is also a VoC, he added. Meanwhile, Joint Secretary of the Union Health Ministry Lav Agarwal informed that the recovery rate has increased to 96.7 per cent.

"In the 4th week of May, 531 districts of the country were reporting more than 100 cases. In the 2nd week of June, it fell down to 262 districts. Right now, only 125 districts in the country are reporting more than 100 cases," Agarwal added. ANI
