t has been six months since Zahra passed her secondary school exams with the merit that hardly brought smiles on her parent's frown faces. She was supposed to choose a course for her undergrad studies but, so far, she hasn't.

What brought logjam in her academic trajectory is her parents' insistence that she appear in the entrance exam for either an MBBS degree or an engineering one.

But there was a minor hiccup.

She didn't want to go for a medical degree or an engineering one since her interests lie somewhere else entirely.

Zahra has always inclined to English Literature and



intended to pursue the same writing since I was in high going ahead. school and wanted to establish

"English as a language and the associated literary works myself in the same field." Her parents, however, seem have always fascinated me," to have other plans for her fu-Zahra says with a typical teen's ture, for which she has never futuristic dream. "I've been been on board.

"It's a strange thing that parents virtually decide everything for their kids out here, be their academic future or anything else," she says.

As Kashmir is currently grappling with the third straight year of campus closure, students like Zahra are finding their call in creative means, "like never before", to keep their sanity intact within weary walls.

Many of them have picked up writing, painting and other creative pursuits in a drawn-out discord situation, to give voice to their anguish and anxiety.

This is where many of these students today don't want to follow the traditional Medical or Non-Medical fields, as made mandatory by their parents since childhood.

Most of them now want to make their passion as their profession.

"And it makes sense too," says Arsilan Nisar, a Class 11 student, who last attended her normal campus class when she was Class 8th student. And that was on August 5, 2019, when New Delhi abrogated semiautonomous status of Jammu and Kashmir and plunged the region into the communication crisis. The unprecedented move shut schools overnight and made students captive within four walls of their home.

Since then, Arsilan has found her expression in poetry.

"I believe education should be pursued in realistic manner not through the make-believe concepts and constructs," she continues.



Study links excessive screen time to obesity in preteens

Parents, take note! A new study has found that children in the United States with greater screen time usage at ages 9-10 were more likely to gain weight one year later.

The findings of the study were published in the journal 'Pediatric Obesity'.

The study found that each additional hour spent on virtually all forms of screen time was associated with a higher body mass index (BMI) one year later. In particular, researchers found that each extra hour spent watching or streaming television, YouTube videos, video games, video chat, and texting led to a higher risk of weight gain one year later.

At the start of the study, 33.7 per cent of children were considered overweight or obese, and this increased to 35.5 per cent one year later, a proportion that is expected to rise in the late teens and early adulthood.

BMI is calculated based on height and weight. Researchers analyzed the BMI z-scores, which is relative weight adjusted for a child's age and sex, of 11,066 preteens who are part of the Adolescent Brain Cognitive Development Study, the largest longterm study of brain development in the United States.

The children answered questions about their time spent on six different screen time modalities, including television, social media, and texting.

"Screen time is often sedentary and

may replace time for physical activity. Children are exposed to more food advertisements and are prone to snacking and overeating while distracted in front of screens," said lead author, Jason Nagata, MD, assistant professor of pediatrics at the University of California, San Francisco.

"A negative body image and subsequent overeating may be a result of



"This study emphasizes the need for more research on how screen time impacts the well-being of young people now and in the future." added

benefits such as education and socialization during the pandemic, but parents should try to mitigate risks from excessive screen time including increased sedentary time and decreased physical activity. Parents should regularly talk to their children about screen-time usage and develop a family media use plan," concluded Nagata.





J&K Second Most Corrupt State: Survey

NEW DELHI - Kerala has emerged as the country's corrupt state while the dubious distinction of being the worst in this regard went to Bihar followed by Jammu and Kashmir according to global corruption watchdog Transparency international first state wise analysis.

The India Corruption Study 2005 conducted by Transparency International India (TII) land Centre for Media Studies (CMS) said Kerala, Himachal Pradesh. Gujarat, Andhra Pradesh and Maharashtra - in that order - were the least corrupt states.

The study had a sample of 14405 respondents in 15 cities and 306 villages across 20 States and covered 11 services including police, Judiciary, schools and public distribution system. While Kerala topped in all the departments. Bihar was the last, it said.

The national capital Delhi was ranked 11th in the least corrupt state preceded by Chhatlisgarh (6) Punjab (7), West Bengal (8),Orissa (9) and UltarPtadcsh(10).

Tamil Nadu was placed 12th followed by Haryana, Jharkhand, Assam. Rajasthan, Karnataka and Madhya Pradesh.

Jammu and Kashmir was placed very low at 19th position only to be followed In Bihar.

Full Withdrawal Imminent As Last Us Troops Leave Biggest Base In Afghanistan

wenty years after invading Afghanistan, US-led coalition troops have vacated the largest military base in the ancient city of Bagram, about 45 miles north of Kabul.

The sprawling airfield, which was once the epicenter of US military operations in Afghanistan, was on Friday formally handed over to the Afghan forces, according to media reports, quoting officials.

The massive airfield with two runways, 110 revetments, three large hangars, a control tower and many support buildings was the main entry point for tens of thousands of foreign troops that came to Afghanistan over the past 20 years. It was also the exit point for nearly 2,000 US service members killed in the fighting.

The base occasionally came un- the unprecedented spike in violence. der the target of Taliban attacks, which included suicide bombings and rocket attacks, putting at risk many residential areas in its vicinity. At its peak in mid-2011, nearly 100,000 US troops passed through the compound, apart from some 35,000 US contractors, which have

and 18,000 contractors. The full withdrawal of some 2,500 US troops from the country is expected to complete by mid or late July, ahead of US President Joe the war-torn country, located in Biden's September 11 deadline. It is the second time in recent

history that an invading army has come and gone through Bagram. The air base was built by the Soviet Union in 1950s. When it invaded Afghanistan in 1979 to back a communist government, it turned it into its main military base in the country.

For about 10 years, the Soviets fought the US-backed mujahedeen, whom then-US President Ronald Reagan called 'freedom fighters'. Some of them would later fight the US and become 'terrorists'.

The hushed departure of US and NATO forces from their most significant military base in the country comes amidst resurgence of the Taliban and

Experts see it as a symbolic victory for the Taliban, who have upped the ante in recent months, overrunning a large number of districts across the country. The quiet exit also signifies the defeat for US-led coalition forces after 20 years of occupation. Most NATO troops have already left

emony, in stark contrast to their dramatic emergence in 2001, when they lined up to back the US-led invasion. The coalition agreed in April to pull out its 7,000 forces from Afghanistan, and 19 countries have announced troop withdrawals totaling more then 4,800. Germany and Italy declared their missions in Afghanistan over on Wednesday and Poland's last troops have returned home.

The US military, however, is expected to keep about 650 troops in the war-ravaged country, on the pretext of protecting its large em-bassy in Kabul, while keeping the option of airstrikes open.

According to reports, Gen. Scott Miller, the top U.S. commander in Afghanistan, will fly out, and his role will be taken over by Marine Gen. Frank McKenzie, the top US commander for Middle East, who is based in Florida.

The new US commander in Afghanistan will be Navy Rear Adm. Peter Vasely, who will head the security mission at the US Embassy in Kabul, according to reports.

In his final press conference in Kabul earlier this week, Miller spoke at length about the deteriorating security situation in Afghanistan.

Pandemic Tourism: Thailand Launches Phuket 'Sandbox' Plan



PHUKET: Thailand embarked on an ambitious but risky plan on Thursday that it hopes will breathe new life into a tourism industry devastated by the pandemic, opening the popular resort island of Phuket to fully vaccinated foreigners from

lower-risk countries. As the first flight arrived, airport fire trucks blasted their wathe Etihad jet from Abu Dhabi as it taxied to its gate.

Leaving the airport, Frenchman Bruno Souillard said he had been dreaming for a year of returning to Thailand and jumped at the opportunity. I am very, very happy," the

60-year-old tourist said. The "Phuket sandbox" programme largest – where they can lounge comes as coronavirus infections are on the white beaches, jet ski and Thailand including a significant number of cases of the Delta variant, and many have questioned if it's too early to woo tourists back, and whether they'll come in significant numbers in any case due to the restrictions they'll still face. The fear and anxiety behind writing this op-ed to the American audience and pleading for every kind of cooperation with the US in Afghanistan (except military) is that Pakistan, after refusing to host US bases, risks losing strategic clout in Afghanistan and fears that it might be left to face a post-withdrawal potential civil war in Afghanistan alone. Islamabad seems to have noticed lately that its relationship with the US was based only on its military geostrategic importance to the latter vis-a-vis Afghanistan, Given Khan's explicit statement of not allying with the US on military action, Pakistan might lose its importance in US strategy. In a recent interview with The New York Times on 25 June 2021, the Prime Minister said that after the US pull-out Pakistan would want a "civilized relationship" with the US like that of "U.S. and Britain, or actually between U.S. and India right now". Further, when Khan was asked whether Pakistan will continue to have any strategic relevance to the US once the withdrawal is completed, Khan replied, "I don't know, really. I haven't thought about it in that way, that Pakistan should have some strategic relevance to the U.S. I mean, states really have relationships based on common interests." It points out a shift in Pakistan's vision towards its relations with the US. Instead of the geo-strategic, Islamabad now seeks to promote its geo-economic importance and wants broader relations with the US. This was evident in a recent interview on Geo News b у Imr a n

Khan's National Security Advisor (NSA) Moeed Yusuf, who while speaking about the absence of contact between President Biden and PM Khan emphasized that if there are talks between the two countries they must go beyond the Afghanistan issue and include bilateral relations-economic, trade and commerce.

The NSA further complained that despite Islamabad's significant contribution to Afghanistan, the Kabul civil government, the US and the world are pointing fingers towards Pakistan and blaming them for the violence in Afghanistan. In addition, as evident from the recent interviews of both the Pakistani Foreign Minister and the NSA, Islamabad has become wary and increasingly concerned of the recent 'active' Indian role in Afghanistan including New Delhi's overtures to the Taliban. However, there were early signs that these developments would take place in case Pakistan continued to follow its

relationship with the US and muted hostility with the latter in the form of denial of bases in the op-ed should also be seen as a response to and an implicit acknowledgement of increasing Chinese importance in Afghanistan. This acknowledgement of China over the US was also reflected in Khan's recent interview to China Global Television Network (CGTN) where he mentioned the 'very special relationship' spanning 70 years between Pakistan and China which won't be tampered despite 'Western (US) pressure' and in the same interview, the Pakistani PM also took a jibe at the US-led Quad including India as one of the major drivers of conflict and rivalry in South Asia.

Khan's statements from the op-ed such as Pakistan's readiness to be 'a partner for peace in Afghanistan' as well as appeals to the Afghan civilian government to 'stop blaming Pakistan' can be seen as attempts at bridging the chasm and deep mistrust of Kabul given Islam-

traditional strategy and the current path in Afghanistan. Therefore, Islamabad pted both, the blame for all the violence in Afghanistan and the entry of India into talks with the Taliban. Further, Pakistan's firm position on not hosting the US bases only exacerbates the issue. The US itself now seems less concerned about the situation in Afghanistan and as it pulls out its forces in haste, Pakistan is worried that it might be left alone to face an imminent civil war in Afghanistan. In case of a civil war, Pakistan will face a huge influx of refugees and therefore encounter economic instability once again. Another reason behind Khan's seeming displeasure with the US might be seen in the context of the growing strategic Sino-Pakistan relations. In addition to Pakistan's economic as well as military alliance and dependence on China, Islamabad's crippling 294 billion dollars debt to its all-weather ally (as of December 30, 2020) and with expectations and speculations of an increased role of Beijing in Afghanistan post-US withdrawal [given China's role in the Afghan peace process along with Russia and the US and Chinese indications of extending the China Pakistan Economic Corridor (CPEC) into Afghanistan] it would make sense for Pakistan to side with China. Hence, Imran Khan's costbenefit analysis of Pakistan's

abad's ties with the Mujahideen and Taliban since the Cold War era of 1980. But the emphasis on 'nartner also be seen as a response to India's intervention and humanitarian aid to Afghanistan and the confidence and goodwill enjoyed by New Delhi in the eyes of Kabul (something which Pakistan is seeking right now- hence 'stop blaming Pakistan'). In addition, the entry of India seems to have upset Pakistan's equation in Afghanistan. The 'India' connection with the op-ed becomes clear as it comes in the heels of (deliberately or coincidentally) Pakistan Foreign Minister Shah Mahmood Qureshi's interview with the Afghanistan channel Tolo News. In the interview, Qureshi mentioned 'India's seemingly oversized role ('larger ought than it to be') in Afghanistan

not being a border country and even went on to accuse New Delhi of 'carrying out terrorist activities' from Afghan soil. Although Qureshi later received flack for his un-diplomatic statements, vet the former's insecurities and Khan's insistence in the op-ed on winning the trust of Kabul can be seen as Pakistani concern of India's role and popularity in Afghanistan as a credible partner. This is evident in the reception of Indian aid in terms of providing vital supplies of food and medicines; infrastructural development, initiation of small and community-led development projects and in the field of education including 500 annual scholarships and training of Afghan civil servants. Yet in the strategic front including shaping the future of Afghanistan, India doesn't enjoy the position of other players like China, the US and Russia (including Pakistan) given its absence in the Doha peace talks with the Taliban and the Extended 'Troika' Statement of March 2021 (mentioned in the op-ed). Despite the above advantage enjoyed by Pakistan over India, the Op-Ed's insistence on winning back the trust of the Kabul government is an indication of the deep-seated suspicion about the Pakistan government in the eyes of the general Afghan psyche. This can be witnessed from the 2016 Congressional statement of US Special Representative for Afghan Reconciliation Zalmay Khalilzad who, while condemning Pakistan unequivocally as 'sponsors of terrorism' had stated- "We need to look at strengthening cooperation with India on terrorism and counterterrorism and on strengthening Afghanistan...it is not

ministration to seal the 2, 640 km Durand Line boundary with Afghanistan for 'safeguarding national interests' as well as preventing the influx of Pashtun refugees in the aftermath of a possible Taliban take-over. At the same time, Khan criticised the US withdrawal as one of the core reasons behind the increase in the Taliban's confidence. In addition, the Pakistani NSA labelled New Delhi's recent engagement with the Taliban as 'shameless'. While Pakistan had a historic role in the training of and strategic relations with the Taliban, yet the above actions and Khan's mention of Pakistani casualties indicate growing differences between the two 'convenient allies'. However, despite this antagonism, Khan's mention of the Talibani participation in Afghan governance is a sign of Pakistan's acknowledgement of the importance of its ally in the US postwithdrawal Afghanistan as well as a tacit attempt to pacify the militia group for the strategic safety of the Afghan-Pak border. In addition, the Pakistani military establishment (since the Zia ul-Haq era) and right-wing groups such as Tehreek e-Labbaik Pakistan (TLP) harbouring secret sympathies for the Afghan jihad i.e. two powerful sections united in their support for the Taliban would also deter Khan from taking any proactive actions against the Taliban (particularly right-wing groups would cheer for a complete Taliban victory in Afghanistan).

Finally, towards the end, the op-ed speaks of how peace fostered by economic and regional development would prevent the re-emergence of the 19thcentury Great Game situation in Af

Another interesting point in the op-ed is Khan's attitude towards the Taliban. Although the author recounts the civilian and military 'collateral damage' borne by Pakistan as a result of Islamabad's 'mistake by choosing sides between warring Afghan parties' , yet as per Khan the Taliban 'must be included in any (postconflict Afghan) government for it to succeed'. Such a conciliatory note must be contrasted by the decision made by the Pakistani adghanistan. But it would appear that the inconsistencies between Khan's opinions and Pakistan's strategic concerns and choices, tied with the US, China, India and Taliban would set the stage for a new Great Game West (borrowing from Bertil Lintner's Great Game East between India's North-East, China and Myanmar) of the 21st century.

'Keeping your friends close, makes cortisol levels low for life'

esearchers at the Beckman Institute for Advanced Science and Technology at the University of Illinois Urbana-Champaign determined that communicating with female friends decreases stress hormone levels for women across the lifespan.

The study, titled 'What are friends for? The impact of friendship on communicative efficiency and cortisol response during collaborative problem solving among younger and older women', was published in the Journal of Women and Aging.

Directing a meeting, dialling up an old acquaintance, dictating the perfect tuna salad sandwich across a drive-through window. For business and for pleasure, human beings are in constant communication.

Our proclivity for socialization is lifelong, equally prominent in the lives of adolescents and adults. A recent study determined key differences in the ways that various age groups communicate, as well as one conversational component that stands the test of time: friendship. Specifically, bonds between individuals who identify as female.

Led by former Beckman Institute postdoctoral researchers Michelle Rodrigues and Si On Yoon, an interdisciplinary team evaluated how interlocutors' age and familiarity with one another impacts a conversation, reviewing the interaction's overall effectiveness and stress responses generated as a result.

Two hypotheses form the foundation of this female-focused study. First, the tendand-befriend hypothesis, which challenges the traditionally masculine "fight-or-flight" dichotomy.

"Women have evolved an alternative mechanism in response to stress," said Rodrigues, who is currently an assistant professor in the Department of Social and Cultural Sciences at Marquette University. "In order to deal with stress, women can befriend female peers.

The team also tested the socio-emotional selectivity hypothesis, which postulates a social "pruning" as humans advance in age and pursues more intimate, higher-quality circles of friends.

The introduction of age as a variable is novel in the field and stems from an interdisciplinary Beckman collaboration.

"I was working with several different groups in several different disciplines, coming from the perspective of studying friendship but having previously done research on adolescent girls, but not older women," Rodrigues said

She combined forces with then-Beckmanpostdoc Si On Yoon, who was studying the cognitive mechanisms of natural conversation across the lifespan, including healthy younger and older adults.

"My research program was focused on language measures in social interactions, and I was glad to work with Dr Rodrigues to develop an integrative approach including both language processing and physiological measures to study social interactions," said Yoon, who is currently an assistant professor in the Department of Communication Sciences and Disorders at the University of Iowa.

The interdisciplinary team merged both theories into a single query: Across women's lifespans, how are the tendencies to "tend and befriend" as well as socially select reflected

"A referential communication task like this requires that you see where the other person is coming from. It seems like the younger adults are a little more hesitant in trying to do that, whereas the older adults have an easier time doing that with strangers," Rodrigues said.

This was not predicted based on the socio-emotional selectivity hypothesis, which anticipated a correlation between age and social isolation.

"Even though older adults choose to spend more time with people who matter to



in their communication?

They tested a pool of 32 women: 16 "older adults" aged 62-79, and 16 "younger adults" aged 18-25. Each participant was either paired with a friend (a "familiar" conversation partner) or a stranger ("unfamiliar").

The partnerships underwent a series of conversational challenges, wherein the participant instructed her partner to arrange a set of tangrams in an order that only the former could see. The catch? Each shape was abstract, their appearances purposefully difficult to describe

"You could look at one [tangram] and say, 'This looks like a dog.' Or, you could say, 'This looks like a triangle, with a stop sign, and a bicycle wheel," Rodrigues said.

This exercise helped quantify each conversation's efficiency: partners who achieved the desired tangram arrangement in fewer words were considered more efficient, and pairs who needed more words to complete the task were considered less efficient.

The researchers found that while the younger adult pairs communicated more efficiently with familiar partners than their older counterparts, they communicated less efficiently with unfamiliar partners; alternatively, the older adults demonstrated conversational dexterity, quickly articulating the abstract tangrams to friends and strangers alike.

them, it's clear that they have the social skills to interact with unfamiliar people if and when they choose to," Rodrigues said.

Rodrigues' team also measured salivary cortisol to quantify and compare participants' stress levels throughout the testing process

"When you experience something stressful, if you have a stress response system that's working as it should, the result is an elevated amount of cortisol, our primary stress hormone, which then tells our bodies to release glucose into our bloodstreams," she said.

"That's reflected in our saliva about 15 to 20 minutes after we experience it. If we see a rise in salivary cortisol from an individual's baseline levels, that indicates that they are more stressed than they were at the time of the earlier measurements," she added.

Across both age groups, those working with familiar partners had consistently lower cortisol levels than those working with unfamiliar partners

"A lot of the research on the tend-and-befriend hypothesis has only focused on young women, so it's great to have these results that pull that out to the end of life. We can see that friendship has that same effect throughout the lifespan. Familiar partners and friendship buffer stress, and that's preserved with age," Rodrigues said.

Ranatunga Criticises SLC For Hosting 'Second-String Indian Team'

COLOMBO: Sri Lanka's World Cup-winning former captain Arjuna Ranatunga has slammed the country's cricket board for agreeing to host a "second-string Indian team" in a white-ball series later this month, saying it is nothing short of an "insult"

India and Sri Lanka are due to compete in three ODIs and as many T20 Internationals beginning July 13.

With India's major stars like skipper Virat Kohli and his limited-overs deputy Rohit Sharma in England for an upcoming Test series, the team here is being led by opening batsman Shikhar Dhawan and features half a dozen uncapped players.

This is a second-string Indian team and their coming here is an insult to our cricket. I blame the current administration for agreeing to play with them due to television marketing needs," Ranatunga, a government minister until two years ago, told reporters at his residence.

"India sent their best team to England and sent a weaker side to play here. I blame our board for that," added the legendary batsman, who led Sri Lanka to the 1996 ODI world title.

The visiting team has just completed its compulsory quarantine and would play the home team in the first ODI on July 13.

India's National Cricket Academy chief and celebrated former captain Rahul Dravid is the head coach for the tour.

Ranatunga also spoke about the current poor run of the Lankan team in the international arena.

Sri Lanka lost their fifth T20 series in a row when they went

down 3-0 to England last month. They were also forced to send back three senior players from the ongoing tour of England for breaching bio-bubble protocol.

Ranatunga said the lack of discipline was also the fault of the administration and when he was at the helm, he did not allow any misconduct.

He demanded the overhauling of the local administration and advocated the appointment of an interim committee to manage Sri Lanka Cricket (SLC). It was only in mid May that the current SLC administration was elected.

Ranatunga was the head of an interim committee politically appointed in 2007-08.

Indian Team Undergo First Training Session

The Indian cricket team on Friday underwent its first training session ahead of the limited series against hosts Sri Lanka from July 13. India, who have picked a secondstring squad for the series with the Test team currently in the UK, had arrived in Sri Lanka on Monday following which the players quarantined in their room for three days.

The side is being led by senior batsman Shikhar Dhawan and coached by NCA head Rahul Dravid. The series is India's last before the T20 World Cup in October-November. The squad has as many as six uncapped players including Chetan Sakariya, K Gowtham, Nitish Rana, Devdutt Padikkal, Varun Chakaravarth and Ruturaj Gaekwad.

It is also an important assignment for the likes of Prithvi Shaw, Ishan Kishan, Sanju Samson and Suryakumar Yadav who are looking to secure their place in the World Cup squad. India play three ODIs and as many T20Is.

PCB Central Contracts: Babar, Hasan In 'A' **Category, Hafeez Left Out**

KARACHI: Senior players like Muhammed Hafeez and Haris Sohail were left out of a list of 20 Pakistan players who were awarded central contracts by the country's cricket board with a 25 per cent hike in annual retainership.

Captain and top batsman Babar Azam, Hasan Ali, Mohammad Rizwan and Shaheen Shah Afridi were placed in the highest bracket of Category A.

The board, however, did not disclose the exact amounts to be paid to the players.

Those missing out included Hafeez, who was offered a mid vear contract early this year. Sohail. Asad Shafiq, Muhammad Abbas, Imad Wasim and Shan Masood. Seniors like Wahab Riaz and Shoaib Malik still remain out of

the list like last year. Interestingly the PCB has also dropped young batsman, Haider Ali and fast bowler Naseem Shah from the contracts list in the emerging category. The PCB announced an across-the-board 25 per cent increase in the monthly retainers for all four categories.

The board said it was announcing an enhanced and performance-based central contract list for 2021-22 for 20 elite men cricketers in which match fee across all formats has also been equalised.

A Board official explained that previously, match fees of players differed in different categories in all formats based on seniority.

"But now that has been changed. Increases have been made in match fees of B, C and emerging categories in Test, ODI and T20 formats so that now all players get the same fees," the Board stated.

The 12-month contracts will run from July 1, 2021 to June 30, 2022. The wide ranging increases announced for the contracted players include:

In Category A there would be no increase in Test, ODI and T20I match fee, while in Category B Test match fee has been increased by 15 per cent, ODI match fee increased ov 20 per cent and T20I match fee

increased by 25 per cent.

In category C, the board has announced a 34 per cent increase in Test match fee, 50 per cent increase in ODI match fee, and 67 per cent increase in T20I match fee.

The remuneration in Emerging Category has been increased by 15 per cent, with 34 per cent increase in Test match fee, 50 per cent increase in ODI match fee, 67 per cent increase in T20I match fee.

PCB Chief Executive Wasim Khan made it clear that selecting 20 players from a big pool of quality cricketers is always a challenging task.

"In the new list, we have seen eight new players emerge who have now gained central contracts. Due to the competitive nature of the central contract system nine players who had contracts in 2020-21 have sadly missed out on this occasion." he said.

"The door remains firmly open for these players and they will continue to remain in the plans of the selectors.

"The equalisation of match fees means that all players who walk out together to represent Pakistan will receive the same match fees irrespective of which category they are in, or whether they have a central contract or not," he said.

The board said the list was finalised by a panel that comprised Director - International Cricket, Zakir Khan, chief selector Muhammad Wasim and Director -High Performance, Nadeem Khan, who also consulted head coach Misbah-ul-Hag and captain Babar Azam as part of the process.

Sha'Carri **Richardson To Miss Tokyo Olympics After Positive** Marijuana Test

EUGENE: American sprinter Sha'Carri Richardson has accepted a one-month suspension after testing positive for cannabis, the United States Anti-Doping Agency said on Friday, ruling her out of the 100 metres in Tokyo although she may yet be able to run in later relay events.

The positive test came at the U.S. Olympic trials last month where Richardson established herself as a gold medal contender by winning the 100m in 10.86 seconds.

"The rules are clear, but this is heartbreaking on many levels; hopefully, her acceptance of responsibility and apology will be an important example to us all that we can successfully overcome our regrettable decisions, despite the costly consequences of this one to her," USADA CEO Travis Tygart said.

Richardson said in an NBC Interview on the Today Show on Friday that her action came during the trials while she was dealing with the news of the death of her mother.

"Like I tweeted yesterday, I'm human. We are human, I want to be as transparent as possible with you guys whether it's good, whether it's bad," the American sprinter said.

"But when it comes to Sha'Carri Richardson there will never be a steroid attached to the name Sha'Carri Richardson. The charge and what the situation was marijuana.'

Euro 2020: England Aim To Cope Without Home Support Against Ukraine

ROME: Having overcome historic rival Germany in the last 16, facing Ukraine might seem like an easier proposition for England.

Turns out, though, that Saturday's quarterfinal match at the Stadio Olimpico might be England's toughest test of the European Championship.

That's because it's the only match of Euro 2020 that England will have to play away from the friendly confines of Wembley Stadium.

Making matters more complicated is that the Italian government has explicitly warned Britain-based England fans to stay away from the game unless they can prove they have observed five days of quarantine since arriving.

For a team like England that is known for its traveling supporters, that's a major blow.

"We've got to create our own atmosphere on Saturday in Rome, which we're capable of doing," said England goalkeeper Jordan Pickford, who has kept four clean sheets in the tournament. "The fans were tremendous the other night and throughout the group stages as well. I think that gives us added motivation for the game on Saturday to come back for a semifinal with 60,000 fans."

The winner between Ukraine and England will play either Denmark or the Czech Republic in the semifinals on Wednesday at Wembley, with the final also scheduled for England's home stadium.

For Ukraine's coaching staff, meanwhile, playing in Italy is a homecoming.

Head coach Andriy Shevchenko was one of Serie A's most prolific scorers during his playing career with AC Milan, while assistant coach Mauro Tassotti is from Rome



and began his playing career at the Stadio Olimpico with Lazio before going onto a long and successful career at Milan as both a player and assistant coach.

"If the Italians support us because we're the weaker team that's absolutely fine," Tassotti said. "I'm really hoping the fans give us some big support." Still, Tassotti acknowledged that beating England is a "titanic challenge."

"But we've seen what happened over the past few days with the Netherlands and France," Tassotti told the Gazzetta dello Sport. "England has enormous talent but they've also had the advantage, like other nations, of

playing only at home." Expect an old-fashioned Italian "catenaccio" (lockdown defense) and counterattack approach from Ukraine to deal with talented England strikers Raheem Sterling and Harry Kane, who accounted for the goals in the 2-0 win over Germany. Tassotti said the tactics will be to "stifle" England, "close spaces," and

"prevent them from running." "Those are the types of matches they don't like. They've got talent but we've got to try to force them to

think as much as possible and only then take advantage of our talent,' Tassotti added. "If we think we can play them straight up considering all the talent that they have, we won't go very far."

If Ukraine can get into the opponent's half, the attack should flow through Andriy Yarmolenko, who plays in England for West Ham.

Likewise, Oleksandr Zinchenko is teammates with Sterling at Manchester City.

Having barely scraped through the group phase, it will be Ukraine's first European Championship quarterfinal match.

England is looking to match its performance from the 2018 World Cup, when it reached the semifinals. The last time England made it to the last four of the European Championship was in 1996. But the bigger goal for England at this point is to duplicate the success of the 1966 team that won the World Cup and lifted the trophy on home soil.

"We just need to be on our A game," Pickford said. "We know it's going to be a tough game. Every game is tough so we'll be ready."

Indian Wrestler Sumit Malik Gets 2-Year Ban For Doping

NEW DELHI: His hopes of competing in the Olympics over, Indian wrestler Sumit Malik was on Friday banned for two years by the sport's world governing body UWW after his B sample also returned positive for a prohibited stimulant.

The 28-year-old has one week to decide if he would accept the sanction or challenge it.

Malik was handed a provisional suspension last month for failing a dope test during the World Olympic Qualifier event in Sofia, where he had qualified for the Tokyo Games in the 125kg category.

His 'B' sample was opened on June 30 and expectedly that also provided the same result.

A specified substance was found in Malik's sample, though, the 2018 Commonwealth Games gold-medallist had told PTI that he only took painkillers to manage right knee niggle.

"Sumit Malik's B sample has given the same result and the UWW has banned him for two years from June 3. He has a week to respond. He can call for a hearing or accept the sanction," a

source in the Wrestling Federation of India (WFI) told PTI. Sources close to Rohtakbased Malik said they will soon

take a decision. "We are discussing the matter with our lawyer," said the person who is interacting with Malik on the matter.

The general opinion in WFI is that Malik should challenge the sanction since it was not a steroid but a stimulant that was taken inadvertently.

Malik has been nursing a knee injury that he suffered during the national camp before the Olympic Qualifiers began at different venues.

He had competed at the Asian Qualifiers in Almaty in April but did not succeed in earning the quota. He then competed at the Asian Championship at the same venue and returned medal-less.

However, at the World Olympic Qualifiers in Sofia held in May, Malik earned the quota by reaching the final, which he for-

feited due to the same injury By the time hearing takes place and a verdict comes out, he would miss competing at the Olympics.

Toni Kroos Announces **Retirement From** International **Football**

BERLIN: Germany midfielder Toni Kroos has announced his retirement from international football after his team's exit from the European Championship, the 31-year-old said on Instagram. The 2014 World Cup winner earned 106 caps for his country, contributing 17 goals and 19 assists.

Kroos said it was clear to him "for a long time" that he would not be available for the World Cup in Qatar next year. He said his priority now would be to focus on his club career with Real Madrid and spending time with his family.

He identified the slain militants as Lashkar's district commander Nishaz Hussain Lone alias Khitab of Tral, Danish Manzoor Shiekh of Kakapora, Amir Wagay of Hanjan Payeen, Mehran Manzoor of Jamalata Srinagar and a Pakistani militant Abu Rehan alias Tawheed.

He said that the slain LeT commander was active since 2018 and all the killed militants were part of groups involved in many militancy cases and civilian atrocities.

The police spokesperson also claimed recovery of arms; ammunition and other incriminating materials were recovered from the site of encounter, including an SLR rifle which was snatched by militants in the year 2016 from guard of TV tower in Lower Munda

"All the recovered materials have been taken into case records for further investigation and to probe their complicity in other crimes," he said.

"In this connection police have registered a case under relevant sections of law and investigation has been initiated. People are requested to cooperate with police till the area is completely sanitized and cleared off of all the explosive materials, if any," he added.

The police spokesperson also quoted IGP Kashmir congratulating Police and central forces for the big success and conducting successful operation in professional manner.

Army Chief Gen MM Naravane on Thursday said that the easy availability of drones has increased the complexity of security challenges from both state and state-sponsored actors.

BSF Opens Fire

Drones were spotted hovering over vital Army installations in different areas of Jammu during night hours on Monday, Tuesday and Wednesday as well.

While the Army said it thwarted a drone activity on its brigade headquarters at Kaluchak and Ratnuchak during the intervening night of Sunday-Monday, it neither confirmed nor denied the movement of drones over its military stations at Sunjwan, Miran Sahib, Kaluchak and Ratnuchak during the subsequent days. of that country, is strongly suspected to be behind it, Jammu and Kashmir Police chief Dilbag Singh said on Friday.

Singh said the use of armed drones by Pakistan-based militants is a very serious threat to the security system and there was a need to have a relook at the security of vital places and persons.

"We have got very serious and strong suspicion that LeT is involved in this case.... Since LeT is involved and the outfit is run from Pakistan, so in a way Pakistan's involvement cannot be ruled out," the police chief told reporters on the sidelines of a function in Kathua district. "It is very much possible that it (drone) has come from across but other angles would also not be ruled out at this stage, he said.

In response to a question about the threat posed by the use of armed drones, Singh said it is a very serious threat to the security system.

Under the international protocol, this kind of activity is not supposed to be taking place but if it has started and some militant outfits are involved in this, it poses a serious threat. We have a relook of the security of the vital places and important persons. The threat does not respect the parameters of the security, he said.

A statement from the delimitation commission had earlier said that during the visit, it will interact with political parties, public representatives and Union Territory administration officials including district election officers/deputy commissioners of 20 districts to gather first-hand information and inputs concerning the ongoing process of delimitation as mandated under the Jammu and Kashmir Reorganisation Act, 2019.

It had said that the commission expected that all stakeholders will "cooperate" in this endeavour and provide valuable suggestions so that the task of delimitation is completed timely.

Once the delimitation exercise is completed, the number of assembly seats in Jammu and Kashmir will go up from 83 to 90.

Twenty-four seats of the Assembly continue to remain vacant as they fall under Pakistan-controlled Kashmir (PcK).

Creative Pursuits

"Thing is, we're witnessing an overwhelming situation in Kashmir where attempts are being made to alter our reality. Under these circumstances, expecting us to pursue the normalized careers is a bit unfair. Most of us were never brought up in normal circumstances – no matter how hard our parents try to make certain careers charming or compulsory for us."

The murmurs regarding this shift started last year when pandemic made many Kashmiris wonder— "Don't we've any scientist who could rise to the occasion when parents make Science a do-or-die career choice for children since childhood in Kashmir?"

This online noise soon translated on the ground where many students questioned their "delusional" schooling and forced career choices.

But now, much of that is changing. Inside his home atop hillock in a South Kashmir village, Amaan, who lately graduated his secondary school, is currently looking for a change.

A voracious reader and believer in the platonic school of thought, he had his eyes set on a course in Philosophy at Tata Institute of Social Sciences. Still, his father, an employee with the civil secretariat, had something else in mind for him.

Coming from a family that has churned out mostly doctors and civil servants in the past decade, Amaan had little to no choice in choosing his future course. The subdued light in his room, more or less, represents his current state of mind.

"I understand change is not a cakewalk," the teenager said with grave expressions.

"It never was—until someone decided to be a difference maker. I believe the decision I've taken need a strong backup of nerves and resilience. But come what may, I'm up for it, for the sake of my passion." Although this 'lettered spirit' is

nothing new in Kashmir, the tribe of passionate learners is apparently growing today. "At the end of the day" says Amaan out of life. She survived, she says, because hemlock wasn't available.

Mindful of these "pulverized passions" and "brink brains", Dr. Iftikhar Bhat, a child psychologist, is involved in an extensive research project looking into the modalities and nuances of the parental psyche in Kashmir.

He's trying to find out what factors coerce the kids into choosing one kind of a major which will land them a cushy, well-paid job and "staying away" from the ones that won't.

"Kashmir is no different a place when it comes to parents dictating career choices to their kids," Dr. Iftikhar said.

"Ours is a lamina of the South Asia as a whole but, we can notice a gradual decrease in parental interference regarding the kind of education their kids choose in other parts."

But in Kashmir, the child mental specialist said, parental career choice is still highly prevalent.

"The parents, in most cases, decide for their kids the kind of stream they choose," he continued.

"There is little to no academic agency with the kids when it comes to Kashmir. I believe we still are a few decades behind, putting to shame the times Galileo lived in, when accepting the changes in the world in general and the academic ecosystem specifically."

This has led to a repressed psyche among the younger generation, he said, where the lack of agency has created a mental chasm within them. The ugly offshoot of this burdened

mindset, many believe, is the suicidal tendencies among students—some of whom took their own lives during the second viral wave in the valley.

About the rising trajectory of suicides in the younger generation of the valley, Dr. Iftikhar said, "It's natural that when an individual feels repressed and believes he doesn't have a choice regarding his own matters, so he will tend to look for some way out. We've seen in many cases. To end the feeling of helplessness and misery, one chooses to go for rather hardcore egresses. It's a classic case of feeling a smidge of control in life by taking control of one's end."

One of the reasons for this situation, said academic Dr. Shahid Mantaqi, is the schooling system which over the time has been rather rigorously transformed into an investment for the future.

"The caveat is, the future being secured is of the parents and not the kids," Dr. Shahid said. "A kid securing a good job is an insurance policy and a point of prestige for the parents."

The aspirations and the ambitions of the children aren't given much thought to, or are often derided, the academic continued.

"This has led us to a quagmire and a psychologically despotic and corrupt education system for our kids," he said.

"In my three decades of experience as a teacher and academic consultant, I've come across kids who dropped out because their parents wanted and expected something else from them. In even worse cases, some of my students attempted to kill themselves. There is hardly any semblance of imparting knowledge We need to enforce the rule with a clear plan, besides communicating the same to all the stakeholders," the

To what extent Pakistani agencies are involved would be known only when the investigation proceeds further, he added.

The National Investigation Agency (NIA) has taken over the investigation into the first-of-its-kind drone attack on the Indian Air Force (IAF) station at Jammu airport on June 27.

Two bombs were dropped from drones, causing minor injuries to two airmen. The first blast ripped off the roof of a single-storey building at the technical area of the Jammu airport manned by the IAF. The second one was on the ground. A cocktail of explosive material, including RDX, is believed to have been used.

Referring to the seizure of a 5.5-kg improvised explosive device (IED) in Jammu hours after the twin blasts at the IAF station, Singh said, "They were planning to trigger an explosion at a crowded place with the aim to cause the largest possible casualties. But luckily we were able to intercept and capture the fellow (militant) who gave certain leads and we were able to recover the IED and avert a major militant attack."

The Director General of Police (DGP) said over a dozen incidents had taken place earlier wherein the LeT was involved in dropping weapons, ready-made IEDs and narcotics using drones.

Asked whether the recovery of the IED and the IAF bombing are linked, he said, I would not be able to say at this point of time that the two are connected. But we are trying to prove if there is any linkage.

The DGP said it is very much possible that the drones came from across the border.

"In the earlier drone droppings, the drones covered a distance of 10 to 15 km and the aerial distance of the Jammu airport (from the international border) is not more than that. The particular route which is suspected to have been taken by the drone if it had come from across also comes within the range of 15 km, he said. This issue has come into my notice and I have written to the state branch," he said.

In a series of tweets after a threeand-a-half-hour-long meeting with the leaders that included four former chief ministers, the prime minister said, "Our priority is to strengthen grassroots democracy in JK. And now, when most of the youngsters are being hailed as role models for creating their own identities in liberal arts, Amaan is sure that more and more students will be setting themselves free from the clutches of certain coerced careers.

However, before this academic resistance, students from the valley were mainly pushed towards majors that are likely to provide financiallysecure futures and are considered "respectable professions", or courses that provide one with enveloped and padded ends.

Upon graduating from high school and secondary school levels, it's believed that parents play a significantly imposing role in deciding for their kids what majors they have to opt for.

On an annual basis, an average of 5000 students from a mixed bag of majors graduate from various higher education institutes in the valley. Out of the said numbers, about 25 per cent of the students drop out of opting for any further education, a worrying trend in itself, but the underlying reason is more worrisome.

Conversations with students coming from different backgrounds help one understand to what extent the parents in the valley influence or decide the academic futures of their kids.

The discussions with the representative sample of the student populace in the valley, more or less, establish the fact that parents have a relatively more immense or decisive influence on the academic paths their kids opt for. This academic "coercion" ends up creating its own issues for students.

So far, Sadia, a Kashmiri student in her early twenties, has made two attempts on her life in three years.

After graduating from secondary school, she wanted to go for a course in Humanities for her undergrad studies. But she was met with a blunt denial from her parents and was forced to opt for a science course.

Unable to cope with the excessive stress and anxiety, she chose to opt

based on one's aptitude."

Dr. Shahid advocates for an aptitude-based learning mode starting from high school levels to promulgate better education methods.

"We need to rectify this system of ours at the earliest," he said. "We have to encourage parents to constantly interact with their kids to let the academic decisions be as informed and fitting as they can be. Our kids also need to indulge their psyches to understand their intellectual leanings better and make primed decisions."

At her home, Zahra often pours her heart out on paper these days. Apart from penning what she calls "allweather woe" of her homeland, she writes her own pathos while following her passion.

But she mostly writes about hope and its magical power.

"Things take time to shape up," she says. "Till they do, one has to stay patient and persistent."

Germany Recommends Combining AstraZeneca, **mRNA Shots**

ermany is recommending that all people who get a first shot of the AstraZeneca coronavirus vaccine switch to a different type of vaccine for their second shot.

The aim is to increase the speed and effectiveness of vaccinations as the more contagious Delta variant spreads.

Health Minister Jens Spahn conferred with his colleagues from Germany's 16 states on Friday, the day after the country's standing committee on vaccination issued a draft recommendation.

In a statement, the committee said "according to current study results", the immune response from a mixture of AstraZeneca with an mRNA vaccine was "significantly superior" to that from two doses of AstraZeneca.

It recommended that the second dose with an mRNA vaccine -Germany uses those made by BioNTech-Pfizer and Moderna – be administered four weeks or more after the first AstraZeneca shot.

That is much shorter than the nine to 12 weeks the committee recommends between two doses of AstraZeneca

German Chancellor Angela Merkel, who is 66, recently received a second shot of Moderna's vaccine after taking the first shot of AstraZeneca.

Her spokesman said that was a conscious effort to encourage people not to be afraid if they are advised to get a mix of shots.

The committee, known by its German acronym STIKO, did not detail what studies its conclusion was based on.

Germany's disease control centre noted that it was a draft, and that a final recommendation with more detail and sourcing will follow.

Earth's Cryosphere Shrank By 87,000 Sq Kms Per Year In Last 37 Years

BEIJING: The global cryosphere -- all the areas with frozen water on Earth -- shrank by about 87,000 square kilometers per year on average between 1979 and 2016, as a result of climate change, according to a new study.

The extent of land covered by frozen water is just as important as its mass because the bright white surface reflects sunlight so effectively, cooling the planet. Changes in the size or location of ice and snow can alter air temperatures, change the sea level, and even affect ocean currents worldwide.

The researchers from Lanzhou University in China calculated the daily extent of the cryosphere and averaged those values to come up with yearly estimates. While the extent of the cryosphere grows and shrinks with the seasons, they found that the average area covered by Earth's cryosphere has contracted overall since 1979, correlating with rising air temperatures. The new study is published in Earth's Future.

Pregnant Women In India Now Eligible For COVID-19 Vaccination

regnant women in India are now eligible to get vaccinated against COVID-19 with the union Health Ministry on Friday giving the approval based on recommendations of the National Technical Advisory Group on Immunization (NTAGI).

The decision empowers pregnant women to make an informed choice on taking the Covid vaccination, the ministry said, adding these women can now register on CoWIN or walk-in to the nearest Covid vaccination centre to get themselves inoculated. The decision has been communicated to all the States and union territories to implement it under the ongoing National Covid Vaccination Program, it said in a statement.

India's Covid vaccination program incorporates recommendations of the foremost experts in the field of immunization, public health, disease control and information technology. Based on scientific and epidemiological evidence, the programme gives priority to strengthening the country's healthcare system by protecting the professionals, health and frontline workers, manning it, as well as protecting the most vulnerable population groups, the ministry said. Till now, all groups except

pregnant women were eligible for Covid vaccination. Now, it is expanded to even pregnant women in the world's largest immunization drive, the statement said.

Covid infection during pregnancy Studies have shown that Covid infection during pregnancy may result in rapid deterioration of health of pregnant women and they are at an increased risk of severe diseases and it might affect fetus too, it said. The matter has been examined

by domain knowledge experts based on the evidence that indicate that pregnant women are at an increased risk for severe illness from Covid compared to nonpregnant women in case they get infected. "Further, pregnant women with COVID-19 infection are at an increased risk for preterm birth and other adverse pregnancy outcomes including higher chances of neonatal morbidity. Additionally, the experts have also highlighted pre-existing co-morbidities, advanced maternal age, and high body mass Index as factors for severe COVID-19 in pregnancy," the statement said

The NTAGI has recommended vaccination for pregnant women. The National Expert Group on Vaccine Administration for CO-VID-19 (NEGVAC) too has unanimously recommended it. Further. a national level consultation on Covid vaccination for pregnant women was also convened by the health ministry to build consensus on Covid vaccination of pregnant women. The consultation unanimously welcomed the recommendation of NTAGI to vaccinate pregnant women. The consultation included professional bodies like FOGSI, representatives of state governments, CSOs, NGOs, Development Partner agencies, technical experts etc.

The ministry has accepted these recommendations and prepared an operational guideline for vaccination of pregnant women, counselling kit for medical officers and frontline workers, and information education communication material for general public to equip the states and union territories to carry out the vaccination of pregnant women.

Pregnant women, who opt for vaccination, can be inoculated with Covid vaccines available in the country any time during their pregnancy at the nearest government or private vaccination centre after registration on CoWIN or by walk-in registration at the nearest centre, the statement said.

The procedures and modalities like registration, generation of certificates after vaccination etc. will remain the same as it is for any beneficiaries above 18 years of age under the Covid vaccination programme, it said.

tion of underground tunnels with innovative technological solutions. "So far, after a lot of efforts, we have not been able to find a solution to identify and detect tunnels from above the ground. So, this is one challenging area where we have to work." the DG said.

According to data, 17 such structures have been detected by the BSF along the Pakistan border area in the last two decades.

Asthana said another vital area of

communication systems and mobile telephony solutions for its troops who are deployed in remote areas "characterised by difficult and undulating terrain that include long stretches of shadow area where there is no communication."

"There are so many areas in the west and east particularly in the north-east where we feel difficult to communicate particularly the troops cannot communicate with their family members through mobiles or any other technology," he said.

Asthana shared a personal experience of staying at a BSF post located in a shifting sand dunes desert area of Rajasthan where there "was no mobile communication for full 24 hours but had only wireless communication.

The BSF chief assured the participants of the hackathon that it will provide them all logistical support when their analysts and engineers visit a forward area and said "any product found suitable will be explored for procurement on trial basis...

Drone Spotted Over Indian Mission In Islamabad; India Lodges Protest

drone was spotted over the Indian High Commission Complex in Islamabad late last week, prompting India to lodge a strong protest with Pakistan over the incident, people familiar with the development said on Friday.

A day after the attack on the Air Force station attempts to target the Ratnuchak-Kaluchak military station in Jammu with drones was thwarted by soldiers.

High Court Refuses To Stay Proceedings In Sedition Case Against Lakshadweep Filmmaker

KOCHI: The Kerala High Court today refused to stay further proceedings in the sedition case registered against Lakshadweep filmmaker Ayesha Sulthana.

Considering a plea filed by Ayesha Sulthana seeking to quash the FIR or police case registered against her by the Kavaratti police, the Kerala High Court said investigation in the case was in a preliminary stage and more time may be required for completing the probe.

Refusing to stay further proceedings in the case, the court directed the Lakshadweep administration to provide details of the investigation.

When the matter was taken up,

the counsel for the administration opposed the plea, submitting that

A case was registered on June 9 under Section 124-A (sedition) and 153 B (hate speech) of Indian Penal Code on the basis of a petition filed by a political leader from Kavaratti.

Last week, the Kerala High Court had granted anticipatory bail to Ayesha Sulthana in the sedition case.

Granting bail, Justice Ashok Menon had said there was no apparent indication in her statement, which amounts to imputations or assertions prejudicial to the national interest, nor does it propagate any class of persons against another group of persons

Those who did not pre-register for the game can simply head to the Google Play store and download the complete game.
