SRINAGAR: Jammu and Kashmir on Monday recorded six COVID-19 deaths and 274 fresh cases, taking the number of fatalities and infections to 4,343 and 3,17,250 respectively, officials said

Out of the new cases, 113 were reported from Jammu and 161 from Kashmir, they said.



Reasi district recorded the highest number of cases at 72 all travellers, followed by Srinagar at 53, they added.

The number of active cases has dropped to 3,774 in the union territory, while 3,09,133 patients have recovered from the infection so far, according to the officials. • More On P6

SRINAGAR: Amid the recent controversy over interfaith marriages in Kashmir, a delegation of Sikh activists led by a prominent businessman of Srinagar, met Union Home Minister Amit Shah at his residence in New Delhi and sought his immediate intervention

to prevent 'imminent large scale migration' of Sikhs from Kashmir Valley.

While hailing the repeal of Article 370 and enactment of the Citizenship Amendment Act (CAA), the delegation of Sikhs led by Baldev Singh Raina, Chairman All Sikh Gurdwara Management Committee, also extended an invitation to Sikhs and Hindus from outside India to settle in the Kashmir valley.

Heaping praise on BJP leadership for abrogation of Article 370, Raina presented a four page letter to Home Minister which read: "A dawn has begun-a terror free and corruption free state which you

promised has already started. Sir we are proud Sikhs of the Valley with a heritage which is forgotten by all successive cen-

tral and state governments." The letter by Raina, who also heads Peaks Auto, a Maruti dealership here listed nine demands for the "betterment and welfare of the community".

The meeting of Sikh delegation was confirmed by the Home Minister on his Twitter handle.

"Met a delegation from All Sikh Gurdwara Management Committee-Kashmir," posted on Twitter. "We Kashmiri Sikhs wel-

SRINAGAR: The Concerned Citizens' Group (CCG) led by former Union Minister Yashwant Sinha on Monday arrived on a three-day visit to Srinagar to assess the ground situation and to meet the leaders of mainstream political parties in the Valley.

Besides Sinha, who has been former Finance and External Affairs minister in the BJP government in the past, the other group members including Air Vice Marshall (Retd) Kapil Kak, Bharat Bushan, and Sushobha Barve (Executive Secretary of Centre for Dialogue and Reconciliation), arrived in Srinagar on Monday afternoon on a three-day visit. Another prominent member of the group Wajahat Habibullah could not make it to the Valley due to some personal reasons.

"We have been regularly coming to Kashmir. This time, we want to try and understand a little more about the prevailing situation on the ground. We have a number of meetings with political leaders tomorrow and a day after," Barve told Kashmir Observer.

"We will also meet the leaders of Gupkar alliance. We will hear from them more in detail about the Delhi meeting. We will also hear how they see the way forward," she added.

Among other mainstream leaders, the CCG delegation is likely to meet National Conference President Faroog Abdullah, People's Democratic Party (PDP) President Mehbooba Mufti, and CPI-(M) leader MY Tarigami. Besides it, the group will also

Mughal, Sinthan Roads Open For Traffic After Two Years

SRINAGAR: The historic Mughal and Sinthan roads, connecting Kashmir valley to Poonch-Rajouri and Chenab Valley regions respectively, were thrown open for vehicular traffic on Monday after remaining closed for nearly two years following the abrogation of Jammu and Kashmir's special status in August 2019.

"Light motor vehicles as well as heavy motor vehicles were allowed to ply on Mughal road on Monday. The road was reopened for civilian movement

after two years," an official said. The historic Mughal road connects Shopian in south Kashmir to Poonch and was the route used by the Mughal kings

to reach Kashmir.

The Sinthan-Kokernag road, which connects Anantnag district to Kishtwar, was also opened for civilian traffic.

The roads were closed on August 4, 2019 as a precautionary measure as the Centre abrogated Article 370 that provided special status to Jammu and Kashmir while bifurcating the then state into two union territories.

The opening of the roads comes four days after Lieutenant Governor Manoj Sinha made an announcement to this effect.

"In the past few days, many delegations from Rajouri, Poonch, Kishtwar, Doda met me. Today, we've decided that Mughal Road and Sinthan Road will be opened for the common public from • More On P6







Country-Wide Security Alert

NEW DELHI - An alert was sounded today in major capitals and sensitive towns across India following the terror attack on the makeshift temple in Ayodhya this morning. Security was particularly tightened around important temples and other place, if worship across the country in view of the targeting of the makeshift shrine where once the Babri Masjid structure stood and the possible repercussions it may have.

In Delhi, security was beefed up near the temples and the RSS headquarters in Jandewalan area in a crowded area in the central part. Additional personnel of police and para-military forces have

been mobilised in Delhi and patrolling has been intensified. In Mumbai, the scene of serial blasts and riots after the December 1992 demolition of the disputed structure in Ayodhya,

security was beefed-up. "We have taken special measures outside temples and other religious places in the city following the the Ayodhya incident, Police Commissioner A N Roy, said.

Additional forces have been deployed at prominent temples and other places of worship. Security has also been beefed up an the Department of Atomic Energy (DAE) installations across the country, Chief Security Officer of DAE N C Gop, said.

Security was also alerted across West Bengal with special emphasis on communally-sensitive areas. In Surat, where the RSS is holding a conclave, a security cor-

don was thrown around the venue of the meeting. A high alert was also sounded in the Char Dham shrine circuit comprising Badrinath, Kedarnafh, Yamunotri and Gangotri m Uttaranchal and Krishna Janamabhoomi. "Our police force has been put on high alert," Deputy Inspector General of Police

R Singh Meena, said in Dehra Dun. Police have been asked to be on patrol day and night in Badrinath temple area as it is one of the famous shrines in Uttaranchal, he said. Uttaranchal is attracting hundreds of pilgrims as the Chardham Yatra is going on.

Afghan endgame

ver since the United States and the NATO forces announced their withdrawal from Afghanistan by September this year, The Taliban's march through the war-torn country has been gaining momentum. In recent weeks many more districts have fallen under Taliban control. The Taliban now rule roughly a third of all 421 districts and district centres in Afghanistan. On Sunday, the Taliban's strides in Badakhshan province forced several hundred fleeing Afghan forces to cross over into Tajikistan.

This has created a grim situation. Afghanistan seems very likely edging towards yet another spell of a devastating civil war. And at the rate at which Taliban seem to be advancing, it looks but certain that they may once again take over the country in the near to medium term. And such a prospect could once again confront India and Pakistan with serious security challenges. One solution for this would have been for the two neighbours to talk to each other to resolve their issues. This would have included cooperating on Afghanistan. As of now, the two countries are working at cross-purposes. Pakistan wants a pro-Islamabad regime in Kabul to achieve its goal of strategic depth as a cushion against India. India, on the other hand, seeks a pro-New Delhi government to deny Pakistan this advantage.

There are several factors at play: One is the larger geopolitics of the region with the progress of the war in Afghanistan at its core. The unfolding situation in Kabul, where the Taliban are now dominant has suddenly reduced India's capacity to influence the outcome in the country. Accordingly, Pakistan is suddenly in a greater position of leverage. The long-standing rivalry and suspicion between the two nations make the matters worse. It persuades them to act at cross-purposes in Kabul. And they would continue to do so until they reach an understanding between themselves.

It is in this context that the recent back-channel dialogue between them had raised some hopes. The dialogue had generated more hopes when the two countries reaffirmed their 2003 ceasefire agreement along the Line of Control in February. But ever since the talks seem to have unraveled. The two governments have obviously failed to act, consolidate and build upon the process. As things stand, this could only further complicate the security situation in the region. Hence the urgent need for them to return to engagement.

The challenge before the two countries is not only to establish a dialogue to address their mutual issues but also to bring their divergent policies and positions on Afghanistan in line. With stakes in Kabul getting bigger and bigger with every passing day, much hinges on how the neighbours are able to handle and steer their relationship in the weeks and months to come.

Battling Inflation

India was lucky last year with the monsoon, which enabled the farm sector to grow even amid a pandemic-induced economic contraction. The bumper harvests also ensured that soaring international food prices from around October didn't translate into higher domestic inflation, barring in import-dependent commodities such as edible oils and, to an extent, pulses. India's annual consumer food inflation in May, at 5 per cent, stood way below the corresponding global rate of 39.7 per cent. This year, however,

While rainfall was 74 per cent above per cent in the first half of last month, on has since stalled. There has been no advance of its northern limit after June 19 and the India Meteorological Department (IMD) sees no favourable condi-

tions for revival in the next 4-5 days. That is bad news. Mid-June to mid-July is the peak season for kharif plantings. Punjab is witnessing power outages now, as the state government is diverting supplies to farmers who are struggling to keep their transplanted paddy crop alive. They may be luckier compared to farmers in other states, where the extended dry spell has delayed sowings of not only paddy (which requires continuous standing water for 40-50 days after transplanting of seedlings), but also pulses, oilseeds and coarse cereals. The Rs 16-17 per litre increase in diesel prices is a double-whammy. For most farmers, who have no three-phase electric tubewell connections or solar pumps, irrigation using diesel engines is simply unaffordable today. A lot, then, hinges on the monsoon reviving sooner than later. One can only hope that the "negative' Indian Ocean Dipole conditions — the abnormal warming of sea waters off Australia and Indonesia, causing increased cloud-formation activity there at the expense of the ocean's western part closer to India — do not intensify during July-September, as many global weather agencies are predicting. Even the IMD has pointed to that possibility in its July 1 forecast update.

A Tale of Two Communities

s the dust settles, it has become clear that the Zoya (Manpreet Kaur) affair was an orchestrated political drama whose purpose was to polarize communities and prepare ground for the upcoming elections in Punjab and Delhi. This was Shiromani Akali Dal's experiment with the right-wing model of electoral success. The main protagonist of this political drama flew from New Delhi with a bunch of his supporters, sat in a protest in Srinagar against a fabricated case of forcible conversion of Sikh girls and went away, for his supporters, as savior of the Sikh community.

No doubt the Delhi Sikh leader got a lot of political mileage out of the Manmeet Kaur affair. But while he made a triumphant return to Delhi – parading gloomy Manpreet (Zoya) before the media and declaring victory "against forced Nikah and Conversions happening in Kashmir", he and his supporters left behind them a trail of ill-feelings. By invoking the bogev of 'Love Jihad' and resorting to Islamophobic tropes and remarks, the Delhi Sikh leader and his supporters (from outside and within Kashmir) have inflicted damage on the cordial relations between Muslims and Sikhs in Kashmir. In one stroke, political opportunists have sowed seeds of mistrust between the two communities who have for long maintained inter-community harmony and solidarity because they both have been at the receiving end of the

majoritarian state. When the case of two Sikh women emerged for the first time around 28 June, there were discussions on the Club House on the issue. I found some of my Kashmiri Muslim friends and acquaintances trying to reason out with the members of the Sikh community, assuring them of unconditional support and solidarity. 'We stand with our Sikh brethren' was a common refrain/hashtag in many social media posts of Kashmiri Muslim netizens, who reminded each other that Sikhs supported and helped in February 2019 when Kashmiri Muslims were targeted in Indian cities and towns and we must reciprocate at this moment, though full details of the case were not known. On 29 June, social activist Mohammed Afaaq Sayeed wrote in his Facebook post, "I reiterate, we stand in solidarity with our Sikh brethren. Their daughters

wing narratives by targeting Kashmiri Muslims. So, through a few political opportunists, the Sangh successfully managed to trigger ill-feelings between the two communities which soon boiled over into a series of vicious exchanges.

Nonetheless, while Sirsa and the gang hogged the limelight (with the help of right-wing aligned electronic media), there were voices from within the Sikh community who understood the larger political game and took a stand against Sirsa's communal politics and politicization of a marriage between individuals belonging to two different faiths. On 30 June, Khushhal Singh, general secretary of Kendri Singh Sabha (KSS). an organization of Sikh intellectuals, took exception to Sikh leaders in Delhi intentionally stoking "a religious frenzy over the issue." On 2 July, KSS issued another statement where the organization called out Delhi Sikh leaders for becoming willing instruments of the Sangh's sectarian agenda. The KSS statement criticized the involvement of the Jathedar in the issue and said that "Most Sikhs feel their religious sensibilities have been hurt as some self-proclaimed Delhi Sikh leaders aligned with the ruling BJP made the Jathedar write the letter which fits into the Sangh Parivar's political programme of projecting a certain minority as an 'aggressor' and pitting other minorities against that.

Jagmohan Singh Raina, president of All Parties Sikh Coordination Committee, also condemned Delhi Sikh leaders, whom he accused of using Kashmiri Sikhs for elections. Describing Kashmir as a sensitive state, he cautioned against politicizing the issue which can burn Kashmir once again. In a press statement on 30 June, he said "The Sikh community in Jammu and Kashmir has been living in harmony with the majority Muslim community. Over the years many attempts were made to create a wedge between the two communities by the vested interests. However, the nefarious designs got defeated due to the strong bond that exists between the two communities.

While Raina displayed modation and condemned communal main accused. The key accused in all the cases are Muslims."

Senior advocate and executive director of Centre for Law and Policy Research, Jayna Kothari, has termed UP's anti-conversion law as "draconian" and violative of fundamental rights because it imposes onerous requirements on the couples who seek inter-faith marriage. Another problematic aspect of the anti-conversion laws (currently in operation in BJPruled states) is that they put burden of proof on persons who facilitated the conversion. In case a magistrate is not satisfied with the proof, the facilitators or those who caused the conversion can be booked for criminal offence. Facilitators could mean family members, friends, relatives, a religious cleric who solemnized the marriage or the conversion. Thus, asking for a law that could potentially be used against a specific community is not wise.

Raina's demand for Inter-caste Marriage Act has been criticized by some members of the Sikh community. Research scholar Preetika Nanda wrote on her Facebook: "Kashmiri Sikh leaders are now demanding an anti-conversion law and inter-caste marriage act to uphold caste endogamy which is in direct contravention of Sikh ethos and principles. Ironically, they want new laws but refuse to accept a woman's statement in Court." Similarly, National Vice-President of All India Students' Association, Kawalpreet Kaur, has termed the demand for anti-conversion and inter-caste marriage act as "obnoxious, unjust and inhuman." She further wrote on Twitter (2 July) that those asking for inter-caste marriage act are doing "major disservice by going against its [Sikhism's] fundamental tenants of casteless society. Sikhism doesn't believe in Caste.'

'TURKISH' Tastemaker in Wazwan Town

In the heartland of Kashmiri Wazwan makers, a native is trying to create his niche as a Turkish tastemaker.

HE window that once opened into the "Venice of East" now offers a bustling sight on a bludgeoned blacktop privy to Kashmir's polemic past. But while the scene stays static, both Nallamar and its showmen have long proceeded as legends in the political amphitheater of the valley. However, the lasting signs—like a clan of classic goldsmiths—continue to make it a "Jewel Street" of Kashmir.

Watching this old-world charm enhanced by the pigeon-lofted heritage houses in his hometown, a native who recently returned with a new-age avatar gets alerted by another order at his door.

In the busy stretch of Old Srinagar, between Bohri Kadal and Saraf Kadal, Shadab Chashoo, 29, has lately established himself as

The tall and handsome man has set up his eatery in the place where the raging spark would mostly discourage many to go for branding based on a popular culture.

But the native whose family moved from the place during Kashmir's tumultuous years not only returned, but demonstrated a steely resolve to introduce popular culture in his café.

Inspired by the Turkish television show Dirili: Ertu rul, Shadab has started his own café and restaurant based on the Ertugrul theme in Downtown. The decision, he says, was driven by his belief of serving the tastes with a difference.

Inside the café, the epic drama's characters have become a wall of fame. A throne, Turgut bay's iconic axe, flags of Kayi tribe, Turkish lights and swords are uplifting the dramatic mood.

"The idea was to create that feel," Shadab, a man of few words, says. "At the end of the day, whatever initiative one is taking has to have a certain distinct feel and flavour.'

That feel and flavour might be barely a couple of fortnights old, but the downtown—long awaiting a popular culture based hangout place—has already started responding to the native's cause.

"The response is overwhelming," Shadab says, while helping his staff to ensure a timely delivery of online orders. "Most of the time, I myself act as a delivery boy.' But creating a niche in the old city — that takes a certain pride for housing some finest Wazwan chefs of Kashmir — doesn't appear

to be a cakewalk for the native son. At a stone's throw from his café, there live some legendary Wazas by the name of Khosas and Bandaris, besides an entire neighbourhood of chefs called Wazpora.

"People have a sense of taste here," Shadab says. "So, in a way, it's a bit challenging, but I'm up for it."

But unlike others getting swayed by the new-age café wave around the city of seven bridges, Shadab has an advantage of a spry street housing some top merchants and their full of go clientele.

Prior to this theme-based café, the area was merely known for the celebrated ice-cream sellers of Bohri Kadal and some random street barbeque stalls. It lacked a good eatery, especially for the family dining and special outings.

Before his return with a "business with difference" mindset, Shadab as a young boy had walked away from the place in 1995. In his new home in Srinagar's Naseem Bagh, he soon lost his father

to a critical disease. Along with his mother and siblings, he lived a quintessential "life of uncertainty" in the valley.

By the time he joined Islamia College, he would make rounds of his birthplace and often wonder about the ways to infuse a new life in what had then become a rundown residence. After an MBA degree and a job stint in Pune, Shadab decided to revive his roots.

But even then, there was no clarity about what to do with that ancestral piece of property before New Delhi enforced communication clampdown in the valley.

"As everything was shut after the abrogation of Article 370 in August 2019, I along with my friends once went for a pizza outing,' Shadab, sitting on the window of his ancestral house turned trendy café, says. "We ended up visiting a small pizza shop in a very narrow

lane in Srinagar. The idea struck me there that if this man can run his business in that small space and during such a challenging time when everything had come to a grinding halt in Kashmir, I can also

has now become 'Kardesler: The Kashmir Café'.

But his resolve still needed a eureka moment. It came when he saw his cousins, friends and acquaintances consuming Turkish drama at length during lockdown.

"I thought, why not to start something on the theme which had suddenly become a pan-Kashmir lockdown engagement," Shadab recalls. "It had a huge fan-base, especially among youth delivering the Turkish warrior series to each other through pen-drives amid internet blockade.'

The series featuring Ertugrul Ghazi, warrior and father of Ottoman Empire founder Osman, depicts the struggles, tyranny, oppression, suffering, identity and justice of Kayi, a minor group of Turk-

However, the pandemic lockdown came as a spoiler for Shadab. But once the viral wave thawed, he opened the padlock, dusted his birthplace, and started what has now become 'Kardesler: The Kashmir Café'. (Kardesler, in Turkish, means brother.)

Apart from Turkish theme, the young café owner is also introducing the Turkish taste in his hometown.

Things just got delayed because of this second viral wave," he says. "We're introducing Turkish dishes soon on our platter to create a distinct flavour.'

Board exams 2022: CBSE announces special assessment scheme, two term-end exams to be conducted

New Delhi: Bifurcating the academic session, holding two term-end exams and rationalising the syllabus were part of the special assessment scheme for class 10 and 12 board examinations in 2021-22 announced by the Central Board of Secondary Education (CBSE) on Monday in

view of the COVID-19 pandemic. The term one exams will be conducted by the Board in November-December, 2021 while the second term exams will be conducted

March-April, 2022, as per an official order by Joseph Emmanuel, Director (Academic) of the CBSE.

The syllabus for the board examination will be rationalised, similar to that of the last academic session, and will be notified in July 2021, it said and also announced plans to make the internal assessment and project work more "credible" and "valid".

At the end of the first term, the board will organise exams in a flexible schedule between November-December 2021 with a window period of 4-8 weeks for schools situated in different

parts of the country and abroad. "The exams will have Multiple Choice Questions (MCQ) including case-based MCQs and MCQs on assertion-reasoning type. Duration of test will be 90 minutes and it will cover only the

rationalised syllabus of the first

term. The question papers will be sent by the CBSE to schools

along with the marking scheme. "The exams will be conducted under the supervision of the external center superintendents and observers appointed by CBSE. The responses of students

will be captured on OMR sheets

which, after scanning may be directly uploaded at the CBSE portal or alternatively may be evaluated and marks obtained will be uploaded by the school on the very same day," he added.

At the end of the second term, the board would organise Term II or year-end examination based on the rationalised syllabus.

"This examination would be held around March-April 2022 at the examination centres fixed by the board. The paper will be of two hours duration and have questions of different formats (case-based/ situation based, open ended-short answer/long answer type).

"In case the situation is not conducive for normal descriptive examination a 90-minute MCQ-based exam will be conducted at the end of the second term also," Emmanuel said.

The CBSE has decided that in case the situation of the pandemic improves and students are able to come to schools or centres for taking the exams, the board would conduct Term I and II examinations at schools or centres and the theory marks will be distributed equally between the two exams.

Airlines can operate maximum of 65 pc pre-Covid domestic flights: Govt

New Delhi: Airlines can now operate a maximum of 65 per cent of their pre-Covid domestic flights instead of the 50 per cent allowed till date, the civil aviation ministry said on Monday.

The carriers have been operating only 50 per cent of their pre-Covid domestic flights since June 1 in accordance with a May 28 order of the ministry. Before June 1, the cap was at 80 per cent.

The May 28 decision to bring down the cap from 80 to 50 per cent was taken "in view of the sudden surge in the number of active COVID-19 cases across the country, decrease in passenger traffic and the passenger load (occupancy rate) factor", the ministry had said.

It issued a fresh order on Monday, wherein it modified the May 28 order stating that "50 per cent capacity may be read as 65 per cent capacity".

The PAGD is an alliance of six mainstream parties -- National Conference, Peoples" Democratic Party, CPM, CPI, Awami National Conference and Jammu and Kashmir People's Movement -- that was cobbled after the Centre abrogated the special status of the erstwhile state of Jammu and Kashmir on August 5, 2019 and divided it into two union territories (UTs).

"To this end (restoration of statehood to J-K), the People's Alliance for Gupkar Declaration has decided to reach out to other political parties in Jammu and Kashmir with a view to take a common position on the issue," PAGD spokesperson and CPM leader M Y Tarigami said in a statement.

The PAGD issued the statement after holding an emergency meeting late on Sunday night at the residence of its chairperson and former Jammu and Kashmir chief minister Farooq Abdullah.

The PAGD meeting, which was called to discuss the all-party meeting with PM Modi held in Delhi, came a day before the visit of the Delimitation Commission to the Kashmir valley. The commission headed by retired Supreme Court judge Ranjana Desai along with Chief Election Commissioner (CEC) Sushil Chandra and J-K"s chief electoral officer will hold meetings with representatives of political parties in Kashmir and Jammu starting Tuesday.

"All the members of the PAGD expressed their disappointment at the outcome of the Delhi meeting especially at the absence of any substantial Confidence Building Measures such as releasing political and other prisoners from jails and taking concrete steps to end the siege and atmosphere of suppression that has choked IK since 2019," the PAGD statement said.

It said the confidence building measures would have initiated the much-needed process of reaching out to the people of Jammu and Kashmir, who are the biggest stakeholders and

On the abrogation of Jammu and Kashmir's special status by the Centre and its subsequent bifurcation into two UTs, the PAGD reiterated its commitment to fight together to reverse the unconstitutional and unacceptable changes "foisted" on the people of the erstwhile state "using all constitutional, legal and political means at its disposal".

'The PAGD"s struggle for undoing these changes will continue as long as it takes while striving to achieve this objective as early as possible," it said.

As far as the restoration of statehood is concerned, the PAGD said, it has been the BJP's commitment on the floor of Parliament and it must honour its word.

"So, any assembly election must be held only after the restoration of full statehood for JK," it added.

The PAGD"s meeting was attended by its vice chairperson and PDP president Mehbooba Mufti, Tarigami, NC leader Hasnain Masoodi, People's Movement chief Javed Mustafa Mir and Awami National Conference senior vice president Muzaffar Ahmed Shah.

The June 24 meeting that was chaired by PM Modi was the first outreach by the Centre to the leaders of Jammu and Kashmir since the abrogation of the erstwhile state's special status. Fourteen leaders from eight different political parties including four chief ministers -- Abdullah, his son Omar, Mehbooba and Congress leader Ghulam Nabi Azad -- had participated in the meeting.

Union Home Minister Amit Shah, National Security Advisor Ajit Doval and Union Home Secretary Ajay Bhalla

Seven districts of the Jammu region have been allotted one hour each while five districts of Kashmir half hour each, IKPCC chief spokesperson. Ravinder Sharma said, adding that the commission should consider giving reasonable time and space to all.

The commission members are also likely to hold separate meetings with civil society groups and similar organisations after they obtain prior approval and are allotted time slots by their respective deputy commission-

During the June 24 meeting with 14 leaders from Jammu and Kashmir, PM Modi had said the delimitation exercise has to happen quickly so that polls can be held to install an elected government in the union territory that will give strength to its development

trajectory. The delimitation, therefore, has attained an urgency amid indications that the Centre is keen to hold early assembly elections in Jammu and Kashmir. There is speculation that the polls could be held in the next six to nine months.

Officials said the commission has asked JK chief electoral officer to ensure that representatives of each registered, national and regional political party are provided a separate time slot so that separate discussions can be held with each of them.

The commission will meet leaders of political parties in Srinagar on July 6 and in Iammu on July 8. The three-member commission.

with the JK CEO being the third member, will also hold separate interactions with the DCs, the officials said.

Twenty-four seats of the assembly continue to remain vacant as they fall under Pakistan-controlled Kashmir (PcK).

India, Australia, 15 Others **Express Interest To Host ICC ODI Events During Next Cycle**

DUBAI: India, Australia and England are among 17 member nations to have expressed interest in hosting ICC white-ball events during the next eight-year tournament cycle from 2024-2031, the game's global governing body said on Monday.

As per a PTI report, the BCCI last month decided to bid for three global events -- including two World Cups in shorter formats -- during the next cycle that starts from 2024, but the Indian board is not keen on paying any hosting fee.

There will also be an issue of tax waiver which BCCI needs to get from its own government to host any ICC event.

The BCCI took the decision dur-



Initial submissions have been received from Australia, Bangladesh, England, India, Ireland, Malaysia, Namibia, New Zealand, Oman, Pakistan, Scotland, South Africa, Sri Lanka, West Indies, UAE, USA and Zimbabwe.

ICC acting chief executive Geoff Allardice said: "We are delighted with the response from our Members to hosting ICC men's whiteball events post 2023. This process gives us an opportunity to extend our range of hosts and grow interest in cricket worldwide reaching more fans whilst creating a longterm legacy for the sport.

"Cricket has more than a bil-

Following the expansion to its event programme in the next cycle, the International Cricket Council has commenced the process to identify the hosts for men's white-ball events to be held post 2023.

Eight men's ODI and T20 events, comprising two men's ODI World Cups, four men's T20 World Cups and two ICC Champions Trophies, will be staged from 2024-2031 cycle and the lion fans around the world and ICC events have a proven track record of bringing significant economic and social benefits for host counties.

"These events provide hosts with a wonderful opportunity to work closely with local communities to grow the game whilst supporting economic and social development public policy goals."

Recently the ICC had announced that the Champions Trophy, which hasn't been held after 2017 in England, will be revived during the next FTP cycle and accordingly India has decided to bid

Allardice added, "We will now move forward to the second phase of the process where Members will provide a more detailed proposal before the ICC Board takes decisions on our future hosts later this year."

Confident Brazil Take On Peru **In Copa America Semifinals**

RIO DE JANEIRO: Defending Copa America champion Brazil is still regarded as the team to beat _ not bad for a tournament some of their players didn't even want to be in.

Few expect that favorite tag to change as Brazil gets ready for Monday's semifinal against Peru, a team that the Selecao thrashed 4-0 two weeks ago in the group stage.

The winner at the Nilton Santos Stadium in Rio de Janeiro will play Saturday's final at the historic Maracana Stadium against Argentina or Colombia, which play on Tuesday.

"It is obvious we are favourites for being at home, but we need to know how to deal with that." Brazil midfielder Fred said at a news conference on Sunday. "Players want to have the match of their lives against Brazil. The last one (beating Chile 1-0 in the quarterfinals) was tough, but the next will be tougher. Peru will be motivated, trying to win, it will be the match of their lives."

Brazil and Peru played in the 2019 Copa America final, with host Brazil winning 3-1 before nearly 70,000 fans. Monday's match will be played without fans due to the COVID-19 pandemic.

Two key strikers won't be playing in the semifinal. Brazil's Ga-

briel Jesus and Peru's Andre Carrillo (against Paraguay) were sent off during the quarterfinals. Brazil's Everton, one of the top scorers at the 2019 Copa America edition, and veteran Christian Cueva are set to take their places.

Brazil advanced to the semifinals after a hard-fought win with 10 men for almost all of the second half against Chile.

Peru recovered from its 4-0 defeat against the hosts by beating Colombia and Venezuela and securing a draw with Ecuador. It reached the semifinals on penalties after a 3-3 draw with Paraguay.

"We will have the chance to face Brazil and correct all the things that went wrong in the first match," Peru coach Ricardo Gareca said. "Brazil continues to be a very powerful team, this Brazil is very good. Our team is also improving.'

Alex Sandro, Neymar, Everton Ribeiro and Richarlison scored for Brazil against Peru.

Peru will look to striker Gianluca Lapadula, replacing its all-time top scorer Paolo Guerrero who missed the tournament due to a knee injury.

Brazil will once again count on Neymar, its best player in the tournament so far, who finished the clash against Chile in a state of exhaustion, along with many of his teammates.

NEW DELHI: Celebrated boxer M C Mary Kom and men's hockey team skipper Manpreet Singh will be the country's flag bearers at the opening ceremony of Tokyo Olympics, the Indian Olympic Association announced on Monday.

One of India's biggest medal hopes, wrestler Bajrang Punia, will be the flag bearer at the closing ceremony on August 8.

The IOA has communicated the decision in this regard to the organising committee of the Tokyo Games. In a first, India is having two

flag-bearers -- one male and one female -- at the upcoming Tokyo Games to ensure "gender parity". This was recently informed by IOA chief chief Narinder Batra.

"It would be a huge huge moment for me given that it is my last Olympics. Who knows might even get emotionally overwhelmed," Mary Kokm told PTI after being named as one of the flag bearers.

"I am truly honoured to get this

opportunity of leading the team out during the opening ceremony

and I thank the sports ministry and IOA for naming me. It would be added motivation for me. I promise to do my best for a medal," the sixtime world champion added. The country's lone individual

Olympic gold-medallist Abhinav Bindra was the flag bearer at the opening ceremony of the 2016 Games in Rio de Janeiro.

The Tokyo Games are schedlled to open on July 23 and over 100 Indian athletes would be gunning for podium finishes at the showpiece, which was postponed

by a year because of the COVID-19 pandemic.

At its executive board meeting last year, the International Olympic Committee had made provisions for flag-bearers from both genders at the opening ceremony.

"...the IOC Executive Board also decided that there should be for the first time ever at least one female and one male athlete in every one of the 206 teams and the IOC Refugee Olympic Team participat ing at the Games of the Olympiad,' IOC chief Thomas Bach had said.

IPL Will Wear Out UAE Pitches Before T20 World Cup, Fears **SA Coach Mark Boucher**

NEW DELHI: The remainder of Indian Premier League being held in the United Arab Emirates will hugely affect the pitches, which might get worn out and help the spinners "massively" during ICC T20 World Cup, feels South Africa head coach Mark Boucher.

The 2021 IPL, which was suspended following COVID-19 cases inside the bio-bubble, will be completed in UAE, which will also host the T20 World Cup after the ICC decided to shift the showpiece event from India due to the unprecedented health crisis.

The second leg of the IPL is scheduled to be held from September 19 to October 15, while the T20 World Cup will begin on October 17. "The wickets after the IPL are go-

ing to be a bit dry. It's not the same as we are used to back in South Africa where you can go out and bash your way to 180 to 200 runs. You've got to be skillful here; you've got to be smart," Boucher was quoted as saying in ESPNcricinfo.

"If anything, it's going to go even further into subcontinent conditions, on the extreme side. They are playing the IPL there, there are not a lot of grounds and those wickets



are going to be worn, so scores will probably go even further down."

Boucher said batting will be tough on this pitches as spinners will hold the key.

"It's going to be tough to bat on especially at the back end as we saw here," said the South African.

"We will have an idea of what scores are going to be by watching the IPL and then taking a look and assess how the wickets are playing during the beginning part of the World Cup.

"I suspect spinners will play a massive role."

Left-arm wrist spinner Tabraiz Shamsi had claimed seven wickets as South Africa won a five-match T20I series against the West Indies 3-2 at the National Cricket Stadium in St George's, Grenada.

Mohammad Amir Needs Domestic Success For International Return: Wagar Younis

ISLAMABAD: Pakistan bowling coach Wagar Younis feels it will be tough for paceman Mohammad Amir to make a comeback to international cricket without first impressing domestically.

Amir retired from international play last December, saying he was mentally tortured by his teammates and coaches. The left-arm fast bowler played in the recent Pakistan Super League with minimal success

He reportedly met with Pakistan Cricket Board chief executive Wasim Khan earlier this year, leading to speculation of a return before the Twenty20 World Cup in October.

"No doubt he's a fine cricketer. but if he doesn't want to take his retirement back and impress selectors by playing cricket, it will be hard," Younis told reporters via videoconference from England on Monday.

"It's Pakistan cricket, it's not yours or my cricket (team), you have to do the right things to play for your country. This is not a franchise cricket and one got to remember that." Younis said he was not aware about any meeting between Khan and Amir.

"To be honest I didn't know about this (meeting)," he said. "He



(Khan) is head of the cricket and he has every right to meet whosoever he wants to see: he went there in his personal capacity and we didn't know about it.'

Amir played for Karachi Kings in the PSL, but could take only five wickets in 11 matches at an average of 69.80. Karachi was knocked out after losing both of their playoffs. Amir took 259 wickets across 36 Tests, 61 one-day internationals and 50 T20s. He was 18 when he was banned in 2010 for five years and jailed for three months for spot-fixing in a Test series in England. He was allowed to return to cricket a few months early and recalled by Pakistan in 2016.

In 2019 he no longer wanted to play Tests, to focus on white-ball cricket and prolong his international career. Amir's last international was in August 2020 in a T20

Djokovic Wins At Wimbledon For 50th **Major Quarterfinal Berth**

WIMBLEDON: Two-time defending champion Novak Djokovic held every service game Monday and reached his 50th Grand Slam quarterfinal by beating No. 17-seeded Cristian Garín at Wimbledon, 6-2, 6-4, 6-2.

Diokovic earned his 12th quarter-

final berth at Wimbledon, which ties

him with Arthur Gore for third place on the men's all-time list, behind Roger Federer's 18 and Jimmy Connors' 14. Three men became first-time Wimbledon quarterfinalists, including No. 25 Karen Khachanov of Rus-

sia, who won a bizarre fifth set to beat American Sebastian Korda on his 21st birthday, 3-6, 6-4, 6-3, 5-7, 10-8. With both players battling fatigue and nerves, there were 13 services breaks in the final set.

For Korda, it was a disappointing end to an otherwise impressive Wimbledon debut.

Khachanov will next face No. 10 Denis Shapovalov, who hit 15 aces and beat No. 8 Roberto Bautista Agut 6-1, 6-3, 7-5. Khachanov and Shapovalov joined

Wimbledon's final eight for the first time, as did No. 7 Matteo Berrettini, who became the first Italian man in 23 years to reach the quarterfinals by ousting Ilya Ivashka 6-4, 6-3, 6-1.

Top-ranked Ash Barty also became a first-time Wimbledon quarterfinalist when she beat French Open champion Barbora Krej íková 7-5, 6-3. Barty was troubled again by a shaky serve but saved eight of 10 break points and did manage an ace on match point to end Krej íková's 15-match win streak.

Barty has yet to play her best in



to claim her second Grand Slam title. The Australian won the 2019 French Open and was the Wimbledon girls singles champion in 2011.

"I love coming out here and test myself against the best in the world," Barty told the crowd. "And there's certainly no place I'd rather be at the moment." Ons Jabeur of Tunisia became



Maybe Luis Enrique isn't aware, but Italy is rolling at the moment.

This might be a match between teams who have almost forgotten what it feels like to lose — Spain has only one defeat in its last 29 games but Italy looks to have the edge, at both ends of the field.





Much has changed since Roberto Mancini took charge in May 2018, with the team having evolved into a high-energy unit that presses hard and attacks at pace. But the Azzurri's defense needs little introduction. Formidable center backs Leonar-

do Bonucci and Giorgio Chiellini are still holding the fort, like they have been for more than a decade, and Italy has conceded only two goals so far. Spain's defense, on the other

hand, is a work in progress while center back Aymeric Laporte integrates following his switch of nationality from France. In attack, striker Alvaro Morata

continues to frustrate for Spain and Luis Enrique has seemingly yet to settle on his preferred wingers. Italy, though, has had strong and reliable performances from striker Ciro Immobile and wide forward Lorenzo Insigne, the scorer of the decisive second goal against Belgium.

It's in midfield where Spain can seriously challenge Italy, potentially making it the department where the match could be won or lost. Jorginho, Nicola Barella and probably Marco Verratti for Italy versus Sergio Busquets, Pedri Gonzalez and Koke for Spain is a must-watch duel all by itself.

Neither team has made it this far in a major international competition since 2012, when they met in the European Championship final in Kyiv. Spain won that match 4-0. Two players remain from each country: Bonucci and Chiellini for Italy, and Jordi Alba and Busquets for Spain. So while this is far from unchart-

ed territory for two countries with nine European Championship or World Cup titles between them, it is for most of the players involved.

Expect the Spanish to have the majority of possession, but maybe by not as much as they are accustomed. And expect the Italians to launch quick counterattacks from turnover balls, seeking to get behind the aging Busquets and attack the soft center of Spain's defense.

A win for Spain, which has the youngest squad at the tournament, sets up the prospect of a third European Championship title in four editions and potentially the start of new period of success for a nation that dominated world soccer from 2008-12.

A win for Italy surely means Mancini's team would enter the final as the favorite, no matter who wins the second semifinal match between England and Denmark.
