

# **6 Assam Policemen Killed in Clashes** with Mizoram

GUWAHATI: At least six Assam police personnel were killed on Monday in the border troubles with Mizoram, Assam Chief Minister Himanta Biswa Sarma said.

States of Assam and Mizoram share roughly 100 miles of a disputed border. The boundary dispute between the two states has been simmering since Mizoram was formed as a separate state in the Eighties. Several rounds of talks have been held since 1995 to resolve the tensions between the two states.

Sarma, who also holds the Home Department portfolio. in a tweet said: "I am deeply pained to inform you that six brave jawans of Assam Police

have sacrificed their lives while defending the constitutional boundary of our state at the Assam-Mizoram border. My heartfelt condolences to the bereaved families.'

An Assam police official said that while the district and police officials were dealing with the border troubles and discussing the unauthorized constructions on the Assam side, there was unprovoked firing injuring many security personnel and killing the six policemen on the spot.

The Assam-Mizoram border troubles flared up on Monday with at least 20 officials and civilians injured and vehicles damaged in clashes as both Chief Ministers sought Union Home Minister Amit Shah's urgent intervention. Officials • More On P2



# **'35 Drowning Deaths This Summer': Does Kashmir Lack Lifesaving Support?**

was the second day of Eidul-Azha, when fresh-faced Anzoor Raise of Khanabal Kupwara left home amid festivity. The breadwinner of his old parents and two younger siblings had felt compelled to come out for the sake of his underprivileged family.

But his survival outing shortly involved him in a rescue mission ending up consuming the sole support of his family.

Near Kehmil Nallah in his hometown, he saw a motherdaughter duo struggling to cross the temporary bridge-about which many had raised concern

fearing the fatal consequences. The bridge had chosen the breadwinner as its victim on Eid. Manzoor's 'social worker' spirit didn't allow him to ignore the duo.

He helped cross the daughter with ease, but her mother stumbled on the troubled bridge and fell into the gushing water body. Manzoor instantly jumped to rescue the lady-but neither he, nor the lady could come out alive.

Before drowning, Manzoor had saved many lives. But as his luck ran out on Eid, his family was torn asunder by grief and existential crisis.

But what happened at Kupwara wasn't the first



instance of drowning in Kashmir cousin sisters-Utba (17) and this summer. Alongside suicides, Insha (19)-drowned after a sudden flow of water to a power canal the rate of drowning deaths is also escalating in the valley. washed them away at Ferozpur On 14 July 2021, two teenage Nallah in Drang tourist resort.

It was the birthday of one of the deceased girls, who had insisted on going for the picnic.

"I was just standing near the Nallah and watching my children taking Selfies," Yasmeena Khan, mother of Utba told Kashmir Observer."Suddenly, a water gush washed them away. Everything happened so fast that we failed to act and react."

What followed was a quintessential tragic tale-leaving another Kashmiri family with loss and lamentations.

But apart from sudden drowning incidents, many say surging life attempts in water bodies of Kashmir is also escalating the rate of such deaths."It's not swimmer to rescue a drowning person," said Sajad Shangloo, a fisherman with dozens of rescue ops to his name. "These are tiring rescue ops, which often end up consuming the rescuer himself."

Above and beyond these suicide-triggered drowning cases, a summertime heat-relieving dives into rivers, ponds, lakes and streams are also creating these casualties.

"If you don't know how to swim, why jump into the water,' said Riyaz Wani, a professional swimmer. "This is suicide."

Apart from lack of training, Wani said, the dearth of life-saving equipment in Kashmir is equally

responsible for these deaths.

"Drowning incidents happen in other states as well, but authorities deploy life-saving guards there to prevent such mishaps," he said."However, here

A member of the Swimming imparting swimming training and recording the drowning incidents-Wani said the ongoing summer already recorded 35 drowning deaths in different parts of the valley.

"Except seven, rest died," he said. "And most of the deceased were teenagers.

# UK High Court Declares Vijay Mallya Bankrupt For Indian Banks To Realise Debt

LONDON: A British court on Monday granted a bankruptcy order against Vijay Mallya, paving the way for a consortium of Indian banks led by the State Bank of India (SBI) to pursue a worldwide freezing order to seek repayment of debt owed by the now-defunct Kingfisher Airlines. "As at 15.42 [UK time], I shall ad-

judicate Dr Mallya bankrupt," Chief

Insolvencies and Companies Court (ICC) Judge Michael Briggs said in his ruling during a virtual hearing of the Chancery Division of the High Court.

"I have to decide if there is a real prospect of payment of petition debt in full within a reasonable period of time there is insufficient evidence that [Mallya's asset realisations in India] will pay the debt in full within a reasonable period of time, Judge Briggs noted, in reference to defence

arguments pointing to a restora-tion process in India following a Prevention of Money Laundering Act (PMLA) court order for the attachment of Mallya's assets.

"In my judgment, the sums provided to date are conditional there is no evidence Dr Mallva will return to India to deal with the criminal trial and seek to unlock the allocation of realisations which have been made," the judge concluded.

The 65-year-old businessman. wanted in India on fraud and money laundering charges, remains on bail in the UK while a "confidential" legal matter, believed to be related to an asylum application, is resolved in connection with the unrelated extradition proceedings. During the course of Monday's hearing, Judge Briggs asked Mallya's barrister, Philip Marshall, if there was any "indication" if his client intended

to return to India to deal with the criminal proceedings and was told that there was no such indication.

by the law firm TLT LLP and barrister Marcia Shekerdemian, had argued for the bankruptcy order to be granted in favour of the Indian banks who are owed over GBP 1 billion and pointed out that the long-drawn legal battle would complete its third birthday in September this year".

The Indian banks, represented

against a trial court order which called its investigation into a Delhi riots case callous and farcical and imposed a fine of Rs 25,000. The appeal said that the imposition of fine, which was to be recovered from the station house officer (SHO) of Bhajanpura police station and his supervising officers, was unwarranted and uncalled for. In its plea filed through advocates Amit Mahajan and Rajat Nair, Delhi Police has said that the July 13 order was in violation of principles of natural justice as it was passed without giving any opportunity to the DCP to make his submissions, and that very serious remarks were made against the investigation even prior to the commencement of trial.

In its order, Additional Sessions Judge Vinod Yadav had pulled up the police for lack of efficacy and fairness in the investigation in the case and said that it had been done in a most casual, callous, and farcical manner.

#### Attends Vijay Diwas at Baramulla

President Kovind visited the Dagger War Memorial in Baramulla and paid tributes to those soldiers who laid down their lives on Kargil heights during conflict with Pakistan in 1999.

President later said the event evokes profound respect for the brave fighters who laid down their lives for the safety and security of the country.

Kovind was scheduled to visit the War Memorial at Drass in Ladakh to pay homage to personnel of the armed forces killed in the 1999 Kargil war, but bad weather forced cancellation of his plans and he instead paid tributes to martyrs on the 22nd anniversary of Kargil Vijay Diwas at Baramulla, officials said.

The president, in a message in the visitor's book at the Dagger War Memorial, wrote: "The nation salutes the soldiers and officers of the 19th Infantry Division, who have been safeguarding our borders in the most hostile terrains under adverse weather conditions as our frontline troops."

They have scripted exceptional stories of indomitable courage, bravery and sacrifice, he said in his message.

"The Dagger War Memorial evokes profound respect for the brave fighters who laid down their lives for the safety and security of our country. I am sure that this memorial will educate the people of India about the highest values of the Indian army and inspire them. Jai Hind!" he wrote.

The president, who was accompanied by Lt Governor Manoj Sinha, also visited the High Altitude Warfare School at Gulmarg and interacted with troops there.

"It has been a pleasure to visit the High Altitude Warfare School at Gulmarg. Established by the great General Thimayya, it has emerged as one of the most premier institutions in the field of warfare," Kovind wrote in the visitor's book of training school.

India has previously slammed Pakistan for its decision to hold elections in Gilgit-Baltistan and said any action to alter the status of the "militarily occupied region" has no legal basis

Barrister Sultan Mahmood PTI Chaudhry, who is the front-runner candidate for the 'Prime Minister' of the region, won from his seat. Former 'Prime Minister' and PML-N leader Raja Farooq Haider retained his seat. Another ex-'Prime Minister' and chief of Muslim Conference, Sardar Attique Ahmed Khan, also won.

A total of 587 candidates contested the elections in 33 constituencies of various PcK districts and 121 candidates in 12 constituencies of Jammu and Kashmir refugees settled in Pakistan.

Pakistan's Opposition parties, Pakistan Peoples Party (PPP) and Muslim League-Nawaz Pakistan (PML-N), have accused Khan's party of "rigging" the elections held on Sunday. There is proof of systematic rigging

in the election, PPP's vice-president Senator Sherry Rehman. She said PTI workers attacked the

PPP worker during polling time, while police had uprooted a camp belonging to her party. "There is a clear difference between the voter lists of several polling stations, she said.

PML-N spokesperson Marriyum Aurangzeb, in a statement, claimed that to rig the election the PTI "goons" attacked her party's workers in Gujranwala's Alipur Chatha area.

"PTI has been allowed to engage in hooliganism with complete liberty,' she said.

However, the region's Election Commission rejected the allegations and said that the polls were held in a fair and peaceful manner.

The chief election commission, Abdul Rashid Sulehria, told the media that he was satisfied with the election process.

At least two PTI workers were shot and killed in clashes with PPP activists at a polling station in Charhoi area of Kotli district on Sunday. The two men were shot dead by unidentified persons, police said.

Also, at least four soldiers were killed while three soldiers and a civilian driver were injured when their vehicle plunged down a ravine off a curvy mountain road in Laswa area of the region, the military said in a statement on Sunday.

Minister Mizoram Home Lalchamliana in Aizawl said that around 200 Assam armed Police led by an Inspector General of Police, accompanied by DC, Cachar, SP, Cachar and Divisional Forest Officer came to the Vairengte auto-rickshaw stand on Monday and forcibly crossed the duty post manned by CRPF personnel stationed there and overran a duty nost manned by the Mizoram police personnel. He said the Assam Police also damaged several vehicles while travelling along the National Highway between Vairengte and Lailapur.

In March this year, Parra was chargesheeted by the National Investigation Agency (NIA) and it was alleged that the PDP youth leader had paid Rs 5 crore to the son-in-law of hardline Hurriyat Conference leader Syed Ali Shah Geelani for keeping Kashmir in turmoil after the death of Burhan Wani, a commander of the Hizbul Mujahideen group, in 2016.

The NIA accused Parra, who was arrested last November, of being involved with banned groups such as the Hizbul Mujahideen and the Lashkar-e-Taiba.

The NIA alleged that after the death of Wani, who was killed in an encounter with the Army in July 2016, Parra got in touch with Altaf Ahmad Shah, alias Altaf Fantoosh, and asked him to ensure that the valley was kept on the boil with widespread unrest and stone-pelting.

In January this year Parra was granted bail by the NIA court, which said there was no reference to him in the original as well as the supplementary charge sheets presented in July and October last year respectively. However, he was arrested by the CIK

Wing in the case related to nexus between mainstream politicians and secessionists, and he continues to be in jail since then. His bail was rejected by the NIA court in Srinagar.

with swimming", Wani said, he fears more drowning cases as the soaring mercury is compelling youngsters to beat the heat in water bodies.

However, to prevent drowning deaths, the administration in Kashmir has restricted swimming at water bodies.

The disaster management department in its latest advisory has said that people should not venture out into the water bodies unless they know how to swim.

"Don't dive into the water or push someone into the water," it said."Don't swim alone, especially if you are an inexperienced swimmer."

The current may be faster, the advisory warns, with dangerous undercurrents, even difficult for experienced swimmers.

"A rope, lifejacket, lifebuoy, or improvised flotation device should be made available for rescue operations at places where drowning incidents happen," Aamir Ali, Disaster Management Director, told Kashmir Observer. "Elders should keep a constant visual contact with children when they are swimming. Learn first aid as you might save someone's life." However, the biggest issue—the lack of life-saving support in Kashmirhas already doomed Manzoor's poor family.

#### Imran Khan's Party

Muslim League-Nawaz (PML-N) secured just six seats, the state-run Radio Pakistan reported.

Muslim Conference (MC) and Jammu and Kashmir Peoples Party (JKPP) were successful in one seat each.

However, Geo TV reported that PTI won 25 seats, followed by PPP with nine and PML-N six. One seat each was won by Muslim Conference and Jammu and Kashmir Peoples Party.

Thus, PTI got a simple majority to form the government without support of any other party. It is for the first time that it will form a government in PcK.

Traditionally, the ruling party in the country wins the elections in Pck.

The assembly has a total of 53 members but only 45 are directly elected, while five seats are reserved for women and three are meant for the technocrats.

The 45 members directly elected included 33 residents of PcK and 12 refugees' who came over the years from Kashmir and settled in various cities of Pakistan.

The soldiers were part of army troops deployed to help maintain peace during the elections.

In another incident, five police constables were injured after Jamaat-e-Islami activists attacked them with batons at the Dhal Chakhya polling station of Jhelum valley district.

A PML-N candidate Choudhary Muhammad Ismail Gujjar kicked up a storm as he threatened on Sunday that he would "seek India's help" if the local administration failed to address his concerns after his party's polling agents were removed from a polling station, the Geo News reported.

Following their exit from the polling station, the agents got into a heated argument with the deputy commissioner after which the polling process was halted there.

He, however, later clarified on media that his statement was directed towards the administration.

Secretarv Election Region's Commission Muhammad Ghazanfar Khan claimed that the elections were held in a free, fair and transparent manner.

He expressed satisfaction over the law and order and appreciated the performance of the police and the Pakistan Army for ensuring the peaceful conduct of the elections, in which there were 32 lakh people eligible to vote to elect 45 members of the assembly for a five-year term.

The last general election for PcK Legislative Assembly was held in July 2016 and won by Pakistan Muslim League-Nawaz led by former prime minister Nawaz Sharif.

In this election, the PTI nominated candidates for all the 45 constituencies, while PML-N and PPP each issued tickets to candidates for 44 seats.

Tehreek-e-Labbaik Pakistan (TLP), the Islamist party which was banned in April by the Pakistan government for its violent activities, contested on 40 seats. The TLP was not de-registered by the Election Commission of Pakistan even after the ban, enabling it to take part in the elections.

Apart from the ticket holders of different political parties, a total of 261 independent candidates were also in

Srinagar: Several diversions in view of the security arrangements amid President of India Ram Nath Kovind's three-day visit to Jammu & Kashmir and Ladakh Monday choked the city streets consequently leading to massive jams thereby enraging the commuters.

As part of security measures for the President's visit, traffic on the two approach roads to Raj Bhawan where President Kovind has been diverted between Sunday and Wednesday.

A traffic department official said diversions have been placed in some areas of the city and no traffic is being allowed on Foreshore Road, along the famous Dal Lake from Dalgate and Nishat axis, as well as towards Gupkar for the next three days.

Kovind is in the capital city Srinagar and is scheduled to address the convocation of Univer-

sity of Kashmir on Tuesday. His visit began on Sunday and will last till Wednesday. In Srinagar, the president will address the 19th Annual Convocation of the University of Kashmir on Tuesday

Meanwhile traffic on Baramulla-Srinagar highway was diverted on Monday morning. Traffic on Gupkar and Foreshore roads, the two approach roads to Raj Bhawan and the Nehru state guest house on the banks of Dal lake, has been diverted between July 25 and 28.

In addition to this the small passenger vehicles coming from South Kashmir were also diverted through Lasjan Byepass as part of security measures for the President's visit.

The massive security arrangements have caused massive inconvenience to the people, who complained that the arrangements choked the city streets. Pertinently, the Kashmir Observer staffers were also barred from entering their office that is located on the Boulevard road.



Polythene and other single use plastics are extremely harmful to the environment and public health. Solid Waste Management Rules, 2016 (SWM Rules, 2016) and Plastic Waste Management Rules 2016 (PWM Rules, 2016) and its amendments provide for rules and guidelines to deal with this menace. In compliance with the SWM Rules, 2016 and PWM Rules 2016 & in pursuance of various orders passed by the Hon'ble High Court of J&K and Ladakh following orders are hereby issued:

There shall be complete ban on use and sale of single use plastics and polythene (as defined in the prohibited categories in Plastic Waste Management Rules, 2016) in Srinagar Municipal Limits.

No one shall bring polythene or single use plastics into the Srinagar city for personal or commercial use via any of the entry points of the city.

- No one shall engage in sale of polythene and prohibited single use plastics in the city.
- No one shall sell goods or commodities in polythene or prohibited plastic bags.
- No one shall stock or hoard prohibited polythene or single use plastics.
- 6. No one shall use or carry goods in bags made of prohibited polythene or single use plastic products.

No restaurant or hotel or eatery or any commercial unit shall use disposable items made of single use plastic or polythene for serving food or tea etc. to the customers.

No individual shall use disposable items made of single use plastics or polythene in marriages or other social or religious functions.

All commercial units including shops, hotels, restaurants, street vendors, malls, institutes, offices (government & private), public or private sector companies, schools, colleges, universities etc shall not use prohibited polythene or single use plastics for packaging or sale.

All commercial units including shops, restaurants, hotels, street vendors, malls, institutes, of-10. fices (government & private), public or private sector companies, schools, colleges, universities etc. shall keep two dustbins in or outside their units for keeping wet (bio-degradable) and dry (non-biodegradable) waste within three days after publication of this notice.

No one shall litter waste including that of polythene or plastic in public places including roads, footpaths, vacant land, drains, streams, rivers or lakes

No one shall litter anywhere in the city. The waste shall be deposited in the designated dustbins 12. only. 13.

All commercial units and establishments including street vendors, shops, restaurants, hotels, private or public offices, malls, institutes, public or private sector companies, schools, colleges, universities etc. shall make sure that waste generated by them or by their customers or clients is properly managed and the compounds are kept clean and litter free. The waste shall be segregated, disposed scientifically or handed over to SMC Sanitation staff.

All bulk waste generators shall ensure they have a proper mechanism for waste collection and disposal in place.

All hospitals, nursing homes, dispensaries, pharmacies and medical shops shall ensure bio-medical waste, expired or used medicine, equipment, etc is disposed-off in accordance with bio medical waste management rules 2016 and its amendments. Negligence would lead to heavy penalties and immediate sealing of the establishments/units. 16. There shall be following penalties for violation:

Rs 500 fine for use of polythene bags/ prohibited single use plastics by individuals

Rs 5000 fine for use or for selling goods in polythene bags by commercial establishments/units. Rs 10,000 fine per kilogram for carrying, stocking or selling or bulk use of polythene or other b. prohibited plastics.

Rs 500 fine for littering by individuals Rs 5000 spot fine for littering by commercial establishments. Repeated offences shall invite heavy penalties including deregistration and sealing of businesses.

Rs 25000 fine for failure to manage solid waste by bulk waste generators in accordance with rules.

Repeated offences by commercial establishments shall invite heavy penalties including deregistration and sealing of businesses.

Chief/Zonal Enforcement Officers, Heath Officer, Chief/Zonal Sanitation Officers, Chief Anti-Encroachment Officer, Anti-Encroachment Officers, Anti-Polythene Officers, Ward Officers and Sanitary Inspectors of SMC are directed to enforce the order and are authorized to impose the fine on violations. #### Car With 100 KG RDX seized Stolen car intercepted near Magam, was headed for Srinagar?

rinagar - Death and devastation on a large scale was averted today when the police recovered 100 kilograms of RDX from a stolen Maruti car near Magam in the Baramulla district. The driver of the car was apprehended while two other occupants managed to escape.

"The RDX was concealed in a trunk and was fitted with two live grenades fixed to detonators/' Inspector General of Po-lice. Kashmir, Javed Mukhdoomi, said at a hurriedly-called press conference this evening. A wireless Set was also found along with the explosives.

Police immediately called the bomb disposal squad who neutralised the explosive material.

"There is a possibility that the car was being driven to Srinagar for a bombing," he said, adding that a major tragedy had been averted.

The recovery was made during routine checking near Magam when a blue Maruti 800 Was stopped by line police at around 6 PM Tuesday evening. The three occupants of the car made a break for it, but one of them, the driver, identified as Zahoor Ahmad of Haniiwera, Pattan, was caught at Mazhama on the Srinagar-Magam road after the police gave chase, the IGP said.

The car (original registration number JKE 6394) was fitted with a false number plate (DL3C 8177). It had been stolen a few days ago from Aripathan, and an FIR stands lodged in the Beeru police station, the IGP said. The interrogation of the driver was going on. 'Seizure a major breakthrough'

The Centre today described the seizure of an explosive-laden car and the arrest of its driver on Srinagar1 Gulmarg Highway a major breakthrough in the investigations into a spate of bomb blasts in the recent past. "This is a major breakthrough and we are hopeful that the security forces will be able to bust the militant network carrying out these attacks." a senior Home Ministry official said.

### KO VIEW Fake arms license scam

he Central Bureau of Investigation (CBI) on Saturday carried out raids at the offices and homes of several senior bureaucrats in nearly 40 locations across Jammu and Kashmir. These raids were part of an ongoing investigation into arms license racket whereby the deputy commissioners of various districts in the former state are alleged to have illegally issued bulk arms licenses between 2012 and 2016 in lieu of monetary consideration. It is alleged that more than 2.78 lakh arms licenses were issued to non-entitled persons in J&K between 2012 and 2016. The searches were carried out in Jammu, Srinagar, Udhampur, Rajouri, Anantnag, Baramulla and Delhi.

The case first came to light in 2018 when an investigation carried over months by the anti-terror squads of Rajasthan and Madhya Pradesh revealed that the fake arms licenses procured from J&K have led to the proliferation of illegal weapons across several states. At that time, around 40,000 licenses were said to have been issued in the then state in the preceding six years.

The reason for this is that it was not difficult to get a license in J&K state if anyone faked the identity of security personnel or produced a forged letter from a commanding officer of an army unit and used a picture in the application form wearing an army uniform and greased the palms of the concerned officials.

What is more, most of these licenses were not issued to the J&K residents but to the outsiders. This, in turn, triggered an illegal arms trade in some states with thousands of people ending up possessing arms on fake documents. Alarm bells so triggered led to investigations by Madhya Pradesh and Rajasthan ATS who tried to reveal the extent of the scam.

The then J&K Government too had started a probe to be carried out by the State Vigilance Organization. The state's then home department ordered the divisional commissioners of Kashmir and Jammu regions to verify all cases of individual new arms licenses issued between 1 January, 2017, to 23 February, 2018, in eight districts of the state.

And also the district magistrates in the state were directed to take urgent steps to revoke all such "individual arms licenses issued to various persons excluding the personnel of State Police, Army and Central Armed Po-

Jordanian King Abdullah became the first Arab leader to meet the US President Joe Biden at the White House on July 19. By granting him this honour the new US administration is putting its weight behind Jordan to become the voice of the region and non-gulf Arab nations, once again.

As the Jordanian monarch for the last 22 years King Abdullah has been seen by American presidents as a moderate, reliable ally in the Middle East, besides being the eyes and ears from the Arab world in Washington.

However, during the last four years that special relationship was put into cold storage, as Donald Trump favoured working with Saudi Arabia and the Gulf states instead

For instance the Trump administration didn't consult King Abdullah on the Mideast peace plan, which originally provided for annexation of the Jordan Valley.

Reports say that in his renewed role as a representative of moderate, pro-Western Arabs, Abdullah brought several messages to Biden.

#### Impact on Jordan-Saudi relations

President Joe Biden may have little appetite for Israeli-Palestinian peace-making efforts, but he seems determined to prevent certain third parties from exploiting the regional stalemate to their advantage Although the US's and Biden's foreign policy priorities are heavily focused on China and Russia, the Middle East is a region that the new administration understands very well it cannot afford to ignore. Relations between Jordan and Saudi Arabia had their own ups and downs during the last four years. The Saudis were irked by King Abdullah's fierce rejection of Trump's recognition of all of Jerusalem as Israel's capital. Jordan also refused to consider the president's Israeli-Palestinian peace plan. King Abdullah suspected that the US and Israel were favouring a Saudi role in the administration of the Muslim sites on the Temple Mount in Jerusalem. Jordanian officials denied reports last year in Israeli newspapers quoting Saudi diplomats as saying that Jordan was willing to grant Saudi Arabia observer status in the endowment administering the Muslim holy sites on the Temple Mount. The Saudi interest is marked by various moves initiated by the country in recent years, though it has not officially declared its desire to wrest control of the Temple Mount from Jordan, yet.

Saudi King Salman announced at the Arab Summit in Dhahran in April 2018 that he was donating \$150 million to support Islam's holy places in Jerusalem. The donation was aimed to counter Turkish bequests. Saudi Arabia has since clashed with Jordan at various Arab forums over Jordan's exclusive control of the administration of the Jerusalem sites and is believed to have been wooing Palestinian religious dignitaries to achieve its objective.

Here the risk for Saudi Arabia is that broadening the administration of the Jerusalem sites could lead to demands that the custodianship of Mecca and Medina should also be internationalised. This proposition, often put forward by Iran, sounds horrific to the Saudis.

For much of the past century, the administration of Jerusalem's Muslim holy sites has vested in a Jordanian government-controlled endowment. And Jordan views the Saudi and other interested Islamic nation's efforts as an affront, which certain observers also describe as the battle to emerge as the supreme leader of the Islamic world.

The stakes in the struggle for control of Muslim holy sites in Jerusalem sites are high. For Riyadh's ruling Saud family, this is about bolstering its religious claim to leadership of the Muslim world.

For Jordan and its Hashemite monarchs, who trace their ancestry back to the Prophet Muhammad, this is more about politics than religion. Palestinians account for more than 40% of Jordan's population, thus maintaining the status quo in Jerusalem-which most Palestinians hope to be the capital of a future Palestinian state—is key to ensuring the regime's survival. Despite Abdullah's fraught relationship with the Saudi crown prince, the Jordanian monarch told Biden, "we have to work with MBS," the sources said. This magnanimity stems from the confidence Abdullah has in reviving his ties with the new US administration.

King Abdullah also urged Biden to join a task force to help stabilise Svria. The approach Abdullah advocates would bring together the United States, Russia, Israel, Jordan and other nations to agree on a road map for restoring Syrian sovereignty and unity.

Reports say that Biden hasn't yet committed to the proposal, as it would mean realigning the US interest with both Russia and the Bashar Al Assad regime, both of which are controversial decisions to be made.

US academic Curtis Ryan, a widely acclaimed Jordanian expert opines that Jordan and its partners see the new three-way alignment or axis with Iraq and Egypt as an alternative power centre in Arab politics that will help to bring non-Gulf voices back to the forefront of Arab politics

In this regard Egyptian President Abdel Fattah Al Sissi's visit to Baghdad can be described as a "positive step" to limit Iranian influence there.

Bruce Riedel, a senior fellow at the Brookings Institution says that Abdullah has been the most energetic Arab leader by far in trying to support a stable Iraqi government. This summit in Baghdad of Iraq, Jordan and Egypt is the first time that the Sunni Arabs have ever done anything in 18 years since the fall of Saddam-that they have actually done something to not only stabilise Iraq, but to offset Iranian influence.

A final major area of discussion was Jordan's relationship with the new Israeli government. Abdullah labelled a recent meeting he had with PM Bennett as reassuring, and said he trusts the two governments could cooperate on security and other issues. Although Jordan and Israel have a peace treaty, relations remained tense during Netanyahu's long tenure as prime minister. However, this time though King Abdullah has apparent support of POTUS, he also will have to outmanoeuvre his younger rivals like Sheikh Mohammed of the UAE and Prince MBS of Saudi Arabia to regain the regional Islamic leadership.

lice Forces (CAPFs)."

J&K Government's order also required the district magistrates to ensure "all such persons, whose licenses are revoked, to deposit their arms and ammunition with the officer in charge of the nearest police station, failing which action, as warranted under the law, will be initiated". The probe brought under its scanner the district magistrates from the various districts which had witnessed the issuance of most of the licenses.

As the CBI raids would imply, the probe into the case is still ongoing. One can only hope that this time round it reaches its logical conclusion.

# Exploitation of the Fragile Himalayas

ine tourists were killed and three others injured in Himachal Pradesh's Kinnaur district on Sunday when boulders fell on their vehicle during multiple landslides, triggered by heavy southwest monsoon rains. On July 12, heavy rain-triggered flash floods in the state's Kangra district swept away three people, buildings, and vehicles. Uttarakhand too has seen its share of natural disasters this year, starting with the massive flash flood in Chamoli in February that killed more than 80 people.

The Himalayan landscape is susceptible to landslides. Formed due to the collision of Indian and Eurasian plates, the northward movement of the former puts continuous stress on the rocks, rendering them weak and prone to landslides and earthquakes. This, combined with steep slopes, rugged topography, high seismic vulnerability, and rainfall, make a deadly cocktail. Top this with the utter disregard for the fragile topography and climate-sensitive planning. From the mega road expansion project in the name of national security (Char Dham Highway) to building cascading hydroelectric power projects, from unplanned expansion of towns to unsustainable tourism (even in the middle of the pandemic), the Indian State has ignored warnings about the fragile ecology. Such an approach has also led to pollution, deforestation, and water and waste management crises.

It is important to have early warning and better weather forecast systems, and a trans-boundary coalition of Himalayan countries to share and disseminate knowledge about the mountains. But what is most critical is to review the area's present status and draw up a sustainable plan that respects the specific requirements of this fragile region and the impact of the climate crisis.

major journalistic investigation has found evidence of malicious software being used by governments around the world, including allegations of spying on prominent individuals.

From a list of more 50,000 phone numbers, journalists identified more than 1,000 people in 50 countries reportedly under surveillance using the Pegasus spyware. The software was developed by the Israeli company NSO Group and sold to government clients.

Among the reported targets of the spyware are journalists, politicians, government officials, chief executives and human rights activists.

Reports thus far allude to a surveillance effort reminiscent of an Orwellian nightmare, in which the spyware can capture keystrokes, intercept communications, track the device and use the camera and microphone to spy on the user.

#### How did they do it?

The Pegasus spyware can infect the phones of victims through a variety of mechanisms. Some approaches may involve an SMS or iMessage that provides a link to a website. If clicked, this link delivers malicious software that compromises the device.

Others use the more concerning "zero-click" attack where vulnerabilities in the iMessage service in iPhones allows for infection by simply receiving a message, and no user interaction is required.

The aim is to seize full control of the mobile device's operating system, either by rooting (on Android devices) or jailbreaking (on Apple iOS devices).

Usually, rooting on an Android device is done by the user to install applications and games from non-supported app stores, or re-enable a functionality that was disabled by the manufacturer.

Similarly, a jailbreak can be deployed on Apple devices to allow the installation of apps not available on the Apple App Store, or to unlock the phone for use on alternative cellular networks. Many jailbreak approaches require the phone to be connected to a computer each time it's turned on (referred to as a "tethered jailbreak").

Rooting and jailbreaking both remove the security controls embedded in Android or iOS operating systems. They are typically a combination of configuration changes and a "hack" of core elements of the operating system to run modified code.

In the case of spyware, once a device is unlocked, the perpetrator can deploy further software to secure remote access to the device's data and functions. This user is likely to remain completely unaware.

Most media reports on Pegasus relate to the

compromise of Apple devices. The spyware infects Android devices too, but isn't as effective as it relies on a rooting technique that isn't 100% reliable. When the initial infection attempt fails, the spyware supposedly prompts the user to grant relevant permissions so it can be deployed effectively.

#### But aren't Apple devices more secure?

Apple devices are generally considered more secure than their Android equivalents, but neither type of device is 100% secure.


Apple applies a high level of control to the code of its operating system, as well as apps offered through its app store. This creates a closed-system often referred to as "security by obscurity". Apple also exercises complete control over when updates are rolled out, which are then quickly adopted by users.

Apple devices are frequently updated to the latest iOS version via automatic patch installation. This helps improve security and also increases the value of finding a workable compromise to the latest iOS version, as the new one will be used on a large proportion of devices globally.

On the other hand, Android devices are based on open-source concepts, so hardware manufacturers can adapt the operating system to add additional features or optimise performance. We typically see a large number of Android devices running a variety of versions — inevitably resulting in some unpatched and insecure devices (which is advantageous for cybercriminals).

Ultimately, both platforms are vulnerable to compromise. The key factors are convenience and motivation. While developing an iOS malware tool requires greater investment in time, effort and money, having many devices running an identical environment means there is a greater chance of success at a significant scale.

While many Android devices will likely be vulnerable to compromise, the diversity of hardware



and software makes it more difficult to deploy a single malicious tool to a wide user base.

#### How can I tell if I'm being monitored?

While the leak of more than 50,000 allegedly monitored phone numbers seems like a lot, it's unlikely the Pegasus spyware has been used to monitor anyone who isn't publicly prominent or politically active.

It is in the very nature of spyware to remain covert and undetected on a device. That said, there are mechanisms in place to show whether your device has been compromised.

The (relatively) easy way to determine this is to use the Amnesty International Mobile Verification Toolkit (MVT). This tool can run under either Linux or MacOS and can examine the files and configuration of your mobile device by analysing a backup taken from the phone.

While the analysis won't confirm or disprove whether a device is compromised, it detects "indicators of compromise" which can provide evidence of infection.

In particular, the tool can detect the presence of specific software (processes) running on the device, as well as a range of domains used as part of the global infrastructure supporting a spyware network.

#### What can I do to be better protected?

Unfortunately there is no current solution for the zero-click attack. There are, however, simple steps you can take to minimise your potential exposure — not only to Pegasus but to other malicious attacks too.

1) Only open links from known and trusted contacts and sources when using your device. Pegasus is deployed to Apple devices through an iMessage link. And this is the same technique used by many cybercriminals for both malware distribution and less technical scams. The same advice applies to links sent via email or other messaging applications.

2) Make sure your device is updated with any relevant patches and upgrades. While having a standardised version of an operating system creates a stable base for attackers to target, it's still your best defence.

If you use Android, don't rely on notifications for new versions of the operating system. Check for the latest version yourself, as your device's manufacturer may not be providing updates.

3) Although it may sound obvious, you should limit physical access to your phone. Do this by enabling pin, finger or face-locking on the device. The eSafety Commissioner's website has a range of videos explaining how to configure your device securely.

4) Avoid public and free WiFi services (including hotels), especially when accessing sensitive information. The use of a VPN is a good solution when you need to use such networks.

5) Encrypt your device data and enable remotewipe features where available. If your device is lost or stolen, you will have some reassurance your data can remain safe.

# Breakthrough COVID-19 Infections: What Vaccinated People Need To Know

Breakthrough coronavirus cases are disappointing - but most of them are also evidence that the shots are working.

Reports of people experiencing breakthrough coronavirus infections after getting vaccinated keep surfacing. It can be alarming to read headlines about ore people getting sick or stories about the aw-

ful symptoms that come with it.

But these cases don't mean the shots are a failure it means they're working.

When the scramble for a COVID-19 vaccine started last year, health officials were hopeful one would have even just 50% efficacy against severe disease and death, said Monica Gandhi, an infectious diseases specialist at the University of California, San Francisco. "Even a notso-great vaccine would make a huge dent in the pandemic," she added. All three vaccines available in the United States have performed much better than that.

"It was so astounding. And that's what played out in the real world," Gandhi said. According to the Centers for Disease Control and Prevention, 97% of people who were hospitalized because of COVID-19 were unvaccinated; 99.5% of fatalities are among unvaccinated individuals. If you're vaccinated, you don't have to worry about getting very sick or dying.

That is the goal of the COVID-19 vaccines. That has always been the overall goal. Getting a mild case of the coronavirus after you've been fully vaccinated can also be looked at as evidence that the inoculation is doing its job. It's likely not going to turn into anything worse something that wasn't a guarantee before the vaccines.

It's fair to be concerned after all, no one wants to get sick in any form but there's no reason to panic right now if you're vaccinated. Here's why:

#### Overall, breakthrough cases are the exception, not the rule.

It may appear that there are scads of new COVID-19 cases in people who are fully vaccinated. But keep in mind that social media can be an echo chamber. Additionally, there are more than 200 million people who have received a vaccine, so cases will happen just based purely on mathematical possibilities. Still, they're rare.

"Of course, you're going to hear stories here and there of people who are fully vaccinated and catch COVID because there are a lot of us out there who are fully vaccinated," said Megan Ranney, an associate professor of emergency medicine and associate dean of the School of Public Health at Brown University. "But the people who are in the hospital are people who were not vaccinated. Just remember that although there are those few stories out there, those should not be enough to make you shun the vaccine."

### And this is likely happening because we're returning to our pre-pandemic lives.

The vaccines aren't becoming useless. Many



are just taking fewer precautions after the shots.

"Back in February, March and April, most folks were still masking, avoiding travel and avoiding restaurants. Now everyone is doing everything," Ranney said. "The fact that there are infections doesn't mean that the vaccine is somehow failing. It just means that people are being exposed to the virus with no other protection other than the vaccine."

#### Breakthrough cases are mostly asymptomatic or mild.

A majority of breakthrough cases will either come with no symptoms or what doctors consider mild. That doesn't mean that the illness won't feel horrible; it may feel like a terrible cold or the flu.

But, as mentioned, that can be seen as a sign that the vaccine is doing its job. Your immune system is remembering how to fight off the virus and prevent it from becoming severe a way better outcome than what happened before the shots were being distributed.

### Experts don't currently believe breakthrough infections will lead to long COVID for most people.

Long-term complications have occurred with even mild cases of COVID-19. Long-haulers are living with debilitating symptoms, such as nerve pain, neurological issues, fatigue and oxy-

gen complications. Experts don't believe that will be the case following breakthrough infections because your immune response will attack the virus a lot faster.

"It's really the disregulated immune response that happens with a natural infection where it takes you a while to clear it that causes long COVID," Gandhi said. "With the vaccine in place, your immune system kicks in quickly and ... it goes specifically toward that virus to get it out of your system. It also doesn't trigger this crazy immune response that can make you so sick."

Gandhi noted that this is being studied to confirm the hypothesis, however right now there's no reason to assume otherwise overall. There have been some reports of people experiencing long-term symptoms, but they appear to be rare. As time goes on, we'll have more data to make a definitive conclusion.

#### If you're still not convinced, use the seatbelt analogy.

Just because you know someone who got into a car accident while wearing a seatbelt doesn't mean that you believe seatbelts are useless.

"Seatbelts prevent you from getting really hurt. They don't prevent you from getting in a crash and if you get in a bad crash, you might get hurt even though you're wearing a seatbelt. But it's going to protect you, for the most part, from injuries," Ranney explained.

Think of the vaccines in the same way. At the end of the day, we're so much better off with them. That's the point.

# Study links ultra-processed food to higher risk of IBD

new study has shed light on the adverse effects of consuming ultra-processed food items. According to the research, a higher intake of ultra-processed food is associated with an increased risk of inflammatory bowel disease (IBD).

The findings of the study were published in the journal 'The BMJ'.

Ultra-processed foods include packaged baked goods and snacks, fizzy drinks, sugary cereals, ready meals containing food additives, and reconstituted meat and fish products - often containing high levels of added sugar. fat and salt, but lacking in vitamins and fibre.

IBD is more common in industrialised nations and it is thought that dietary factors might play a role, but data linking ultraprocessed food intake with IBD are limited.

To explore this further, an

international team of researchers drew on detailed dietary information from 116,087 adults aged 35-70 years living in 21 low, middle, and high-income countries who were taking part in the Prospective Urban Rural Epidemiology (PURE) study.

PURE is examining the impact of societal influences on chronic diseases in different countries around the world.

Participants were enrolled in the study between 2003 and 2016 and were assessed at least every three years. Over an average follow-up

of 9.7 years, new diagnoses of IBD, including Crohn's disease or ulcerative colitis, were recorded. During this time, 467 participants developed IBD (90 with Crohn's disease and 377 with ulcerative colitis). After taking account of other potentially influential factors, the researchers found that a higher intake

of ultra-processed food was associ-

ated with a higher risk of IBD. For example, compared with less than one serving of ultra-processed food per day, they found an 82 per cent increased risk of IBD among those who consumed five or more servings per day, and a 67 per cent increased risk for 1-4 servings per dav

Different subgroups of ultra-pro-cessed food, including soft drinks, refined sweetened foods, salty snacks, and processed meat, each was associated with higher risks of IBD

In contrast, intakes of white meat, red meat, dairy, starch, and fruit, vegetables, and legumes (such as peas, beans and lentils) were not associated with IBD.


Results were consistent for Crohn's disease and ulcerative colitis, and were similar after further analysis to test the risk of developing IBD based on age and region, suggesting that the findings are ro-

> bust. This is an observational study so can't establish causality. What's more, results relied on self-reported diagnoses and did not account for dietary changes over time. And the researchers cannot rule out the possibility that other unmeasured (confounding) factors may have affected their results.

Nevertheless, they said their findings "support the hypothesis that intake of ultra-processed foods could be an environmental factor that increases the risk of IBD.'

As white meat, unprocessed red meat dairy starch and fruit veg etables, and legumes were not found to be associated with the development of IBD, this study suggests that it might not be the food itself that confers this risk but rather the way the food is processed or ultraprocessed, they explained.

'Further studies are needed to identify specific potential contributory factors among processed foods that might be responsible for the observed associations in our study. they concluded.

# J&K Bank Cashier 'Manhandles' Customer In Handwara



# **Scottish Climber Dies** In Avalanche On K2: **Pakistani Official**

ISLAMABAD: A renowned Scottish climber died in an avalanche while attempting to scale K2 in northern Pakistan, the world's second-highest mountain peak, a Pakistani mountaineering official and the charity said Monday.

Rick Allen, 68, died in the avalanche three days ago while trying to reach the summit along a route that had not been attempted previously on the mountain's southeast face, said Karrar Haidri, the secretary of the Alpine Club of Pakistan.

Allen's two climbing partners survived the avalanche and were subsequently rescued, Haidri added. Their expedition was aimed at raising funds for the U.K.-based charity Partners Relief & Development, where Allen was a board member. The charity, which works for the welfare of children, confirmed Allen's death on its Facebook page.

An experienced and veteran climber, Allen was involved in an avalanche and was rescued in 2018 when he was scaling Broad Peak, which like K2 lies also in the Karakoram Range, along the Pakistan-China border.

"Rick died doing what he loved the most and lived his life with the courage of his convictions," said



the charity's statement.

Pakistan is home to several top mountain peaks and climbers flock from all over the world to attempt to scale the summits.

Earlier this year, three climbers – Pakistani mountaineer Ali Sadpara, Jon Snorri of Iceland and Juan Pablo Mohr of Chile – died while attempting to summit the 8,611-meter (28,250-foot) high K2. Their bodies could not be traced and retrieved despite several attempts by Pakistani search and rescue team aided by the military.

Last week, famous South Korean climber Kim Hong Bin fell into a crevasse and went missing in bad weather after scaling the 8,047-meter (26,400-foot) high Broad Peak. A rescue operation to try and find him has been put on hold because of bad weather.

### **Three Athletes Among** 16 New COVID Cases At **Tokyo Olympics**

TOKYO: The COVID-19 infections associated with the Tokyo Olympics rose to 148 after organisers reported 16 new cases on Monday, including three athletes.

The organisers, in their daily COVID-19 update, announced that three athletes, four contractors, eight Games-concerned personnel and one Games employee have been found to be COVID positive. All the three athletes are not residents of the Olympic Village, which has reported 16 cases since it was opened.

One Games-connected personnel and a contractor are residents of Japan in the fresh additions.

The three athletes and seven Games-concerned personnel have been put under the mandatory 14day quarantine.

The total number of Gamesconcerned personnel to have tested positive so far stood at 83 after the addition of 8 new cases.

The contingents that have been hit by COVID-19 after landing in Tokyo include Czech republic, the USA, Chile, South Africa and the Netherlands among others.

Of these, the Czech Republic is inquiring into possible health safety protocol violations by its contingent after four athletes tested positive for the virus, forcing withdrawals from beach volleyball and road cycling events. On Monday, the organisers urged the media covering the Games to adhere to

COVID-19 protocols, saying that they have been "made aware of incidents of alleged non-compliance". They warned of "disciplinary con-

sequences" for violating laid down rules on health safety precautions.

### 58-Year-Old Al-Rashidi **Gets His Olympic Moment** With Kuwaiti Flag

TOKYO: Abdullah Al-Rashidi pulled a Kuwaiti flag from his pocket and draped it over his shoulders, a huge smile beaming beneath his bristly mustache.

Olympian wrapped the black, red, green and white cloth around his face, kissed the corner and raised his arms before waving to the crowd. Olympic protocols forbid athletes

from displaying their country's flag before the medal presentation. Al-Rashidi didn't care. He was not

recognized as a Kuwaiti athlete at the Rio de Janeiro Olympics five years ago and he couldn't wait to honor his country after winning a second straight skeet-shooting bronze.

"I am happy too much to see my Kuwaiti flag and second Olympic medal," Al-Rashidi said after Monday's skeet final at the Tokyo Games. Al-Rashidi was a big hit on the

Rio skeet range five years ago, waving his arms and pumping his fists to work up the mostly-Brazilian crowd. Shooting in his first Olympic final,

the three-time world champion who trains falcons in his off time thrived on the sport's biggest stage, riding the fans' energy to a bronze medal. After winning the bronze in Rio,

Al-Rashidi raised his arms in the air, dropped to his knees and kissed the ground. He rose and threw his hat in the air as the crowd chanted in Portuguese: "Ole, ole, ole, Mustache!"

The only disappointment: He was considered an independent athlete, not a Kuwaiti. Kuwait's national Olympic com-

mittee was suspended by the IOC for government interference so Al-Rashidi and his compatriots at the Rio Games had to compete as part of an independent team. That meant no team uniform - he wore the jersey of the English soccer club Arsenal - no Kuwaiti flag nor national anthem should anyone win gold.

Some of the shine taken off his first Olympic medal, Al-Rashidi stood on the podium with his head down during the ceremony.

"I didn't like seeing the Olympic flag," he said. "I needed to see my flag, the Kuwaiti flag.'

## Israeli Judoka Left To Ponder After Two **Opponents Withdraw Citing Palestine**

TOKYO: Tohar Butbul could only shake his head in resignation after the Israeli judo star's first two potential opponents dropped out of the Tokyo Olympics shortly before they would have faced him.

These are things that sometimes occur in judo, so it wasn't that odd for me," Butbul said through a translator. "I just had to wait, stay focused and wait for my first chance."

Algeria's Fetih Nourine withdrew from the Games on Saturday when he learned he would meet Butbul if he advanced to the second round Monday, explicitly citing his support for Palestinians for his decision.

On Monday, Sudan's Mohamed Abdalrasool didn't show up to face Butbul in their round of 32 bout despite weighing in earlier.

Abdalrasool didn't make a public statement about his decision, but Butbul said his team was told Abdalrasool had a shoulder injury - a reason that didn't exactly convince Butbul or the Israeli team.

Nourine and his coach were swiftly suspended by the International Judo Federation last weekend. The Algerian Olympic committee withdrew both men's accreditations and made plans to send them home.

The IJF didn't comment on Abdalrasool's withdrawal after sharply criticizing Nourine, who also quit the World Judo Championships in 2019 right before he was scheduled to face Butbul at the Budokan, the site of the Tokyo Olympics.

Butbul is ranked seventh in the world at lightweight. He likely would have manhandled Nourine, who is



ranked 31st, or Abdalrasool, who is 469th and only got into the Olympics through a late invitation.

With an unimpeded path to the round of 16, Butbul beat Victor Sterpu of Moldova and advanced to the quarterfinals against South Korean star An Changrim, who beat him

with a waza ari. Butbul then lost to Arthur Margelidon of Canada in repechage, ending his first Olympics effectively in seventh place.

Butbul refused to talk about politics after his eventful day, instead lamenting his athletic shortcomings. "I came with a pure aim to win

a medal, and it's very hard for me to bear that I didn't fulfil my own expectations," Butbul said. "That was the goal I put into the whole of my career. It's still too early for me to understand what happened. I wasn't precise in executing my plan, but in judo sometimes there is a gap

between how you plan and what is in reality.'

The governing body of judo has been firm in its anti-discrimination policies and strong support of Israel's right to compete in recent years.

In April, the IJF suspended Iran for four years because the nation refused to allow its fighters to face Israelis. The IJF said Iran's policies were revealed when former Iranian judoka Saeid Mollaei claimed he was ordered to lose in the semifinals of the 2019 world championships in Tokyo to avoid potentially facing Israeli world champion Sagi Muki in the finals.

Butbul's teammate, Timna Nelson Levy, also fell just short of a medal, losing to Tsukasa Yoshida of Japan in the quarterfinals and losing her repechage bout to Kaja Kajzer of Slovenia.

Israel has won 10 medals, half of them in judo, in its Olympic history.

The 58-year-old seven-time
