CASO Continues In Bandipora Forest

SRINAGAR: The Cordon and Search Operation (CASO) by security forces entered its fourth day on Tuesday in the woods of north Kashmir district of Bandipora. So far three Lashker-e-Toiba (LeT) militants were killed and a soldier of 14 Rashtriya Rifles (RR) was injured in the encounter which ensued on July 24 at Shokbaba forest Sumblar in Bandipora. Official sources said more security forces from different areas have joined the CASO in the densely forest in Bandipora as three to four militants are reportedly trapped there. However, so far no fresh contact has been reported after Saturday's encounter, they said.



Court Again Rejects Parra's Bail Plea

Says 'Prima Facie' Terror Charges 'True At This Stage'

SRINAGAR: The bail application of PDP leader Waheed-ur-Rehman Parra, a close aide of former chief minister Mehbooba Mufti, has been rejected for the second time in five months by a special court which said "prima facie" terror charges levelled against the accused seem to be "true at this stage". The 24-page bail order passed by the special NIA court here, however, rejected the contention of the prosecution that a fresh bail application should not have been entertained by the court as no fresh development has taken place since the last rejection in February. While rejecting Parra's bail application, the special judge said the contention raised by the defence counsel "herein cannot be considered at this stage and the good grounds do not exist at this stage which would warrant the release of the accused herein on bail in view of the given facts and circumstances governing the matter in hand". '... And at present I am satisfied in view of the material placed on the record that the alleged offences leveled against the accused/applicant (Parra) herein appears to be prima facie true at this stage," the order said. s the lately-proscribed drone snaps the signature **N**ensemble of Kashmir's grand mosque, the funny man whose pranks have become a debated online laughter makes an entry on a hand-pulled cart – singing: "One minute up, one minute down, Baby this is Down Town." A telling trajectory of the love-hate facts about the city of seven bridges follows.

Makers of 'Down Town' video song have blended humour with different hues of life in Shehre-Khas. Apart from immaculate visual storytelling, lyrics and tunes are making it an engaging number. Sung my protagonist Musaib Bashir who goes by his stage name, Mr. Musaib, the song captures the characteristic pulse of downtown.

Days after his song got released and praised for its content and creativity, Musaib is attending endless calls from unknown "fans" inside his fabric store in downtown's Saki Dafar area. To every wish and praise, the entertainer armed with a Masters in Commerce degree replies to everyone in a jest manner.

"This song is my tribute to my city, my downtown," Musaib says. "I've only tried to maintain my own style in the video.'

Three years ago, when his debut funny video went viral, the "shy person" was thrown out

of his home for his antics. But that hardly stopped him staging some uncanny street performances. Amid lockdown, he was seen pulling off a "Pepsi bottle" prank in the trade-heartland of Srinagar and almost faced the wrath of paramilitary personnel. Jammu and Kashmir hereby directs that all Clinical Establishment(s)/Hospital(s) situated within the territorial jurisdiction of Union territory of Jammu and Kashmir having more than 50 beds shall establish an Oxygen Generation Plant of appropriate capacity for facility of patient care," reads the order issued by

The Estates Departments, it said, shall devise a proper mechanism for issuing hassle-free NoCs/Clearances, in favour of employees both at Jammu and Srinagar.

On June 20, the Lieutenant Governor Manoj Sinha had announced that the Jammu and Kashmir administration has completely transitioned to e-office, thereby ending the 149-year-old practice of the biannual durbar move.

The practice of durbar move has been a part of the J&K administration since 1872 when it was introduced by Maharaja Ranbir Singh. Srinagar serves as the summer capital of J&K, while lammu is the winter capital. The administration used to function in Jammu during the six months of winter and in Srinagar during the summer.

The practice was continued later with the aim of providing governance benefits to both Kashmir and Jammu regions for six months by turns. (GNS)

2600 Flats For

its approval for construction of 2744 flats at an estimated cost of Rs. 356 crore; as transit accommodation on the G+3 and G+5 models at seven locations in Kashmir division." he said.

The project, he said, is expected to be completed in 18 months and will provide employment to approximately 413 skilled and unskilled workers on a daily basis during its life cycle.

"On completion, the residential buildings will provide Government accommodation with basic services to the Kashmiri migrant employees engaged under the Prime Minister's Relief Package," the official spokesperson said.

Earlier in 2015 under the Prime Minister's Development Package, he said, the Government of India approved the construction of 6000 additional transit accommodation units in Kashmir valley for employees appointed under the package, with the sanctioned cost of Rs. 920 crore.

The president said Kashmir is the meeting point of various cultures and it is impossible to write a history of Indian philosophy without referring to the region's contributions to it.

"One of the oldest manuscripts of the Rigveda was written in Kashmir. This is the most conducive region for philosophies to prosper.

'In medieval times, it was Lal Ded

in the land of great historical and cultural significance.

It has been called "Rishi Vaer" or the land of seers and has always attracted spirituality seekers from far and wide, he said, adding, "I feel blessed standing on this land, which is not only a reservoir of wisdom but is also endowed with unparalleled natural beauty," he said.

The president said close to three lakh students would receive their degrees on Tuesday.

"With more than 2.5 lakh bachelor degree holders and over 1,000 doctorates in the last eight years, the university has made remarkable progress," he added.

The spokesman said that Amir had a long history of cases which included firing upon the motorcade of SP Shopian at Landoora Hermain Crossing in which the vehicle of SP Shopian got damaged, kidnapping of three Police personnel from their homes at Batagund Kapran area on 21 September 2018 and subsequently killing them.

"Besides, he was also involved in a series of attacks on Police/Security establishments. He was also part of a group involved in firing upon the Army Camp at Mantribugh Shopian and Police Station Shopian, besides threatening local Panchs.'

Parra's counsel Shariq Reyaz had urged for cancellation of the FIR uncourt and the issue raised can only be properly addressed after the trial of the case and it is premature stage to assess and decide" whether the two cases -- one probed by the NIA and the second by police -- are the same

or not. The judge said that the points raised by the defence counsel can only be addressed during the course of the trial.

start for you?

Well, let me first tell you, I'm a fulltime businessman and a part-time comedian.

For someone like me born in Nawa Kadal area, Downtown and its intrigues instilled that sense of humour from the word go. Someone out there might find my antics eerie, but I'm only expressing that signature street humour of downtown.

Back in 2018, when I was an extremely shy and camera-conscious person, a friend introduced me to an application where I could record video with a background audio. I recorded my satirical expressions and uploaded them on Facebook. Within days I was a viral sensation around Kashmir.

After that, I decided to create my own content and fill Kashmir's entertainment space with my familyfriendly content with social-messages. People liked my humour and with a span of just three years, my Instagram followers went up from 20 to 70K.

But do you think your pranks and satire have found acceptance in people?

Let me tell you, my father threw me out of the house for my so-called antics. But now, he understands the difference.

In Kashmir, there's acceptance towards decent and dandy content. Just look at Pakistani serials. Because of their decent storyline, they've more acceptance in Kashmir compared to Indian dramas. Akin to those serials, I try to avoid grossness or rudeness. I personally believe that decency is the basic ingredient of viral content.

But having said that, we could've created our own slot and spot in the world by investing in our creative content all these years. Kashmiri entertainment industry was much more popular than the Punjabi entertainment industry once. It had everything-from Sufism to Nature-but we Kashmiris never invested in it.

How do you want to change this as a content creator?

Well, I want people to invest in content-creators and help them to achieve their goals, rather than pulling them down. If there's no unity and effort, then how can we expect decent content?

Personally, for me, even if one of my followers follows my way of working and creates something unique out of his own perspective, that's where I'll feel as if I've achieved everything.

CASO Continues

It was stated in the complaint that the complainant had already paid Rs 10,000/- to the GRS as demanded by him but the GRS still refused to perform the work of complainant until he was paid in full, it added.

Based upon the facts disclosed in the complaint which prima facie constituted an offence under section 7 of the PC Act 1988 r/w Section 120-B IPC, an FIR No. 06/2021 was registered in P/S Central ACB, J&K on 26-07-2021 against the accused persons namely BDO Changa, Asif Ahmad Chandel, Mansoor Ahmad Gram Rozgar Sewak (GRS), Block Changa and JE Arshad Amin. A trap team was constituted whereupon the accused JE Arshad Amin was caught red handed while accepting the bribe of Rs 17,000.

He has been arrested in the case. Gram Rozgar Sewak is absconding and all efforts are being made for his sustained investigation, the statement said. adding that further investigation in the case is under progress.



Amnesty: Children unprotected In J&K

RINAGAR - The unlawful killing of three teenaged boys and the serious injuries to a fourth boy during the last Weekend in Bangergund village in Kupwara throws into sharp focus the lack of protection for children's right to life and safety in the state, global human rights watchdog, Amnesty International said today.

"Children are at risk of human rights violations from both state agents and abuses from armed groups" Amnesty said in faxed statement to Kashmir Observer. "Amnesty International urges both the state government and armed groups to respect the rights of children", the statement said adding the government of Jammu and Kashmir is under an international obligation to promote and protect child rights in line with India's ratification of the United Nations Convention on the Rights of the Child. Armed groups are under an obligation to abide by the standards of humanitarian law which strictly forbid the torture, killing and hostage taking of all civilians, including children, amnesty further said.

An army spokesperson stated that 'the four Juveniles, all between 11 and 15 years of age, were shot on 24 July 2005 in Bangargund village in Kupwara district when troops of the 6th battalion of the Rashtriya Rifles opened fire on the four teenagers whom they mistook for militants. The boys had started to run away when an army patrol called on them to stop in an area close to the line of control.

Villagers claimed that the juveniles were part of a marriage party and had gone for a stroll in the village in the early hours of Sunday when soldiers opened fire before the boys could reply to their commands. According to reports, there was no curfew in the area. Local villagers claim that the village elders had informed the army of the marriage party and that people were likely to move about late at night.

An army spokesperson termed the incident as 'unfortunate' and announced that the army would cooperate with a magisterial inquiry set up by State Chief Minister Mufti Mohammad Sayeed. The army also ordered an internal inquiry. Police have registered a case against the army. On dozens of occasions the armed groups have perpetrated indiscriminate attacks which have affected children. They have exploded bombs close to schools resulting in the deaths of several children and causing parents to fear for the safety of their wards.

KO VIEW Lingering stand-off

ndia has moved key elements of the Army's "1 Strike Corps" otherwise tasked westwards, to eastern Ladakh, media reports have said. This includes armoured formations, infantry combat vehicles, besides troops. This effectively means that the formations of the Mathurabased One Strike Corps have also been reoriented towards the Northern border. The Army has also deployed over 15.000 additional troops in eastern Ladakh to counter China. These troops were part of the army's counter-insurgency units in Jammu and Kashmir.

If anything this shows there has been little change in the situation along the Line of Actual Control since China staged incursions along its four points and captured around 1000 square kilometre land. Though the two countries have since resolved the stand-off along Pangong Tso lake, the stalemate along the other three points - Galwan Valley, Hot Springs and Gogra - persists. And it is unlikely to end anytime soon. And considering the two countries are only bolstering their troop presence in Ladakh, the conflict looks set to continue for now.

India wants China to go back to status quo ante as it existed in April last year but Beijing is in no mood to do so. On the contrary, the People's Liberation Army has enhanced its military profile on the border by deploying thousands of its soldiers and equipment. In recent years China has reportedly more than doubled its total number of airbases, air defence positions and heliports near the Indian border.

This has now become a high stakes war of nerves between the two countries. However, this time New Delhi is approaching the situation very cautiously and waiting if China's intermittent statements of reconciliation are translated into action. There is also the realisation that the complete de-escalation will be a long haul.

The current stand-off with China has been the bitterest since the 1962 war. This time China has aggressively asserted its claim to its side of the LAC and also captured strategic areas in Galwan Valley, Hot Springs and Gogra besides trying to push in along the LAC in Arunachal Pradesh and Sikkim. So, resolving these issues will take time. But the dis-engagement in Pangong Tso is a positive development. This allowed for dialogue to take place. A lot will depend on China's behaviour in the near future. We can only hope that the communist country sticks to the path of dialogue and gives precedence to sorting out the issues peacefully than unilaterally changing the facts on the ground.

Precarious Primary School Education in Kashmir

Due to triple lockdowns, primary school education has suffered the most in Kashmir

chool-going children in Kashmir have been badly affected by the triple lockdown. Nearly 2 million kids have missed around two years of formal schooling. Following the revocation of Article 370 on 5 August 2019, curfew, communication blockade and hartal kept schools closed for many weeks. In spring 2020, schools in Kashmir were closed due the first wave of Covid-19 pandemic. Then the so-called 'second wave' (of Covid-19) struck and schools were again closed under Government Order No. 91-Edu of 2021, dated 04.04.2021.

Although teaching switched to online mode globally, Kashmiri students and teachers faced internet issues. Authorities restored highspeed 4G Internet only in February 2021, after a 550 days ban. According to BBC News (23 June 2021) "students from more than 150 villages in the area [Kashmir] have had no access to online lessons.³

The triple lockdown is a unique context which has created a uniquely challenging situation for Kashmiri students, particularly from the economically weaker sections who lack resources to navigate the crisis. Prolonged school closures and continuous disruption during the formative years of primary education is especially concerning, because students lose out on developing basic cognitive (and acquiring) other skills.

Specific context of Kashmir as a site of a protracted armed conflict makes the crisis all the more serious. Because prolonged disruption of studies of children could potentially add to the dynamics that have a bearing on the mental health of Kashmiri children, and in turn on the political situation in the region. Amit Sen, a child and adolescent psychiatrist, visited Kashmir during the 2019 military lockdown and later wrote in his article 'A Childhood Denied' (Indian Express, 31 Jan 2020) that "Children and adolescents who could access mental health services, were reporting all kinds of abuse (physical, sexual and emotional) and nightly raids by security forces — as corroborated through reports from other members of our group who had visited villages and towns in different districts — which had created an atmosphere of terror and panic amongst young people and their families. They shared experiences of paralysing fear, acute anxiety, panic attacks, depressive-dissociative symptoms, post traumatic symptoms, suicidal tendencies and severe anger outbursts. There was a marked increase in psychological distress in 70 per cent (as estimated through a recent survey by mental health professionals in the Valley) of the population. Professionals working on the ground expressed concern about the aftermath of this imbroglio and feared that the trauma suffered by thousands of people will become evident in the months and years to come.' Sen argued that "repetitive, violent trauma in endemic war zones can be deeply damaging for the community, especially children and adolescents, who could be scarred for life. and pass on their fear and anger to generations that follow. They don't need to be tutored or indoctrinated to form extreme attitudes and prejudices. According Dr Majid Shafi, a clinical psychiatrist based in Srinagar, "Almost every parent of kids and teenagers in Kashmir is complaining these days about increased behavioural issues in their children." Dr Shafi's assessment is that there is an increase in symptoms such as "a feeling of hopelessness, anxiety, mood disorders, and a decline in academic performance" (as quoted by Majid Maqbool in The Conversationalist, 15 July 2021). About 90% of the children of government primary schools belong to Below Poverty Line (BPL) category, including tribal and other backward categories. So, generally, students of government primary schools come from weaker socio-economic backgrounds - labour class, autorickshaw drivers, agricultural labourers, slum-dwellers, tribal and other BPL families. In comparison, most students of private schools in Kashmir come from middle- and high-income families. This economic disparity affects the outcome in terms of who gets better education



or in the present context of an unprecedented health crisis, who manages to receive sufficient classes and get to participate in relatively better (alternative) learning processes. A positive aspect of online teaching has been that the process became a learning experience for parents as well. A parent whose kid studies in a private school in Pampore

said about online classes that "It is not only kids who are learning, but us parents also have learnt so many things - like writing techniques, activities, pronunciation etc." But this is a privilege that most government school students' parents do not have because they are from working-class

backgrounds. While government schools started online teaching classes around the same time the private schools did, they were less successful than private schools. Main reasons for this are lack of parental guidance, lack of smartphones, and poor internet connectivity (because rural areas in Kashmir usually have patchy internet). Other reasons could be related to psychological issues, such a lack of motivation among students due to the chronic crisis. But that needs to be properly researched.

Keeping in view the limitation of online teaching in the context of Kashmir, Directorate of School Education Kashmir started 'community classes', which have been somewhat successful. Community classes are taken in open air, usually in the school grounds or in commons closer to the school, with students kept at a 2-meter distance from each other. Classes run from 8-10 AM. According to India Blooms News Service (17 July 2021), both government and private school students have benefited from the communityclasses. Online classes should continue for the connected children through Learning Management System (LMS) or Real Time Video Conferencing Apps or conference calls and other digital platforms."

However, in effect, community classes have replaced online mode of teaching. Because community classes are relatively more effective than online teaching. At least, this is what teachers from District Pulwama told me. A Zonal Education Officer (ZEO) from one of the Tehsils of the district told me that "Primary schools were badly hit by the pandemic lock down due to having a delicate lot of learners prone to infection. Due to non-availability of Internet facilities and Android phones with the children, the online teaching could not be held for most of the lock down period. However, it took a measure time with parent's cooperation to make things available but almost only 10 to 20% of students. However, community teaching was of great support."

community-classes Although have been relatively successful, problems still persist. Some of these problems precede the crisis. Firstly, most government primary schools do not have their own grounds. So, they are forced to rent nearby orchards or private properties to conduct their classes. State land abutting many govt schools (that could be transferred to the school department) have been encroached upon by locals. Cooperation from students is mixed many don't attend com-

munity classes regularly. Only some

parents cooperate, most do not ac-

tively involve themselves in their kid's education, because they are

from the working-class. Two hours

(8-10 AM) are not sufficient to cover

to the advanced and well performing schools in and out-side union territory to get well equipped with knowledge and skills. The primary schools need school-maids for proper watch and ward, sanitation, health & hygiene of the students.'

If Kashmir wants to catch up with others, and improve its future human resource, the above-mentioned problems must be immediately addressed through a comprehensive policy backed up substantial investment plan. A silver-lining in this crisis has been that there weren't many drop outs in government schools. In fact, some private school students switched to being government schools (although this was due to the financial crunch brought by the triple lockdown).

Many experts advocate blended learning, but primary stakeholders must be brought on board and a policy must be formulated after receiving their feedback. Parents of govt primary school students seem to be unsatisfied with online mode of teaching. Father of a govt primarv school student from Awantipora, a laborer by profession, told me that "I am not satisfied with online teaching; these kids keep their mics mute and do other stuff than listening to their teachers. I kept my phone at home but my son would play the Free Fire game on it rather than attend his classes. I prefer face to face classes where teachers will at least keep him under discipline." A government school teacher from Awantipora told me, "It (alternative teaching) is just a compensatory thing, to keep students engaged." These views were echoed by some other teachers. A government school teacher from Pampore told me that "We started community classes in 2020, but it was moderately successful. There is marginal engagement of parents in the process, not all students join. We have a roll of 85 students, we have just 3 rooms. We have seven teachers out of which three are on Covidduty." These are important views, and must be considered during policv formulations.

I have focused on primary school students, because in comparison to higher secondary school students they are affected more. Students of higher secondary schools have already acquired basic cognitive skills, so they can manage on their own However, primary class students are learning, and prolonged closure of schools has taken away their crucial formative years of basic learning. Also, schools have been 'informally' asked schools not to fail students. Students who were in Grade 3 in 2019, were promoted to Grade 4 in 2020 and, most probably will be promoted to Grade 5 in 2021. But, since they have not covered the entire syllabus of the previous two classes, they cannot be expected to have the required prior training/ skills to be able to read or adequately understand the syllabus and texts of the class they have not progressed to in a normal way. As a rough analogy, they are like entry level swimmers who must first learn how to properly enter and exit a pool but instead they are being asked to do 50 yards of swimming with different strokes in a local stream without sufficient aid and support. Furthermore, higher secondary school students can get resources/ materials from the internet and photostat shops or from private coaching centres. For primary students there are far fewer options. There are far more coaching centres catering to the high school students than primary school students in Kashmir. During the winter of 2020, private coaching centres worked normally in almost all districts of Kashmir. Therefore, I think the 'triple lockdown' has affected the primary school students more than high school students. But this is a question that requires to be explored through empirical research. A Summary Response

mongst the defining images of the second wave of the pandemic were those of patients gasping for breath outside chaos-riddled hospitals. Innumerable people turned to social media to send out SOS messages for hospital beds and medical oxygen. States accused each other of blocking oxygen tankers at border crossings. On Tuesday, in a written reply to a question in Rajya Sabha, Union Minister of State for Health and Family Welfare Bharati Pravin Pawar acknowledged this crisis, but in a manner that left much to be desired. Noting that the unprecedented surge in the demand for medical oxygen required the Centre's intervention, the minister pointed out that states did not "specifically report" deaths due to lack of oxygen supply. Technically, she is right. There is no established protocol to link Covid deaths with depleted oxygen supplies. Hospital authorities, too, have been wary of making such connections. However, with the desperation caused by the runaway surge in Covid-19 cases easing in most parts of the country, it's time to attempt answering difficult questions. A conversation must begin about the Covid problems, dilemmas and failures — and successes too — in a manner that could catalyse a truer depiction of what happened during the second wave. With its summary response on Tuesday, the Centre let go of the opportunity to initiate such a conversation.

The judiciary in at least three states, Karnataka, Goa and Delhi, has been more sensitive to the trauma of families who lost their loved ones to the oxygen crisis. Earlier this month, the Karnataka High Court ordered the state government to pay compensation to 13 such families. In the last week of April, the Delhi High Court directed the Arvind Kejriwal government to enumerate the oxygen-related toll at the city's nursing homes and hospitals. Creating such a list would no doubt have required joining several dots between accounts of relatives and records generated by doctors, hospital administrators and government agencies. It would have demanded an empathetic attitude to the constraints of hospitals from government investigators and reinvigorating channels of communication between the Centre and states, built during the first wave. This complicated process became even more fraught with the two governments bickering over the formation of the committee to look into claims by patients' families and doctors, forcing the Delhi government to shelve its compensation plans.

It's now evident that the failure to anticipate the second wave — as well as a lot of the devastation caused by the virus - owes much to the poverty of the country's health information system. Much of what happened during this fateful period is in the realm of speculation. The government needs to shine the light, clear the air.

class initiative. By mid-July, around 1,80,407 students from government schools attended community-classes, while 6270 private school students also participated in the community classes in the same period. Top three districts for community class participation are: Anantnag (42,579), Baramulla (39,032), and Pulwama (20,634). It is claimed that around 30,000 government school teachers are engaged in communityclass initiatives.

However, the School Education Department Kashmir treats community classes as "a parallel hybrid learning exercise to supplement the existing Learning Management System (LMS)." That means community-classes cannot replace the online mode of teaching, which is, seemingly, a more preferable alternative for the department. As the official circular (quoted by Greater Kashmir, 30 June 2021) makes clear: "The community school should be prioritised for those children who are not connected through online classes and should in no way be considered an alternative to online

everything. Teachers told me that they can give lessons, but they cannot check homework and conduct other activities. School Department is working with the Health Department and their focus is on managing Covid-19 pandemic. As a result, some schools are facing staff shortage because some of their teachers have been assigned non-academic duties, such as Covid-19 pandemic related surveillance. Most schools have just 3-4 rooms, and lack toilets. Teachers and masters are forced to partition rooms with thin plywood. Noise from one class disturbs others. In some rural schools, there are only fewer teachers for a large number of students, while there are many teachers for a fewer lot of students in some urban areas.

In terms of problems, a ZEO said that "primary schools...are in dire need of furniture with proper seating arrangement. The schools need Internet facilities with all other modern gadgets required for primary teaching. The primary school teachers need specialised training from time to time and explore visits



Deepfakes – New World, New Threats



India's permanent representative to the United Nations, TS Tirumurti , highlighted among other issues, the use/misuse of deep fakes to disturb global peace, fuel misinformation, divisions, and political instability. The concerns about the misuse of deep fakes technology has been the center of a new age of computational propaganda. The elephantine amount of digital photos and videos on various social media platforms may drive modern man into a sinister digital apocalypse. As with any new innovative technology, it can be weaponized to inflict harm.

What is a Deep Fake?

Deepfake is a new media technology wherein a person simply takes existing text, picture, video, or audio and then manipulates, i.e., 'fakes' it to look like someone else using advanced artificial intelligence (AI) and neural network (NN) technology. The data driven machines need a sizable amount of data in a few hundred photos or a few hours of video of any person and can create an entirely new video that seems real. In India, the first noticeable video of deepfake technique was used in the parliamentary election of 2019. Since then, in Asia alone, the number of deepfake videos has been doubling every six months. it a realistic "understanding" of what he or she looks like from many angles and under different lighting. Then they'd combine the trained network with computer-graphics techniques to superimpose a copy of the person onto a different actor. Although a few years ago it took a considerable amount of time to synthesize a near perfect chunk of video, today with better technology driven systems it's synthesizing time is slashing day after day.

What can it do?

In an interview to BBC Professor Hao Li of University of Berkley expressed his opinion and said, "We are already at the point where you can't tell the difference between deepfakes and the real thing. However, the greater threat is the potential for deepfakes to be used in political disinformation campaigns.Elections are already being manipulated with fake news, so imagine what would happen if you added sophisticated deepfakes to the mix?"

It could be even more dangerous in developing countries where digital literacy is very limited. Here, it can really impact public opinion. You can even spread misinformation that can get people killed.

Additionally, another great risk that deepfakes pose is their entry into the world of revenge pornography. Deepfake can create an ep-

lot to worry about, yet again.

Spotting Deepfakes

Detecting deepfakes is a hard problem. Amateurish deepfakes can, of course, be detected by the naked eye. Other signs that machines can spot include a lack of eye blinking or shadows that look wrong. The machine/ software combination that generate deepfakes are getting better all the time, and soon we will have to rely on digital forensics to detect deepfakes—if we can, in fact, detect them at all.

Generally, the masses need to be made aware of the various challenges and threats posed by this technology. We should organize the events to create awareness in the general public. Digital literally is going to play a decisive role in this.

Moreover, the government's role is most important. Its primary duty is to bring in legislation to check the dangers of deepfakes. In its secondary role, it can help to disseminate the information to make the public aware on a greater scale and mobilize various law enforcement agencies and institutions to make necessary steps to counter it. It can also undertake or sponsor research on how to counter it

Internet giants like Google, Facebook and Youtube must also amp up their technology to detect deepfakes before they're posted online. A collaborative effort is needed to nip the mischief in the bud before it is out in the open with no scope for redressal.

How is it created?

The main ingredient in deepfakes is machine learning, which has made it possible to produce deepfakes much faster at a lower cost. s we try to control COVID-19, many people are keen to know what proportion of the population will need to be vaccinated in order to reach "herd immunity".

It's a reasonable question. People are asking because they want to know when we'll see an end to lockdowns; when they'll be able to reunite with loved ones overseas; when their businesses will have more security; when headlines will no longer be dominated by COVID-19.

Right now expert modellers are plugging in numbers and looking at various scenarios to estimate the scope of protection different levels of vaccination coverage will give us. We're expecting to see the results of this modelling from the Doherty Institute as early as this week.

But it's important to acknowledge it's difficult to pin down a single magic number for herd immunity.

What is herd immunity again?

To understand why experts often avoid pinpointing a single vaccination figure needed to reach herd immunity for COVID-19, let's first recap the concept.

Herd immunity is when immunity in a population is high enough to block the pathway for the ongoing transmission of the disease.

While vaccination provides each of us with direct protection against disease, with herd immunity, even people who are unvaccinated benefit from that blocked transmission pathway.

Different diseases have different thresholds for herd immunity. For measles, for example, the herd immunity threshold is 92%-94%. Estimates for COVID-19 have varied, with some putting it at 85% or higher.

However, many hesitate to give a single number. Here are three reasons why.

1. Variations in the vaccines, and the disease itself

A single herd immunity figure is difficult to estimate when the infectiousness of SARS-CoV-2 (the virus that causes COVID-19) remains so variable.

When Will We Reach Herd Immunity?

We understand the infectiousness of a disease by looking at the R0, or reproduction number — the average number of people infected by one case where no control measures are in place. The ancestral strains of SARS-CoV-2 have an R0 of 2-3, but Delta is estimated to be twice as infectious, with an R0 around 4-6. The lower the vaccine effectiveness, the higher the level of coverage we'll need to control COVID well.

2. We cannot cover the entire population yet

The Pfizer vaccine has now been provisionally approved for 12-15-year-olds in Australia. If it becomes routinely recommended for this age group, it

The type of vaccine, doses given (whether one or both), and how well the vaccines cover the different variants all factor in.

Estimates from the United Kingdom show two doses of the Pfizer vaccine are between 85% and 95% effective against symptomatic disease with the Alpha variant, while two doses of AstraZeneca are 70% to 85% effective. Overall vaccine effectiveness appears to drop about ten percentage points with the Delta variant. will still take time to vaccinate them. Even once that occurs, there will remain a gap in our population protection among younger children.

Children should benefit somewhat from adult vaccination. In England, where overall vaccine uptake is 48.5% for two doses, there was initially a decline in infections for children aged under ten years. This is partly due to indirect protection offered by adults being vaccinated.

3. Population protection will vary in time and space

There is rarely a neat threshold after which everything changes for good. Vaccine protection in individuals is likely to wane over time. With that and new variants appearing, we will almost certainly need boosters to sustain population protection against COVID-19.

With influenza vaccination, we rarely even talk about herd immunity, because the duration of protection is so short. By the next flu season, immunity from the current season's vaccine will be much less effective against the newest viral strain.

Spatially, protection can vary across localities and demographics. Even in a country that has reached a herd immunity threshold for vaccination coverage against measles, you can see small outbreaks in pockets of lower coverage in kids, or where a cohort of teens and adults weren't adequately vaccinated as children.

The capacity to achieve herd immunity is also affected by population density and how much people in a population mix with a variety of others — what's called heterogeneity of mixing.

Life will gradually change as more people are vaccinated

Given these factors, it's understandable experts often avoid giving a single figure for herd immunity.

With the infectiousness of Delta, we will need very high vaccination rates. Then, life will look different, particularly once this happens globally.

Angry Politicians Make Angry Voters, New Study Finds

Politicians may have good reason to turn to angry rhetoric, according to research led by political scientists from Colorado-the strategy seems to work, at least in the short term.

In a new study published in the journal Political Research Quarterly, Carey Stapleton at the University of Colorado Boulder and Ryan Dawkins at the US Air Force Academy discovered that political furore may spread easily: Ordinary citizens can start to mirror the angry emotions of the politicians they read about in the news. Such "emotional contagion" might even drive some voters who would otherwise tune out of politics to head to the polls.

"Politicians want to get reelected, and anger is a powerful tool that they can use to make that happen," said Stapleton, who recently earned his PhD in political science at CU Boulder.

The researchers surveyed roughly 1,400 people online from across the political spectrum, present-

ing them with a series of mock news stories about a recent political debate. They discovered that when it comes to politics, anger may lead to more anger.

Subjects who read about an enraged politician from their own party were more likely to report feeling mad themselves than people who didn't. Those same steaming partisans also reported that they were more likely to get involved in politics, from attending rallies to voting on Election Day.

"Anger is a very strong, shortterm emotion that motivates people into action," said Stapleton. "But there can be these much more negative implications in the long term. There's always the potential that anger can turn into rage and violence. Anger and politics in the US have

long gone hand-in-hand--the nation's second president, John Adams, once referred to Alexander Hamilton as a "bastard brat of a Scotch peddler." But Stapleton and Dawkins' findings come at a time when American politics has grown especially divisive.

According to the Pew Research Center, in the lead up to the 2020 presidential election, "around nine-in-ten Trump and Biden supporters said there would be 'lasting harm' to the nation if the other candidate won." That anger boiled over with deadly results when a mob of supporters of then-President Trump stormed the Capitol on Jan. 6. Stapleton, who is not related to

the Colorado political family, wanted to find out just how contagious those kinds of emotions could be. He will start a position as a postdoctoral researcher at the University of Notre Dame in the fall

"Most political science research to date has focused on what we do when we feel an emotion like anger, rather than how our emotions affect other people," Stapleton said.

To find out how the emotions of politicians might rub off on their supporters, he and Dawkins ran an experiment. The duo wrote a series of news stories about a debate on immigration policy between two candidates for an open

Congressional seat in Minnesota. Unbeknownst to the study's subjects, neither the candidates nor their debate was real. In some cases, the faux politicians used language that tipped into outrage (although it might still look tame in the current political landscape). "When I look at our borders, I'm enraged by what I see," as an example. In other cases, the soap boxers stuck to more neutral language. The team's results are among the first to show what many Americans have long known--that political anger can be a powerful force.

"We report being angrier after seeing our fellow partisans being angry," Stapleton said. "When the other side is angry, it doesn't seem to affect us much at all." If Democrats read about a fellow Democrat getting mad, for example, they often reported feeling angry themselves. In contrast, blue voters who encountered neutral information or saw an angry quote from a Republican didn't experience the same swings in emotion.

J&K Targets Macadamization Of 8,000 Km Of Road During 2021-22

SRINAGAR: The Chief Secretary, Dr. Arun Kumar Mehta today chaired a meeting to review the functioning of the Public Works (R&B) Department and take stock of progress made under the flagship programme, 'Pradhan Mantri Gram Sadak Yojana' (PMGSY). Principal Secretary, Public Works

(R&B) Department along with concerned officers of the Department and Director-General, Budget were present in the meeting. It was informed that presently,

the Department is maintaining 41,584 km road length across Jammu and Kashmir which includes National Highways, PMGSY, and R&B roads, and 1343 bridges.

During the previous financial year, it was further informed that the Department completed 1289 schemes associated with R&B, MED, DIQC sectors, and Mughal Road project by incurring an expenditure of Rs. 1,638 crore.

Under PMGSY, the Department registered an achievement of completing 3,167 km of rural roads under 272 schemes, thereby providing safe and secure all-weather connectivity to 119 habitations at an estimated cost of Rs. 2,072 crore. The Chief Secretary directed the Department to complete 4,200 km road length under PMGSY I & II this fiscal which includes 800 km and 3400 km rural road in Kashmir and Jammu province, respectively. This will thus conclude the first two phases of PMGSY in J&K, paving the way for initiation of phase III for which 1,750 km roads have been identified and submitted for approval.

STATE

The Department was also asked to keep a check on the quality standards of new constructions and ensure the creation of high-quality infrastructure, besides undertaking routine inspections through mobile maintenance teams with focussed attention on maintenance work.

The Department was further asked to evolve a mechanism to ensure regular monitoring of the quality of roads especially around all tourist places and public facilities.

Moreover, the Department was asked to prioritize blacktopping of roads towards developing and maintaining pothole-free roads in Jammu and Kashmir. The Department will be macadamizing 8,000 km of road length during 2021-22, out of which 2,007 km has already been completed so far.

The Chief Secretary also reviewed issues related to unawarded works, forest clearances, land acquisition, quality standards, and utility shifting.
