Govt Fires Six More Employees For 'Terror' Links 2 Cops, Two Teachers, Forest Range Officer Among Those Dismissed

SRINAGAR: Six government employees, including two policemen, were on Wednesday dismissed from service for their alleged links with militants in Jammu and Kashmir, taking the total number of employees sacked in last nearly six months to 25, officials said. Among those dismissed from service earlier, there were two sons of Pakistan-based Hizbul Mujahideen chief Sved Salahuddin and tainted Deputy Superintendent of Police Davinder Singh who was caught along with a wanted militant and two others early this year.

The six employees who were dismissed by the government, include constable Showkat Ahmad Khan, a resident of Budgam who was involved in the looting of service weapons from the house of a member of legislative council in Srinagar



with whom he was posted as a Personal Security Officer in 2018. The policeman was arrested and subsequently detained under the Public Safety Act (PSA) on August 8 last year, the officials said. They said constable Jaffer Hussain Butt of Kishtwar was

SRINAGAR: For the first time in over two months, Jammu and Kashmir reported on Wednesday over 200 fresh cases of novel coronavirus, while no Covid-19 related fatality was reported from the Union Territory during the last 24 hours.

According to the officials, Kashmir Valley reported 159 new cases of coronavirus, almost half of them from Srinagar, where administration is mulling to impose lockdown in certain pockets to combat the spread of deadly disease.

The remaining 45 cases, officials said, were detected from the winter capital.

Decomposed Body Of Soldier Found, Family Says It's Him **Press Trust Of India**

SRINAGAR: The decomposed body of a man, suspected to be that of a Territorial Army jawan kidnapped by militants last year, was recovered from Kulgam district of Jammu and Kashmir, police said on Wednesday.

Police found the body, wrapped in a tarpaulin, in Mohammadpora in Kulgam.

Police suspect that the mortal remains might be of Territorial Army jawan Shakir Manzoor Wagay who was kidnapped by militants on August 2 last year.

Police has taken the body for identification and other medical formalities, they said. Meanwhile, the family be-

JAMMU: Normal life was hit across the Jammu region on Wednesday amid a day-long strike call given by the Jammu Chamber of Commerce and Industries (JCCI) to protest against the alleged directionless policies of the administration. The strike, which evoked

widespread support from almost all opposition political parties and social groups, remained peaceful with no untoward incident reported from anywhere, officials said.

The work in courts was affected by the strike, which was also supported by the Jammu chapter of J&K High Court Bar Association.

The main markets in the city



wore a deserted look as shops and business establishments including retail chemist shops were closed, while the movement of public and private transport was thin.

Protests and rallies at various places by traders and activists of

National Panthers Party (NPP) in the city marked the strike, which was the first of its kind in the Jammu province after the abrogation of Article 370.

NEW DELHI: The Indian Army is continuously monitoring the situation in the country's neighbourhood and is ready to meet any security challenge that comes its way, Army Chief General M M Naravane said on Wednesday.

Addressing the AIMA National Management Convention, the Chief of Army Staff noted that the army is prepared to tackle even a dual-front war if the need arose.

He highlighted that the Indian Army was making rapid strides in changing itself from being a manpower intensive army to a technologically empowered one in order to keep an edge over opponents.

'We always continue to do a regional and environmental scan and based on that scan we do keep reviewing what threat



perceptions could be. Based on those threat perceptions, we recalibrate our possible responses.

"That is always work in progress and we will always be prepared to meet whatsoever security challenges that come due to this changed situation," Gen Naravane stated.

Beerwah Police, CRPF Taste RR Ire

Cops Accused Of Harbouring Militants

SRINAGAR: In an unprecedented operation, army carried out a cordon and search operation at a pol ice station in the central Kashmir district of Budgam yesterday. Administration and police authorities have taken a strong exception to the incident which left the police and central reserve police force (CRPF) personnel shell shocked and gripped in fear.

Quoting police, agency reports said troops of 34 Rashtriya Rifles (RR) led by Col T Shashidharan laid seige to the police station at Beerwah at about 6 p.m. yesterday and called out all the policemen and the CRPF personnel from its 197 battalion deployed in a portion there. Six persons lodged in the police lock up at the moment were also brought out.

Accusing the police of harbouring militants in the police station, the army officer told the officials a suspect had entered the premises shortly before. That was why the operation was started, he said. The surprised policemen produced one Ghulam Rasool before him saying he had come to report the theft at his home earlier.

Denying that he was the person who had entered the premises earlier, the army officer allegedly threatened the policemen of torching the police station along with the personnel in the event of any untoward incident there. The entire premises including the police station and the family quarters were thoroughly searched. The operation lasted one and a half hours.

On learning about the incident, the deputy commissioner, Budgam, accompanied by the superintendent of police, visited the police station this morning, primarily to mollify the visibly agitated police officials. They assured them of investigation into the matter and 'appropriate action' against those responsible.

Reports said the RR action has generated fear not only among the police and security forces, but among the local people as well. Residents told API the RR personnel had allegedly made their life miserable. Viewed in light of their action against the police and CRPF, they said, one could easily guess what could be the extent of the harassment they caused to the common people.

It may be recalled the RR camp located next to the police station was stormed by the Lashkar-e-Taiba and Jami'at-ul-Mujahideen groups in a pre-dawn sneak attack on 12th of this month killing about a dozen army jawans and injuring several others before getting killed themselves. An API report had put the toll in the incident at 21. The deputy commissioner, Rohit Kansal, said this evening the army had searched some private buildings adjacent to the police station, including a building "being used by the police for various purposes". The police matter had been taken up with the army authorities at the corps headquarters here and they were enquiring into it.

When contacted, the deputy inspector general of police, Srinagar-Budgam range, K Rajender, confirming the incident, told Observer News Service the matter had been taken up with the army authorities at the corps headquarters here and they were enquiring into it.

Severe COVID-19 Can Lead **To Delirium, US Study Finds**



WASHINGTON: A study of 150 patients hospitalised for COVID in the US at the beginning of the pandemic found that 73 per cent had delirium, a serious disturbance in mental state wherein a person is confused, agitated and unable to think clearly.

The study, published in the journal BMJ Open, found that patients with delirium tended to be sicker, with more comorbidities like hypertension and diabetes, and appeared to have more severe COVID-related illness.

"COVID is also associated with a number of other adverse outcomes that tend to prolong hospitalisation and make recovery difficult," said study author Phillip Vlisides, from the University of Michigan in the US.

The researchers used patient medical records and telephone surveys following hospital discharge for a group of patients hospitalised in the intensive care unit between March and May 2020. They attempted to identify common threads amongst patients who developed delirium.

The researchers noted that the disease itself can lead to reduced oxygen to the brain as well as the development of blood clots and stroke, resulting in cognitive impairment.

Inflammatory markers were greatly increased in patients with delirium. Confusion and agitation could be a result of inflammation of the brain, they said.

"Early on in the pandemic, we weren't performing standard delirium prevention protocols like we usually do," Mr Vlisides said.

"A big reason for that is early on in the pandemic in the prevaccine era, we had limited personal protective equipment and were trying to limit COVID exposure and disease transmission." he added. There was a correlation between the use of

sedatives and delirium - patients with delirium were sedated more often and frequently at higher doses.

"It is common to use IV sedatives in the ICU, particular for patients on a ventilator. However, from talking to nurses, we found that patients with severe COVID were inherently more delirious and agitated at baseline, perhaps prompting more sedative use, said Mr Vlisides.

The study also found that cognitive impairment can persist even after discharge.

Almost a third of patients did not have their delirium marked as resolved in their chart upon leaving the hospital and 40 per cent of these patients required skilled nursing care.

Almost a quarter of patients screened positive for delirium based on assessment by their caretaker. For some patients, these symptoms lasted for months.

This can make managing the recovery process after hospitalisation that much more difficult. "Whatever creative ways we

can implement in delirium prevention protocols is likely to be very helpful," Mr Vlisides said. "That includes consistent

communication with family members, bringing in pictures and objects from home, and vid-

eo visits if family cannot safely The take-home message is

that for patients hospitalised with severe COVID-19, cognitive impairment - including depression and delirium - is highly likely, he added.

"Overall, this study highlights another reason why getting vaccinated and preventing severe illness is so important. There can be long term neurological complications that perhaps we don't talk about as much as we should," Mr Vlisides said.

WHO Says Air Pollution Kills 7 Million Annually, Toughens Guidelines

World Health Organization (WHO) strengthened its air quality guidelines on Wednesday, saying air pollution was now one of the biggest environmental threats to human health, causing seven million premature deaths a year. It said urgent action was need-

ed to reduce exposure to air pollution, ranking its burden of disease on a par with smoking and unhealthy eating. "WHO has adjusted almost all the

air quality guideline levels downwards, warning that exceeding the new... levels is associated with significant risks to health," it said. "Adhering to them could save

millions of lives." The guidelines aim to protect people from the adverse effects of air pollution and are used by

governments as a reference for legally-binding standards. The UN health agency last is-

sued air quality guidelines, or AQGs, in 2005, which had a significant impact on pollution abatement policies worldwide.

However, the WHO said in the 16 years since, a much stronger body of evidence had emerged, showing how air pollution impacts on health at lower concentrations than previously understood.

"The accumulated evidence is sufficient to justify actions to reduce population exposure to key air pollutants, not only in particular countries or regions but on a

global scale," the organisation said. Southeast Asia hard-hit The new guidelines come just in time for the COP26 global cli-

mate summit held in Glasgow from October 31 to November 12. The WHO said that along-

environmental threats to human health. Improving air quality would enhance climate change mitigation efforts, and vice versa, it said

The WHO's new guidelines recommend air quality levels for six pollutants, including ozone, nitrogen dioxide, sulphur dioxide and carbon monoxide.

The other two are PM10 and PM2.5 -- particulate matter equal or smaller than 10 and 2.5 microns in diameter.

Both are capable of penetrating deep into the lungs but research shows PM2.5 can even enter the bloodstream, primarily resulting in cardiovascular and respiratory problems, but also affecting other

PM2.5 exposure. Southeast Asia is the worst-affected region.

"Air pollution is a threat to

health in all countries, but it hits people in low- and middleincome countries the hardest,"

-- also called coronary heart disease -- and stroke are the most common causes of premature death attributable to outdoor air pollution.

Evidence is also emerging of other effects such as diabetes and neurodegenerative conditions, the organisation said.

The WHO said the burden of disease attributable to air pollution was "on a par with other major global health risks such as unhealthy diet and tobacco smoking".

"First Time In 20 Years US Not At War, We Have Turned The Page": Joe Biden

UNITED NATIONS: The US has ended 20 years of conflict in Afghanistan and as Washington closes this period of "relentless war", it is opening a new era of "relentless diplomacy" to lift people up around the world and renew and defend democracy, US President Joe Biden said today.

In his maiden address to the high-level 76th UN General Assembly, Mr Biden told world leaders and diplomats gathered in the General Assembly hall that in his view the world is at an "inflection point in history". "Instead of continuing to fight

the wars of the past, we are fix-ing our eyes and devoting our resources to the challenges that hold the keys to our collective future - ending this pandemic, addressing the climate crisis, managing the shifts in global power dynamics, shaping the rules of the world on vital issues like trade, cyber, and emerging technologies and facing the threat of

terrorism as it stands today. "We've ended 20 years of conflict in Afghanistan and as we close this period of relentless war, we're opening a new era of relentless diplomacy; of using the power of our development aid to invest in new ways of lifting people up around the world; of renewing and defending democracy; of proving that no matter how challenging or how complex the problems you're going to face, government by and for the people is still the best way to deliver for all of our people," he said.

Mr Biden referred to the UN Security Council resolution on Afghanistan, adopted under India's Presidency of the 15-nation UN organ last month, and said that while the United States will do its part, but "we're more successful and more impactful if all of our nations are working" together. "As we look ahead, we will lead, we will lead on all the greatest challenges of our time from COVID to climate, peace and security, human dignity and human rights but we will not go alone. We will lead together with our allies and partners and in cooperation of all those who believe as we do that this is within our power to meet these challenges, to build a future and lift all of our people and preserve this planet," the US president said.

WASHINGTON: A small aircraft on Tuesday (local time) entered the Temporary Flight Restriction (TFR) area in New York City while the United Nations General Assembly with participation from world leaders had commenced.

A Cessna 182 entered the TFR at approximately 2 pm and the small aircraft was intercepted by an F-16 fighter jet and escorted out of the TFR "without incident," Federal Aviation Administration's North American Aerospace Defense Command said in a statement.

The TFR was in place order for VIP movement in New York from Monday at 4:45 pm until

Tuesday at 3:45 pm (local time). The restricted region includes the Hudson River and the East River.

The developments came during the high-level segment of the 76th United Nations General Assembly that began in New York on Tuesday. Top leaders from across the world have converged in New York for UNGA high-level debate.

According to media reports, the incident took place at about the same time that US President loe Biden who had addressed the UNGA in the morning departed the city after meetings with Australian Prime Minister Scott Morrison and Iraqi President Barham Saleh.

The UNGA meeting this year is in a hybrid format but a large number of leaders are expected to arrive in New York.

This is perhaps the first time that the foreign diplomats met Karzai and Abdullah who stayed put in Kabul after the Taliban seized power in Afghanistan last month ahead of the withdrawal of the US and NATO troops. Their meeting also coincides with the Taliban's letter to the

The new grouping includes China, Pakistan, Iran, Tajikistan, Turkmenistan and Uzbekistan, all of them Afghanistan's neighbours. The Foreign Ministers of the group held a virtual meeting on September 7.

Highlighting its significance, Pakistan Prime Minister Imran Khan told BBC on Tuesday that the new group will jointly decide about extending recognition to the Taliban's interim government.

Elaborating on China, Russia, Pakistan Special envoys talks with the Taliban officials in Kabul, Zhao said they discussed the situation especially regarding inclusiveness, human rights, economic and humanitarian matters and the friendly relations between Afghanistan.

They also discussed ties with other countries as well as the reunification and territorial integrity of the country, he said.

"They had an in-depth and constructive discussion and also expressed support to combating

responsible role in consolidating the stability in Afghanistan. The three countries called on more humanitarian assistance to Afghanistan from the international community," Zhao stated.

They stressed that the US and allies shoulder the main responsibility for the economic and social reconstruction in Afghanistan and provide much needed economic livelihood and humanitarian assistance. Zhao said.

The three countries have agreed to maintain constructive contact with the Taliban to promote peace, prosperity, regional stability and development, he said.

In their talks with Karzai and Abdullah, they discussed issues related to peace and stability in Afghanistan, he said.

"China said we will not interfere in the internal affairs of Afghanistan and has been playing a constructive role for the political settlement of the Afghan issue. The Afghan side should make a political arrangement that is open, inclusive and exercises prudent policy," Zhao added. PTI

The US military withdrew from Afghanistan amid a hasty and chaotic airlift of more than 1.00,000 Afghans and foreigners, and has largely withdrawn from Iraq. Iran shares long borders with Afghanistan to its east and Iraq to its west, where Shiite militias are powerful.

The perseverance of nations, he said, is stronger than the power of superpowers. In a dig at the political slogans used by Trump and his successor President Joe Biden, Raisi said: "Today, the world doesn't care about "America First" or "America is Back."

Speaking remotely via video from Tehran, Raisi wore a black turban on his head that identifies him in the Shiite tradition as a direct descendant of the Prophet Muhammad. He praised Iran's Islamic Revolution of 1979 as the fulfilment of "religious democracy" and linked the growth of "indigenous terrorism in the West" to a decline in spirituality.

Despite the criticism aimed at Washington, Raisi appeared not to rule out a return to the negotiating table for the nuclear accord, saying Iran considers talks useful if their ultimate outcome is the lifting of all sanctions. Still, he stated: "We don't trust the promises made by the US government."

Tensions peaked last year between the US and Iran after the Trump administration's assassination of powerful field commander, Qassim Soleimani, and a top Iraqi Shiite militia leader by a US drone strike in Iraq.

Taliban Ask To Address UN, Name Suhail Shaheen As Afghan Envoy

UNITED NATIONS: The Taliban have asked to address world leaders at the United Nations in New York this week and nominated their Doha-based spokesman Suhail Shaheen as Afghanistan's UN ambassador, according to a letter seen by Reuters on Tuesday.

Taliban Foreign Minister Amir Khan Muttaqi made the request in a letter to U.N. Secretary-General Antonio Guterres on Monday. Muttaqi asked to speak during the annual high-level meeting of the General Assembly, which finishes on Monday.

Guterres' spokesperson, Farhan Haq, confirmed Muttaqi's letter. The move

sets up a showdown with Ghulam Isaczai, the U.N. ambassador in New York representing Afghanistan's government ousted last month by the Taliban. Haq said the rival requests for Afghanistan's U.N. seat had been sent to a nine-member credentials committee, whose members include the United States, China and Russia, The committee is unlikely to meet on the issue before Monday, so it is doubtful that the Taliban foreign minister will

address the world body. Eventual U.N. acceptance of the ambassador of the Taliban would be an important step in the hardline group's bid for international recognition, which could help unlock badly needed funds for the

cash-strapped Afghan economy. Guterres has said that the Taliban's desire for international recognition is the only leverage other countries have to press for inclusive govern-

ment and respect for rights, particularly for women, in Afghanistan. The Taliban letter said Isaczai's mission "is considered over and that he no longer represents Afghanistan," said Haq. Until a decision is made by the credentials committee Isaczai will remain in the seat, according to the General Assembly rules. He is currently scheduled to address the final day of the meeting on Sept. 27, but it was not immediately clear if any

The lawsuit, filed in Dutchess County, New York state, says that New York Times reporters Susanne Craig, David Barstow and Russ Buettner conducted "an extensive crusade to obtain Donald J.

Trump's confidential tax records." The defendants engaged in an insidious plot to obtain confidential and highly-sensitive records which they exploited for their own benefit and utilized as a means of falsely legitimizing their publicized works," the lawsuit says, alleging they were

For Peace To Prevail

eneral Officer Commanding (GoC) of the Army's 15 Corps, Lt Gen D P Pandey, said on Monday there has been no ceasefire violation along the Line of Control (LoC) in Kashmir since the reaffirmation of the 2003 agreement between the armies of India and Pakistan in February this year, He added that some infiltration attempts unlike previous years have not been "adequately supported" by ceasefire violations by Pakistan. Lt Gen Pandey's statement attests to the peace ushered in along the LoC by the February truce. The sudden announcement of the agreement between India and Pakistan at the time had taken everyone by surprise. The truce came at a time when the relations between them had plunged to their lowest in the wake of the withdrawal of Article 370 in August 2019. But despite the fact that the two neighbours have not been able to follow up on the agreement by engaging in dialogue, as had appeared likely, the peace on the border has held. This is also apparent from the fact that there have been just two successful infiltrations this year, as revealed by Lt Gen Pandey.

As against this, there were 111 successful infiltration attempts into J&K last year, as was disclosed by the then Union Minister of State for Home G Kishan Reddy in parliament. Also, last year, security forces had killed over 200 militants and so far this year around 163 militants have been killed in various encounters. But according to the existing figures, the number of militants continues to hover around 200. If anything, these figures show that the militancy in the Valley has gone nowhere following the revocation of Article 370. Over the last two years, the security forces have achieved greater success in the operations against militants and at one time it appeared a distinct possibility that the militancy was on its way out.

But going by the rise and fall of militancy over the past three decades, such a prospect is unlikely to come about. The militancy in Kashmir has often risen from the ashes. Never had it come so close to extinction as by 2013 when the Valley had a little over hundred militants, only a small number of them locals. But from 2014 the number started rising again. In 2018, the most violent year in a decade, 271 militants were killed but it still didn't make any difference to the ground situation.

Going forward, there is little indication that the militancy would cease. The simultaneous recruitment of the local youth in the militant ranks and the now shrunk infiltration from across the border invariably replenishes the shortfall created by the killings of the militants. And it will continue to do so unless the dynamic that animates the militancy is addressed. And this redressal is not in the killing of the militants but in a meaningful political outreach that has been sorely missing in the current climate. Ironically so, when the current establishment has the power to make such an outreach. It only needs the will.

Secondly, there are Afghanistan's notorious "warlords", many of them veterans of the anti-Soviet war of the 1980s. Some of the most powerful include Ahmad Massoud, son of the MI6 favourite Ahmad Shah Massoud; war criminal and CIA asset Abdul Rashid Dostum; and the corrupt and fabulously wealthy Atta Mohammad Noor, whose son is a recent graduate of Sandhurst military academy. Until earlier this year, all of these men controlled substantial militias and territories. However, as the Taliban swept all before them, they increas-ingly seemed like a busted flush, and have all now fled the country.

The country's erstwhile most dangerous warlord, however, Gulbuddin Hekmatyar, may still have cards to play. A leading recipi-ent of CIA and British support in the 1980s who personally threw acid in a woman's face and once met Margaret Thatcher, he was "famed for skinning infidels alive" and went on to mercilessly bombard Kabul in 1992 following his exclusion from the city's conquering armies. He has been deeply involved in negotiations with the Taliban, and may yet be able to stir up trouble if things do not go his way, especially given his links to the other powerful political figures left out of the Taliban government following negotiations, Hamid Karzai and Abdullah Abdullah.

Finally, there is the potential for opposition from within the Taliban's own ranks. The Taliban leadership has been keen to present a scrubbed image to the world, emphasising its commitments to counter-terrorism, girls' education and "inclusive government", as well as its commitment to friendly relations with China.

Yet power now lies with the fighters, not the political spokesmen, and their acceptance of this new agenda is far from assured. Inbox Lost Pitch

t was supposedly the last step in Pakistan's long and arduous road to bringing cricket back home. After a decade in wilderness, post the attack on Sri Lanka's team bus by terrorists in Lahore in March 2009, Pakistan was being incrementally reintegrated into the touring schedule. It has hosted West Indies. Sri Lanka and Zimbabwe, besides the elite players of world cricket in the popular Pakistan Super League in the last two years. The fear and reluctance of touring the country were gradually receding, and hosting New Zealand and England, in the next couple of months, was the logical and final step in declaring to the sporting world that Pakistan is safe to tour. But the cancellation of both tours, have sucker-punched their dreams and ambitions to be once again a vibrant, colourful cricket host.

New Zealand's reluctance, citing "specific, credible security threat" against the team, is more reasonable, and hence acceptable, than that of England. Only a fortnight ago an ISIS sympathiser randomly stabbed six people at a supermarket in Auckland. In the past, their cricketers have endured close shaves, twice in Colombo at the peak of Lankan civil war and once in Karachi, after an explosion outside their hotel. But England's excuses in cancelling the trip, chiefly "the mental and physical well-being of our players", "increasing concerns about travelling to the region" and "bubble fatigue", reeked of panic and pretence.

The boards of New Zealand and England, perhaps the ICC too, might compensate Pakistan's logistical loss, but not the damage it has inflicted on a sparkling cricket culture, as deep and diverse, as joyous and frenzied as India's. The cricket-mad country will have to be content with PSL and visits of lowrung nations, even those could be limited in the aftermath of the pullouts, and their best cricketers would be forced to consider someone else's home their home again. That last step on Pakistan's redemption road now looks longer and more arduous than ever before.

Fatal Falls

alls are the second most common cause of injury-associated mortality worldwide. This is true of Kashmir as well and is especially relevant given the recent deaths reported due to this occupational hazard. In fact, in September last week, around six deaths were reported due to fall from walnut trees. This pushed J&K Disaster Management Department to issue Dos and Don'ts to prevent these accidental deaths.

Falling down from a walnut tree, which is quite tall, is one of the major causes of grievous injuries and a leading cause of seasonal deaths in Kashmir.

Walnut trees are found almost everywhere in Kashmir. It is one of the prime indigenous products of Kashmir and is referred to as the pride of Kashmir's dry fruits.

Official data suggests that around 2.66 lakh metric tonnes of walnuts are cultivated on 89,000 hectares across Jammu and Kashmir. Walnuts constitute almost 98 per cent of the dry fruit that Kashmir produces in a year.

Walnut trees can grow up to the height of 50-60ft and the bark of these trees is very slippery. When the walnut cultivators climb these trees carrying a long stick in their hand to hit the fruit, they lose their balance which results in them falling off it.

Fatalities and the injuries caused by falling from walnut trees are most common and still remain so, especially in the harvesting months of August and September. Hence, these falls have become a seasonal occupational hazard and are exasperating health care especially dur-

ing the time of covid-19 pandemic. am a medical student, posted in the CT-Scan section of Government Medical College, Anantnag. Every day, we receive at least five patients, who are robust males but have a history of fall from walnut trees due to these traditional outdated methods employed in our region for harvesting walnut trees. Cervical spine injuries (27.50%) are the most common injuries reported, followed closely by brain contusion (26.43%) and multiple fractures, mainly rib fractures. Many patients have multiple injuries. The mortality rate is about 50%. 20% of patients are rendered paralysed for life.

Government must come up with some ideas about preventive measures including educating walnut cultivators about the safety measures. Many lives could be saved if the farmers are educated and if more scientific methods are used. One such method could be the use of tree stands about 30 ft above ground and use of non-slip boots. Similarly, the use of safety harnesses such as head gear, chest and abdomen gears are recommended. Moreover, nets can also be provided to people, to slow down the fall. More urgently, experienced and trained professionals should be provided with licences and without licences, it should be prohibited to climb such tall trees, this will lead to a dramatic decrease in mortality and morbidity caused by falls from walnut trees.

Arba'een And Shia Spirituality

he concept of pilgrimage exists in all major religions, however, not many know about the pilgrimage to Iraq - Najaf and Karbala, which is known as Arba'een. The Arabic word Arr-ba-een translates to forty days period of mourning (Aza). This period of mourning as an ideology may be new to many, but there are many parallels to the outpouring of grief by Catholics shown at Easter. Sicilian and Spanish faithful who reenacted the crucifixion of Jesus by nailing a young man to the cross and then beating their chest with chains. Arba'een is the living symbol of the rise of the Shia power deprived for 1400 years.

On Sept 26th thirty million dressed in black, Shiite Muslim worshippers will converge on Iraq's holy city of Karbala as part of the annual pilgrimage, culminating a 40-day mourning period for the killing in AD 680 of Imam Hussain (as) , grandson of the prophet Muhammed (pbuh) He was killed in Karbala on a day which became known as "Ashura", the tenth day of the Islamic month of Muharram, having refused to pledge allegiance to the corrupt and tyrannical caliph, Yazid.

Arba'een is distinctively Shia spirituality, however Sunnis, even Christians, Yazidis, and Zoroastrians partake in both the pilgrimage as well as serving of devotees. In recent years, Archbishop of Tibilisi Malkhaz has participated in the walk. It probably has to do with the fact that the press is concerned with negativity, and dramatized tabloids than with inspiring stories, particularly when it comes to Arba'een. How could a man Imam Hussein who was killed 1400 years ago be so alive and have such a profound presence today that he makes millions take up his cause?

There is also hypocrisy in the US media

which gives 24/7 airtime to a pro-democracy demonstration in Hong Kong and impeachment, but a gathering of thirty million people fails even to make it into print media or cable news. US media demonstrates blatant disregard for this important news story and tries to keep it marginalized. Nevertheless, the media outlet has many correspondents even in the most remote parts of the world who cover the news events immediately and minuteby-minute. The deliberate censorship of newsworthy of 'Arba'een'' is to underrate the important significance of the event.

Arba en is newsworthy, because of a unique and exceptional 55-mile walk. Millions will walk for three days during the daytime with the scorching desert sun bearing down upon them and they will rest in the evenings in tents when the blistering cold takes over as temperatures rapidly plummet. They walk in unison toward Karbala as part of the ocean of faithful walking in waves like the ocean waves. The volunteers, doctors, and devotees distribute free food and drinks by the roadside and have tents for medical attention, relaxing, sleeping and washing.

The pilgrims are perplexed at the sight of thousands of tents with makeshift kitchens set up by local villagers who live around the pilgrim's' path. The tents (called 'mawkeb') are places where pilgrims get practically everything they need. From fresh meals to eat and a space to rest, to free international phone calls to assure concerned relatives, to baby diapers, to practically every other amenity, free of charge.

All sorts of questions arise: who will accommodate all these people? What

about the food? Yet everyone in Iraq, whether they are children or adults, civilians, or soldiers, wealthy or poor, works together to serve the visitors of Husain. Even the children would stand with either a perfume they spray on the people walking by or a packet of tissues, prompting anyone to take as they please. This is the hospitality and generosity that truly reflects the image and legacy of the Infallible whose shrines are there. The event of Arba'een. is largely self-organizing however, the event is well secured and superbly managed by the Iraq authorities. The mood of the pilgrimage is one of intense piety, unity, and solidarity

Long Covid And Double Jabs

n unvaccinated people, around one in 20 who get symptomatic CO-VID-19 experience symptoms for at least eight weeks. Around one in 50 have symptoms that drag out for three months or more.

We wanted to know whether CO-VID-19 vaccines might protect against developing long-lasting symptoms. To find out, we looked at data provided by more than a million regular contributors to the COVID Symptom Study, a project in which members of the public log their symptoms via an app to help with research.

Our latest analysis of the study's data, covering around 2 million vaccine doses, shows that vaccines significantly reduce the risk of catching COVID-19, with only 0.2% of those fully vaccinated later testing positive for the virus.

Even if you're unlucky enough to catch the virus after being vaccinated, your chances of falling seriously ill or dying are slashed. Double-vaccinated people are 31% less likely to experience acute COVID-19 symptoms and 73% less likely to be hospitalised – a result that's borne out in the relatively low hospitalisation and death rates we're seeing now even as tens of thousands of people are still testing positive every day in the UK.

Reassuringly, for those who did fall ill with COVID-19 after being vaccinated, only around 5% went on to have symptoms that lasted for more than four weeks, meaning their chances of developing long COVID were cut by half. One of the best ways to reduce your risk of getting long COVID is to get fully vaccinated as soon as possible.

However, we did notice that frail older people and those living in more socially deprived areas were more likely to be infected and fall ill with COVID-19 after being vaccinated, especially if they had only had one vaccine dose. This suggests that we should prioritise further vaccination efforts and public health measures such as masking and social

distancing among these groups, especially where infection rates are high and people are mixing and moving around. Vaccines and long COVID

As the UK vaccination programme rolled out, we also started to notice anecdotal reports from people living with long COVID that their symptoms seemed to improve after being vaccinated.

The patient-led LongCovidSOS group chose to investigate this by surveying over 800 long COVID patients early in 2021. More than half of those surveyed noticed an overall improvement in their symptoms after vaccination, which then appeared to be sustained in about half of this group. Around a quarter of the overall respondents reported no difference and one-fifth said their symptoms had got worse. These findings have been released as a preprint, so haven't yet been reviewed by other scientists, but they've been backed up by data from the COVID Symptom Study, which we'll be publishing soon. However, while there does seem to be some kind of link between receiving a COVID-19 vaccine and improvements in long COVID, it's not clear exactly how the two are connected. It could be that the immune response triggered by the vaccine has a direct impact on symptoms.

Alternatively, it could just be that time has continued to pass since these people were originally infected and they're experiencing a natural recovery from the virus. Or it could be a bit of both. Either way, more research is needed to tease out what's going on.

What we can say is that COVID-19 vaccines certainly aren't harmful for people with long COVID. What's more, because we know that it's possible to be reinfected with the virus, there's a risk that catching it a second time could exacerbate symptoms for people living with long COVID and set them back even further. It's therefore vital that we encourage anyone with long COVID who has not been vaccinated to do so as soon as possible, to help protect themselves and those around them. **A serious threat**

Although the chances of developing long COVID after being vaccinated are small, this is a numbers game and a small percentage of a big number can still be substantial. As long as we are seeing tens of thousands of cases every day, we can still expect to see a substantial number of people living with lingering symptoms over the coming months.

This is particularly important for younger people, who may be less worried about hospitalisation or death, yet who can still be susceptible to the debilitating long-term effects of the virus. A lot can happen in a few months when you're young, and long COVID can mean that people miss out on lifechanging opportunities, like sitting an exam or taking up a new job, as well as the social activities that bring joy and wellbeing to life.

We'll probably all be living with CO-VID-19 for some time to come. But with a combination of vaccination and public health measures where necessary, we can help to make sure that as few people as possible have to directly live with its life-limiting long-term effects.

Adb Lowers India's GDP Growth Projection For This Fiscal To 10 Pc On Covid Disruptions

NEW DELHI: The Asian Development Bank (ADB) has lowered India's growth projections for the current financial year by a percentage point to 10 per cent, mainly due to disruptions in economic activity caused by the second wave of the COVID-19

pandemic. In April, ADB had projected a growth rate of 11 per cent in ernment's vaccination drive, its 2021-22 for India.

In its update of the Asian Development Outlook (ADO) released on Wednesday, the multilateral lending agency has also trimmed the growth forecast for Asia as a region from 7.3 per cent to 7.1 per cent for 2021, though it rector for India, said. retained the growth projections

for China at 8.1 per cent. "The growth forecast for India in fiscal year 2021 (ending March 2022) is revised down, as May's spike in COVID-19 dented the recovery. The outbreak, however, dissipated faster than anticipated, resulting in several states easing lockdown measures and returning to more normal travel patterns," said the ADO Update (ADOU) 2021.

The economy is expected to rebound strongly in the remaining three quarters of FY2021, and grow by 10 per cent in the full fiscal year, before moderating to 7.5 per cent in FY2022 (fiscal strong, despite a

ending March 2023), ADB said. The Reserve Bank of India (RBI) also trimmed India's economic growth projection by a similar margin to 9.5 per cent in June

this year. The forecast, for the 12 months ending March 31, 2022, takes into account disruptions in economic activity caused by the second wave of coronavirus disease (COVID-19) pandemic, which adversely impacted services, domestic consumption, and the urban informal sector, ADB said.

Because consumption will recover only gradually, the government spending and exports will contribute more to FY2021 than they did in the previous fiscal, it said.

ADB said strong growth in advanced economies will continue supporting the recovery in global trade.

"Rapid vaccine rollouts in these economies have reduced the incidence of severe cases, hospitalizations, and deaths during the resurgence of COVID-19 infections," as per the update.

Growth in the US, Euro area, and Japan will remain robust in 2022 with GDP likely to grow by 3.9 per cent on an average.

On the price front, ADB said inflation has moved up in some economies in Asia due to rising energy and food prices as well as exchange rate depreciation.

"But it nevertheless remains close to the targets of central banks across the region, excluding Central Asia. Against this backdrop, fiscal and monetary policies continue to be accommodative and financial conditions remain robust," the ADOU 2021 said.

Gold Jumps Rs 196, Silver Climbs Rs 319

NEW DELHI: Gold rose by Rs 196 to Rs 45,746 per 10 gram in the national capital on Wednesday amid firm global cues and rupee depreciation, according to HDFC Securities.

In the previous trade, the precious metal had settled at Rs 45,550 per 10 gram.

Silver jumped Rs 319 to Rs 59,608 per kg from Rs 59,289 per kg in the previous trade.

The rupee depreciated by 26 paise to 73.87 against the US dollar on Wednesday.

In the international market, gold was trading in the green at USD 1,776 per ounce and silver was flat at USD 22.72 per ounce.

"The speculation ahead of the US FOMC (Federal Open Market Committee) and uncertainty over China's Evergrande crisis has sent mixed cues to the market boosting buying in bullion," according to HDFC Securities, Senior Analyst (Commodities), Tapan Patel.

Navneet Damani, VP Commodities Research, Motilal Oswal Financial Services said, "Bullions edged higher as unease over China's Evergrande insolvency and OECD's lower growth forecast for 2021 spurred safe-haven buying, ahead of the US Fed policy meet." (PTI)

Rupee Slumps By 26 Paise To Nearly 4-Week Low Against Dollar

MUMBAI: The rupee declined by 26 six currencies, was trading 0.02 per cent paise to close at a nearly four-week low of 73.87 against the US currency on Wednesday due to a stronger dollar in overseas markets ahead of the outcome of the US Fed meeting and worries over China's Evergrande situation.

Forex traders said investors are awaiting cues on taper timeline and US Fed's projections on interest rates. The US Fed meeting outcome will be announced later in the day.

At the interbank foreign exchange market, the local currency opened at 73.70 and witnessed an intra-day high of 73.66 and a low of 73.93 against the US dollar in day trade.

The local unit finally settled at 73.87 a dollar, the lowest closing level since August 26. On Tuesday, the rupee had settled at 73.61 against the US dollar.

LG Flags Off 95 Newly Procured Buses Of JKRTC

JAMMU: In a major boost to the government owned J&K Road Transport Corporation (JKRTC), the Union Territory Lieutenant Governor, Manoj Sinha on Wednesday flagged off the first lot of 95 newly procured buses for the corporation and dedicated them to the service of people of J&K.

PM Modi's Plane Flies Over Pakistan Airspace En Route To US

NEW DELHI: Prime Minister Narendra Modi's plane en route to the United States flew over the Pakistan airspace on Wednesday after the neighbouring country gave permission for the aircraft, according to sources.

There was no official confirmation from the government on whether the prime minister's aircraft flew over the Pakistan airspace, but sources confirmed that the route included Pakistan airspace.

According to flight-tracking website Flightradar24, the plane -- Boeing 777-337 (ER) -- took off from the national capital at a little past 11.40 am and the route shows it flying over Pakistan and Iran, among other countries. The sources said the per-

mission came late from Pakistan authorities for the prime minister's plane to fly over its airspace. In case, permission was not given, there was an alternative plan for the prime minister and his entourage to make a stop at Frankfurt and then proceed to the US, they added.

In October 2019, Pakistan had denied India's request to use its airspace for Modi's flight to Saudi Arabia. The same year in September also, Pakistan had denied overflight clearance for the prime minister's aircraft.

Modi emplaned for the US on Wednesday morning. His office tweeted a picture of him just before boarding the plane for the US where he will take part in a wide range of programmes.

In a statement just before leaving for the US, Modi said he will conclude his visit with an address at the United Nations General Assembly focusing on the pressing global challenges, including the COVID-19 pandemic, the need to combat terrorism, climate change and other important issues.

he is currently on bail since August 30. Teacher Abdul Hamid Wani of Bijbehara in Anantnag district was also among those dismissed from service. It is alleged that before joining government service, he was a district commander of militant group Allah Tigers and propagated secessionist ideology, the officials said.

They said he had reportedly secured the employment without any selection process by leveraging Jamaat-e-Islami (Jel) influence. He was a key speaker and organiser in the 2016 agitation following the killing of militant commander Burhan Wani.

A junior assistant in the Roads and Buildings Department, Mohd Rafi Butt of Kishtwar, is accused of having provided logistical support to Hizbul Mujahideen militant in Kishtwar, besides providing a safe environment to them to execute militant plans. He figures in an FIR registered by the NIA and is presently on bail after being arrested, the officials said.

They said teacher Liyaqat Ali Kakroo of Baramulla was appointed in government service in 1983 and was arrested in 2001 with an explosive substance. The probe against him revealed that he was a locally-trained militant.

A cache of arms was recovered from his possession in 2002 and subsequently, he was detained under the PSA for two years. However, he was acquitted by court in both the cases, the officials said, adding that two grenades were recovered from his possession again in 2021.

Range officer Tariq Mehmood Kohli of Poonch was allegedly involved in smuggling of illegal arms, ammunition and explosives, including hard drugs and fake Indian Currency Notes from Pakistan, they said.

They said Kohli, who was arrested in a case registered against him in 2010, had remained in fouch with active militants and was mentioned case of virus.

"We are concerned about 50,000 small shopkeepers who will be rendered jobless if Reliance opens its retail stores. We will not tolerate any decision which we feel is against the interests of the people of Jammu business community," Gupta said. Activists of the NPP also staged protests in support of the traders and restoration of statehood. India's Oldest Mosque Basks In Past Glory After Renovation; Set To Reopen

Thrissur, Kerala: India's first mosque and the oldest in the sub-continent is all set to welcome back devotees and general public after regaining its past glory and grandeur.

The classic beauty and humble style of the "Cheraman Juma Masjid", dating back to 629 AD, was restored after a painstaking renovation and conservation process spread over nearly 30 months under the state-run Muziris Heritage Project (MHP).

Located at Kodungallur taluk in this central Kerala district, the heritage structure was recreated in tune with its original character and aesthetics, at a cost of 1.14 crore, PM Noushad, Managing Director of MHP, said.

Besides the renovation and conservation initiative, which started in May 2019, a two-storey Islamic Heritage Museum was also constructed in the mosque campus spending nearly one crore and its internal refurbishment is going on now, he noted.

After submitting the letter of completion to the government, the MHP authorities are now awaiting Chief Minister Pinarayi Vijayan's date to reopen the oldest mosque for visitors.

"It is expected to happen any day.. We are waiting for a conve-nient day of the Chief Minister for the inaugural function. If the COVID-19 situation is completely under control, it may happen within the next two week," Mr Noushad told news agency PTI.

According to local tradition, Cheraman Perumal, as the king, went to Arabia where he met the Prophet and embraced Islam in the early 7th century. From there, he had sent letters, along with Malik Ibn Dinar, as a Persian scholar who travelled to India.

Dinar is believed to have built the masjid in 629 AD, five years after the king's death.

Mr Noushad said they focused more on conserving the exist-ing portions of the old structure and recreate its appearance in the past based on the old photographs.

"We demolished

that such portions had been renovated and conserved. Besides the MHP's conser-

vation effort, a multi-crore construction project is also underway at the mosque under the aegis of the mosque management.

An underground prayer hall, being constructed, is envisaged to accommodate at least 2000-3000 devotees. A total of 15-20 crore is expected for the same, the MD explained.

"It's structural work and internal plastering is over. Flooring and beautification work is pending and expected to be completed soon," he added.

The MHP, entrusted with the heritage management by the state government, had initiated discussions with the mosque committee and entered into an MoU with them for implementing the renovation and conservation initiatives. After the renovation, the MHP is now awaiting the nod to include the Cheraman Juma Masjid in the Union Ministry of Tourism's 'National Mission on Pilgrimage Rejuvenation and Spiritual Augmentation Drive (PRASAD). A proposal for a 10 crore

project has been submitted to the Centre in this regard, the official said adding that the construction of a facilitation centre and the rejuvenation of a pond in the mosque campus would be a reality if it is included in the PRASAD scheme.

"A large number of people from across the state are coming here now to have a glimpse of the renovated structure of the oldest mosque, " Mr Noushad added.

The Cheraman Masjid occupies a pivotal place in the Muziris civilisation that enjoyed glory as the ancient world's greatest trading centre in the East, trading everything from spices to precious stones.

Chinese Hackers Targeted Aadhaar Database, Times Group: Report

hinese state-sponsored hackers are believed to have infiltrated and stolen data from an Indian government agency responsible for a national identification database and one of that country's largest media conglomerates, according to a new report by cybersecurity firm Recorded Future Inc. Both the government agency and the media company dispute the claims.

The Unique Identification Authority of India, also known as the UIDAI, contains the private biometric information of more than 1 billion Indian citizens. The authority's networks were believed to have been breached during intrusions tracked between June and July this year, though it's not clear what data was taken, according to Recorded Future. The government agency said it had no knowledge of such a breach and that its

database was encrypted and only available to users with multifactor authentication. The agency had a "robust security system in place" that was constantly upgraded to maintain the "highest level of data security and integrity an email from the agency said. Bennett Coleman & Co., also known as the Times Group, which publishes the Times of India, also appeared to be tar-geted by the Chinese hackers, according to Recorded Future. Data was exfiltrated from the company between February and August, but it wasn't clear data was stolen, Recorded Future said. The company dismissed the report, saying the "alleged exfiltration" was blocked by its cybersecurity defenses. Turkish President Again Makes Reference To Kashmir In UN General Assembly

UNITED NATIONS: Turkey's President Recep Tayyip Erdogan has again referred to the issue of Kashmir in his address to world leaders at the high-level UN General Assembly session.

Last year also, Erdogan in his pre-recorded video statement to the General Debate had made a reference to Jammu and Kashmir. India at that time termed it as "completely unacceptable", saying Turkey should learn to respect the sovereignty of other nations and reflect on its own policies more deeply.

Erdogan in his address to the General Debate on Tuesday said: "We maintain our stance in favour of solving the ongoing problem in Kashmir for 74 years, through dialogue between the parties and within the framework of relevant United Nations resolutions."

The Turkish President, a close ally of Pakistan, had repeatedly raised the issue of Kashmir in his address to the high-level General Debate. He had also raised the Kashmir issue during his visit to Pakistan last year.

The Ministry of External Affairs (MEA) at that time has said Erdogan's remarks reflected neither an understanding of history nor of the conduct of diplomacy and that they will have strong implications on India's ties with Turkey.

It said India rejected the repeated

attempts by Turkey to justify the cross-border terrorism "practised so blatantly" by Pakistan.

In his address on Tuesday, the Turkish President also referred to China's minority Muslim Uyghurs in Xinjiang and Myanmar's Rohingya during his address.

Erdogan said that "within China's territorial integrity perspective, we do believe that more efforts need to be displayed regarding the protection of the basic rights of the Muslim Uyghur Turks.'

The US and the EU besides many other countries have accused China of committing genocide against the Uyghurs in resource-rich Xinjiang and called for an international probe by human rights groups.

"We also support ensuring the safe, voluntary, dignified return of Rohingya Muslims, who are living in difficult conditions in camps in Bangladesh and Myanmar, back to their motherland," Erdogan said.

Responding to the Times Group's comments, Jonathan Condra, the lead analyst on Recorded Future's report, said he was able to observe "sustained communications across a single session that lasted five days" from the media company's networks. He said there were also "strong indications" that the communications were coming from within the Times' computer networks and going out to malicious servers, "which suggests a successful implant communicating outwards." works have escalated in the past year, Recorded Future said in its report. The alleged Chinese hacks follow a rapid deterioration in relations between the two countries According to its data, Recorded Future said there was a 261% increase in the number of suspected state-sponsored Chinese cyber operations targeting Indian entities through August of this year, compared to 2020. The suspected intrusions track back to the start of a bloody skirmish between Indian and Chinese soldiers at a border post in the Himalayas, Mr Condra said.

MUMBAI: Two foreign nationals, a woman and her daughter, were arrested by customs officials with nearly 5 kg of heroin worth ₹ 25 crore at the Chhatrapati Shivaji International Airport in Mumbai, an official said on Wednesday.

The narcotics was concealed in the cavities of the trolley bags carried by the two women, who had travelled to Mumbai on Sunday from South Africa's Johannesburg via Doha in a Qatar Airlines flight, the official told news agency Press Trust of India.

Their nationality of the two women was not disclosed.

The women were caught with 4.95 kg of heroin worth ₹25 that the accused had arrived in India on the pretext of seeking treatment for lung cancer. A probe revealed the two women were supposed to deliver the consignment at a hotel

room and was going to get a huge amount of money for carrying and delivering the contraband, the official said.

The customs department has started a search for the person who was supposed to receive the drug consignment, he said.

The two women, arrested under relevant sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act. was produced in a court which remanded them in judicial custody for 14 days, the official added.
