Families Question 'Encounter', **Police Asserts Militancy Links**

after **SRINAGAR:** Shortly the police claimed to have killed militants in Srinagar's Hyderpora locality, the families of the two slain civilians have questioned the police version, asserting that both of them were killed in "cold blood".

Four persons were killed in a shootout, according to police, Monday night in the high security quarter of the city. They included Muhammad Altaf Bhat, the house owner and his tenant Mudasir Gul, a dentist turned businessman.

Noha Bhat, the daughter of 48 year old Muhammad Altaf Bhat, who owned the property where the killings took place, raised questions over the police version of the incident. "There is no proof of militants being there (in the building)," she said. "There was no firing from the other side.' Inspector General of Police

Rs 35,000 Cr Investments Expected In J&K By Dec: LG

IAMMU: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Tuesday said investments in the Union Territory are expected to reach Rs 35,000 crore by December 2021 and proposals for Rs 25.000-crore funding have already been received.

Sinha highlighted the key reforms and steps taken for managing the UT's economy during COVID-19, its growth potential and focus areas, besides putting across issues that require consideration by the Union government during interaction with Finance Minister Nirmala Sitharaman, in a meeting chaired by her.

Highlighting the steps taken for growth in the economy, the lieutenant governor said "the investment in J&K is expected to

BJP Seeks 'Security Audit' Of Minority Areas, KP Camps In Kashmir

JAMMU: In the wake of alleged selective killings of minority community people by terrorists in Jammu and Kashmir, the BJP Tuesday demanded a comprehensive security audit of minority areas and transit camps housing Kashmiri Pandit employees in the Valley.

The demand was raised by J&K BJP spokesperson and former legislator Girdhari Lal Raina in a meeting with Lieutenant Governor Manoj Sinha at the Raj Bhawan here.

Raina also sought resolution of teething problems troubling the displaced community, in particular those related to the security of religious minorities of Kashmir including employees recruited under the prime minister's employment package.

6 Kargil Students Summoned For Provoking Anti-Govt Protest

SRINAGAR: The Ladakh administration has summoned six students for allegedly provoking girl students to stage an anti-government protest last month in the mountainous Kargil district of the newly carved out Ladakh

Union Territory. At least six students have been summoned by the Executive Magistrate, 1st class, Kargil for allegedly trying to breach peace and create chaos by provoking the students of girls' higher secondary against the administration, sources told Kashmir Observer.

Pertinently, scores of girls' students hit the streets in Kargil town on October 28 and staged a protest over the alleged occupation of the land by some locals belonging to the girls' higher secondary school. The protesting students had marched to the

office of Deputy Commissioner, Kargil to press for their demand. The protesting students were given assurance by the ADC, Kargil that their genuine demand

A sudden arrival of Altaf's son in the mourner's room pitched these wails. "When is he coming back home?" Ibaad asks, innocently, amid the wails in his house.

Some five miles from this mourning household of old Barzulla, another family in Kanipora is trying to come to terms with their doctor son's death.

His entire family had gone to the Police Control Room for his body but they were denied on the grounds that it will create a "law and problem". To

Baderwah labourers killed as militants

RINAGAR: The three persons described as militants claimed to have been killed in an encounter in Bhadarwah area of Doda dis¬trict three days ago have turned out to be innocent labourers whom the security forces had picked up.

According to a report, the security forces had taken three local mazdoors working with a contractor in a forest of Bhadarwah area for guiding them. However, they did not return till late in the eve¬ning. Next day, the government claimed killing of 'three militants' in an 'encounter' with the security-forces in

Bodies of the slain 'militants', the agency report said, were handed over to the local police station where these remained unidentified for two days.

 $\label{eq:meanwhile} \mbox{Meanwhile, the contractor approached the police station}$ to lodge the first information report (FIR) about the missing labourers. He was shunned on seeing the bodies of the three labourers lying there. They were identified as Muhammad Yousuf s/o Muhammad Qasim of Dunadhi Gandoh, Muhammad Yaqub s/o Sain Gujjar of Balgara and Muhammad Ishaq of Teeligarh, Chanote, Bhadarwah.

It may be recalled a 9th class student identified as Ishrat Qayoom was killed in an encounter in the area two days earlier. A militant, Abu Hasan, had also been killed in the gunbattle. (KASHMIR OBSERVER, 17 NOVEMBER, 2000)

Number Of Smokers Globally Expected To Fall To 1.27 Billion By 2025: WHO

GENEVA, SWITZERLAND: The number of smokers worldwide has dropped steadily in recent years, the World Health Organization said Tuesday, urging countries to step up control measures further to kick deadly tobacco addiction.

Tobacco use is estimated to kill more than eight million people each year, most of them directly due to their own tobacco use, while 1.2 million of them are non-smokers exposed to second-hand smoke, according to WHO numbers.

Tuesday's report cautioned that the annual numbers of deaths would continue climbing for some time even as tobacco use declines "because tobacco kills its users and people exposed to its emissions slowly."

The report hailed that 60 countries were now on track to reduce tobacco use by 30 percent between 2010 and 2025.

When WHO published its last two years ago, only 32 countries were on track to do so.

Pfizer Allows Others To Make Its Covid Pill, 53% Of The World To Benefit

GENEVA: US pharmaceutical giant Pfizer on Tuesday announced a deal to make its prospective antiviral Covid-19 pill available more cheaply in the world's least wealthy countries.

Pfizer will sub-licence production of its promising Paxlovid pill to generic drug manufacturers for supply in 95 low- and middle-income nations covering around 53 percent of the world's population.

Under the deal struck with the global Medicines Patent United Nations-backed interna-Pool (MPP), Pfizer -- which also ly-used Covid vaccines with German lab BioNTech -- will not receive royalties from the generic manufacturers, making the treatment cheaper.

The agreement is subject to the oral antiviral medication passing ongoing trials and regulatory approval.

The Pfizer drug is to be taken Interim data from ongoing trials demonstrated an 89 percent reduction in the risk of Covid-19-related hospitalisation or in non-hospitalised high-risk adults with Covid-19 within three days of symptom onset, said Pfizer.

Similar results were seen within five days of symptom onset, it added.

Ahmadabad To Remove Non-Veg Food Stalls From Roads



High Court Allows Sale Of Herbal Hookah In Restaurants, Pubs In Delhi

NEW DELHI: The Delhi High Court has allowed for the time being the use of herbal hookah in restaurants and pubs in the national capital, saying that COVID-19 restrictions cannot be permitted to

continue at the cost of livelihood. Justice Rekha Palli, who was hearing a batch of pleas by several restaurants and bars against the prohibition on the sale or service of herbal flavoured hookahs, said that prohibitions imposed on account of the pandemic "cannot go on forever" and noted that the authorities have already permitted cinema halls and swimming pools

to function at full capacity. granting permission as an interim

Ban On IRF Founded By Islamic Preacher Zakir Naik Extended By 5 Years

NEW DELHI: The ban imposed on Islamic Research Foundation (IRF), set up by Zakir Naik who was accused of inspiring Muslim youths in India and abroad to commit terror acts, has been extended by the Centre by five years.

Naik, who was born in Mumbai but fled India in the wake of the 2016 Dhaka bombing, is accused of spreading hatred among different communities through his Peace TV and social media networks where he has over 20 million followers. and is currently living in Malaysia.

In a late-night notification, the Union Home Ministry said the IRF has been indulging in activities which are prejudicial to tential of disturbing peace and communal harmony and disrupting the secular fabric of the country and hence declared unlawful

under the stringent anti-terror law UAPA. The IRF was first banned under the Un-



lawful Activities (Prevention) Act by the central government on November 17, 2016. Naik fled India after the July 1, 2016 bombing at a cafe in Dhaka where terrorists killed over 20 people, including 17 foreigners.

One of the bombers of the Bangladesh capital had said that he was inspired by Naik's speeches. Facebook Says Hackers In Pakistan Targeted Afghan **Users During Taliban Takeover**

Hackers from Pakistan used Facebook to target people in Afghanistan with connections to the previous government during the Taliban's takeover of the country, the compa-

ny's threat investigators said in an interview with Reuters. Facebook said the group, known in the security industry as SideCopy, shared links to websites hosting malware which could surveil people's devices. Targets included people connected to the government, military and law enforcement in Kabul, it said. Facebook said it removed SideCopy from its platform in August.

The social media company, which recently changed its name to Meta, said the group created fictitious personas of young women as "romantic lures" to build trust and trick targets into clicking phishing links or downloading malicious chat apps. It also compromised legitimate websites to manipulate people into giving up their Facebook credentials.

"It's always difficult for us to speculate as to the end goal of the threat actor," Facebook's head of cyber espionage investigations, Mike Dvilyanski, said. "We don't know exactly who was compromised or what the end result of that was." _REUTERS

Value Of Life In Kashmir

our persons were killed in an encounter at Hyderpora in Srinagar on Monday. According to police, two of them were militants - one of them a foreigner - an overground worker (OGW) and the house owner. However the families of the alleged OGW Mudassir Gul and the house owner Altaf Ahmad claim they were innocent civilians. The family of Gul has identified him as a doctor. Ahmad's family has alleged he was used as a human shield. This has cast doubt on the encounter which the government should be doing everything to dispel. All major politicians in the Valley have called for probe into the killings with former J&K Chief Minister going so far as to term the encounter as "fake". Another former chief minister Mehbooba Mufti has termed the use of human shield as part of the government's "rulebook" now. Similarly, People's Conference chief Sajad Lone and Srinagar mayor Junaid Azim Mattu has also called for an enquiry into the killings.

This makes it incumbent on the government to order a probe into this tragic incident. Not doing so will not reflect well on it. It is true that the killings of civilians have now become a new normal in Kashmir. There is little outrage let alone any steps being taken to prevent their occurrence. The government looks at the situation in law and order terms. This rationalizes the civilian killings.

The governments, both in J&K and in New Delhi, are happy to rationalize the situation in terms of the law and order. This is a sad state of affairs and explains why more things change in Kashmir, more they remain the same. In fact, the governments by resorting to an exclusively security driven approach have only worsened the situation. Let alone dialogue or a political engagement, even the leadership has been largely absent. If a turnaround is to be expected, the government needs to move beyond the use of force as the remedy. This has only perpetuated the cycle of death and destruction.

One invariable part of the continuing tragedy of Kashmir has been that its people are generally considered incidental to the long-standing conflict over the region. Across the world, Kashmir is primarily known as an issue between India and Pakistan. The two countries have fought three wars over the region. The troubled situation in Kashmir is seen as an extension of this conflict. with its people seen as acting on behalf of one or the other country. Their aspirations and agency count for little. Over 70,000 killings so far and their continuing humanitarian fallout have little weight.

What is more, people continue to die every day under various labels largely unknown and uncared for in the rest of India, let alone by the world. This has bred a numbness towards the conflict that remains as intractable as ever. If things have to change in Kashmir, the lives in Kashmir including those of the security personnel have to start to matter.

Another CoP Out?

f there is one thing that different governments ought to be able to agree on, it is the need to save the planet. Yet, after two weeks of heated debates, negotiators ended Friday the official culmination of CoP26, the United Nations climate change conference — without a shared, global commitment. Talks continued on Saturday, but it appears that any agreement, if reached, will represent a watered-down effort with enough wiggle room so that it will be hard to truly hold most nations accountable. It all looked so different in the early days of the summit, when India announced a net-zero emissions target by 2070 and multiple nations struck mini deals with major implications. More than 100 world leaders agreed to end deforestation by 2030. The United States of America and the European Union announced a joint plan to cut methane emissions by 2030. In a surprise announcement, China and the US - otherwise bitter geopolitical rivals - agreed to work together to limit the global temperature increase to 1.5 degrees Celsius from pre-industrial levels.

But when it comes to forging a global consensus on some of the knottiest issues around climate change, world leaders and their teams appear ready to kick the can down the road. It is clear that major coal consumers like China, the US and India do not want to commit to a timeline for phasing out the use of fossil fuel. If that resistance has been partly responsible for holding up an outcome in Glasgow, CoP26's host city, the reluctance of wealthy nations to deliver on their promises to help finance the transition of developing nations to green economies is equally to blame. Emerging economies, many of which are among the worst victims of climate change, are also seeking a global fund to help them adapt to extreme weather events. Once again, developed countries are hesitant to step up.

Old Foes, New Face-Off

India And Pakistan Are Poised Against Each Other, To Play A More Proactive And Constructive Role In Afghanistan's Redevelopment, Trying To Negate Each Other's Initiatives

to power in Afghanistan almost two-and-a-half months ago, after the hasty and chaotic withdrawal of the US forces from the country had raised hopes that Afghanistan may see the dawn of a peaceful era and the Taliban 2.0 might be able to establish a stable and secure government in the country.

he ascendancy of Taliban

Since August, a lot of regional and multilateral meetings and conferences have been hosted to find a roadmap to lead Afghanistan to peace and stability, besides various country's representatives meeting Taliban representatives in Doha.

Countries that have a lot of stake in Kabul and are affected by the Afghanistan affairs both internally and externally have taken most of these initiatives.

Meetings on Afghanistan

Russia hosted the first regional conference titled Moscow Format Consultations on Afghanistan in which all the Central Asian republics, China, Iran, Pakistan and India and a high-level Taliban delegation also participated.

Its objective was to find "a regional consensus" amongst the participants regarding the Taliban2.0. But the primary objective was to get the Taliban to form a broad-based government in Kabul, reflecting the country's ethnic and religious diversity and ensure basic human rights of all Afghans particularly the women and children, and get an assurance from the Taliban that Afghan territory will not be allowed to be used as a launchpad for terrorist attacks on other countries.

Soon after, Tehran hosted a similar conference of regional and neighbouring states to discuss how to deal with the Taliban. Once again, the de facto objective was to find a regional consensus and to pressurise the Taliban to adhere to its commitments. Its additional aim was to ensure the welfare and safety of the Hazara community and other Shias of Afghanistan.

DRSD and T+ Meetings

However, the most curious of the meetings were hosted by India and Pakistan on 10th and 11th of November in New Delhi called the Delhi Regional Security Dialogue and in Islamabad called Troika Plus. It seems as if the two regional foes wanted to

establish their supremacy over each other, in order to play a crucial role in the redevelopment of Afghanistan. But a more curious play out during

these meetings was that no Taliban representative was present at either of the two, though the acting foreign minister of the Taliban government, Amir Khan Muttaqi was present in Islamabad from 10 to 12 November. He had to contend with meeting the participating special representatives of Pakistan, US, Russia and China and Pakistan prime minister and foreign minister separately.

In yet another twist, Russia issued a statement of its own after the release of the Delhi Declaration based on a twist of words and nated at different times during the last twenty years, but were described as controversy theories and were brushed under the carpet. But now the turn of events shows that they indeed were true.

According to reports published by Afghanistan's Ministry of Mines and Petroleum, the country possesses at least \$1 trillion of untapped mineral resources. A country of 38 million people is estimated to hold more than 2.2 billion tonnes of iron ore, 1.3 billion tonnes of marble and 1.4 million tonnes of rare earth minerals like Lithium, Chromite, Aluminium etc. besides Gold and Silver.

According to geologist Scott Montgomery, a minimum of seven to 10 years is required to develop large-scale mining in Afghanistan, to become a major source of revenue for the poor country. On September 2, the Taliban said that the group would rely primarily on financing from China, which already holds several long-term mining leases around the country.

So one can deduce that this newfound love for Afghans and Afghanistan is based on the hunger for these mineral resources. During the last twenty years, the American geologists might have identified key areas and processes to be adopted to mine these resources, yet the US based on experience understands very well that to commercially exploit this natural wealth of Afghanistan, a peaceful and business conducive atmosphere is needed, otherwise in a war ravaged country the cost of mineral commercialisation may shoot up very high. That's why it seems to have propped up Taliban 2.0, ensuring that they are able to establish their government and promising them to give a small percentage of the revenues back to it as Developmental Aid and pocket the big chunk of revenue and utilising the rare minerals for its industries. The

technicalities but this is uncalled rest of the international community for in diplomatic circles.

On China skipping the dialogue, sources said that though it is not attending the conclave because of the scheduling difficulties, it has conveyed its readiness to maintain contacts with India on Afghanistan through bilateral and multilateral channels.

Why so much worry about Afghanistan?

Now the question that arises is, why are different regional and international players so interested in Afghanistan? The US which entered Afghanistan twenty years back, following the traces of its one time prodigy in the name of War on Terror, is also seen kowtowing to the same Taliban with which it fought for twenty long years.

The underlying reason seems to be based on reports, which origi-

too seems to be following this blueprint. A classic case of present day economic imperialism.

As far as India is concerned, it wants to play a constructive role in Afghanistan, so as to ensure that the still present rogue terrorist elements in Afghanistan do not find their way to Indian Kashmir. Though it established contacts with Taliban last, but was seen as lagging behind to pursue them proactively, perhaps because of internal political dynamics. But it will have to take a calculated risk to engage with the Taliban with foresight, so as to manage Pakistan's rude attitude on the issue, which considers Afghanistan as its protectorate and can't tolerate any Indian play. Only then India could claim to be a regional power.

have been the areas where we need to focus. Parents and schools can collaborate to provide kids to socialise safely and get involved in physical activities like sports as well.



Tolerance In Islamic Tradition

TOLERANCE IS A NOBLE

Islamic thought suggested in many verses of Quran in different forms, with complete emphasis and explicitness. The Islamic tradition, in principle as well as in practice, provides compelling answers to many questions pertaining to the relationship between religious tolerance and the practice of one's own faith

International Day for Tolerance is commemorated every year on November 16 to foster mutual understanding among different cultures and strengthen tolerance among people. For its fiftieth anniversary on 16 November 1995, UNESCO's Member States adopted a Declaration of Principles on Tolerance. Among other things, the Declaration affirms that tolerance is respect and appreciation of the rich variety of our world's cultures, our forms of expression and ways of being human. Tolerance recognizes the universal human rights and fundamental freedoms of others. People are naturally diverse; only tolerance can ensure the survival of mixed communities in every region of the globe. The Declaration qualifies tolerance not only as a moral duty, but also as a political and legal requirement for individuals, groups and States. It emphasizes that States should draft new legislation when necessary to ensure equality of treatment and of opportunity for all groups and indi-

viduals in society

We are living in a globalised world, with diverse religious, ethnic, cultural, social, economic and political backgrounds. All these suggest the importance for a better understanding of one another through interfaith partnership. The objective of interfaith partnership is to create mutual understand-

Lunar Catch

Moon's Surface Has Enough Oxygen To Sustain 800 Crore Humans For 1 Lakh Years – But There's A Catch

longside advances in space exploration, we have recently seen much time and money invested into technologies that could allow effective space resource utilisation. And at the forefront of these efforts has been a laser-sharp focus on finding the best way to produce oxygen on the Moon.

In October, the Australian Space Agency and NASA signed a deal to send an Australian-made rover to the Moon under the Artemis program, with a goal to collect lunar rocks that could ultimately provide breathable oxygen on the Moon.

Although the Moon does have an atmosphere, it is very thin and composed mostly of hydrogen, neon and argon. It is not the sort of gaseous mixture that could sustain oxygen-dependent mammals such as humans.

That said, there is actually plenty of oxygen on the Moon. It just is not in a gaseous form. Instead, it is trapped inside regolith – the layer of rock and fine dust that covers the Moon's surface. If we could extract oxygen from regolith, would it be enough to support human life on the Moon?

Breadth of oxygen

Oxygen can be found in many of the minerals in the ground around us. And the Moon is mostly made of the same rocks you will find on Earth (although with a slightly greater amount of material that came from meteors).

Minerals such as silica, aluminium and iron and magnesium oxides domi-



nate the Moon's landscape. All of these minerals contain oxygen, but not in a form our lungs can access.

On the Moon, these minerals exist in a few different forms including hard rock, dust, gravel and stones covering the surface. This material has resulted from the impacts of meteorites crashing into the lunar surface over countless millennia.

Some people call the Moon's surface layer lunar "soil", but as a soil scientist, I am hesitant to use this term. Soil as we know it is pretty magical stuff that only occurs on Earth. It has been created by a vast array of organisms working on the soil's parent material – regolith, derived from hard rock – over lakhs of years.

The result is a matrix of minerals that were not present in the original rocks. Earth's soil is imbued with remarkable physical, chemical and biological characteristics. Meanwhile, the materials on the Moon's surface is basically regolith in its original, untouched form.

Extracting oxygen

The Moon's regolith is made up of approximately 45% oxygen. But that oxygen is tightly bound into the minerals mentioned above. In order to break apart those strong bonds, we need to put in energy.

You might be familiar with this if you know about electrolysis. On Earth, this process is commonly used in manufacturing, such as to produce aluminium. An electrical current is passed through a liquid form of aluminium oxide (commonly called alumina) via electrodes, to separate the aluminium from the oxygen.

In this case, oxygen is produced as a byproduct. On the Moon, the oxygen would be the main product and the aluminium (or other metal) extracted would be a potentially useful byproduct.

It is a pretty straightforward process, but there is a catch: it is very energy hungry. To be sustainable, it would need to be supported by solar energy or other

Extracting oxygen from regolith would also require substantial industrial equipment. We would need to first convert solid metal oxide into liquid form, either by applying heat, or heat combined with solvents or electrolytes. We have the technology to do this on Earth, but moving this apparatus to the Moon – and generating enough energy to run it – will be a mighty challenge.

Earlier this year, Belgium-based startup Space Applications Services announced it was building three experimental reactors to improve the process of making oxygen via electrolysis. They expect to send the technology to the Moon by 2025 as part of the European Space Agency's in-situ resource utilisation mission.

Quantity of oxygen

That said, when we do manage to pull it off, how much oxygen might the Moon actually deliver? Well, quite a lot as it turns out.

If we ignore oxygen tied up in the Moon's deeper hard rock material – and just consider regolith which is easily accessible on the surface – we can come up with some estimates.

Each cubic metre of lunar regolith contains 1.4 tonnes of minerals on average, including about 630 kilograms of oxygen. NASA says humans need to breathe about 800 grams of oxygen a day to survive. So 630 kg oxygen would keep a person alive for about two years (or just over).

Now let us assume the average depth of regolith on the Moon is about ten metres, and that we can extract all of the oxygen from this. That means the top ten metres of the Moon's surface would provide enough oxygen to support all 800 crore people on Earth for somewhere around 1 lakh years.

This would also depend on how effectively we managed to extract and use the oxygen. Regardless, this figure is pretty amazing!

Having said that, we do have it pretty good here on Earth. And we should do everything we can to protect the blue planet – and its soil in particular – which continues to support all terrestrial life without us even trying.

Study finds increase in obesity among children during Covid pandemic

month-long study done by a leading private facility in New Delhi has found that more than half of the children surveyed had reported increase in body weight due to sedentary lifestyle and other factors during the COVID-19 pandemic.

The results of the online survey conducted during October 1-31 by Sir Ganga Ram Hospital were released on Saturday.

Institute of Minimal Access, Metabolic and Bariatric Surgery in association with Institute of Child Health of the hospital carried out a simple survey to "quantify the magnitude of rising obesity during this ongoing pandemic," the hospital authorities said in a statement.

"The results are shocking. More than 60 per cent of the respondents replied in the affirmative that their children had gained over 10 per cent of their base line weight. Most attributed it to the sedentary lifestyle along with the easy availability of fast food. Eating disorders were also due to the stress and abnormal sleep cycles," it said.

The 1,309 children surveyed, aged an average of 15 years, the statement said.

According to Sudhir Kalhan, Chairman, Institute of Minimal Access, Metabolic and Bariatric at the hospital, "We did a survey among 1,309 children, who were

forced to sit at home during the recent Covid crisis. We found there was an approximately 10 per cent weight gain among 60 per cent of the respondents i.e. 785 children."

"Majority of them (36.8 per cent of the respondents) reported sedentary life as the major cause of weight gain, where as 27.55 per cent reported sleeping late as a triggering factor, and 22.4 per cent reported overeating as cause for weight gain," he said.

The multitude of respiratory complications, the secondary infections like mucormycosis or black fungus and the uncontrolled diabetes are still causing ravage in the society, doctors said.

Study finds best way to avoid procrastination

No deadline and the oneweek deadline led to many early responses, while a long deadline appeared to give people permission to procrastinate, and then forget.

Professor wasn't surprised to find that specifying a shorter deadline increased the chances of receiving a response compared to a longer deadline. However, he did find it interesting that they received



the most responses when no deadline was specified.

"We interpret this as evidence that specifying a longer deadline, as opposed to a short deadline or no deadline at all, removes the urgency to act, which is often perceived by people when asked to help," he said.

"People, therefore, put undertaking the task and since they are inattentive or forget, postponing it results in lower response rates," he added.

He said it is possible that not specifying a deadline might still have led participants to assume that there is an implicit deadline.

Professor Knowles hopes his research can help reduce the amount of procrastinating people do.

China Is Now World's Richest Nation, Ahead Of US

BEIJING: Global wealth tripled over the last two decades, with China leading the way and overtaking the U.S. for the top spot worldwide.

That's one of the takeaways from a new report by the research arm of consultants McKinsey & Co. that examines the national balance sheets of ten countries representing more than 60% of world income

"We are now wealthier than represents an I.O.U. by that we have ever been," Jan Mischke, a partner at the McKinsey Global Institute in Zurich, said in an interview.

Net worth worldwide rose to \$514 trillion in 2020, from \$156 trillion in 2000, according to the study. China accounted for almost one-third of the increase. Its wealth skyrocketed to \$120 trillion from a mere \$7 trillion in 2000, the year before it joined the World Trade Organization, speeding its economic ascent.

Richest 10%

muted increases in property prices, saw its net worth more than double over the period, to \$90 trillion.

In both countries -- the world's biggest economies -- more than two-thirds of the wealth is held by the richest 10% of households, and their share has been increasing, the report said.

As computed by McKinsey, 68% of global net worth is stored in real estate. The balance is held in such things as infrastructure, machinery and equipment and, to a much lesser extent, socalled intangibles like intellec-

tual property and patents. Financial assets are not counted in the global wealth calculations because they are effectively offset by liabilities: A corporate bond held by an in- it more in line with world individual investor, for instance, come. (Bloomberg)



'Side Effects'

The steep rise in net worth over the past two decades has outstripped the increase in global gross domestic product and has been fueled by ballooning property prices pumped up by declining interest rates, according to McKinsey. It found that asset prices are almost 50% above their longrun average relative to income. That raises questions about the sustainability of the wealth boom.

"Net worth via price increases The U.S., held back by more above and beyond inflation is questionable in so many ways, Mischke said. "It comes with all kinds of side effects.'

Surging real-estate values can make home ownership unaffordable for many people and increase the risk of a financial crisis -- like the one that hit the U.S. in 2008 after a housing bubble burst. China could potentially run into similar trouble over the debt of property developers like China Evergrande Group.

The ideal resolution would be for the world's wealth to find its way into more productive investments that expand global GDP, according to the report. The nightmare scenario would be a collapse in asset prices that could erase as much as onethird of global wealth, bringing

Fitch Affirms India's Sovereign Rating At 'BBB-', Retains Negative Outlook

NEW DELHI: Fitch Ratings on Tuesday kept India's sovereign rating unchanged at 'BBB-' with a negative outlook, and said that the rating balances a still-strong medium-term growth outlook and external resilience from solid foreign-reserve buffers against high public debt, a weak financial sector and some lagging structural issues. It said the country's rapid economic recovery from the Covid-19 pandemic and easing financial sector pressures are resilience of India's economy, narrowing risks to the mediumterm growth outlook.

However, the negative outlook on the rating reflects lingering uncertainty around the medium- at 'BBB-'; with a negative outlook. term debt trajectory, particularly

still had no inkling that his father had been killed. "I appeal to them [the police] to at least give his dead body back," she said. "He was not a militant. He was killed only because he was a Muslim. What regime rules here," daughter said in a video clip that went viral on social media

She further alleged that the police fled after murdering her father, to which a tenant in the building was an eyewitness. The tenant, later identified as Mudasir Gul, who she claimed "was a witness to the incident, was also shot dead."

Mudasir was a dental surgeon by qualification and businessman by profession. As per the Gul family, Mudasir was in the process of setting up a call centre in Altaf Bhat's property and was residing there with his business partner Imran and their office helper from Banihal, Aamir.

Muzamil Gul, brother of the deceased, said quoting an eyewitness, the Police Special Operations Group (SOG) personnel arrived at the building in three Tavera vehicles and directed them to evacuate.

The eyewitness had not recognised the presence of a fourth individual, Gul quoted

Later, the three men were again directed to accompany the SOG personnel back inside the building, Gul quoted the eyewitness as saying. "As soon as they had stepped inside the building, the police fired upon them," alleged Muzamil.

"My brother was no militant associate and neither was he harbouring anyone," he said. "My brother was killed in cold blood

Amid questions surrounding the alleged gunfight, the Jammu and Kashmir Police called for a hurried press conference on Tuesday, where the IGP Vijay Kumar, flanked by Srinagar police chief, Sandeep Chaudhary, reasserted their version of the killings.

Kumar, while acknowledging Altaf and Mudasir as civilians, said the two were injured when militants opened fire using pistols. The police, he said, fired back "in self defence" leading to the encounter.

Kumar said: "It is not sure whether militant bullets or the bullets fired by forces hit him [Altaf Bhat]. Militants were carrying pistols and it would be clear after investigations whose bullet hit him."

Kumar added that a Special Investigation Team led by the Deputy Inspector General (DIG) will further head a probe into how the alleged encounter went down.

Kumar earlier alleged that Mudasir had provided shelter to a foreign militant Haider and his associate-office helper Aamir-and "was also involved in ferrying Haider from the recent attack site of Jamalatta (Nawakadal) Srinagar where a police man was injured.'

Kumar also said that police have recovered two pistols, magazines, besides six mobile phones and an unspecified number of computers from the site of the alleged

Meanwhile families of the two city residents said they visited the police station several times demanding that the bodies be returned to them for proper burial but they were denied.

Citing law and order apprehensions, Kumar however said all the four were ers here. buried by authorities in north Kashmir's Handwara Handwara lies 80 kilometers from Srinagar in North Kashmir.

"However, in the initial exchange of fire, both the individuals accompanying search party received critical gunshot injuries and succumbed to their injuries.

In the ensuing encounter, both the terrorists hiding in the room were eliminated and their bodies were retrieved from the site of encounter," he added.

The police identified the slain militants as Haider alias Bilal Bhai, a Pakistani national and his associate Amir Ahmad, resident of Banihal. Ahmad, police said was a hybrid militant, who was working earlier as an OGW of LeT Commander.

"Preliminary investigation revealed that the killed Mudasir Ahmad was living on rent in the said building and was working as a terrorist associate and also running an illegal call centre," the police spokesperson

He said incriminating materials, arms and ammunition including 2 pistols, 3 magazines, 6 mobile phones, 1 call centre (6 cabins along with 6 computers, 6 CPUs working network, VOIP enabled) various virtual numbers of foreign numbers, dairies with alpha, beta, gamma codes, 1 US map, cabins and other equipments were recovered from the site of the encounter.

"Besides, a hideout of terrorists with warm clothes, snow boots, kitchen equipments, food packets, TV and other necessary equipments like drug bottles, cigarette packets and 04 mobile phones were also recovered," he said, adding

Omar pointed out: "There have been numerous instances of fake encounters in the past and the questions raised about this Hvderpora encounter need to be answered swiftly & in a credible manner."

CPI (M) leader and four-time legislator Mohammad Yousuf Tarigami also demanded a judicial enquiry. "The circumstances in which these killings happened need to be thoroughly probed," he said.

He added: "The rule of the law is being violated with impunity in Kashmir which is highly unfortunate. From arbitrary arrests people, including youth to booking them under draconian laws and now allegations of using civilians as human-shields, the situation is turning from bad to worse."

Tarigami demanded the return of the dead bodies of the killed civilians so that families could perform their last rites. Inspector General of Police Vijay Kumar had on Tuesday said law and order apprehensions led the police to bury them in a graveyard in north Kashmir's Handwara, more than 80 kilometers away from Srinagar.

'Neutral Parties Must Investigate' Meanwhile, chairperson of the Peoples Conference and former minister in erstwhile state's last elected government, Sajad Lone said it was an "opportunity" for Lieutenant Governor Manoj Sinha to "assert that human lives matter" by allowing

a "neutral institution" to probe the killings. Lone added: "In the midst of conflicting claims in the Hyderpora encounter, the least we deserve is a transparent description of what happened by a neutral institution. This is neither the first time nor the last time."

His party criticised the denial of last rites to the family of the killed. "Denying dignity death is an inhuman act," they said.

police, Amir and his Pakistani accomolice were killed in an encounter along ith two others in Hyderpora locality of Srinagar on Monday evening, where an illegal call centre and a "terror hideout" were allegedly being run.

Magray said it was very unfortunate that his son is being dubbed as a militant.

"My son was working with Altaf as an office boy for the last five months and was not a militant. After hearing about the news of his killing this morning, I along with some villagers visited Srinagar to bring back his body but was denied the same by police who claimed that he was a militant," he told report-

"We are nationalists and I myself within a span of two months. killed a militant with bare hands in 2005. My sister and I escaped death with multiple bullet injuries when militants attacked our house to take revenge and forced us to migrate to Udhampur district," he said and lamented, "Is this the reward for the sacrifice of my family?"

After they returned to their village from Udhampur in 2011, the government set up a police picket for their UT protection in view of militant threats,

Moreover, under Mumkin, 250 vehicles have been distributed among eligible youth for their sustainable livelihood in transport sector, and 200 women applicants have been facilitated for generating their livelihood via Tajeswani scheme, he said.

The lieutenant governor also put forth the challenges and issues faced by the UT, including resource gap, higher cost of delivery of services due to unique topography.

In the Valley, officials said, Srinagar reported 51 fresh cases of novel coronavirus, Baramulla 21, Ganderbal 16, Pulwama 12. Kupwara 9, Bandipora 8, Budgam 6 and Anantnag 2. No cases were reported from the twin districts of Kulgam and Shopian in south Kashmir

In the winter capital, officials said, Jammu reported a maximum of 13 new cases, Udhampur and Ramban two each, and one new case each in Rajouri and Doda districts. The five districts of Kathua, Samba. Kishtwar, Poonch and Reasi registered no new cases of Covid-19.

"Moreover, 115 Covid-19 patients recovered during the time, 14 from Jammu Division and 101 from Kashmir," officials said.

'Do Not Travel

Pakistan urged US citizens not to travel to Balochistan province and Khyber Pakhtunkhwa (KPK) province, including the former Federally Administered Tribal Areas (FATA), due to terrorism and kidnapping, and also in the immediate vicinity of the Line of Control due to terrorism and the potential for armed conflict.

"Terrorist groups continue plotting attacks in Pakistan. A local history of terrorism and ongoing ideological aspirations of violence by extremist elements have led to indiscriminate attacks on civilians as well as local military and police targets," it said.

"Terrorists may attack with little or no warning, targeting transportation hubs, markets, shopping malls, military installations, airports, universities, tourist locations, schools, hospitals, places of worship, and government facilities," it said.

"Terrorists have targeted US diplomats and diplomatic facilities in the past," the advisory on Pakistan said.

"Pakistan's security environment has improved since 2014 when Pakistani security forces undertook concerted counterterrorist and counter militant operations. There are greater security resources and infrastructure in the major cities, particularly Islamabad, and security forces in these areas may be more readily able to respond to an emergency compared to other areas of the country. While threats still exist, terrorist attacks are rare in Islamabad," the advisory said.

The US government has limited ability to provide emergency services to U.S. citizens in Pakistan due to the security environment, it said.

Indo-Pak relations deteriorated after India announced withdrawing special powers of Jammu and Kashmir and bifurcation of the state into two union territories in August 2019. The move angered Pakistan, which downgraded diplomatic ties with India and expelled the Indian High Commissioner in Islamabad

Racism In English Cricket: **Rafiq Testifies In Parliament**

LONDON: Giving testimony in tears, former cricketer Azeem Rafiq told a British parliamentary hearing on Tuesday that he was humiliated by the racist abuse and bullying he suffered at England's most successful cricket club.

Rafiq said Yorkshire teamreferencing his Pakistani heritage, and the leadership at the 33-time winners of the English county championship failed to act on the racism.

The Pakistan-born who is Muslim, described his distressing first experience of alcohol at the age of 15 after being asked about his drinking.

"I got pinned down at my local cricket club and had red wine poured down my throat, literally down my throat," the 30-year-old Rafiq said. "The player played for Yorkshire and Hampshire. I (then) didn't touch alcohol until about 2012 and around that time I felt I had to do that to fit in.

"I wasn't perfect. There are things I did which I felt I had to do to achieve my dreams. I deeply regret that but it has nothing to do with racism. When I spoke I should have been listened to. The game as a whole has a problem, with listening to the victim. There is no 'yeah, but' with racism; there is no 'two sides' to racism."

The ICC board on Tuesday awarded the hosting rights of the 2025 Champions Trophy to Pakistan, while picking United States and West Indies as co-host of the 2024 T20 World Cup. This will be the first ever global event hosted in North America.

According to the announcement, India will get to host three ICC events in the next cycle, including the 2026 T20 World Cup and 2031 50-over World Cup, where the country will be co-hosts along with Sri Lanka and Bangladesh, respectively. India will also host the 2029 Champions Trophy singularly.
Pakistan, who had last co-hosted the 1996

World Cup along with India and Sri Lanka, have not been able to host many international games in the country since the 2009 terrorist attack on Sri Lankan team bus in Lahore.

The Champions Trophy was la 2017 and it will be making its return in the ICC calendar after a gap of eight years.

New Zealand and England have recently pulled out of a tour of the country and it will be interesting to see if teams finally get ready to travel to Pakistan.
