1678 KPs Returned To J&K After Aug 2019: GoI Land Of 150 Applicants Also Restored

NEW DELHI: As many as 1,678 Kashmiri migrants have returned to Kashmir after the abrogation of Article 370 for taking up jobs under the Prime Minister's Development Package-2015, the government told parliament on Tuesday.

Union Minister of State for Home Nityanand Rai also said that as per information provided by the government of Jammu and Kashmir, the land of 150 applicants has been restored. "As per the information

provided by the government of Jammu and Kashmir, after abrogation of Article 370, a total of 1,678 migrants have returned to Kashmir for taking up the jobs under the Prime Minister's Development Package-2015," he said in a

written reply to a question. Article 370, which gave special status to Jammu and Kashmir, was abrogated by the central government on August 5, 2019. The state was also divided into two Union Territories.

The minister said the government has taken various measures to restore ancestral properties to migrant Hindus. Under the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection & Restraint on Distress Sales) Act, 1997, District Magistrates (DMs) of concerned Districts in Jammu and Kashmir are the legal custodians of the immovable properties of migrants, who take suo motto action on eviction proceedings More on P10

Obesity Up By 11% Among Men In J&K: NFHS Survey

SRINAGAR: The fifth and latest round of the National Family Health Survey (NFHS) has flagged a worrying increase in the percentage of obesity and overweight across gender groups, particularly among men in the erstwhile state of J&K as the percentage of such cases worsened in the past half a decade.

Pertinently, several of J&K's nutritional indicators have also worsened since the fourth round of the NFHS, which was held in 2015-16. But the erstwhile state has hit a major demographic milestone when the percentage of obesity and Blood pressure in J&K increased at a vicious average among both men

and women, according to the latest survey conducted by the Ministry of Health and Family Welfare between 2019 and 2021. Notably, the silent epidemic of obesity among men is sweeping the erstwhile state and the future looks tense as more men in J&K are suffering through obesity that has increased with a worrying average of 11 percent. The National Family Health Survey - 5 has dropped this big health alert for J&K.

The data in NFHS 2019-21, the fifth in the series, show that among all age groups, the highest spike in obesity was reported among men who are either overweight or obese where the obesity percentage was recorded at 31.6 percent in NFHS-5 report



from 20.5 percent in NFHS-4, 2015-16 report.

The data show that the number was higher in urban J&K where the rate stood at 40.8 per cent

compared to rural J&K where the rate was recorded at 28.2 percent. For women who are overweight or obese (BMI \geq 25.0 kg/ m2), the rate was recorded at 29.3 percent in NFHS-5 that has maintained a same rate what was recorded in NFHS-4. In urban J&K, the rate of 33.4 percent was higher than rural J&K where the rate was 27.9 percent.

This is followed by the category of "Men who have high risk waist-to-hip ratio (≥0.90) (%)" where the percentage was recorded at gruelling 60.7 percent. In this group, too, the number was higher in urban areas where the percentage stood at 66 percent compared to rural J&K where the rate was recorded in the fifth edition of the NFHS series.

rinagar:- The patients at Valley's sole trauma hospital -the Bone and Joint Barzulla, on Tuesday were seen standing in long queues as two of the three X-Ray Machines at the Hospital were not functioning due to "technical" fault.

The patients were writhing with pain as they were standing in que, waiting for their turn.

Many attendants could be seen carrying their patients to the private x-ray labs outside the hospital.

"You can see my patient is not in a position to move out, but we are forced to go for an X-ray outside as the machine hasn't been made functional," said Mohammad Ramza, an attendant from Srinagar.

While patients had a tough time amidst unbearable cold weather, the administration of the hospital said that the matter is being looked into and machines would be made functional at the earliest.

Talking to Kashmir Observer, Medical Superintendent Dr Suhail Mian accepted that two out of three machines are not functioning and the administration will fix the issues as soon as possible.

"One of the X-ray machines stopped working due to an electrical fault and we



will get one restored by tomorrow; the other one may take some time" he said.

He said the sensor of another machine got damaged and we have placed an order for the same. When asked how long it is going to take he said "we never know, it may take a while"

Sources from the hospital told Kashmir Observer that x-ray machines at the hospital are very old and prone to damage.

4 kids among 6 killed in JK

RINAGAR: Six people, including four children, were killed and two others injured in separate incidents across Jammu region since yesterday. According to reports, unidentified gunmen barged into the house of a village defence committee (VDC) member, Gyan Singh, after hurling a grenade towards it and resorted to indiscriminate

firing on the inmates killing four of his minor children and injuring two others at Sharjao village

in Mahore area of Udhampur district last night. Official sources said today that about 10 suspected

militants first threw grenades on Singh's house at Jailanmarh-Sharjao village at around 2245 hours and then barged into it. The victims were sleeping at the time.

The victims were identified as Hoshiar Singh (15), Bika Devi (12), Anju (3) and Darshana Devi (12). Singh and another member of his family, who were injured in the attack had been admitted to hospital, the sources said.

However, a NAFA report said Singh's house was adjacent to an army camp. Security forces cordoned off the entire area this morning. However, no arrests were made.

In an encounter between the security forces and militants, two militants were killed at Gudesa in Banihal area of Doda district yesterday. The deceased were identified as Muhammad Hasil alias Usman r/o Banihal and Muhammad Raliq alias Bambar s/o Ghulam Tarqal.

Unidentified gunmen intruded into the compound of the house of Abdul Rasheed Peer at Churan in Kellar area of Shopian last night. The inmates raised an alarm at which some neighbours came to their rescue. However, while fleeing from the place, the intruders fired some shots without any harm. Official sources said they intended to kill Mst Malla, wife of Peer who they accused was an 'Informer'

The Arrival Of Omicron: Is **Vaccine Inequality To Blame?**

PARIS: In October 2020, as scientists around the world raced to develop a vaccine to fight Covid-19, the leader of the World Health Organization warned against looming 'vaccine nationalism".

In a video address, Tedros Adhanom Ghebreyesus said at the time that the only way to beat the pandemic was by making sure poorer countries had fair access to a vaccine.

"When we have an effective vaccine, we must also use it effectively," he said.

"And the best way to do that is to vaccinate some people in all countries rather than all people in some countries. Vaccine nationalism will prolong the pandemic, not shorten it."

Over a year later, vaccine inequality is undeniable. Rich nations like France and Japan have given at least one dose to over

75 percent of their populations. In South Africa -- where the Omicron variant was first sequenced -- only a quarter of the population has been vaccinated. And is one of the highest inoculation rates on the

continent. But is vaccine inequality the reason behind Omicron's emergence?

French experts tasked with informing their government's pandemic response say Omicron likely

came from a patient with a depressed immune system and is the result of a long line of mutations that accumulated during a chronic infection.

But wherever it came from, its spread would have been "slower, the higher the immunity of the surrounding population," Arnaud Fontanet, scientific advisory board member and epidemiologist at the Pasteur Institute, told AFP.

"You can imagine that the growth of the virus during uncontrolled epidemics creates more opportunities for variants to emerge," he said. - 'Shock the world' -

"I would like for this new worry to shock the world into realising the importance of vaccinating people on a global scale," Fontanet said.

"The planet will only be safe when we achieve a level of global immunity that significantly limits the spread and opportunities for new variants to emerge," he said.

The WHO sounded the alarm on vaccine inequality again in September when countries with plenty of resources began eyeing booster shots for vaccinated adults and others considered vaccines for children. Speaking from WHO's headquar-

ters in Geneva, Tedros called on countries to avoid giving out extra Covid jabs until the end of the year, pointing to the millions worldwide who have yet to receive a single dose.

elhi Chief Minister Arvind Kejriwal on Tuesday said his government is gearing up to fight a possible threat of the Omicron variant of coronavirus and has prepared 30,000 oxygen beds and also ramped up oxygen supply and storage facilities.

The chief minister held a meeting with government departments to review the preparations to deal with a possible third wave. This time, we have prepared 30,000 oxygen beds. Out of these,

Tallest building

Dubai is the glitziest of the UAE's seven emirates and its shining achievement is the needleshaped Burj Khalifa, the world's tallest building.

The 828-metre (2,717-feet) skyscraper, in glistening glass and steel, opened in the downtown area in 2010.

Known as Burj Dubai before its inauguration, it was renamed Burj Khalifa in honour of UAE's President Sheikh Khalifa bin Zayed Al 40 people, and it takes 38 minutes

Will Foil Conspiracies Against Statehood Restoration: Bukhari

SRINAGAR: Apni Party President Altaf Bukhari on Tuesday expressed deep concern over political parties opposed to the restoration of statehood to Jammu and Kashmir.

In a statement, Bukhari vowed that his Apni Party will stay with its pledge and struggle till the Statehood is restored to J&K. "There will be no compromise on this demand, come what may," he remarked.

Bukhari said that since its inception, Apni Party in March 2020, made it clear that it wanted the Statehood restored to J&K at the earliest, while it requested the Supreme Court to decide the matter regarding Abrogation of Article 370 without any further delay keeping in view aspirations of the people.

He said that by their overtures and public posturing it seems that National Conference and PDP are conspiring against restoration of Statehood because they know that Apni Party is the sole party that had taken a firm stand on the issue from day one since this arbitrary decision was taken. "Simply for the reason of their partisan interests, these parties

have started working against Statehood for J&K. Their promise of reuniting Ladakh and J&K is also hollow," Bukhari observed, adding that knowing all this, they want to show that Statehood too is not possible so that they can

avoid accountability to the promises that they had made earlier. He said that Apni Party has time and again maintained that its politics would be rooted in

realism. Bukhari said that Apni Party laid emphasis on restoration of Statehood because snatching away this status had inflicted an assault on the identity of the people of Jammu and Kashmir.

He recalled that this demand was listed in the Apni Party memorandum that was submitted to Prime Minister Narendra Modi and Home Minister Amit Shah from time to time since the inception of the Party.

That time, he said, parties like NC and PDP had started leveling baseless charges, and now they are conspiring to fulfill their petty political ambitions by agreeing to the UT as the final status of Jammu and Kashmir.

"Now these parties have started beseeching for elections in the current status by trying to undermine the idea of the restoration of statehood. Their high mark of getting Article 370 has been edged out of the discourse, and they are maintaining mysterious silence on the restoration of the Statehood to J&K," Bukhari averred.

Azad's Pitch For Statehood

ormer Jammu and Kashmir Chief Minister Ghulam Nabi Azad has called on the Centre to conclude the delimitation process in the union territory by February and hold assembly polls immediately after the winter. Addressing a workers' meeting in Devsar area of south Kashmir's Kulgam on Saturday, Azad also said it was not feasible to conduct polls during the next four months of winter. The former chief minister once again made a strong pitch for the restoration of statehood which, according to him, should be followed up with the delimitation. He rightly said there was no difference of opinion in Kashmir and Jammu over the grant of statehood. "Hindu brothers in Jammu, Sikhs, Muslims in Kashmir and even Pandits want statehood," he said.

Significantly, Azad also called for the restoration of August 4, 2019 position in J&K, something he had been shying away from saying so far. However, he added that till the time the August 4 position was restored, the centre should grant J&K statehood. In his speech, however, Azad ensured he maintained a balance between the sensitivities in Jammu and Kashmir. Recently, many of his loyalists quit the Congress party in the union territory in protest against the current state president of the party Ghulam Ahmad Mir.

But will the centre pay any attention to Azad's pleas on statehood? It is least likely to do so, despite the fact that Azad enjoys a great relationship with prime minister Narendra Modi. When Azad's tenure in Rajya Sabha ended early this year, PM Modi had broken down in his farewell speech for him. But so far as making any political concessions on Kashmir is concerned, there seems hardly any possibility of a rethink in the union government. The centre has no immediate plan to restore statehood. This was also obvious from the recent visit of the home minister Amit Shah to J&K. Statehood, the home minister said will be followed by the fresh delimitation of Assembly seats in J&K and the subsequent elections. A delimitation commission has already been in place for the last over a year and it may soon complete its mandate. The enhancement of the Assembly seats, Shah said, will be followed by holding ny the elections within the union territory framework.

It is not clear whether the statehood that would hopefully come after delimitation and the election would be full or a truncated one where the real power would vest with the governor. Such an arrangement, according to mainstream J&K politicians, would hardly be enough to make a redeeming difference to the existing state of affairs, as fundamentally there won't be much that would change on the ground. But here's hoping that things change for the good and the centre does reach out to Kashmir if not make some real political concessions.

It Is Votes, Stupid!

In Rolling Back Farmer Laws, PM Modi Didn't Back Down. He Made A Clever And Potentially Game-Changing Political Move

THE QUESTION NOW ARISES IS IF the withdrawal of the laws was the outcome of the failure of tapasya as Modi concluded or the steadfastness of the farmers' protest. It RIME Minister Narendra Modi's rolling back of the three contentious farm laws on the occasion of the birth anniversary of Guru Nanak took everyone by surprise. It has been seen as a rare retreat by the PM who has assiduously built a strongman image who does budge from his decision, no matter what. In fact, this image was one of the major factors that catapulted Modi to power at the centre in 2014.

It is true that this image, in part, was also set off by his predecessor Manmohan Singh. Singh's taciturn disposition and passive approach created a mass hankering for a new leader to speak, to interact and articulate the major public concerns and respond to them. More so, for a country that now reveled in imagining itself as a rising global power and thus wanted a leader who radiated some bravado. Modi easily fit the bill. He projected power and strength

Of course, there was much more to Modi: Before he became the PM, he was an engaging media story for the preceding one and a halfdecade during which he incarnated as a strident proponent of Hindu nationalism and a kind of development messiah for his role in turning around Gujarat economy, a fact disputed by the opposition parties and some experts. This made him an all-encompassing persona that spoke to the prejudices, resentments and aspirations of the majority community. In power, he has lived up to this image. Perhaps never in the past seven decades has any leader so fundamentally changed India as PM Modi. True, Indira Gandhi, a powerful leader like Modi, created Bangladesh, and imposed emergency but she didn't tinker with the Nehruvian ideological basis of India. So, didn't Narsimha Rao, when he roped in the future prime minister Manmohan Singh, then a retired bureaucrat, as a finance minister to usher in liberalisation of the Indian economy, diluting the longstanding socialist moorings of the country. But Modi's term has marked a departure from all this. He has put India firmly on the road to Hindutva. He has shown the will to decisively alter the status quo to hone India to

his nationalistic vision.

Call it decisiveness or overreach, Modi embarked on a series of farreaching decisions starting with demonetization in 2015. His second term has been more disruptive in nature: Following the withdrawal of Article 370 he moved fast to enact Citizenship Amendment Act and took steps towards pan-India extension of National Register of Citizens which together have made religion as a basis of Indian citizenship and enabled fast-tracking of the citizenship of the non-Muslim refugees from the neighbouring countries. The government has laid the foundation of Ram Mandir in Ayodhya taking the decades-long Ram Janam Bhoomi movement to its logical conclusion. Now revoked farmers' laws were passed, triggering protests by peasants. New Delhi's Chief Minister Arvind Kejriwal who supported the centre on J&K was himself disempowered with most of the powers being vested in the Lieutenant Governor.

In all the above cases, the PM didn't budge, no matter the intensity of the opposition to the moves. shmir's case he risked the adverse international fallout which, however, didn't materialize. Even Pakistan which claims Kashmir and could have been expected to escalate the security challenge in the former state shied away. But in regard to farmers, Modi has made an exception. The analysts have generally termed this as a result of the year-long resistance by the farmers. True, farmers have been unremitting in their protests, despite losing over 600 people. They braved the chill of last winter and accusations from the top of being "andolanjee-vis" and "Khalistanis", the latter tag reserved for Sikh farmers. Still, the union government stood unmoved. Throughout the year, it gave no indication that it was going to take back the laws - it only offered to defer their implementation until 2022. But then the PM, as he does with all his big-bang announcements, suddenly declared that the laws were no longer in force.

More so, in Uttar Pradesh, India's most populous state, where the chances of the BJP returning to power don't look all that bright and where the BJP needs a victory to stay in the reckoning in 2024 general elections. In India, over 50 percent of the population makes a living from agriculture. Farming forms about 15 percent of the nation's \$2.7 trillion economy.

Any party that ignores farmers does so at their peril. In both states, Uttar Pradesh and Punjab, farmers form a substantial vote bank. In the upcoming elections, this deeply alienated section of the population would not only have been expected to vote against the BJP but would

Surly India

he joke is on a surly 'democratic' India. The 'retirement' of Munawar Faruqui, a young, Muslim standup comedian whose shows have been repeatedly cancelled as a result of the custodians of law - the police in Bangalore being the latest example caving in to pressure from right-wing groups, raises laughs about India's claims of being a mature democracy that is able to laugh at its follies. Mr Faruqui had earlier been jailed on the basis of a complaint lodged by a convener of a right-wing outfit who alleged that the comedian had offended Indian deities - the Supreme Court had dismissed the charge as being specious after the lower courts had rejected his plea for bail. The Supreme Court's summary dismissal of the allegations – was an arrest made for a joke that had not been cracked? - has deepened suspicions that Mr Faruqui's persecution may have something to do with his religious identity rather than humour. Incidentally, New India's war on comedy has had other victims: Vir Das, Kiku Sharda, Agrima Joshua, Kunal Kamra and many others have been subjected to censorship, ranging from intimidation, contempt cases, threats of violence and even jail terms.

This systematic targeting lays bare a fundamental problem. An authoritarian polity - there is little doubt that India has regressed to being one – finds comedy allergic. This is because throughout history humour and satire have retained elements of resistance against a totalitarian ethic. This, unsurprisingly, has led to governments, including elected dispensations, committing transgressions. In fact, the right-wing's campaign against comedians - it threatens their livelihood - cannot be delinked from India's deterioration on such registers as civil liberties, press freedom and the freedom of speech. It is a pity that a government that claims monopoly on valour does not have the courage to stomach a few jibes. Legal protection for performers is necessary. But more needs to be done. Technological innovations and a post-pandemic ambience have led to the rediscovery of the therapeutic value of humour. There is even a lucrative market for such performances. The resistance to the encroachment by vigilantes into this space must, therefore, come from the patrons – consumers and businesses – of this art.

Why Some People Find It Harder To Be Happy

he self-help industry is booming, fuelled by research on positive psychology - the scientific study of what makes people flourish. At the same time, the rates of anxiety, depression and self-harm continue to soar worldwide. So are we doomed to be unhappy, despite these advances in psychology? According to an influential article published in Review of General Psychology in 2005, 50% of people's happiness is determined by their genes, 10% depends on their circumstances and 40% on "intentional activity" (mainly, whether you're positive or not). This so-called happiness pie put positivepsychology acolytes in the driving seat. allowing them to decide on their happiness trajectory. (Although, the unspoken message is that if you are unhappy, it's your own fault.)

The happiness pie was widely critiqued because it was based on assumptions about genetics that have become discredited. For decades, behavioural genetics researchers carried out studies with twins and established that between 40% and 50% of the variance in their happiness was explained by genetics, which is why the percentage appeared in the happiness pie.

Behavioural geneticists use a statistical technique to estimate the genetic and environmental components based on people's familial relatedness, hence the use of twins in their studies. But these figures assumed that both identical and fraternal twins experience the same environment when growing up together – an assumption that doesn't really hold water.

In response to the criticism about the 2005 paper, the same authors wrote a paper in 2019 that introduced a more

nuanced approach on the effect of genes on happiness, which recognised the interactions between our genetics and our environment.

Nature and nurture

Nature and nurture are not independent of each other. On the contrary, molecular genetics, the study of the structure and function of genes at the molecular level, shows that they constantly influence one another. Genes influence the behaviour that helps people choose their environment. For example, extroversion passed from parents to children helps children build their friendship groups.

Equally, the environment changes gene expression. For example, when expecting mothers were exposed to famine, their babies' genes changed accordingly, resulting in chemical changes that suppressed production of a growth factor. This resulted in babies being born smaller than usual and with conditions such as cardiovascular disease. Nature and nurture are interdependent and affect each other constantly. This is why two people brought up in the same environment may respond to it differently, meaning that behavioural genetics' assumption of an equal environment is no longer valid. Also, whether or not people can become happier depends on their "environmental sensitivity" – their capacity to change. Some people are susceptible to their environment and so can significantly change their thoughts, feelings and behaviour in response to both negative and positive events. So when attending a wellbeing workshop or reading a positive psychology book, they may become influenced by it and experience significantly more change compared to others – and the change may last longer, too.

But there is no positive psychology too. But there is no positive psychology too tervention that will work for all people because we are as unique as our DNA and, as such, have a different capacity for wellbeing and its fluctuations throughout life.

Are we destined to be unhappy? Some people might struggle a little harder to enhance their wellbeing than others, and that struggle may mean that they will continue to be unhappy for longer periods. And in extreme cases, they may never experience high levels of happiness.

Others, however, who have more genetic plasticity, meaning they are more sensitive to the environment and hence have an increased capacity for change, may be able to enhance their wellbeing and perhaps even thrive if they adopt a healthy lifestyle and choose to live and work in an environment that enhances their happiness and ability to grow.

But genetics does not determine who we are, even if it does play a significant role in our wellbeing. What also matters are the choices we make about where we live, who we live with and how we live our lives, which affect both our happiness and the happiness of the next generations.

8 Things Japanese Do That Helps Them Live Long

hy has Japan earned the distinction of being the country where people live long, healthy lives? Is there something in their food and nutrition that helps longevity? What are the secret formulae of Japan's nonagenarians and centenarians? Here's a peep into the Japanese way of life that scratches below the surface to find the secrets of Japan's long life record.

In an international comparison of recent mortality statistics among G7 countries, Japan had the longest average life expectancy, primarily due to remarkably low mortality rates from ischemic heart disease and cancer (particularly breast and prostate), observes Shoichiro Tsugane of the Center for Public Health Sciences, Tokyo.

In the report that appeared in the European Journal of Clinical Nutrition and Nature.com, researchers said that Japanese life expectancy has only increased over the years. The low mortality rates from ischemic heart disease and cancer are thought to reflect the low prevalence of obesity in Japan; low intake of red meat, specifically saturated fatty acids; and high intakes of fish, specifically n-3 polyunsaturated fatty acids, plant foods such as soybeans, and non-sugar-sweetened beverages such as green tea.

The typical Japanese diet as characterized by plant food and fish, as well as modest Westernized diets such as meat, milk and dairy products, might be associated with longevity in Japan.

Let us look at the key factors due to which Japanese men and women have been able to live a long, healthy life with good health, mobility, and cognitive skills intact.



Ikigai, Japan's equivalent to 'joie de vivre': The Japa-1. nese live with 'ikigai' - an ancient philosophy that preaches that one must seek some joy and purpose in life instead of merely existing. It's about having a practice that guides you towards fulfilment. It is not about instant gratification but surely about defining your purpose in life, your personal mission, and discovering your full potential. The aim is to define what you can best contribute to the world, what you're good at, and what you enjoy doing. Psychologists explain that this leads to a sense of higher self-esteem and puts us in sync with our capabilities

2. It's coded in the genes: Apart from good healthcare and

a great diet, the Japanese also have a genetic advantage due to two genes in particular - DNA 5178 and ND2-237Met genotype - that is prevalent among the Japanese population. Not every Japanese person will have this gene type, but this is common mostly among those with a longer lifespan. These genes seem to enhance the lifespan by blocking age-related diseases like type 2 diabetes, strokes, heart attacks, cerebrovascular and cardiovascular diseases.

3. Ditch the car and walk: Don't be fooled by some of the best cars and motorcycles in the world coming from Japan. An average Japanese person loves to stay active, walk, take the stairs, squat. Remember the Seiza -- the traditional socialising position of kneeling that involves resting on one's shins and tucking the feet underneath one's bottom? Or Shuudan Koudou -- the Japanese art of synchronized precision walking? Only Japan could have crafted something like that. Their toilets too are designed for squatting, not sitting, thus ensuring that the core stays engaged - also healthier for the bowels and your muscles! An average Japanese would rather take the train or walk to work.

4. "Hara Hach Bun Me": It means the Japanese concept that dictates that one must eat only until you are 80 per cent (8 out of 10 parts) full. It usually takes at least 20 minutes for the brain to get the signal from the body that it needs to stop eating as it has had its fill of nutrients. This practice is the Japanese "clock and reminder to stop eating" that averts overheating. The Japanese serve smaller portions and encourage a slower eating style. Portions are served on smaller plates.

5. Cleaner surroundings and good Health Care setups: The Japanese have an advanced health care system. Regular health campaigns that guide people to incorporate healthy lifestyles like reducing salt consumption, free treatment for TB are a norm. Japan's investment in public health in the 1950s and 1960s with creating a health and hygiene conscious culture is paying off, says a research paper in Lancet. The Japanese are fastidious about hygiene-related practices. Landfill sites are not a menace but are turned into eco-friendly parks.

Mealtime principles: In Japan, families eat together sitting on the floor and using chopsticks, making the eating process a lot slower. The Japanese diet is lean and balanced. with staple foods like sea-weeds seasonal fruits, omega-rich fish, rice, whole grains, tofu, soy, miso, and green and raw vegetables. Low amounts of saturated fats and sugars and are loaded with vitamins and minerals -- amply seen in how the obesity rate is impressively low in Japan.

7. The tradition of drinking tea: Who has not heard of the Japanese tea ceremony? Japan's ancient drink is rich in antioxidants that boost the immune system, help fight cancer, aid digestion, boost energy levels and regulate blood pressure. Some say the elements in the tea brew enhances cell health and help neurons fight age-related deterioration.

8. The elderly and ageing are taken care of: Indians may identify well with the way Japan treats its Dada-Dadi, Nana-Nani population. No segregating or discarding the ageing members of the family. Much like in India, most grandparents in Japan too get a life amidst family members -- and families prefer to have them at home rather than sending them to care homes as is the norm in many western countries. It is normal for grandparents to spend time with grandchildren and impart some traditional wisdom to them. The sense of security that this staying together brings, benefits both -- the elderly and the young ones.

AI Can Make Better Clinical Decisions Than Humans

"t's an old adage: there's no harm in getting a second opinion. But what if that second opinion could be generated by a computer, using artificial intelligence? Would it come up with better treatment recommendations than your professional proposes?

A pair of Canadian mental-health researchers believe it can. In a study published in the Journal of Applied Behavior Analysis, Marc Lanovaz of Université de Montréal and Kieva Hranchuk of St. Lawrence College, in Ontario, make a case for using AI in treating behavioural problems.

'Medical and educational professionals frequently disagree on the effectiveness of behavioral interventions, which may cause people to receive inadequate treatment," said Lanovaz, an associate professor who heads the Applied Behavioural Research Lab at UdeM's School of Psychoeducation.

To find a better way, Lanovaz and Hranchuk, a professor of behavioural science and behavioural psychology at St. Lawrence, compiled simulated data from 1,024 individuals receiving treatment for behavioral issues.

The researchers then compared the treatment conclusions drawn in each case by five doctorallevel behavior analysts with those produced by a computer model the two academics developed using machine learning.

The goal, the researchers believe, should be to use machine learning to facilitate the work of professionals, not actually replace them, while also making treatment decisions more consistent and predictable.

"For example, doctors could someday use the technology to help them decide whether to continue or terminate the treatment of people with disorders as varied as autism, ADHD, anxiety and depression," Lanovaz said.

"Individualized clinical and educational decision-making is one of the cornerstones of psychological and behavioral treatment. Our study may thus lead to better treatment options for the millions of individuals who receive these types of services worldwide.

New Bill On Cryptocurrency After Cabinet Approval: FM Sitharaman In RS

NEW DELHI: The government will soon bring in a new Bill on cryptocurrency after it is approved by the Union Cabinet, said Finance Minister Nirmala Sitharaman on Tuesday in the Rajya Sabha.

A Bill on Cryptocurrency and Regulation of Official Digital Currency for introduction in the Lok Sabha has been included in the Lok Sabha Bulletin-Part II, as part of the government business expected to be taken up during the ongoing winter session.

The Bill seeks to create a facilitative framework for the creation of the official digital currency to be issued by the Reserve Bank of India (RBI) for the ongoing winter session of Parliament. It also seeks to prohibit all private cryptocurrencies in India, however, it allows for certain exceptions to promote the underlying technology of cryptocurrency and its uses.

Replying to a series of questions in the Rajya Sabha, Sitharaman said, "This Bill, once the Cabinet clears, will come into the house".

The government had also listed a similar Bill for the last Parliament session (monsoon) but it was not taken up.

On the floor of the House, the RID leader, who is also a former deputy CM, asked his former

boss Kumar to ensure that lower-level officials are not made scapegoats and the big fish do not go unpunished.

Sale and consumption of alcohol was completely banned in Bihar in April, 2016. The drastic move followed a promise made by Kumar to women of the state during the assembly elections of 2015, which his JD(U) had fought in alliance with the RJD and Congress.

However, bootlegging has been thriving in the state since then and opposition leaders claim that while the poor often ended up being punished for flouting prohibition, those with resources were getting liquor delivered to their homes.

Last month, more than 40 people had died in West Champaran, Gopalganj, Muzaffarpur and Samastipur districts after consuming spurious liquor.

CAG Criticises Defence Ministry For Lack Of Planning In Implementing **Decision On Dress Allowance**

NEW DELHI: The Comptroller and Auditor General (CAG) has criticised the defence ministry for lack of planning in implementing a decision to provide dress allowance to armed forces personnel in lieu of basic uniforms.

In a report tabled in Rajya Sabha on Tuesday, the CAG said the ministry took several months to issue clarifications on the matter after the recommendation of the Seventh Pav Commission to provide dress allowance to Personnel Below Officer Ranks (PBORs) in place of basic uniforms was accepted. It said the Ministry of Finance (MoF) accepted the recommendation of the Pay Commission in August 2017. The amount of dress allowance was to be credited to the salary of employees

with effect from July 2017, the national auditor said. "The Ministry of Defence took three months (November 2017) to convey the above decision to the Armed Forces

and took further seven months (June 2018) in issuing detailed clarifications on basic and special uniforms," a press release issued by the CAG said.

The Ministry of Defence had sufficient time between November 2015 (issue of 7th CPC recommendations) and November 2017 (issue of orders on dress allowance) to review existing stock of basic uniforms lying at various army depots, it said

It said the ministry, however, did not devise a strategy to exhaust the stock or to explore the option of deferring decision to implement the orders on dress allowance.

"This resulted in stock of uniform items worth Rs 126.20 crore lying undistributed in three ordnance depots (January/ February 2020). Further, basic uniform items worth Rs 74.86 lakh were issued to PBORs in addition to the payment of dress allowance," it said.

Sanction is accorded to the adoption of the scheme for granting claim to the next of kin of COVID-19 victims in pursuance of the guidelines issued by the National Disaster Management Authority (NDMA) in compliance with the Supreme Court order, Khan said.

According to the order, the eligibility of a case under the scheme would be verified through the database created by the Health and Medical Education Department and duly certified by the designated medical authority.
