# Iran's Rouhani calls Trump's plan 'most despicable plan of century'

EHRAN :Iran's President Hassan Rouhani has condemned US President Donald Trump's so-called 'peace plan' for the Israeli-Palestinian conflict as 'the most despicable plan of the century.' "Enough of these foolish attempts," Rouhani wrote on his Twitter account on Wednesday. "The

Most Despicable Plan of the Century," he added. Meanwhile, Iran's

Parliament Speaker Ali Larijani also referred to Trump's self-proclaimed "deal of the century" as a dangerous plan for the West Asia region which, describing it as a ploy devised to make up for the failures of the United States and the Israeli regime.

"We have to try to make all Muslim countries united against this illegal and inhuman agreement," Larijani said while speaking in a phone conversation with Syrian Parliament Speaker HammoudaSabbagh on Wednesday.

"In fact, this deal and treasonous conspiracy is designed to fulfill the wishes of the Israeli regime in the region," Larijani noted, adding that despite the claims of the US officials, the plan has nothing to do with the interests of the Palestinian people.

Defying the international outcry, Trump announced the general provisions of the plan at the White House on Tuesday with the Israeli premier at his side. During the Tuesday joint presser with Netan-

yahu, the US president once again endorsed his contentious recognition in December 2017 of Jerusalem al-Quds as Israel's "capital," a move he took in the face of Palestinian demands that the holy city should serve as the capital of their future state. He said the plan envisages the city as the Israeli regime's "undivided capital."

# **Trump's Mideast** peace plan 'absolutely unacceptable': Erdogan

nkara: Turkish President RecepTayyip Erdogan lambasted a Middle East plan unveiled by US counterpart Donald Trump Las "absolutely unacceptable" in comments published Wednesday.

"Jerusalem is sacred for Muslims. The plan to give Jerusalem to Israel is absolutely unacceptable. This plan ignores Palestinians' rights and is aimed at legitimising Israel's occupation," Erdogan said, quoted by CNN Turk broadcaster.

"The plan outlined will not serve peace or bring about a solution," he added.

Trump revealed Tuesday the long-awaited plan aimed at resolving the Israeli-Palestinian conflict, saying Jerusalem would remain Israel's "undivided capital".

As part of the plan, future Palestinian statehood would be based on a series of strict conditions -including requiring the future state to be "demilitarised." Turkey-Israel relations are currently tense while Erdogan regards himself as a champion of the Palestinian cause.

JERUSALEM- The Israeli army announced an increased presence in the West Bank and near Gaza on Wednesday evening as US President Donald Trump's controversial Middle East plan sparked outrage among Palestinians.

The plan, seen as overwhelmingly supportive of Israeli goals and drafted with no Palestinian input, gives the Jewish state a US green light to annex key parts of the occupied West Bank.

It was widely cheered in Israel, but sparked fury among Palestinians, with protests breaking out in the West Bank and the Hamasrun Gaza Strip.

One rocket was fired from the strip on Wednesday evening. In response, the army

Wuhan: The World Health Organization on Wednesday warned all governments to "take action" over the SARS-like virus spreading from China that has killed 132 people and infected around 6.000 others.

The WHO called an urgent meeting for Thursday over whether the viral epidemic should be declared a global health emergency -- a designation that can increase international coordination.

Airlines have begun suspending flights to and from China following cases of onward transmission outside the country.

And some countries have begun airlifting their nationals trapped in Wuhan, the quarantined Chinese city of 11 million people at the centre of the epidemic. A US charter flight from Wu-

han with about 210 Americans on board, including consulate staff, was met at a Califor

nia military base on Wednesday by emergency vehicles with flashing lights and personnel in white biological hazard suits.

The evacuees will be monitored for symptoms and sent to local hospitals if they are found to be ill, the

US defense department said. Among 206 Japanese nationals who returned home Wednesday, 12 were hospitalised for tests after they reported they felt unwell or showed flu-like

symptoms A growing number of governments -- including the United States, Britain and Germany -- have advised their citizens to avoid nonessential travel to China China has urged its own citi-
