He added that there was no report of any casualty so far.

Meanwhile, the estranged armies also exchanged gunfire in Bagtore area of Gurez in Bandipora district.

"At around 6:30 Pakistan army restored to LMG firing along the LoC which was effectively retaliated by the Indian army. There was, however, no report of any damage to property or life," sources said.

Sources said that the Pakistan army resorted to intense firing and shelling last night also in Bagtore area of Gurez. The firing continued for about 15-20 minutes and later stopped, they said.

On Sunday an army soldier identified as Sandeep Yadav of 6 Maratha regiment was injured in cross-LoC firing near Panth post. The injured soldier was evacuated to army's 92 base hospital in Srinagar for treatment.

MeT Predicts Fresh Snowfall Today

minus 24 followed by Leh, where the mercury settled at minus 22.4 degree Celsius.

A Meteorological department spokesperson said that rain or snow would occur at some places in the valley under the influence of a Western Disturbance (WD), which is active in the region.

"The WD has phased off and will have very less impact in the valley," he said, adding on Wednesday, snow could occur at isolated places.

He said the weather will again turn dry from Thursday onwards, which would result in dip in the night temperature though mercury during the day is expected to improve. Despite an improvement of about a degree in the night temperature, world famous ski resort of Gulmarg, about 55 km from here in north Kashmir, was the coldest place in the valley at minus 10.1 degree. The night temperature at world famous health resort of Pahalgam, about 100 km from here in south Kashmir, improved about 6 degree from Monday and settled at minus 6.6 degree. After witnessing improvement of about 2 degree in the night temperature, people woke up to a cloudy and chilly Tuesday morning in the summer capital, Srinagar. Chill further intensified as the day progressed due to overcast conditions, coupled with ice cold winds in the city. The night temperature in the city improved and settled at minus 3 degree, against minus 5 degree recorded on Monday. During this 40-day-long Chilai Kalan, which ended on Wednesday, Srinagar received heavy snowfall, breaking about 30 year old record. The night temperature at Qazigund, Kupwara in north Kashmir and tourist resort of Kokernag improved and settled at minus 6.3 degree, minus 3.9 degree and minus 4.8 degree, respectively.

Jailed Mehbooba Offers **Prayers, Reads Books**

Mehbooba during her ongoing incarceration read many books including Holy Quran, Lost palace by Catherine Bowness, No God but God by Reza Aslan and books of Elif Shafaq, a Turkish-British novelist, Iltija told a local newsgathering agency KNO.

Iltija, who met her mother ten days ago, said only a few family members including mother, daughters and siblings are being allowed to meet Mehbooba at present.

"Although adequate facilities are being provided to my mother in jail, but after spending six months e without any trial, anyone who is under detention would certainly miss her home and family," she said.

About her conversation during her meeting with Mehbooba Mufti, she said anyone who is under detention from last six months wonders what is happening outside.

"The situation in Kashmir is well known to everyone. The internet is still not working

ed, but our frustrations find no outlet. The authority doesn't make the slightest effort to put a stop to our doubts and speculations, but stubbornly tend to go their own way to confine our existence mired in a confused, conflicted and a paralysed world."

The 19-year-old Srinagar-born former actress added: "But I ask the world, what has altered your acceptance of the misery and oppression we're being subjected to? Do not believe the unfair representation of the facts and details or the rosy hue that the media has cast on the reality of the situation. Ask questions, re-examine the biased assumptions. Ask questions. For our voices have been silenced -- and for how long....none of us really know!"

In June last year, Zaira said goodbye to her film career as she held that "relationship with her religion was threatened". In a detailed post on her Facebook page, the 18-year-old had cited religious reasons for her decision to quit her promising career in the Bollywood.

hat had earlier told the court that it should issue notice on the plea, as the matter is connected with alleged conspiracy from February 27, 2002 to May 2002. s many as 68 people, including Jafri, were killed by a mob at Gulberg Society on February 28, 2002. The incident occurred after the S-6 Coach of the Sabarmati Express was burnt at Godhra killing 59 people and triggered riots in Guiarat. The SIT in February 2012 filed a closure report giving clean chit to Modi and 63 others, which included senior officials in the government, citing no concrete evidence was found. Zakia Jafri moved the top court in 2018 challenging the October 2017 Gujarat High Court order rejecting her plea against the SIT's decision. commitments made to the people of Kashmir in 1947, 1952 and 1975 and this will only widen the divide in the state.

He asked the Centre to "undo" the abrogation and acknowledge that it was a mistake.

The Centre on August 5 revoked Article 370 provisions which gave special status to Jammu and Kashmir and proposed that the state be bifurcated into two Union territories, Jammu and Kashmir and Ladakh.

Last month Jammu and Kashmir's Deputy Superintendent of Police Davinder Singh was caught ferrying militants in a car in the Vallev.

Participating in the debate, Samajwadi Party leader Akhilesh Yadav said the BJP government talks about 'Sabka Sath, Sabka Vikas', but it neither took everyone along nor was there any development.

Rather "it is only creating doubts in the minds of people", he said.

Yadav said the government forgot to mention about river Ganga in the President's adproperly. The government actually doesn't want people to express their pain and agony, therefore the services have been suspended continuously," she said.

She said that every Kashmiri is being punished, and the government would have even controlled people to breathe, if they had such powers.

Asked about Mehbooba's continuous detention, Iltija said "It is a banana republic here. Everybody is under the thumb of government. If you see the internet suspension in Assam and other places, the court intervened and services were restored shortly.'

Mehbooba was among the leaders who challenged the abrogation of Article 370 with threatening statements. She had also stated that no one in Kashmir will hold tricolour if Article 370 is tampered with.

However, Iltija while responding to the query said that she doesn't know whether her mother will stick to her words.

"I don't know what will be her future course of action. Once she is out, she has to chalk out what she has to do. I can't decide or speak for anyone else including my mother," she said.
