Researchers identify why men are more prone to cancer

esearchers have identified a key biological mechanism that puts men at higher risk of cancer than women, an advance that may lead to more personalised lines of treatment and prevention for each gender.

According to the study, published in the Journal of the National Cancer Institute, the higher risk of cancer seen in men could be due to the loss of function in certain genes of the sex-determining Y chromosome, which is present only in men.

Chromosomes are coiled thread-like structures containing the genetic material in the form of Deoxyribonucleic Acid (DNA) and several proteins involved in regulating the genome. While embryos carrying two X chromosomes develop into human females, those with one X and a Y chromosomes develop into biological males.

Using data from 9,000 individuals, the researchers, including those from the University of Adelaide in Australia, studied the function of genes present in the Y-chromosome in patients with various types of can-

The findings revealed that the risk for several types of cancer increases with loss of function of six key Y-chromosome genes in various types of cells.

"Recent studies have shown that complete loss of the Y chromosome, which is essential to foetal sex differentiation, occurs, with aging, in the cells of some men," said Juan Ramon Gonzalez, study co-author from Barcelona Institute for Global Health (IS-Global) in Spain.

"Although the loss of the Y chromosome has previously been associated with higher incidence of cancer, the causes of this association are poorly understood," Gonzalez

According to the researchers, the Y chromosome genes play a role in the regulation of cell replication, the failure of which can lead to tumour development.

"Interestingly, these genes are matched by a similar copy on the X chromosome. If, as demonstrated, the X-chromosome copy also mutates in the same cells, the protection against cancer that these genes might otherwise provide is lost completely," explained Alejandro Cceres, lead author of the

Gonzalez said men, apart from facing a higher risk of cancer, also face a worser prognosis compared to women.

"In fact, these differences partially account for the lower life expectancy of men,"

The researchers believe that identifying the factors which make men more vulnerable to cancer has the potential to mitigate risk in this population.

"Although men may be more exposed to carcinogens due to the type of work they do and at higher risk because they are less likely to consult a doctor, our study has shown that there are also biological factors that increase cancer risk among men," Caceres said.

"In fact, it seems that one of these factors can be found in the Y chromosome, the very essence of maleness," he added.

Suppression of the Y chromosome, the scientists said, can occur as a result of the loss of function in the chromosome, or as a result of other mechanisms mediated by the chemical inactivation of the same regions.

"Certain environmental exposures, for example to tobacco or other harmful substances, could affect chromosome function and lead to epigenetic modifications. Our findings open the door for the development
