Nirbhaya Convicts Should Be Hanged Together: HC

NEW DELHI: The Delhi High Court on Wednesday said that four convicts in Nirbhaya rape and murder case should be hanged together and gave a weeks" time to them to avail their legal remedies.

'The death warrants should be executed together. Thus, convict Mukesh cannot be separated from the other convicts. I hereby direct the convicts to use their remedies within one week," Justice Suresh Kumar Kait said while pronouncing the order.

The order was passed on a petition filed by the Central government challenging a sessions court"s order which stayed the death warrants issued against the four convicts in the Nirbhaya gangrape and murder case.

Shootout In City Outskirts, 3 Killed

a shopkeeper. SDG CRPF said that "significant recoveries" were made from the shootout spot including grenades. He also congratulated his troopers for dealing with militants in a professional manner since the area witnesses' huge public and private traffic.

Inspector General of Police (IGP) Kashmir. Vijay Kumar identified the slain militants as Lashkar-e-Toiba militant Zia-ur-Rehman from Budgam and Khateeb Das of Hizbul Mujahideen from Bijbehara. Dass, police said was brother-in-law of ISJK militant Mugees Mir of Parimpora who was earlier killed in an encounter.

The IGP further said that third militant who was captured alive in an injured condition was identified as Omar Fayaz who was affiliated with ISJK, a claim strongly contested by the family.

"Zia-ur-Rehman was involved in the weapon loot incident in year 2018 at the official residence of Congress leader Muzaffar Parray," the IGP said, adding "Dass was associated with Hizbul Mujahideen and was involved in attacks in the areas of south Kashmir. Several cases were registered against him.'

When asked about the number of militants killed this year so far. DGP Singh said as many as 20 militants of different outfits were killed by security forces in the encounters.

"As many as 20 militants of different outfits have been killed in encounters, including the one in Jammu, during the last about a month. Three security force personnel were killed in the exchange of fire during this time. Many modules have also been busted during this time," he said.

Singh expressed optimism that the sumner this year in the Valley will be peaceful "We are hopeful that the situation will remain peaceful," he said.

However, the police in a statement issued in the evening maintained that Fayaz was an Islamic State of Jammu and Kashmir (ISJK) militant. Earlier, DGP Dilbagh Singh at a press con-ference had claimed that Fayaz was injured

Indo-Pak Nuclear War Would Harm Ocean

climate reacted to soot (black carbon) in smoke that would be injected into the upper atmosphere from fires ignited by nuclear weapons.

They considered a range of hypothetical nuclear wars, including a relatively small one between India and Pakistan and a large one between the US and Russia.

Excess carbon dioxide from the burning of fossil fuels enters the ocean and reacts with water to form carbonic acid, which decreases ocean pH (makes it more acidic) and lowers levels of carbonate ions.

Corals, clams, oysters and other marine organisms use carbonate ions to create their shells and skeletons, according to the National Oceanic and Atmospheric Administration.

A more acidic ocean makes it harder to form and maintain shells and skeletons. The massive amount of smoke from a nuclear conflict would block sunlight and cause global cooling, the study said.

The cooling would temporarily boost the pH in the surface ocean over five years and briefly lessen the decline in pH from ocean acidification.

But the cooling would also lead to lower levels of carbonate ions for about 10 years, challenging shell maintenance in marine organisms, said researchers.

"We have known for a while that agriculture on land would be severely affected by climate change from nuclear war," Robock said.

"A lingering question is whether the survivors could still get food from the sea. Our study is the first step in answering this question Robock added

She alleged that police claims that her nephew was taken to the hospital was a white life.

Fayaz's uncle Abdur Rashid Thakur said that his nephew runs a poultry shop in the area and he was at his shop when hit by a bullet.

"Fayaz's mother is a patient and his father was recently operated for his heart ailment," said Thakur, adding, that there are blood marks of his nephew still left at his shop.

"Police should correct the facts and visit the shop once." Thakur said.

The government forces, he said stopped the family at Shalteng due to which Fayaz lost a lot of blood.

"We arranged 18 points of blood for him so far. May God save him," he said.

Fayaz is battling for his life at SMHS hospital. He was hit by a bullet and has operated, his conditions according to doctors is said to be critical.

"Bullet hit his chest and he has been operated. We have put him on ventilator and his condition is critical," Medical Superintendent, SMHS Dr. Nazir Chaudhary told Kashmir Observer.

"We call on the supreme court's judges to examine this issue more closely and ensure that the executive stops violating article 19 of the Indian constitution, as it has been doing for the past six months,"

The RSF statement said that government 'boasted' that it had restored 2G mobile Internet and was establishing a network of 844 kiosks where members of the public could connect to the Internet.

"But, for a region with 8 million inhabitants, this means only one connection point for every 9,500 potential users. The selection of sites for inclusion on the "white-list" seems completely arbitrary," the handout said

"Social media, news sites and peer-topeer networks have been systematically excluded. Similarly, the Indian versions of search engines such as Google and Yahoo continue to be censored. But Yahoo's Quebec version is on the list," it added.

The RSF quoted a recent survey by the Medianama news website that said only 58 sites were really accessible.

"Kashmiris had few illusions. A week after the supreme court ruled on 10 January that the total Internet blackout in the Kashmir Valley was illegal, the government responded by publishing a "white-list" of 153 websites that were now supposedly accessible to Kashmiris. The number of sites was increased to 301 on 24 January," the statement said.

In Srinagar, the Kashmiri capital, RSF has been able to confirm that many of the sites on the "white-list" are in fact inaccessible because of the weakness of the 2G connection, which was originally designed to be used mainly for sending SMS messages. The bandwidth is very low and partial, and the

connection ends up dropping. Despite the blockade, RSF managed to conduct a series of video interviews with nine Srinagar-based journalists describing how it has become impossible to work and how the central government tries to 'control all news and information coming out of the region'. Entitled Voices From Kashmir, the video interviews were posted online of the 100th day of the communications blockade.

India is ranked 140th out of 180 countries in RSF's 2019 World Press Freedom Index but is likely to fall even further in the 2020 Index because of the crackdown on journalistic freedom in Kashmir, RSF said.

RSF quoted a number of journalists in the statement who complained of facing problems in discharging their professional duties

After witnessing a dipped of about a degree in the night temperature, people woke up to a cloudy and chilly Wednesday morning in the summer capital, Srinagar. However, as the day progressed sun came out from behind the clouds, resulting in considerable improvement in the maximum temperature. The night temperature in the city improved and settled at minus 3.9 degree, against minus 3 degree recorded on Tuesday. During this 40-day-long Chilai Kalan, which ended on January 29, Srinagar received heavy snowfall, breaking about 30 year old record.

The night temperature at Gulmarg, about 55 km from here in north Kashmir, dipped about a degree and settled at minus 11 degree. "The weather witnessed improvement as sun came out from behind the clouds on Wednesday in Gulmarg, which is famous for its ski slopes and quality of snow. Tourists, including foreigners, were out on ski slopes enjoying different activities," a hotelier said.

The mercury during the night at Qazigund, Kupwara in north Kashmir and tourist resort of Kokernag settled at minus 4.5 degree, minus 3.2 degree and minus 3.4 degree, respectively.

Of these, seven reports have arrived back and all of them are negative, the officer added.

Department to form committees for physical verification of all the Estates accommodations and eviction of illegal occupants from government quarters at Jammu and Srinagar.
