Air India Has To Recover Over Rs 822 Crore For Providing VVIP Charter Flights: RTI

Under VVIP charter flights, Air India provides its aircraft to ferry-- the President, the Vice-President and the Prime Minister-- for which the bills are paid by the ministries.



Following this, he was sent to police custody for five days which was further extended by three days on February 3.



Reacting to the BJP for mocking him for reciting "Hanuman Chalisa" on television, Kejriwal said that he will ensure that all BJP leaders recite the same.


