Priyanka Demands Release Of Omar, Mehbooba; Chidambaram 'Devastated'

SRINAGAR: The opposition parties on Friday lashed out at the government for slapping controversial Public Safety Act (PSA) against the incarcerated former Chief Ministers Omar Abdullah and Mehbooba Mufti.

Coming down heavily on the Centre. Congress general secretary Priyanka Gandhi Vadra today questioned the basis on which Omar Abdullah and Mehbooba Mufti were booked under the PSA.

Taking to Twitter, Priyanka said the two Jammu and Kashmir leaders have upheld the Constitution and abided by the democratic process and never ascribed to violence and divisiveness.

"On what basis has PSA been slapped on Omar Abdullah and Mehbooba Mufti? They upheld the Constitution of India, abided by the democratic process, stood up to separatists, and never ascribed to violence and divisiveness.

They deserve to be freed, not incarcerated indefinitely without any basis," she said on
