KOLKATA:(PTI) Pro-Left student bodies swept union elections in the Jadavpur University, even as the ABVP, which contested the polls at the institute for the first time, secured the second spot in one of the faculties.

Left and ultra-Left student organisations retained their hold in all the three faculties of the university where elections were held on Wednesday after a gap of three years.

The Bar and Bench report said that a Division Bench of Chief Justice Abhay Shreeniwas Oka and Justice Hemant Chandangoudar today remarked,

"How can the Bar Association pass such a resolution ... By passing such a resolution they are obstructing court work. Are they carrying out a mini trial by themselves?" Karnataka High Court Chief Justice Oka further stated that, "We will ensure that they (advocates who wish to represent the accused) are able to file bail applications for the accused."

The Court observed that the resolution passed is wholly illegal and against the traditions of the Bar. Moreover, the resolution is against the constitutional right of accused persons to have an advocate of their choice represent them, the Court observed.

In this regard, the Court urged the Hubli Bar Association to reconsider its resolution, as it appeared to be "ex-facie" against the mandate of law. The Court also pointed out that the Bar Association was bound by the Constitutional mandate and additionally, its members are bound by professional ethics envisaged in the Bar Council of India Rules. However, if the Bar Association does not reconsider its resolution, the Court would be compelled to examine its legality, the Bench forewarned. The Court further directed the petitioners to implead the office bearers of the Hubli Bar Association as well, the report added.
