## Donald Trump Announces \$3 Billion

state-of-the-art military helicopters and other equipment to the Indian armed forces." Ahead of Trump''s visit to India, the Cabinet Committee on Security headed by Prime Minister Narendra Modi on February 19 cleared the two deals to acquire 24 MH-60 "Romeo" naval multi-mission helicopters for \$2.12 billion and six AH-64E Apache attack choppers for \$796 million from the US.

The first batch of six MH-60R helicopters, equipped with multi-mode radars and nightvision capabilities as well as Hellfire missiles, MK-54 torpedoes and precision-kill rockets for potent anti-submarine warfare, would be delivered within a year. The remaining 18 will be delivered within four years.

The six Apaches, armed with Stinger air-toair missiles, Hellfire Longbow air-to-ground missiles, guns and rockets, would be delivered in three and a half years.

## India, Us Working To Defend People

at the airport, said his administration is working in a "very positive" way with Pakistan to crackdown on the militant organisations and militants that operate there.

Known for his fondness to tweet, Trump also took to Twitter and tweeted messages in Hindi, including one expressing eagerness to visit India, to which Modi responded by tweeting the Sanskrit phrase, "Atithi Devo Bhava (guest is god)".

During the first leg of his two-day trip, Trump talked about India's rich culture and extraordinary diversity repeatedly.

India is always admired around the earth as the place where millions of Hindus, Muslims, Sikhs, Jains, Buddhists, Christians and Jews worship side by side in harmony as it has great tradition of embracing individual freedom, rule of law, dignity of every human being, Trump said.

"The first Lady and I have travelled 8000 mile around the globe to deliver the message to all citizens across this nation -- America loves India, America respects India, and America will always be a faithful and loyal friend to the Indian people," Trump said at the "Namaste Trump" event in the presence of Modi, Melania, daughter Ivanka and son-in-law Jared Kushner besides top officials of the US administration.

During his nearly 30 minutes long speech, Trump also said," while our nations have many differences, they are both defined and propelled by a fundamental truth -- the truth that all of us are blessed with divine light and every person is endowed with a sacred soul" and quoted Swami Vivekanand.

Earlier, thousands of people greeted Trump and his family as the presidential cavalcade criss-crossed the city roads leading first to Sabarmati Ashram and from there to Motera stadium.

In his address, the US president heaped praises on Modi, saying the Prime Minister is a "living proof" of what an Indian can achieve with hard work as Trump referred to his humble background as a tea-seller.

Referring to the threat of terrorism, the US

prime minister added. Modi also praised Trump's leadership in

containing terrorism. Trump said as the world's largest economy, India

gives hope to all humanity and has become an economic giant. "There is a difference between a nation that rises

by coercion and one that rises by setting its people free -- that is India. India and the US have natural and enduring friendship," he said.

Trump also touched on India's cultural diversity and riches as he highlighted the success of its blockbuster movies like DDLJ (Dilwale Dulhania Le Jayenge) and Sholay, and its sporting icons like Sachin Tedulkar and Virat Kohli.

The US president also compliment the Indian government for its achievement in diverse areas including in laying of roads, providing cooking fuel to over 70 million households and lifting 12 Indians out of extreme poverty every single day.

"In single decade, India has lifted 270 million people out of poverty. Under Prime Minister Modi, for the first time in history, every village in India now has access to electricity," said Trump.

He said India will soon have the biggest middle class anywhere in the world and within less than 10 years extreme poverty in the country is projected to completely disappear.

"The potential for India is absolutely incredible. India's rise as a prosperous and independent nation is an example for every nation all over the world and one of the most outstanding achievements of our century.

"It is all the more inspiring because you have done it as a democratic country, you have done it as a peaceful country, you have done it as a tolerant country," he said.

In a tweet after the event Trump said:"Our two national constitutions both begin with the same three beautiful words: "We the people." That means that in America and India alike, we honour, respect, trust, empower, and fight for the citizens we proudly serve!" Later, Trump and Melania visted the Taj Mahal in Agra before arriving in New Delhi.

"The Taj Mahal inspires awe.A timeless testament to the rich and diverse beauty of indian culture! Thank you india," Trump wrote in the message book.

## 'India, US Share Relationship

Ivanka and son-in-law Jared Kushner as well as senior officials of his administration, landed in Ahmedabad on the first leg of his two-day visit to India.

"Anti-Muslim sentiment permeates the policies of both U.S. and Indian leaders. For decades, the U.S.-India relationship was anchored by claims of shared values of human rights and human dignity. Now, those shared values are discrimination, bigotry, and hostility towards refugees and asylum seekers, Margaret Huang, Amnesty International USA's executive director, was quoted as saying in the statement. It was a reference to the anti-CAA protests in India, the internet lockdown in Jammu and Kashmir and the Muslim ban expansion by President Trump affecting Nigeria, Eritrea, Myanmar, Kyrgyzstan, Sudan and Tanzania. the statement said. It added that Amnesty International USA's researchers travelled to Lebanon and Jordan to conduct nearly 50 interviews with refugees that as a result of the previous version of the ban have been stranded in countries where they face restrictive policies, increasingly hostile environments, and lack the same rights as permanent residents or citizens. The statement also came down hard on the Indian government, hitting out at the Citizenship (Amendment) Act (CAA) 2019 and saying it legitimises discrimination based on religious grounds. It criticised statements such as identify them (the protestors) by their clothes or shoot the traitors by Prime Minister Modi and his party workers. Such remarks "peddled the narrative of fear and division that has fuelled further violence", it said. The internet and political lockdown in Kashmir has lasted for months and the enactment of CAA and the crackdown on protests has shown a leadership that is lacking empathy and a willingness to engage. We call on President Trump and Prime Minister Modi to work with the international community and address our concerns in their bilateral conversations, Avinash Kumar, executive director, Amnesty International India said in the statement.

Asserting that the Union Territory administration and security forces are well aware about people using VPN apps to access social media sites despite a ban by Home department, J&K police chief Dilbag Singh had last week said that police is currently concerting on miscreants who are misusing Facebook and WhatsApp to spread rumours in the valley.

He also hinted at taking action against people, who are not misusing social media, but accessing it though VPN apps once they have dealt with miscreants who are spreading rumours to instigate violence.

The DGP has also appealed general public not to use social media via VPN apps. "Our main priority is the deal with people who are misusing social media and spreading rumours. Our second priority is to deal with the rest of the people who are accessing social media through VPN despite a ban. Currently we are concentrating only on the first priority," Mr Singh had said.

The Jammu and Kashmir police last week lodged an FIR against locals for using social media platforms on Virtual Private Networks (VPNs).

Mobile internet and broadband service of all Cellular companies was suspended in the Kashmir valley on August 5, 2019, when centre scrapped Article 370 and 35 A besides divided the state into two Union Territories (UTs).

However, 2G mobile internet service was resumed on January 25 while high speed internet and broadband remained suspended. The social media sites also remained banned and government had directed people to assess only whitelisted sites.

## Lawyers of Kashmiri Students Heckled

Inspection Bungalow from the court. Lawyers' groups held a demonstration against them near the court, while local rightwing activists shouted slogans of 'Go Back' and 'Bharat Mata ki Jai.'

The report also adds that the vehicles of lawyers were also damaged when they reached the court. The lawyers had to return to Bengaluru as they were not able to file the bail applications on behalf of their clients after disruptions inside and outside the court, the report adds.

A lawyer, who was part of the team, told News 18 that they went to Hubli to collect the FIR and other documents, which they were able to do. They also met the president and are passing resolutions that none of their members will appear in certain causes. This is something which worries me immensely," he said.

Highlighting the importance of dissent in a democracy, he said, "If a country has to grow in a holistic manner where not only the economic rights but also the civil rights of the citizen are to be protected, dissent and disagreement have to be permitted, and in fact, should be encouraged".

He said that rule of majority is an integral part of democracy but "majoritarianism is the antithesis of democracy" and in a democracy like India, the government in most cases does not represent the majority of the population, and often not even the voting electorate.

"Therefore, when those in power claim that they represent the will of all the people that is more often than not a totally baseless claim. They may be the elected government voted on the first past the post system by a large number of voters, but it cannot be said that they represent the entire will of the people," he said.

Justice Gupta, however, said that dissenting views must be expressed in a "peaceful manner" and citizens have a right to get together and protest when they feel that actions taken by the government are not proper.

"Their cause may not always be right. At the same time, the Government may also not be right. Merely because certain groups oppose those in power cannot take away their right to oppose what is proposed by the Government or to oppose any actions of the Government as long as the protest is peaceful. The Government has no right to stifle or quell protest as long as the protests are peaceful," he pointed out.

Justice Gupta said that the bedrock of our democracy is the rule of law and this necessitates that there must be an independent fearless judiciary.

"There can be rule of law only when we have judges who can take decisions independent of political influence, totally uninfluenced by media or any other extraneous considerations," he added.

He referred to several historic dissenting judgements including the famous opinion penned by Justice H R Khanna in the ADM Jabalpur case and said that Justice Khanna knew that he was putting his future as Chief Justice of India at stake.

In the ADM Jabalpur case of 1976, the fivejudge bench by a majority verdict 4:1 had arrived at the conclusion that Article 21 is the sole repository of all rights to life and personal liberty, and, when suspended, takes away those rights altogether.

Emergency was imposed in the country for a period of 21 months - from 1975 to 1977. Justice HR Khanna was lone dissenting judge who had held that "the suspension of the right to move any Court for the enforcement of the right under Article 21, upon a proclamation of emergency, would not affect the enforcement of the basic right to life and liberty"

must be open to criticism, and the judiciary is not above criticism.

"If Judges of the superior courts were to take note of all the contemptuous communications received by them, there would be no work other than the contempt proceedings. In fact, I welcome criticism of the judiciary because only if there is criticism, will there be improvement," he said.

Justice Gupta said there must be also introspection as "when we introspect, we will find that many decisions taken by us need to be corrected".

"Criticism of the executive, the judiciary, the bureaucracy or the Armed Forces cannot be termed "anti-national". In case we attempt to stifle criticism of the institutions whether it be the legislature, the executive or the judiciary or other bodies of the State, we shall become a police State instead of a democracy and this the founding fathers never expected this country to be", he said.

Justice Gupta, who is set to retire on May 6, said: "To question, to challenge, to verify, to ask for accountability from the government is the right of every citizen under the Constitution.

"These rights should never be taken away otherwise. We will become an unquestioning moribund society, which will not be able to develop any further".

He disapproved of calls often made by various bar associations refusing to represent accused in various cases and said it is against legal ethics and an obstruction of justice.

The mercury during the night at Qazigund, gateway to the valley, Kupwara in north Kashmir and tourist resort of Kokernag settled at 0.4 degree, minus 1.4 degree and 3.8 degree, respectively.

There was slight respite for people from chilly weather conditions in Ladakh, where water-bodies -- including lakes and streams -- remained frozen due to several degrees' below freezing point temperature. The people in the newly created Union Territory (UT) of Ladakh are mostly dependent on hot water springs during winter. The border town of Leh was the coldest place in the region after the mercury dipped about 2 degree from Sunday and settled at minus 9.5 degree.
