#### 4 Militants, 5 OGWs Held **In North Kashmir: Police**

Srinagar: Police on Friday claimed to have arrested four Lashkar-e-Toiba (LeT) militants and five of the militant group's over-ground workers from Jammu and Kashmir's Handwara and Sopore areas. State forces launched a search operation in GundChogal village in Kupwara district's Handwara area after receiving information about the presence of militants there, a police official said. "During the search operation, four militants linked to the militant outfit LeT were arrested," he said. They were identified as Parvaiz Ahmad Chopan, Mudasir Ahmad Pandith, Mohammad Rafi Sheikh and BurhanMushtaqWani, P-02

#### **Police Files Case After Leopard Lynched**

Srinagar: Police on Friday registered a case against many people in south Kashmir's Kulgam district for lynching a leopard before the beast attacked and injured seven villagers. # **During Pandemic, Dialysis is a New Deadly Distress in Kashmir**

SRINAGAR: A decade-long harrowing tryst with bad kidneys had ended in December 2019 for BasharatHussian-when he got a golden card promising Rs 5 lakh medical insurance to him per annum.

But a year later, as the card stands blocked, he's back to square one — seeking a desperate help for survival from the people themselves grappling with the covid-19 lockdown and stress.

Hussain, 41, was diagnosed with kidney failure in 2008, the year when Kashmir was out on streets against the controversial Amarnath Land Deal. Since then, his tolling and taxing

treatment has consumed his family's lifetime savings, his shop at FatehKadal and countless hours of sleep.

"But last year, when I got the golden card through an Aanganwadi worker, my family, including four sisters, sighed in relief,"



Hussain, a resident of Braripora, Nawakadal in Srinagar, said.

"The card was a big relief to welloff as well as underprivileged section of the society. Thing is, even if you've a fortune, it will get con-

sumed in dialysis treatment." Everything was going fine for him, until his dialysis centre re-

fused to acknowledge his golden card 14 days ago.

"They told me it's no longer

valid," said Hussain, an Antyodaya (AAY) ration card-holder.

The AAY ration cards are issued to "poorest of poor" households, making Hussian an eligible for all the government schemes. ▶PAGE 02

## **J&K At Risk Of Becoming Police State: NC**

SRINAGAR: Jammu and Kashmir is at the risk of becoming a police state, the National Conference said on Friday, a day after a senior police official warned of action against anyone found instigating people on the new domicile law announced by the Centre for the union territory.

"It would appear that along with everything else we also lost the fundamental right to free speech and the right to dissent last year. J&K may not be a 'state' but we risk becoming a police state (if we aren't already one)," the NC said on its official Twitter handle.

A report in a local daily has quoted Inspector General of Police Kashmir Vijay Kumar as saying that "some miscreants are instigating people on the new domicile law by misusing social media. ## 5 Booked For Friday **Prayer Assembly**

# **Covid-19: 5 More Test PositiveIn** J&K, Tally Reaches 75

JAMMU- Five more persons including four from Valley tested positive for COVID-19 inJammu and Kashmir on Friday, taking the total number of cases across the Union Territory to 75, officials said.

Among the four fresh cases detected in Valley today is a man, who had fled from SMHS hospital after doctors took his swab for examination, reports said. The 38-year-old resident of Chattabal, declared as 'red zone' by the officials, was brought back to the hospital by police after his test report came positive to Covid-19. He was later sent to Chest Diseases hospital for treatment.

"He had mentioned his name wrongly in the hospital registry," news agency GNS quoted a doctor as saying.

The second case from this capital city is a resident of Eidgah. He had come into contact with a minor boy who had tested positive to Covid-19 early this week.

Other two people, both teachers are residents of border town Uri in Baramulla district. They are said to have contracted the virus from a coronavirus patient from Samba region of Jammu.

Meanwhile, government spokesperson RohitKansal in a news conference held at Jammu said that the number of positive cases in the Union Territory have reached 75.
