Cop Injured In **Accidental Fire**

Srinagar- A policeman of SSG wing was injured in an accidental fire after his service rifle went off accidentally at Gupkar area of Srinagar City on Monday morning. Anti-Terror Mechanism Used To Track People Escaping Quarantine

NEW DELHI/SRINAGAR- Human Intelligence, a weapon used for busting militant groups in Jammu and Kashmir, has come in handy to trace people who concealed their travel history, besides in retracing the steps of coronavirus positive patients, in an operation that led to tracking of over 1,000 people who have since been quarantined in various parts of the union territory.

Fighting this new battle, officials said the authorities roped in the state intelligence machinery who were tasked to track, identify and bring such people to quarantine facilities.


The intelligence personnel along with the regular police, which remain at the forefront in the fight against militant groups in the union territory, were now complementing the district administration in its efforts to ensure the success of the lockdown, besides tracking people who hid their travel history from the authorities.

According to a report submitted to the Centre, over 1,000 people who had either traveled out of the state or abroad were brought to quarantine centres between March 15 and 31 and their identification and verification was going on, the officials said.

Also, more than 28,000 people are under surveillance which included 10,600 who have been either quarantined at government facilities or in home-isolation, the officials said.

There have been 92 positive cases so far in the union territory out of which two have died.

A total of 34 hotspots have been identified in Jammu and Kashmir which include: seven in Pulwama. five in Srinagar, and four each in Bandipora and Budgam; → PAGE 02

Kupwara Gunfight: 3 More Soldiers Succumb, **Death Toll Mounts To 13**

SRINAGAR- Three more soldiers, who were injured in a gunfight with militants in Kupwara woods, have succumbed to their wounds, taking the number of army personnel killed in the operation to eight. official said on Monday.

Five militants were also killed in the gunfight which continued for nearly a week reaching the climax on Sunday.

Official sources said that while one soldier died on the spot, a number of others were injured in the fierce gunbattle in the woods. Four of the injured military personnel, including a JCO from elite para force, succumbed to injuries on Sunday while three others lost the battle for

life at the army's base hospital here today, reported news agency GNS.

However, an army spokesperson confirmed death of only five soldiers, three on the encounter site, and two others while being airlifted to a military hospital.

"Four soldiers under the command of a Junior Commissioned Officer from the Para SF Units were heli-dropped at the encounter site in a hostile terrain near LOC. An intense hand to hand battle ensued and all five infiltrators were killed," a media report quoting an army spokesman said.

"In this battle, however, Army lost five of its best soldiers, three on the site and two more succumbed while they were airlifted to a nearby military hospital." >> PAGE 02

Omar Abdullah's Poll Posturing In Times Of Political Pandemic

SRINAGAR: Beyond a brewing 'storm in a teacup' over the controversial domicile law in the erstwhile state of Jammu and Kashmir, one man's political posturing has come to define the deafening political silence in the region, now known for its new nomenclature, and crumbling old order.

With riled Jammu forcing New Delhi to inflict job amendments within three days of the new domicile law notice, the prominent Kashmiri unionist with a new twitter bioline-'former PSA Political detainee, former CM of J&K state, former Union Minister, former MP, former MLA'-is apparently playing safe on the issue.

Even his father, the veteran Farooq Abdullah, whom India's "Joan of Arc", Indira Gandhi, once perceived as a potential threat for "India's second partition" has largely lowered his 'blazing gun' guards.

Lately eulogized by the grand old party National Conference's loyalists as "tiger", the senior Abdullah has only maintained a dubious foot-dragging over the
