### Pak Violated Ceasefire In Poonch: Army

Jammu: Army on Thursday accused Pakistani troops of violating the ceasefire by resorting to small arms firing and mortar shelling along the Line of Control (LoC) in Poonch district of Jammu and Kashmir. The shelling from across the border started at 5.45 pm in Shahpur and Kirni sectors of the district, a Defence public relations officer (PRO) said. The Indian Army retaliated befittingly, he added.

### Jaish Militant Held In North Kashmir: Police

Srinagar- A local militant of Jaish-e-Mohammad (JeM) outfit was arrested by state forces on Wednesday night in Shumlaran area of north Kashmir's Baramulla district, police said. ## SC Seeks Centre, J&K Govt's Reply On 4G Restoration

NEW DELHI: The Supreme Court asked the Centre and the Jammu and Kashmir administration on Thursday to respond to a plea seeking directions to them to restore 4G internet in the Union Territory in view of the prevailing COVID-19 pandemic.

A bench of Justices N V Ramana, R Subhash Reddy and B R Gavai issued notices to them and sought their reply within a week on the plea filed by Foundation for Media Professionals' which has assailed an order of the J&K administration on March 26 that restricted to the internet speed to 2G only in the UT.

Senior advocate Huzefa Ahmadi, appearing for the petitioner, contended that in view of the

ongoing lockdown it is very necessary to enhance the technology and connectivity in the Union Territory.

He said that the virtual classes of students, whose schools are shut due to the lockdown, can only be done through enhancement of technology and better connectivity. The bench said it is issuing notice which may be served through e-mail on standing counsel of the Jammu and Kashmir administration and the Centre.

The plea filed through advocate Shadan Farasat, while seeking restoration of 4G internet services, alleged that the action of the government was violative of Articles 14 (right to equality), 19 (freedom of speech) and 21 (right to life) of the Constitution. ● PAGE 02

## '#Restore4G' Campaign Returns, As SC Sends Notice To Raj Bhavan

SRINAGAR: he Supreme Court of India on Thursday issued notice to the government of union territory of Jammu and Kashmir (J&K) regarding the restoration of high-speed internet in the region.

The repeated demands for 4G restoration, even raised by the veteran politicians like Farooq Abdullah and other civil society members have so far been brushed aside in the name of security situation in J&K.

However, Thursday's judicial intervention curtly recreated the online demand for the restoration of the high-speed internet services in J&K.

Twitter users while expressing optimism over the SC announcement restarted the restoration campaign.

"SC notice on restoration of #4G #mobile #internet in #JammuAndKashmir," tweeted Ashish Tripathi.

In the current global pandemic lockdown, when various the world governments are encouraging people to work from home and promoting online classes for students, Kashmiris are grap-

pling with the slow speed of 2G internet services.

"Supreme Court issues notice to the Jammu and Kashmir Administration on restoration of 4G services, gives them a week to respond. This comes after a PIL which said 2G speeds are not enough for virtual classes, tweeted Nidhi Razdan.

4G internet services remain suspended in J&K since last August, when New Delhi scrapped the special status of the erstwhile state and downgraded it into two union territories.

"Is this a face saving week for JK admin or they really will come up with excuses after one week before the court! Your take friends. #4G #Kashmir," tweeted Sarkar Javid.

While the broadband and 2G services were restored early this year, amid the mounting international pressure and bad press, the high-speed internet mandatory for the online businesses, education, research and other purposes remains suspended in the name of security.

## Kashmir Records 24 New Covid-19 Cases, J&K Tally At 184

Srinagar: Coronavirus cases continue to shoot up rapidly in Kashmir Valley as twenty four more people, half of them family members of a Covid-19 deceased, tested positive to the dreaded infection on Thursday, taking the number of total cases across Jammu and Kashmir to 184.

"24 more positive in Kashmir. Total 184. 32 in Jammu, 152 in Kashmir. All are contacts. A result of aggressive testing," Government spokesperson Rohit Kansal tweeted this afternoon.

Among the fresh cases recorded today, twelve are the family members and relatives of a middle-aged Bandipora man, who died of coronavirus at SMHS hospital on Tuesday, becoming third victim of the dreaded disease. The infected family members include the deceased man's wife, two daughters and a granddaughter, a resident of Amarghar in Sopore.

Other eight contacts include the deceased's brother, two sisters-in-laws, 3 nephews, niece and a 22-year-old male relative from Naidkhai area of the Bandipora district, news agency GNS reported.

Eight other people who tested positive to Covid-19 are the contacts of a teacher from Tangmarg, who is already under treatment for the deadly infection. Among the infected are his in-laws: a family of five—48-year-old male, his wife (40), son (12) and two daughters—one aged 14 years and other 20 years—besides 3 other one of them a widow (75) and her son (23) besides a 29-year-old woman, all resident of Sullanda Tangmarg.

The four other cases which surfaced today include that of a 22-year-old from Muqam-e-Shahwali in Kupwara district who had returned from New Delhi on March 20. He was quarantined only two days ago, the sources said. ● PAGE 02

## Surveillance Stepped Up In Kashmir To Track COVID-19 Cases

SRINAGAR: Authorities in Kashmir have intensified ground surveillance to track travellers, who hid their recent travel history, to contain the spread of coronavirus, even as restrictions on the movement of people across the valley remained in force for the 22nd consecutive day on Thursday, officials said.

The tracking of those per-

sons who have travel history but are absconding is being taken up on a war-footing basis, the officials said.

These measures have been taken after a group of five persons, who had travelled to an African country recently, tested positive for COVID-19. These persons were placed in administrative quarantine upon their arrival in Kashmir last month.

They said ground surveil-

lance teams in every district are being strengthened to trace such persons immediately so as to put them for proper screening and quarantine.

The steps are being taken after Divisional Commissioner, Kashmir, Pandurang K Pole, directed all Deputy Commissioners (DCs) in the valley to track-down all absconding travellers on a war-footing basis in their respective districts and put ● PAGE 02

## Is Current Lockdown Changing Perceptions About Kashmir

NEW DELHI: Caught in a captive lockdown for the first time in his life, Gagandeep Sharma keeps thinking about the restriction-ridden Kashmir these days.

But even as the weary indoor routine gets on his nerves, the 22-year-old student from Punjab University feels that the aerobic TV media's biased Covid-19 coverage might once again rob the room for introspection.

"I don't think there's any

change in the state of mind or point of view," Sharma, a confident chap, says in a cheery style.

"I talked to some of my Hindu middle-class uncles and they just say we're in a health emergency and Kashmir is facing another crisis. They don't think there's any comparison."

Unless Hindu middle class understands Kashmir from the point of view of a Kashmiri and commentary of people who have worked in Kashmir, Sharma continues, there cannot be any change in the thought of

the majority of Indians.

"This debate has just been reduced to another tool which is eroding liberals and left-wingers who've chosen to express their thoughts by comparing the two lockdowns," he says.

Parallels are being drawn between the chronic political lockdown of Kashmir and the pandemic lockdown in India at a time when the world is witnessing the worst crisis, after World War-II

The COVID-19 pandemic has engulfed the entire globe. More than 14 lakh people have

been reported infected by novel coronavirus worldwide with the gigantic death toll of 88 thousand.

The death toll due to COVID-19 rose to 166 with the number of cases of 5,734 in India. The Government of India has imposed the world's biggest ever lockdown by restricting the movement of over 1.3 billion people.

In J&K, four persons, three from Kashmir and one from Jammu, have already lost their lives due to COVID-19.
