J&K Admin Rules Out Lockdown Relaxation

All Kashmir Districts In Red Zones, Cases May Spike: Div Com

SRINAGAR: The Jammu and Kashmir administration On Wednesday ruled out relaxation in the lockdown extended till May 3, saying that a significant spike might be witnessed in coronavirus cases in the coming days due to aggressive testing.

Divisional Commissioner Kashmir, Pandurang K Poletold Kashmir Observer that all the districts in Kashmir have red zones and due to which stricter norms will remain in place and there will be no ease in lockdown restrictions. The restrictions, he said will remain stricter in red zones within the districts.

"First of all, the districts have to be categorized in red, grey and green zones. As of now, no district of the Valley falls in green zone. All the districts are in red zones," Pole said.

In Kashmir Valley, 76 hotspots for coronavirus have been found. Srinagar, the capital city is the most affected district in the Valley with 15 Red Zones and 73 cases of coronavirus till Wednesday. The red zone areas of city include, Chattabal, Eidgah, Ahmed Nagar, Lal Bazar, Hawal, Nowshera, Nishat, Khayam, Goripora Hyderpora, Bemina, Jawahar Nagar, Natipora, Lasjan and Tengpora

Elaborating further, the Divisional Commissioner Kashmir said that red zones were those areas where restrictions will be tightened, → PAGE 02

Of Withering Wait & Worry: Kashmir's Captive Chronicles

SRINAGAR: Since the outbreak of the global pandemic, Shameema from Sopore is continuously suffering from searing stress and high blood pressure.

Behind her troubled state of mind and body is the growing concern for her son, Abdullah Bin Muhammad, who's languishing in Kotbalwal Jail, Jammu under the charges of Unlawful Activities Prevention Act.

Shameema has already lost her son, Ibrahim Janwari, in a 2012 gunbattle with troops. And now, her main breadwinner's detention is taking a huge toll on her health. Her son was arrested in January 2019 and shifted to Kot Balwal, Jammu.

Amid Covid-19 scare, Shameema is getting worried about the "unhygienic conditions" in the jail.

"My brother is suffering from a stomach ailment and chest disease from so many months now," said Ubaidullah, Shameema's youngest son.

"As food quality and mandatory social distancing is not possible in a crowded lockup, my mother frets for her son's

A Sister's Stress

On July 13, 2019, Nazima's brother, Muhammad Huzaif Bhat, from the Sangrama area of North Kashmir, was slapped with stringent Public Safety Act (PSA) and shifted to Kotbalwal Jail, Jammu.

"As no healthy food is served to Kashmiri captives, my brother has developed a skin problem in prison," said Nazima. "And since he's the youngest among siblings, our mother has developed an acute state of depression."Nazima's captive

brother recently sent a word to her from his prison cell.

"Everything is good," he told his sister. "But," Nazima said, "he feared that if anyone gets infected in prison, the virus will spread like a wildfire.

A Father's Fear

family breadwinner, Imtiyaz, is languishing in Sub Jail Kupwara under PSA since last year. The only son among five sisters, Imtivaz married an orphan girl in 2018.

"Before imprisoned, he was nursing stomach and occasional fever problems, Ramzan, a resident of North Kashmir's Zainageer area, told Kashmir Observer.

After the COVID-19 outbreak, the father got worried about 'lack of medical facilities in iail'.

"Around 30 captives share a barrack," the father said. "And this makes the chances of spreading of the virus maximum."

▼ live in one of the swish areas in Mumbai – the dream city now fighting to survive the Covid-19 crisis.

Ever since the pandemic enforced a lockdown, the vibrant city with ivory towers and big enterprises looks lifeless. The mundane routine which we once knew has gone into hibernation.

I'm told it's a long haul!

Already 22 days have passed, since I've been locked in my apartment, watching the pervasive desolation hushing and haunting the city, which apparently never slept before.

For a change, I hear birds chirping, while I stand near window sipping my hot chai expecting for a warm company from it. I watch out for hours at late nights. I see these long buildings standing just dead. Alarming ambulances rumbling on abandoned roads further surge the sense of siege.

This is a new pulse of life, driven by a shortage of groceries, life resources, and sanitisers. What once was a promising living has now become a grim survival.

'I see Kashmir in Mumbai'



This desolation drifts me to the faraway land where people are struggling to survive. I think about Kashmir, which I was planning to

visit this spring, the season of tulips, the almond blossom and a promise of life after dead winter. As I watch the struggle from my window these days, I imagine myself a girl caught in curbs in mountains which Kashmiris call their home. Her daily struggle leaves me dazed, as I perceive my-

self a prisoner in my own home now. I think of these iron grills in my window as some prison partition, coming in the way of my

Then I think of girls of my age in the valley, their aspirations, their dreams, their dreads. How does it feel to live such a life?

Most of us didn't have any idea, until, as they say, chickens come home to roost. In this hopeless hour, I see Kashmir in Mumbai. I'm reminded of Appa's promise to visit Dal

Lake this year. This was my major motivation,

my big boost.

But now, as life has taken an unexpected turn, I immersed in the beautiful thought of Kashmir's ecstasy, only to think of that landlocked region cursed with perennial lockdown. Behind the serene face, I see >> PAGE 02

"I urge people to religiously follow the lockdown guidelines so that we don't have these red zones in the Valley," he said.

Pertinently, the Ministry of Home Affairs today issued the updated set of guidelines on coronavirus lockdownasking the State and Union Territories not to dilute lockdown guidelines in any manner and instead impose stricter measures as per local requirements.

Divisional Commissioner Kashmir said that to facilitate rural and agriculture economy, a little relaxation might be given after April 20 strictly on case to case basis. A man with travel history to Nizamuddin New Delhi was among two people who tested positive to coronavirus in Baramulla district. Both of them are residents of Sopore.

Two doctors —one from ASCOMS Sidhra and one Post Graduate (PG) from Medicines Department of the Government Medical College (GMC) Jammu were among four people who tested positive to Covid-19.

Meanwhile, the government in the daily media bulletin issued today said out of 300 positive cases, 260 are active, 36 have recovered and 4 have died.

The bulletin said that till date 56595 travellers and persons in contact with suspected cases have been put under surveillance, including 7784 persons in home quarantine, 270 in hospital quarantine, 260 in hospital isolation and 30228 under home surveillance.

"Besides, 18049 persons have completed their surveillance period of 28 days. Moreover, 6 more COVID-19 patients have recovered and were discharged today," the bulletin said.

It added that 4871 samples have tested as negative till April 15, 2020.

Of Withering Wait continues to be imprisoned till now.

Zafar's old and ailing parents, four daughters and two sons await his homecoming, as many PSA detainees were lately set free.

"We last met him in November 2019," said Muskan Jan, the detainee's eldest daughter studying in Class 8.

"Since then, we don't know anything about him. Since the outbreak of the pandemic, the entire family is worried about his health We want our father back home. He should be immediately released on humanitarian

A Son's Sorrow

The pandemic has increased the restlessness of Ahmed Bin Qasim, son of Dr. Ashiq Hussain Faktoo, serving life imprisonment in Udhampur Jail and of Asiya Andrabi, currently lodged in Tihar Jail.

"Healthcare system is very mediocre, insufficient and terrible in jails," Ahmed said.

"My parents and other prisoners suffer from the frail immune system. In case they contract it [Covid-19], I'm not sure if they may overcome!"

Asiya suffers from multiple ailments which include bronchitis, asthma, while Dr. Qasim battles glaucoma.

To be honest, Ahmed said, there is little you can expect.

"I've lived it," the son said. "My father should have been released after 14 years even if he had committed a crime they accuse him of. They bent laws in order to prolong his detention."

A Wife's Woe

Shabir Ahmed Wani, a 38-year-old contractual computer operator in Govt. Degree College Sogam is lodged in Lucknow Jail under PSA. He was detained on August 3 2019, and subsequently slapped with PSA.

"He had no involvement of whatsoever. No FIR was against him," said Wani's ailing wife. "We got surprised when we were handed a dossier." His dossier mentions that he "might incite trouble in his area".

Wani has a small family including his parents, wife and children.

"He has disc problem, while his mother is diabetic," said Wani's wife, who undergoes

"He should be with us, in this terrible time, as he has done nothing wrong to deserve that dungeon.'

A Sibling's Struggle

On August 4, 2019, Er Rashid, former MLA Langate and chief of Awami Ittehad Party, was summoned by National Investigation Agency (NIA). Since then, he's under trail.

"He's a patient, suffers from chest disease." said Khurshid Ahmed, brother of Er Rashid.

"Last time, when I met him in the court, I gave him medicines prescribed by his doctors, but because of jail rules, he couldn't take them."

Now, due to lockdown, Khursheed said, the family is not able to send him monthly expenditure.

"There's no facility to transfer money to him because of the lockdown," the sibling continued. The situation is very tough for Rashid and

others in jail due to congestion, Khurshid said.

"During night he's kept with 5 to 6 people in a lockup of 10*12 ft," the sibling said.

"It was safe, if political detainees were kept separate but they're kept with criminals. Then, there're employees who frequent their cell. So what is the guarantee?"

A Doctor's Take

A doctor who happened to visit a sub-jail, a couple of months ago, with a team to examine prisoners, told Kashmir Observer that if somehow the novel coronavirus enters the jail premises, it would prove to be a "bomb because of overcrowding".

"Furthermore due to lack of nutritious food and psychological stress, most of them [captives] have developed a weak immune system which makes them vulnerable," he said.

A Judicial Intervention

Keeping the global health crisis in view, the recent Supreme Court order states that the sate/ union territory could consider the release of prisoners who have been convicted or are under trial for offenses for which prescribed punishment is up to seven years or less, "with or without fine and the prisoner has been convicted for a lesser number of years than the maximum".

An Advocate's Argument

While reflecting on the SC order, advocate Shafqat Nazir said the high powered committee established on the orders of Supreme Court of India has issued guidelines of the release of a class of prisoners which seems not in congruence with the guidelines of the Supreme Court.

"We have people detained under PSA on the basis of apprehension," advocate Nazir told Kashmir Observer. "The apex court says to release convicts on parole or bail, and government says we won't release them."

In order, he continued, the government guidelines say no one among militancy-related would be released.

"However, SC had issued no such direction," Nazir said. "Secondly, they excluded people under preventive detentions. People held under sec 107 are to be released."

This is a sad state of affairs, the advocate argued, that convicted people are to be released and not those under preventive detentions, as if the virus won't affect the latter.

"They are making a class within the class which is not permissible under law," he added.

An Academic View

Since the world has not faced the current situation before, therefore nowhere in international law are there specific guidelines related to prisoners under pandemic, said Dr. Sheikh Showkat Hussain, an expert on International Law.

"But yes, there're guidelines as per Geneva Conventions which include they [prisoners] should be kept in a hygienic atmosphere," the law professor said.

"A prisoner or detainee does not lose a basic human right to life. Any act by which his life is put to risk should not be justified."

However, as a result of the near-collapse of the current world order, as argued by Ibrahim Kalin, a special adviser to the President of Turkey, globalization as we know will change in substantial ways.

When asked if the world community would now sit and frame guidelines for prisoners under pandemic, Dr. Hussain told Kashmir Observer, "Maybe, but right now, the situation is chaotic, which has not left the current worldorder affected and disturbed. This is the anarchic chaotic situation now."

An Activist's Advocacy

Zahoor Wani, a human rights defender working with Amnesty International, said the high-powered committee established on the recent Indian apex court order has excluded preventive detentions.

"But the problem in Kashmir is that most of its cases are preventive and militancy-related ones," Wani told Kashmir Observer.

And since militancy-related cases are a matter of national security, the rights activist said, they're very difficult to get released.

"In PSA, you've to approach courts which are dysfunctional at the moment, but if government wishes, it can simply revoke the cases, but that is not happening," Wani said.

A Watchdog Report

Amnesty International India, where Zahoor Wani works as rights activist, recently released a press statement under the title, 'India Covid-19 Response: Government Must Refrain From Abuse Of Power And Immediately Release All Arbitrarily Detained In J&K'. As per the statement, 1249 people have

been administratively detained i.e. without any charge or trial by the authorities. At least 251 prisoners were shifted to out of

Jammu and Kashmir out of which 23 suffered from a health ailment.

An Official Record

As per the Jammu and Kashmir Department of Prisons, "At present, there are 14 functional prisons which include 2 central jails, 9 district jail, 1 special jail, and 2 sub-jails."

In its official website, the department mentions, "Against a lodgement capacity of 2830 inmates, the department is accommodating more than 3600 inmates."

A State's Response

In a move to decongest various jails across J&K amid COVID-19 scare, the authorities lately decided to release 65 prisoners from jails.

Among the liberated prisoners, 22 were facing the stringent Public Safety Act (PSA).

Director General Prisons (DGP) informed the division bench of J&K High Court about this decision through a written report.

The bench comprised of Justice Gita Mittal and Justice Rajnesh Oswal was hearing a Public Interest Litigation (PIL) through video conferencing regarding the spread of Covid-19.

The DGP informed the court that 22 Public Safety Act detenues, 32 undertrials, nine under trial prisoners falling under section 107,109,151 of the CrPC have been released.

The sanction for parole has been granted to 19 other prisoners. Two prisoners are already on

But while the news has finally brought some smiles to the families of these prisoners, many others continue to wither in wait and worry for their captive wards' safety in the pandemic.

Maulana Sa'ad...

An FIR was registered against the cleric on March 31 at Crime Branch police station on a complaint of the Station House Officer of Niza-

He was earlier booked for holding the event, police said.

After several attendees of the Tablighi Jamaat event succumbed to coronavirus, we added IPC section 304 (culpable homicide not amounting to murder) in the FIR against the leader, a police

official said. Some foreigners who attended the event have also been booked for violation of visa norms.

In an audio message, Kandhalvi had said that he was exercising self-quarantine after several hundreds who visited the Tablighi Jamaat congregation at Nizamudddin Markaz tested positive for coronavirus.

The FIR registered against the Tablighi Jamaat event says that the Delhi Police contacted the authorities of Nizamuddin Markaz on March 21 and reminded them of the government order which prohibited any political or religious gathering of more than 50 people.

It says that despite repeated efforts, the event organisers failed to inform the health department or any other government agency about the huge gathering inside the Markaz and deliberately disobeyed government orders.

The sub district magistrate of Defence Colony inspected the premises several times and found that around 1,300 people, including foreign nationals, were residing there without maintaining social distance. It was also found that there were no arrangements of hand sanitizers and face masks, the FIR adds.

The Nizamudddin centre, attended by thousands, turned out to be a hotspot for spread of coronavirus not only in the national capital, but the entire country.

More than 25,500 Tablighi members and their contacts have been quarantined in the country after the Centre and the state governments conducted a "mega operation" to identify them.

At least 9,000 people participated in the religious congregation in Nizamuddin. Later, many of the attendees travelled to various parts

Bandipora Milkman

The officials believe that many women may have comeinto contact with this milkman and may have contracted the infection.

Bandipora district has recorded 53 cases, 26 from Gund Jahangir hamlet.

Deputy Commissioner Bandipora, Shahbaz Mirza said that contacts will be traced, quarantined and tested. He said that milkman who was tested positive, had come into contact with an already Covid-19 patient.

Both these brothers having travel history were lodged at a Guest House, the report added.

Officials said that despite knowing that the coronavirus is a dreaded disease, they negligently and deliberately left the quarantine centre increasing the risk of spreading the infection.

Services provided by self-employed electrician, IT repairs, plumbers, motor mechanics, carpenters to allowed from April 20, according to the fresh order.

However, the exemptions given from April 20 will not be applicable in COVID-19 hotspots/ containment zones and the State/ UT governments shall not dilute guidelines in any manner but may impose stricter measures as per local requirements.

According to the MHA order, all international. domestic flights shall remain suspended till May 3. All train services will also remain suspended during the lockdown period.

"All social, political, sports, religious functions, religious places, places of worship shall be closed for public till May 3," the MHA order reads.

It adds that gatherings of funerals and marriages will be monitored and regulated by the District Magistrate.

Educational institutions, coaching centres, domestic, international air travel, train services will also remain suspended till this time, it said. Public places like cinema halls, malls,

shopping complexes, gymnasiums, sports complexes, swimming pools, bars will also be shut till May 3. Highway 'dhaba', truck repairing shops, call centres for govt activities to remain open from

April 20: Shops of agriculture machinery, its spare parts, its supply chain, repairs, 'Custom Hiring Centres, related to farm machinery to remain open from April 20.

Spitting in public has been made a punishable offence and a strict ban enforced on sale of liquor, gutka and other tobacco products.

From April 20 activities permitted include agricultural, horticultural activities, farmers and farm workers in field, procurement of agri products, 'Mandis'. The home ministry said permitted industries

must make arrangements for stay of workers

within their premises or adjacent buildings by

observing social distancing norms. The home ministry said defence, paramilitary, health and family welfare, disaster management, NIC, FCI, NCC, Nehru Yuva Kendra and Customs

offices will function without any restriction. Other ministries and departments are to function with "100 per cent attendance" with deputy secretary and above rank officers.

"Remaining officers and staff to attend up to

33 per cent as per requirement," it said.

The guidelines said in order to mitigate hardship to the public, select additional activities will be allowed, which will come into effect from April 20.

"However, these additional activities will be operationalised by states and UTs and district administrators based on strict compliance to the existing guidelines on lockdown measures," it

The nation-wide lockdown is aimed to contain the spread of the pandemic that has killed over 370 people and infected over 11,000 in the country.

Only persons with valid passes are allowed to move, they added.

In the declared containment or red zones across the valley, the restrictions have been intensified as authorities have sealed those zones to ensure strict adherence to the standard operating procedure and warned of strict action against anyone who violated the prohibitory orders, the officials said.

"While all entry-exit points of areas declared as containment zones have been sealed, at least half of these points in each one of these areas have been sealed with removable barriers, enabling access into and out of them as and when required," they said.

The local mohalla committees of all such areas have been reached out to and are onboard the administration's efforts to contain the spread of COVID-19, the officials said.

The administration has put in place an elaborate and a comprehensive mechanism to ensure all requirements and needs of the residents are covered for as long as these areas remain under restrictions, they said.

public transport was off the roads with only

pharmacies and groceries allowed to open, the officials said.

directed to strictly observe the protocols like social distancing for labourers etc, working in these kilns, Additional Secretary to Lt Governor, Rakesh Magotra said in a letter to Jammu divisional commissioner.

He said since the Centre has extended the lockdown up to May 3, the administration has to ensure hassle-free supply and distribution of commodities of daily need to the public at large.

The letter said timings for opening of shops selling essential commodities will be increased to avoid overcrowding, while goods stored by dry fruit sellers in their shops or godowns may be allowed to be transported to cold storages in a systematic and staggered manner.

Load carriers are allowed to enter the city premises during the lockdown before 9 pm to unload essential commodities. A plan be devised for opening of business entities engaged in non-essential items like mobiles, books etc in a staggered manner, fixing days in a week during which certain trades shall be allowed to open, the letter read.

Magotra asserted that standard operating procedures be devised for strict compliance by these traders.

Interacting with traders and representatives of various associations at Raj Bhavan here on Tuesday, the Lt Governor said a committee has been constituted for resumption of commercial

and industrial activities in a controlled manner. The Lt Covernor was informed that around 50,000 labourers working in brick kilns across Jammu were left stranded due to the lockdown, with a request to allow the operations of these

Later in an order, the General Administration Department (GAD) said sanction has been accorded to the constitution of an eight-member task force for restoring economic activities and

employment process in the Union Territory. The terms of the reference of the task force include developing a strategy or action plan for restoring normal economic activities in all sectors in the Union Territory and to develop a package for assistance to industry, agriculture, horticulture, animal husbandry sectors to ensure their normal functioning, the order issued by

Additional Secretary Rohit Sharma said. It said the task force will also finalise a timebound plan for recruitment to government job vacancies at different levels along with the process to be followed for early recruitment, keeping in mind the fiscal balance and monitoring the recruitment process.

The order said the task force would submit the recommendations on the recruitment and action plan by May 15 and May 30, respectively. Meanwhile, 29 senior officers, including 23 Indian Administrative Service (IAS) and five Kashmir Administrative Service (KAS) officers, have been assigned the task related to COVID-19

management in addition to their duties. Financial Commissioner (Health & Medical Education department) Atal Dulloo would be the overall in-charge of Union Territory Coordination - COVID-19 response effort.

In April 2018, a special anti-corruption court sentenced Peer to a total of 16 years of rigorous imprisonment for his involvement in the 2012 Common Entrance Test (CET) scam.

The court had also imposed a fine of Rs 1 crore on Peer and Rs 50 lakh on another accused, Sajad Ahmad Bhat, who was acting as a broker in the scam. The court had sentenced Peer to seven years of rigorous imprisonment under section 420 of the Ranbir Penal Code (RPC), five years of imprisonment under section 5 of the Prevention of Corruption Act, three years of imprisonment under section 409 of the RPC and one year of imprisonment under section 120B of the RPC. It has ordered that all the sentences would run "consecutively".

The court had convicted 43 accused, including Peer, in the case, while it acquitted seven others. In its 382-page order, the court had said, "Mushtaq Peer, being at the helm of affairs as chairman of the board, occupied the top position, which he had abused to the fullest by orchestrating the criminal conspiracy for putting on sale the question papers, the secrecy of which he was under obligation to maintain.

"This dastardly crime is his brainchild and it would not have been possible for others to have even a glimpse of the question papers had he not defied the state....'

It had observed that scams like these contributed to the large-scale brain drain from the state and other law-and-order problems and said, "Therefore, this accused deserves no leniency at all."

Peer was arrested on November 23, 2014, by the Crime Branch. During the investigation, it had come to light that Peer, in connivance with the other accused, had sold the CET 2012 examination papers, along with the answer keys, to some candidates for Rs 60 lakh. (GNS)

Pervez Visit To Begin With Prayers

India to fire new CBMs At Pak

NEW DELHI: Pakistan President Pervez Musharraf will begin his two day India visit Saturday with prayers at dargah of Sufi saint Khwaja Moinudin Chisti at Ajmer before commencing extensive talks with Prime Minister Manmohan Singh on all outstanding issues, including Kashmir, on Sunday.

Seeking to break fresh ground. Prime Minister Manmohan Singh is expected to place new confidence building measures to carry forward the peace process in his talks with Pakistan President, who visits India on his first visit after the failed 2001 Agra Summit.

Singh, who will hold parleys with Musharraf after witnessing the last one-day Indo-Pak cricket match for over an hour in the morning, is likely to suggest opening of additional bus routes and ways to promote tourism in Kashmir to enable people-topeople contacts. A joint statement after the talks is not ruled

Official sources said that Musharraf, who will he accompanied by his wife Sebha and a 40-member delegation, has been conveyed Singh's suggestion that providing full security to the Srinagar-Muzaffarabad bus service-was the "joint responsibility" of the two countries and signals from that side have been "positive".

Why Concrete Barricades?

n Tuesday, the government went on erecting concrete barricades at the entry points to the areas declared red zones in Srinagar and some other parts of the Valley. In Srinagar, the barricades were set up at the newly declared red zone Natipora to halt the movement of the people in and out of the area. By the very look of it, the step comes across as exceptionally harsh and, in a way, uncalled for. More so, when the cases in the Valley, especially in Srinagar have tended to flatten in recent days.

The barricades, while they won't stop the people walking out of these colonies seem specifically geared to stop the movement of traffic in and out of them. This is both ridiculous and dangerous. What if there is a fire in these colonies and the fire brigade needs to move in? What if any person is taken seriously ill and needs to be moved to hospital? And if there are other exit routes from these colonies then what is the fun of blocking the one entry point with a concrete barricade? There are no convincing answers.

These barricades make for an apocalyptic sight and should have been avoided. And that too at a time when the people have begun to volunteer to ensure social distancing in their respective colonies. They have also set up makeshift barricades which can be easily removed once the time to lift the lockdown. So, where did the need for officially sanctioned concrete barricades come up? It is almost as if the government thrives in strengthening the curbs on people, no doubt for valid reasons, but a part of it comprising the extreme measures like erecting barricades is almost being resorted to for its own sake.

Government has justified the concrete barriers on the grounds that the people have damaged and removed barricades during nights. Underlying this rationale is a troubling assumption: that people are like cattle and so only the government can think for them and guide their behaviour in a particular direction. This thinking also denies people any agency and so empowers the government to think for them.

Going by this understanding the government would need to micro-manage the public life to ensure people do not contract COVID-19. But the problem with this approach is that for all the all-encompassing powers of a modern government it can't be ubiquitous and omnipotent. It has no option but to trust the people to do the right thing. People need to be sufficiently informed about the disease and urged to follow the precautions and they will certainly obey the advice. Their powerful incentive to do so is that it is in their own interest.

A narrowing window: On extension of lockdown

"t appeared inevitable, and the Centre has accepted the view of several States to extend the national lockdown for the novel coronavirus until May 3. The decision provides comfort and continuity to those in charge of containing the pandemic, but it is a small window within which an orderly exit must be planned. While announcing the extension, Prime Minister Narendra Modi spoke of incentivising areas that avert a spike in cases — over 10,000 nationally — through rigorous enforcement of the restrictions. These areas are to be allowed limited exemptions in activity after April 20, once they pass the 'litmus test' and are not at risk of becoming hotspots. Such a scheme naturally presumes that everyone can get a free or highly affordable confirmatory test for viral infection or recovery, which could place them in a green territory. Again, this has to be aligned with well-recognised protocols on healthy behaviour to stop new infections. The Centre's lockdown is the most rigorous globally, but it has witnessed severe gaps in implementation. Although the Home Ministry's original 21-day order and subsequent enabling amendments on farming had clear clauses, many States did not abide by them. So much so, the Union Home Secretary has had to restate the order's provisions allowing inter- and intra-State movement of goods vehicles. Active follow-up with State governments and clear instructions to enforcement agencies are necessary to help the public adhere to a curfew. The Prime Minister, who has affirmed the need to make full use of the rabi harvest, must ensure that intentions translate into results, and produce reaches the market. Failed communication States are partly responsible — has resulted in distressing

instances of arbitrary and often violent policing. Further extensions of a lockdown appear less and less feasible, as pressure builds up in an economy rendered moribund by the coronavirus. Millions of workers are already dependent on meagre income substitution measures and food donations, and many face escalating private debt. The Finance Ministry's welfare schemes need to be reviewed, and enhanced relief provided to all workers rendered unemployed through funds infusion and provision of food for at least six months. Those who have lost jobs, and senior citizens, should be able to enrol in the PDS online immediately. A gradual reopening of activity after May 3, going beyond essential services will require classification of infection risk for various groups, such as school and college students, teachers, and workers. The reality of COVID-19 is that there cannot be a return to normal overnight, and governments must plan for a sequential restoration of activity. The effort should be to enable the workforce, ensuring its health and safety.

Pakistan Clerics To Resume Group Prayers In Mosques Even As Govt Extends Lockdown

Islamabad: In clear defiance of the government directives, hardline clerics in Pakistan on Tuesday announced they would resume congregational prayers in mosques, even as the coronavirus cases in the country rose to nearly 6,000.

The government has banned prayer congregations of more than five people as part of its measures to curb the spread of the deadly coronavirus.

Despite the government's pleas to observe social distancing, a group of hardline clerics held a meeting in Karachi to discuss the issue of ban on such prayers and made the announcement before media at the Karachi Press Club.

Mufti Taqi Usmani, a religious scholar and former judge of the Federal Sharia Court, who was part of consultation, said it was decided that five time prayers as well Friday prayers would be held in mosques.

He, however, said that the "precautionary measures" of the government would be taken to avoid the spread of the coronavirus.

The clerics' decision came

as the government announced to extend the lockdown for another two weeks until April 30.

Those present at a press conference after the meeting included representatives from the Jamiat-e-ulema Islam, Jamiat-e-ulema Pakistan, Jamaat-i-Islami and Tanzeem-e-Islami among other religious parties.

The decision came despite announcement by Prime Minister Imran Khan to meet the clerics in order to discuss the issue of gathering in mosques in the holy month of Ramadan, which will start from April 25.

On Monday, over 53 senior clerics of Rawalpindi and Islamabad belonging to the Wafaqul Madaris al Arabia held a meeting in Jamia Darul Uloom Zakria to discuss the ban on prayer congregations, Dawn News reported.

The Monday meeting—attended by clerics representing various seminaries, banned groups, proscribed persons and political and non-political parties—warned the authorities against the ban and said government leaders should abide by religious norms and seek forgiveness.

Health Ministry Identifies 170 Corona Hotspots In India

New Delhi: The Union Health Ministry has identified 170 districts as COVID-19 hotspots and 207 districts as potential hotspots, officials said on Wednesday, reiterating that there has been no community transmission of the disease in the country so far.

Addressing the daily briefing to provide updates on coronavirus situation in the country, Joint Secretary in the Ministry of Health Lav Agarwal said that states have been asked to classify districts which have reported a higher number of cases as hotspots, the districts where cases have been reported as non-hotspots, and green zones where no cases have been reported.

"Hotspots are those districts which are reporting more number of cases or where the rate of growth of COVID-19 cases is high," Agarwal said, adding a detailed direction has been issued to states stating consolidated efforts are required to utilise this period of lockdown to curb the spread of the virus.

"Cabinet secretary held a video conference today with all chief secretaries, DGPs, health secretaries, collectors, SPs, municipal commissioners and CMOs where hotspots were discussed and orientation on field level implementation of containment strategy was given.

"They were told about large outbreak containment strategies, cluster containment strategies. Delineation of buffer and containment zone, parameter mapping, defining of entry and exit points were also discussed in detail." he said.

The joint secretary said movement of people will not be allowed in containment zones except for those related with essential services and special teams will search for new cases and samples will be collected and tested as per sampling criteria.

The officials said that health facilities in buffer zone outside the containment zone will be oriented and people facing SARI and influenza-like symptoms will be tested there.



Trump Cuts Off US Funding To WHO Amid Raging Pandemic

Trump said Tuesday that he was cutting off U.S. payments to the WHO accusing the world body of failing to do enough to stop the virus from spreading when it first surfaced in China.

Trump, who has reacted angrily to criticism of his administration's response to the worst epidemic in a century, has become increasingly hostile towards the WHO.

"The WHO failed in its basic duty and must be held accountable," Trump said at a briefing. He said the U.S. would be reviewing the WHO's actions to stop the virus before making any decision on resuming aid.

Nearly 2 million people globally have been infected and more than 124,000 have died since the disease emerged in China late last year, according to a Reuters tally.

Leading health experts have labelled Donald Trump's decision to cut funding to the World Health Organization (WHO) as a "crime against humanity" and a "damnable" act that will cost lives, reported the Guardian

Last week, Trump blasted the WHO for being "China-centric" and alleging that it had "criticized" his ban on travel from China as the COVID-19 outbreak was spreading from the city of Wuhan.

The WHO generally takes care not to criticize countries on their national policies, and it was not immediately clear what specific criticism Trump was alluding to.

Trump himself showed deference to China at the beginning stages of the outbreak.

Asked Tuesday about the appropriateness of seeking to cut the WHO's funding in the middle of a worldwide viral outbreak, Trump said the review would last 60 to 90 days.

Harris said international cooperation is needed to fight the virus, along with science and data.

Corona patients can spread infection two to three days before symptoms show: Study

Beijing: Patients with CO-VID-19 shed, or excrete, infectious coronavirus two to three days before showing first symptoms, according to a modelling study which says control measures taken after symptoms appear may have a reduced effect in curbing the pandemic.

The study, published in the journal Nature Medicine, noted that several factors can affect the efficacy of control measures designed to prevent the spread of the novel coronavirus, SARS-CoV-2.

These include the time between successive cases in a chain of transmission, and the incubation period between exposure to an infection and the appearance of symptoms, according to researchers, including Eric Lau from the University of Hong Kong.

If the serial interval is shorter than the incubation period, this would indicate that transmission may have happened before overt symptoms develop, they said.

In the study, the scientists

assessed the temporal patterns of viral shedding in 94 patients with COVID-19 admitted to Guangzhou Eighth People's Hospital in China.

They analysed throat

swabs collected from these patients from when symptoms first appeared until 32 days later.

Stray Dogs May Have Played Role In Novel Coronavirus Origin: Study

oronto: Scientists tracing signatures of the novel coronavirus across different species, have proposed that stray dogs—specifically dog intestines—may have contributed to the origin of the pandemic.

According to the study, published in the journal Molecular Biology and Evolution, many animals, beginning with snakes and most recently, pangolins, have all been put forth as the likely intermediate hosts transmitting the virus, SARS-CoV-2, from bots to humans.

from bats to humans.

However, according to Xuhua Xia from the University of Ottawa in Canada, the viruses isolated from these animals are too divergent



from SARS-CoV-2.

"Our observations have allowed the formation of a new hypothesis for the origin and initial transmission of SARS-CoV-2," Xia said.

"The ancestor of SARS-CoV-2 and its nearest relative, a bat coronavirus, in-

fected the intestine of canids, most likely resulting in a rapid evolution of the virus in canids and its jump into humans," Xia said.

With scientists across the world scrambling to identify the species of origin to understand how the new coro-

navirus first leapt from its animal hosts to humans, the researcher believes the findings highlight the need for monitoring SARS-like coronaviruses in feral dogs.

According to Xia, the current study is based on the battle scars viruses get from fighting off and evading the host's immune system using adaptations found within their genomes.

He said humans and mammals have a key antiviral protein, called ZAP, which can stop a virus in its tracks by preventing its multiplication in the host and degrading its genome.

Xia said ZAP targets a pair of chemical letters, called CpG dinucleotides, within its RNA genome.

Saudi forces kill man who refused to leave home: Activists

Saudi citizen who refused government orders to give up his home to make way for a new mega-project was killed by security forces, according to Saudi activists.

The man, who identified himself as Abdul Rahim Ahmad al-Hwaiti, said in a video posted online he was from the town of al-Khraybah in the northwest Red Sea region. He and other residents were being pressured by the government to give up their properties and accept financial compensation, he said.

Al-Hwaiti said in one video uploaded on YouTube that "anyone who refuses to leave the area would be arrested by government agents". He



called the government's move "forced displacement".

"This is my home," he said, adding he would not move elsewhere in Saudi Arabia because he considers his tribal area his "own homeland".

Al-Hwaiti said residents of the area do not want to be uprooted but are now living in fear because of what security forces might do to them

forces might do to them.

"Nine people from my area have been arrested so far and I am sure I will be next - or even

killed," he said in one video.
"I am sure if they kill me they
would put weapons around my
body and claim I was a terrorist."

According to Saudi activists, al-Hwaiti was shot dead after recording his last video documenting security forces storming his property. The Saudi government has not commented on the alleged killing. Calls to two government officials seeking comment rang unanswered on Wednesday.

Al-Hwaiti hails from the powerful al-Huwaitat tribe who are based in three countries: Saudi Arabia, Jordan, and the Sinai in Egypt. The al-Huwaitat have resided in the region for more than 800 years, predating the Saudi state itself by many centuries over.

f you feel stressed about coronavirus, you're not alone. Coronavirus (COVID-19) has had ripple effects into almost every aspect of our lives. With schools and workplaces closed for now, it's affected the way we live every day. So much has changed in such a short time.

It's natural to feel anxiety when we face a crisis, the unknown, or sudden change. It's a normal reaction to feel the need for safety, certainty, predictability,

Anxiety is a normal emotion and serves as a signal to pay attention so we can protect ourselves. Anxiety alerts us. It prompts us to adapt. But when we're overwhelmed by anxiety, it sometimes can do more harm than good.

When anxiety becomes overwhelming, we're less able to rise to a challenge, and sometimes we get stuck.

Here are some tips that can help you cope with anxiety and give you a sense of control even during an uncertain time. Many are simple techniques with proven benefits

Follow the advice of experts. First, know what to do to avoid the spread of germs. This not only helps keep you safer, it gives you

and your kids a sense of control! Follow the expert guidelines for health and safety. Wash your hands well and often. Keep surfaces clean. Stay at home. Keep a safe distance from others. When you do these things, you protect yourself, your family, and your community

Notice, label, and accept your emotions. When you feel anxious, quietly say to yourself, "OK, there's my anxiety again." Just putting a label on what we feel helps reduce our concern.

Accept anxiety as one of your many emotions. Don't ignore it, fight it, reject it, or be afraid of it. Don't judge yourself for feeling it. Be kind. Give yourself permission to be human.

Keep it in perspective and notice the good. Don't let anxiety run the show. It's one part of your emotional life, but it's not the whole thing. Leave room to challenge yourself: Is there anything going well? What positive things have happened that make me think this anxious thought might

not be accurate?
Direct your attention or practice mindfulness. When you notice anxious thoughts, know that you don't have to dwell on them. Direct your attention to things that help you feel calm. You can use techniques such as guided imagery (easily found on YouTube or Google Video) or

mindfulness practices that help you focus on being in the moment.

Practice breathing. Just pausing to take a breath can calm you in a difficult moment. It can help you pause before you react, and choose how to react. Specifically, "belly breathing" or diaphragmatic breathing is most helpful. Practice for 5–10 minutes a day. Try an app like "Belly Bio" that is free to download.

Reach out to others. Staying in touch with friends and family is good for you and for them. Feeling close to others reduces anxiety, and has been known to boost the immune system. Even though we're staying home, we can reach out by phone, video chat, or social media. We can feel close, even while we're apart. Practice physical distancing, but social togetherness.

Practice gratitude. Noticing what we're grateful for is a powerful remedy to anxiety. Showing gratitude is another way to feel close to others. It benefits your mood and your health. Say a simple heartfelt thank-you. Make a list of what you're grateful for. Send a letter to someone who's helped you. Let loved ones know how much they mean to you.

Be awed by nature. Even 5 minutes spent appreciating nature can lower anxiety and blood pressure. It raises emotional well-being. It reminds us we are part of something bigger than ourselves.

active. Even though we are staying at home, find ways to be active every day. There are plenty of ways to be active outdoors and still practice social distancing. Exercise relaxes you. It generates hormones that boost the body's immune system. If you can't get out, take a fitness class online.

Keep your balance. Calming anxiety doesn't mean ignoring problems. It's about finding our balance so we can cope well; so we can help ourselves and each other though this situation. We can find calm and well-being even when we face great uncer-

Know when to reach out for help. If your anxiety seems overwhelming — if you're having trouble sleeping, eating, or interacting in the ways you normally would — get help. Sensex tumbles 310 points to close near 30400-mark; Nifty finishes below 9000



MUMBAI: Equity benchmarks reversed early gains to finish in the negative territory on Wednesday as risk-off mood prevailed amid grim prognoses of the economic fallout of the coronavirus pandemic. Traders said that weak global markets and the rupee plunging to its all-time low against the dollar further weighed on sentiment. After gyrating over 1,346 points during the day, the 30-share BSE Sensex ended 310.21 points or 1.01 per cent lower at 30,379.81. Similarly, the NSE Nifty settled 68.55 points, or 0.76 per cent, down at 8,925.30.

Kotak Bank was the top loser in the Sensex pack, cracking 6.23 per cent, followed by Hero MotoCorp (4.83 per cen), Bajaj Finance (4.63 per cent), HDFC (3.61 per cent), HDFC Bank (3.57 per cent) and Maruti Suzuki (3.55 per cent). On the other hand, HUL, HCL Tech, ITC and Nestle India were among the gainers, rising up to 6.07 per cent.

Despite opening on a positive note, domestic stocks gave up all gains in a highly volatile session following negative sentiment in global equities amid projections of major slump in economic growth, traders said.

The IMF on Tuesday slashed India's projected GDP growth to 1.9 per cent in 2020 from 5.8 per cent in January, as the global economy is seen hitting the worst recession since the Great Depression in the 1930s due to the raging coronavirus



Meanwhile, the government on Wednesday said industrial units in rural areas will be allowed to function from April 20, provided they follow social distancing norms, while all kinds of public transport will be barred and public places closed till

"There may be greater clarity for the market participants as the details of the limited relaxation of the lockdown rules are announced by the state governments. But the volatility in the markets may stay with us till the trajectory of growth and price level becomes less uncertain," said Joseph Thomas, Head of Research - Emkay Wealth Man-

Analysts also said the focus will now also shift to the earnings season and the management commentary on the impact of coronavirus."Almost all sectors have been affected by the lockdown and the market will try to measure the future financial impact of this, rather than focusing on the previous quarter numbers. This is expected to drive stock specific moves in the market in the coming days. IT companies will officially kick off the earnings season and investors will be keen on how the virus spread has impacted their services and the locations in which those services are offered," said Vinod Nair, Head of Research at Geojit Financial Services.

BSE bankex, finance, energy, auto and consumer durables indices ended up to 2.49 per cent lower, while FMCG, basic materials, realty, capital goods and metals gained up to 4.33 per cent. Broader BSE midcap and smallcap indices rose up to 1.32 per cent.On the currency front, the rupee tumbled 17 paise to close at an all-time low of 76.44 (provisional) against the US dollar. Brent crude futures, the global oil benchmark, slipped 4.43 per cent to USD 28.29 per barrel.

Bourses in Shanghai, Hong Kong and Tokyo ended significantly lower. Stock exchanges in Europe too opened in the red.

The death toll due to COVID-19 rose to 377 while the number of cases in the country climbed to 11,439 on Wednesday, according to the Union Health Ministry. Global tally of the infections has crossed 19 lakh, with over 1.2 lakh deaths.



Petrol, Diesel Demand To Pick Up As **Trucks Allowed To Ply Amid COVID-19 Lockdown Extension**

NEW DELHI: Petrol and diesel consumption, which saw its biggest ever decline in the aftermath of a nationwide lockdown, is likely to pick up in the second half of the month as the government has allowed trucks to ply as well as farmers and industries in rural areas to resume operations after April 20.

Petrol and diesel sales had fallen by over 66 per cent and aviation turbine fuel (ATF) consumption collapsed by 90 per cent as the unprecedented nationwide lockdown shut factories, stopped road and rail transportation and suspended flights.

"The government has allowed inter and intra-state movement of goods traffic by road as well as rail. Also, farming operations, as well as industries outside municipal limits, have also been allowed to operate from April 20. All these will involve fuel consumption," a top industry official

Trucks are the biggest user of diesel. Diesel is also used as fuel in the harvester and other agri equipment. tions. Some goods train also run on diesel.

The official said that all these activities will allow diesel demand to pick up in the latter part of the month. Also, vehicles used by ecommerce operators will be allowed struction, irrigation projects, construc-

to ply. These vehicles would largely tion work and projects in industrial use petrol. "There isn't much hope areas such as SEZ and EoUs will be alfor ATF but petrol and diesel demand certainly will look up if all the industries and activities permitted by the government resume operations from April 20," the official said.

The government hasn't yet allowed resumption of domestic and international flights. Also, road construction and resuming on work on projects in industrial clusters has been allowed, which too would consume fuel, he said. As part of a plan to exit the world's biggest lockdown and revive stalled economic activity, the government on Wednesday allowed makers of information technology hardware, farmers and industries in rural areas to resume operations after April 20.

This came a day after Prime Minister Narendra Modi extended a nationwide lockdown to May 3 to prevent the spread of coronavirus. The lockdown was first imposed on March 25 for 21 days. From April 20, the government will lift restrictions on e-commerce companies, goods movement by roads and restart port and air cargo opera-

Factories beyond municipal limits including those in the food processing industry, mining, packaging material, oil and gas exploration and refineries will be allowed to operate. Road con-

lowed to operate.

The official said both public and private sector oil refineries had cut down their run-rate following the drop in demand. Petrochemical plants too had shutdown as products like polymers they produced were not being lifted by user industries such as plastics and packaging unit.

He said that now with packaging industry allowed to operate, some of the products from packed godowns will move, allowing resumption of petrochemical units. The collapse of demand in the world's third-biggest consuming nation during April came on the back of worst fuel sales in more than a decade recorded in March 2020.

The country's petroleum product consumption fell 17.79 per cent to 16.08 million tonnes in March. Diesel, the most consumed fuel in the country, saw demand contract by 24.23 per cent to 5.65 million tonnes.

This is the biggest fall in diesel consumption the country has recorded as most trucks went off-road and railways stopped plying trains. Petrol sales dropped 16.37 per cent to 2.15 million tonnes in March as the 21day nationwide lockdown enforced to prevent the spread of COVID-19 took most cars and two-wheelers off


